FIG. 4 is a left side view of the bicycle saddle;

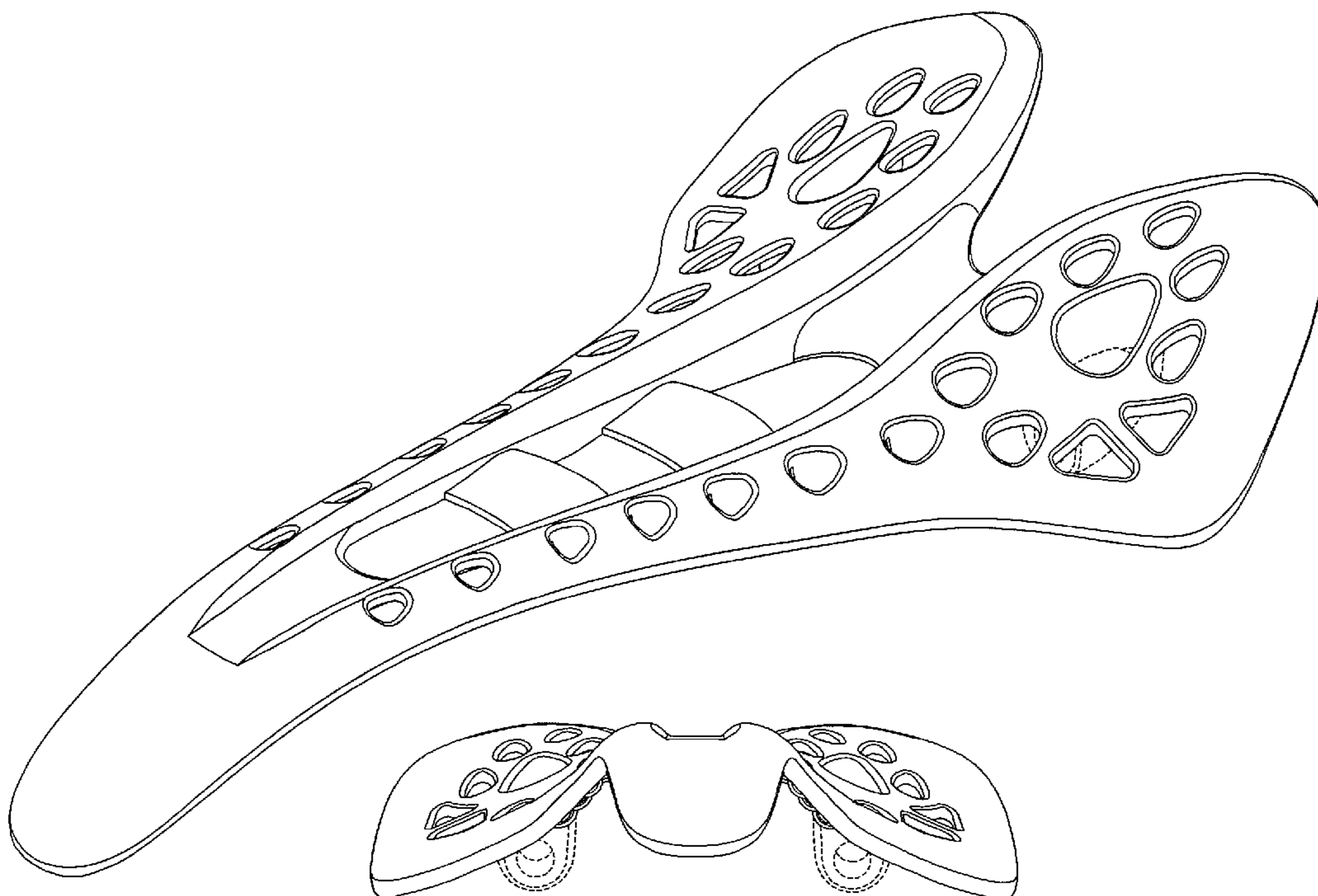
FIG. 5 is a right side view of the bicycle saddle;

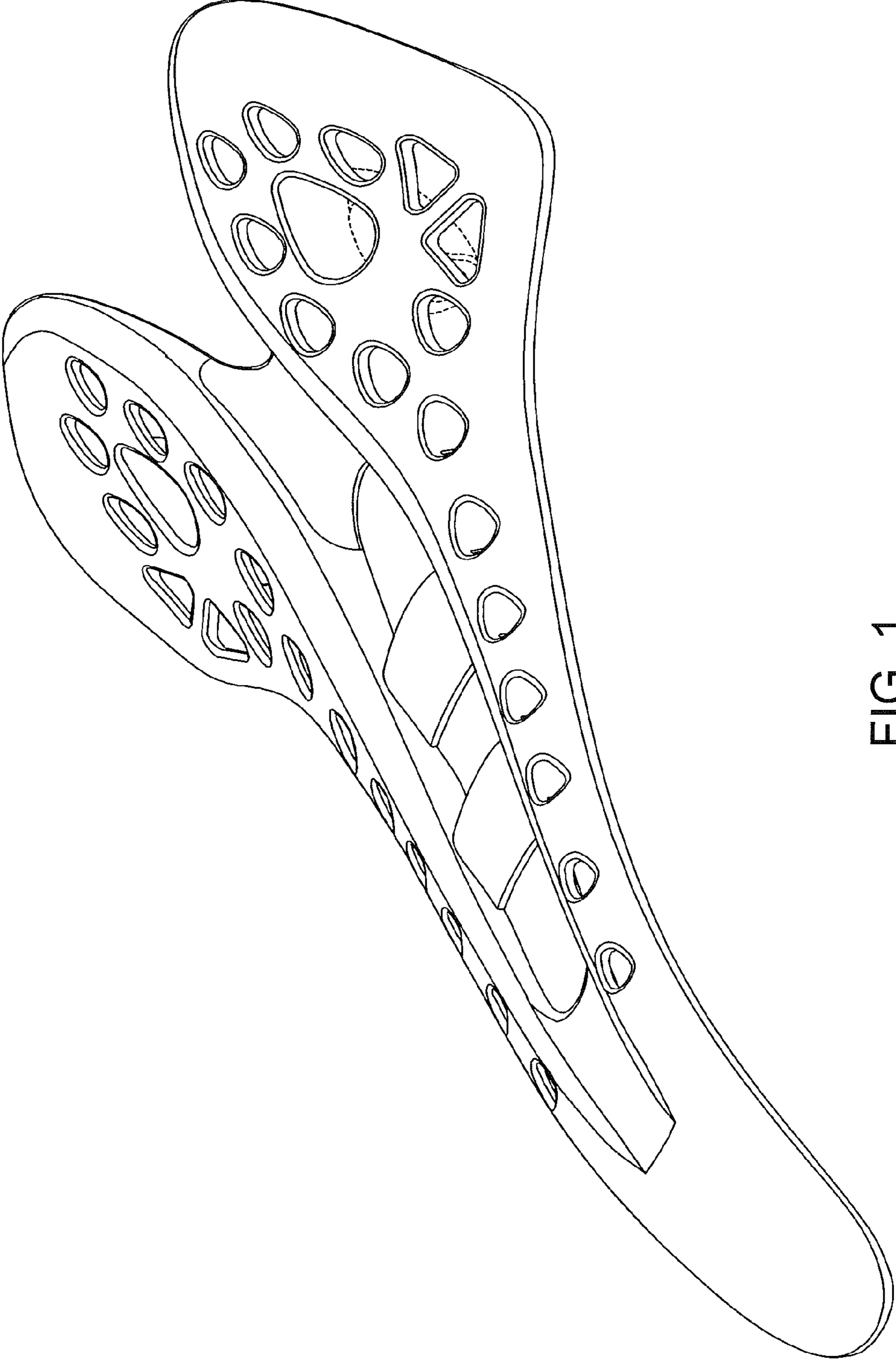

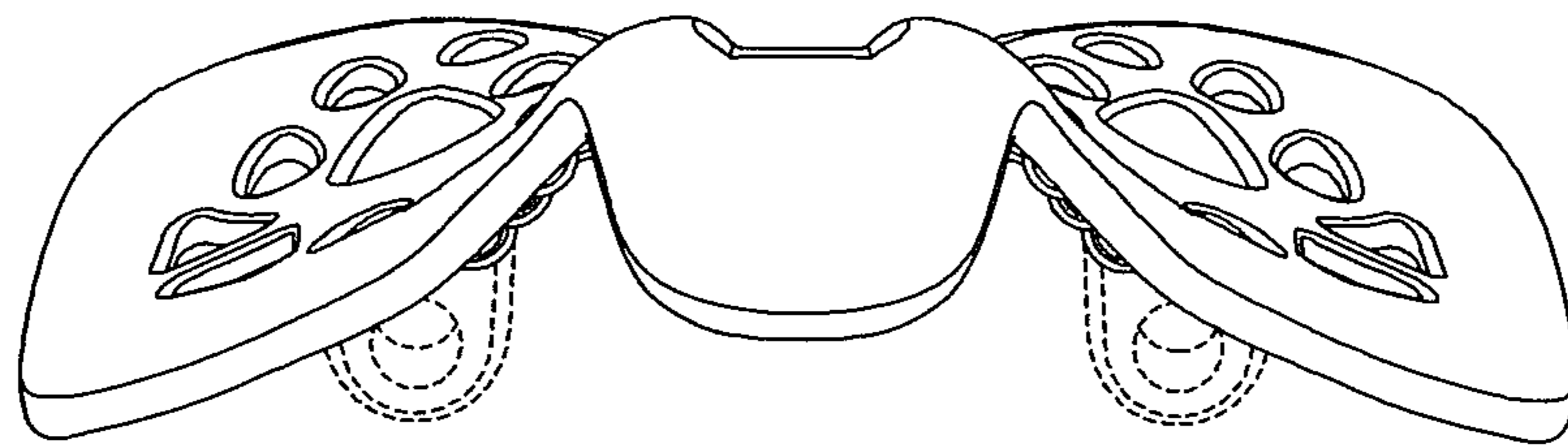

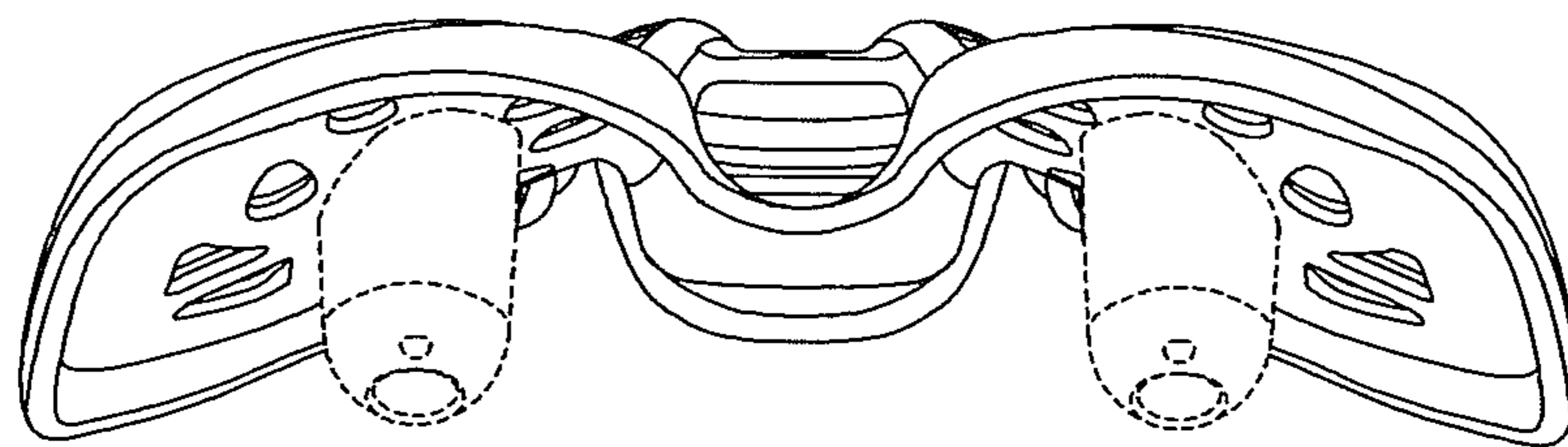

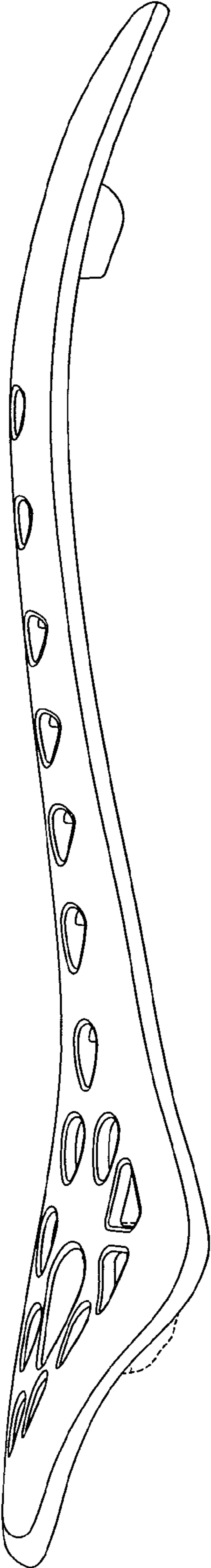

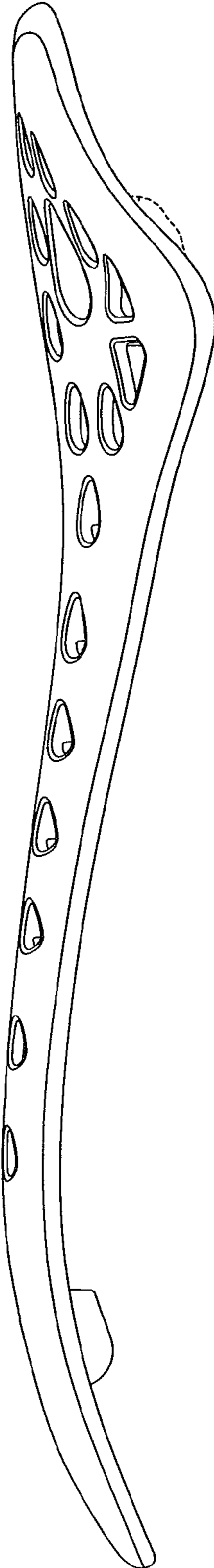

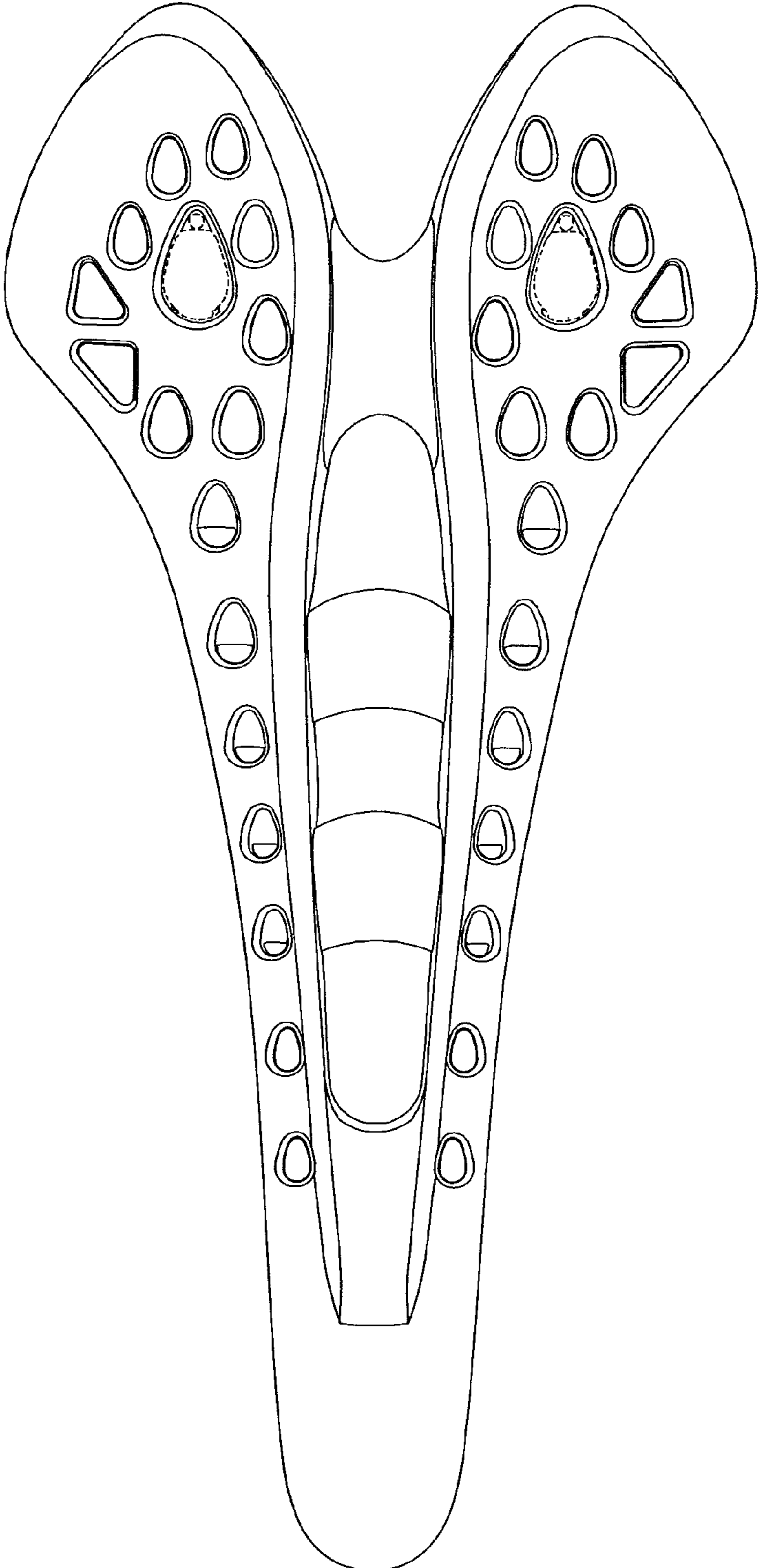

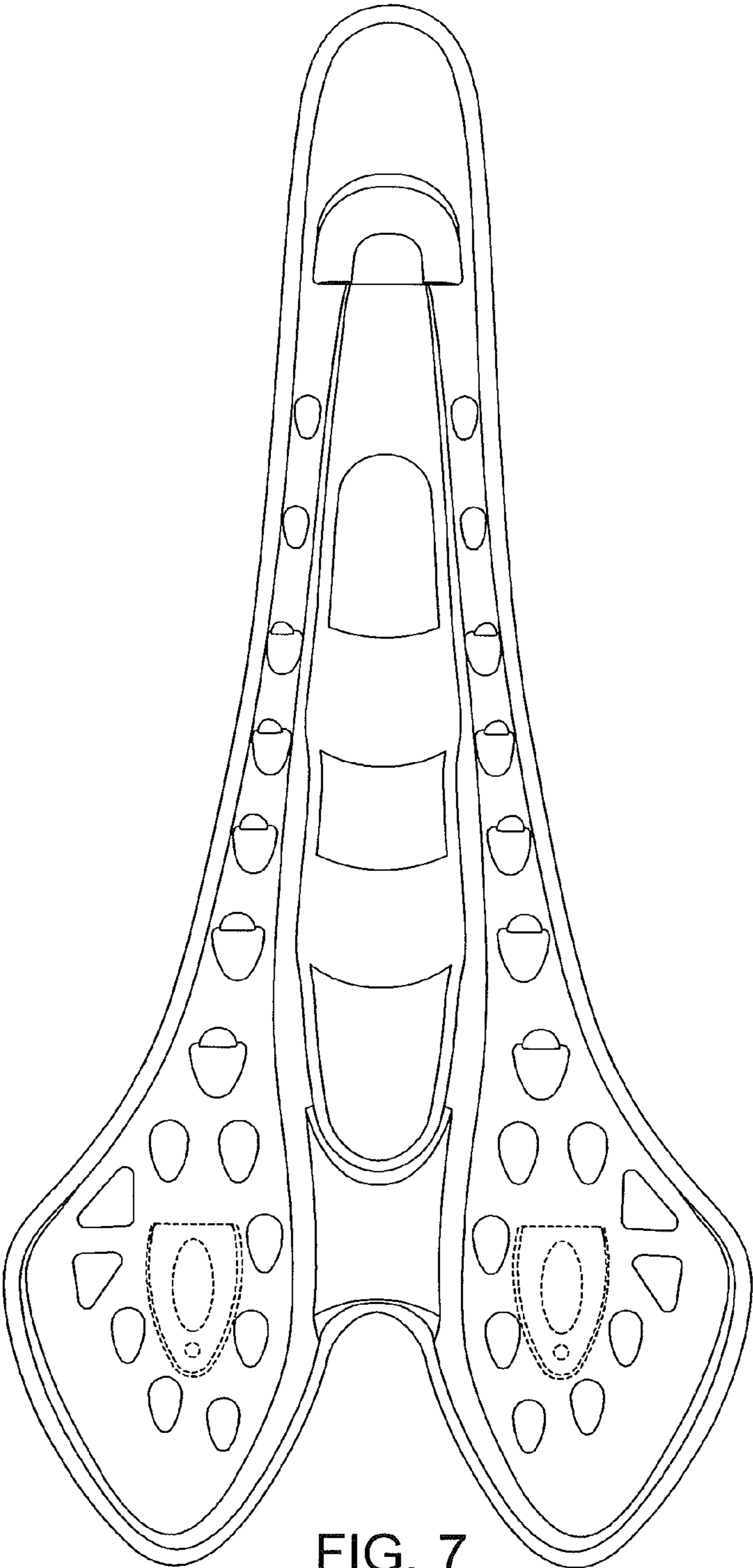
