DESCRIPTION

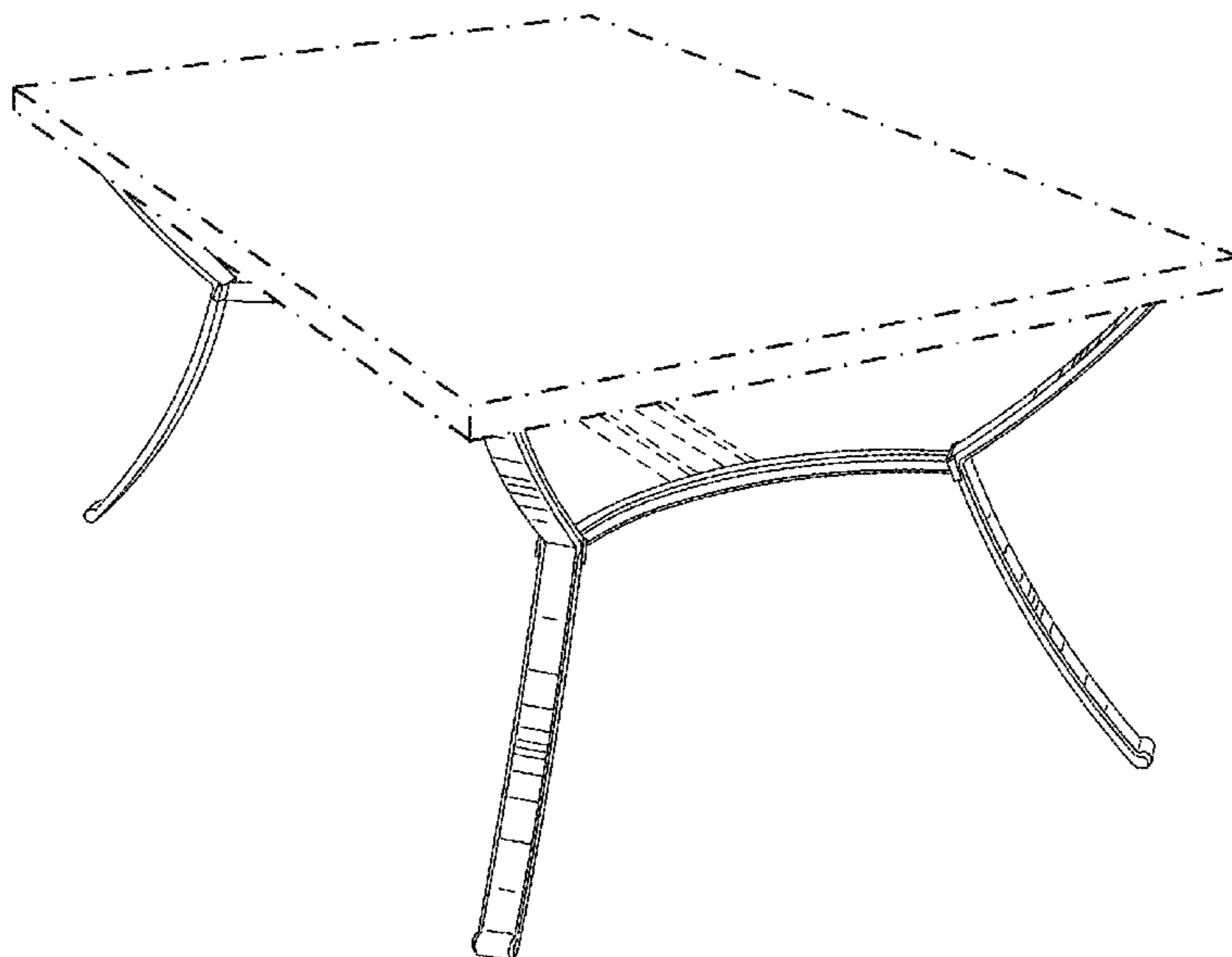
FIG. 1 is a first perspective view of a table base;

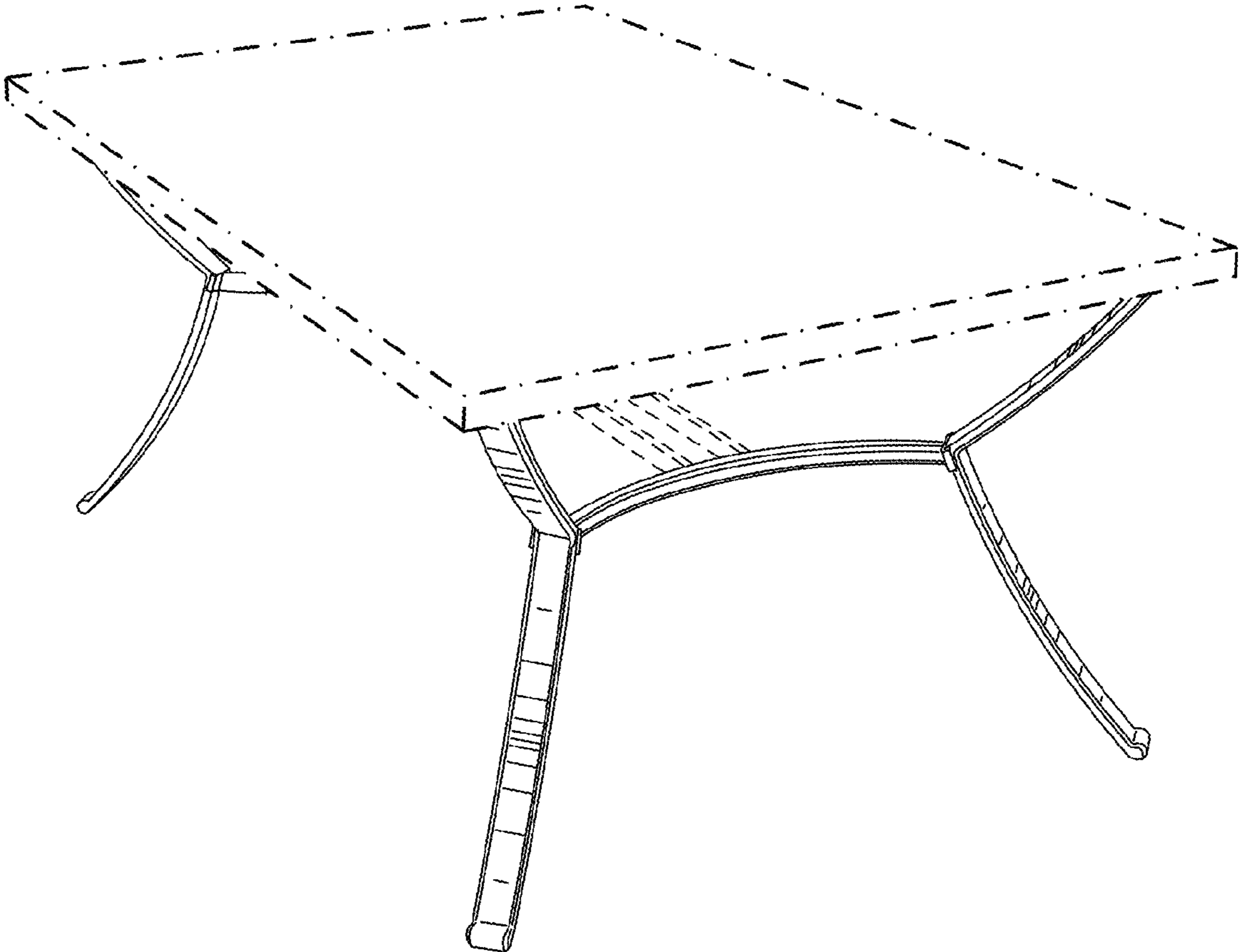

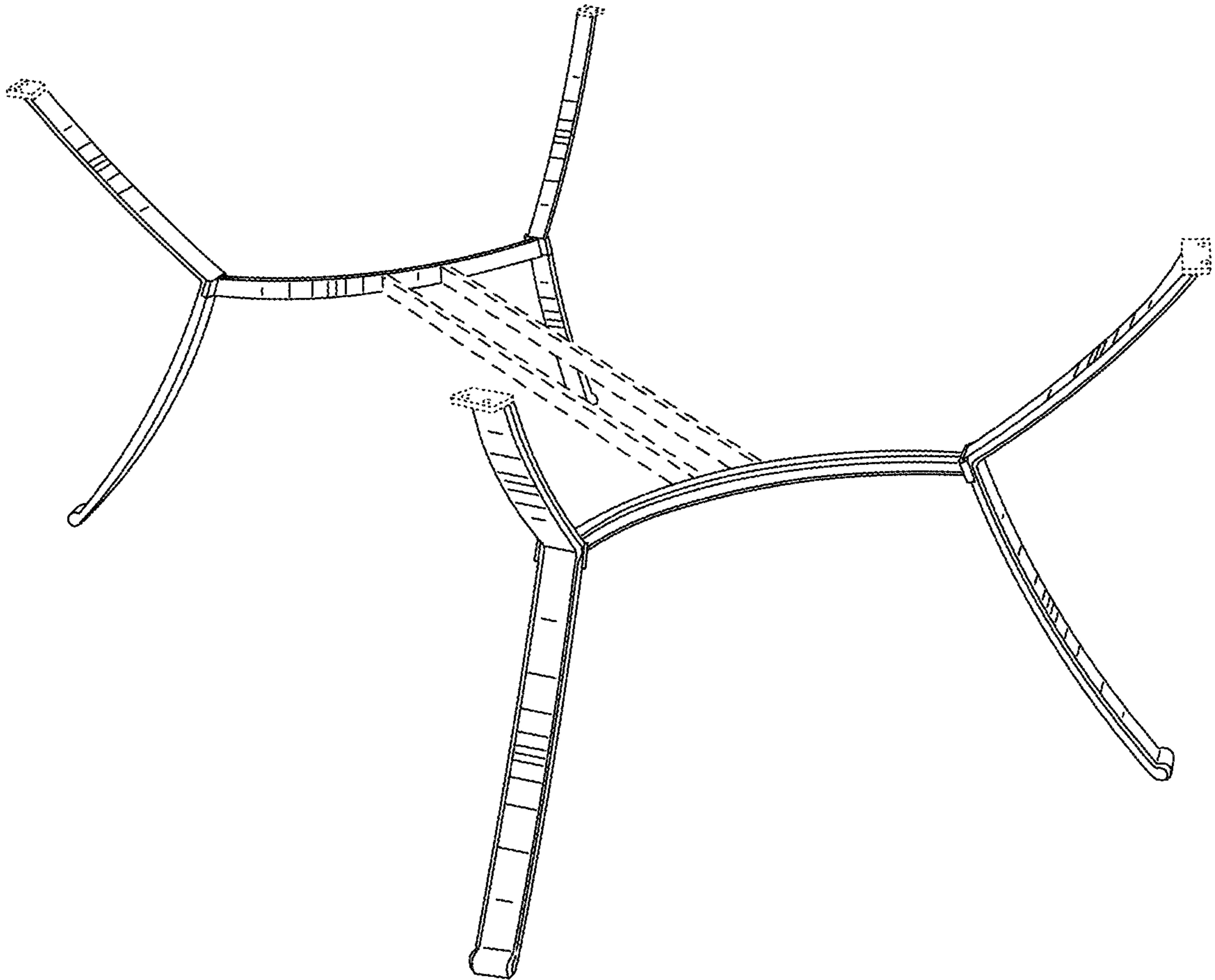

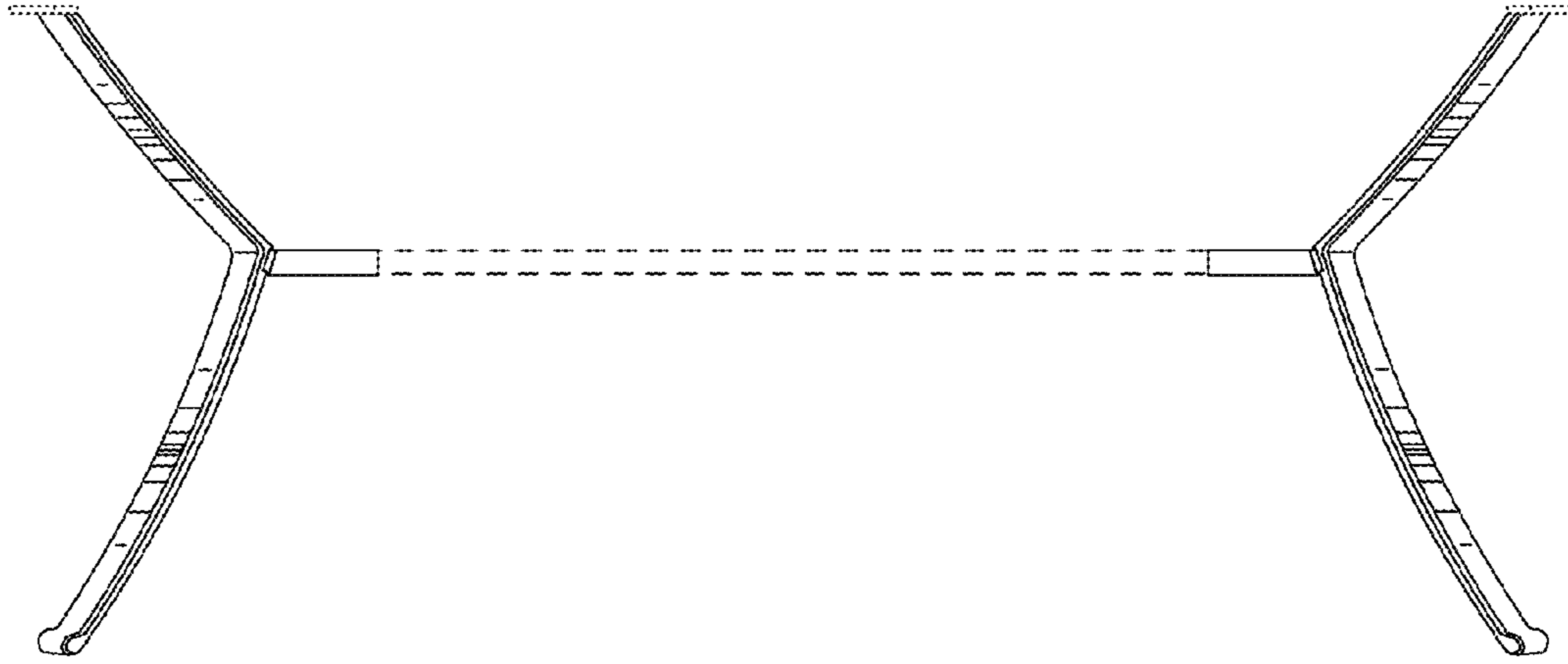

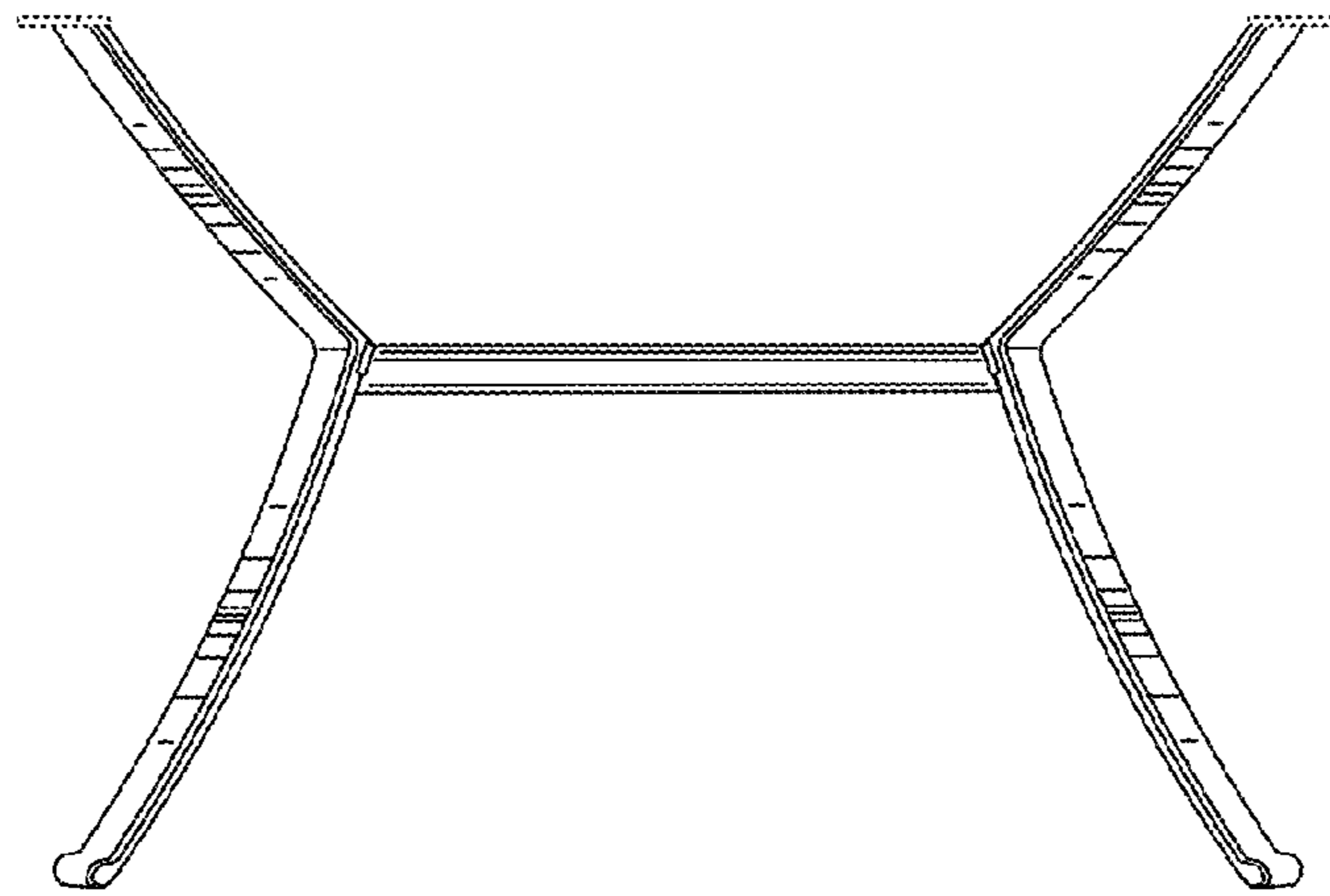

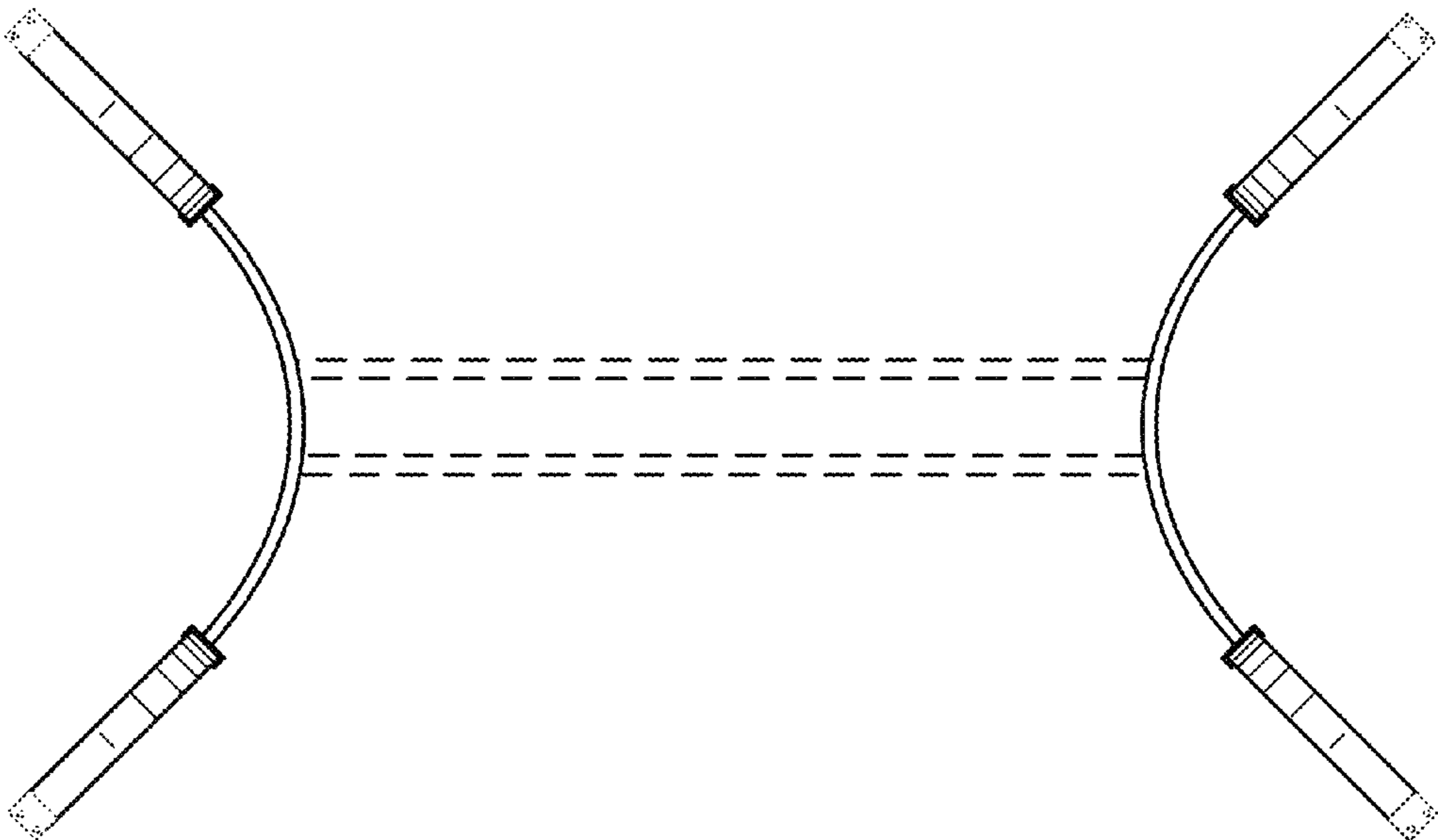

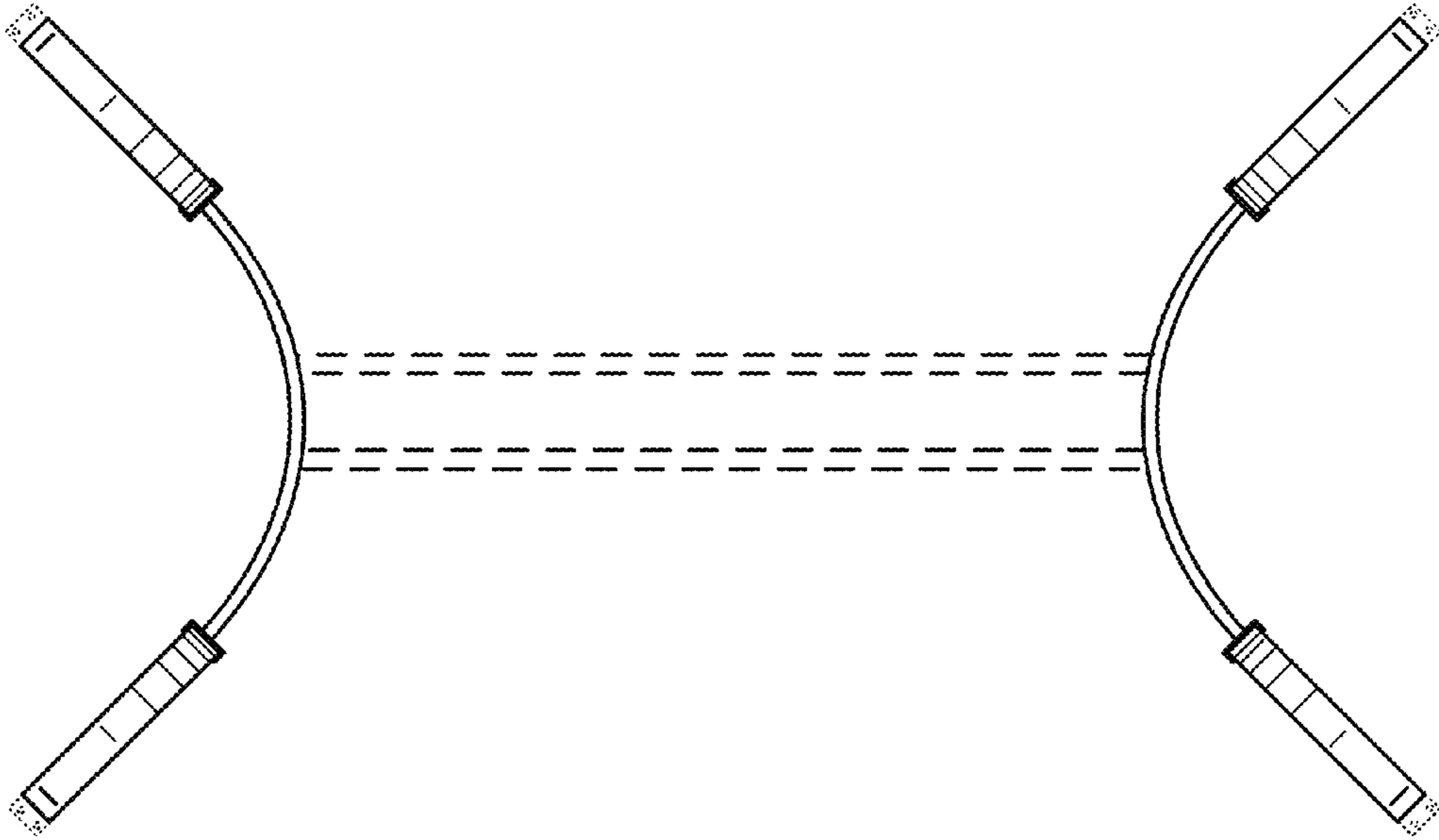
