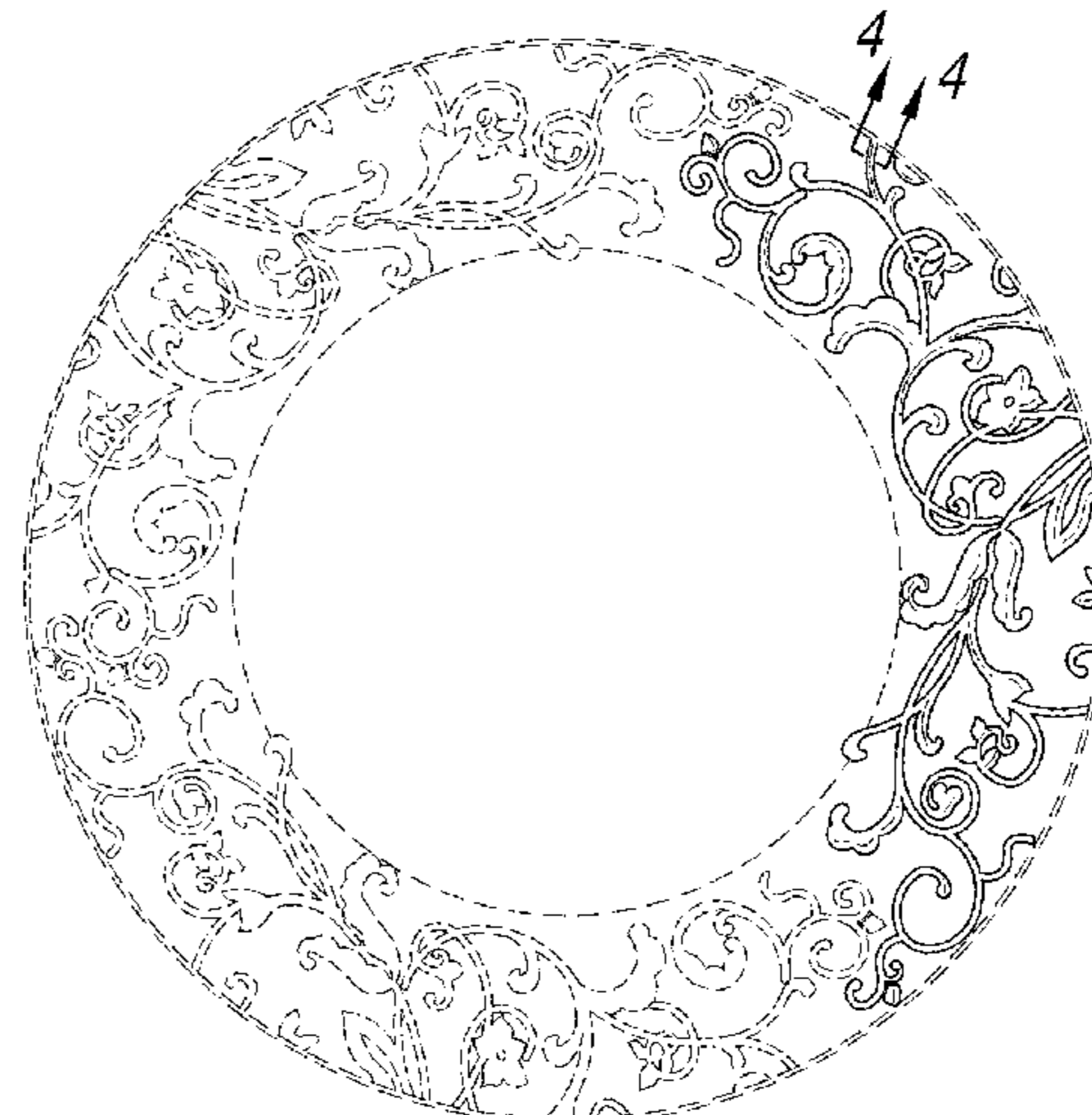
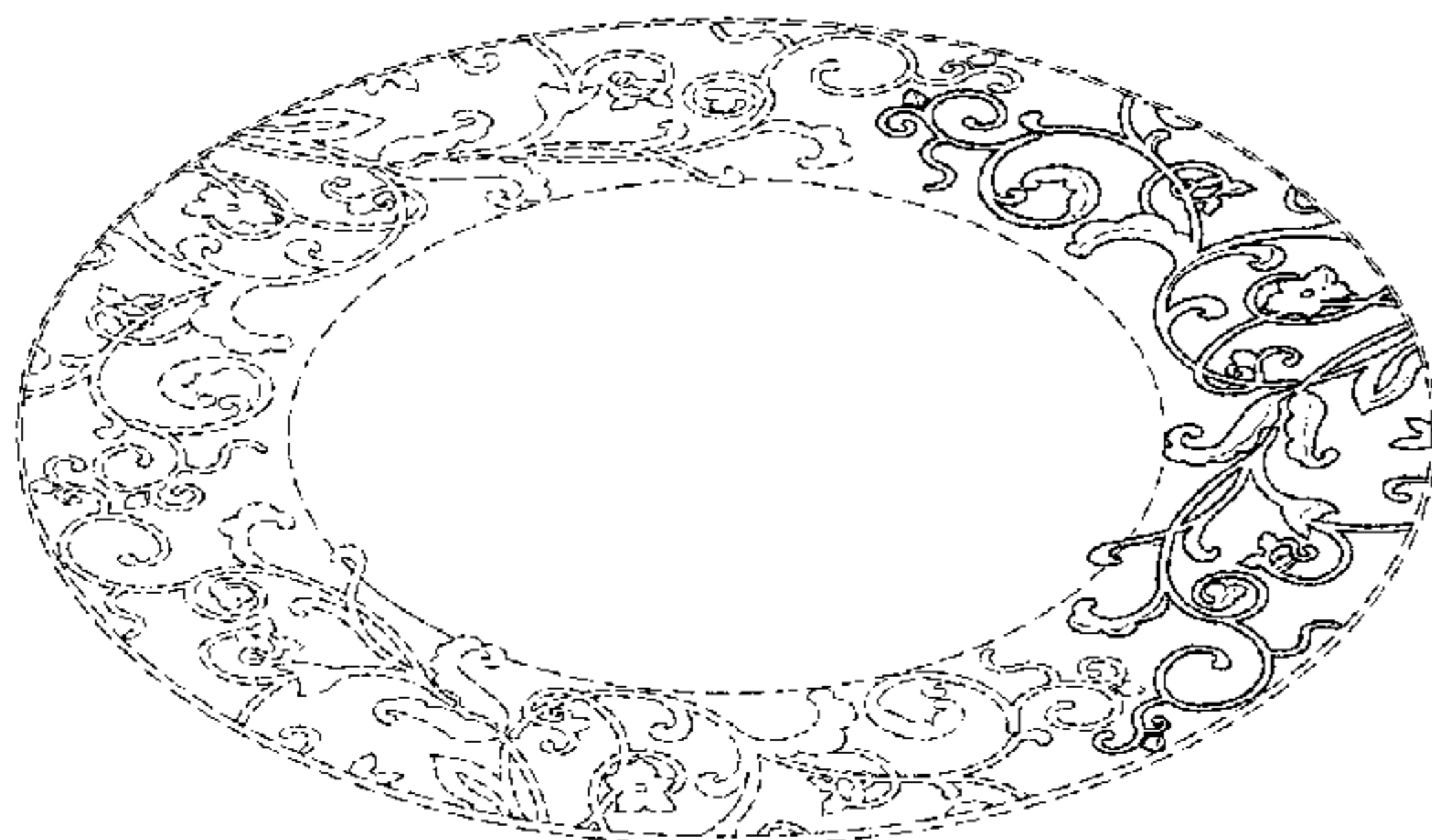
(57) **CLAIM**

We claim the ornamental design for a surface ornamentation for dinnerware, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a surface ornamentation for dinnerware according to the present invention.  
FIG. 2 is a second perspective view of the surface ornamentation for dinnerware of FIG. 1;  
FIG. 3 is a top plan view of the surface ornamentation for dinnerware of FIG. 1;  
FIG. 4 is a cross-sectional view of the surface ornamentation for dinnerware of FIG. 1 taken along the line 4-4;  
FIG. 5 is a front elevation view of the surface ornamentation for dinnerware of FIG. 1, the rear elevation view, and side elevation views being identical images thereof; and,  
FIG. 6 is a bottom plan view of the surface ornamentation for dinnerware of FIG. 1.  
The broken lines form no part of the claimed design.

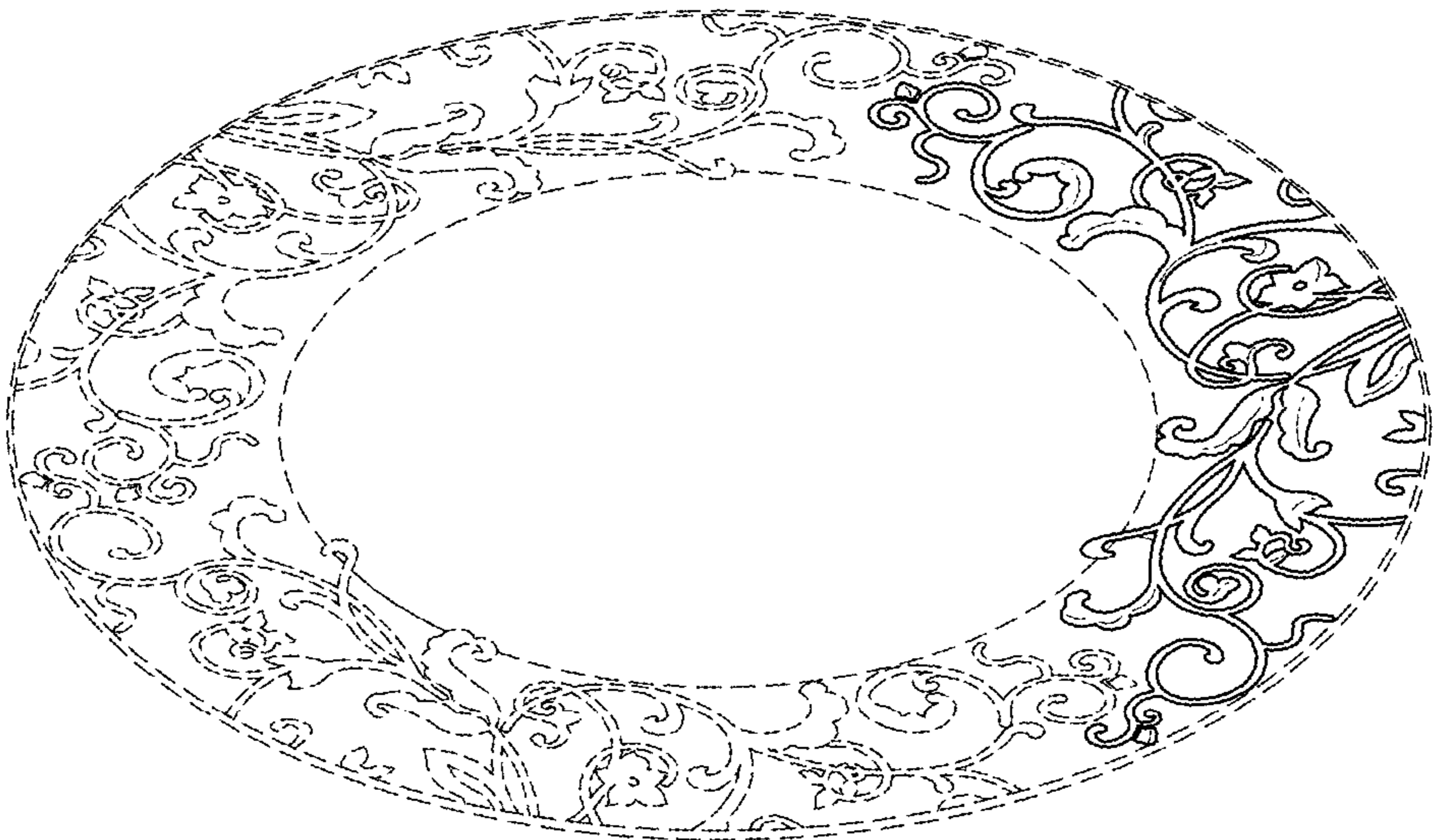

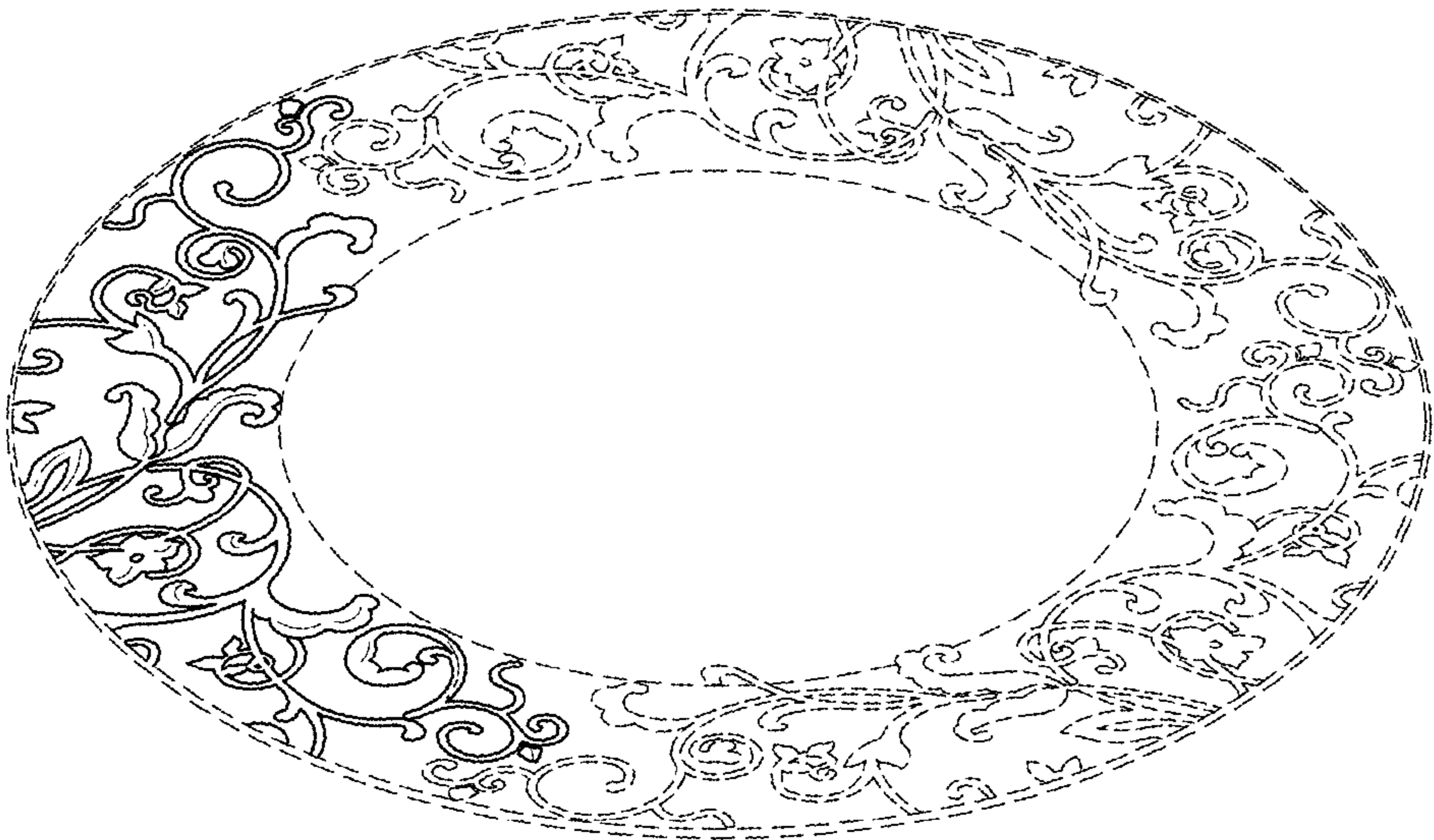
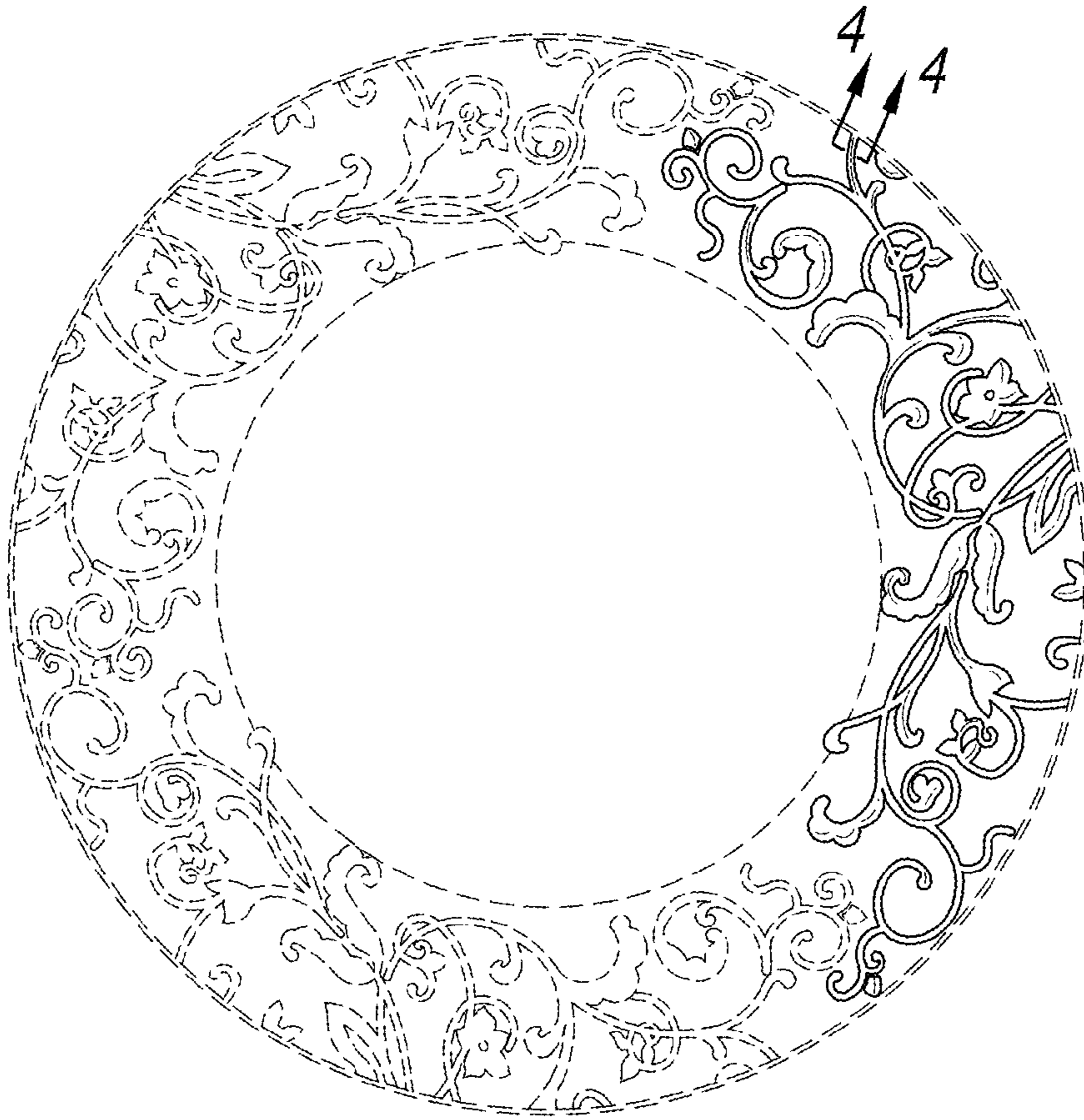
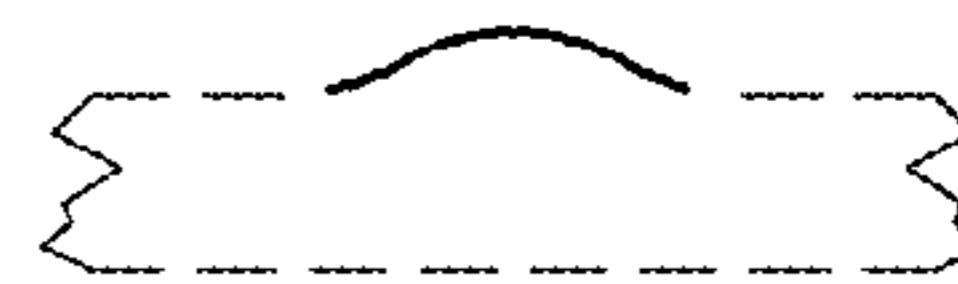


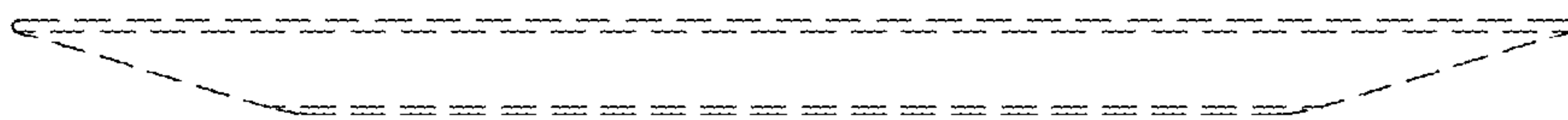

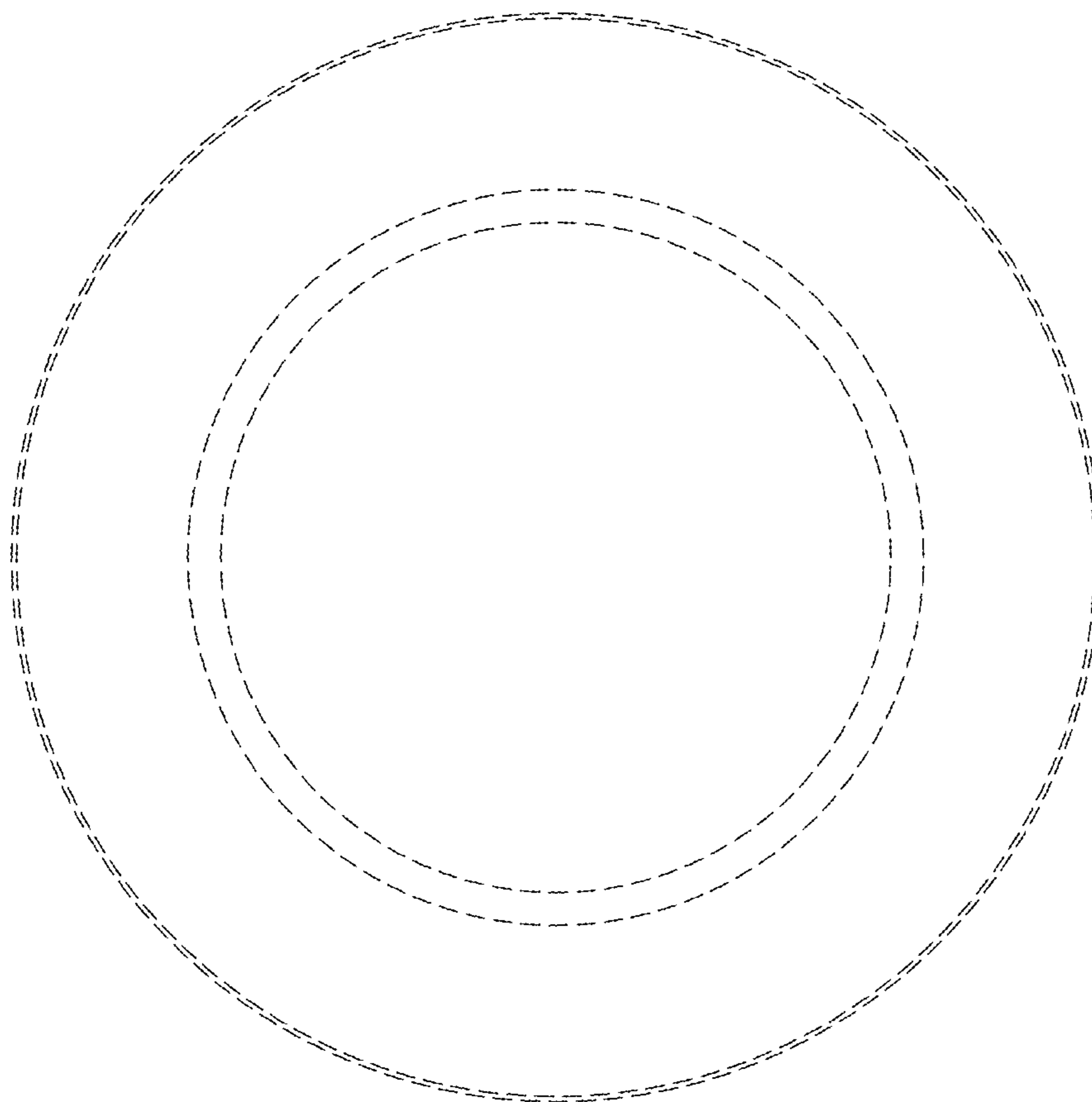
