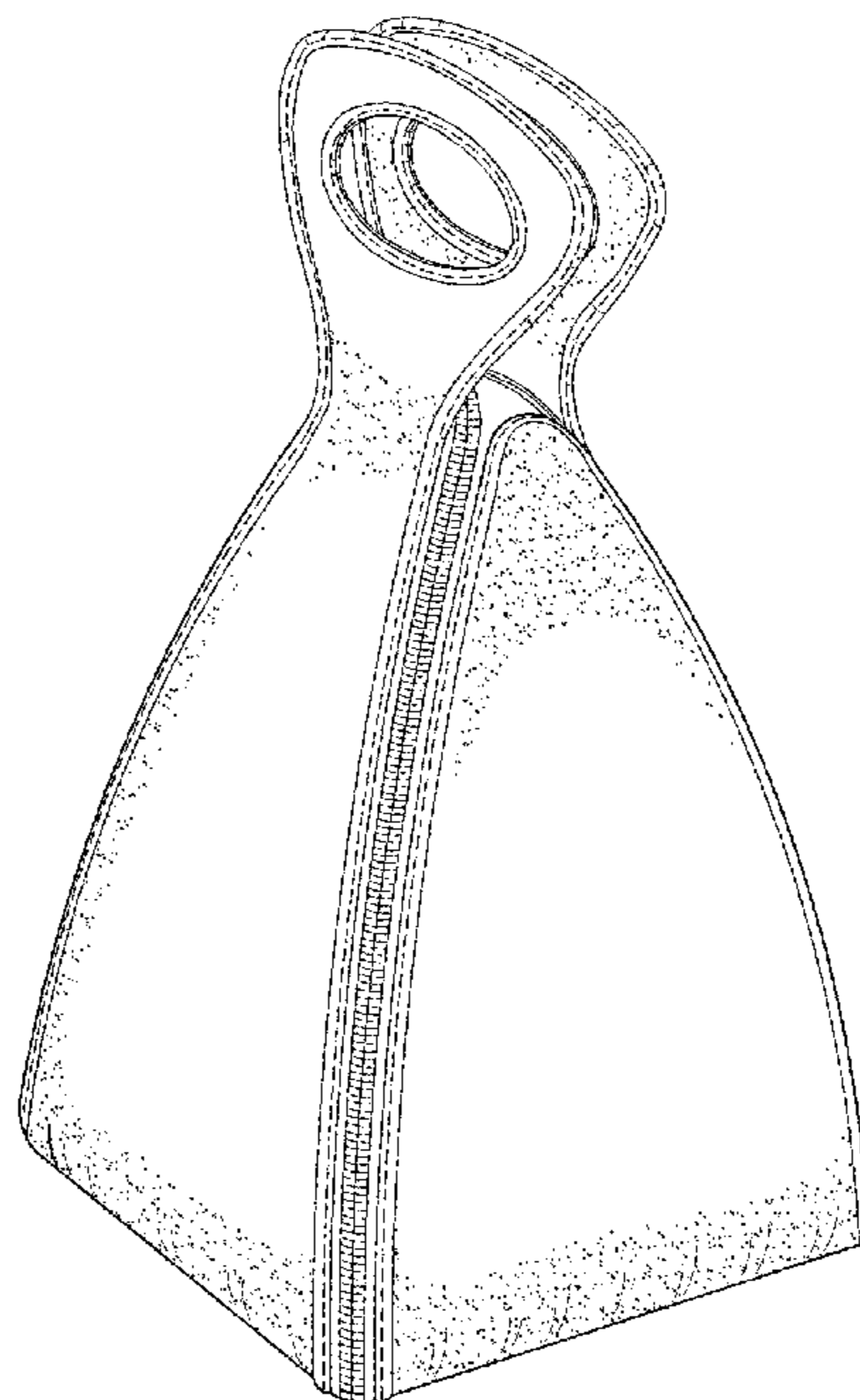
(57) **CLAIM**

The ornamental design for a convertible carry container and protective mat, as shown and described.

DESCRIPTION

FIG. 1 is front, top prospective view of a convertible carry container and protective mat showing our new design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof, the rear elevational view being identical thereto; FIG. 5 is a right side elevational view thereof, the left side elevational view identical thereto; FIG. 6 is a bottom plan view of the convertible carry container and protective mat shown in a fully opened position; and, FIG. 7 is a top plan view of the convertible carry container and protective mat shown in the fully opened position. The broken lines throughout the drawing figures illustrate stitching.

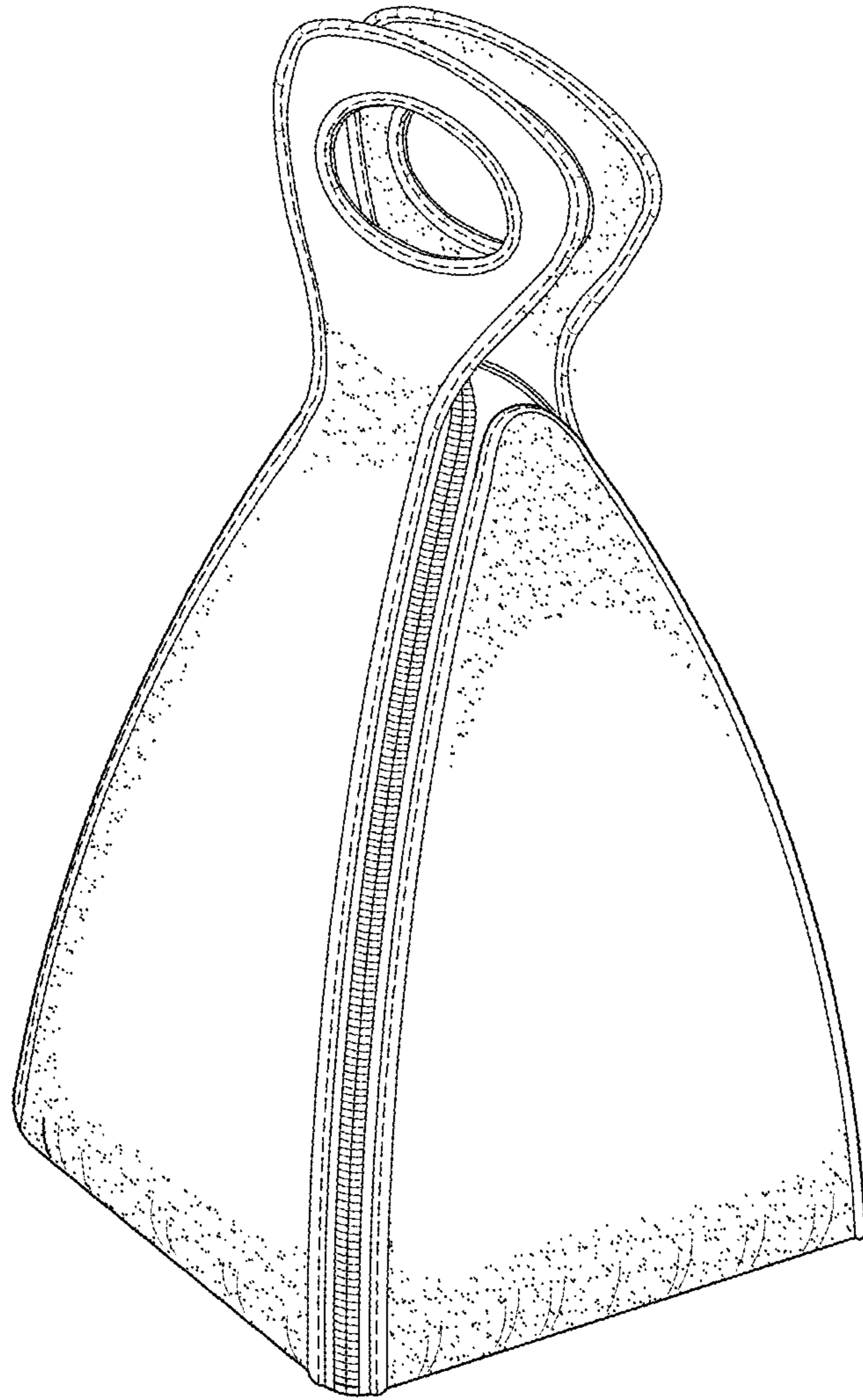

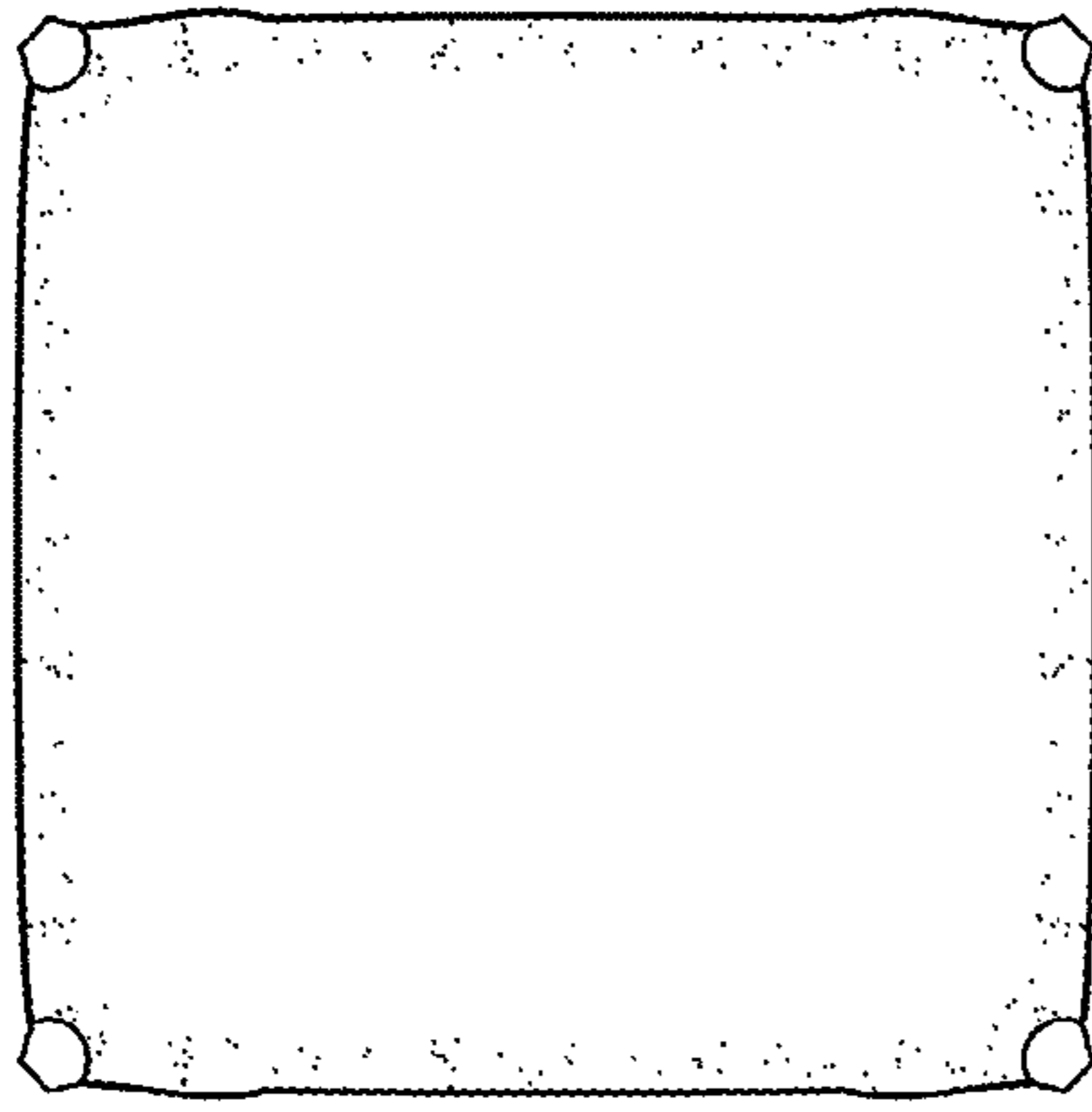

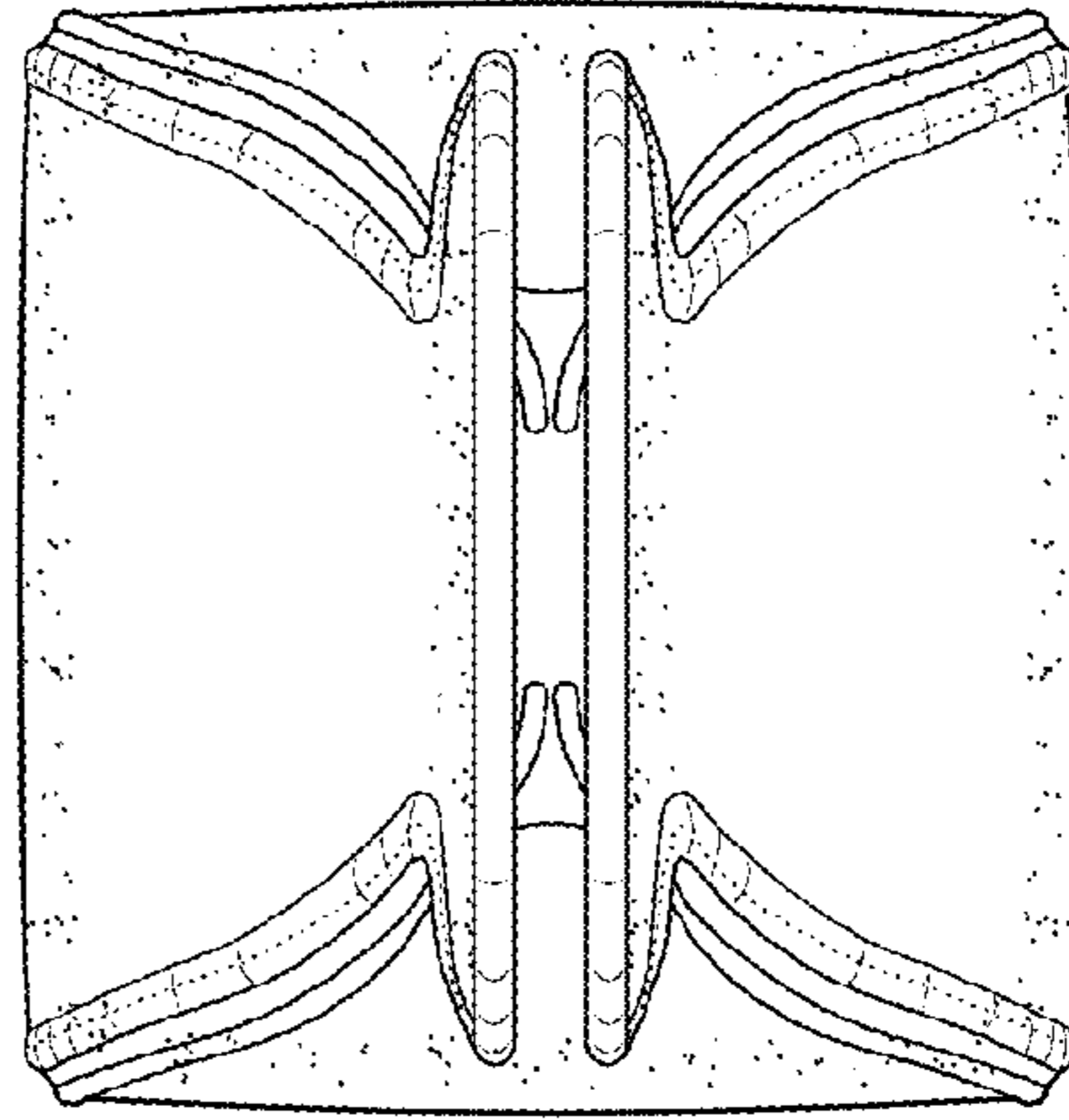

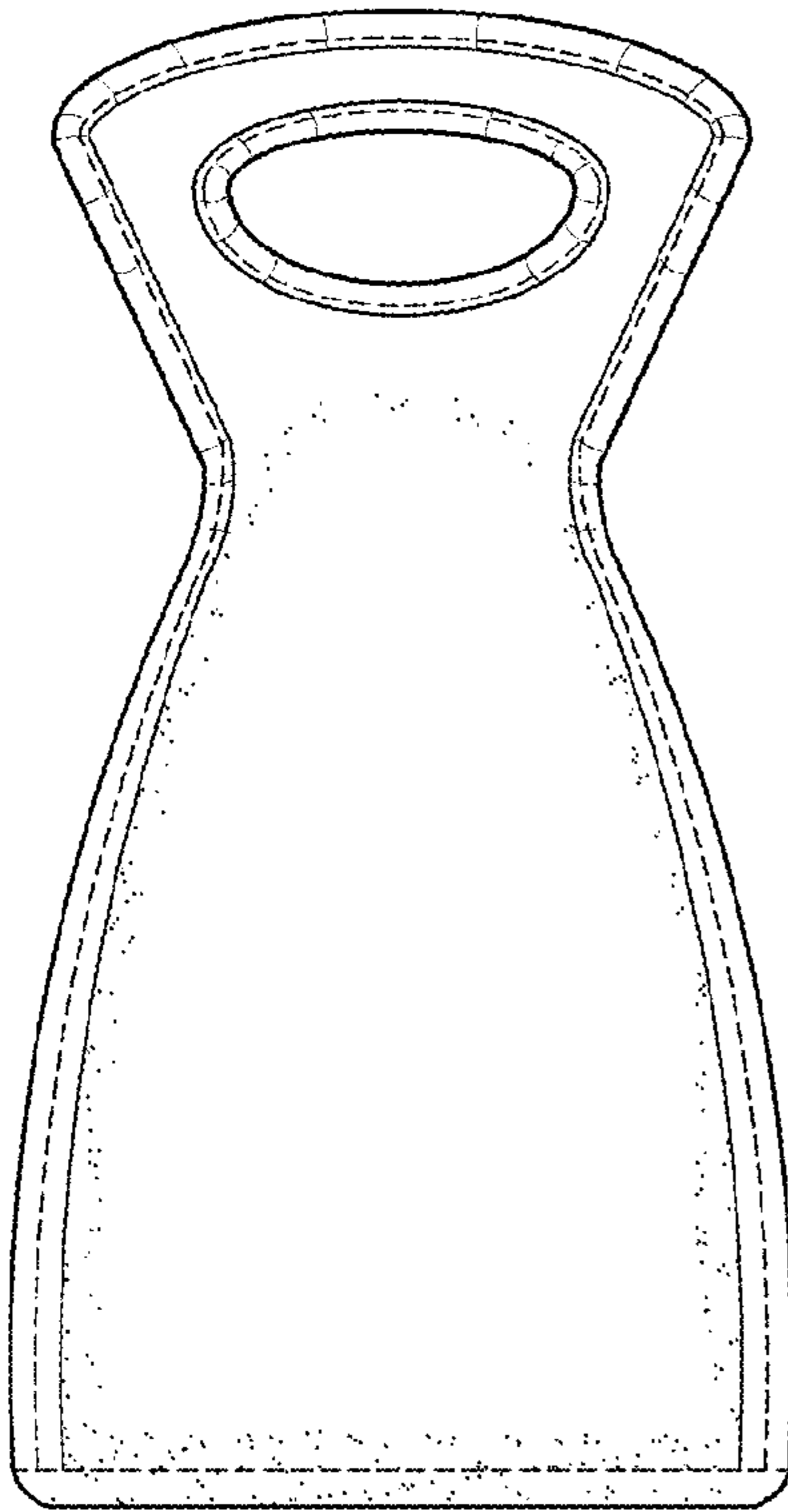

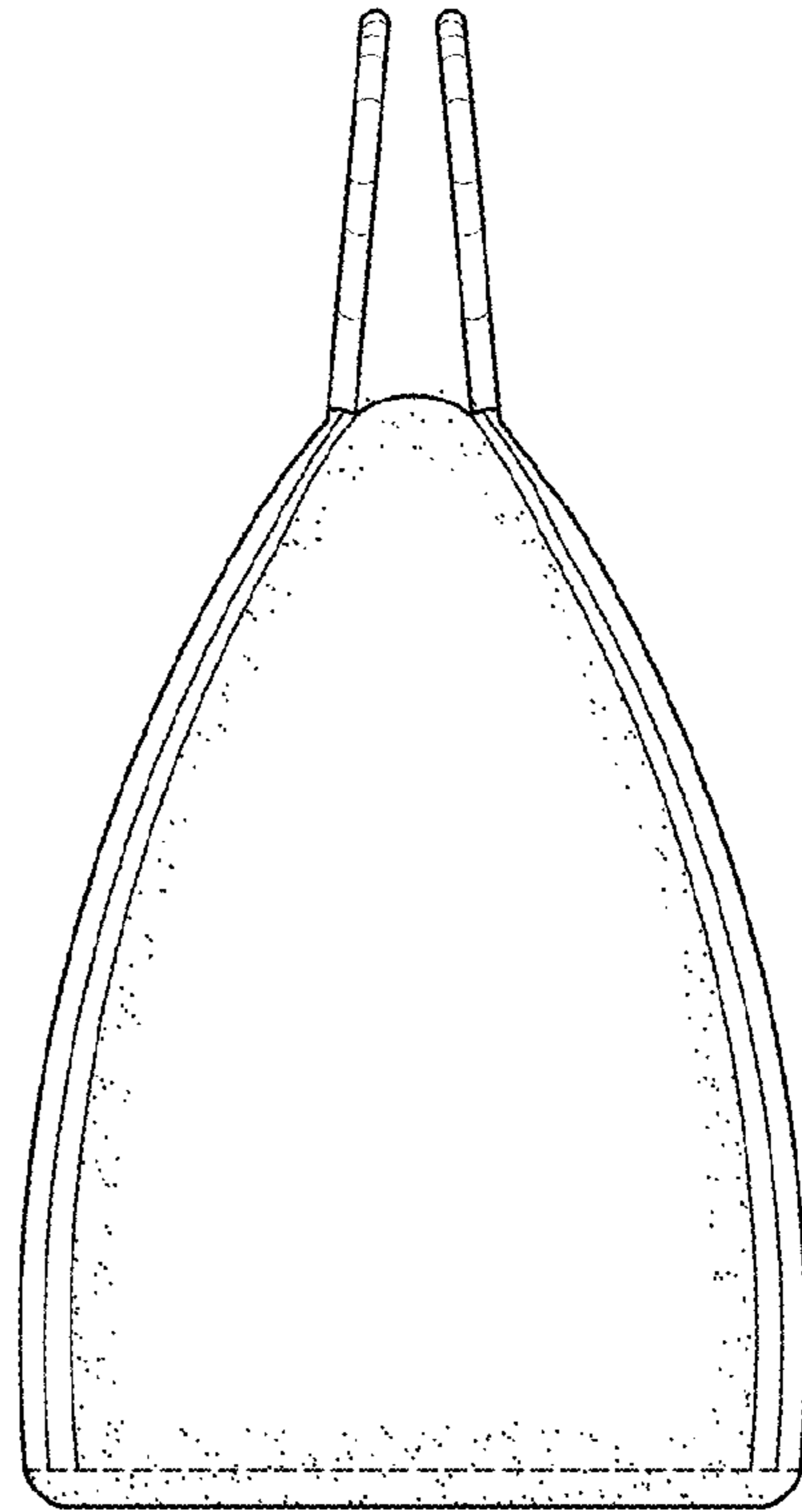

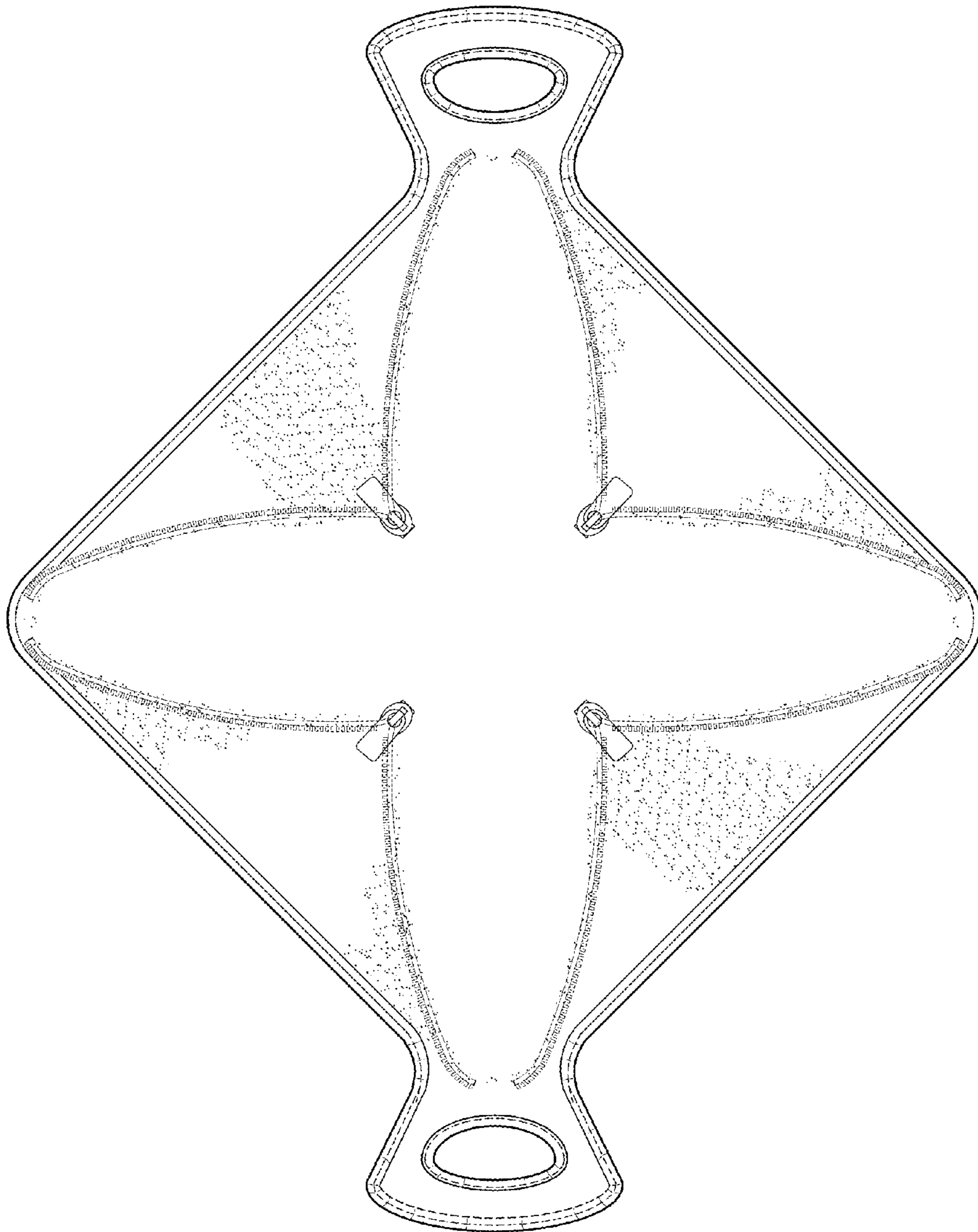

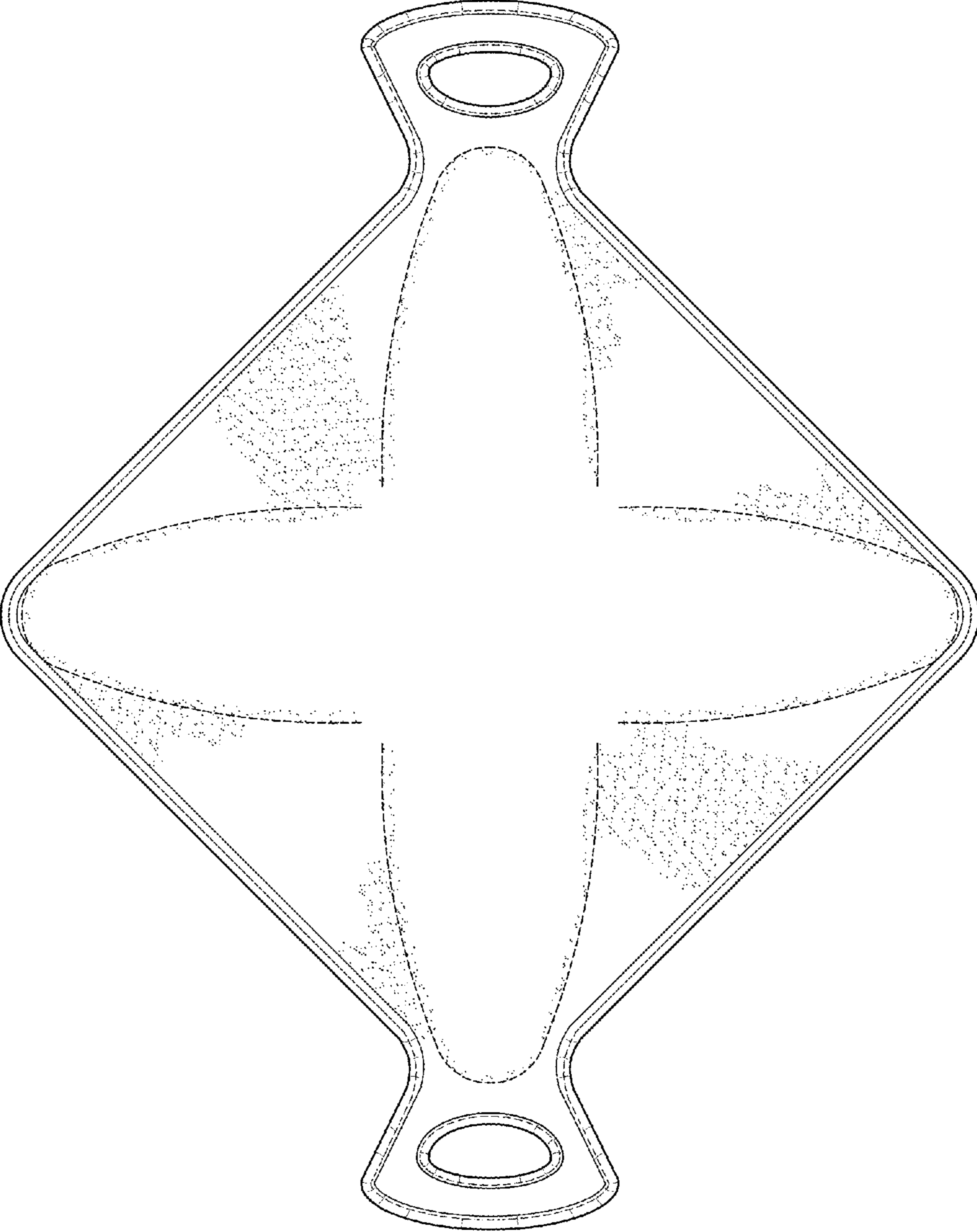
