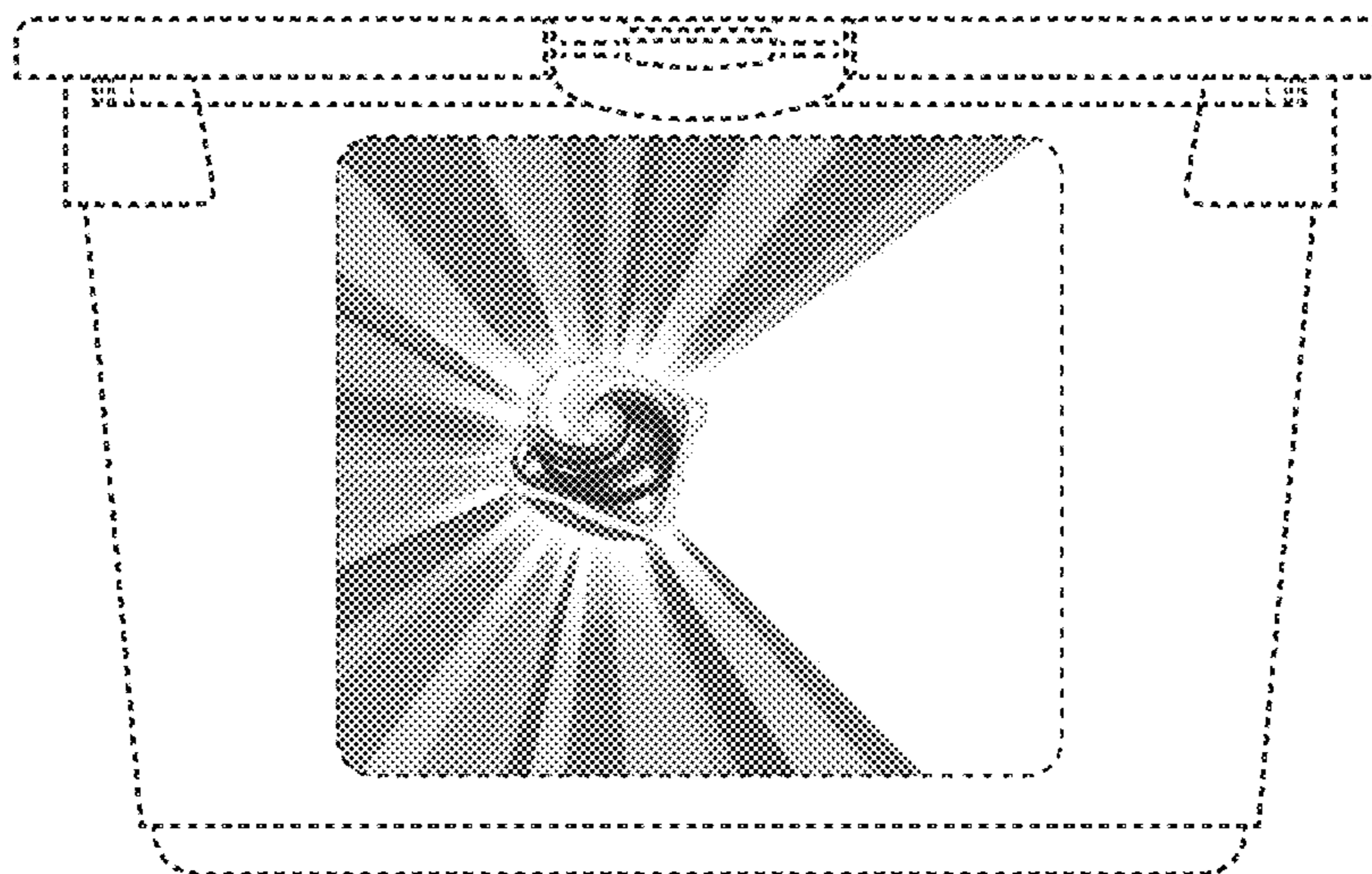
The container with ornamentation, as shown and described.

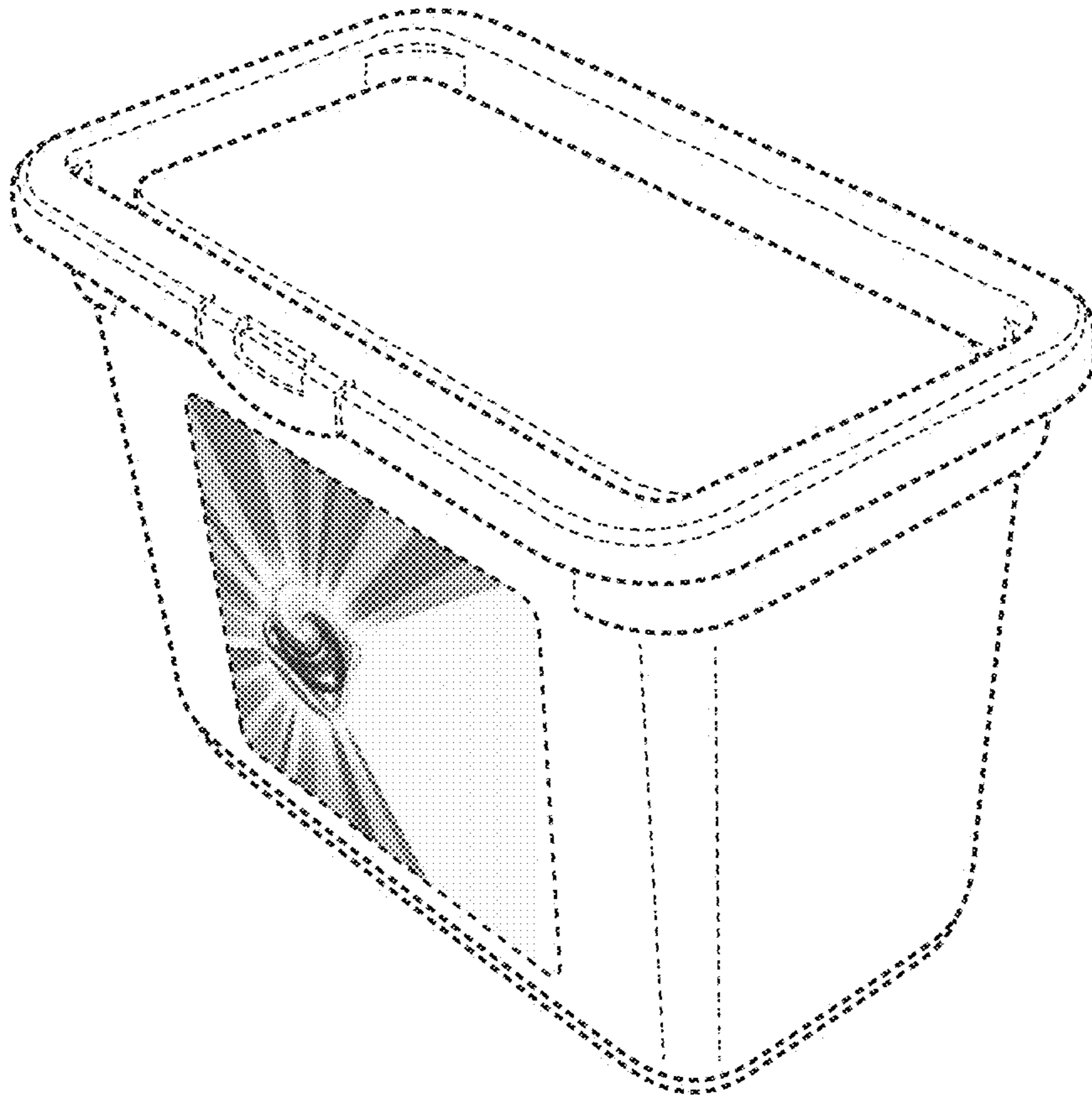

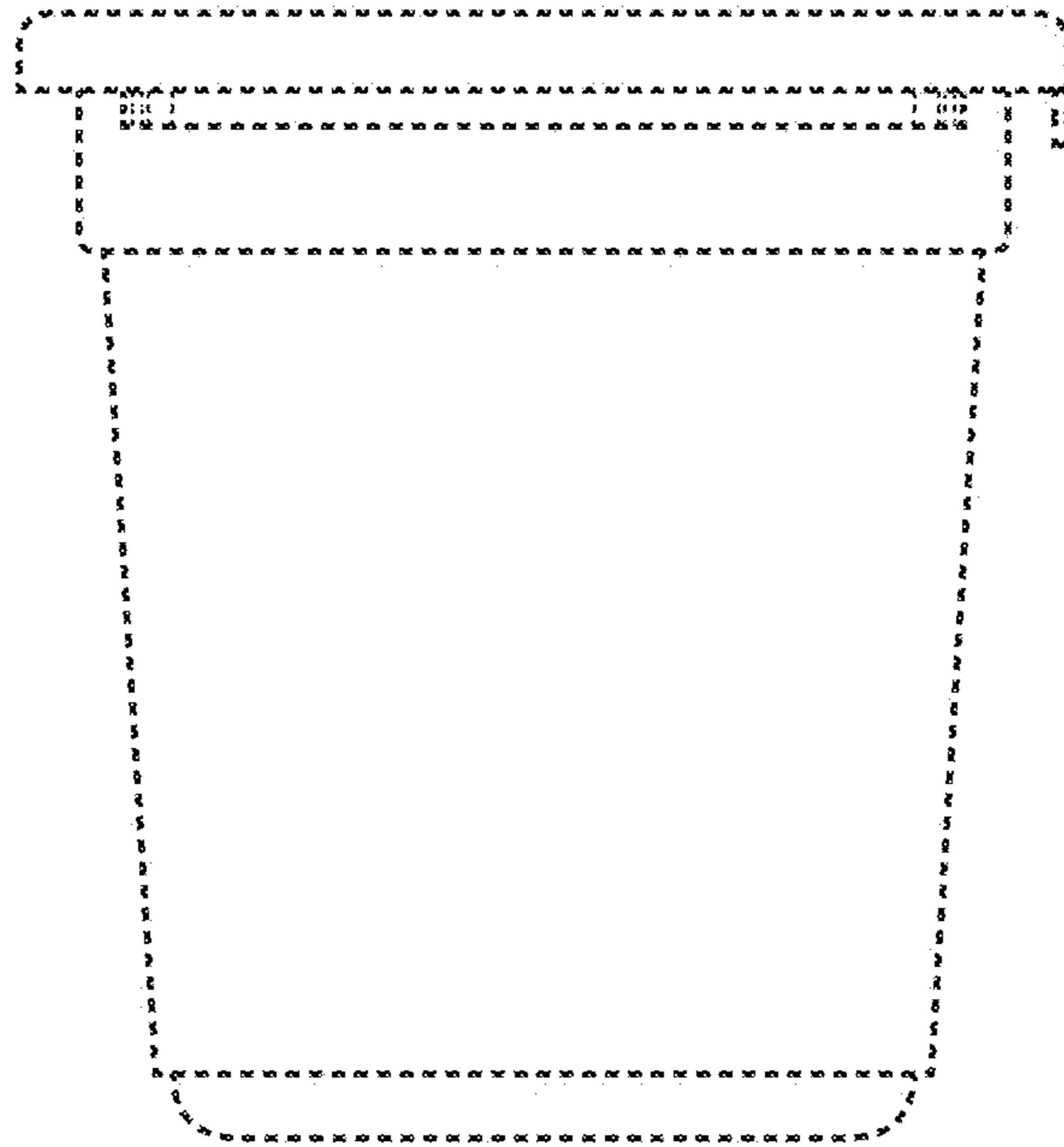

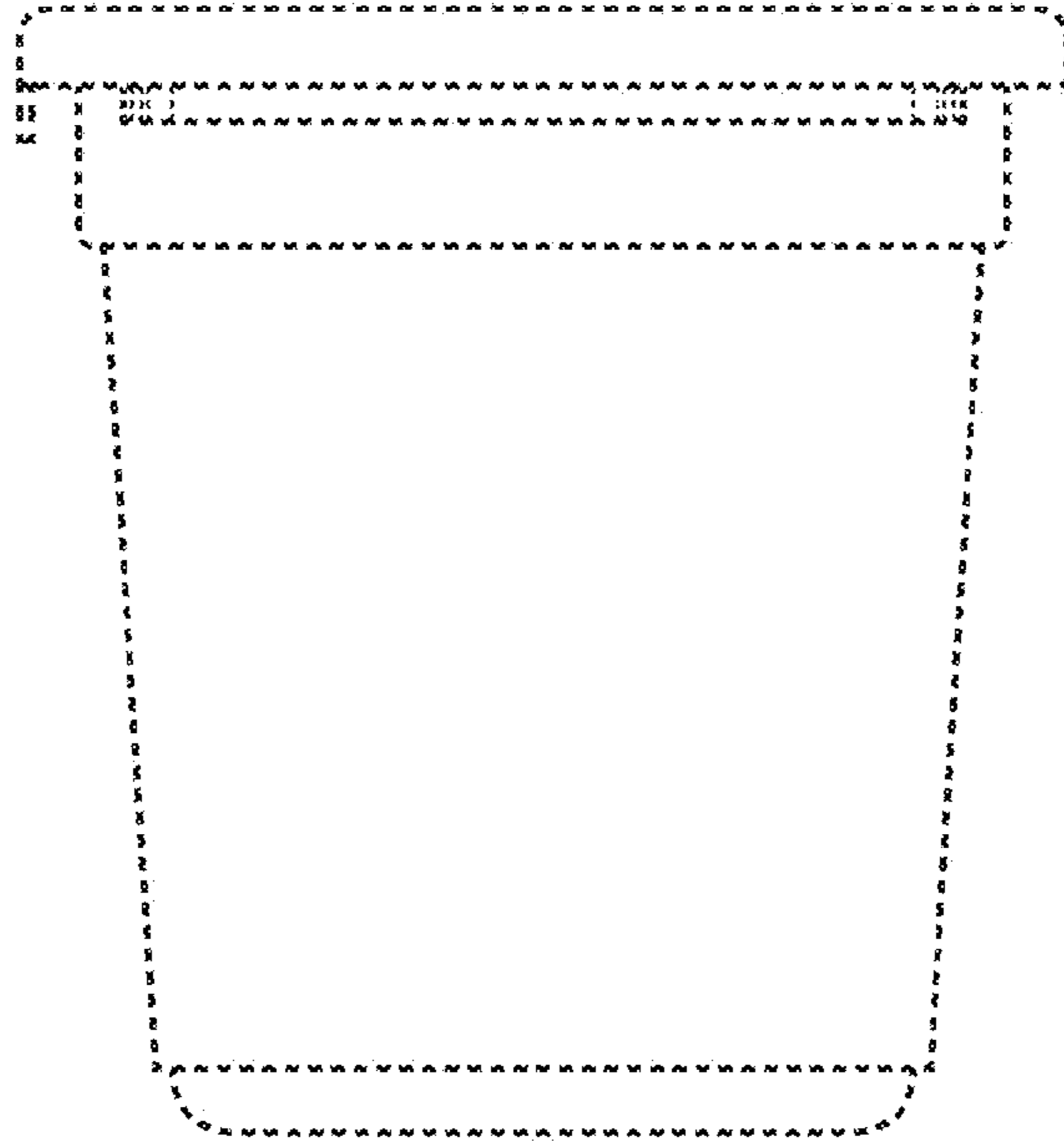

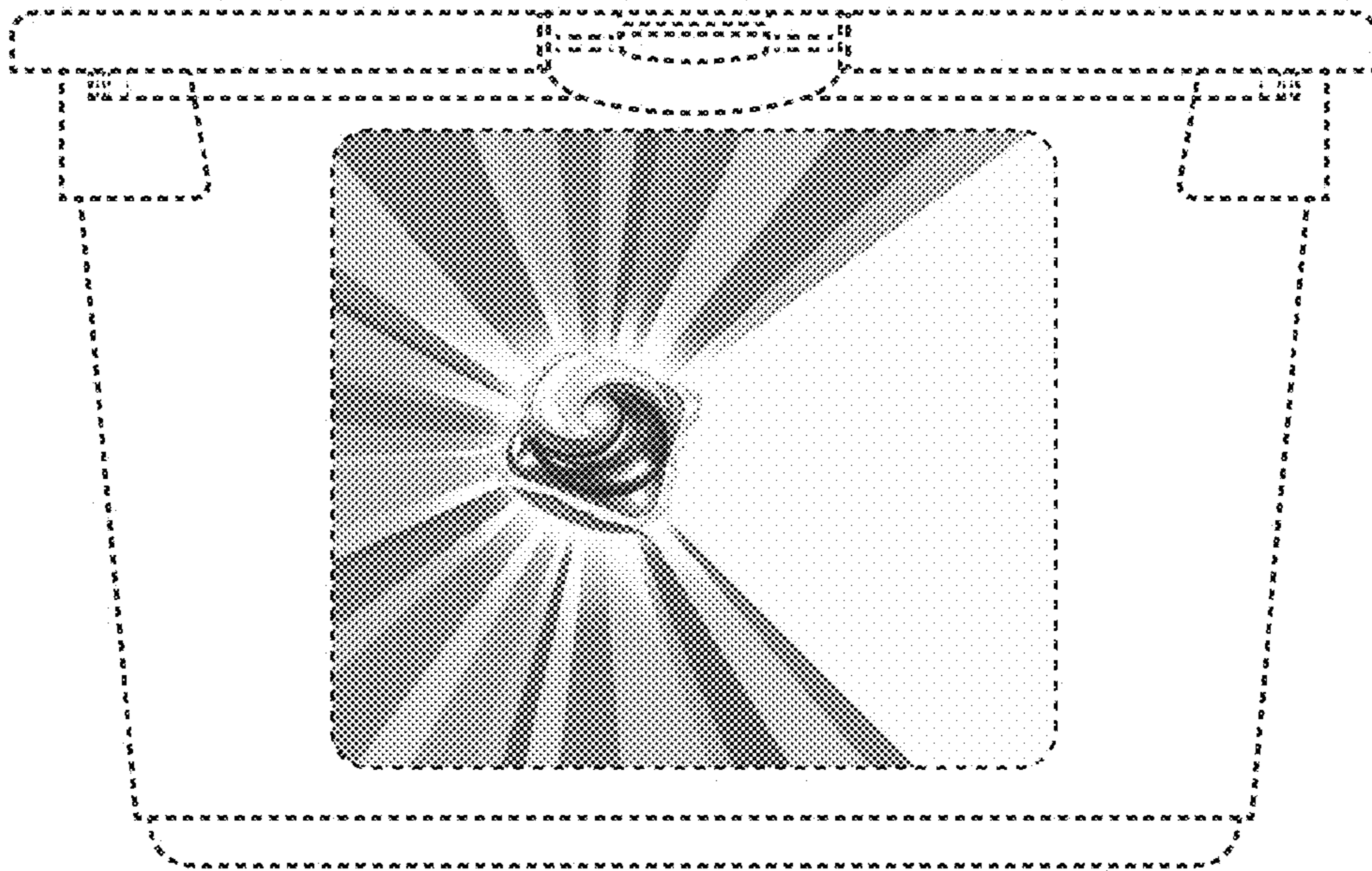

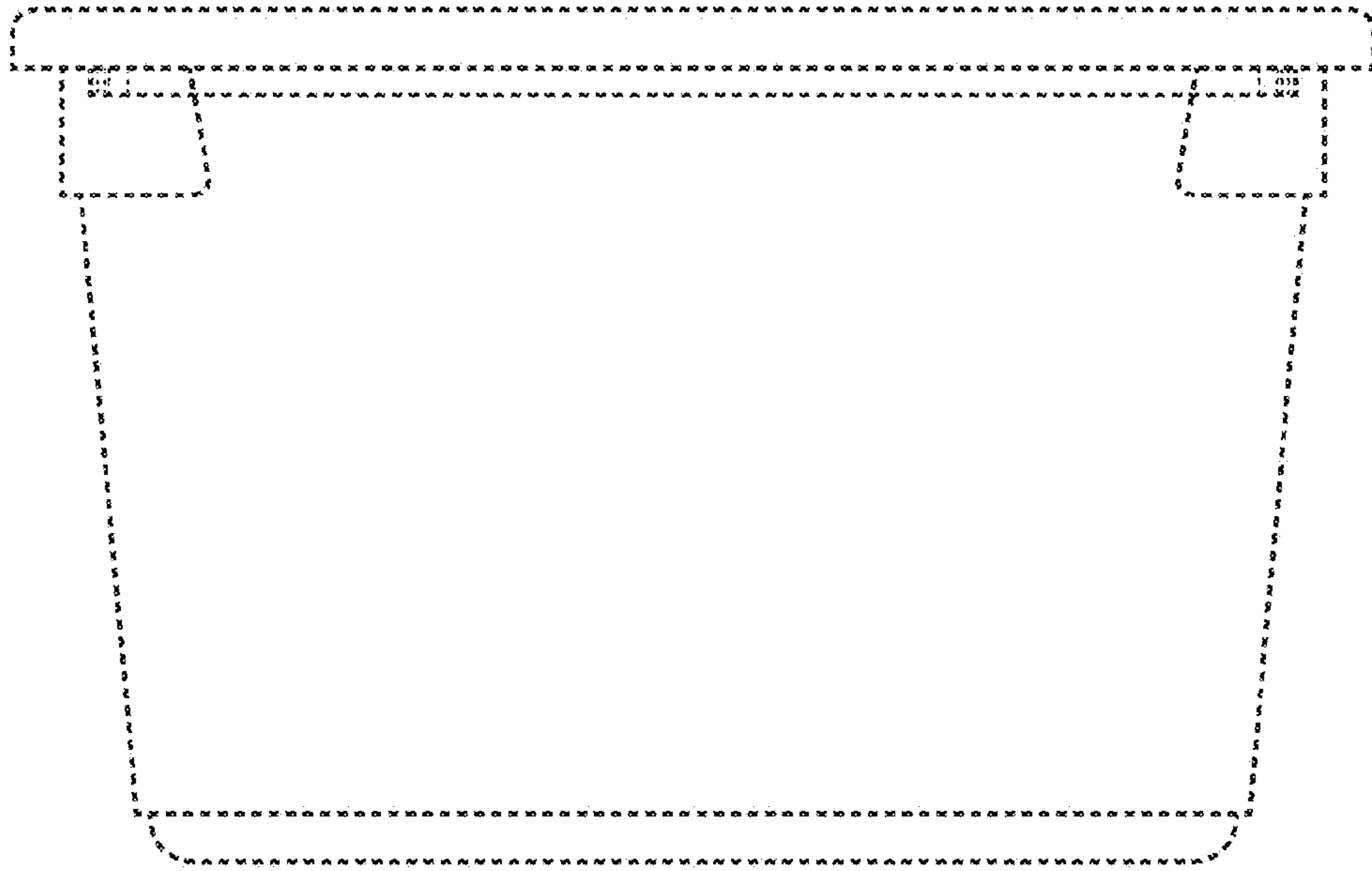

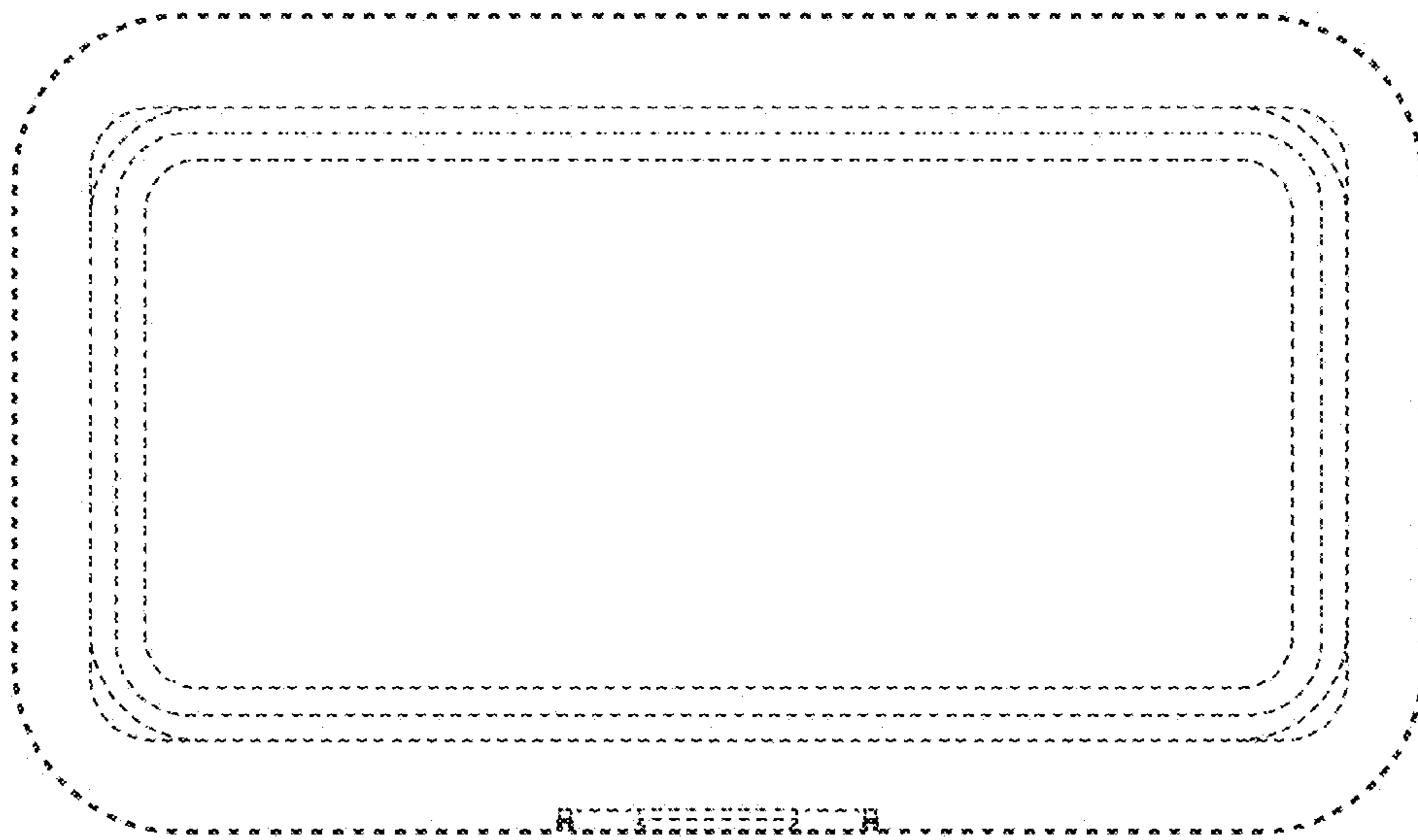

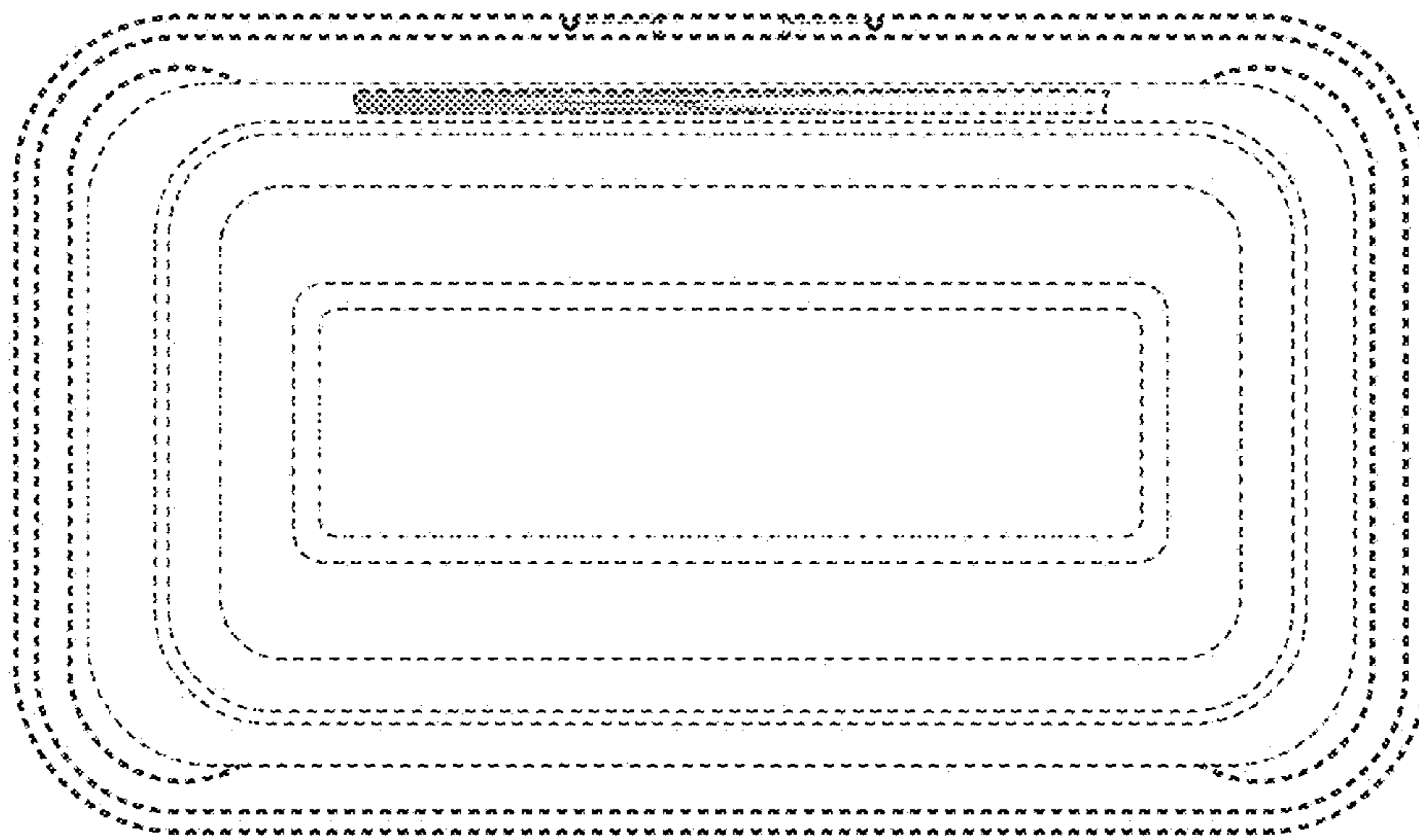
