The ornamental design for a cosmetic container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cosmetic container of the present disclosure;

FIG. 2 is a front elevation view of the cosmetic container shown in FIG. 1;

FIG. 3 is a rear elevation view of the cosmetic container shown in FIG. 1;

FIG. 4 is a left side elevation view of the cosmetic container shown in FIG. 1;

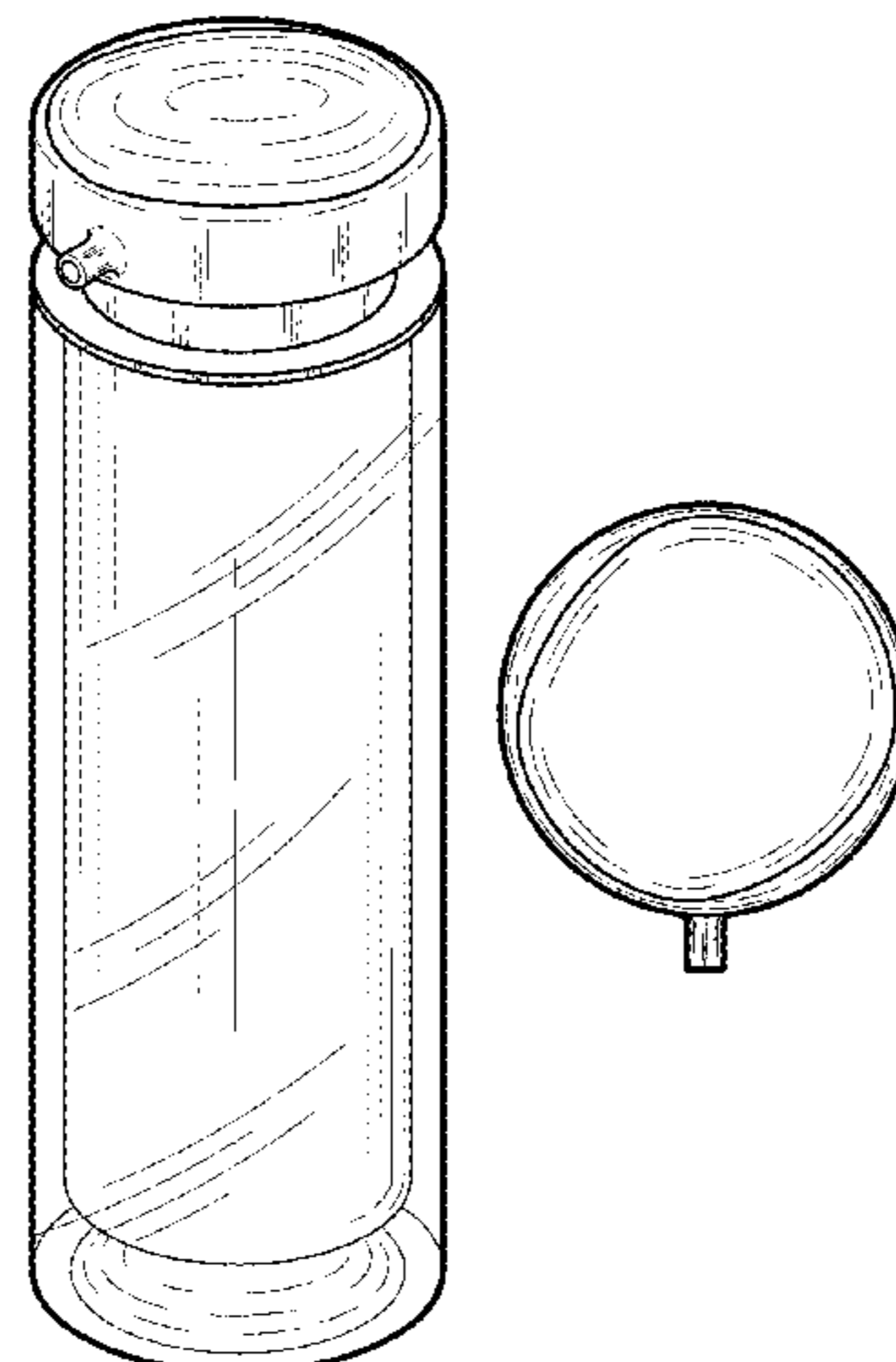

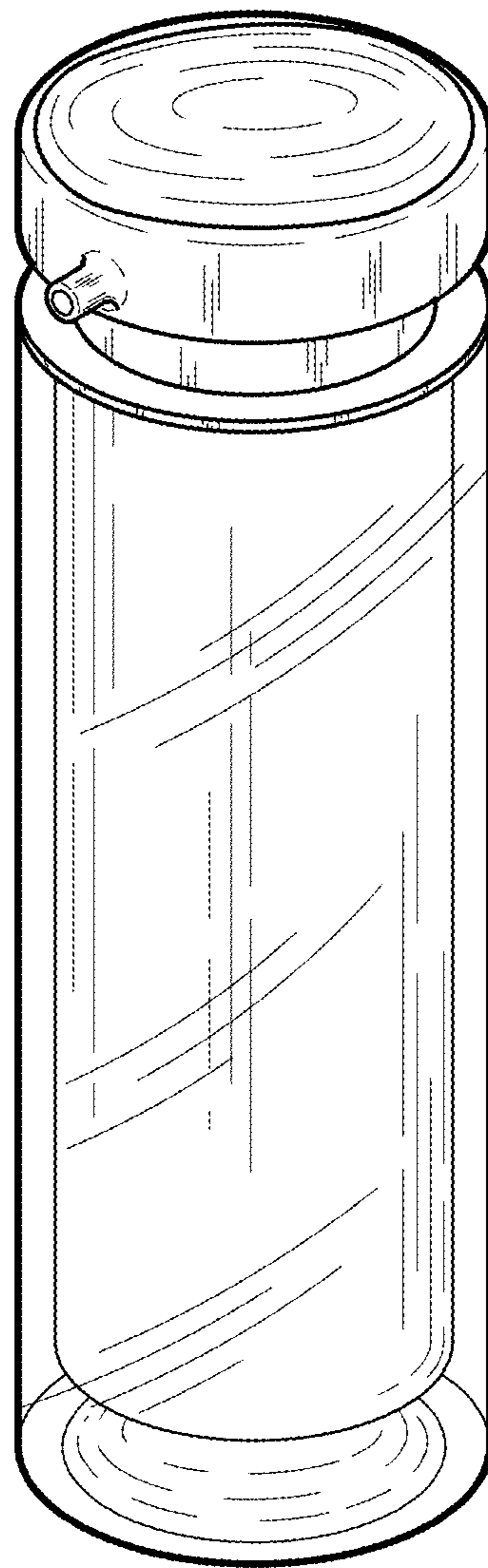

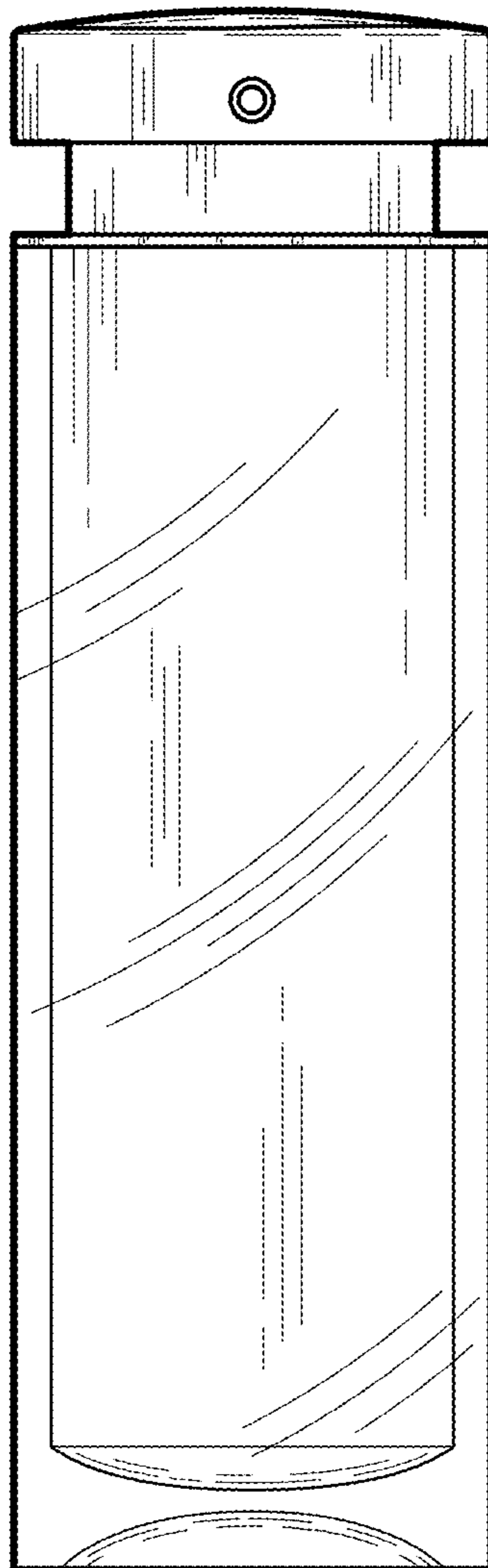

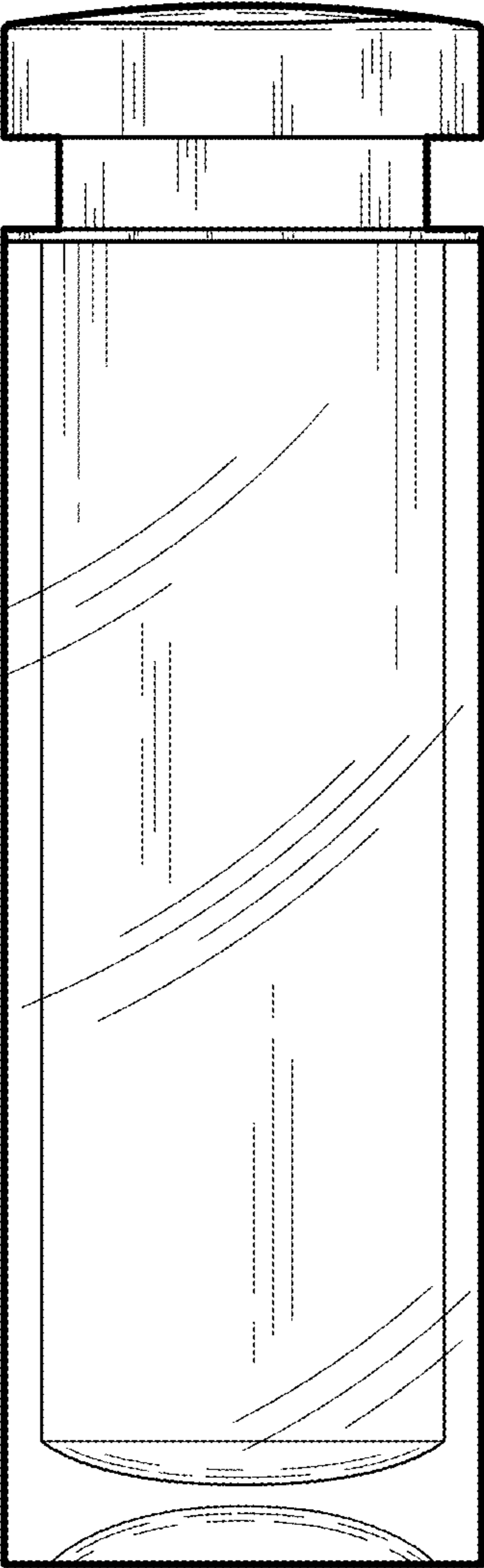

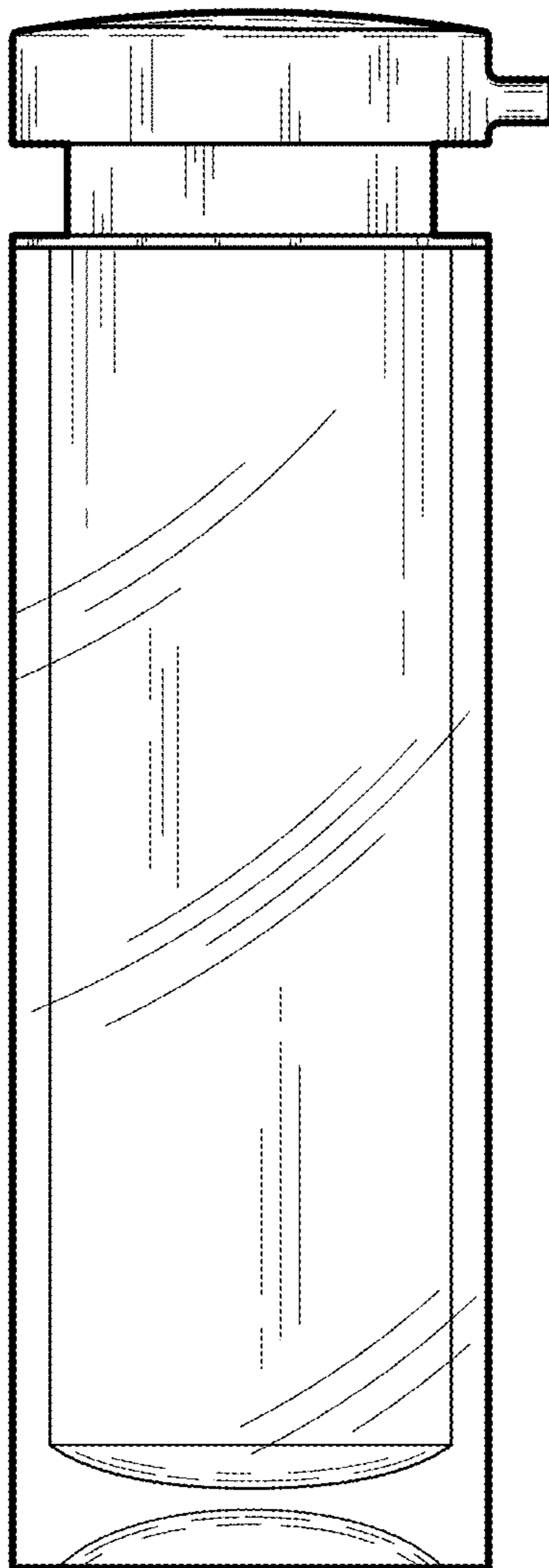

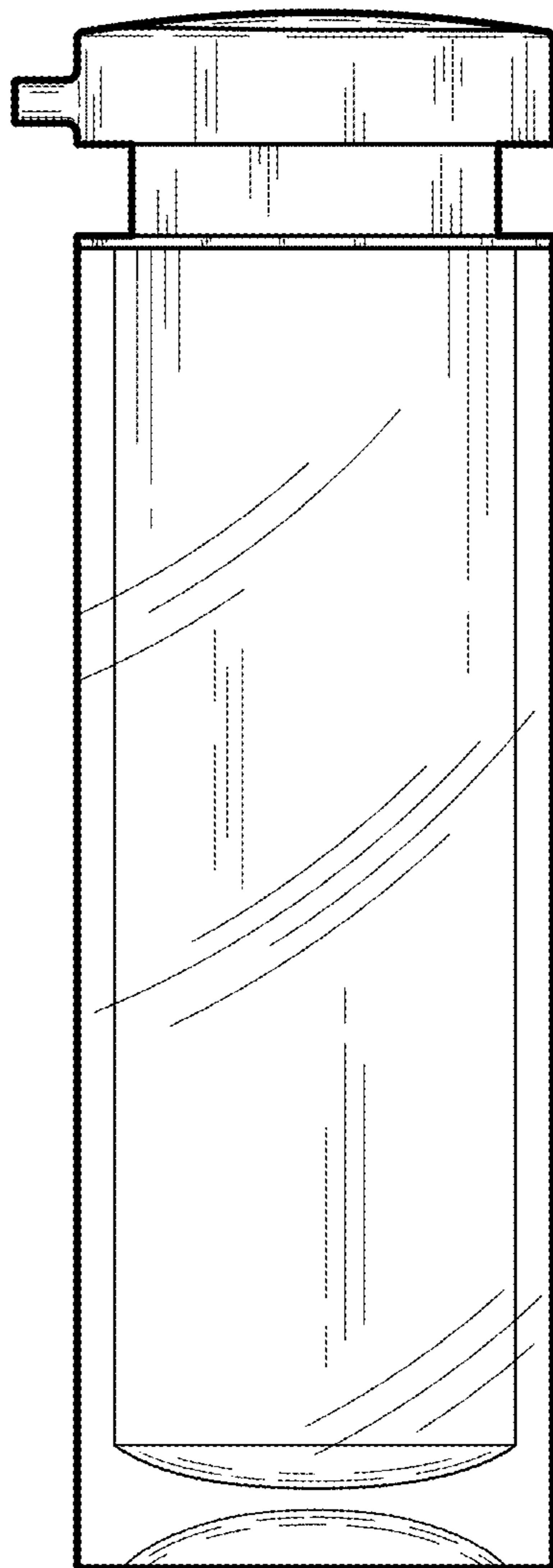

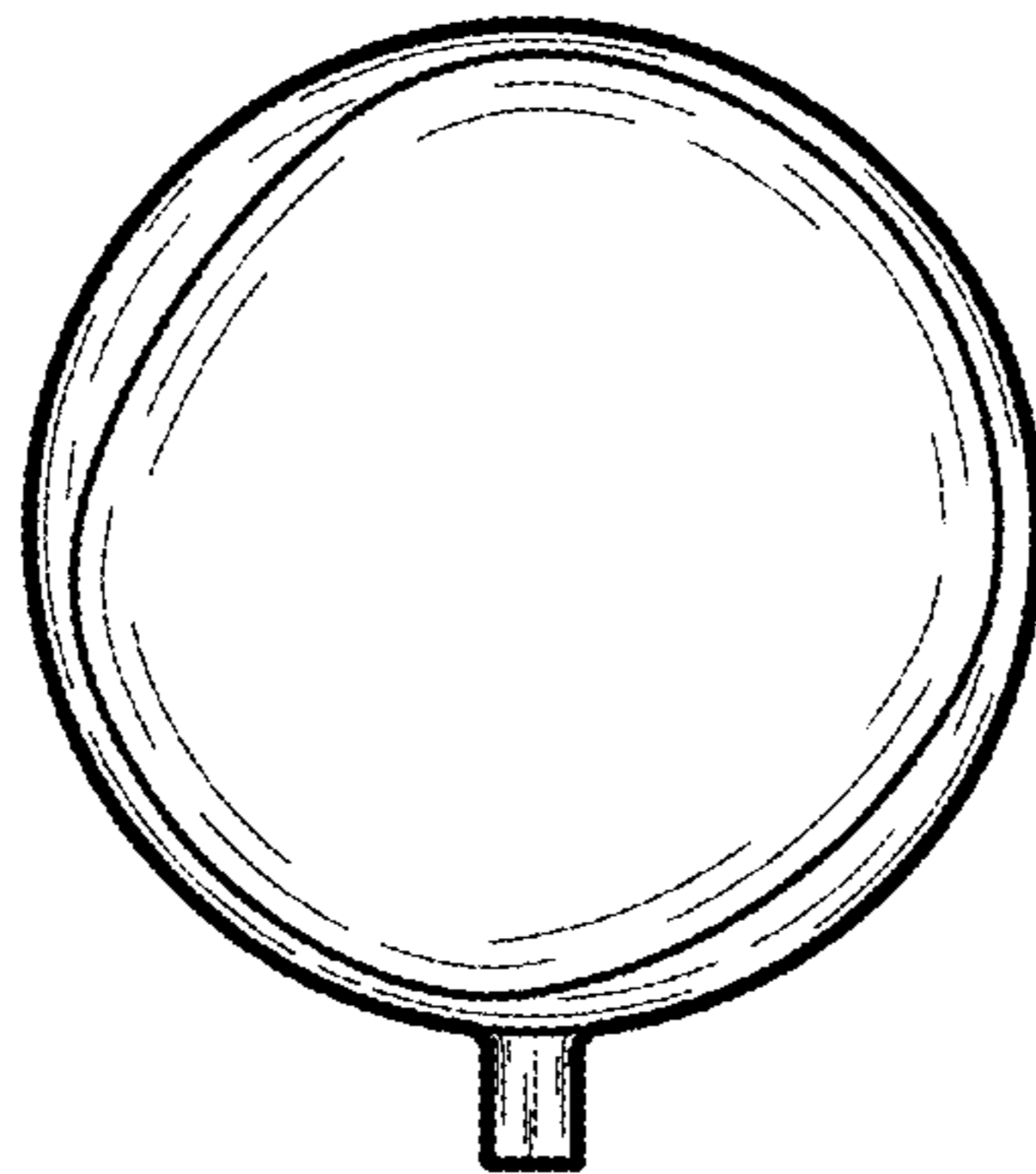
