DESCRIPTION

FIG. 1 is a front elevational view of a bracelet showing my new design;

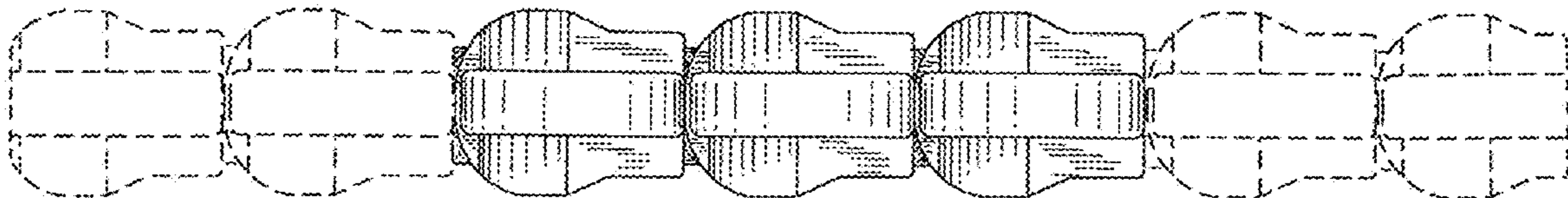

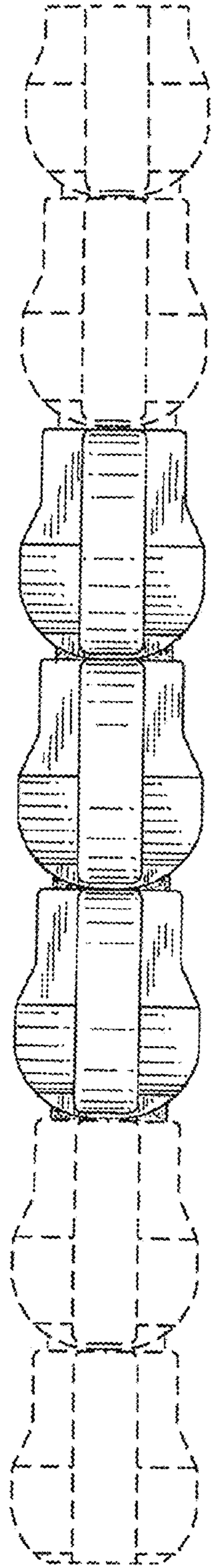

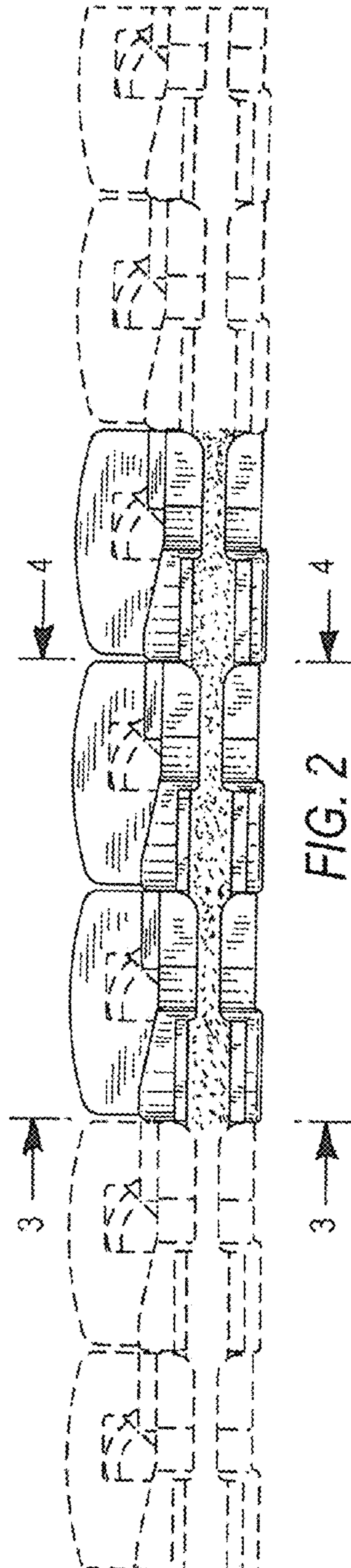

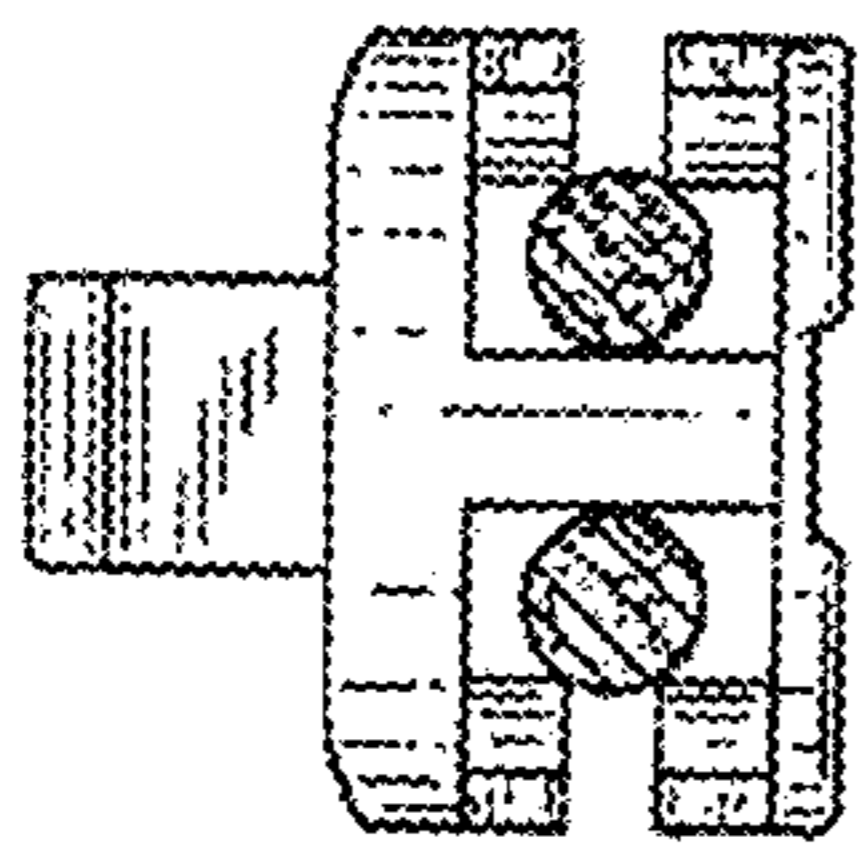

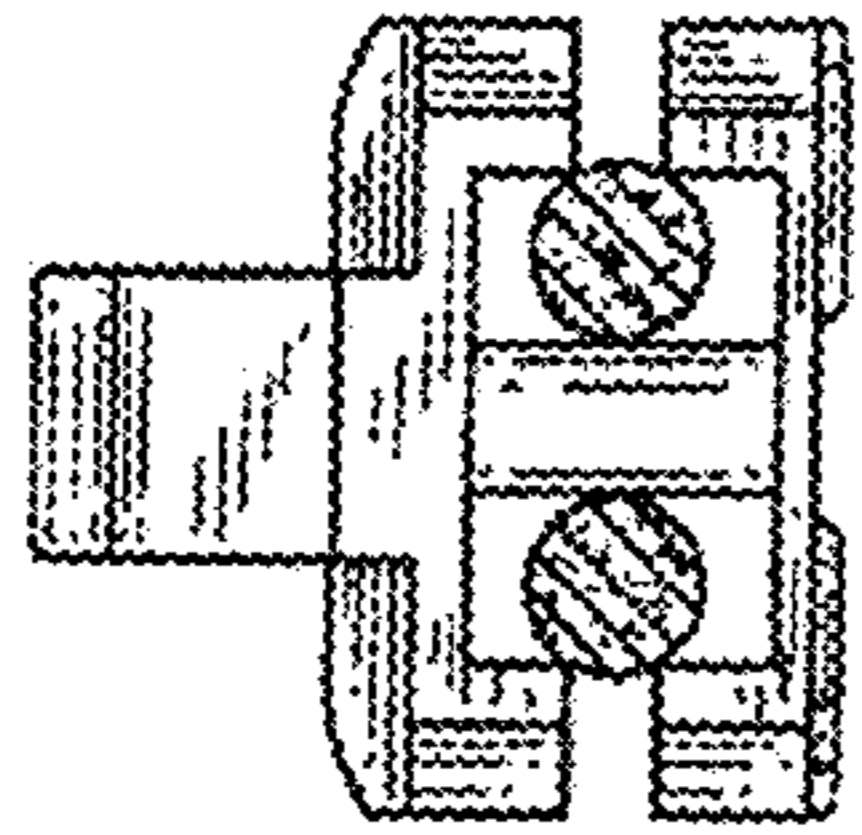
