The ornamental design for a canopy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a canopy showing my new design;

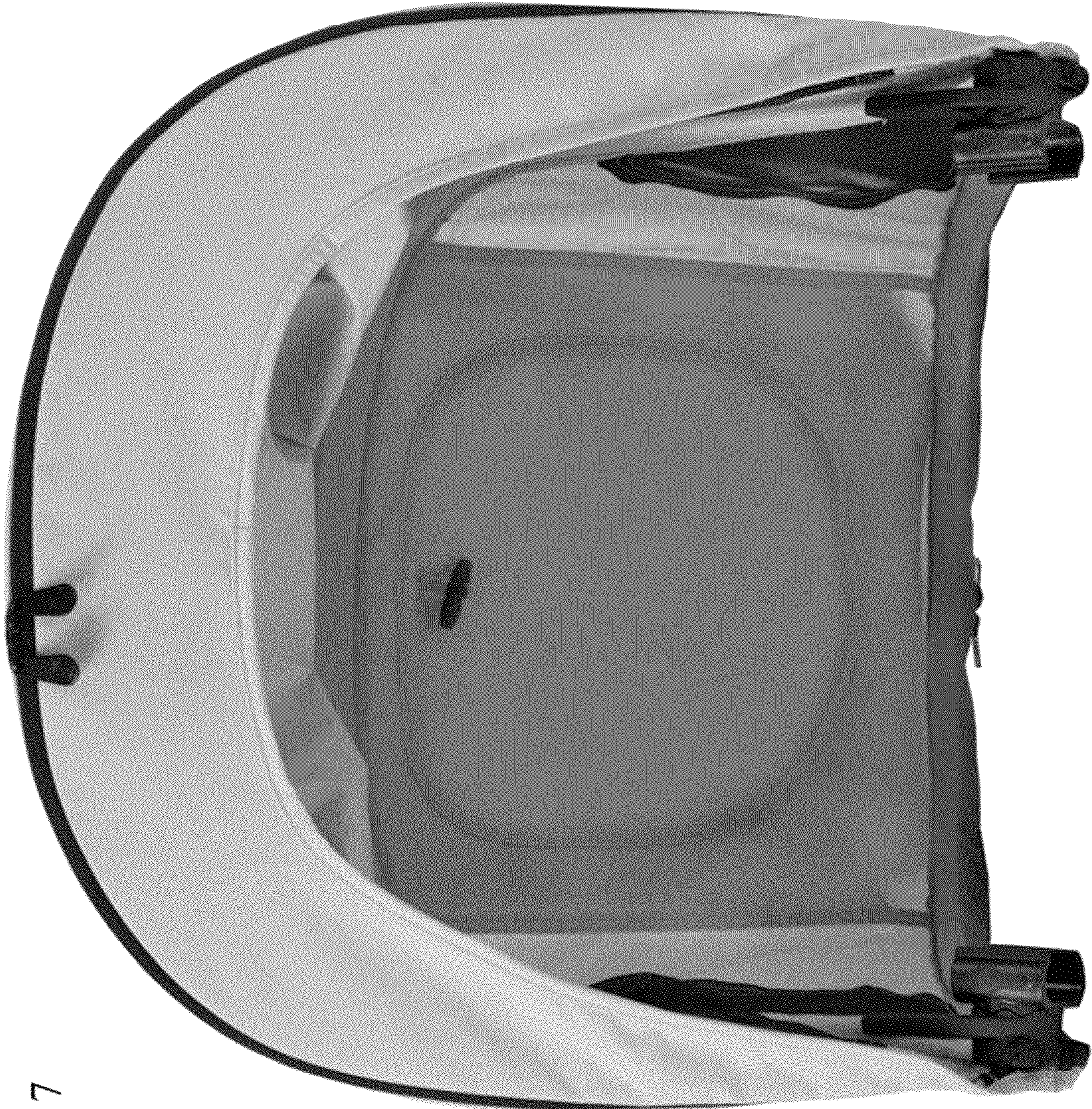
