FIG. 3 is a left side elevational view of the present invention shown in FIG. 1;

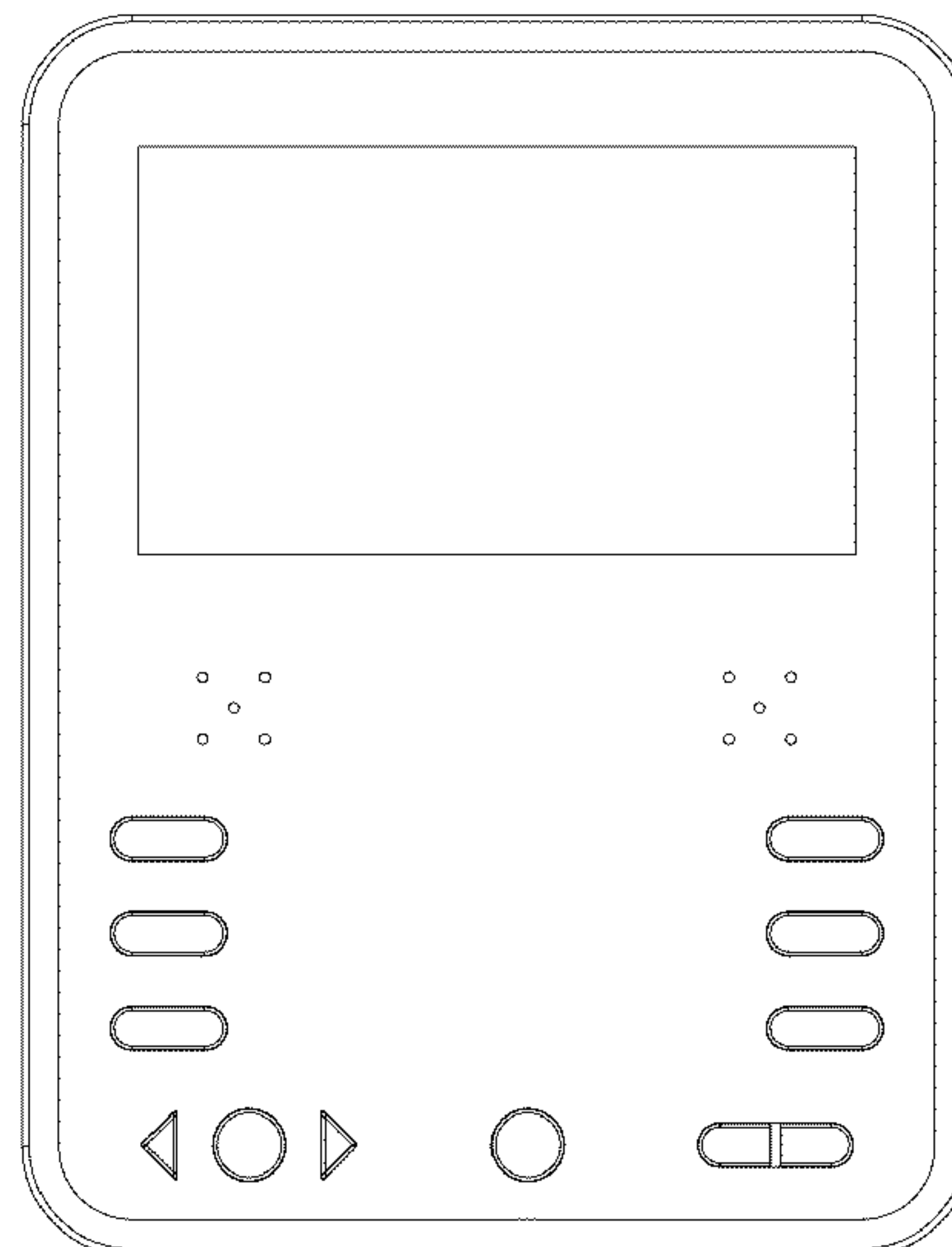
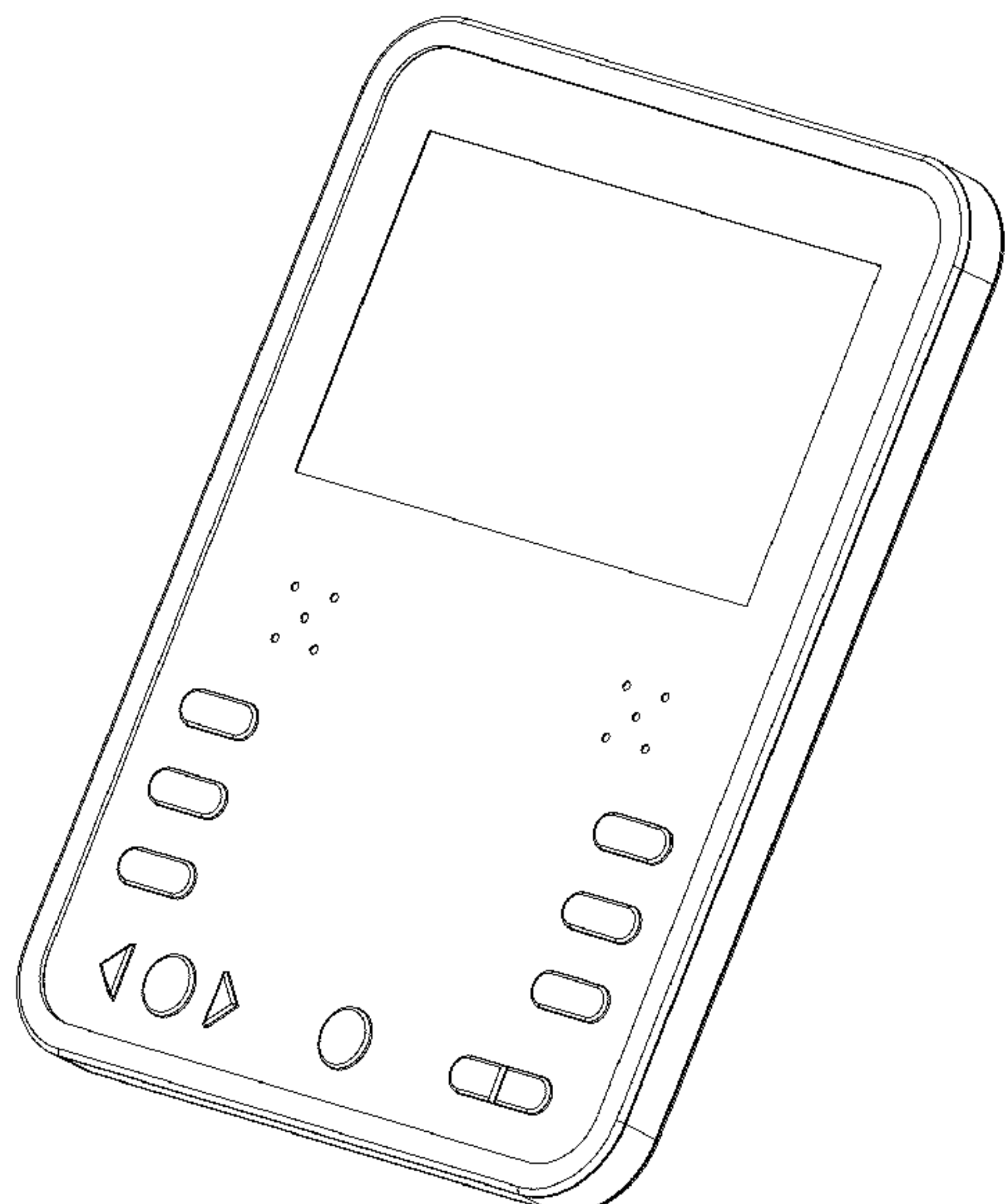
FIG. 4 is a right side elevational view of the present invention shown in FIG. 1;

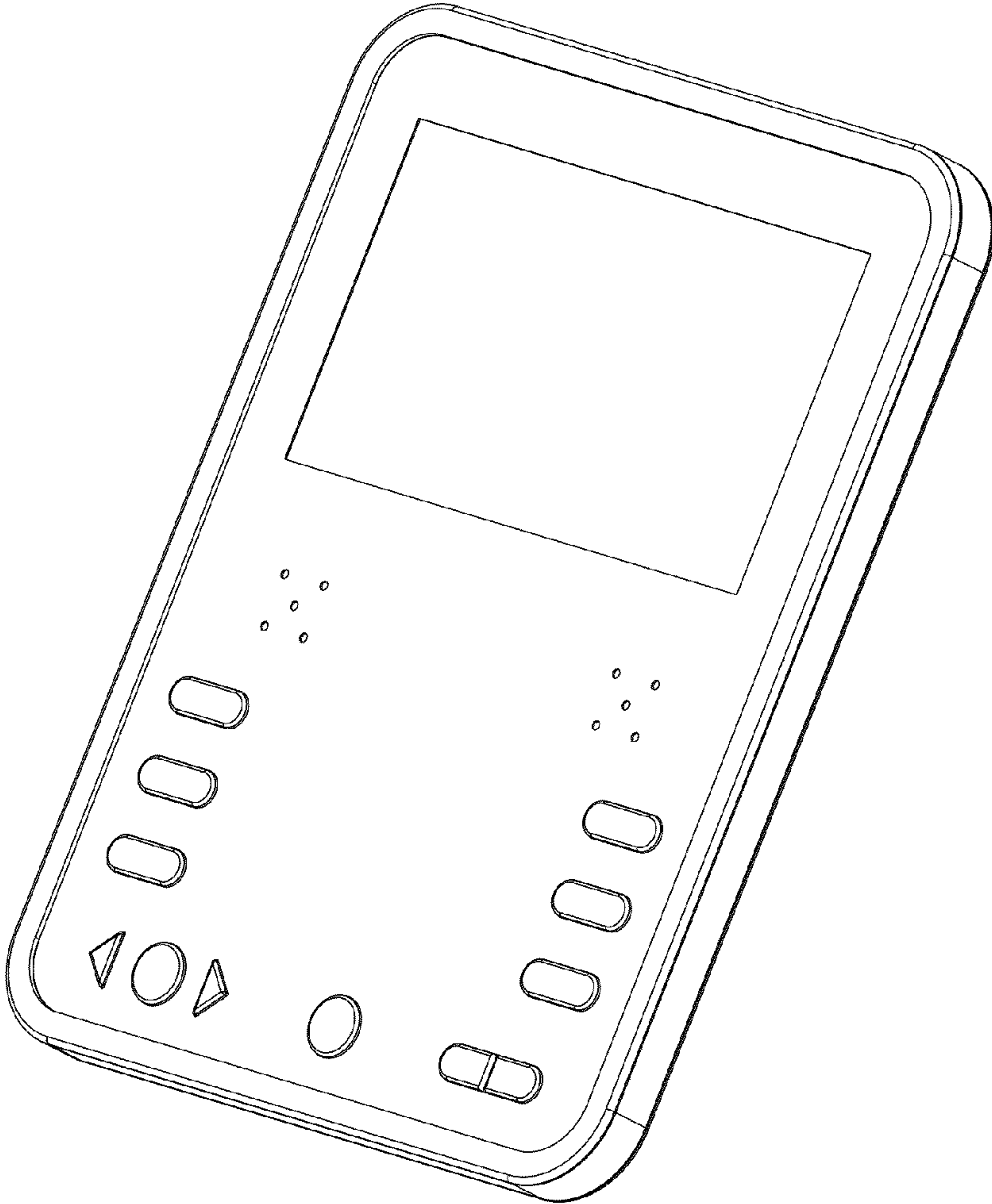

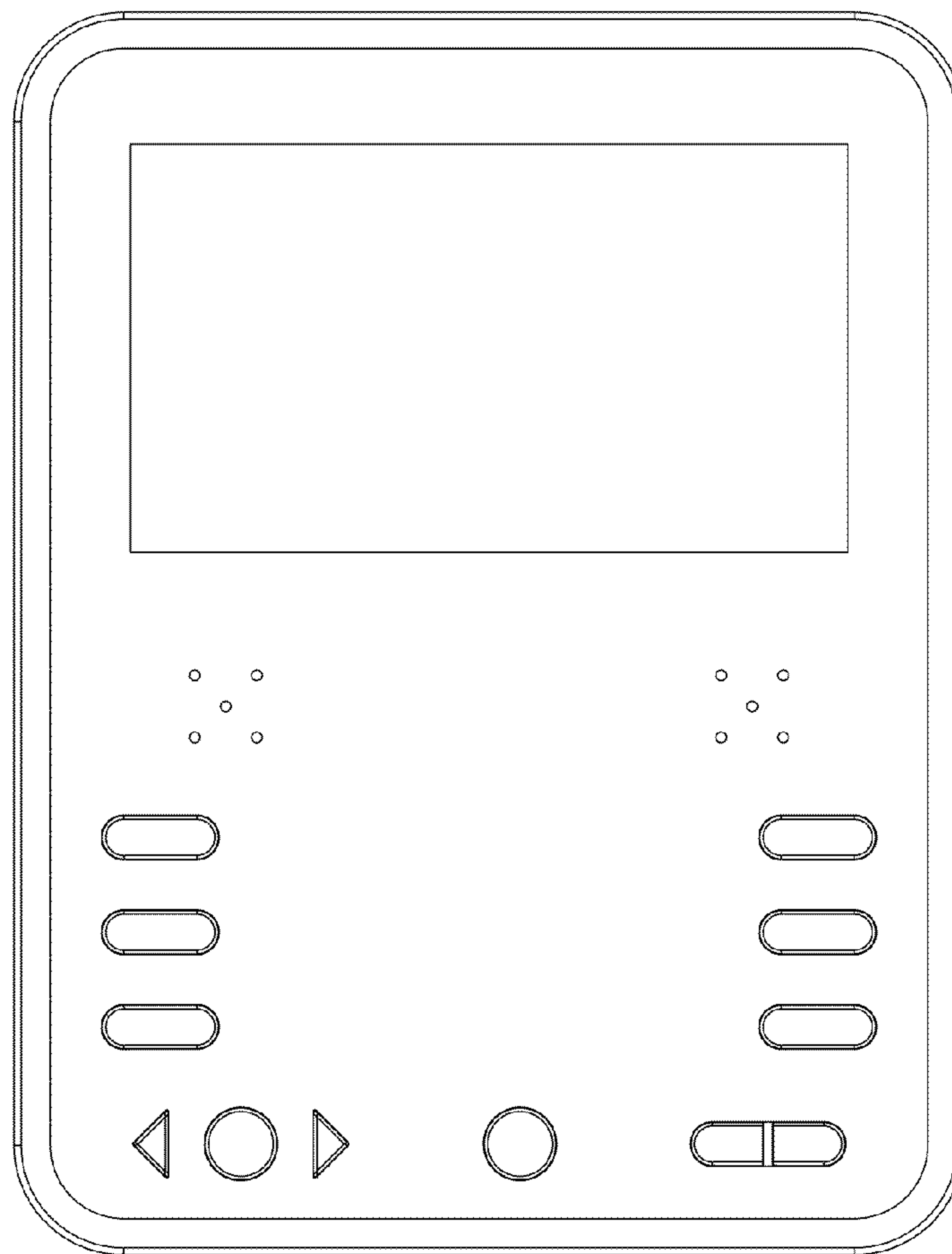

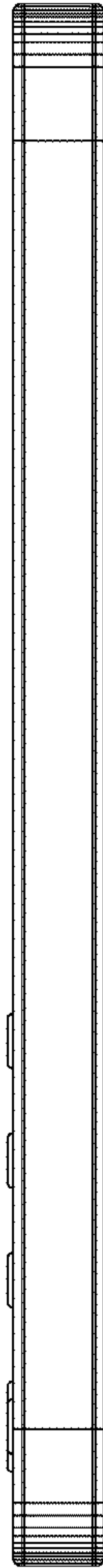

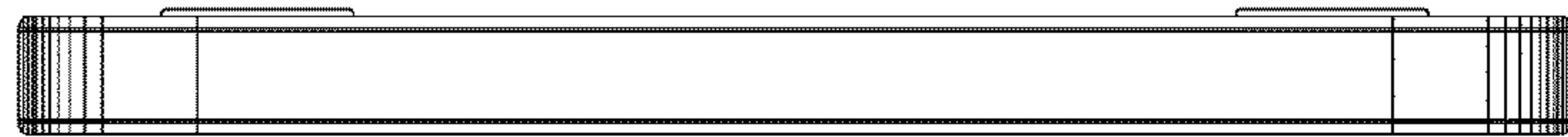

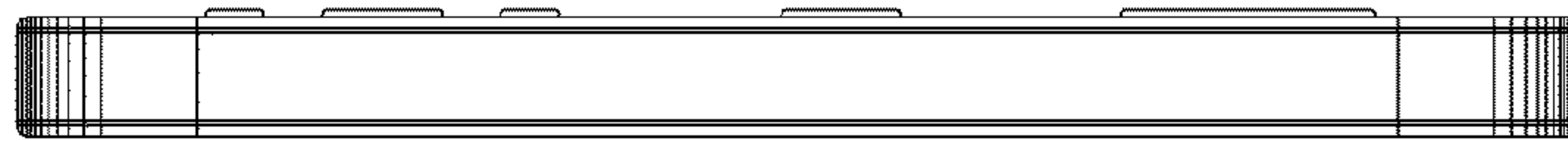
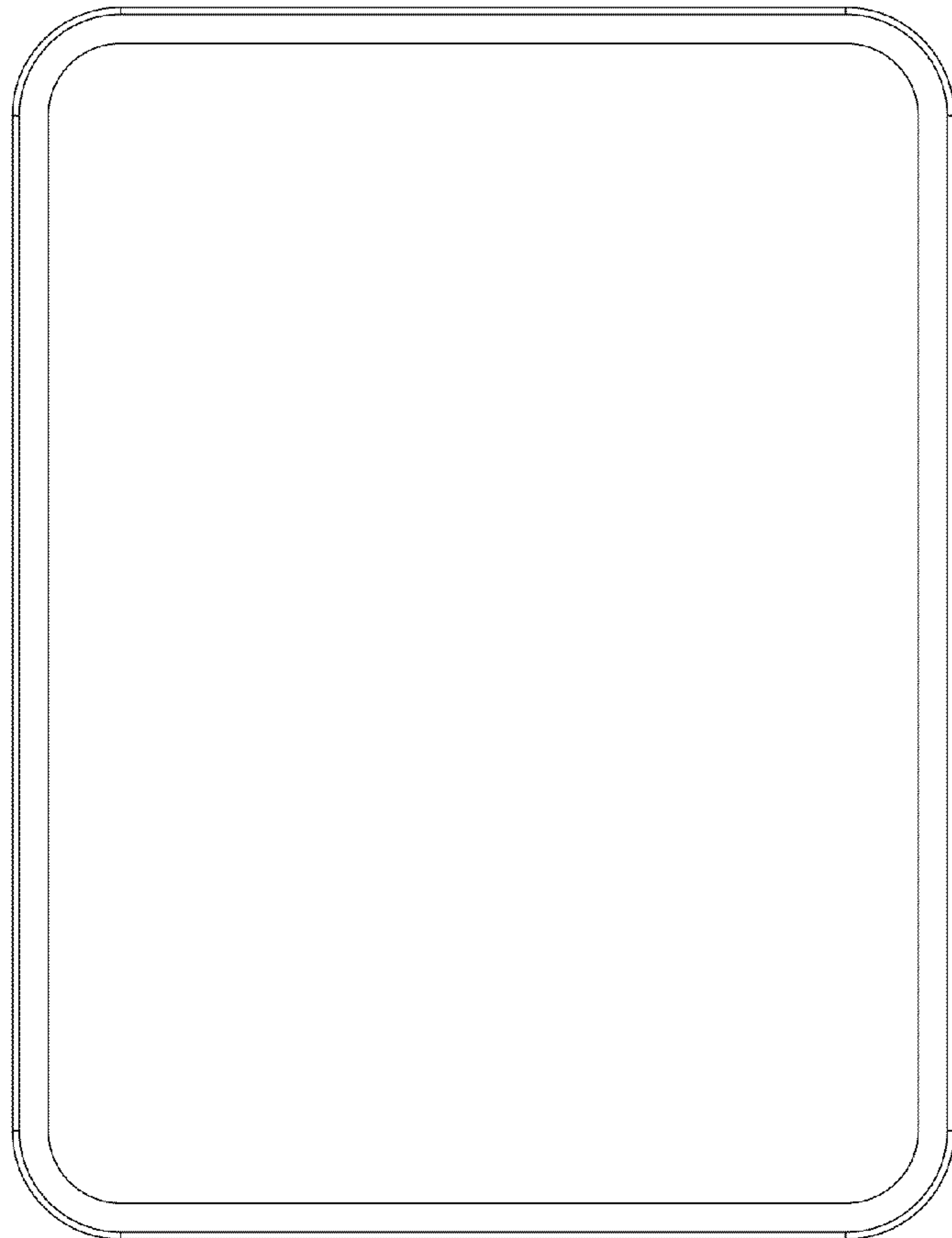
