(57) **CLAIM**

The ornamental design for a display screen with graphical user interface for an account identifier, as shown and described.

**DESCRIPTION**

FIG. 3 is a front view of a third embodiment of an display screen with graphical user interface for an account identifier showing our new design;

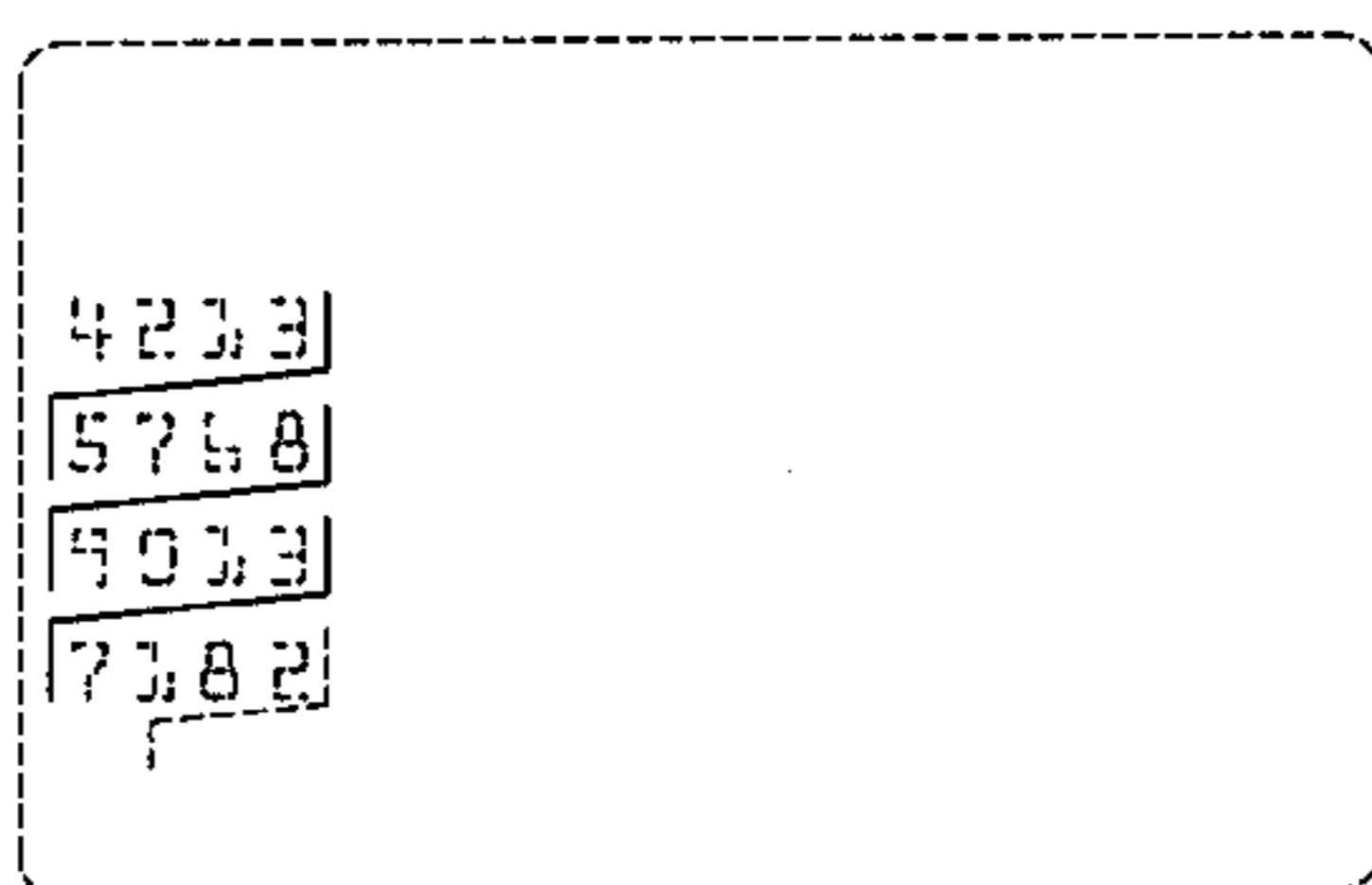
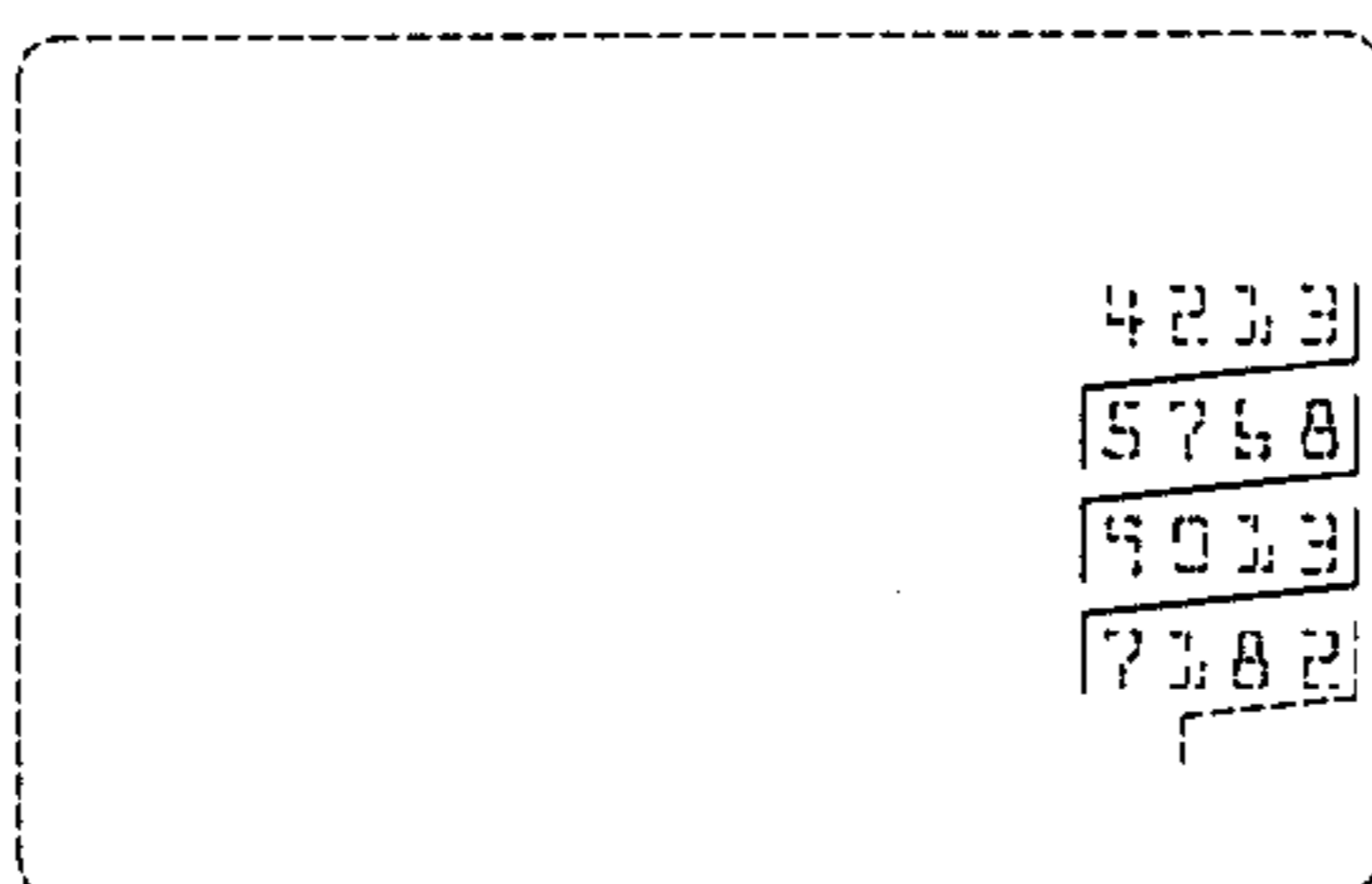
FIG. 4 is a front view of a fourth embodiment of an display screen with graphical user interface for an account identifier showing our new design;

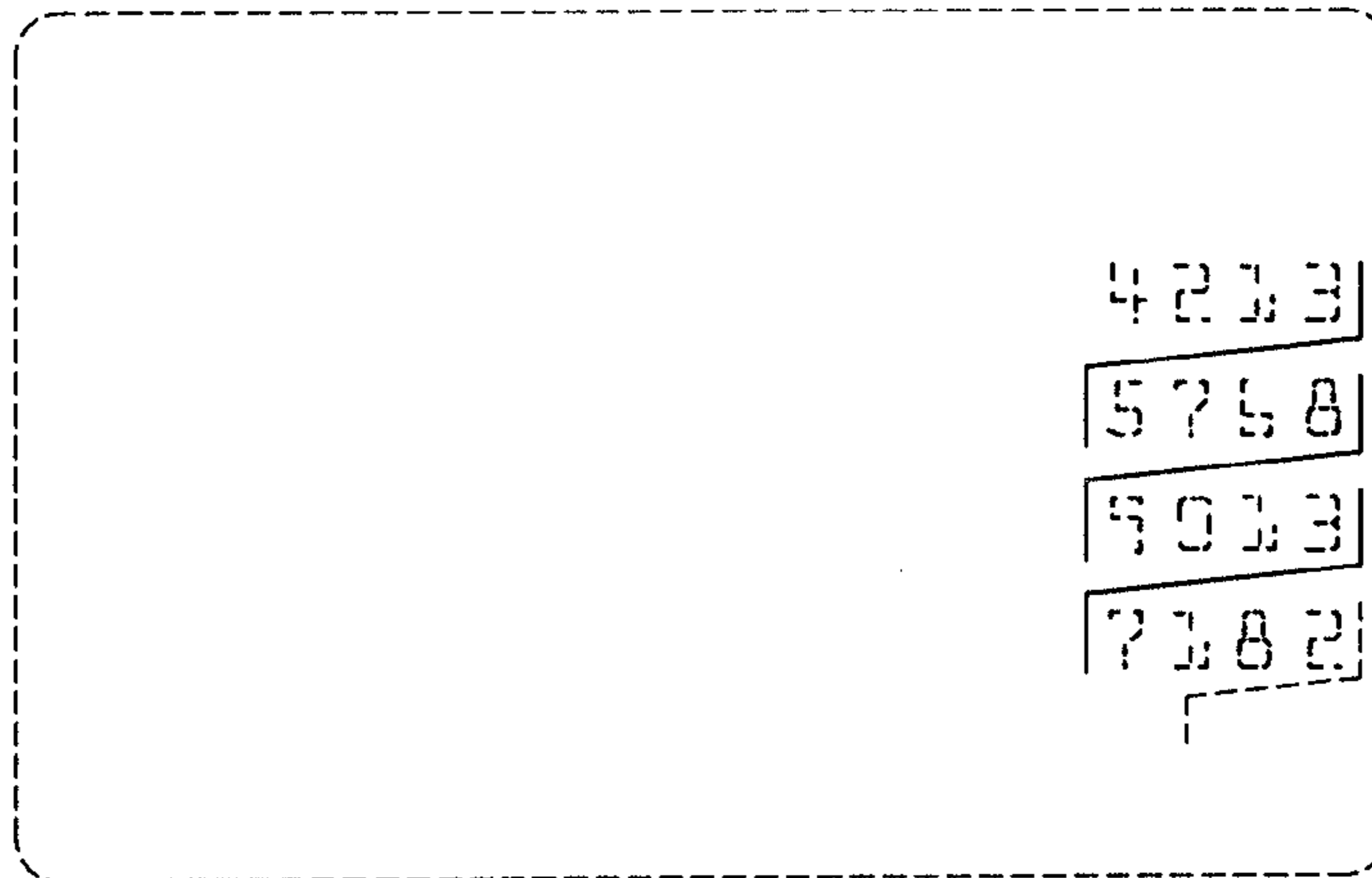

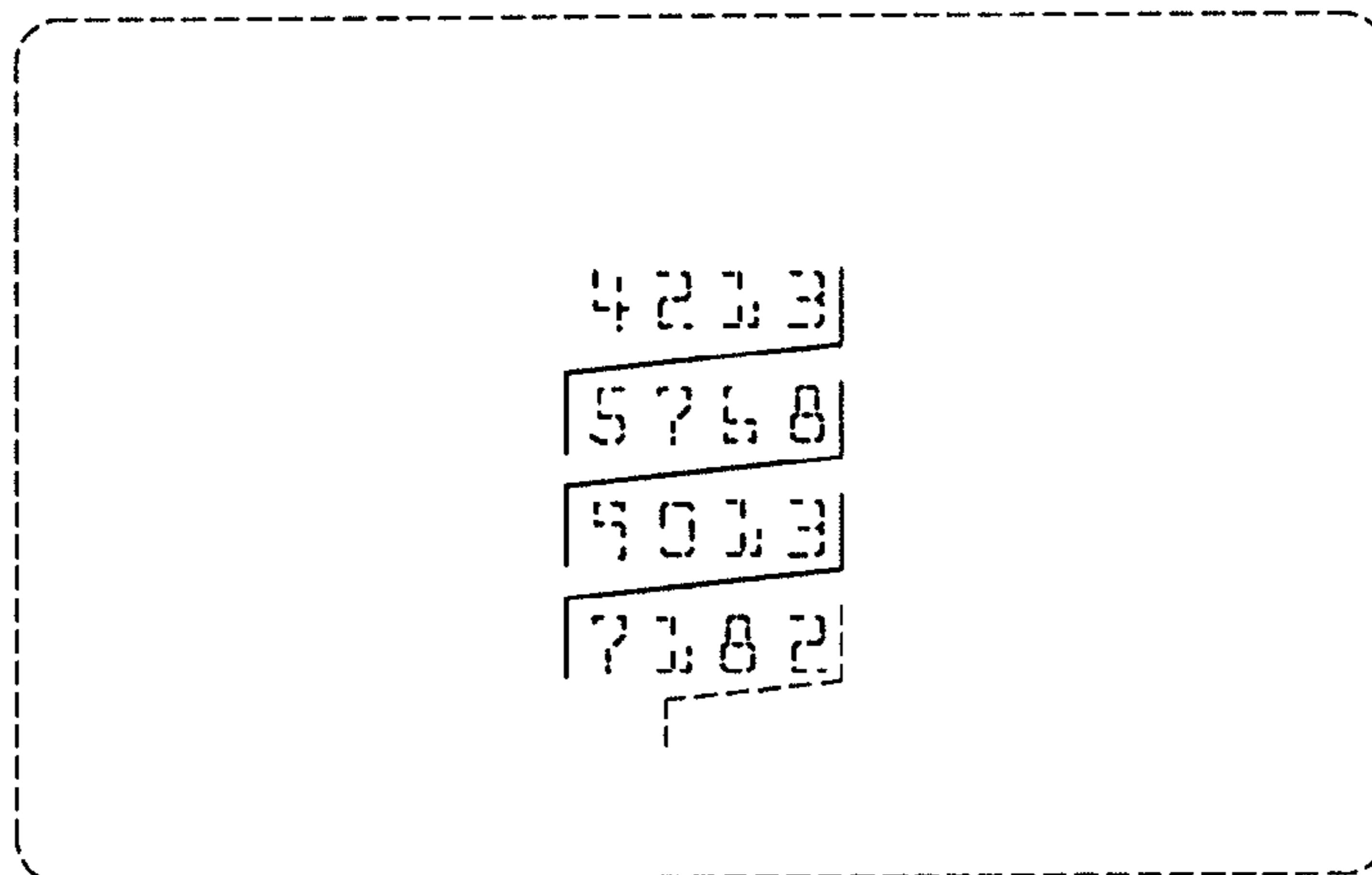

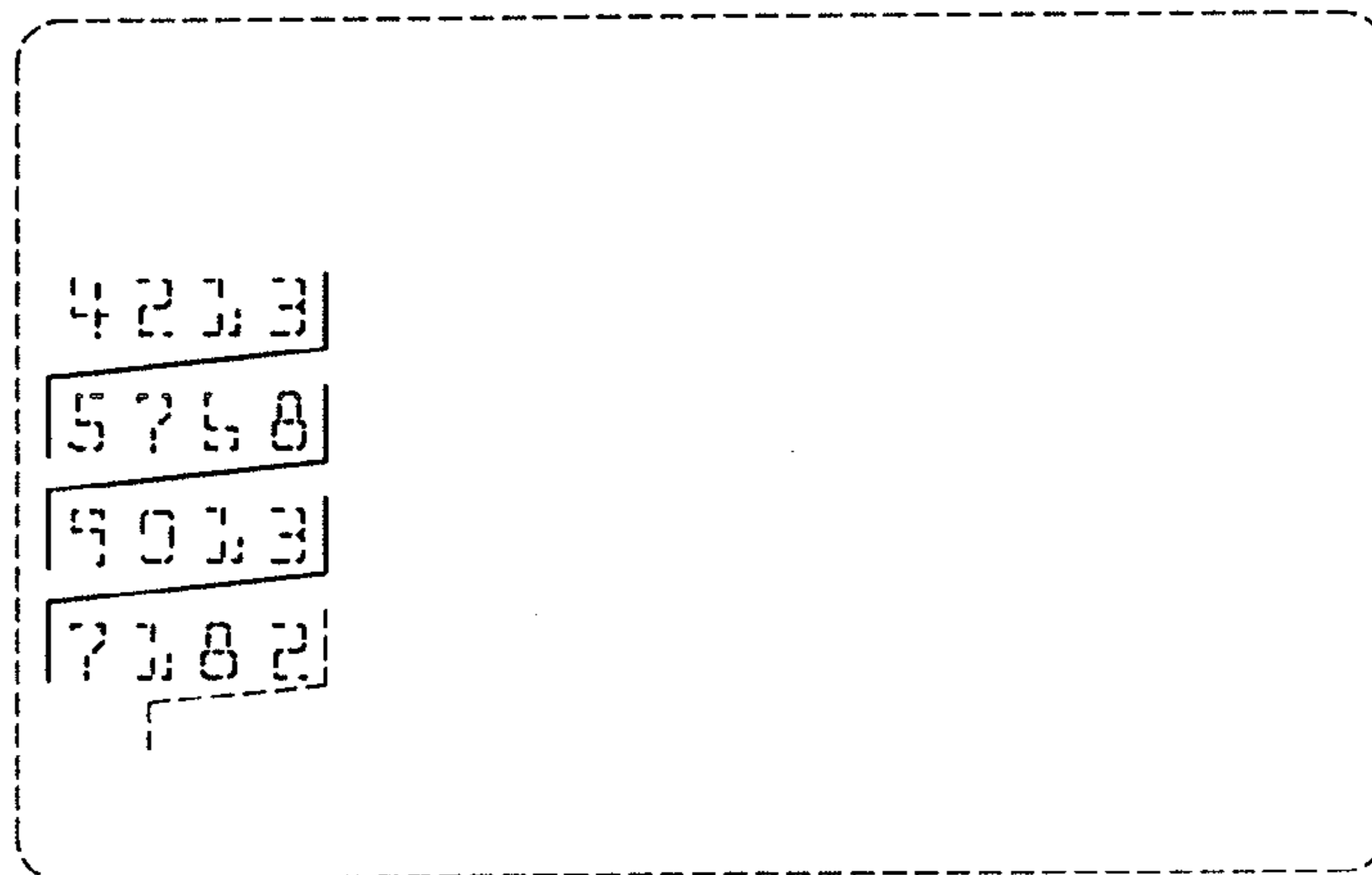

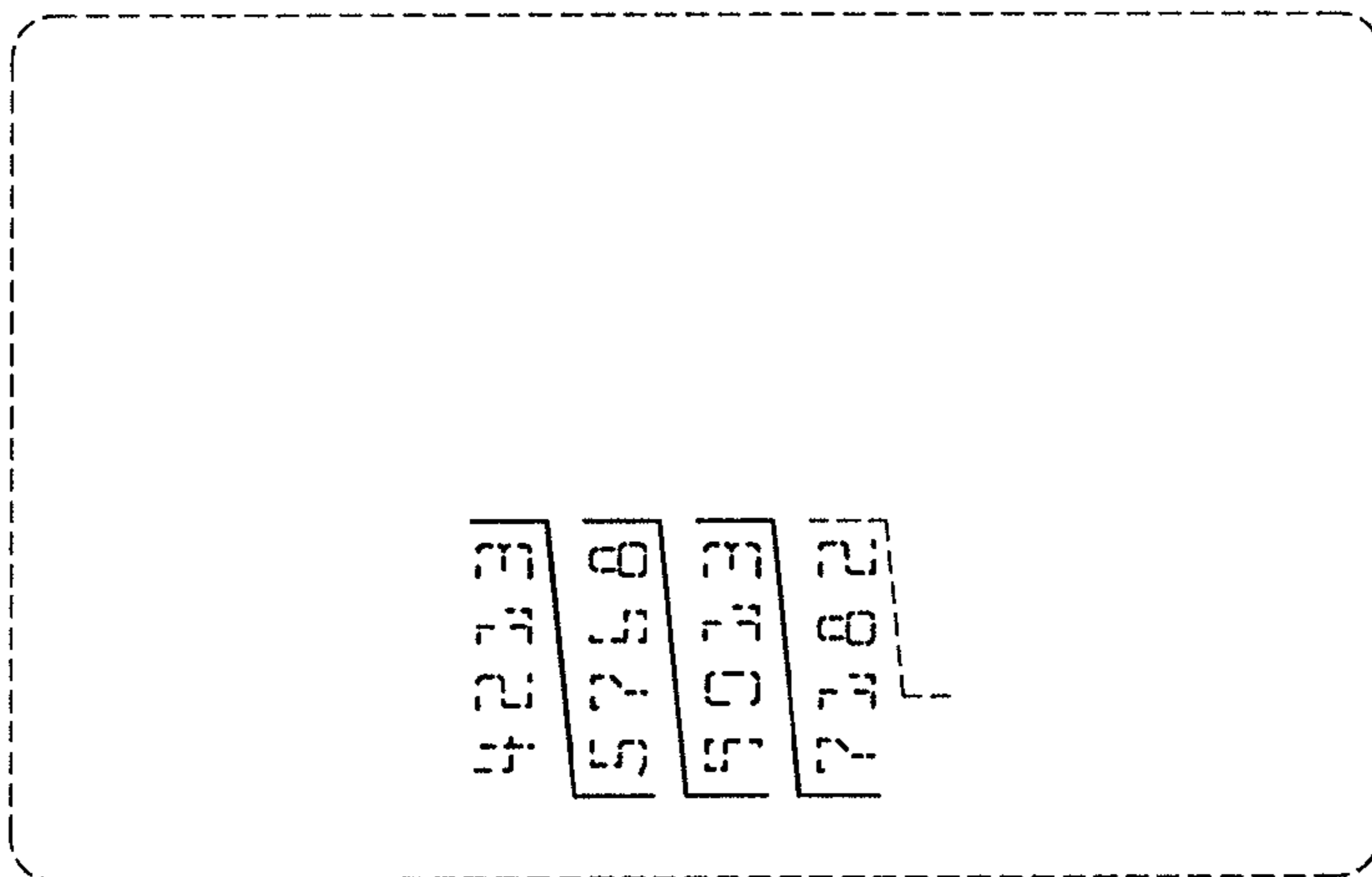

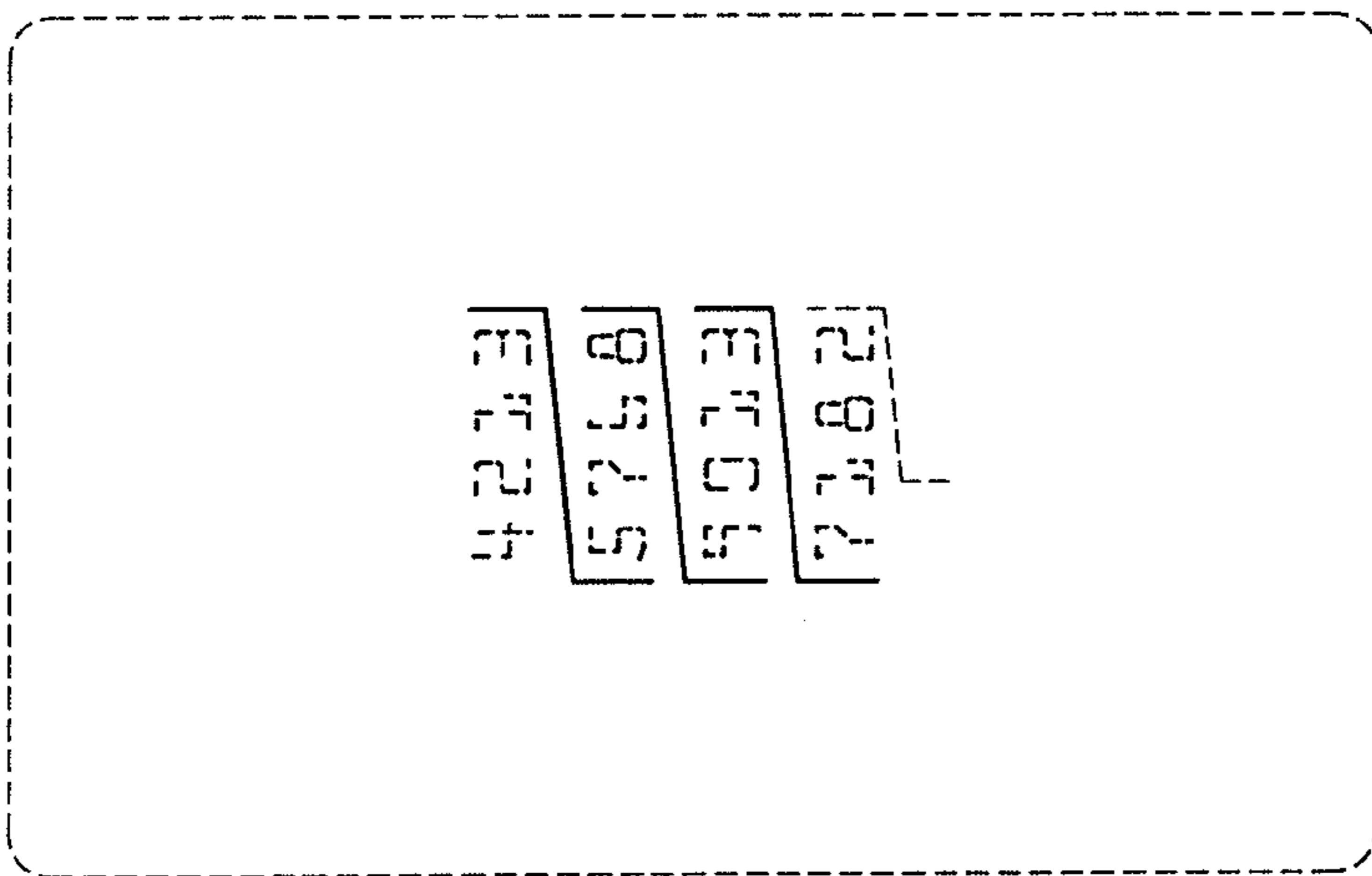

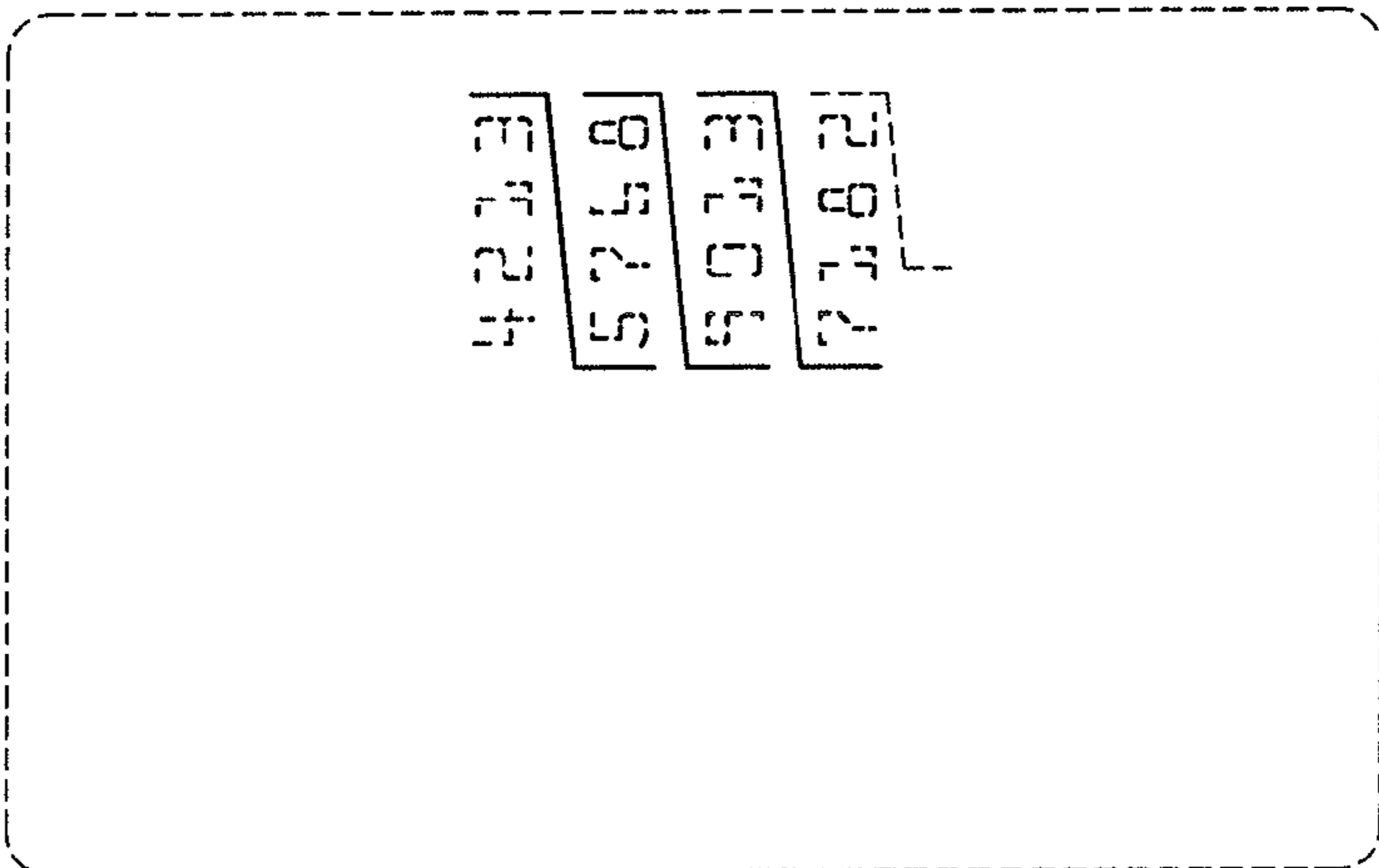
