The ornamental design for a lacrosse head, as shown.

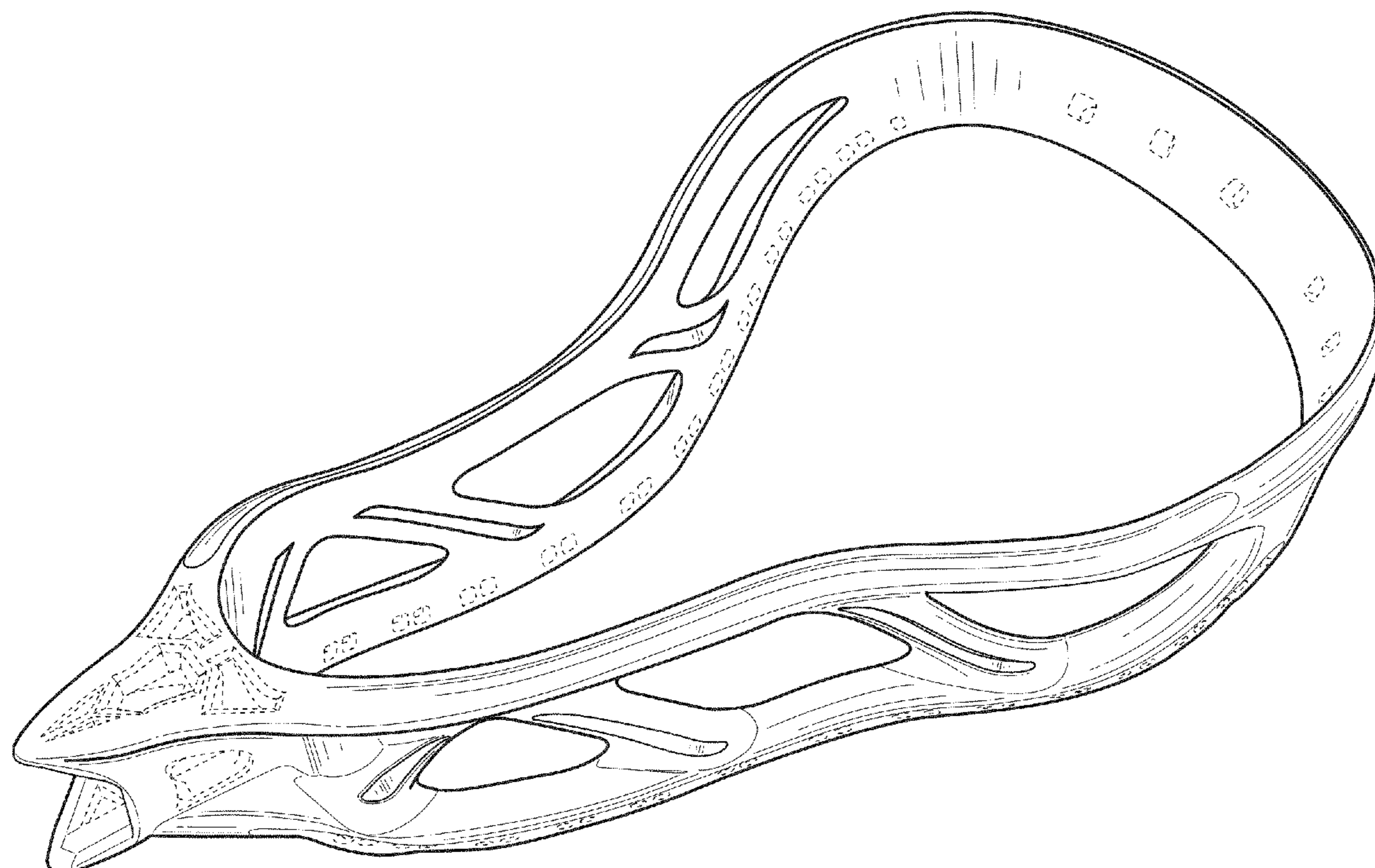
DESCRIPTION

FIG. 1 is a perspective view of a lacrosse head in accordance with the present invention;

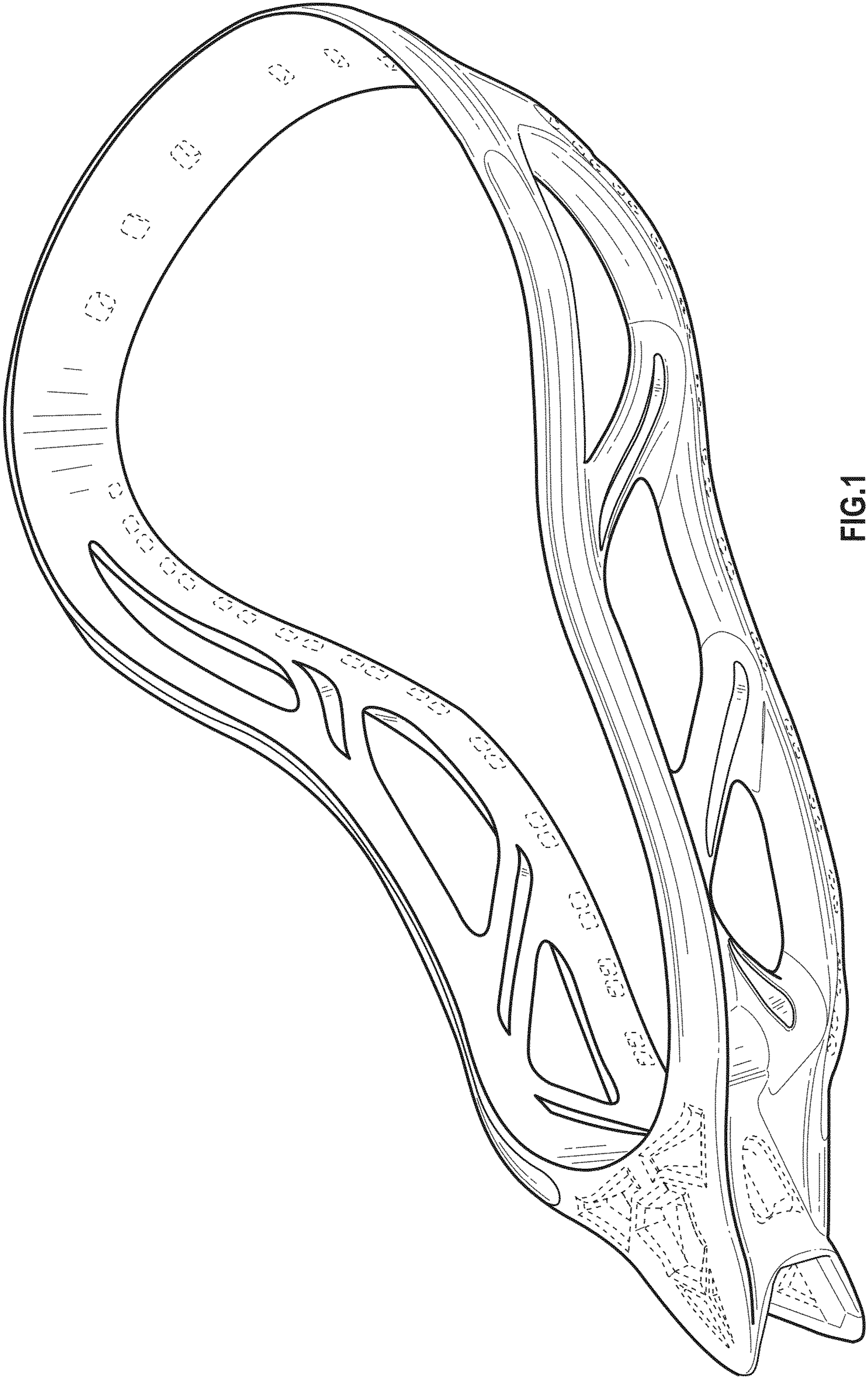

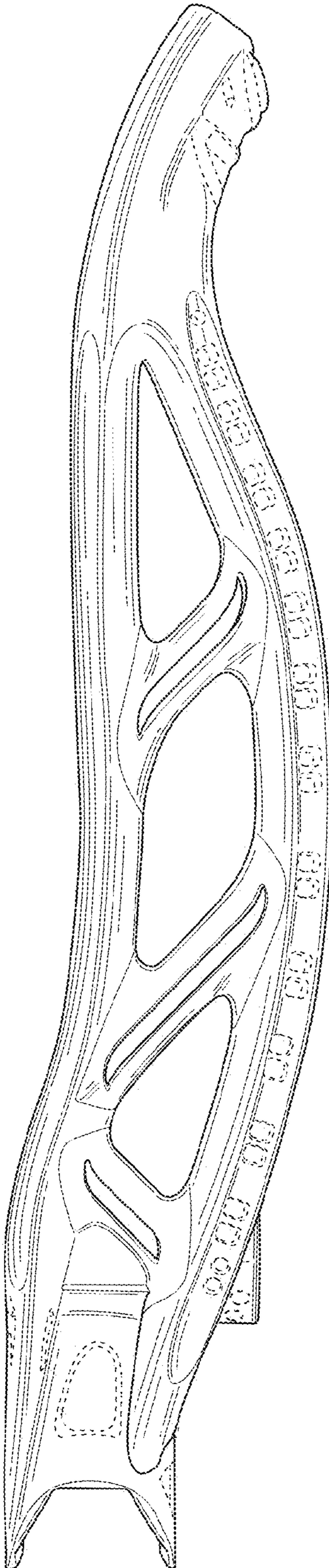

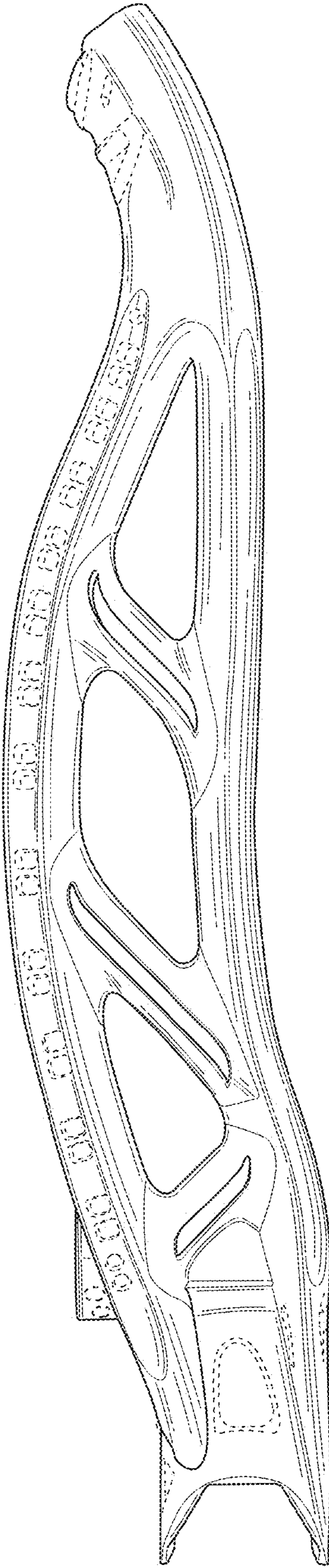

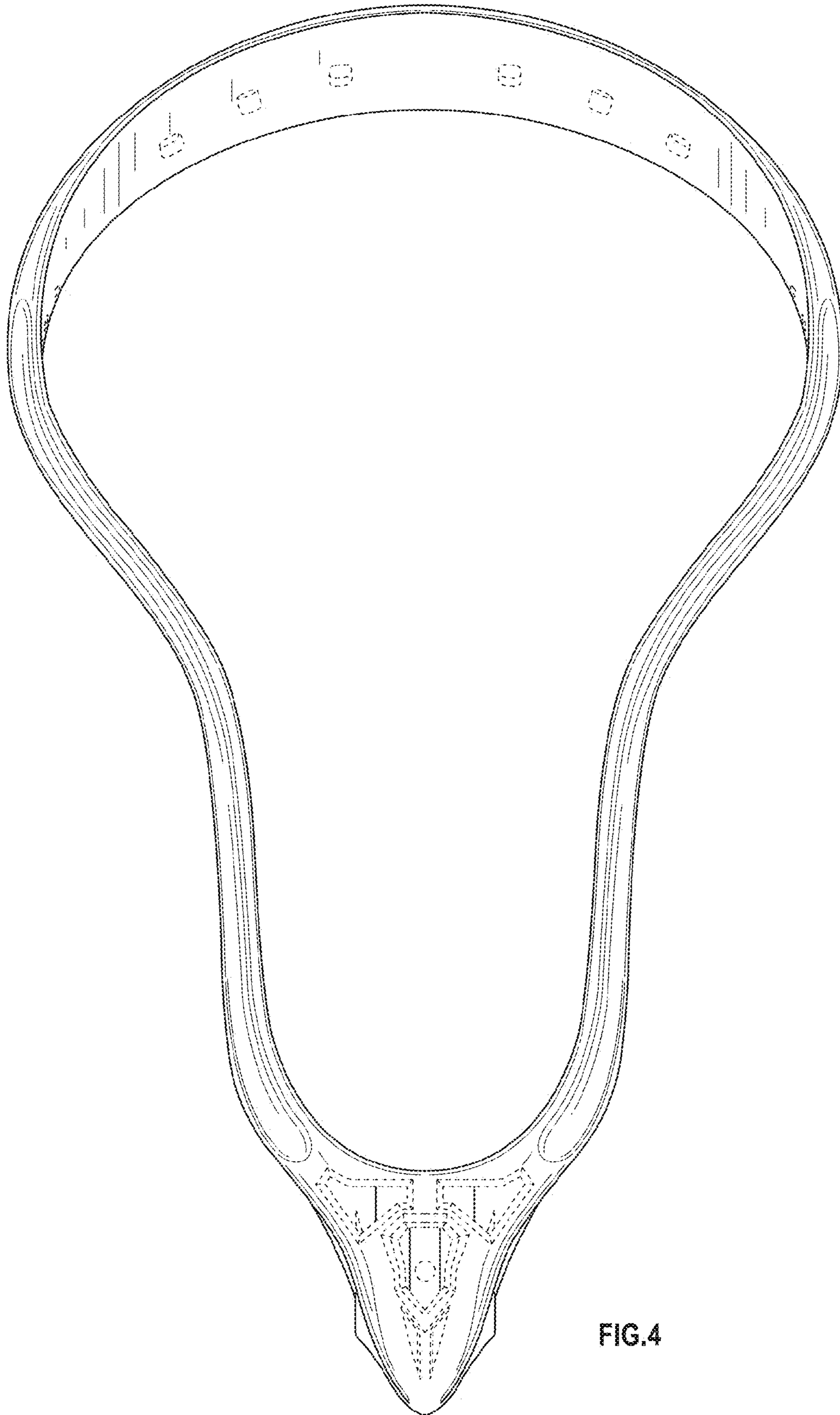

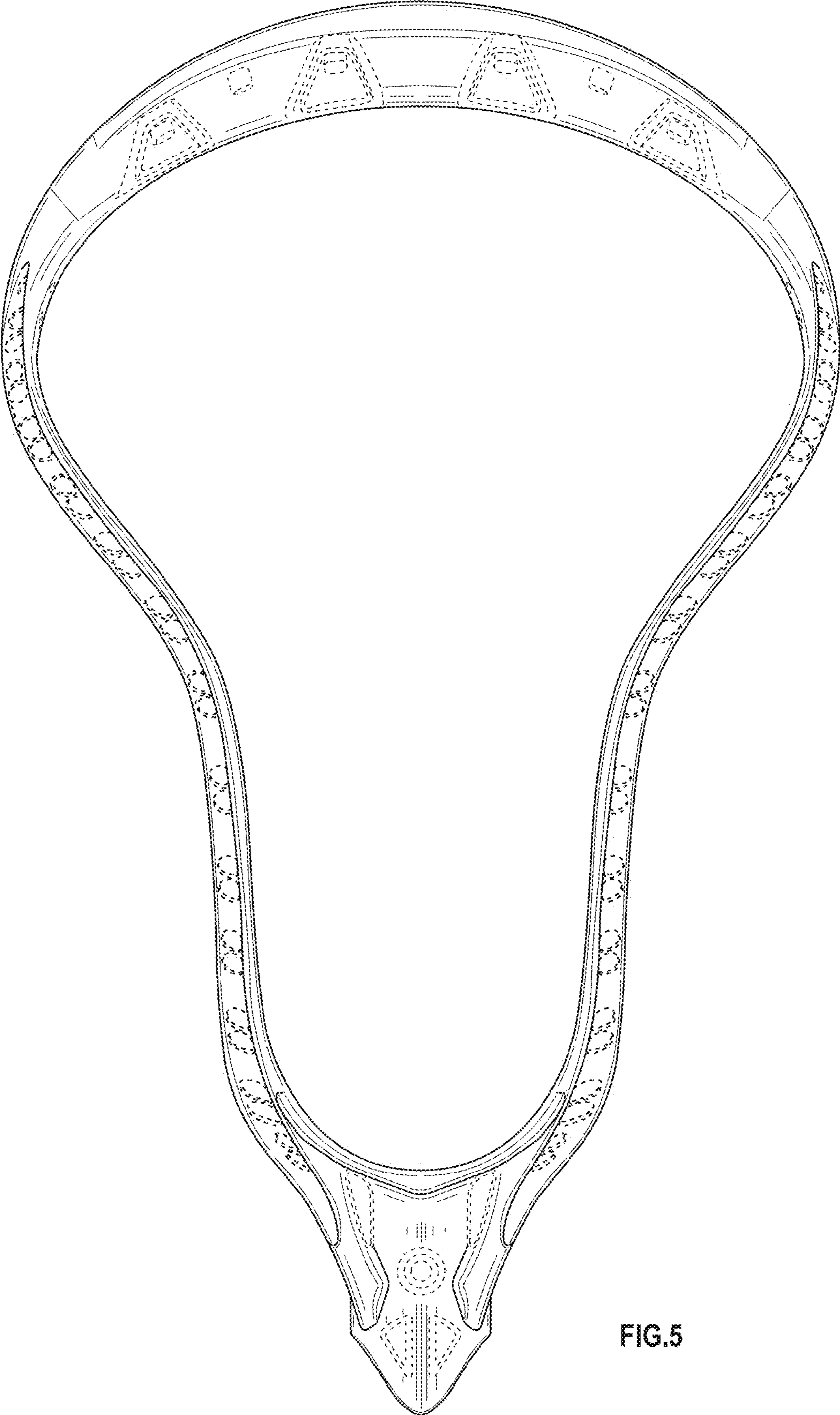

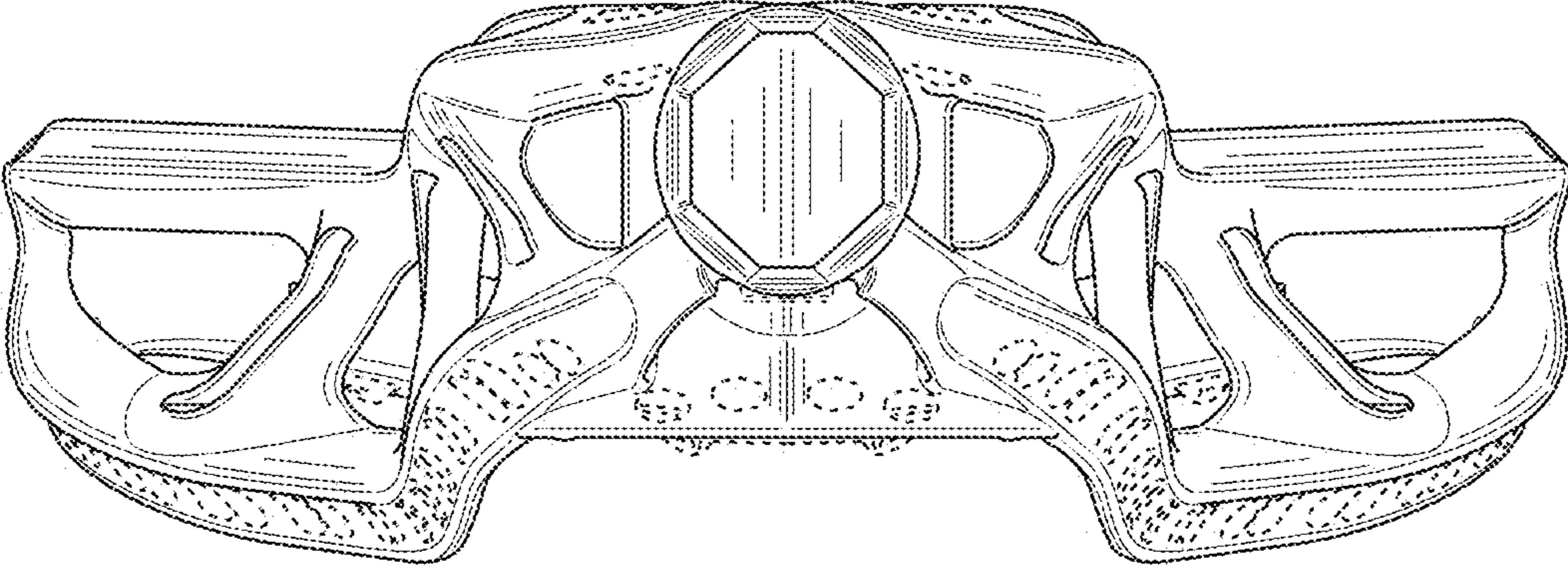

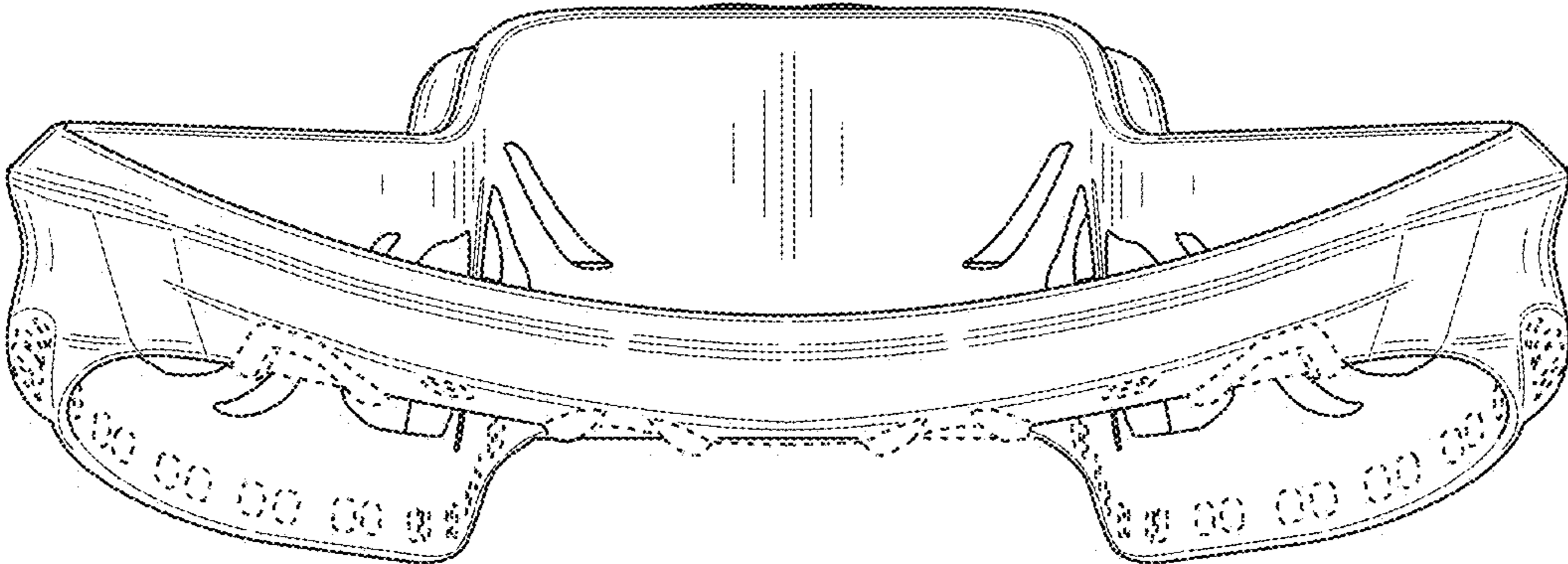
