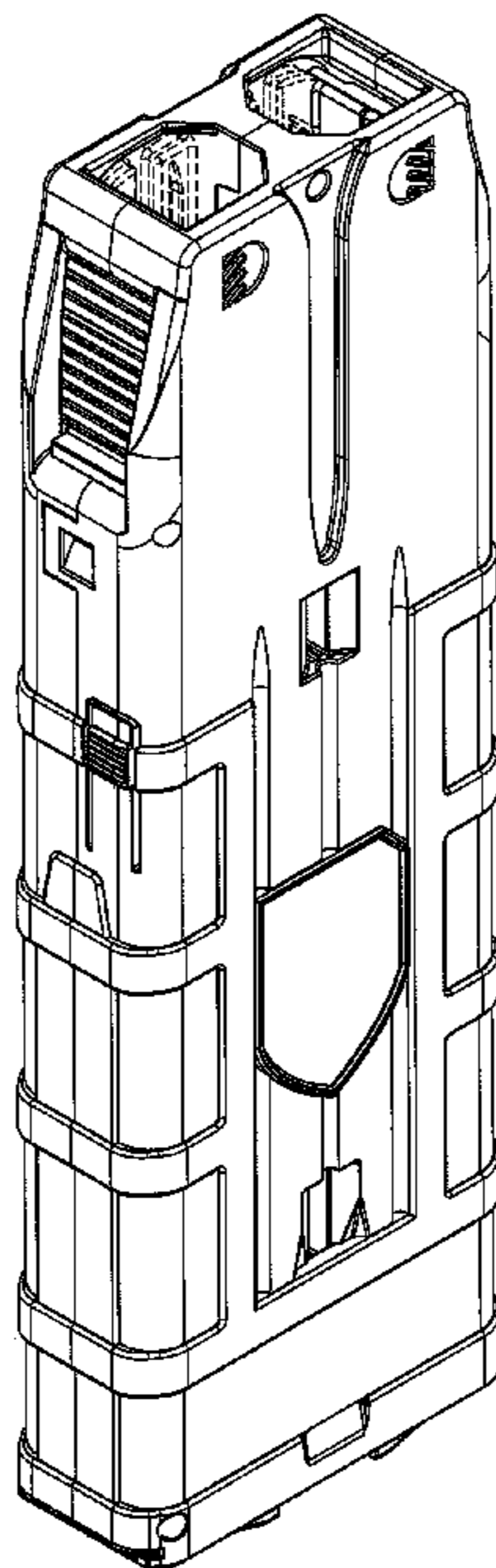
(57) **CLAIM**

The ornamental design for a magazine, as shown and
described.

DESCRIPTION

FIG. 1 is a front side perspective view of a magazine showing
our new design with both doors in an open position;
FIG. 2 is a front side perspective view of the magazine show-
ing the doors in a loading position;
FIG. 3 is a front side perspective view of the magazine show-
ing the doors in a closed position;
FIG. 4 is a side view thereof;
FIG. 5 is an opposite side view thereof;
FIG. 6 is a front side thereof;
FIG. 7 is a back side thereof;
FIG. 8 is a top view thereof with the doors in an open position
and showing a pair of followers inside the magazine; and,
FIG. 9 is a bottom view thereof.
The broken lines in FIGS. 1, 2, and 8 are included for the
purpose of illustrating a portion of the magazine that forms no
part of the claimed design.

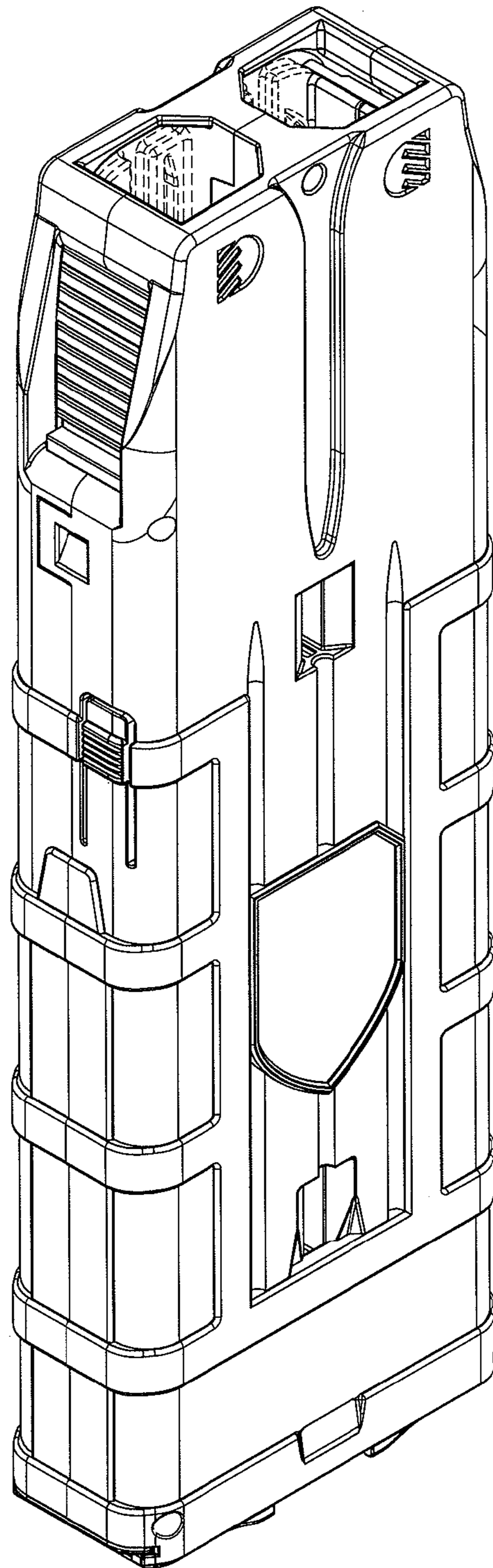

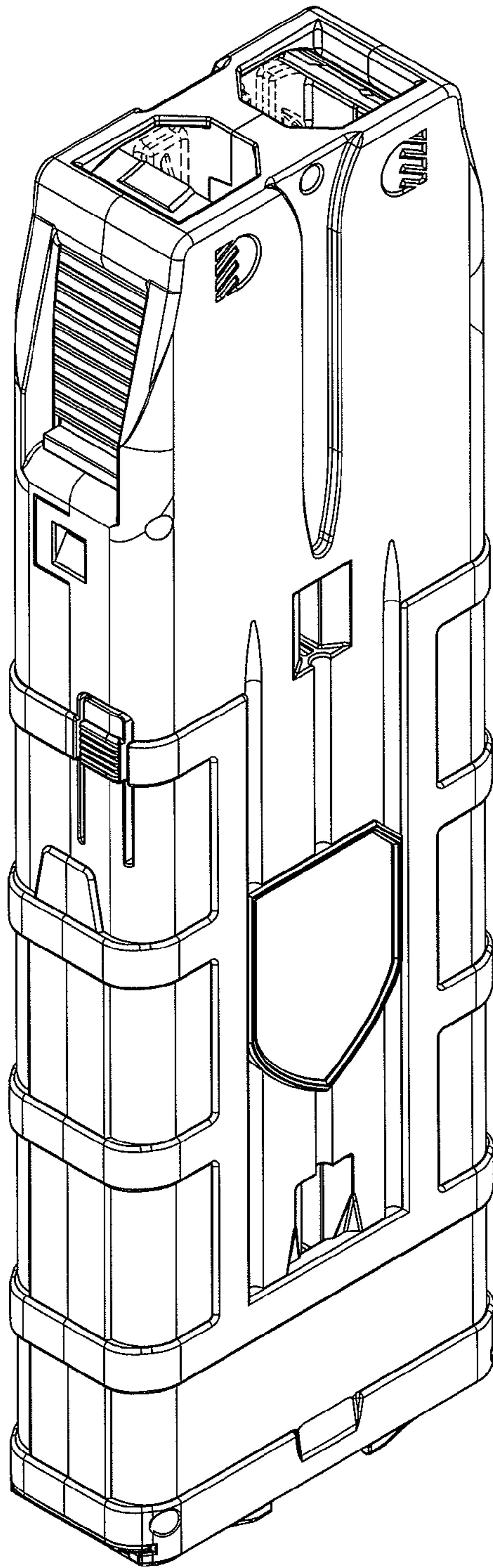

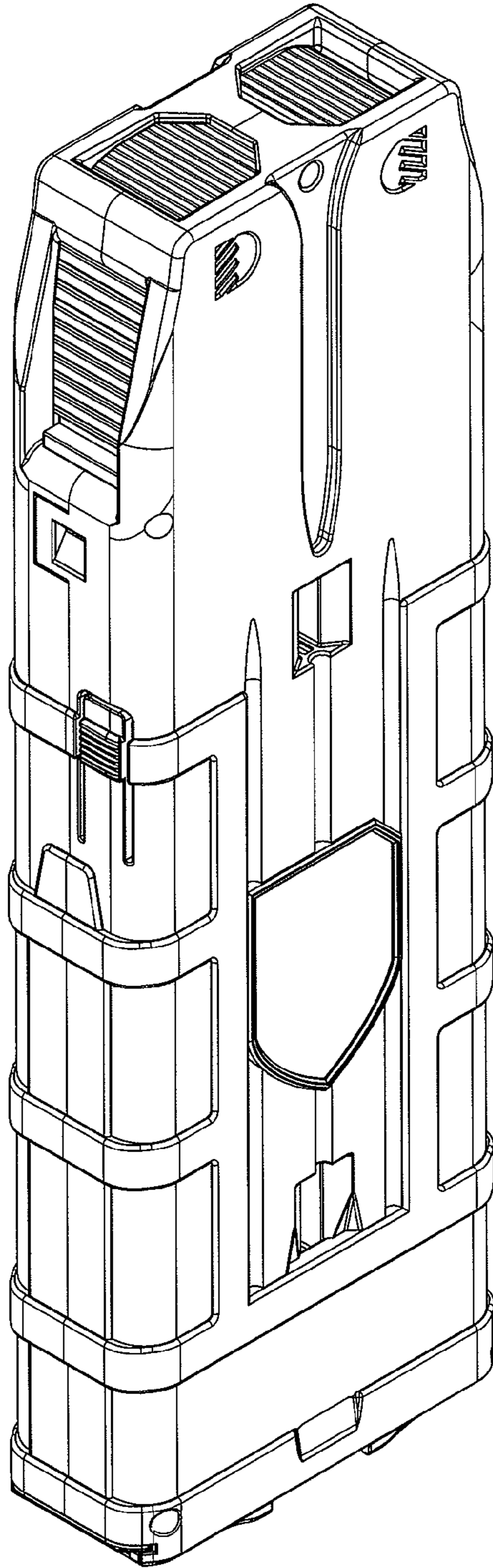

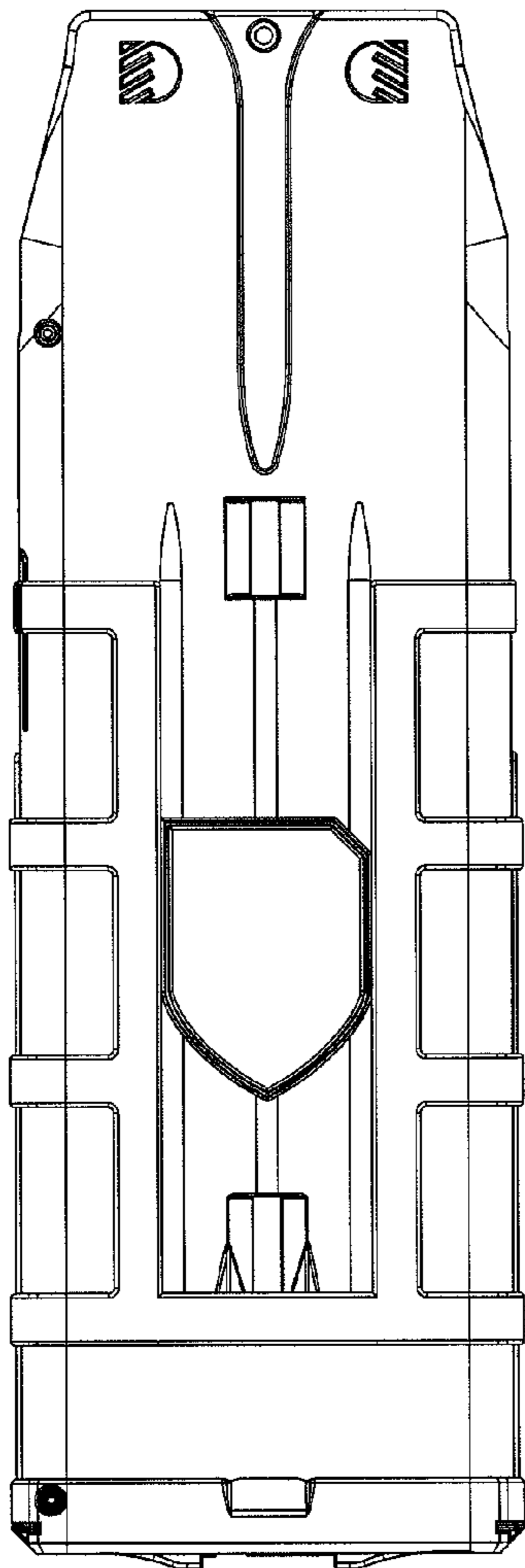

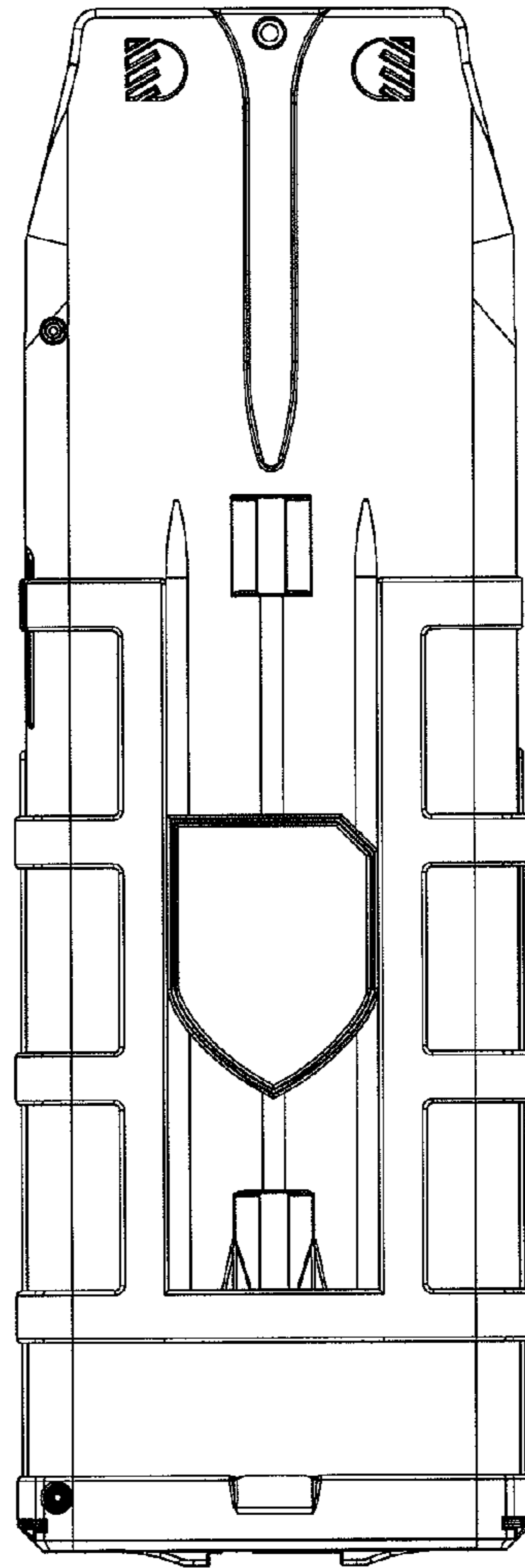

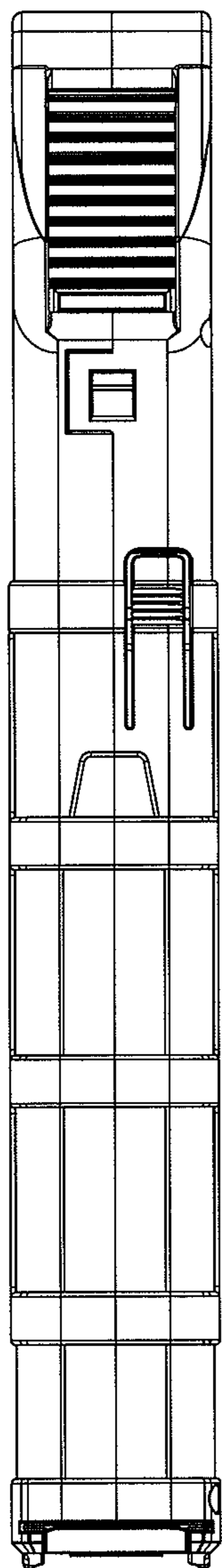

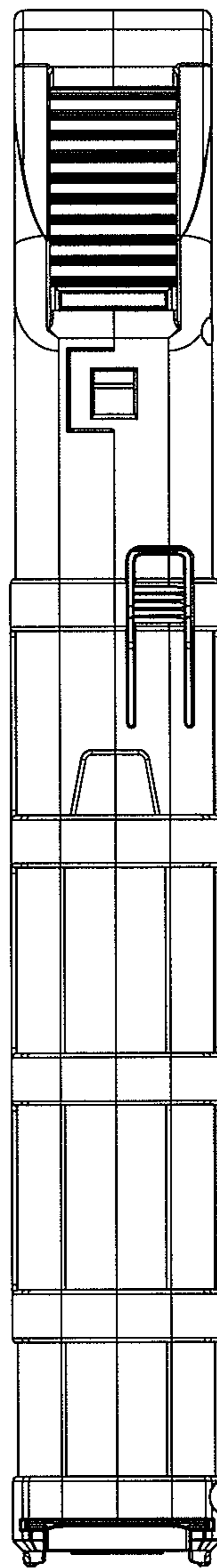

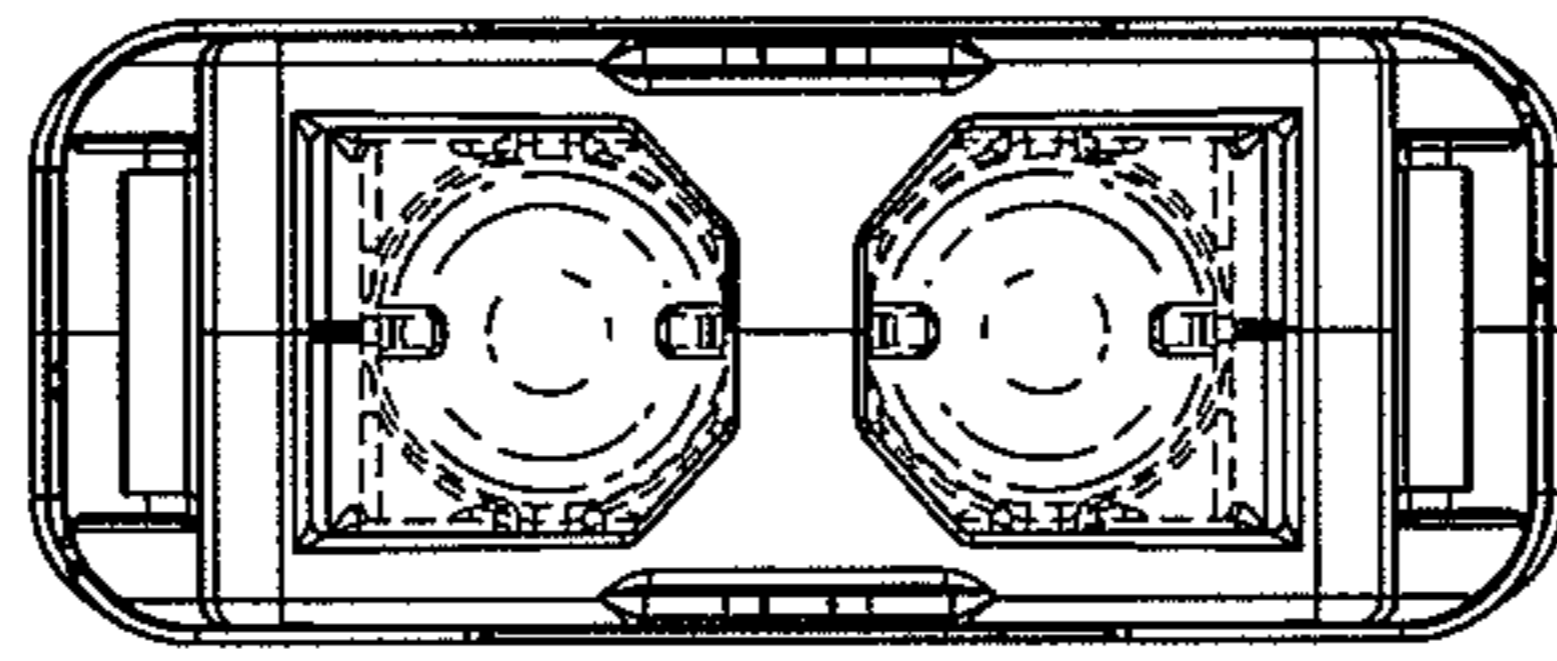

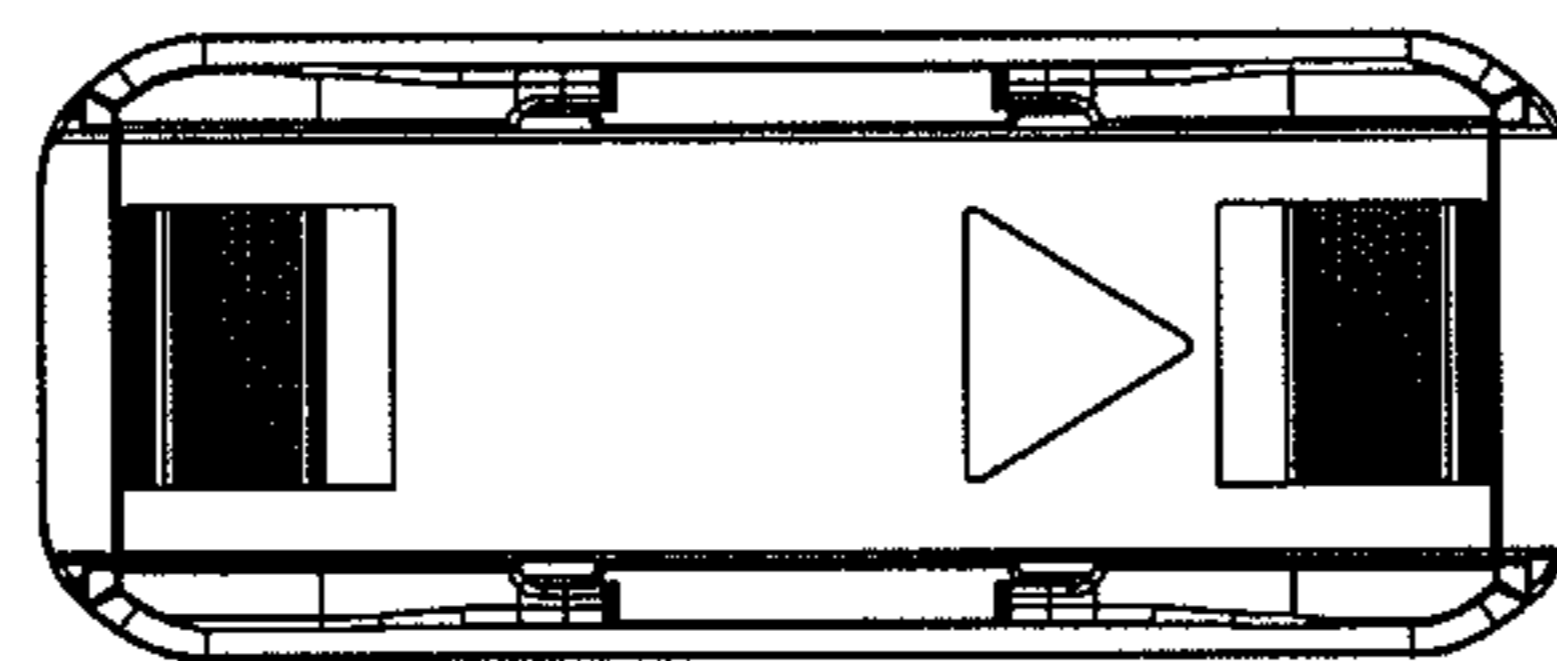
