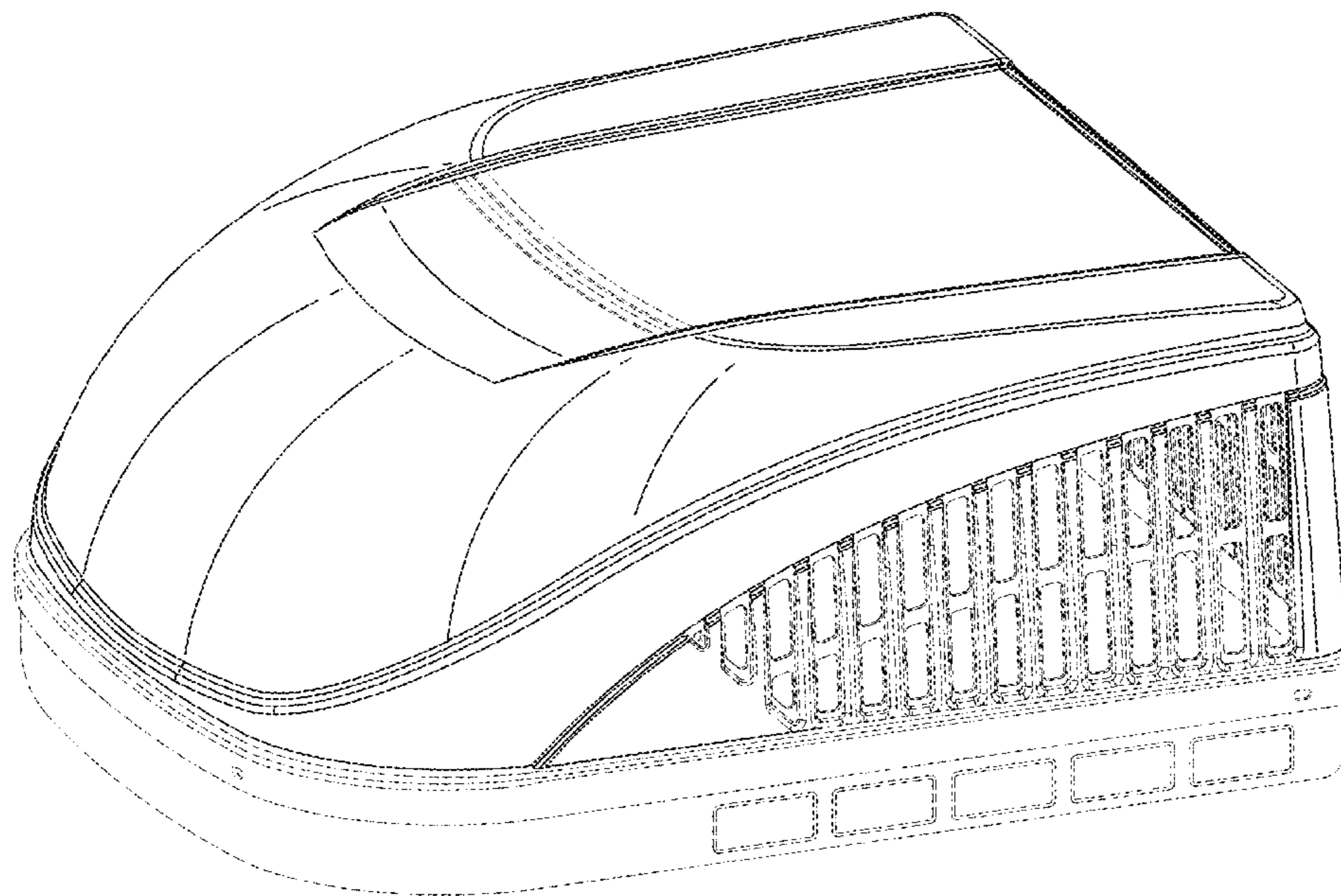
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an exemplary air shroud
showing my design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a front elevational view thereof the exemplary air
shroud of FIG. 1;
FIG. 6 is a top plan view thereof; and,

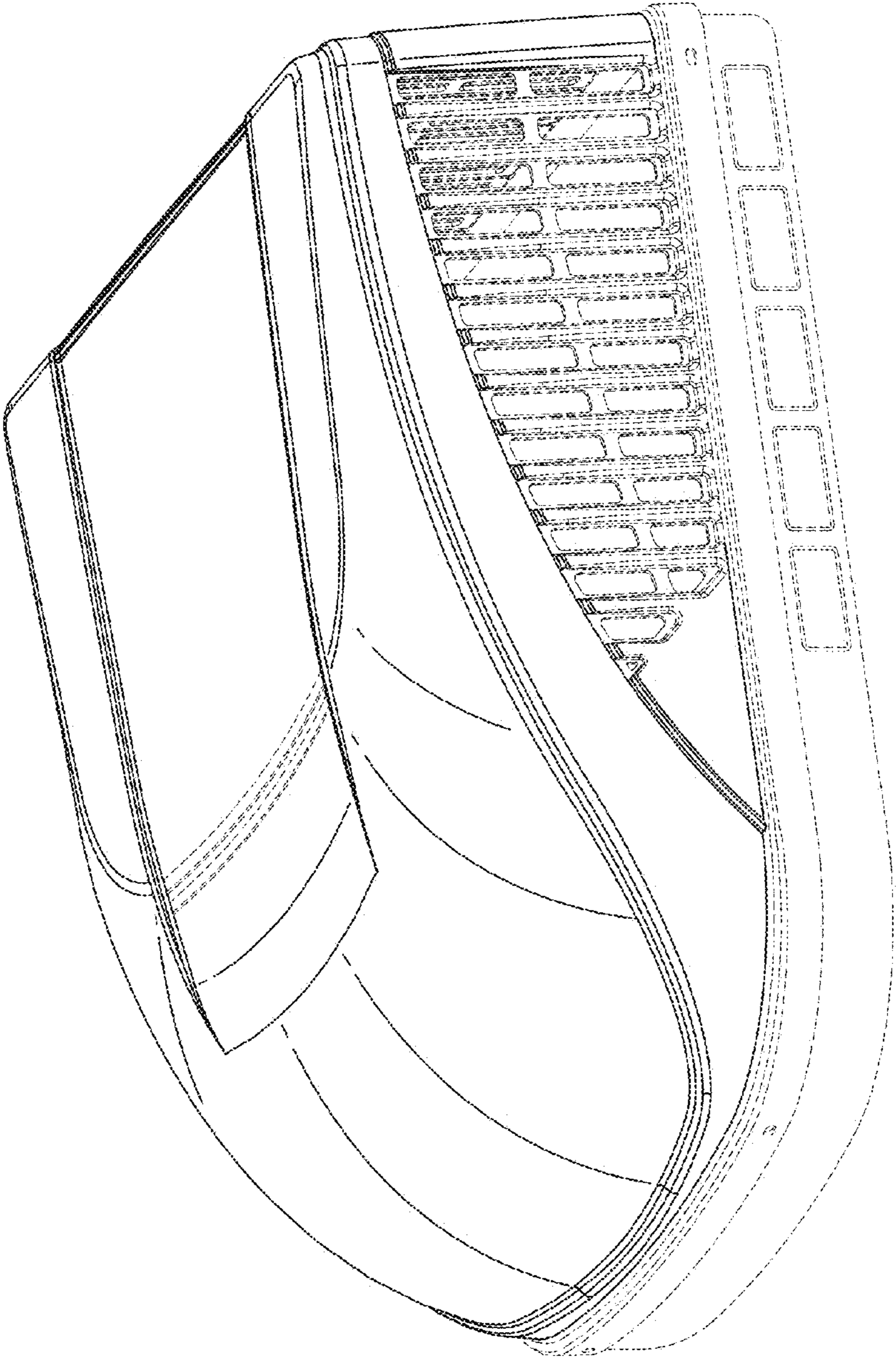

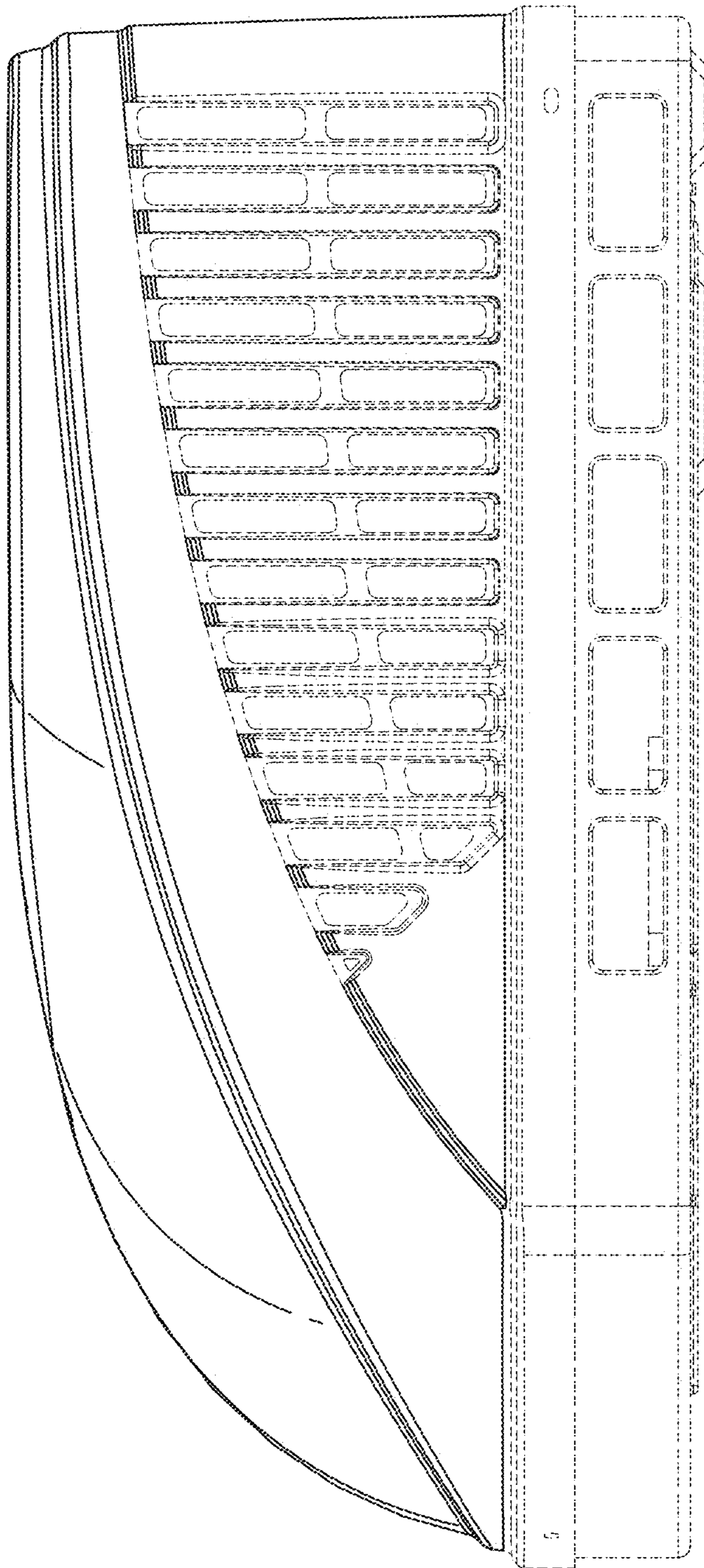

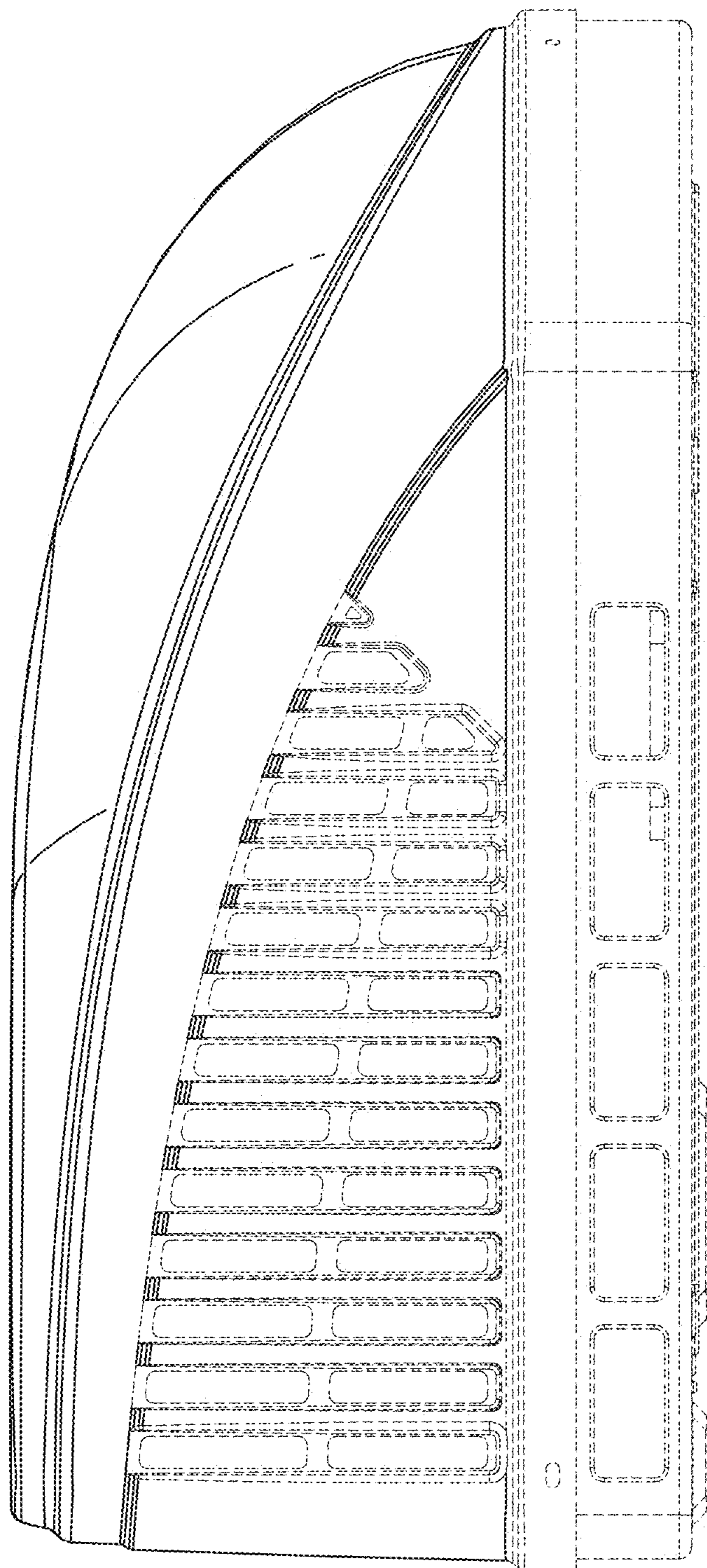

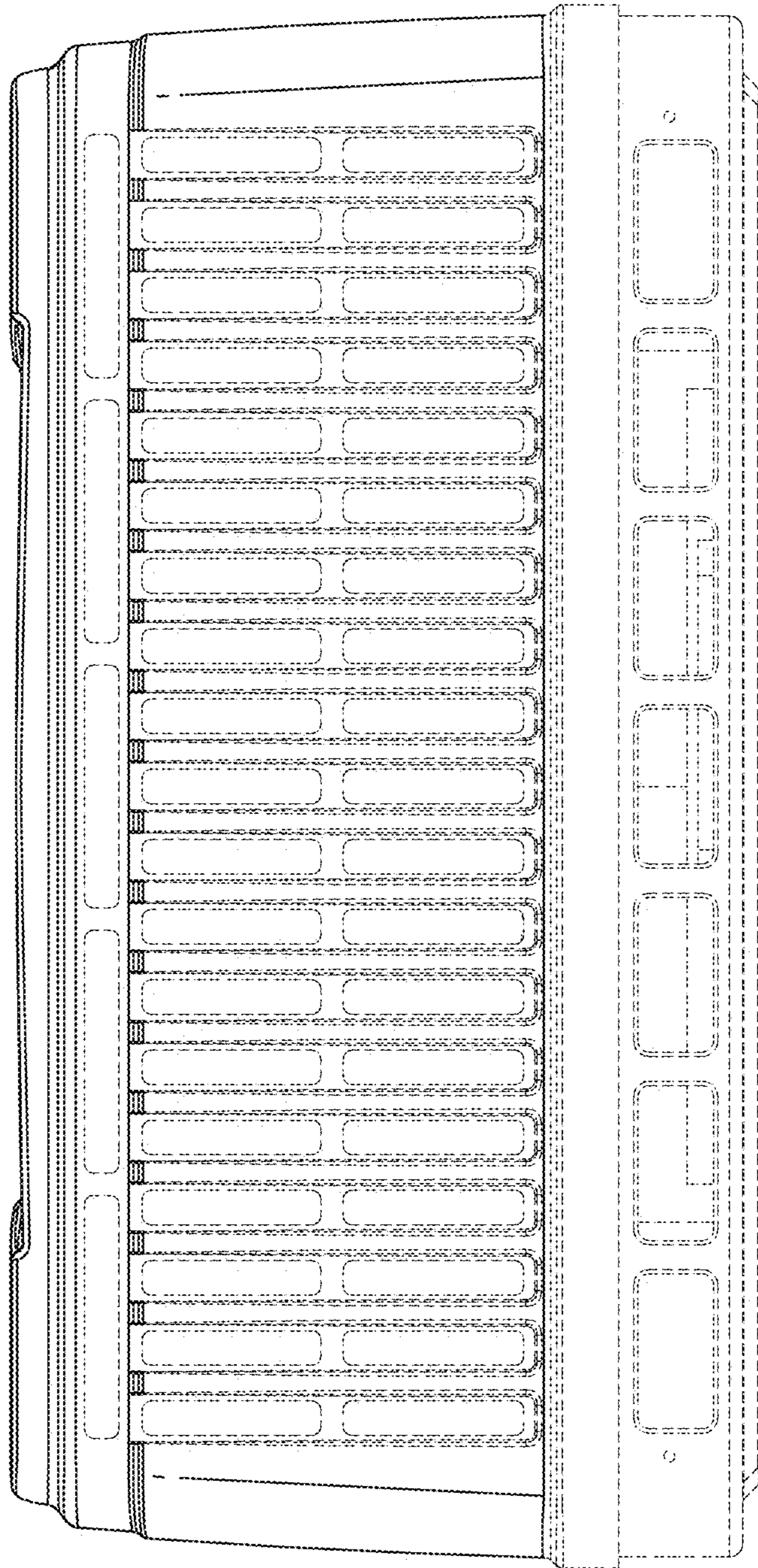

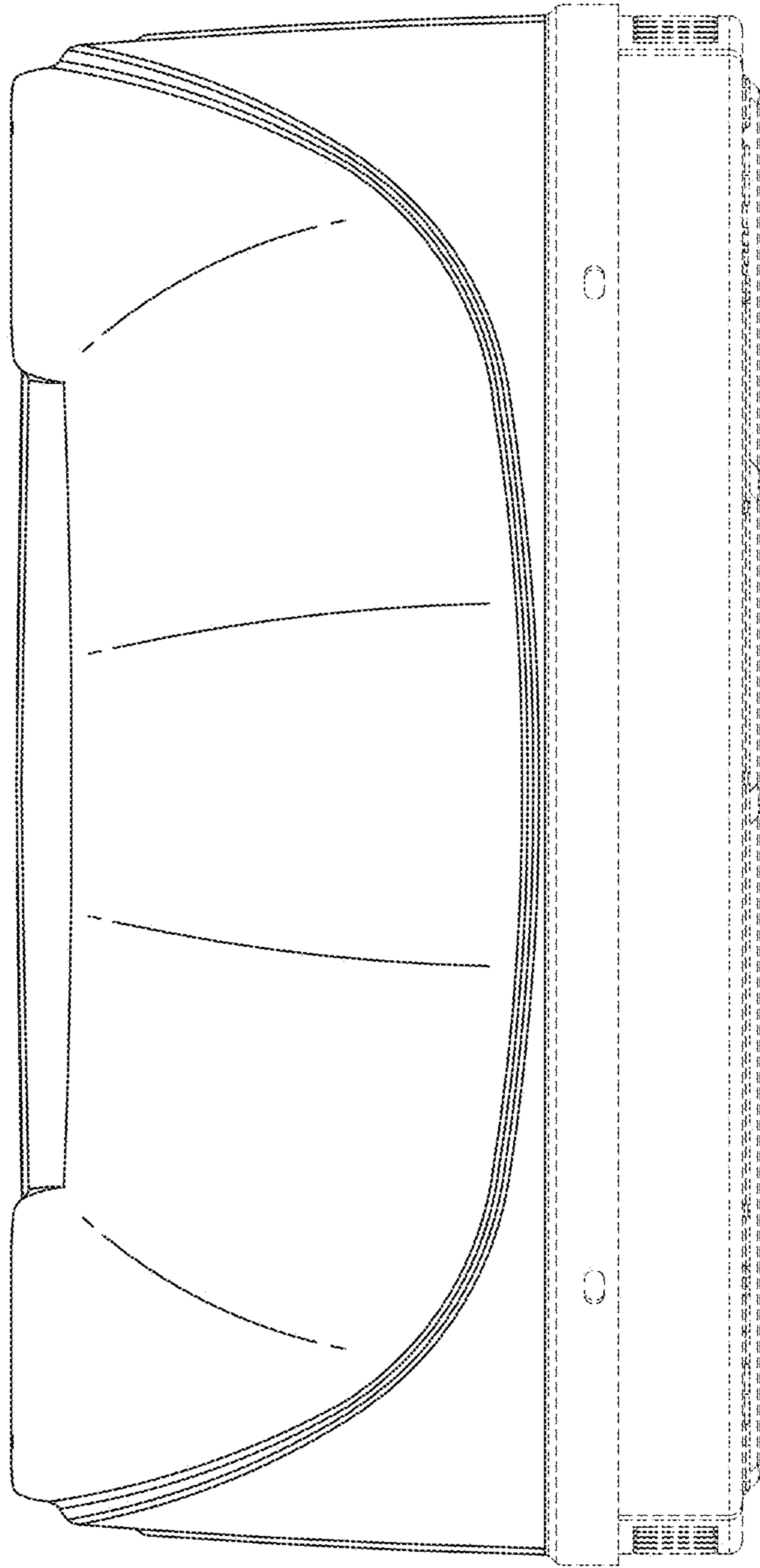

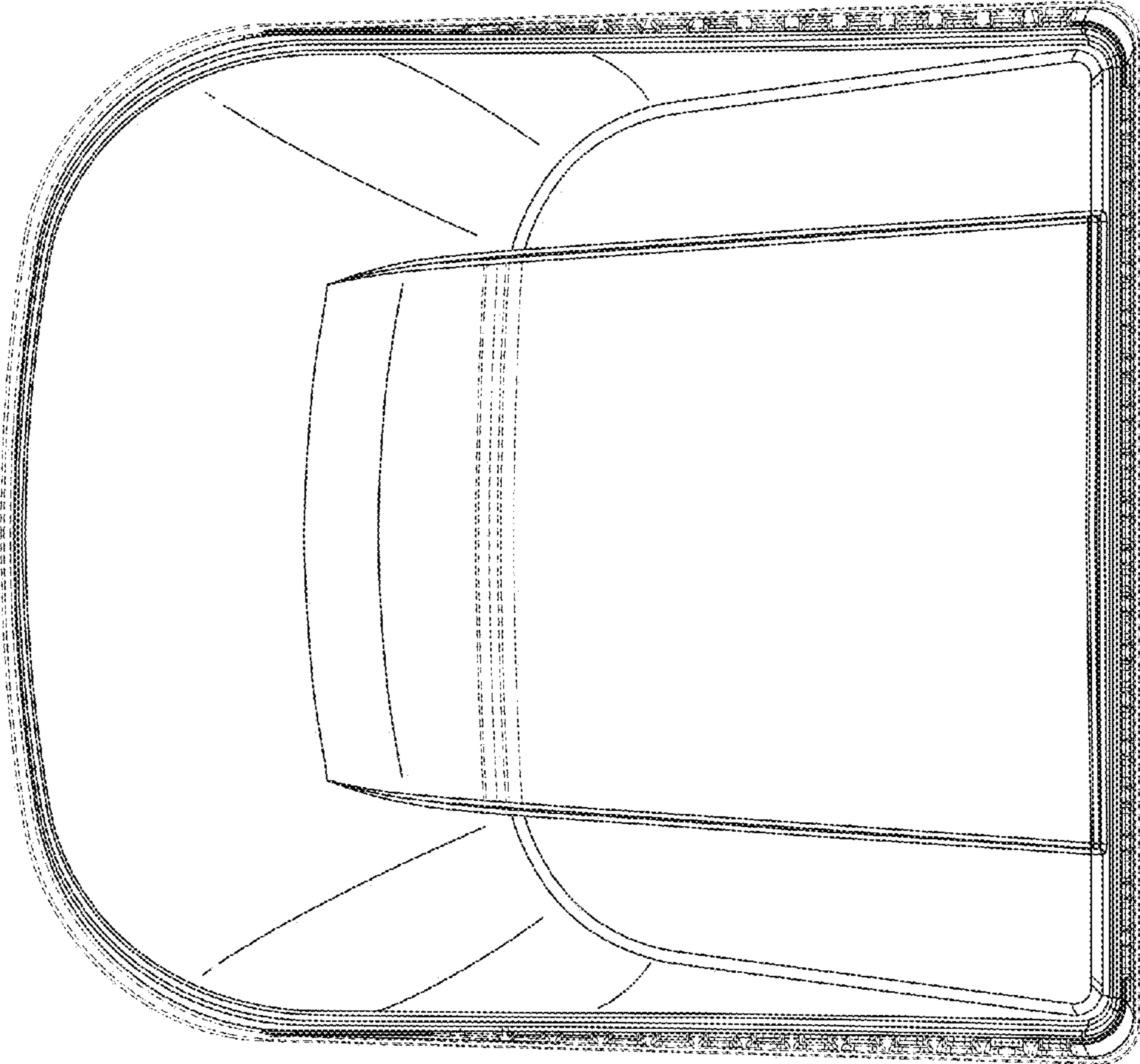

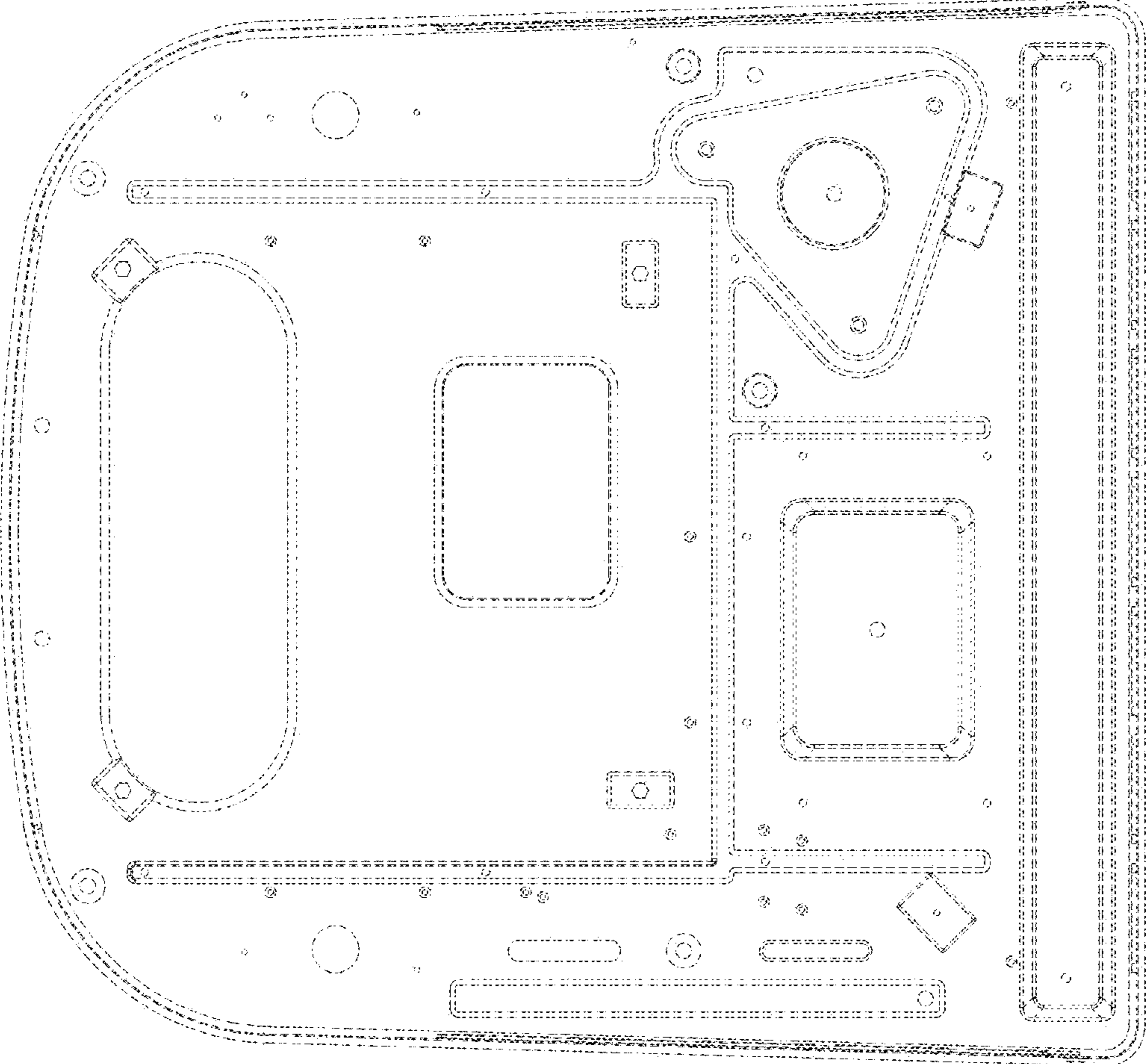
