FIG. 21 is a bottom plan view of the inhaler of FIG. 15;

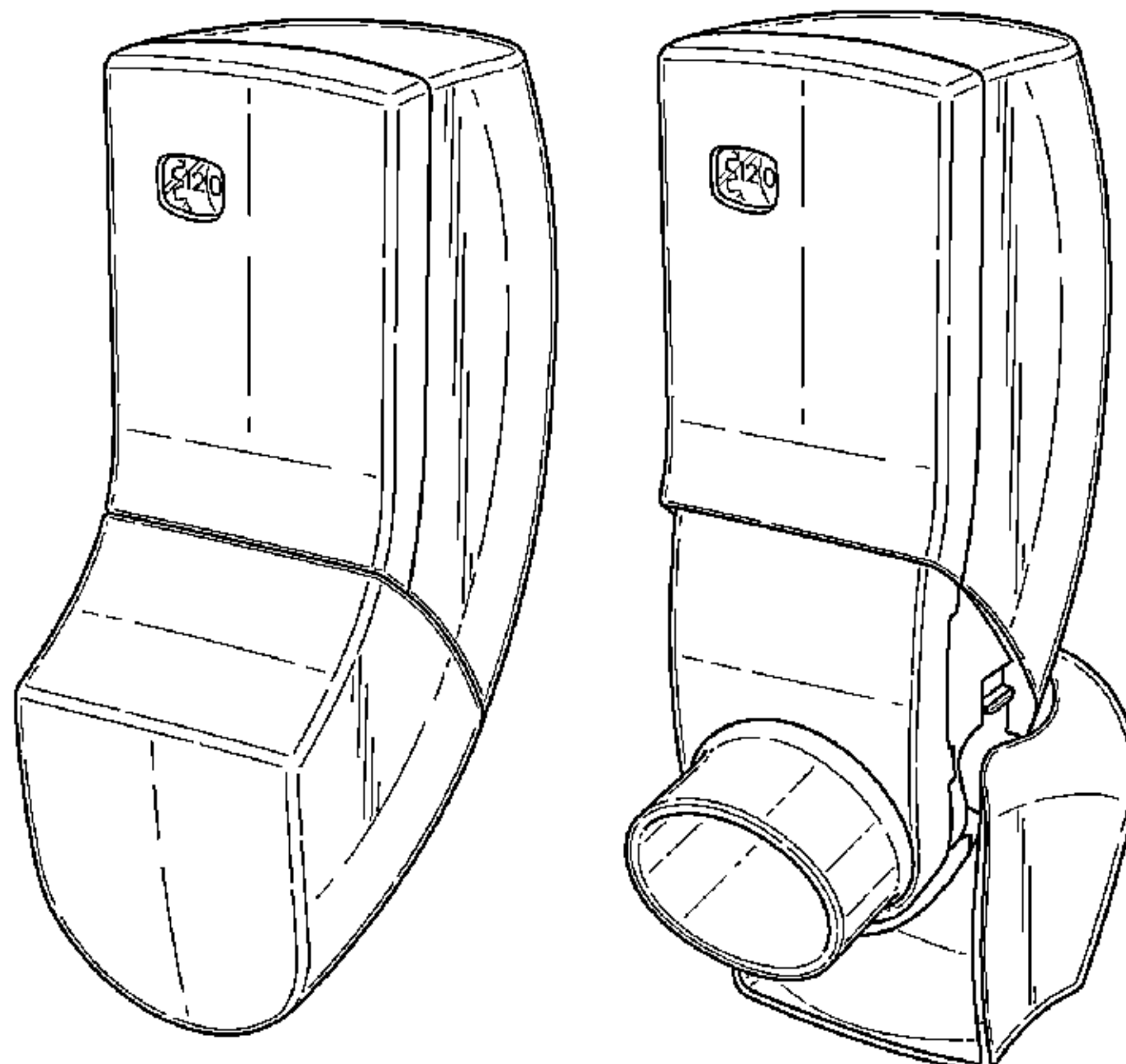


FIG. 22 is a perspective view of an inhaler with a closed mouthpiece showing the second embodiment of our new design;

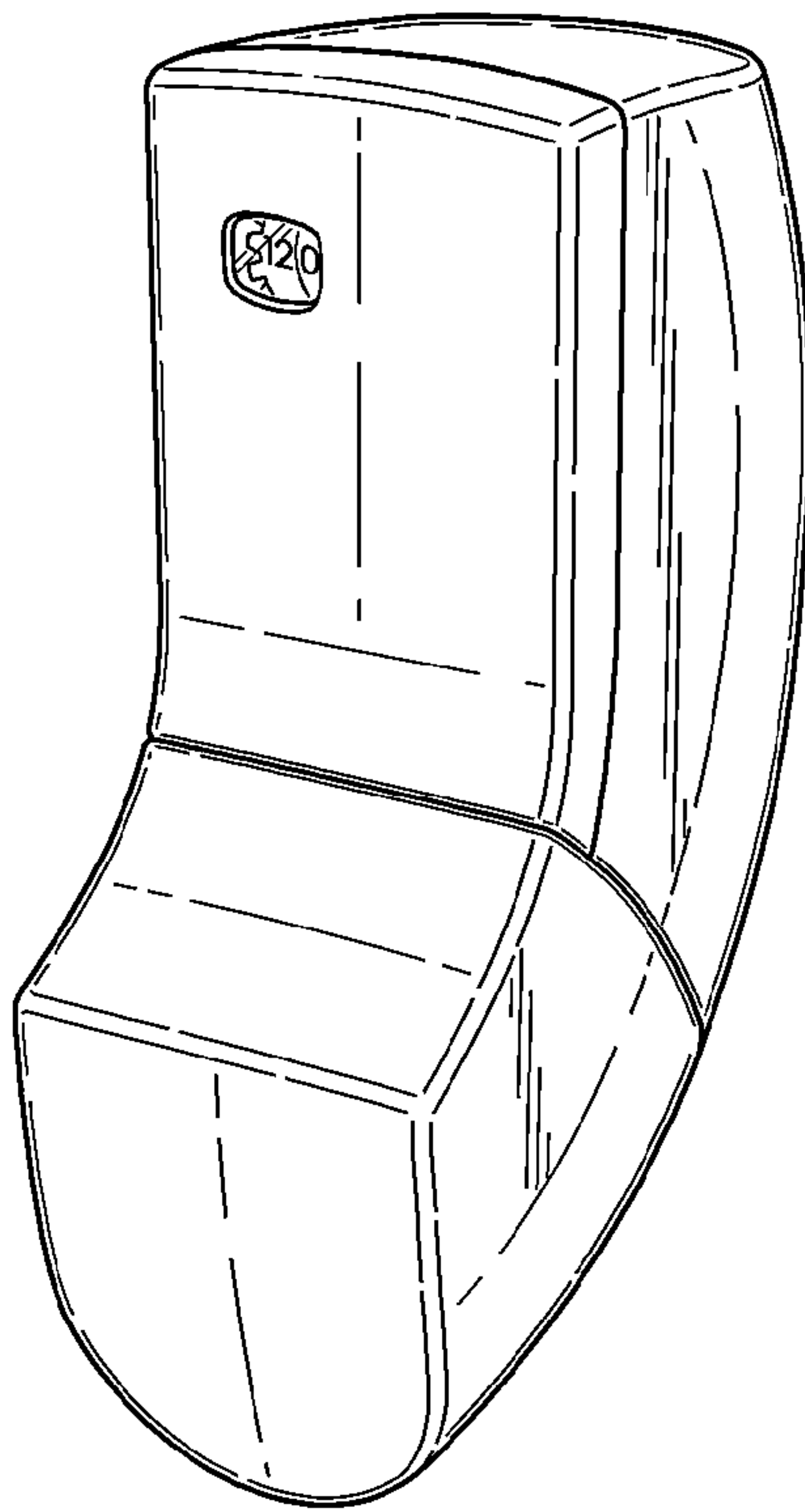

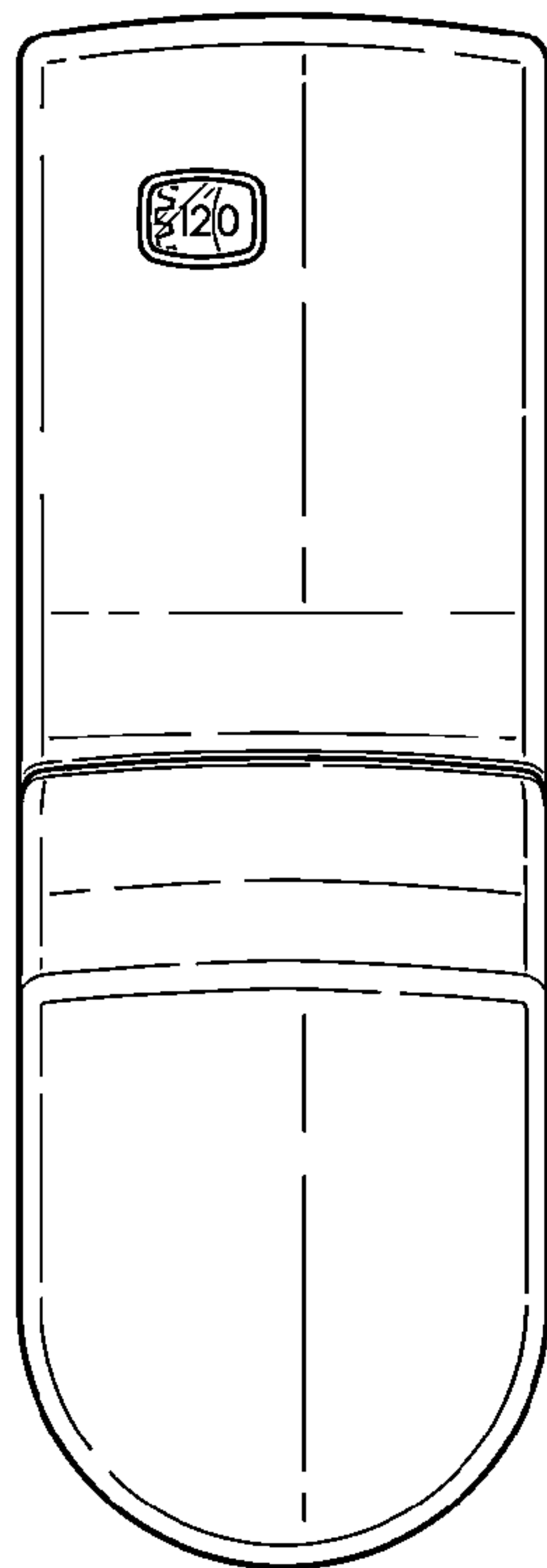

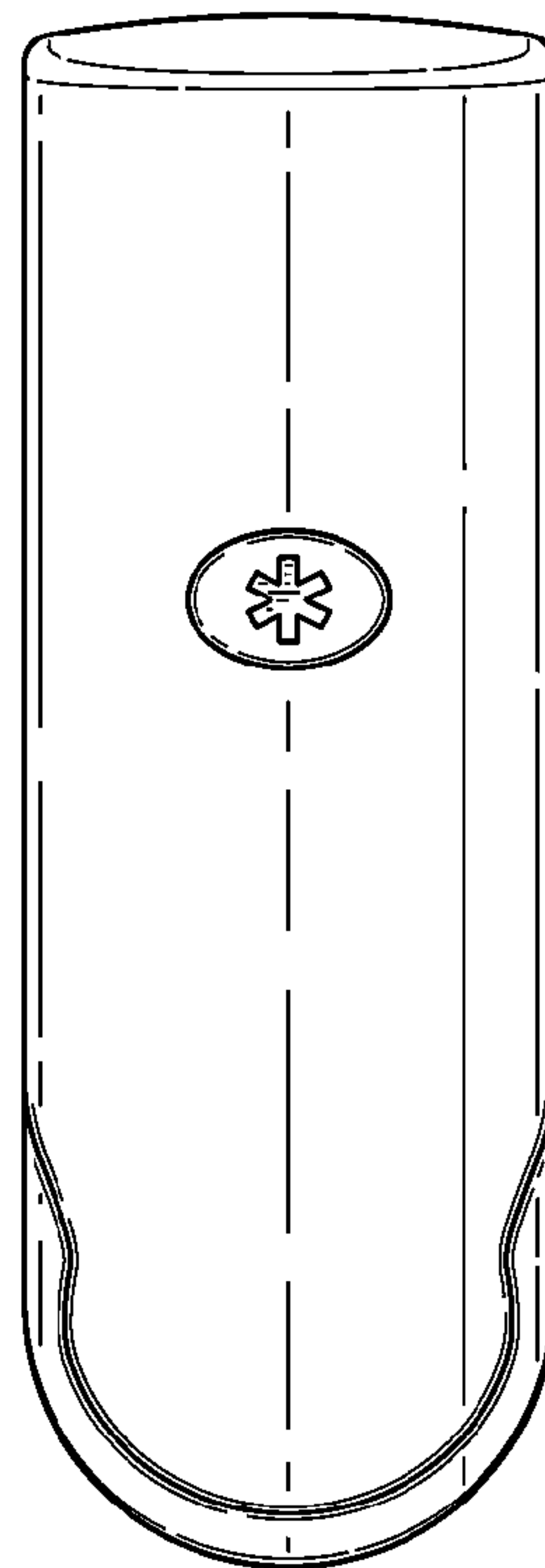

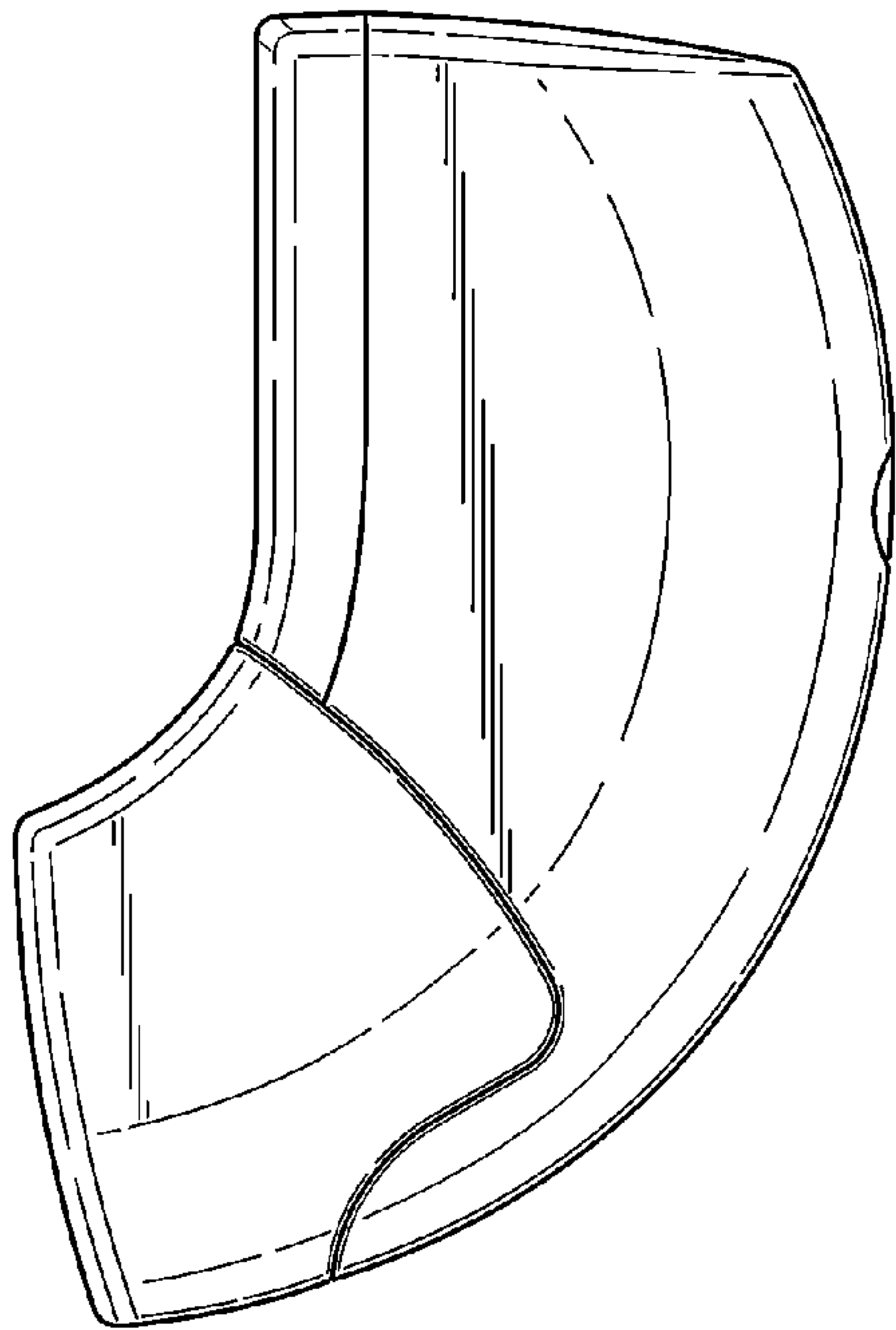

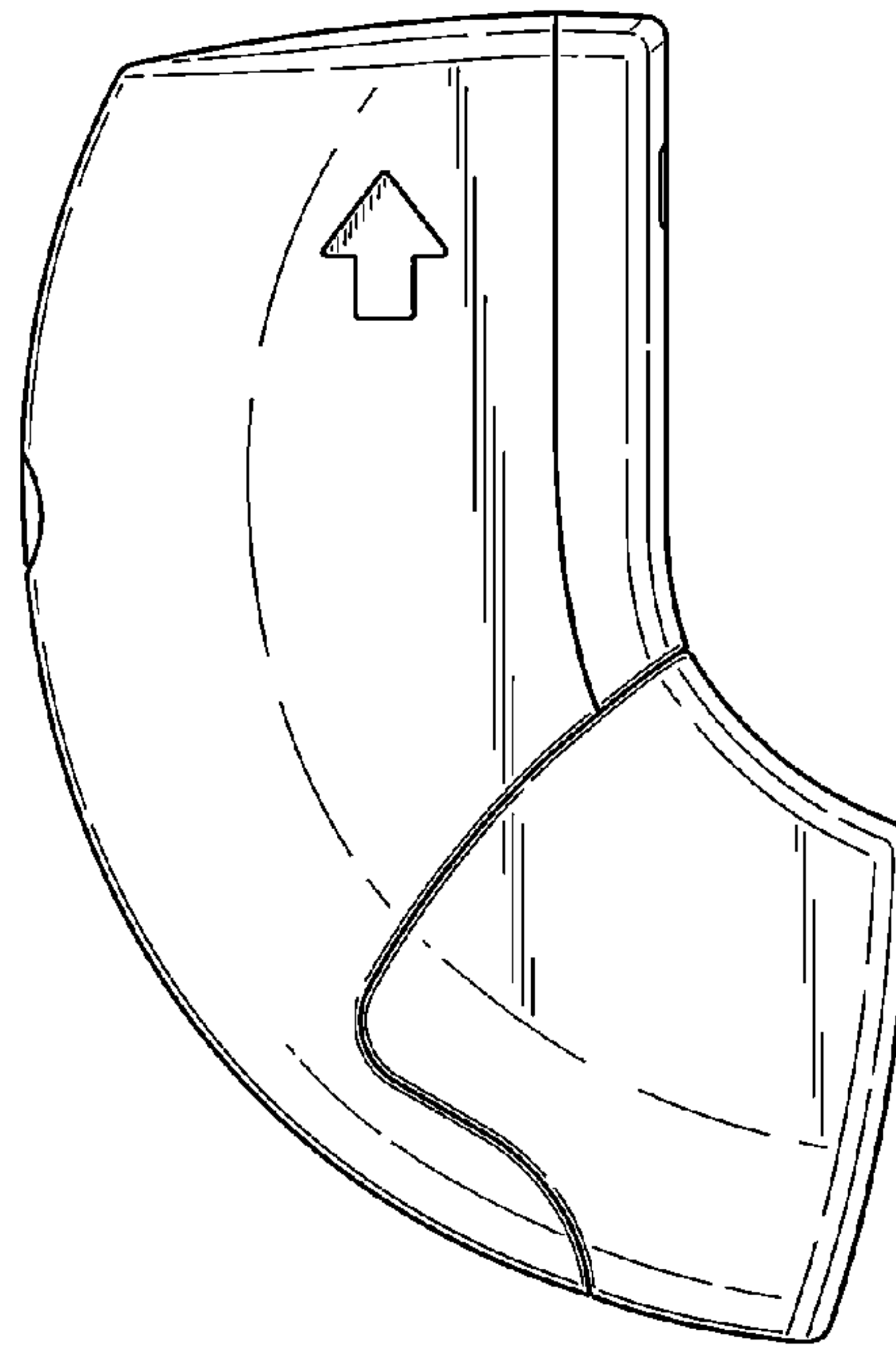

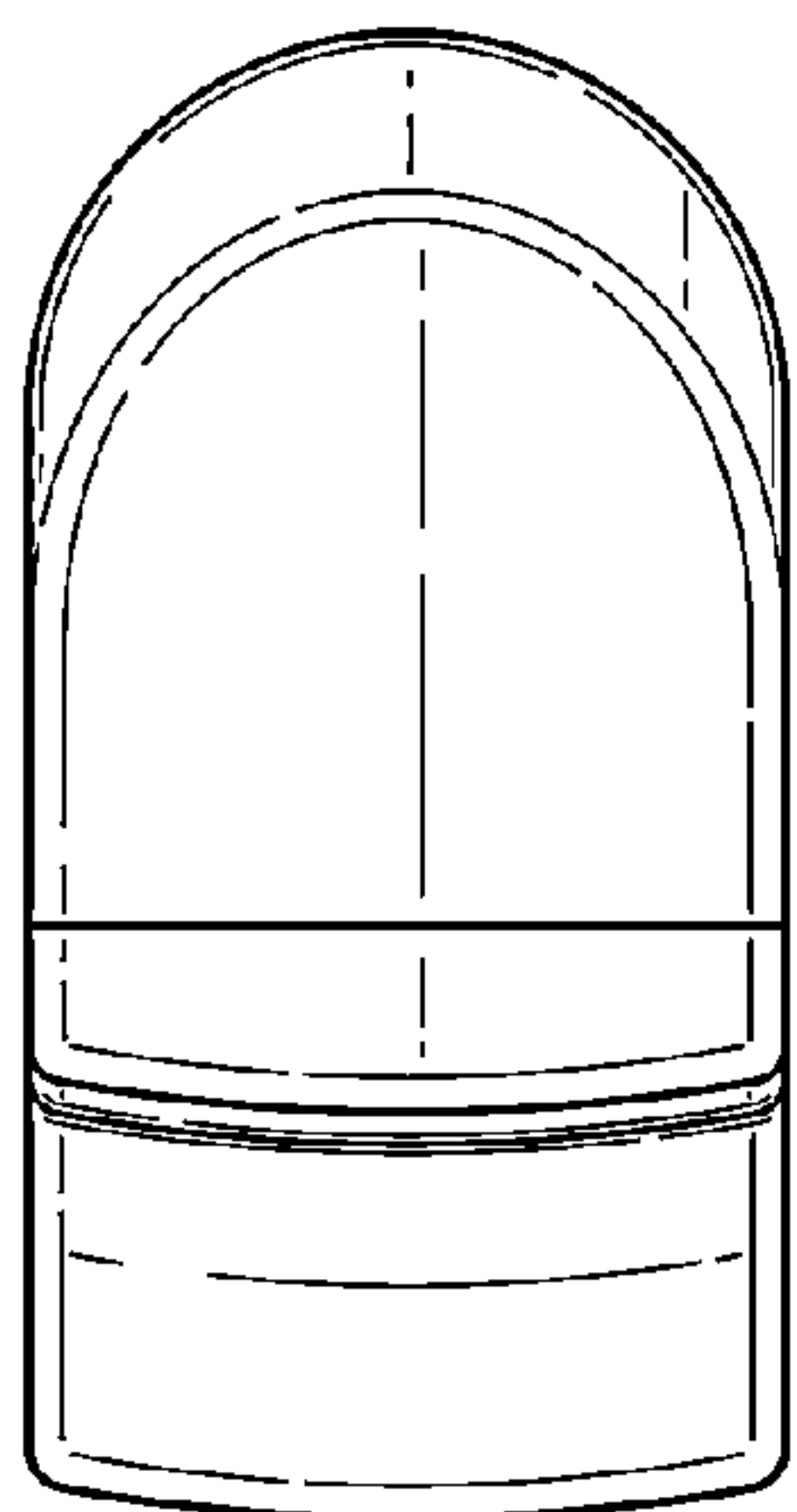

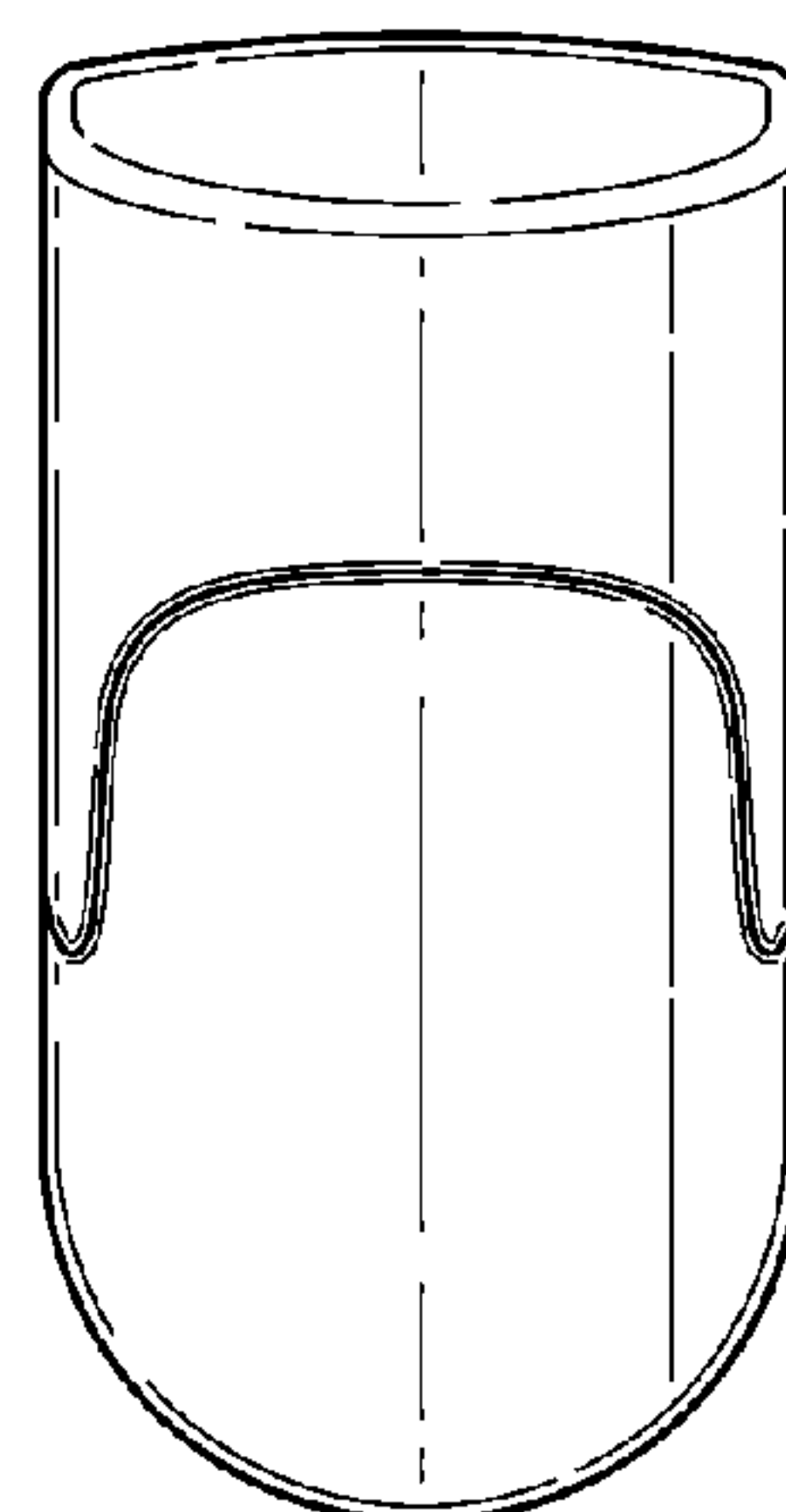

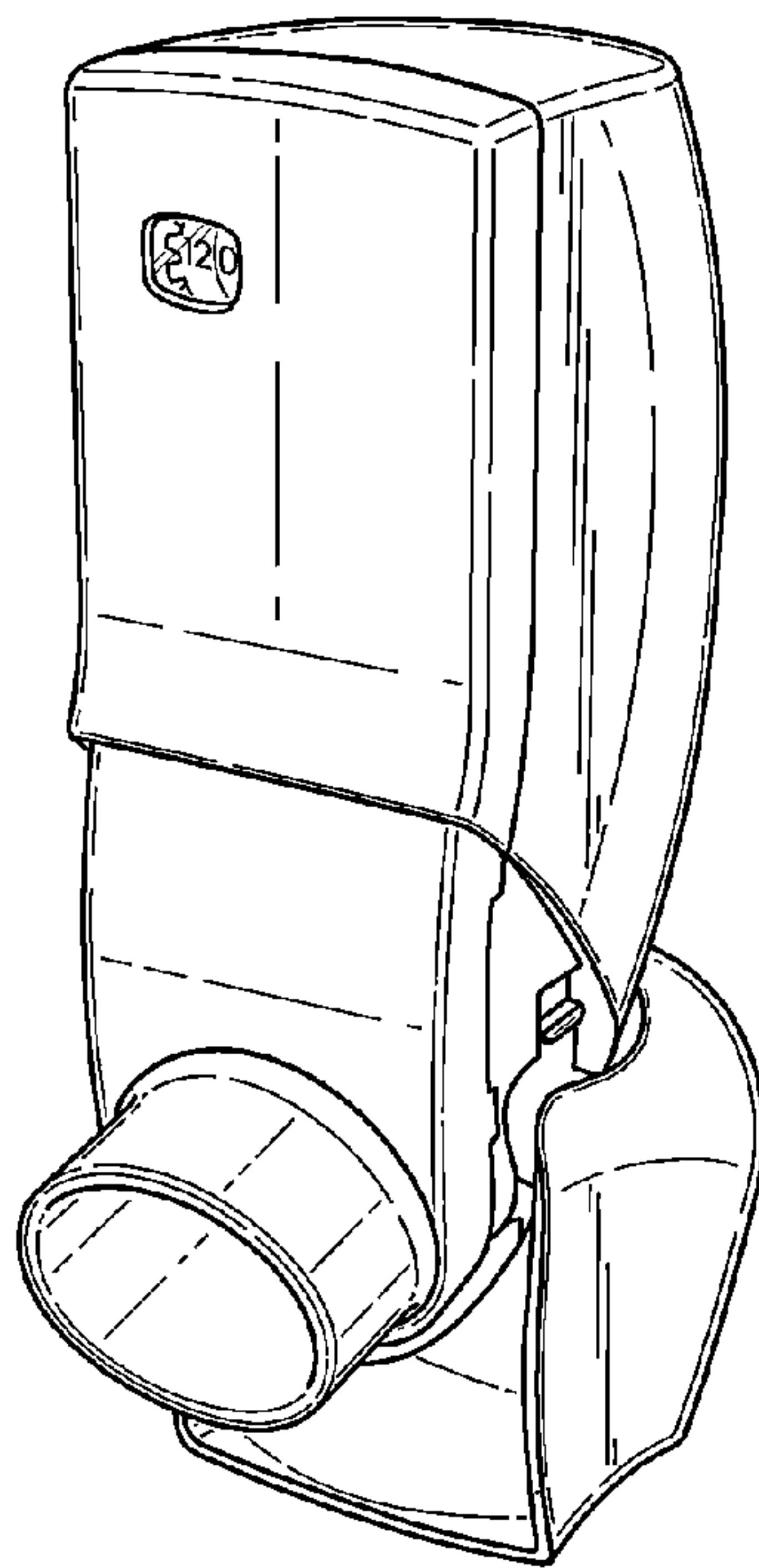

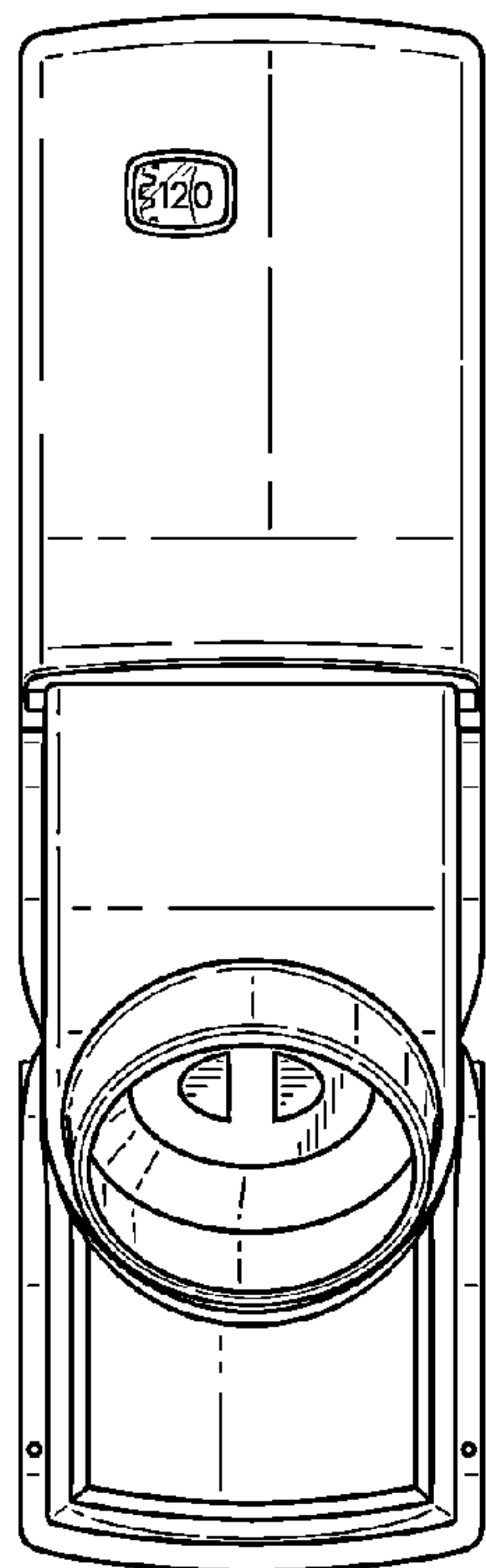

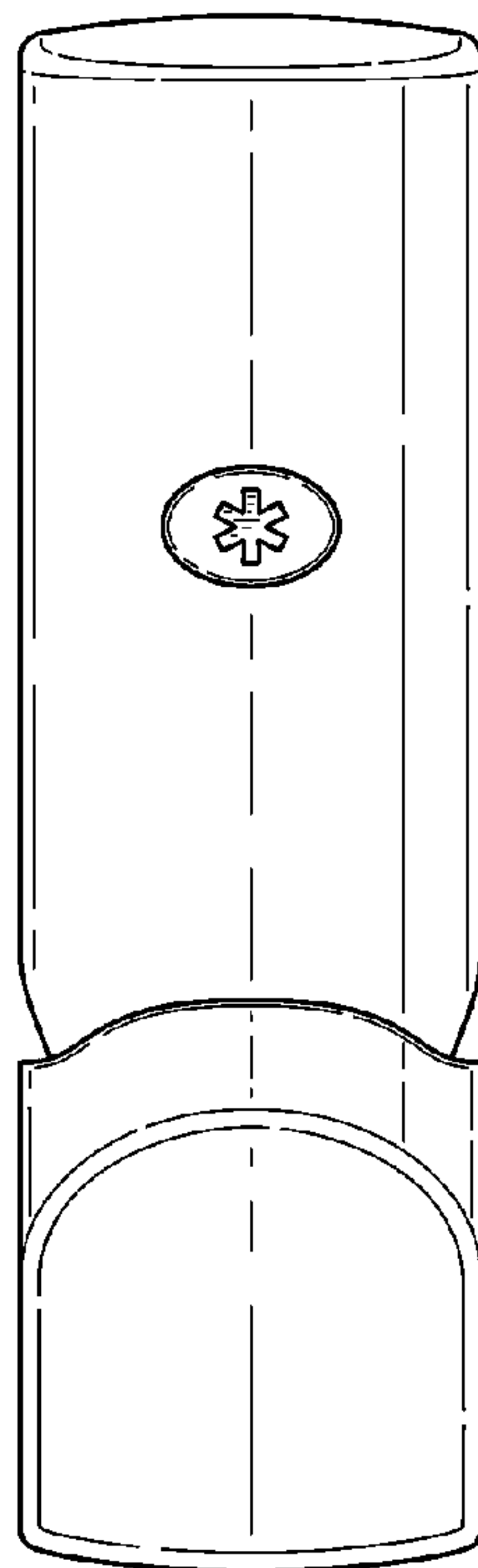

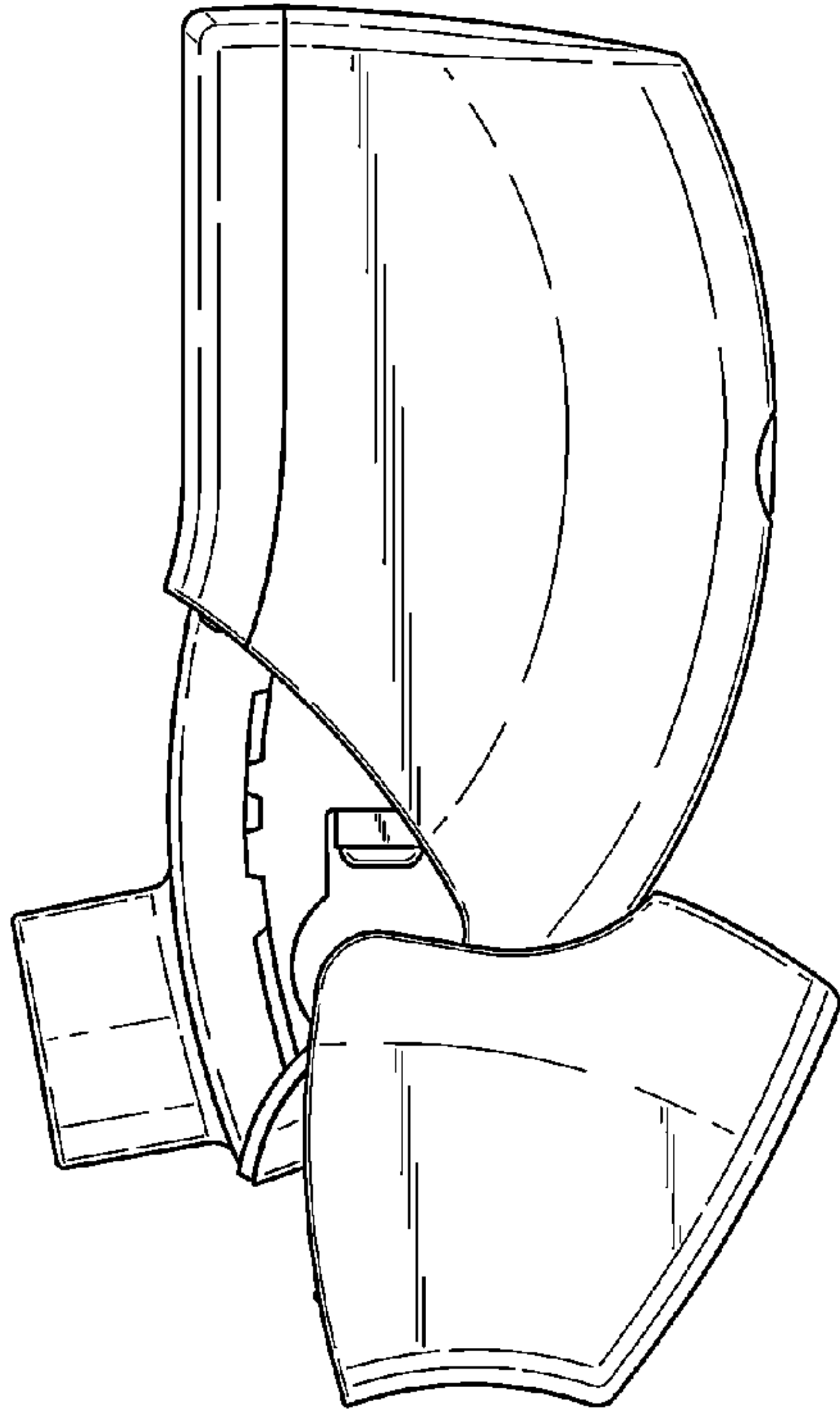

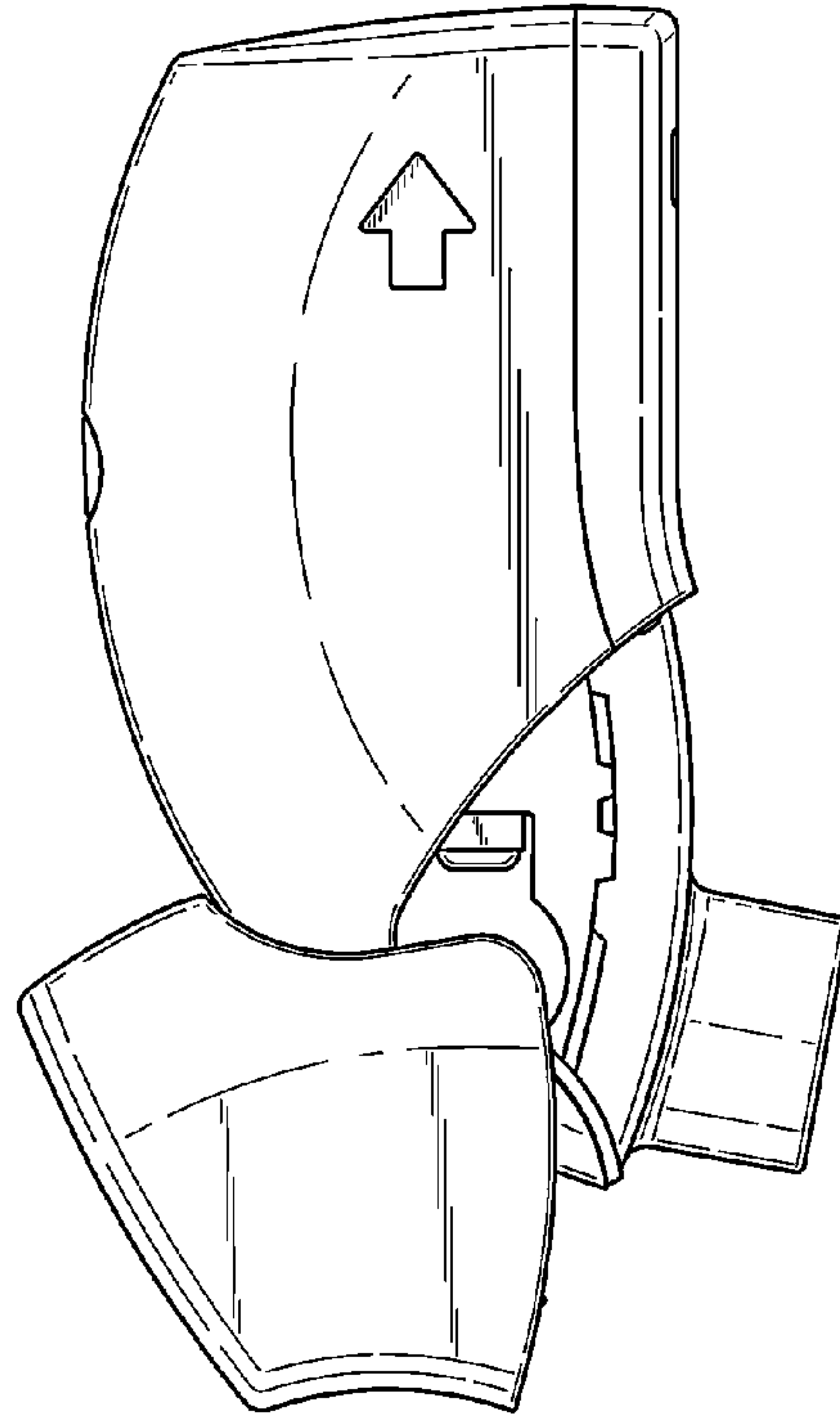

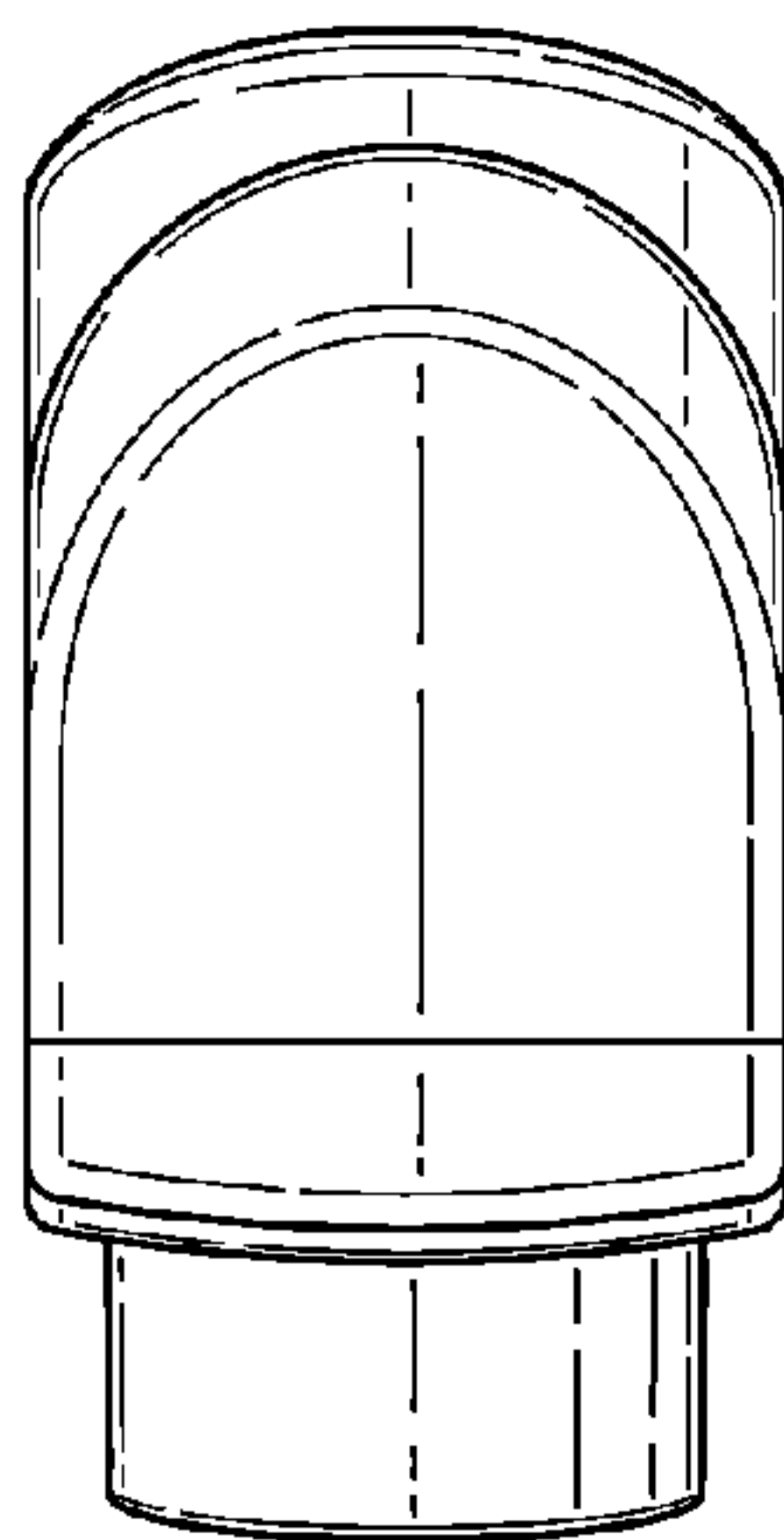

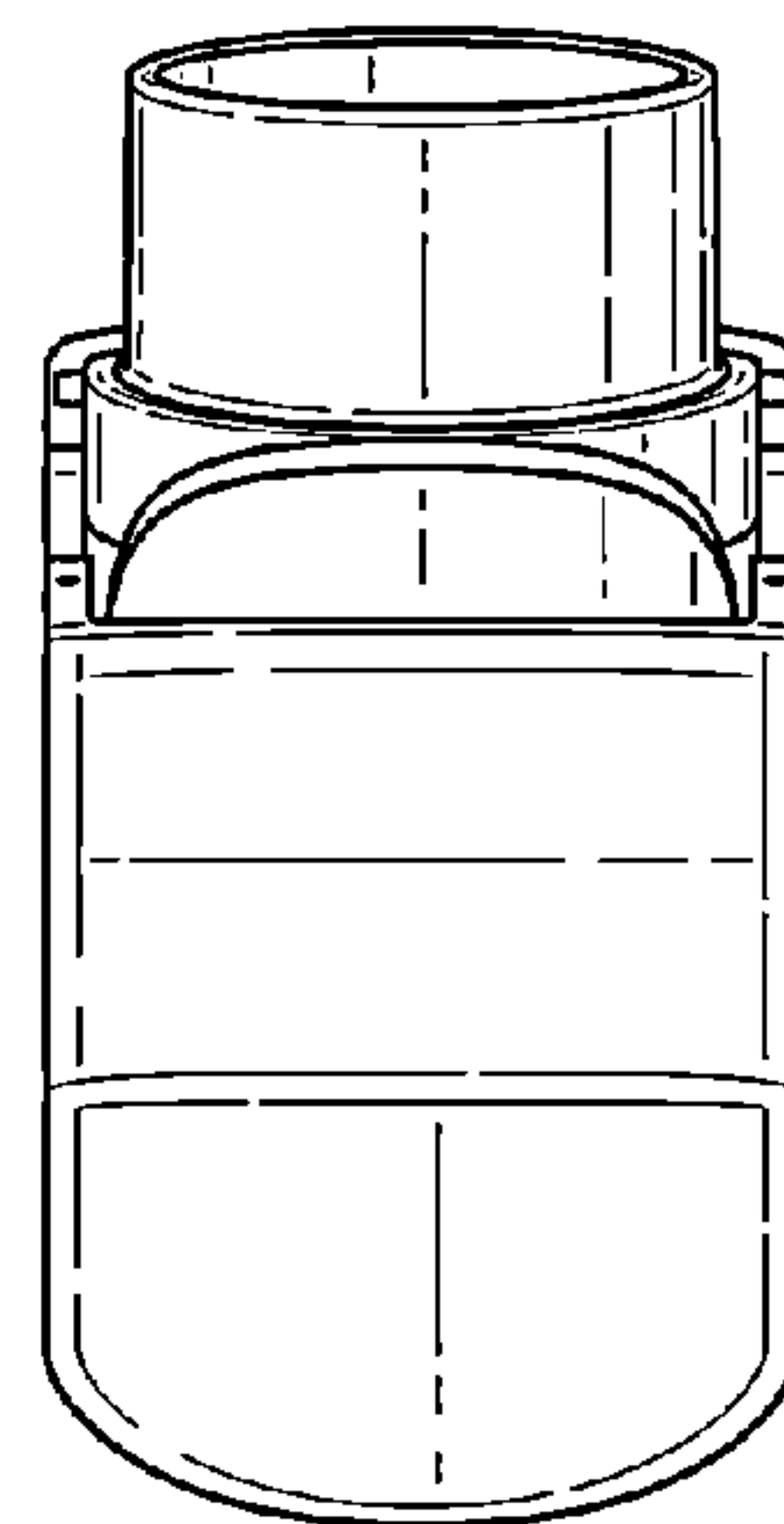

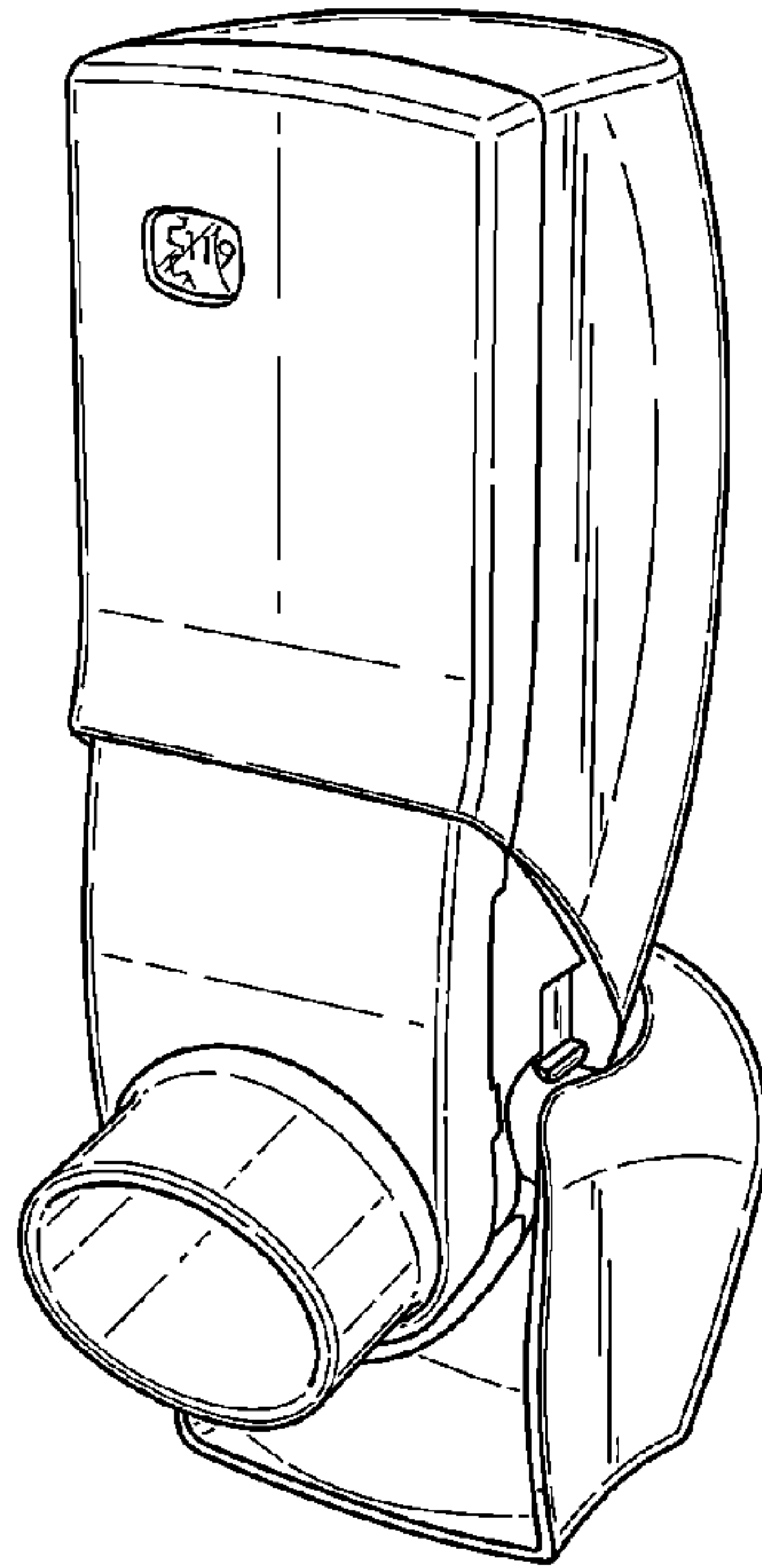

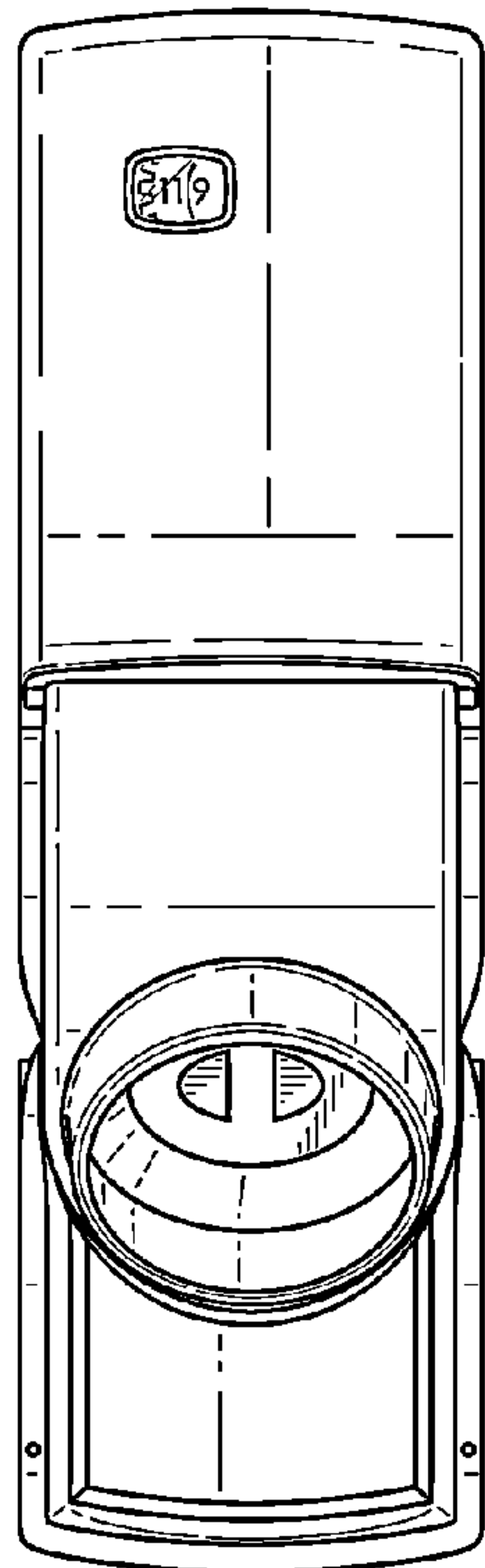

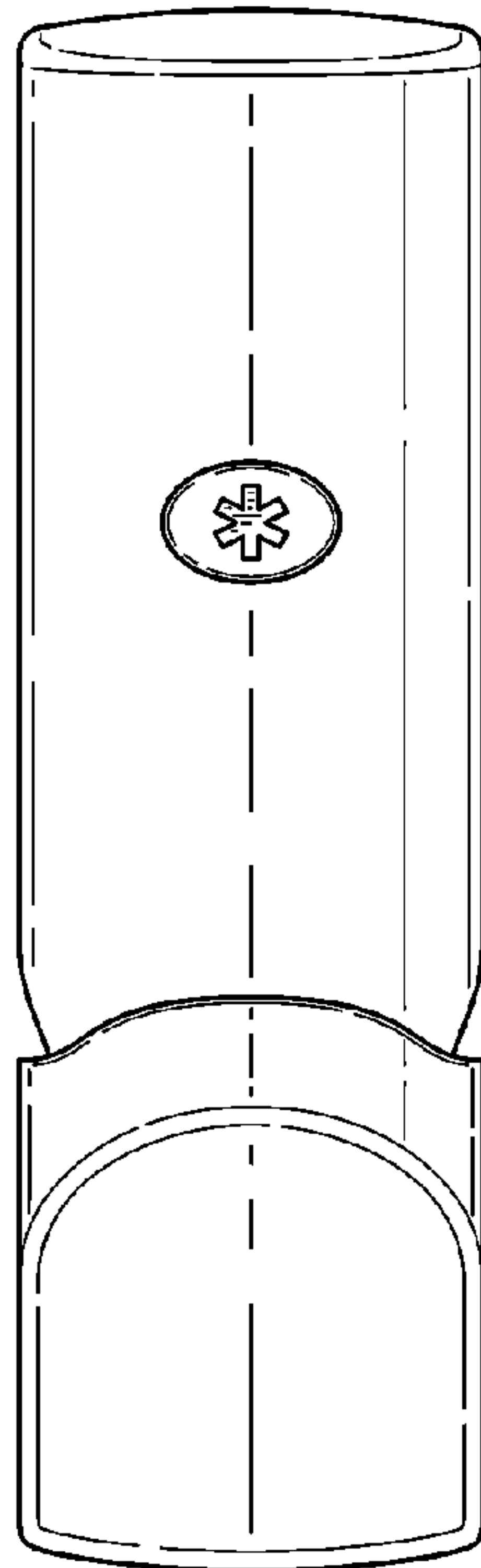

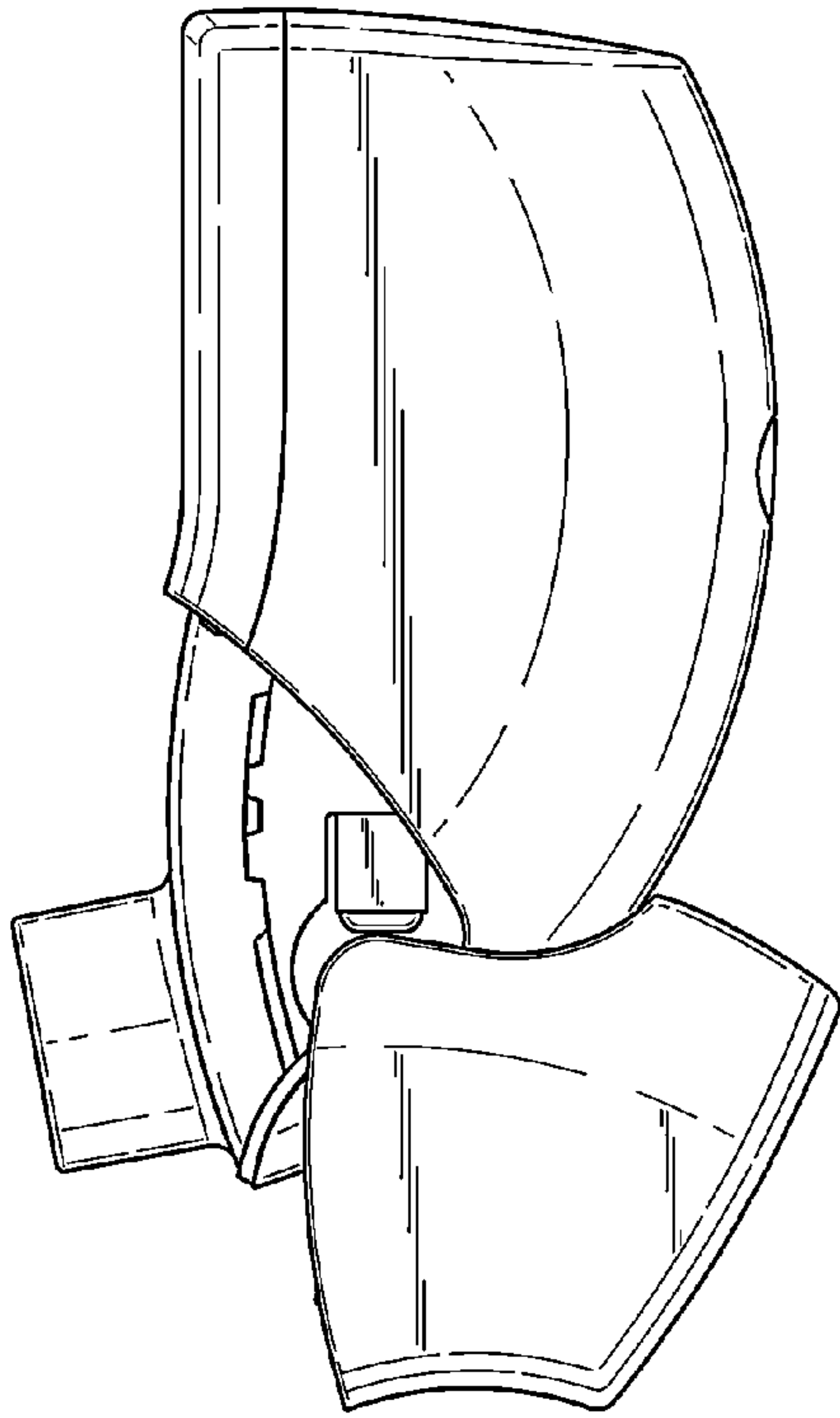

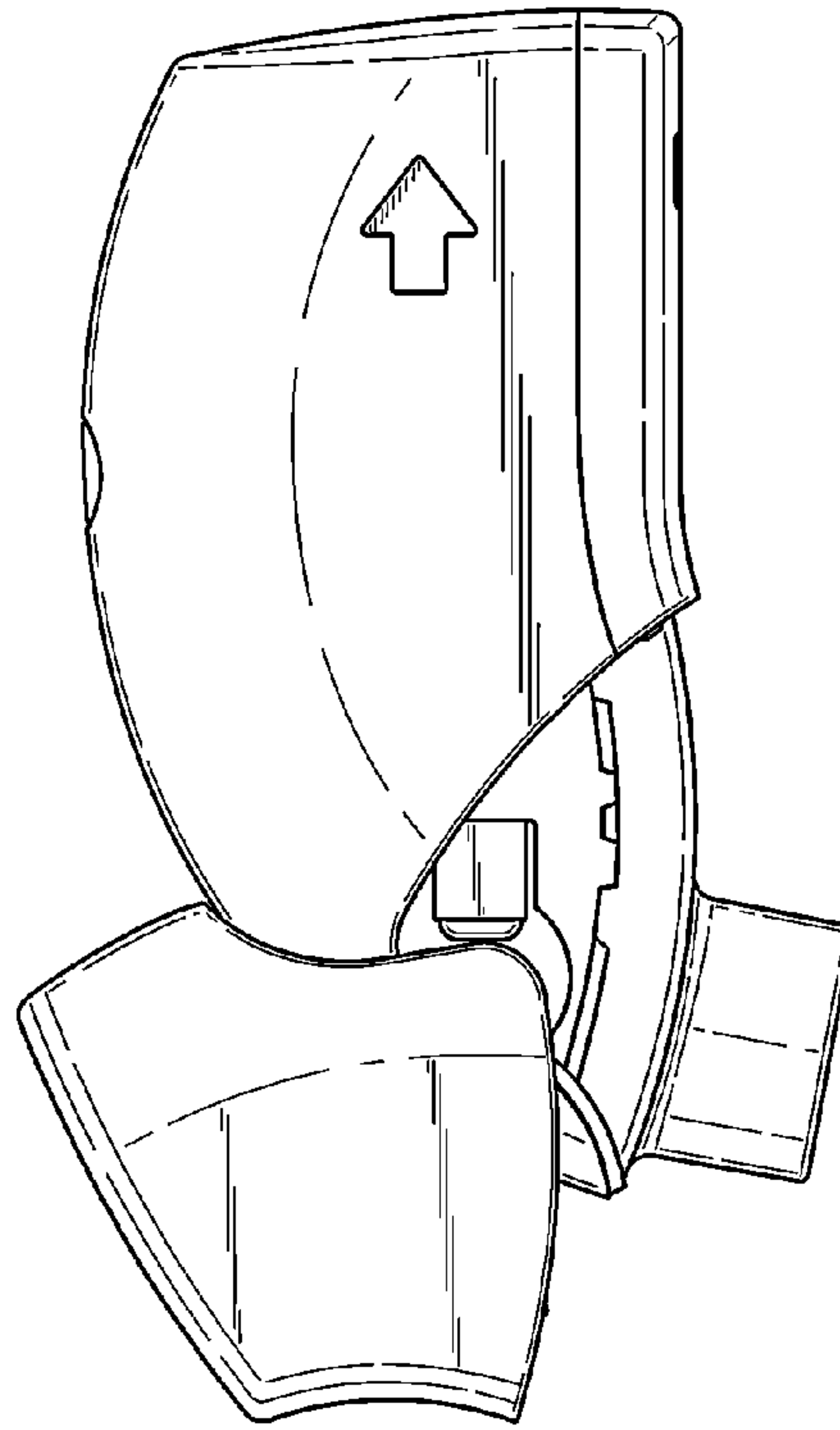

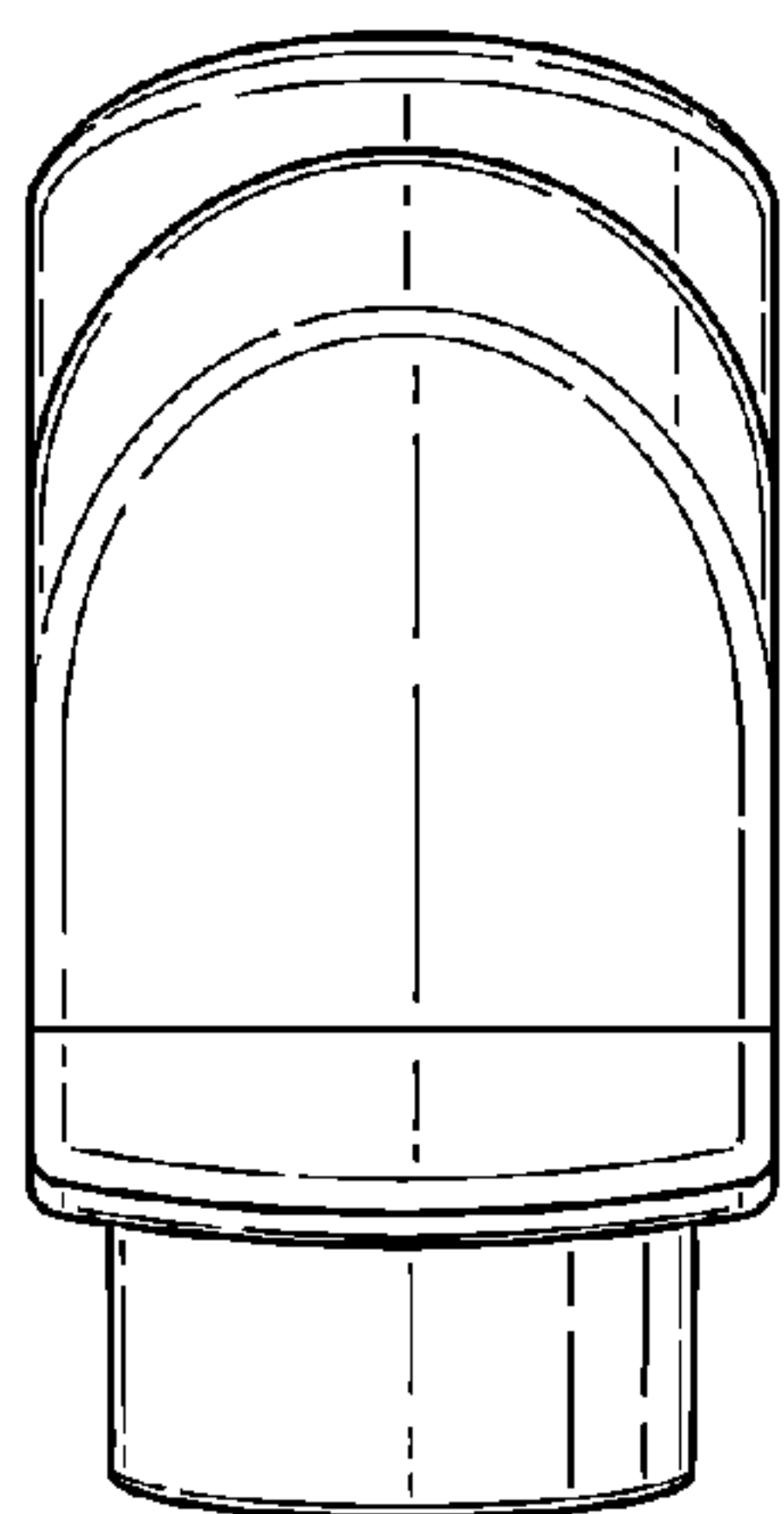

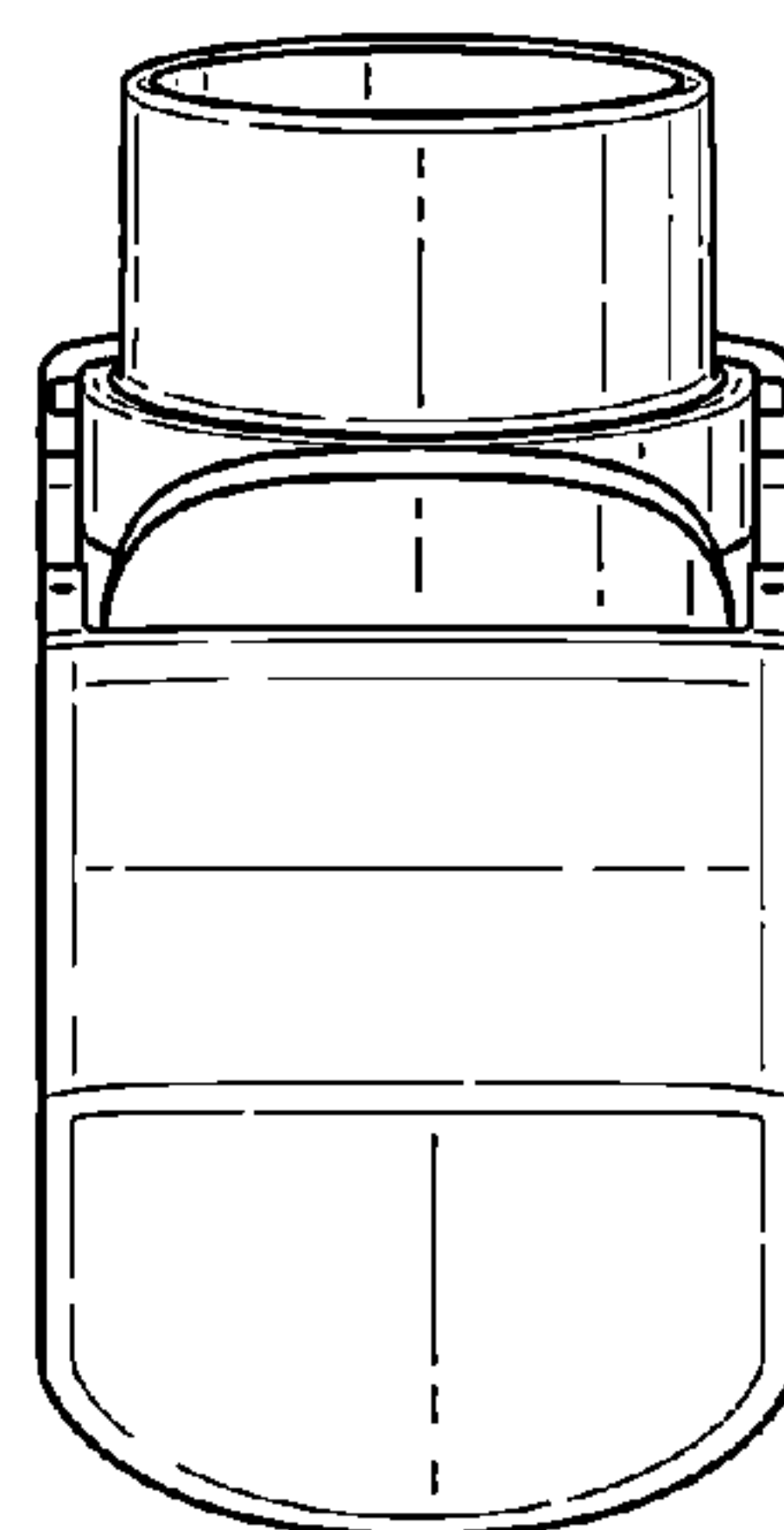

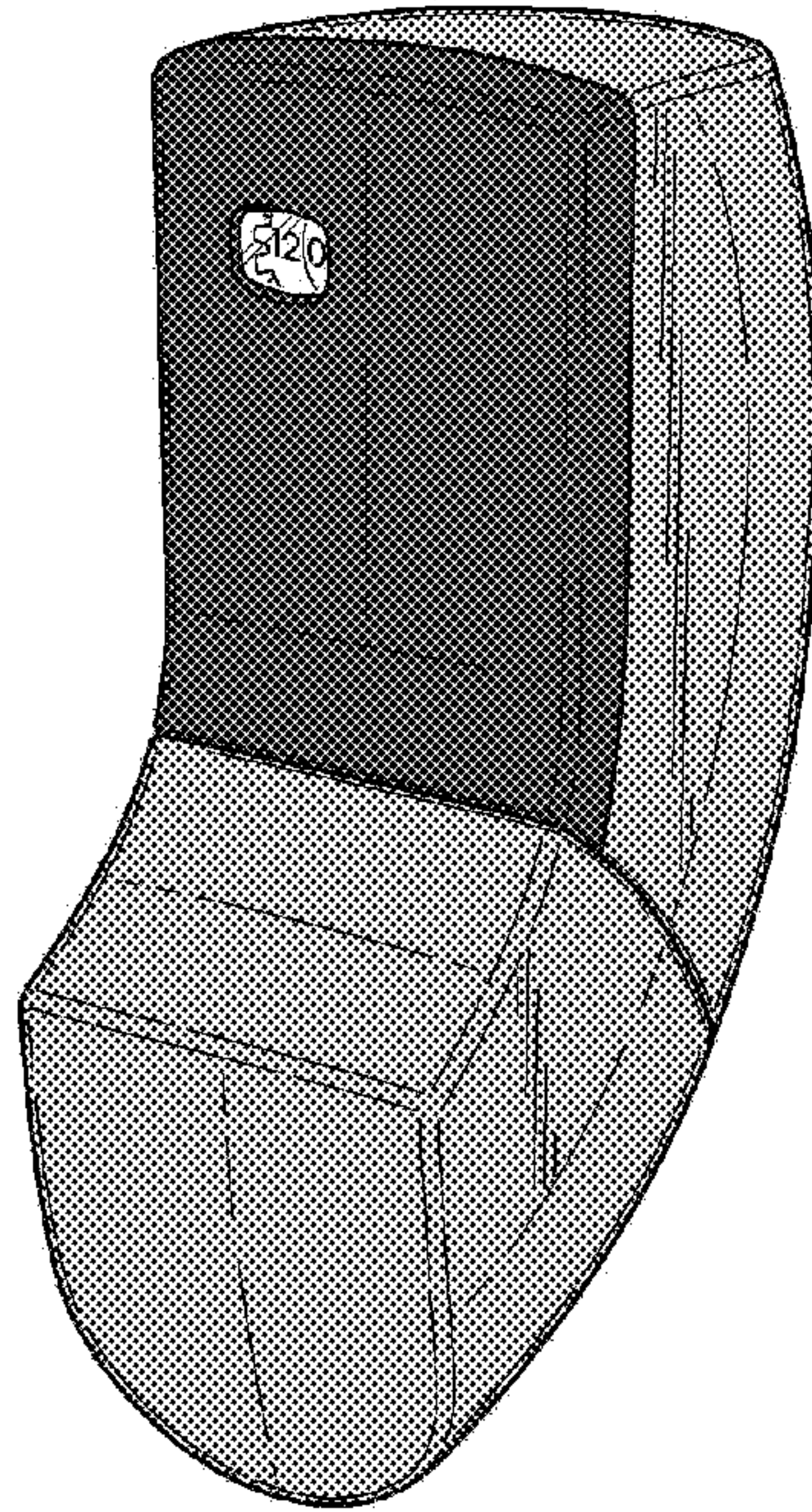

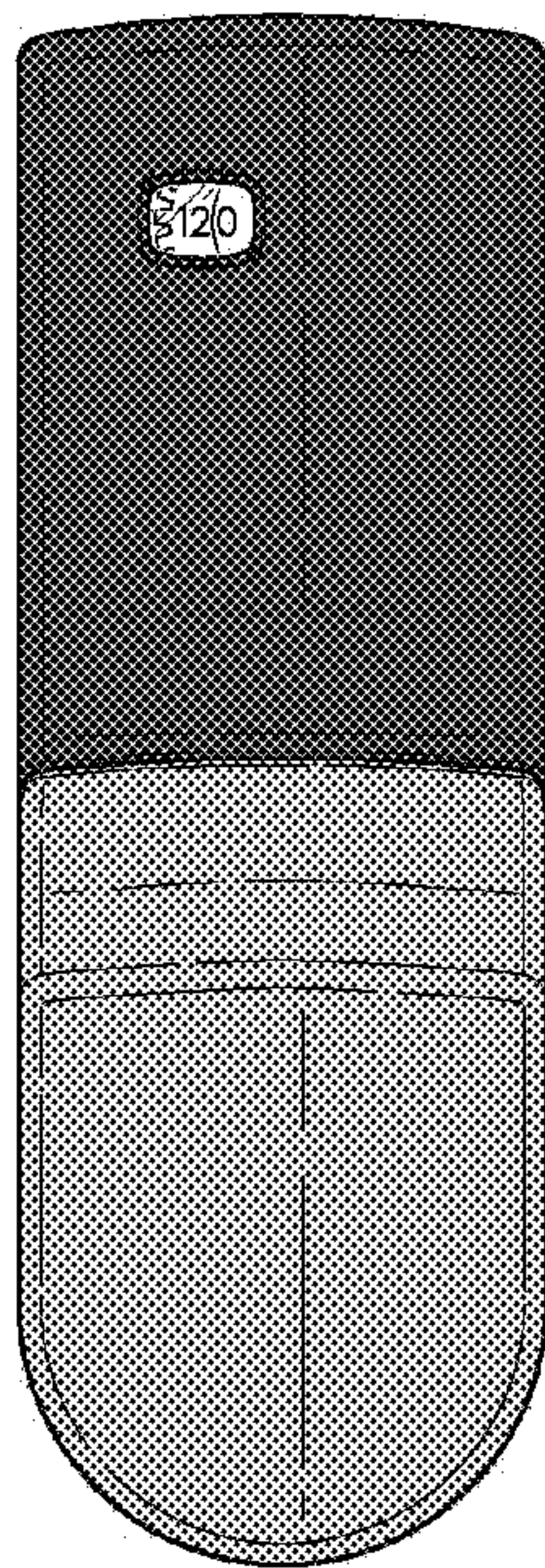

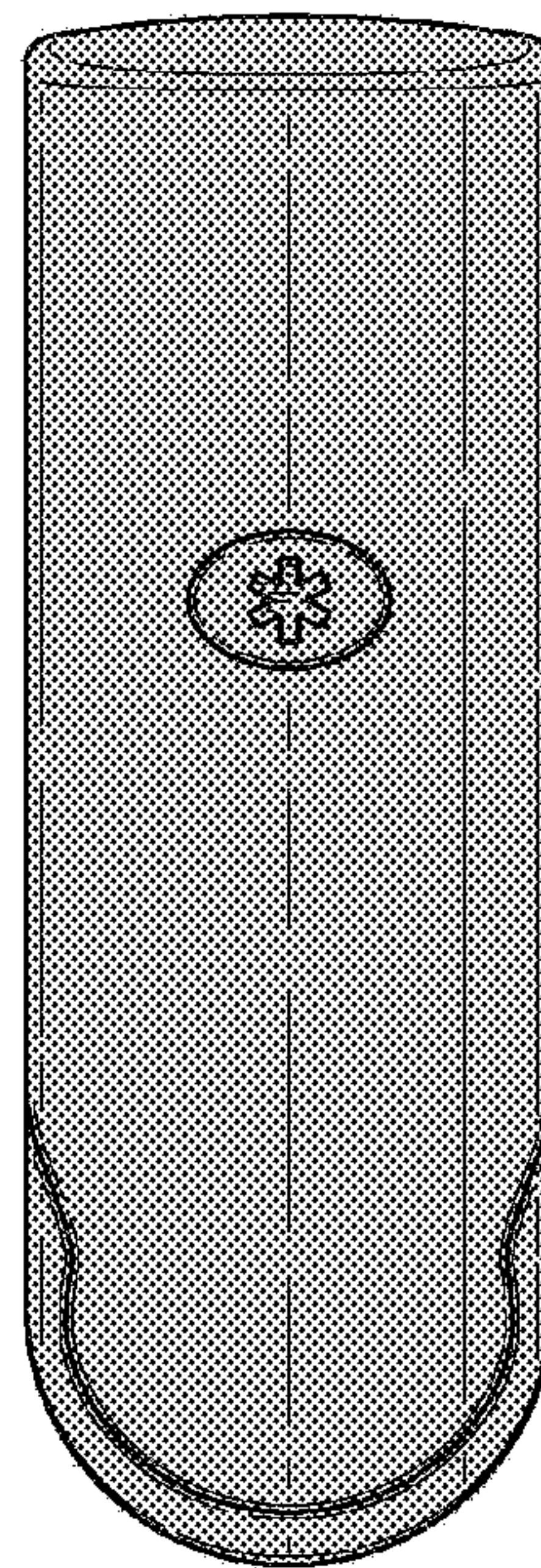

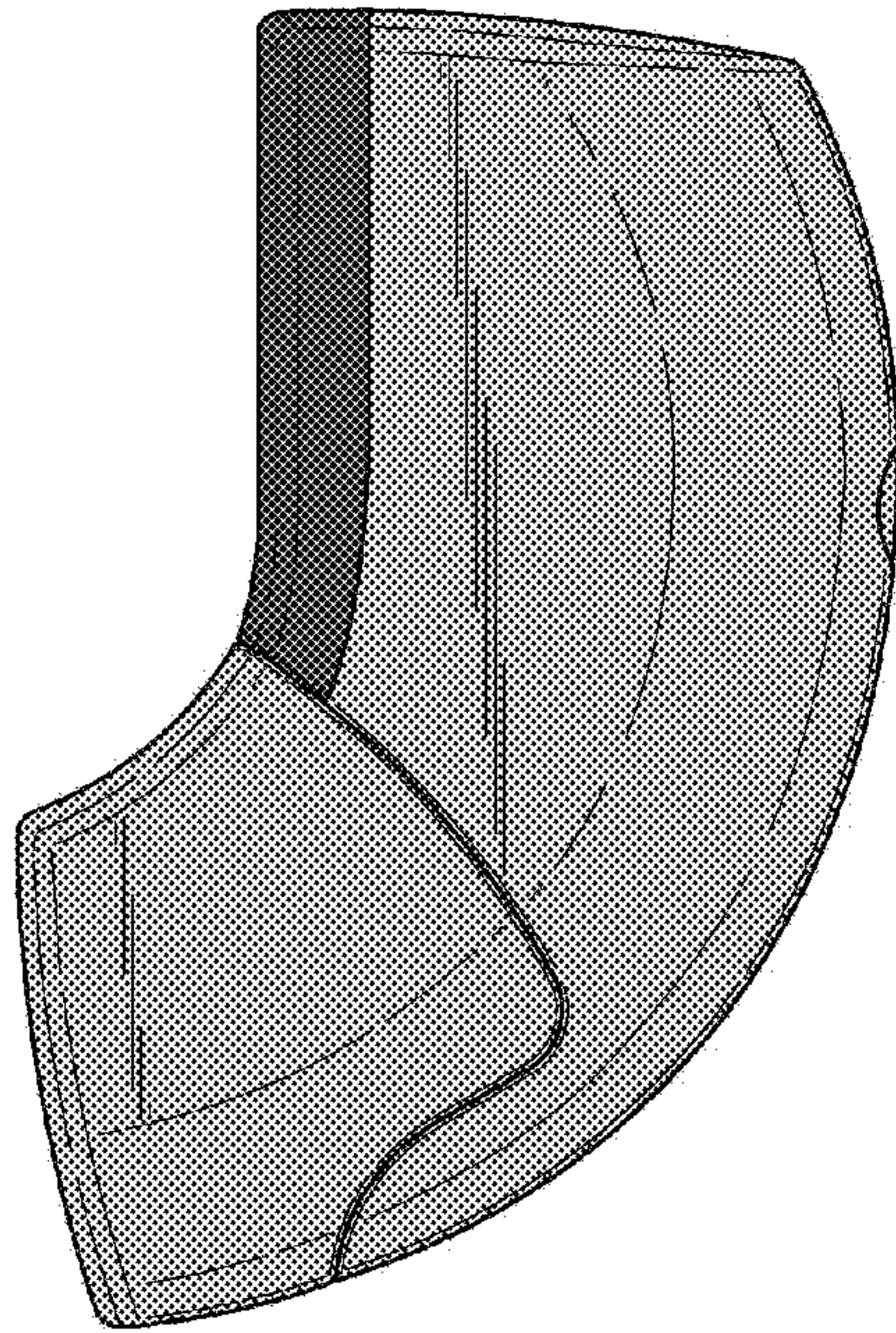

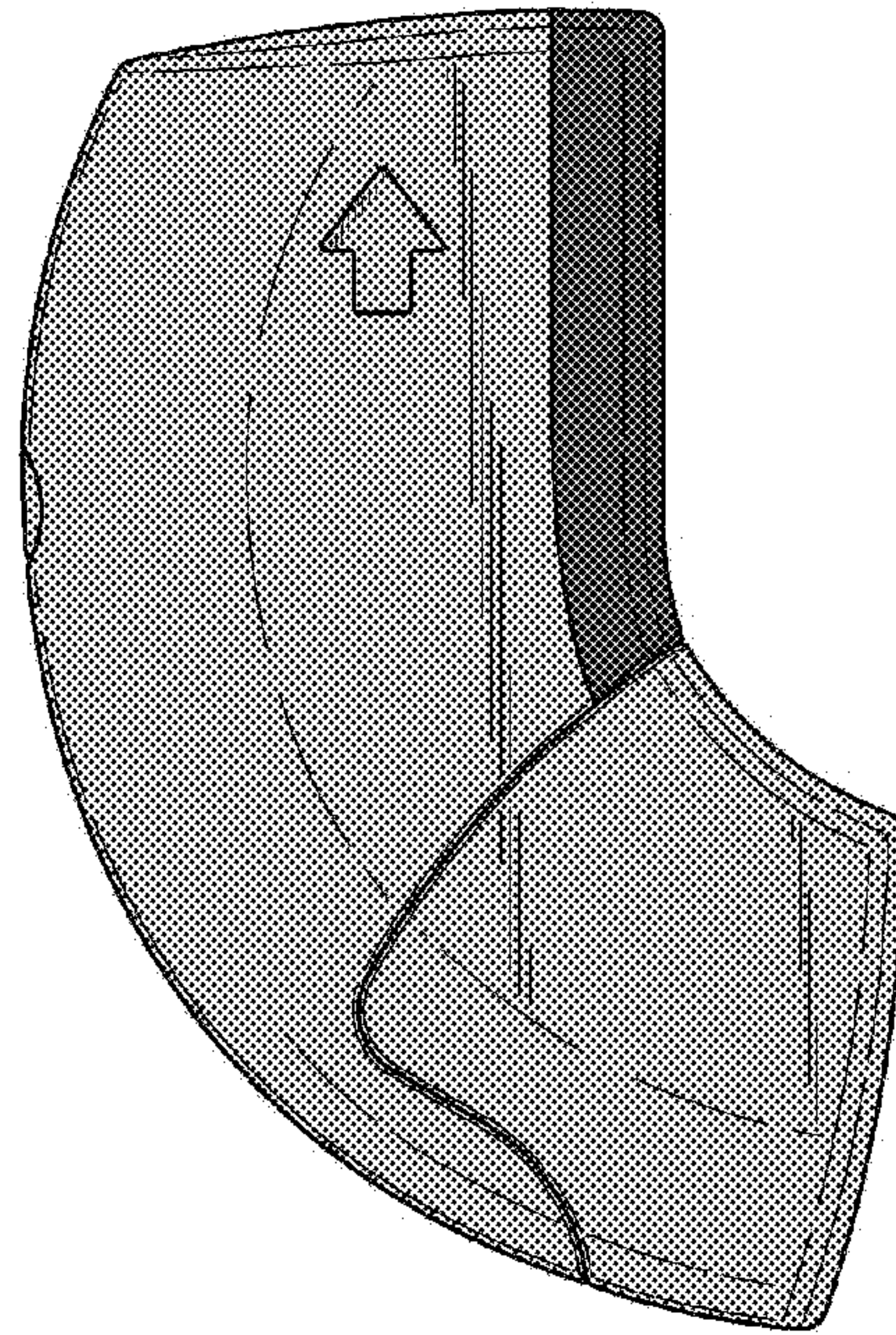

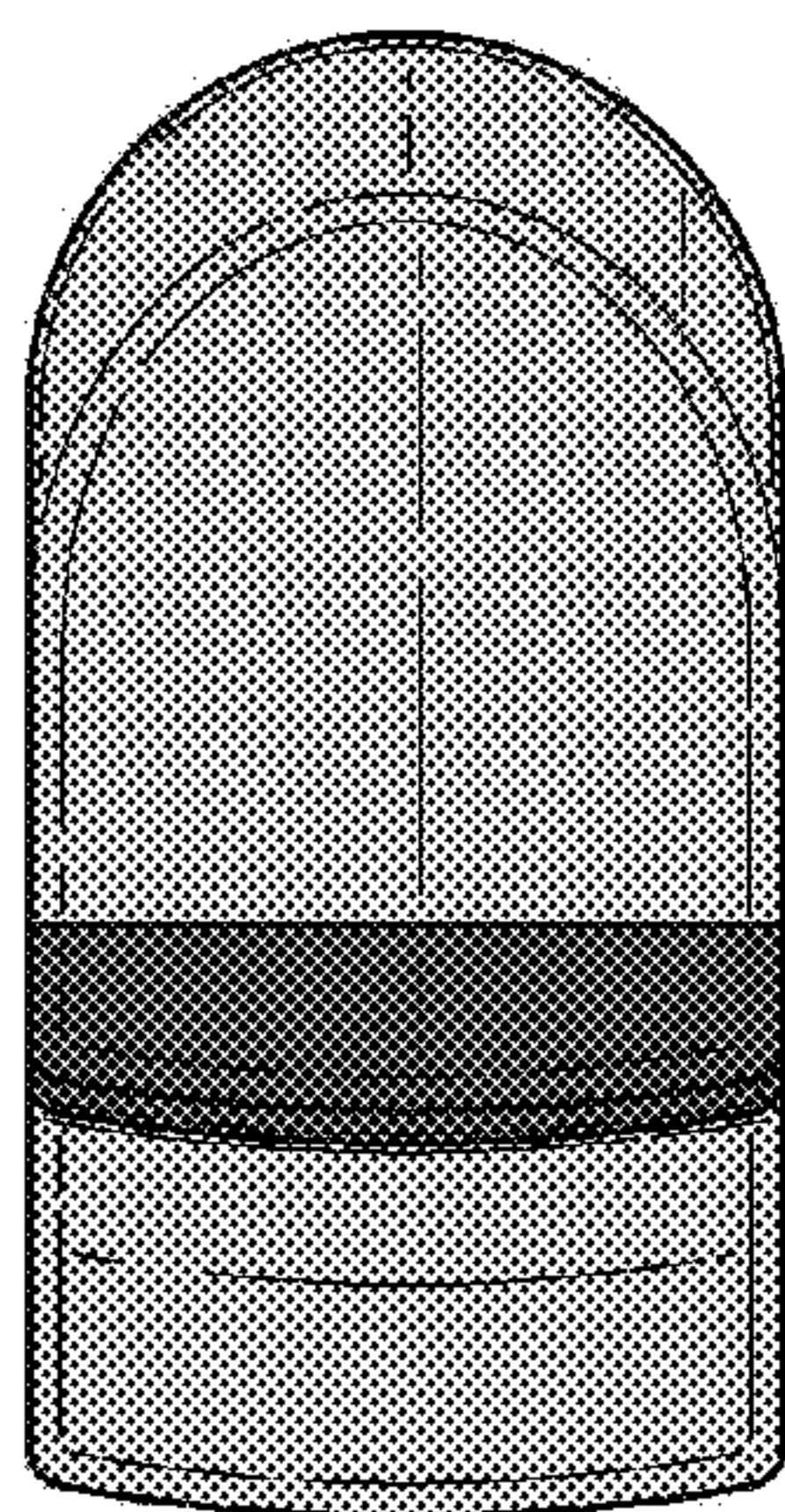

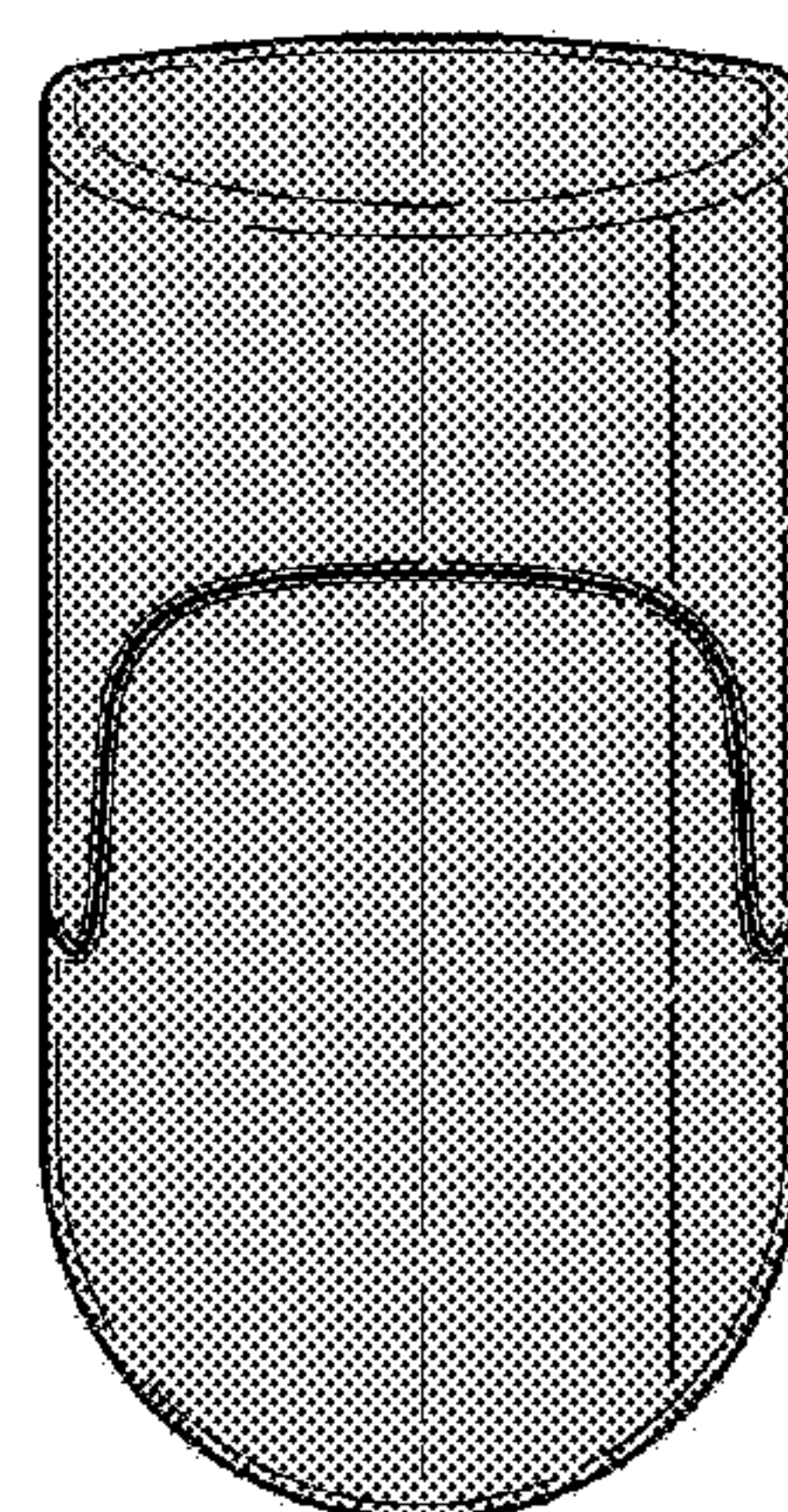

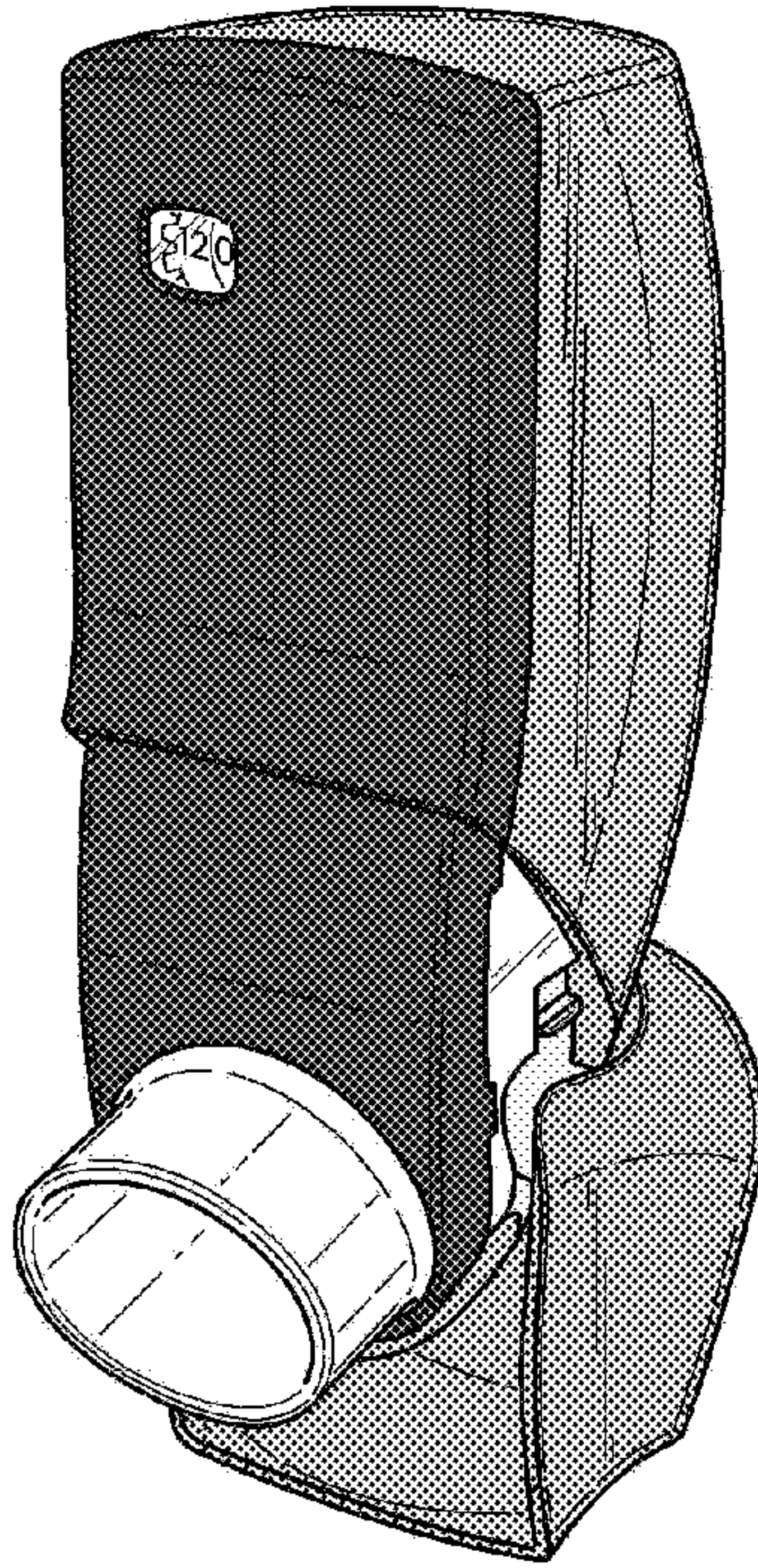

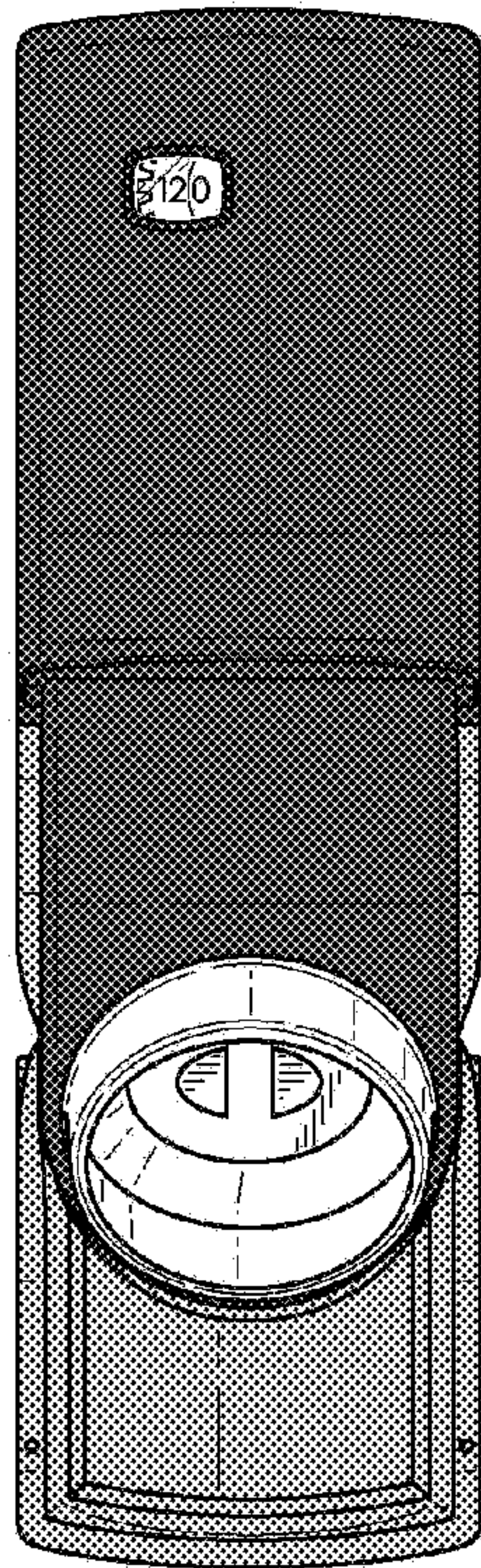

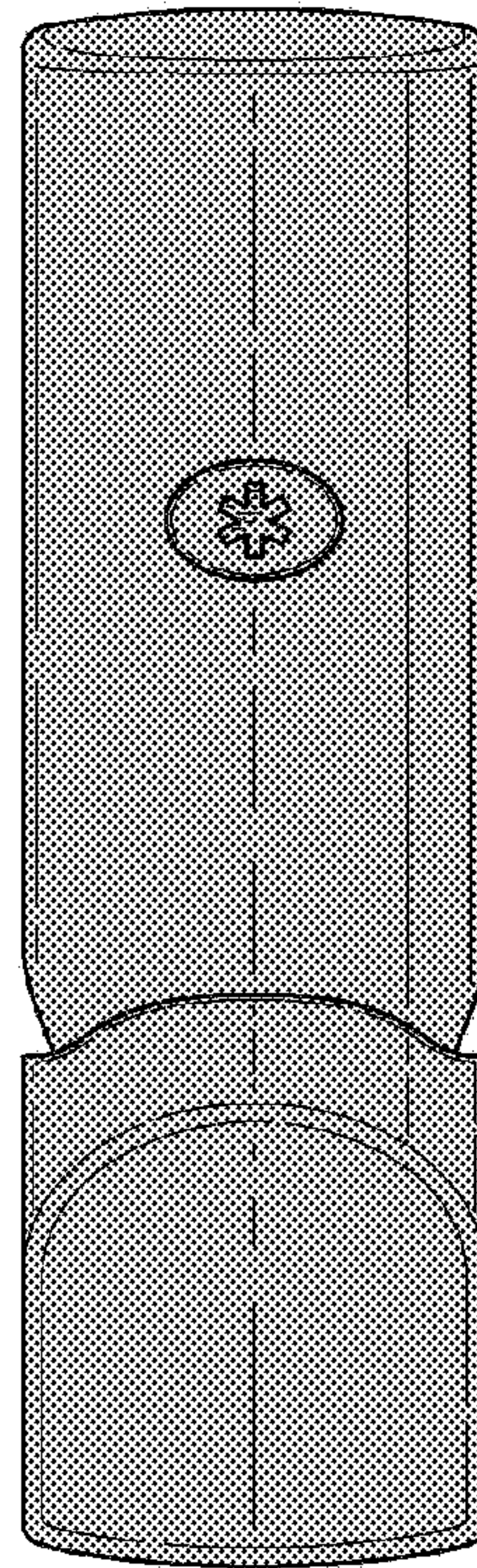

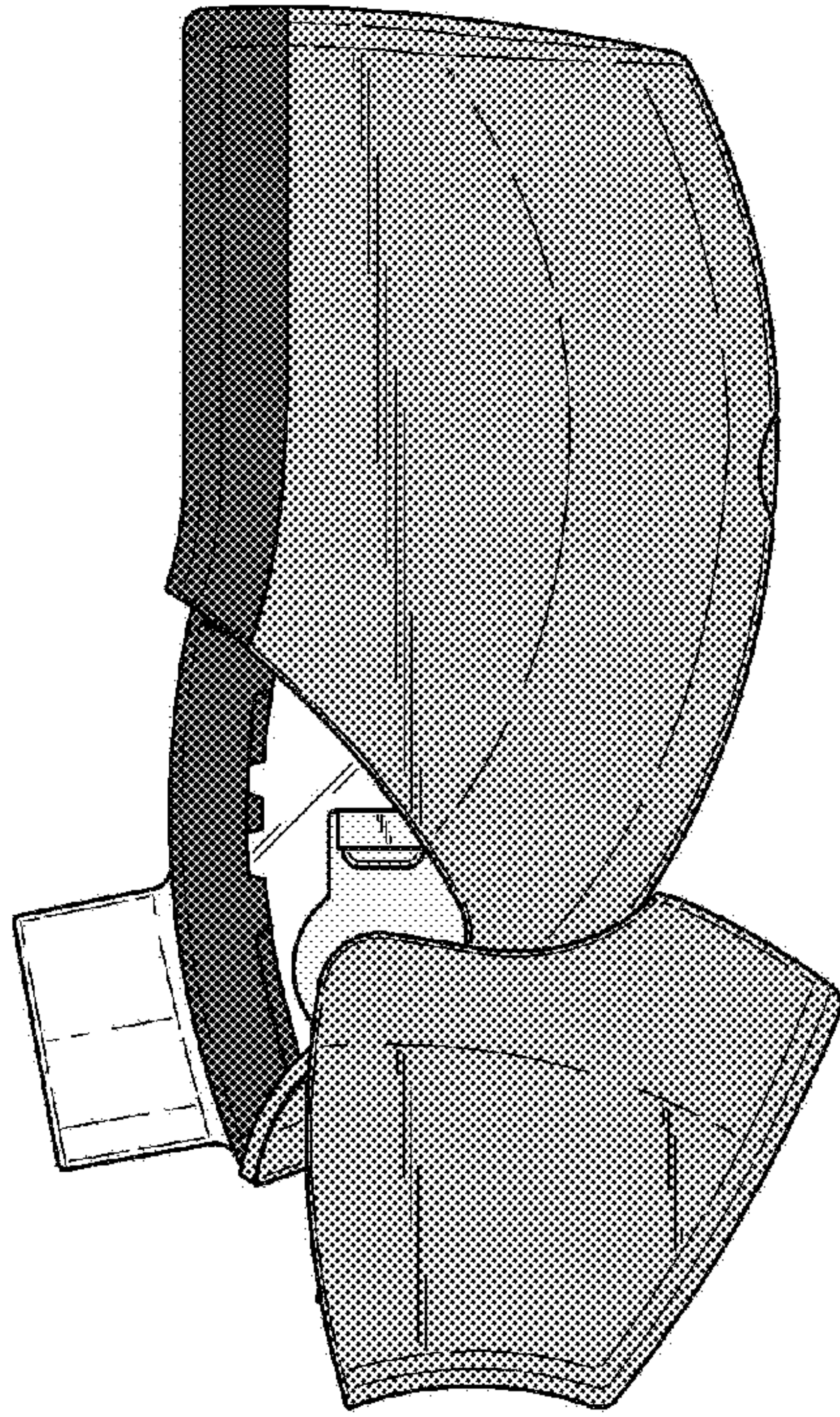

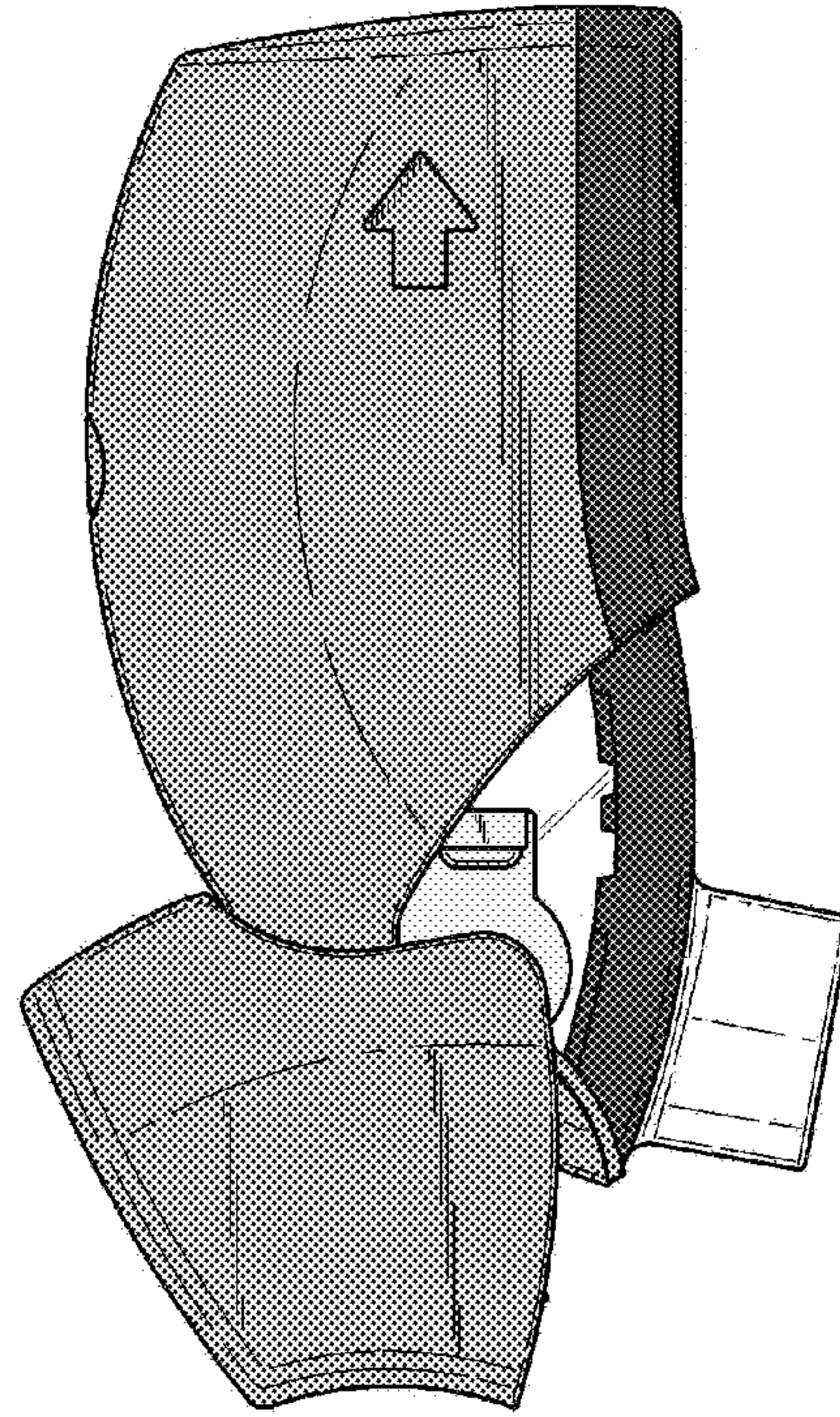

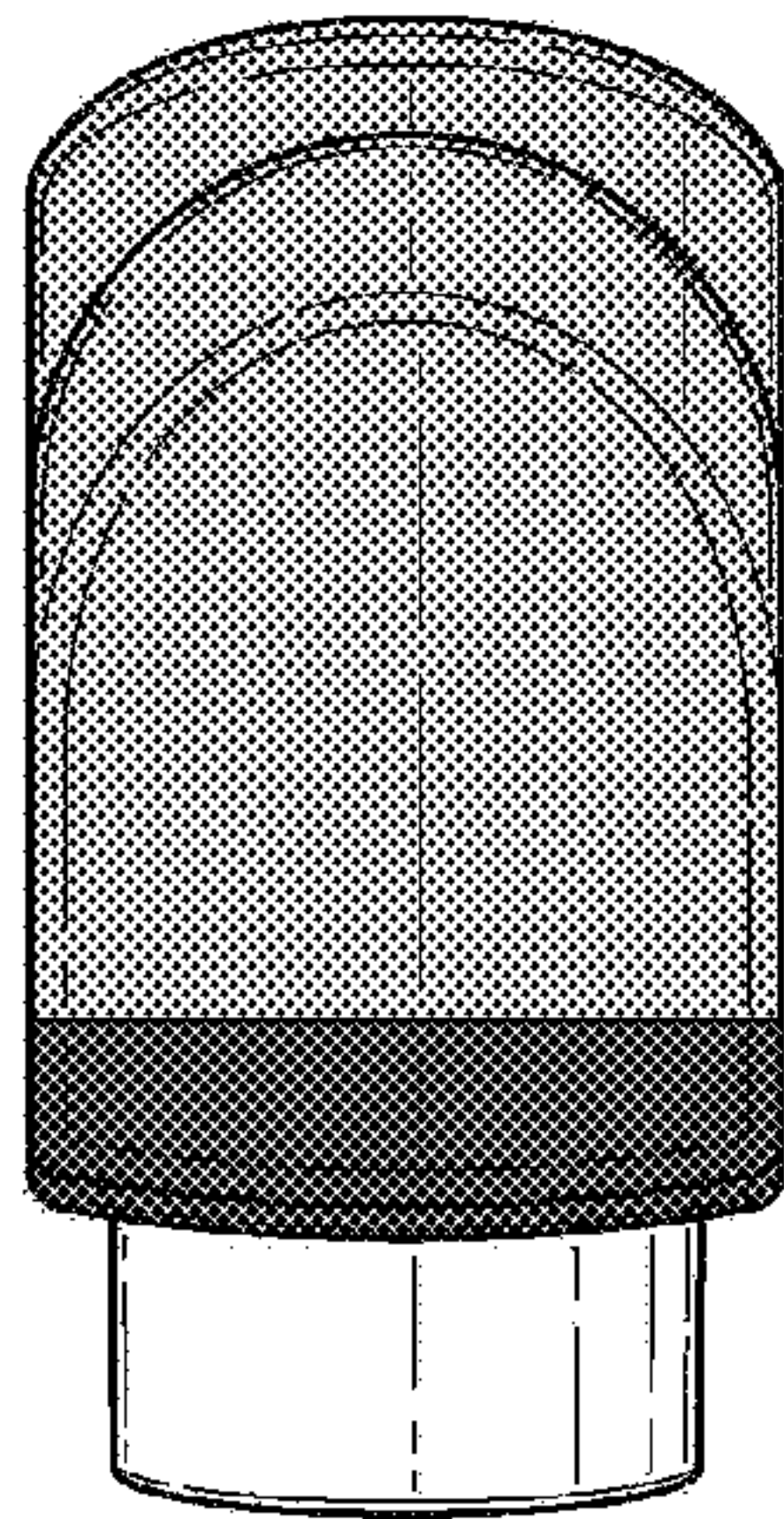

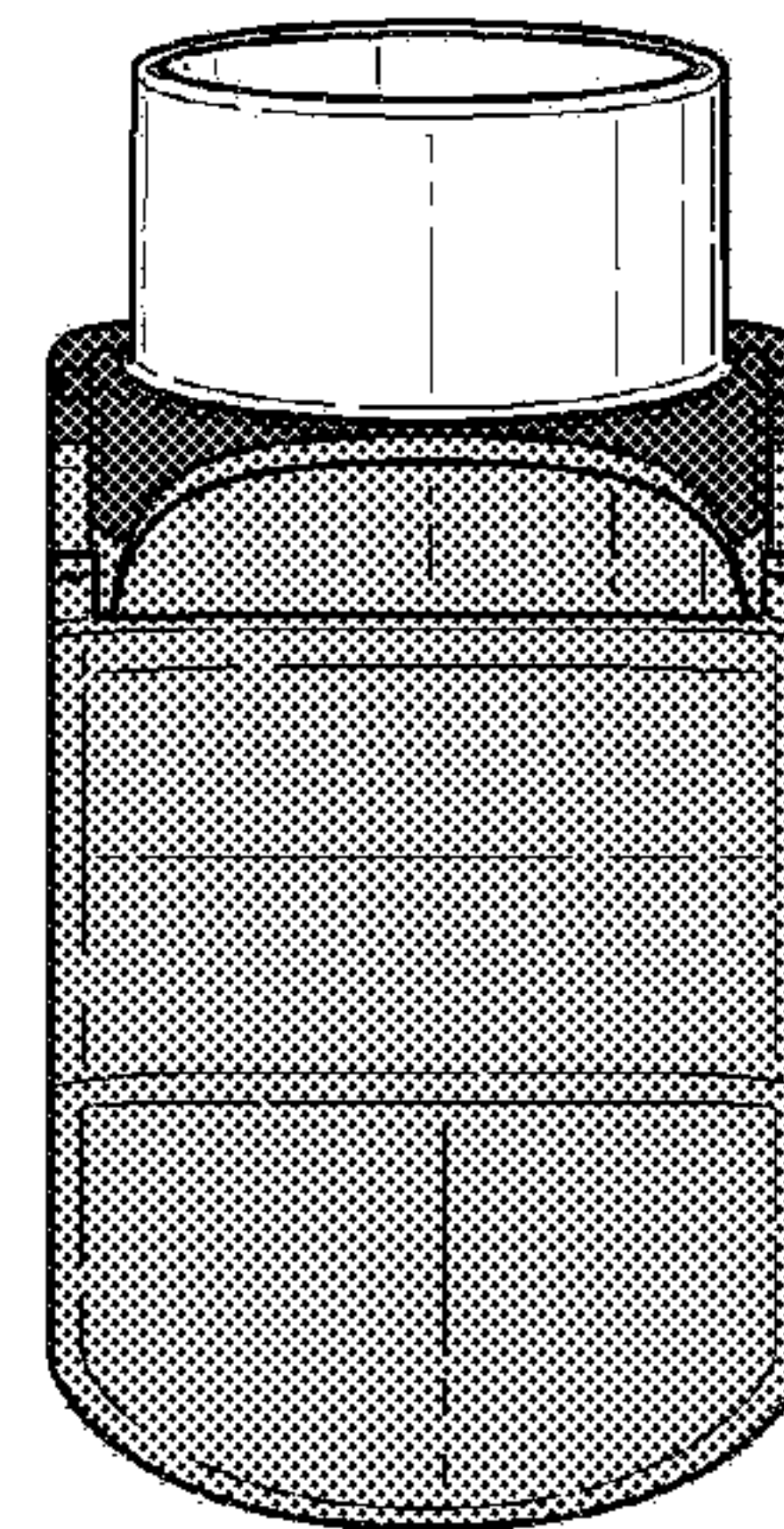
