The ornamental design for a massaging foot rest, as shown and described.

FIG. 33 is a perspective view of the massaging foot rest of my new design in a fourth partially unfolded configuration from the front bottom right thereof;

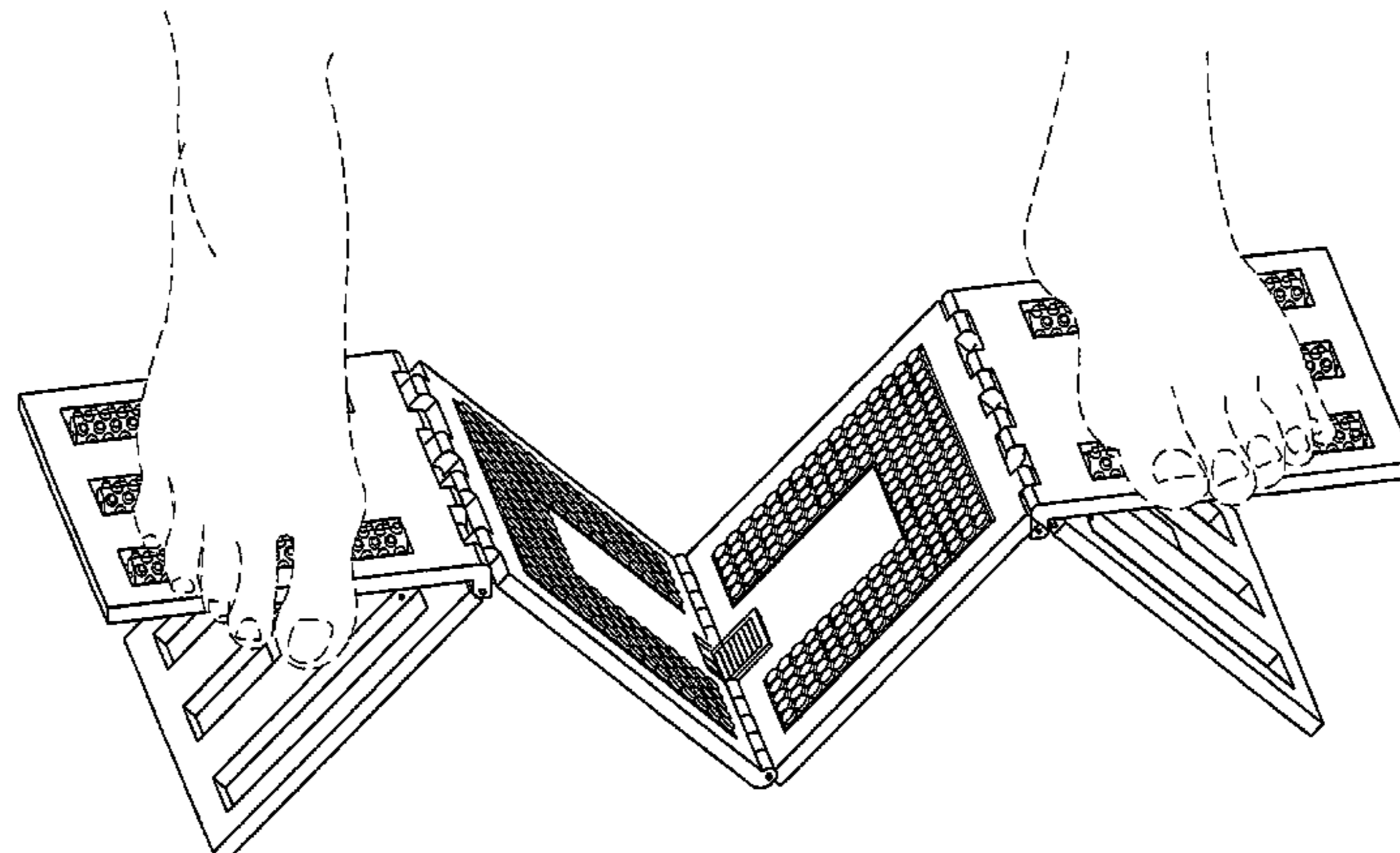


FIG. **34** is an elevational view from the bottom thereof;

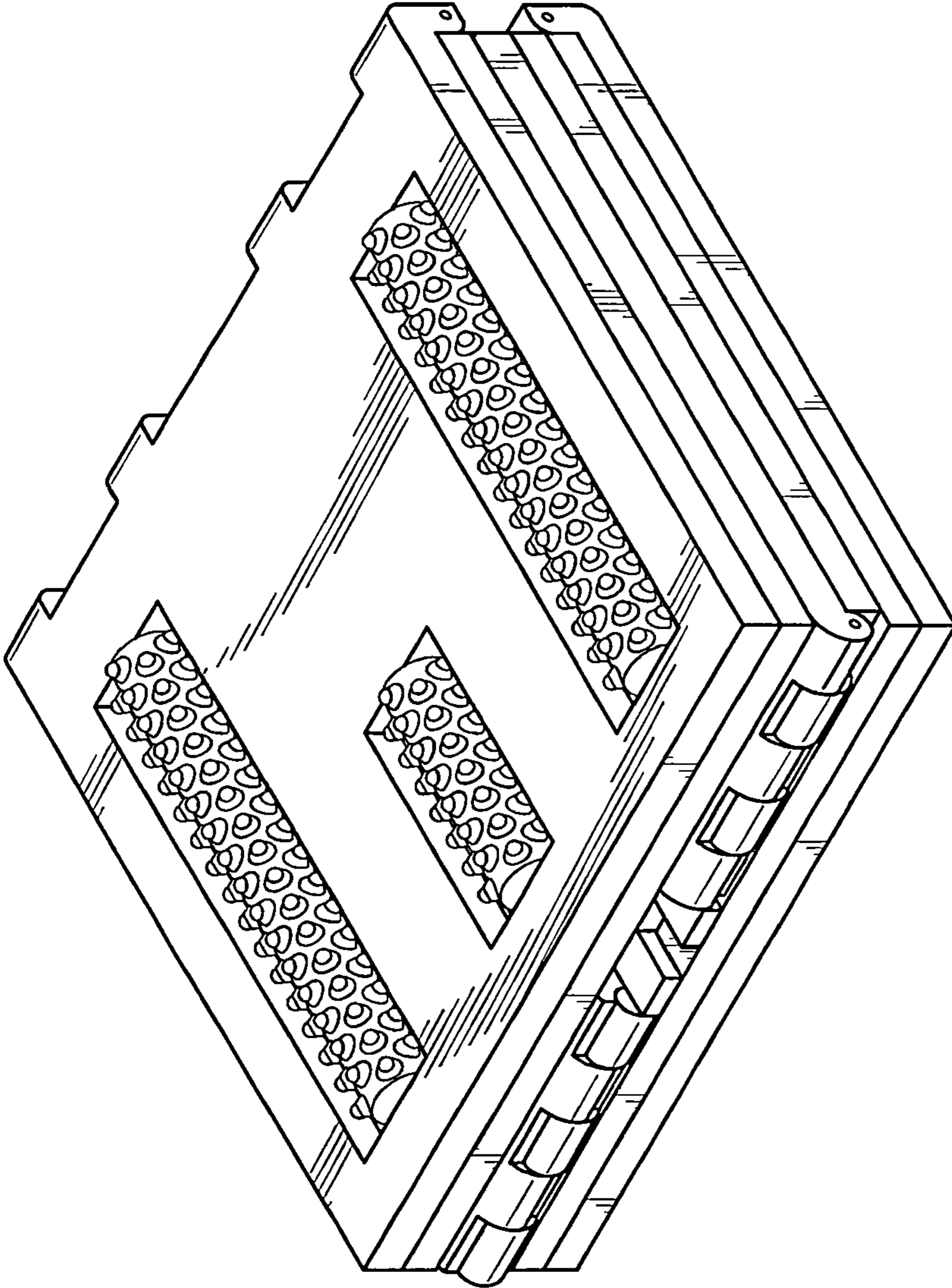

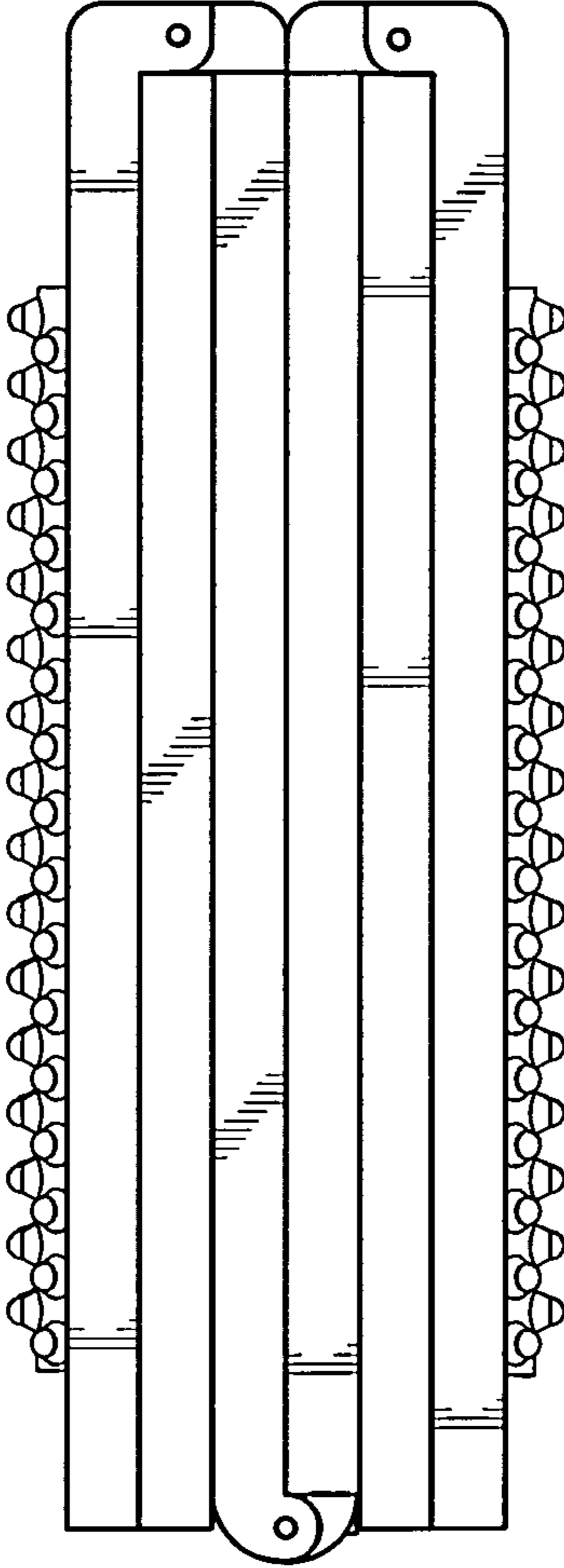

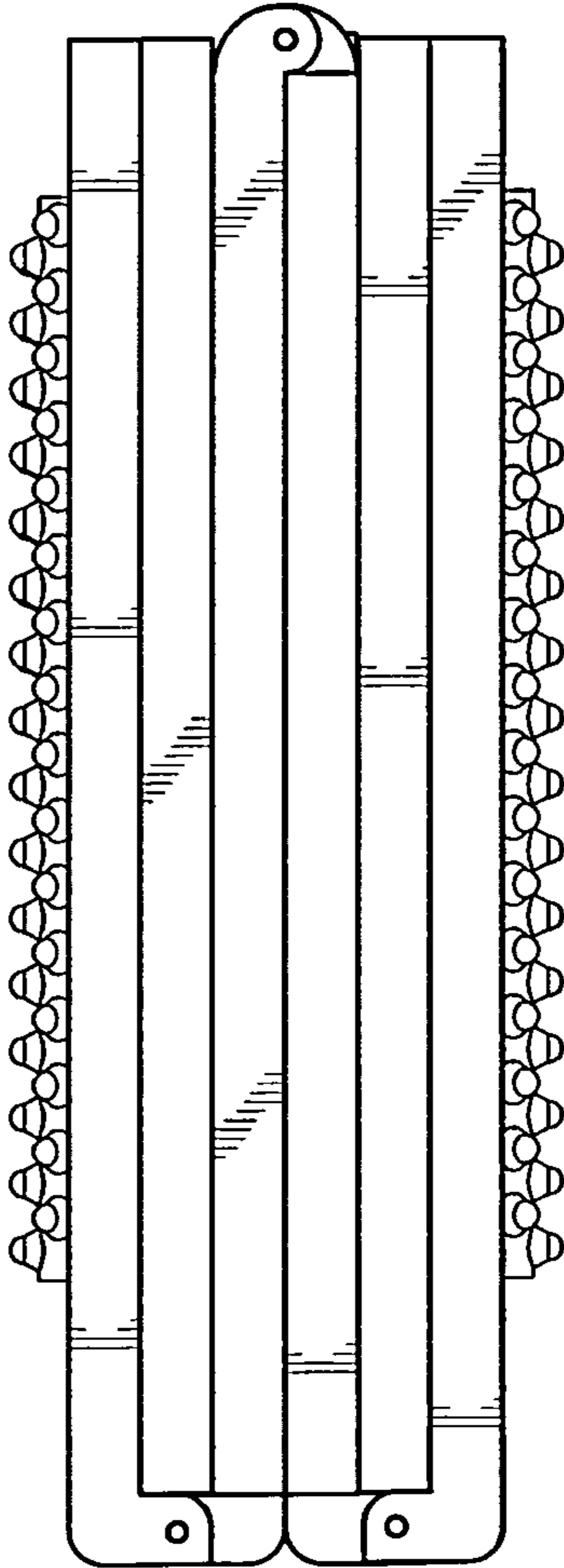
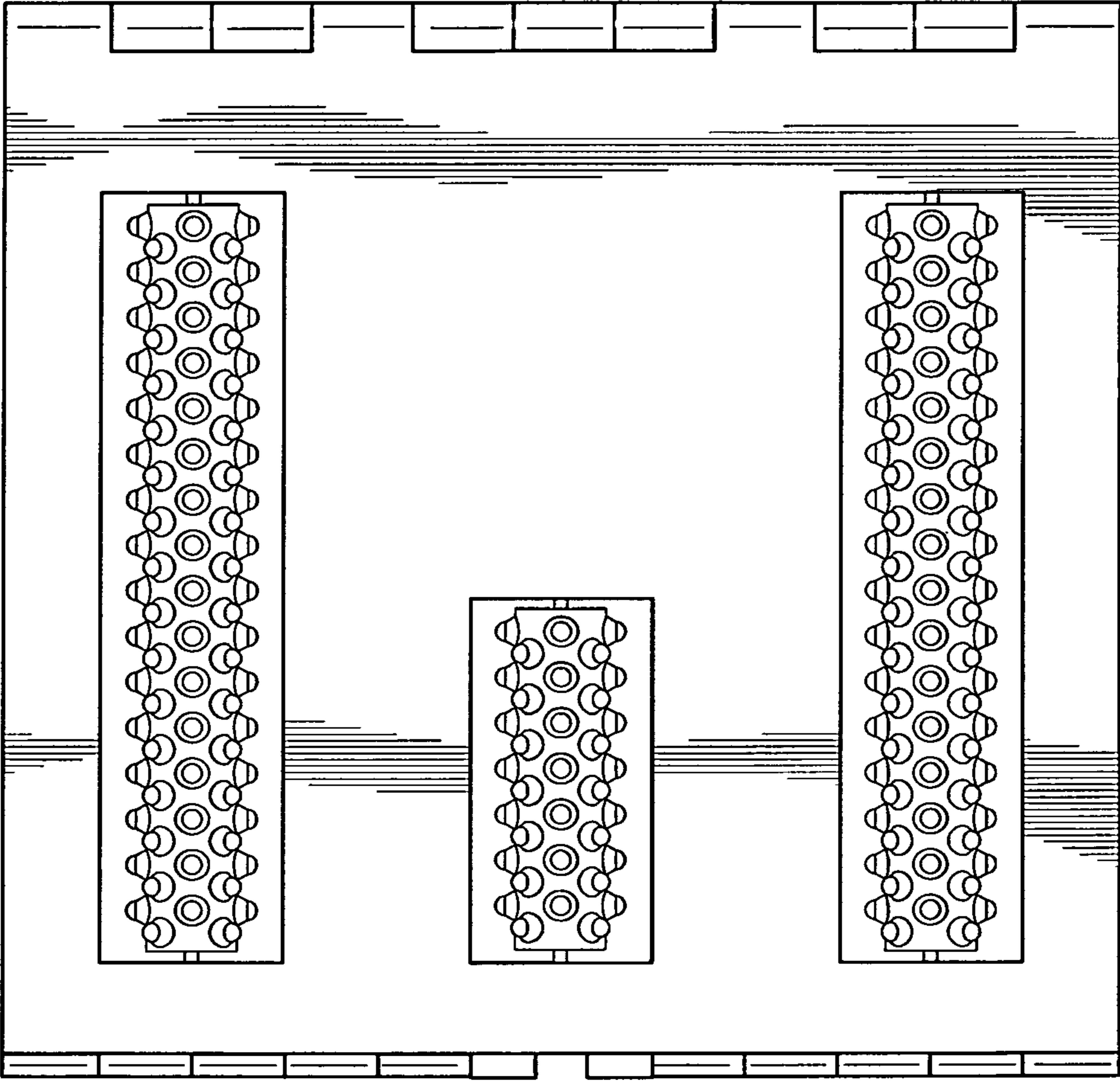

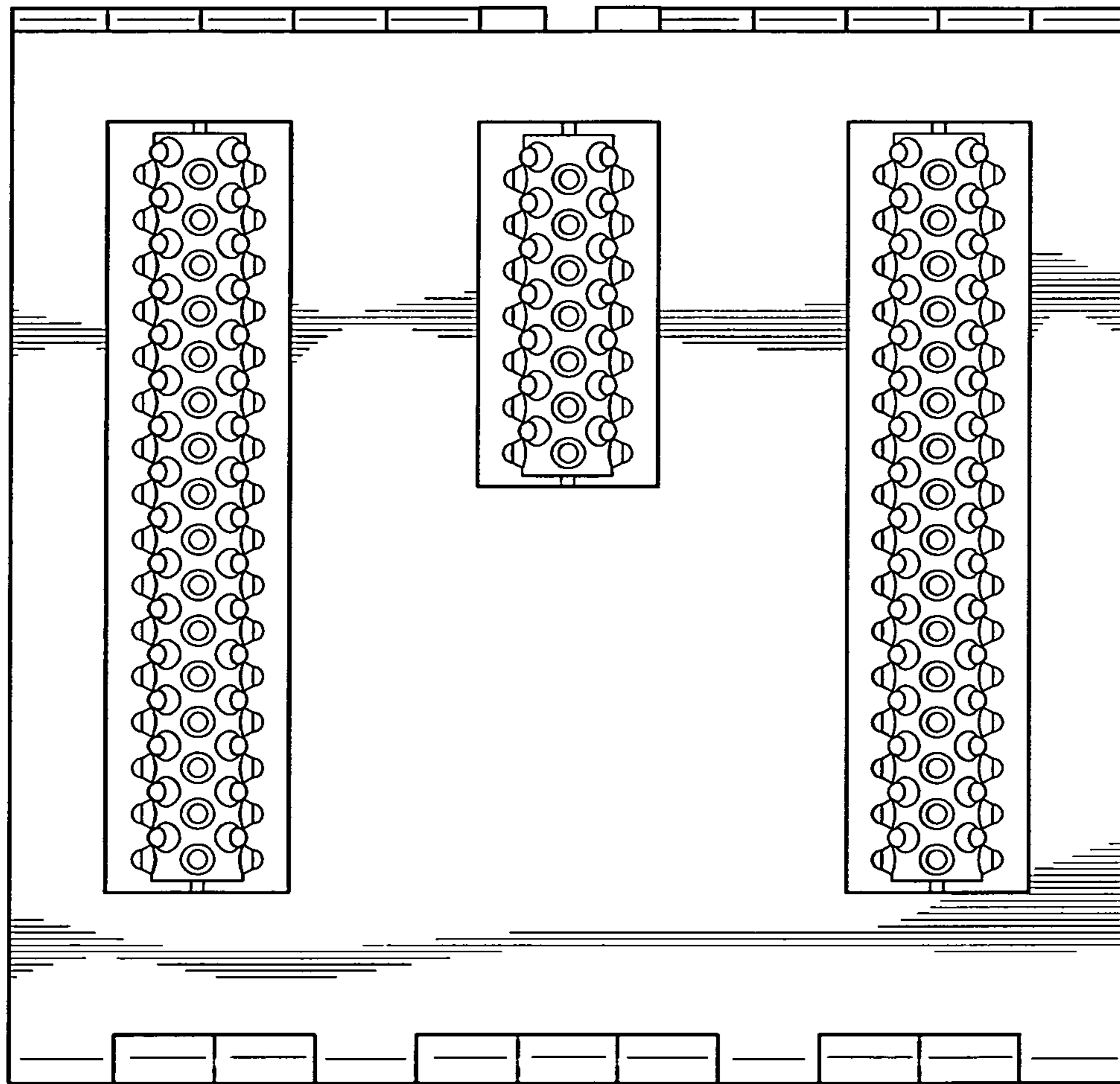

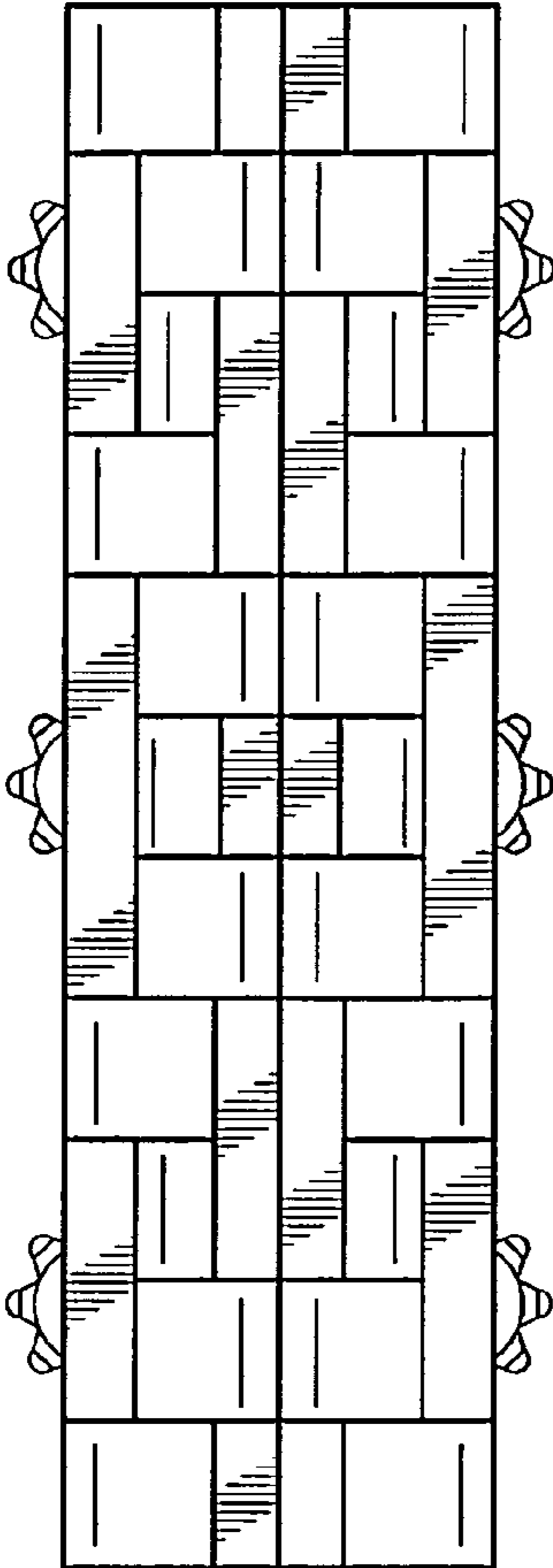
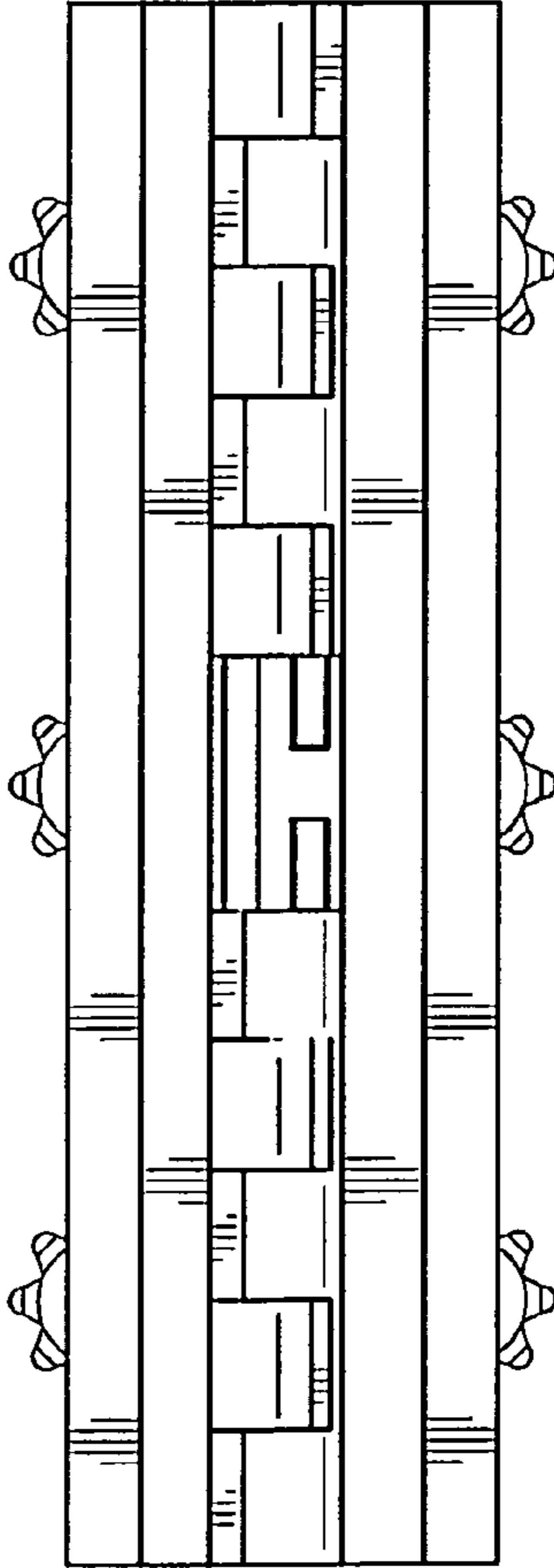

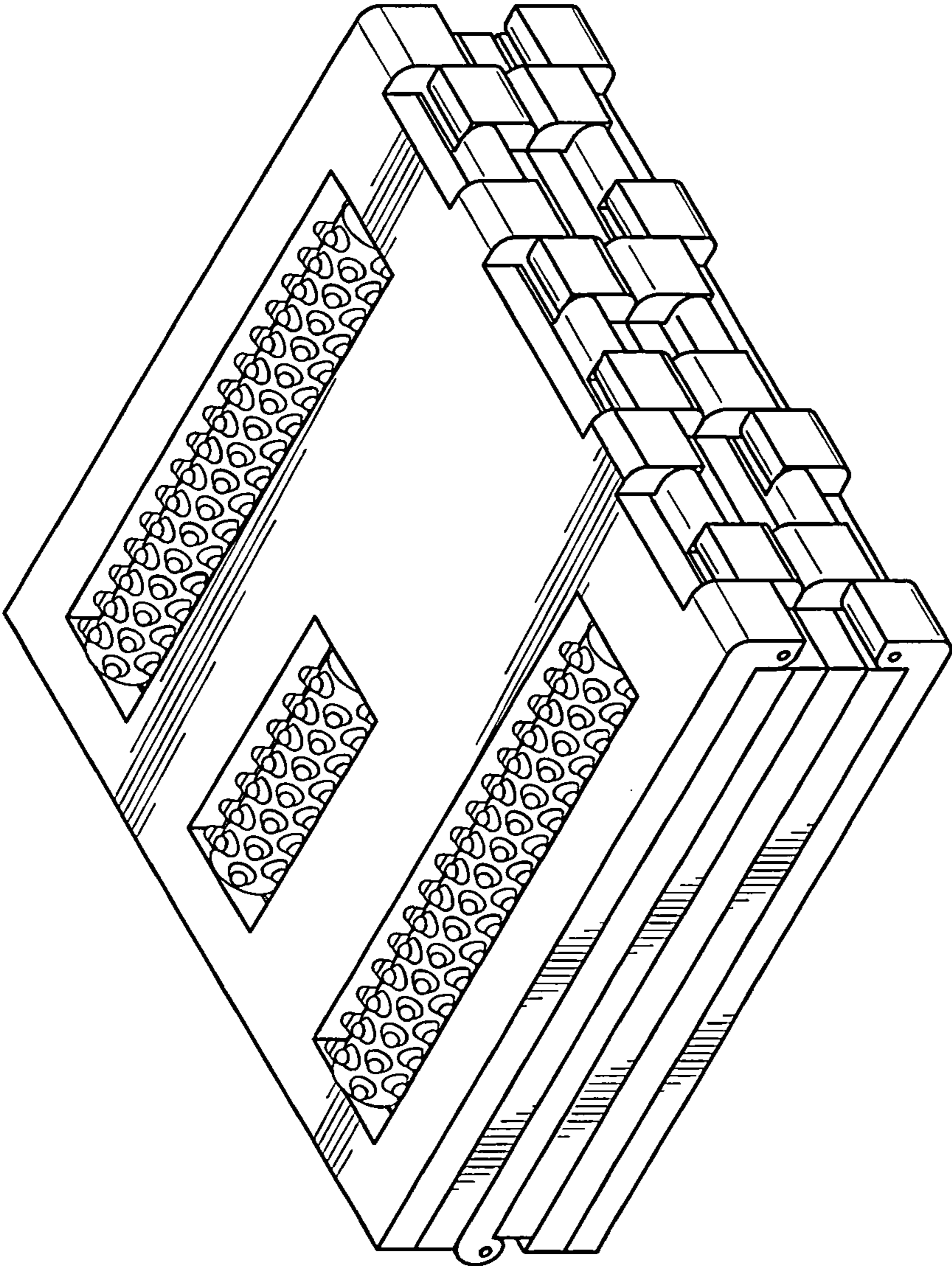

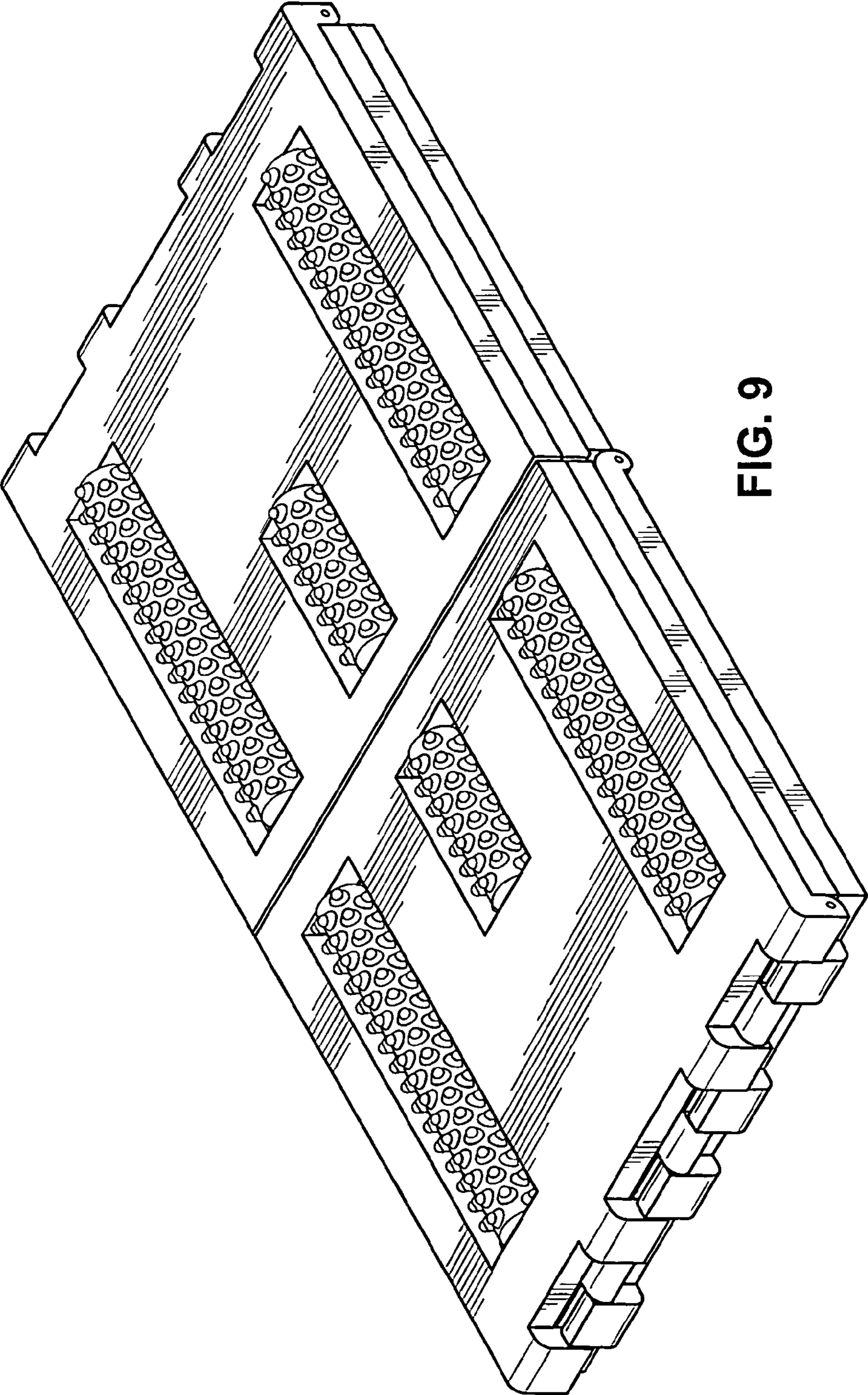

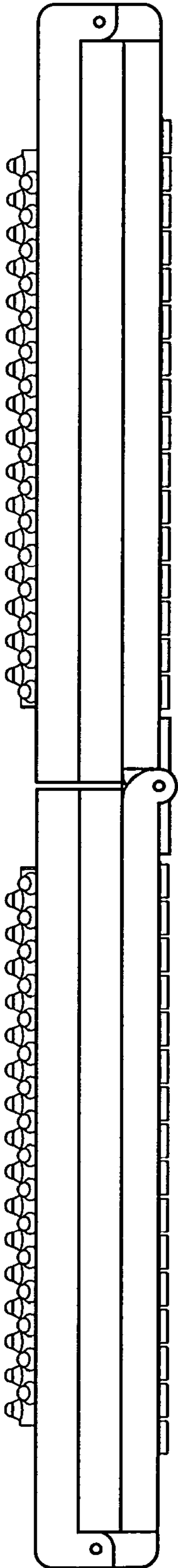

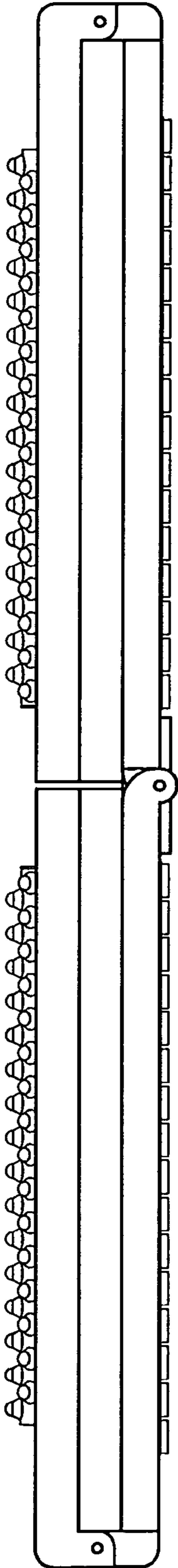

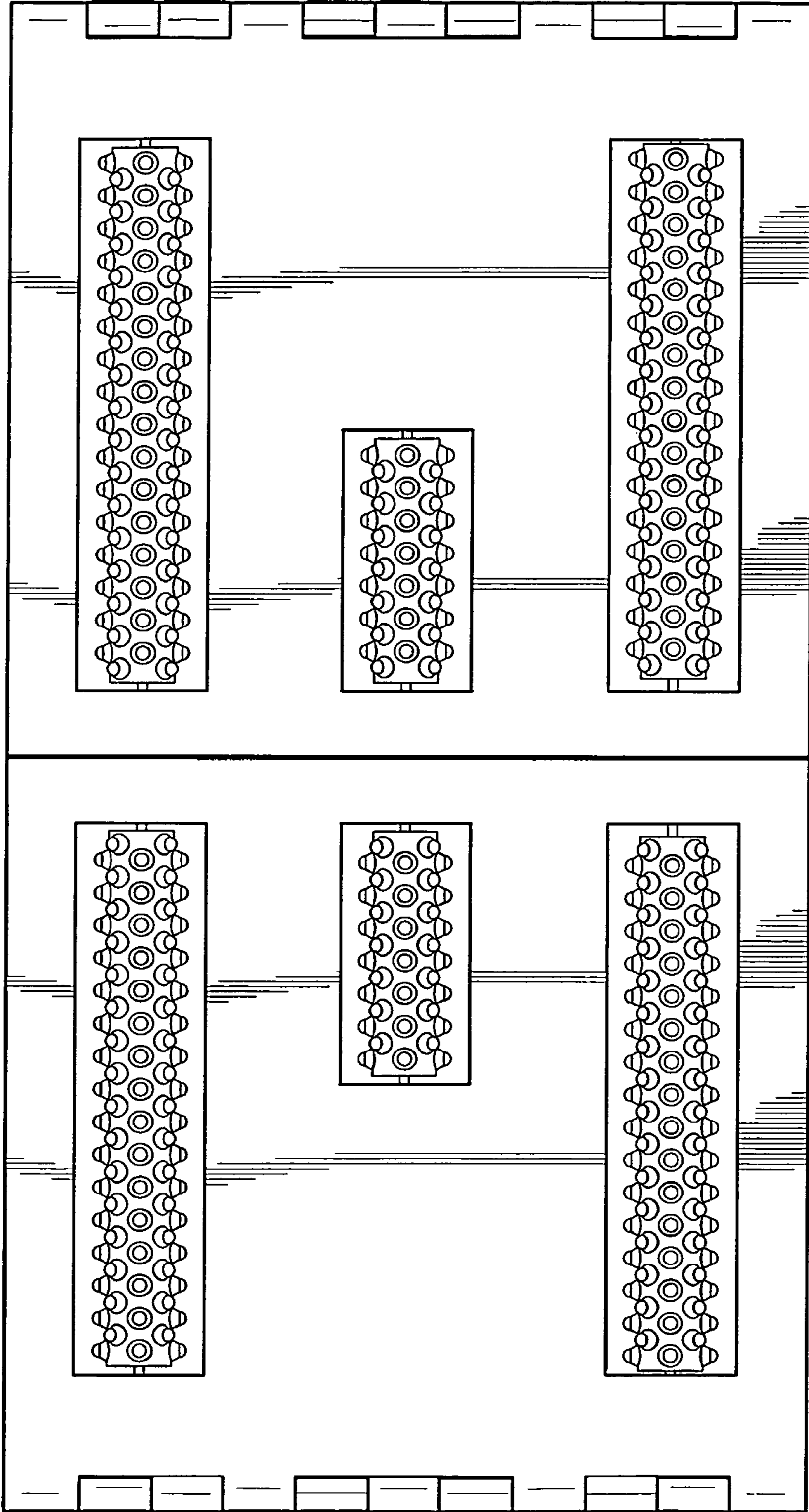

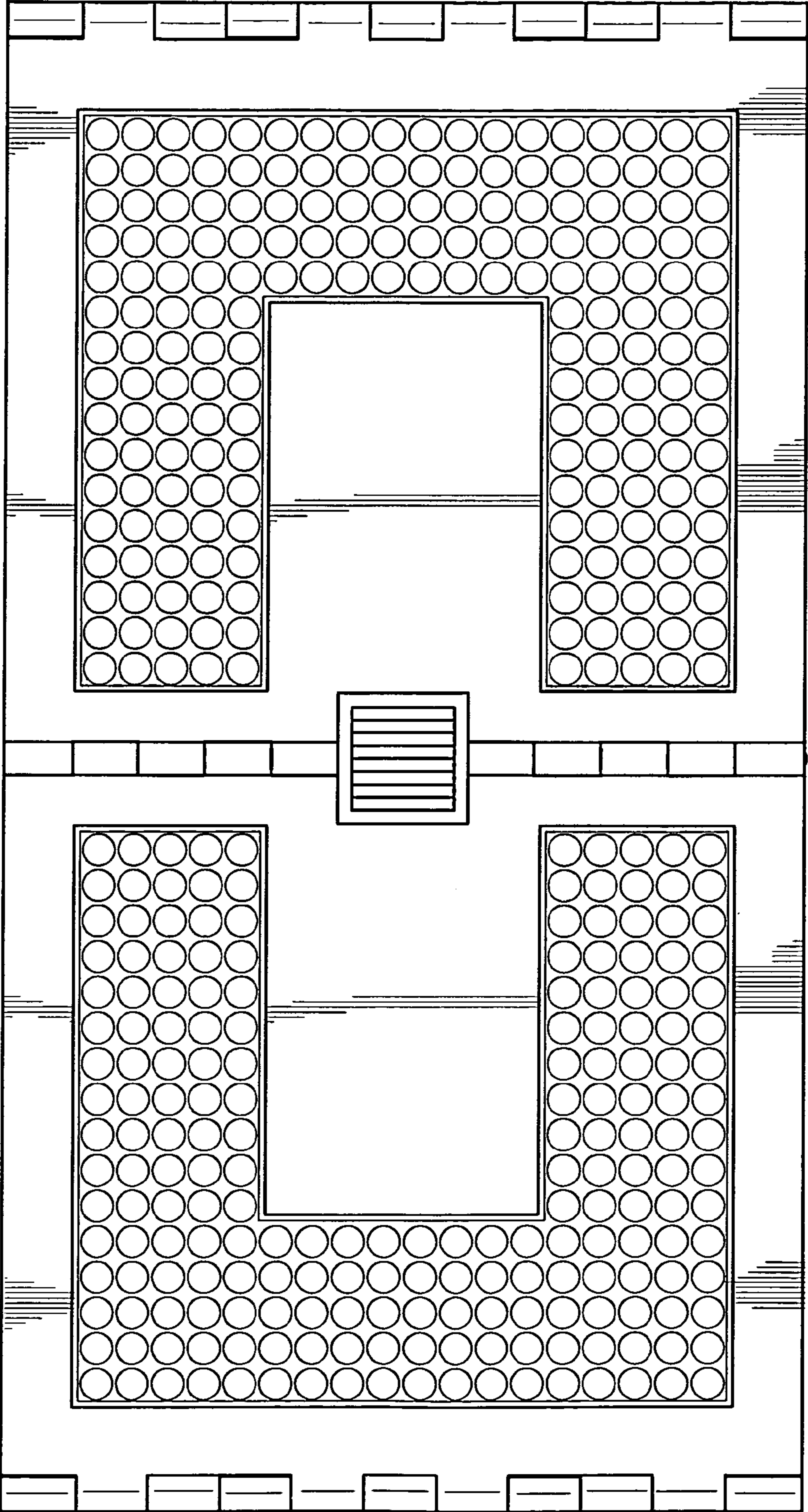

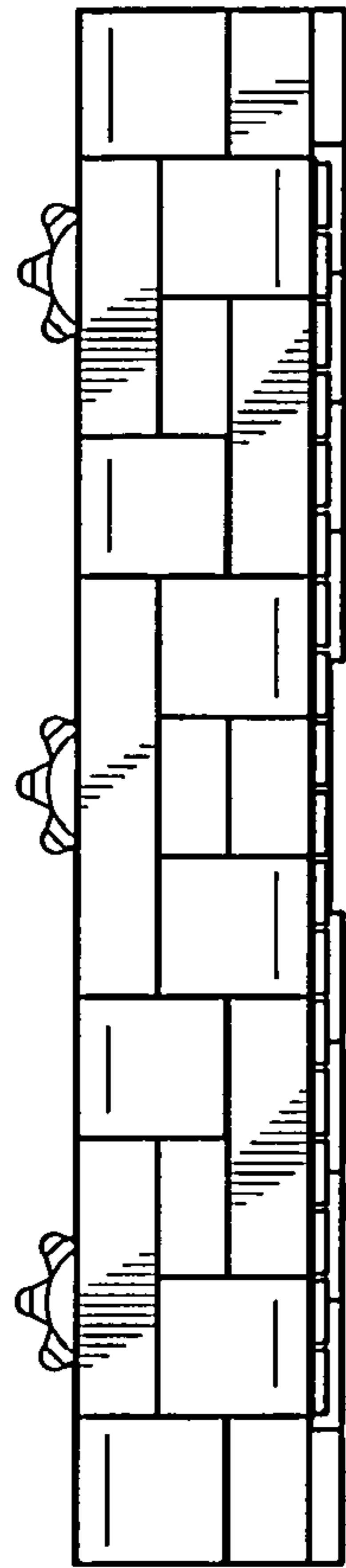

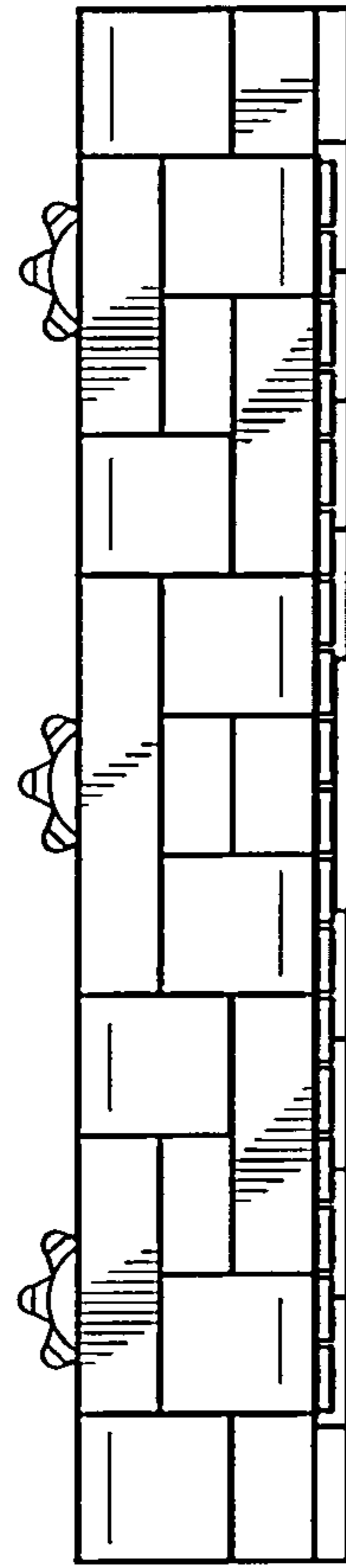

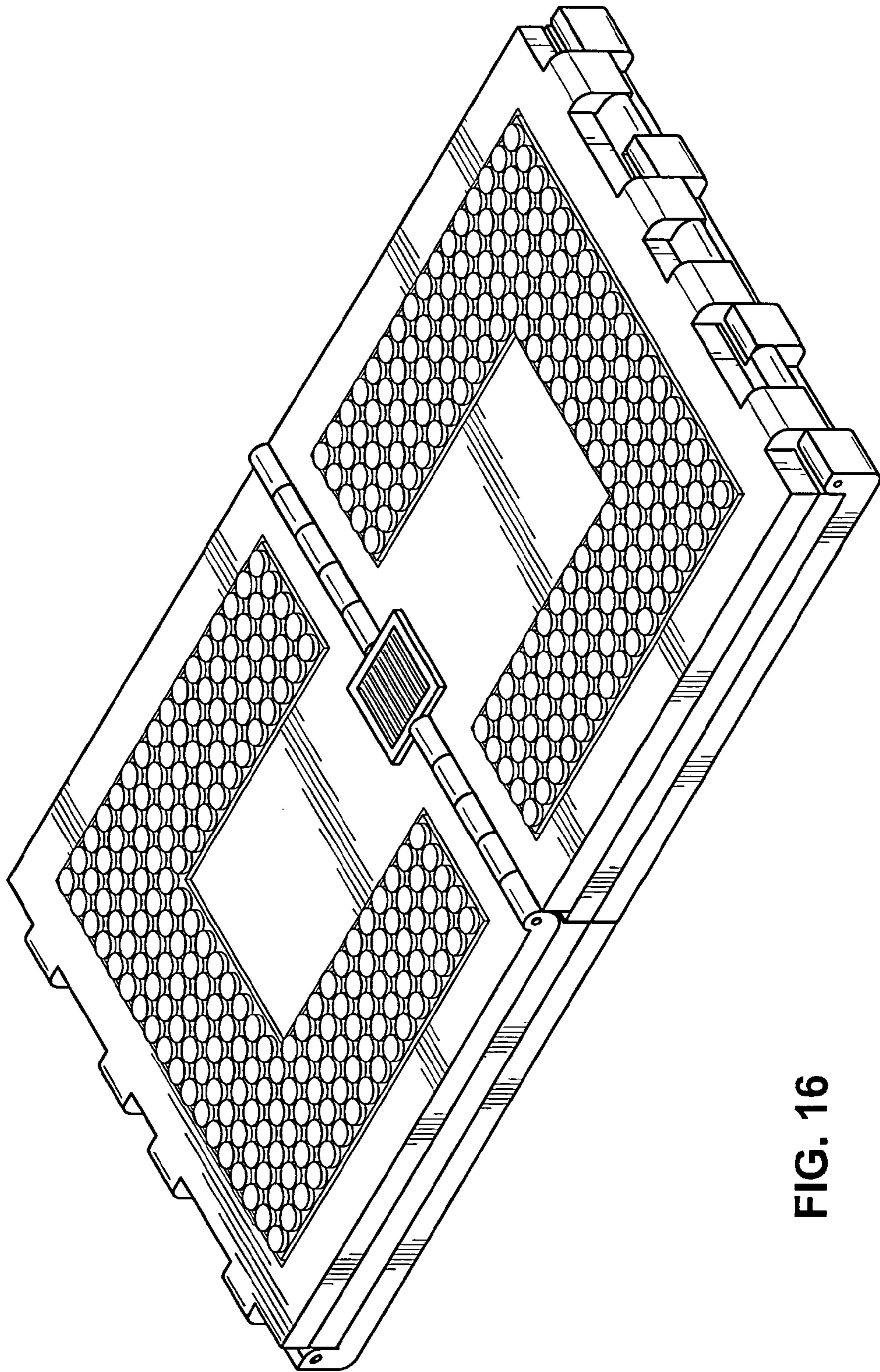

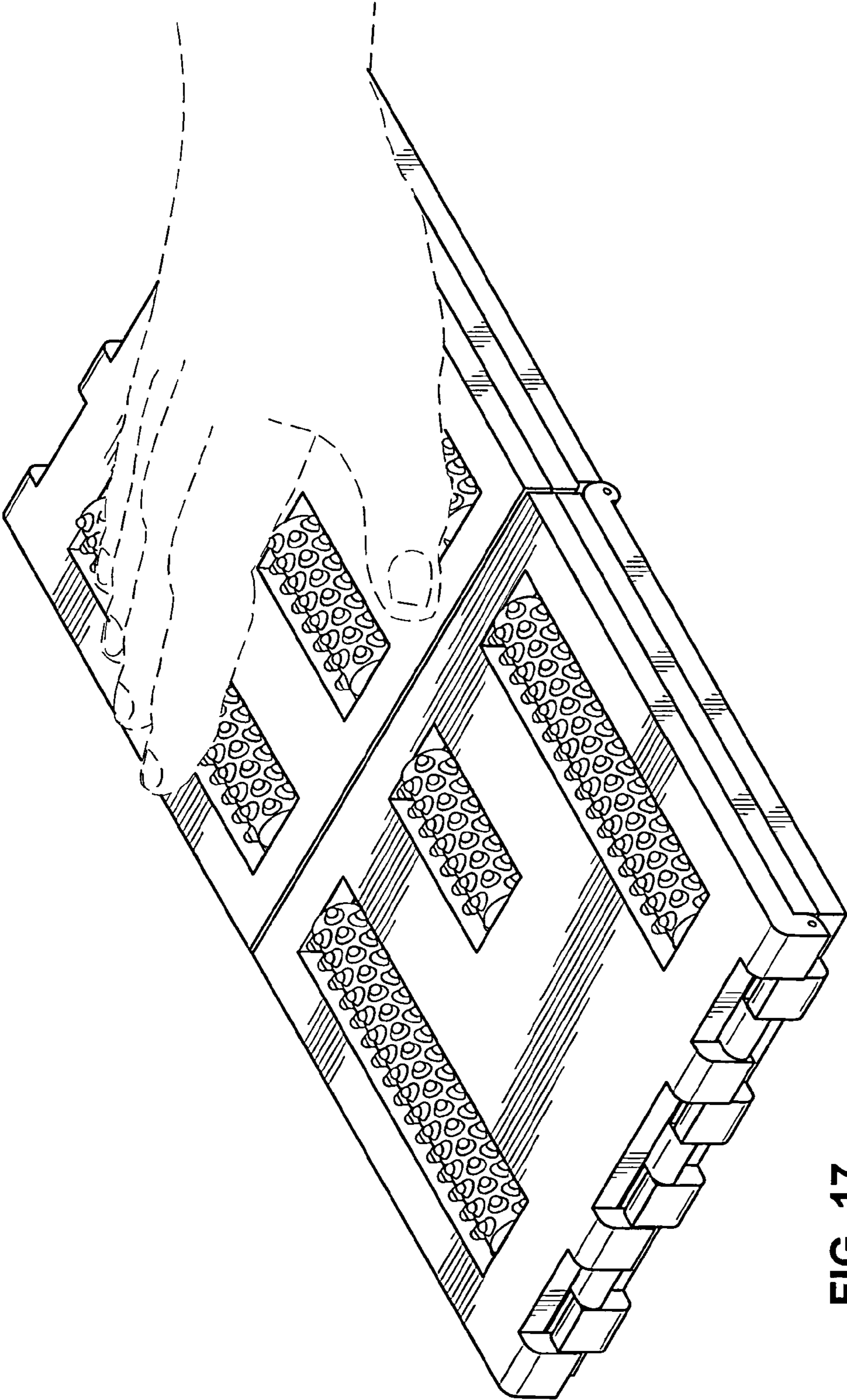

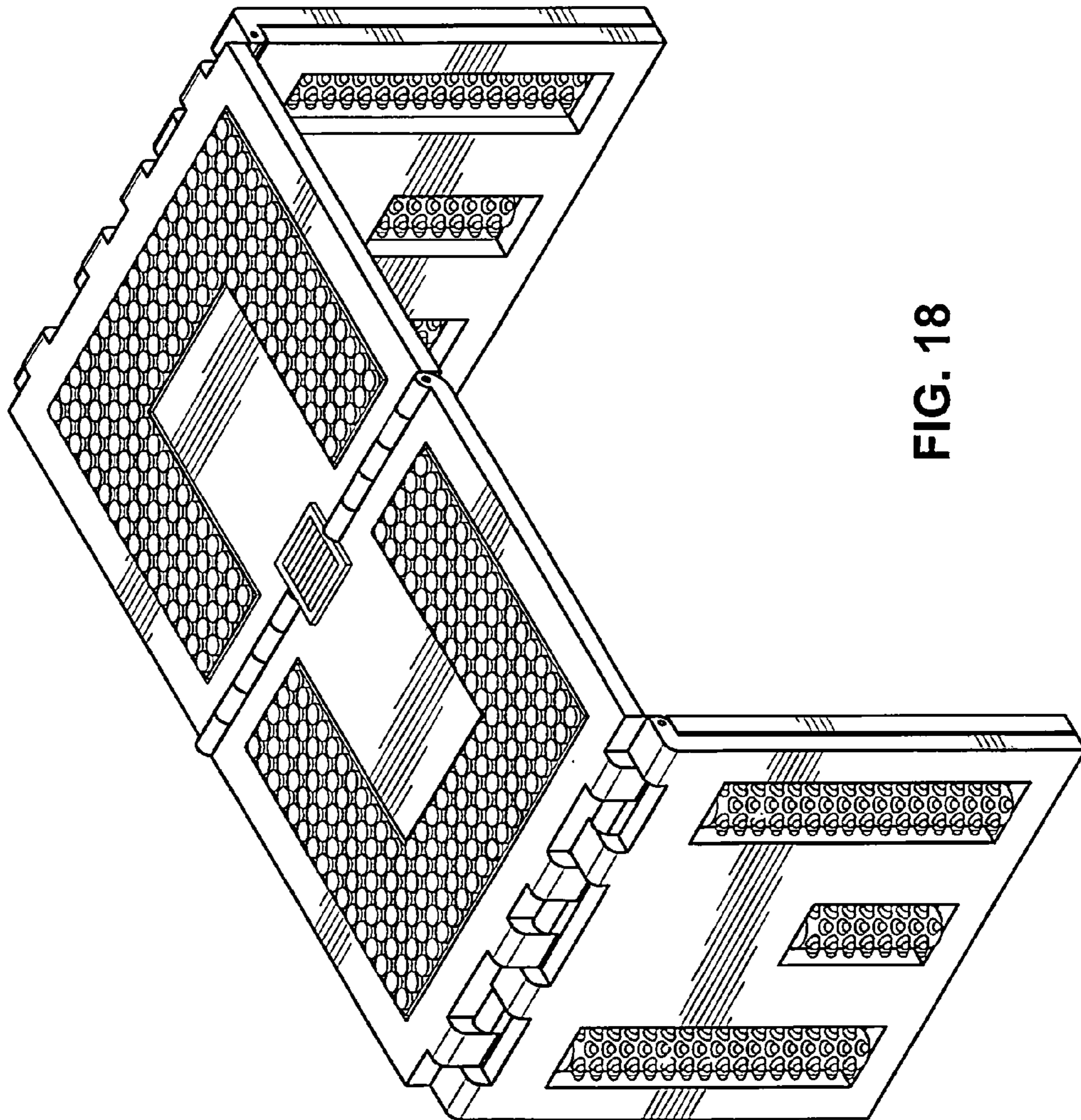

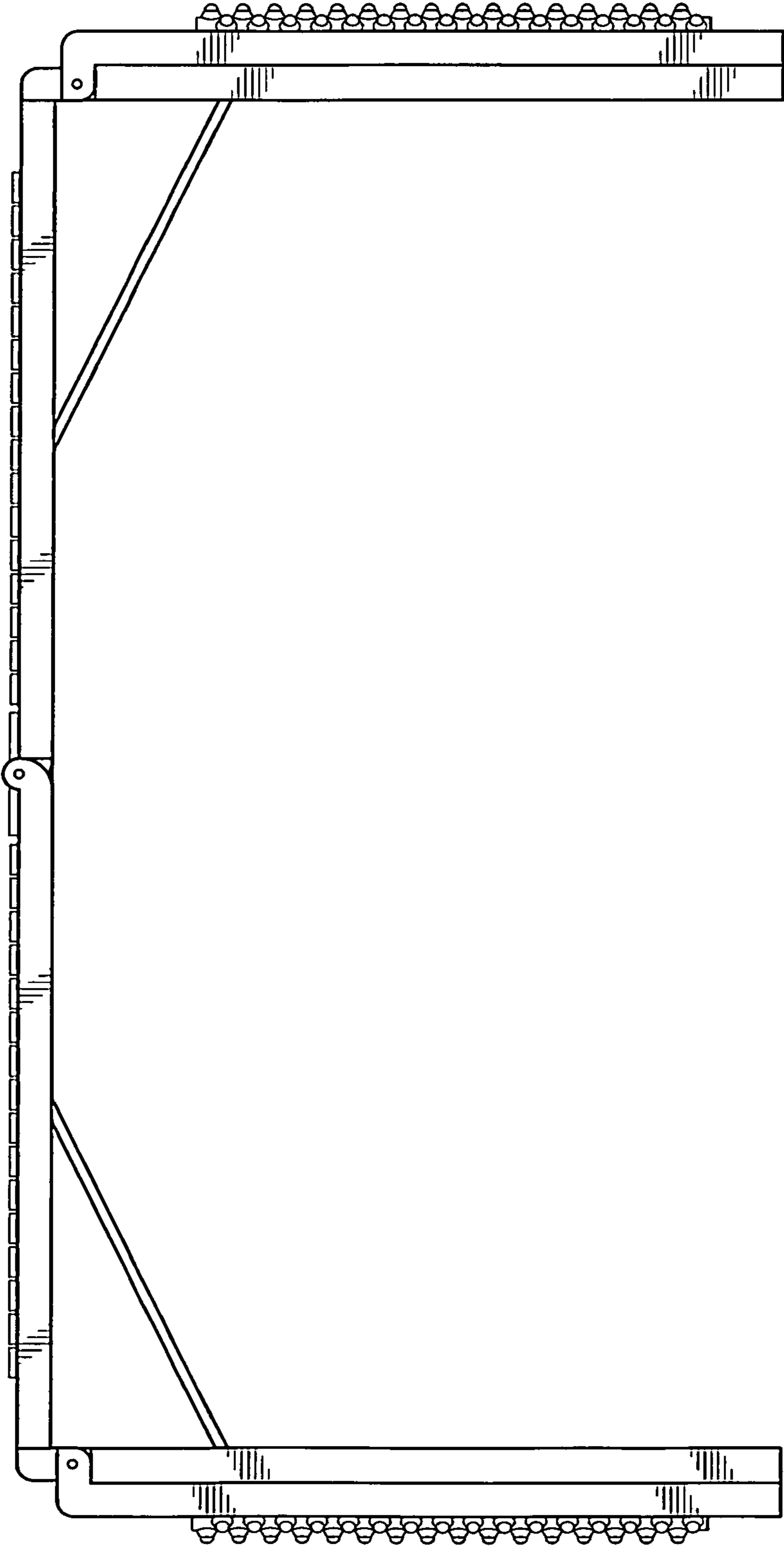

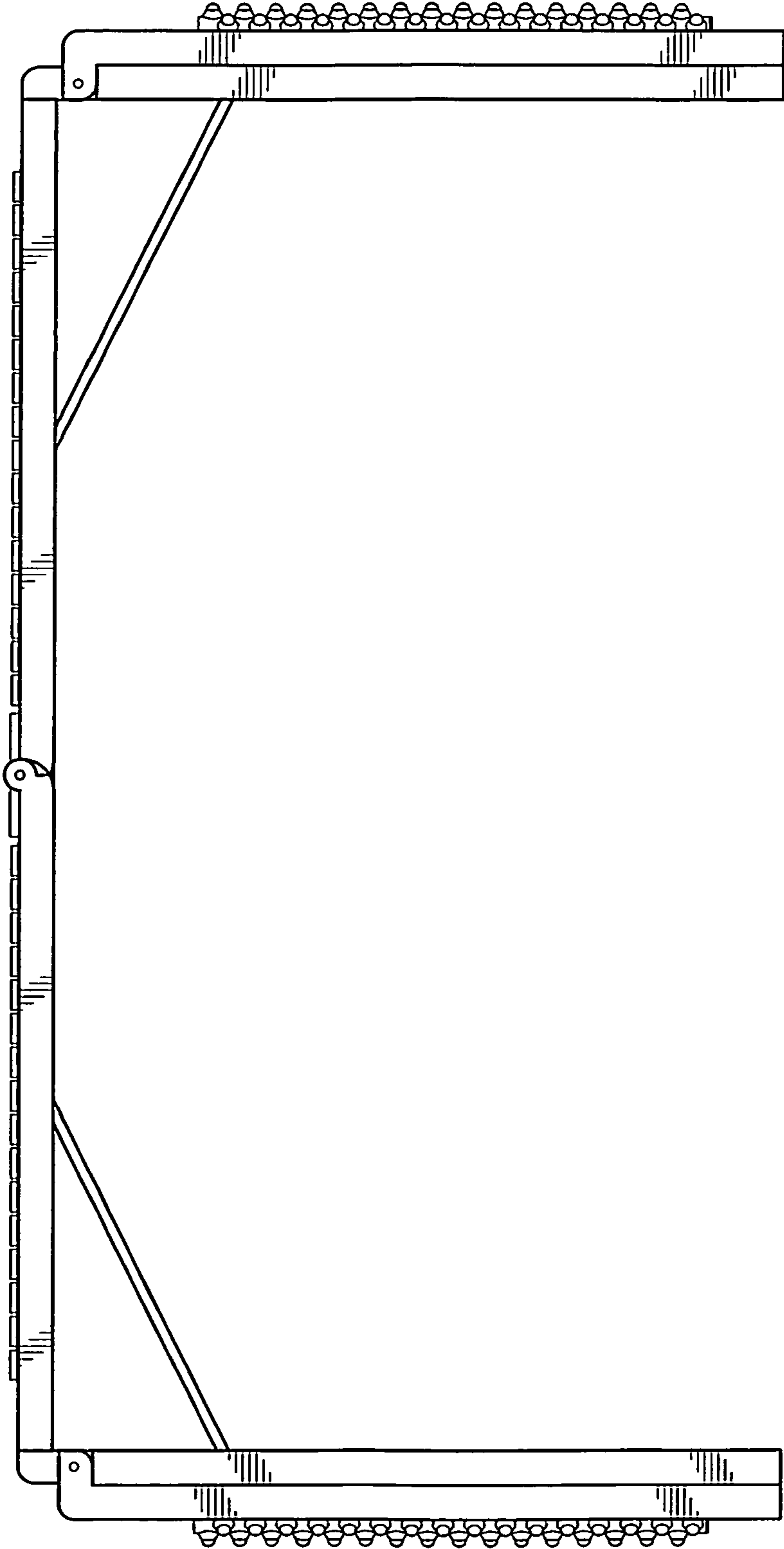

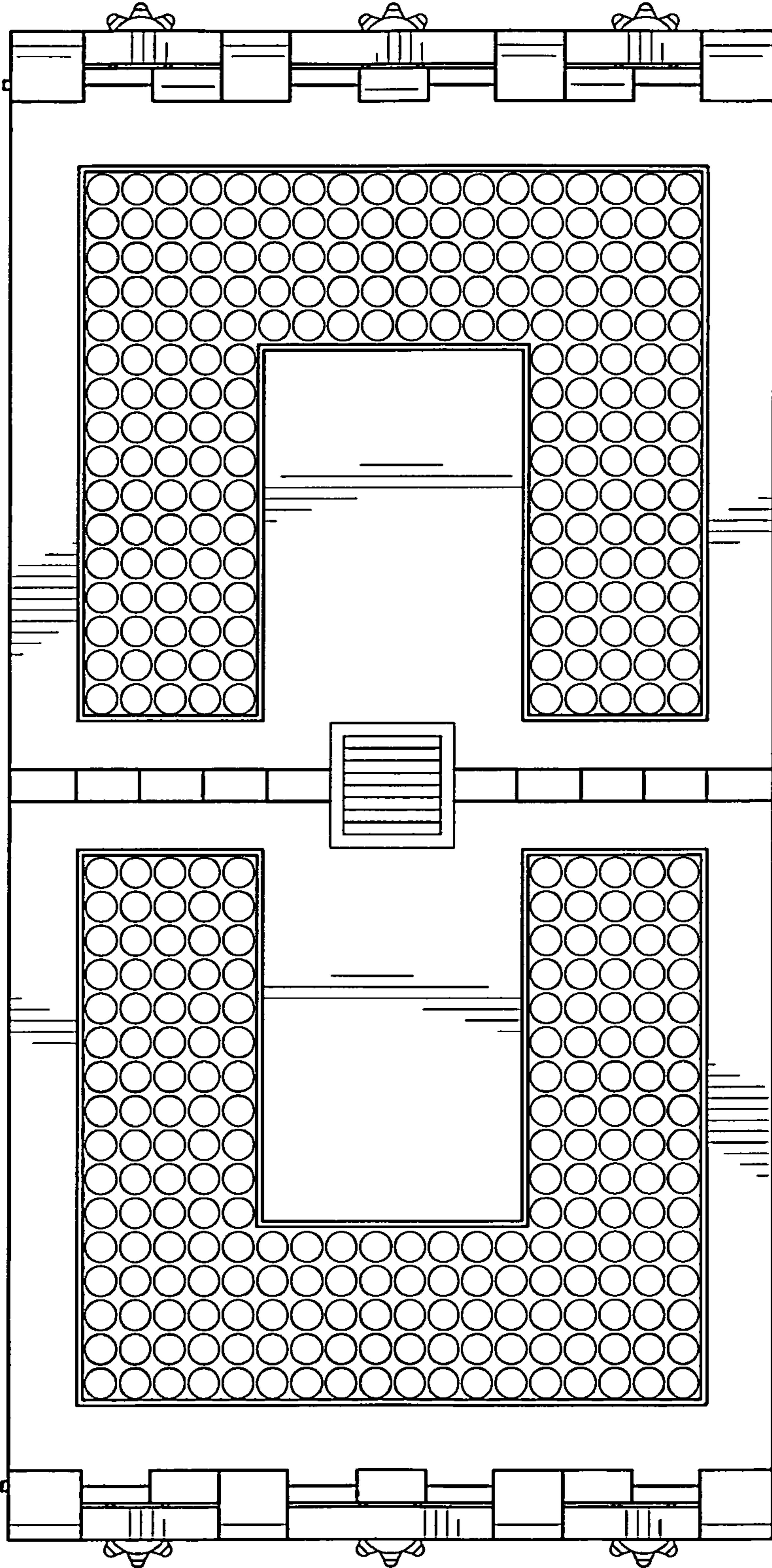

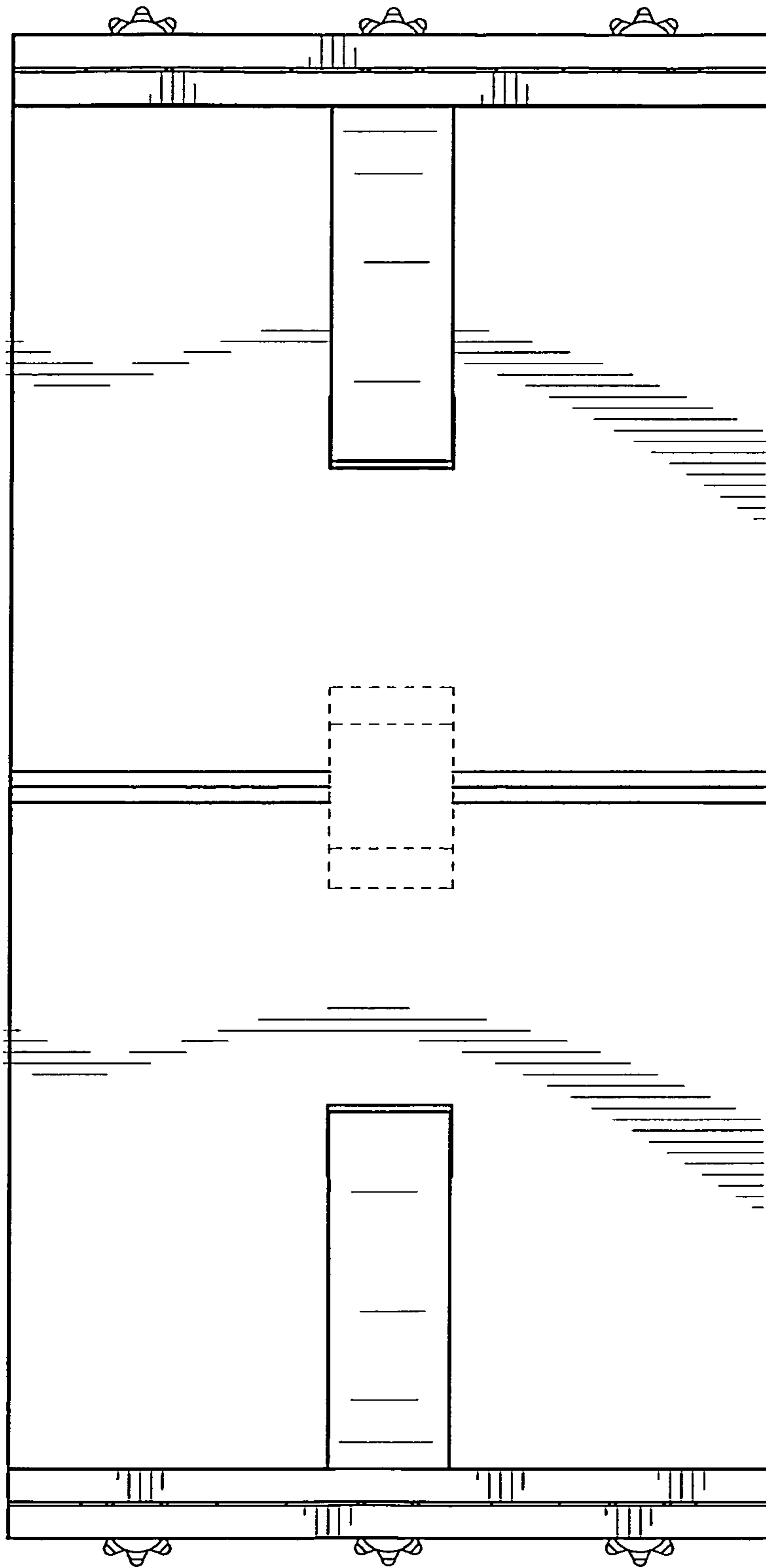

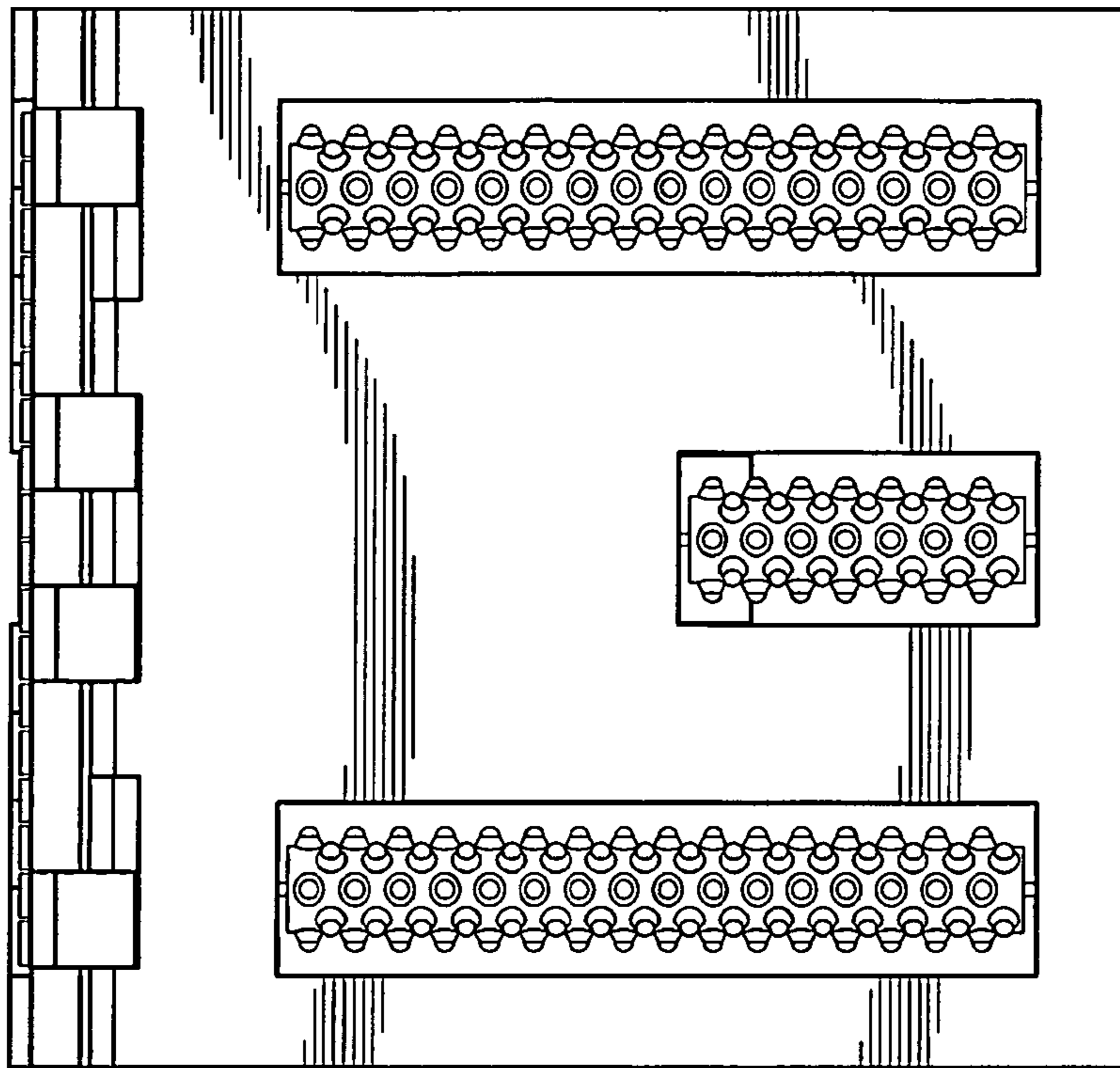

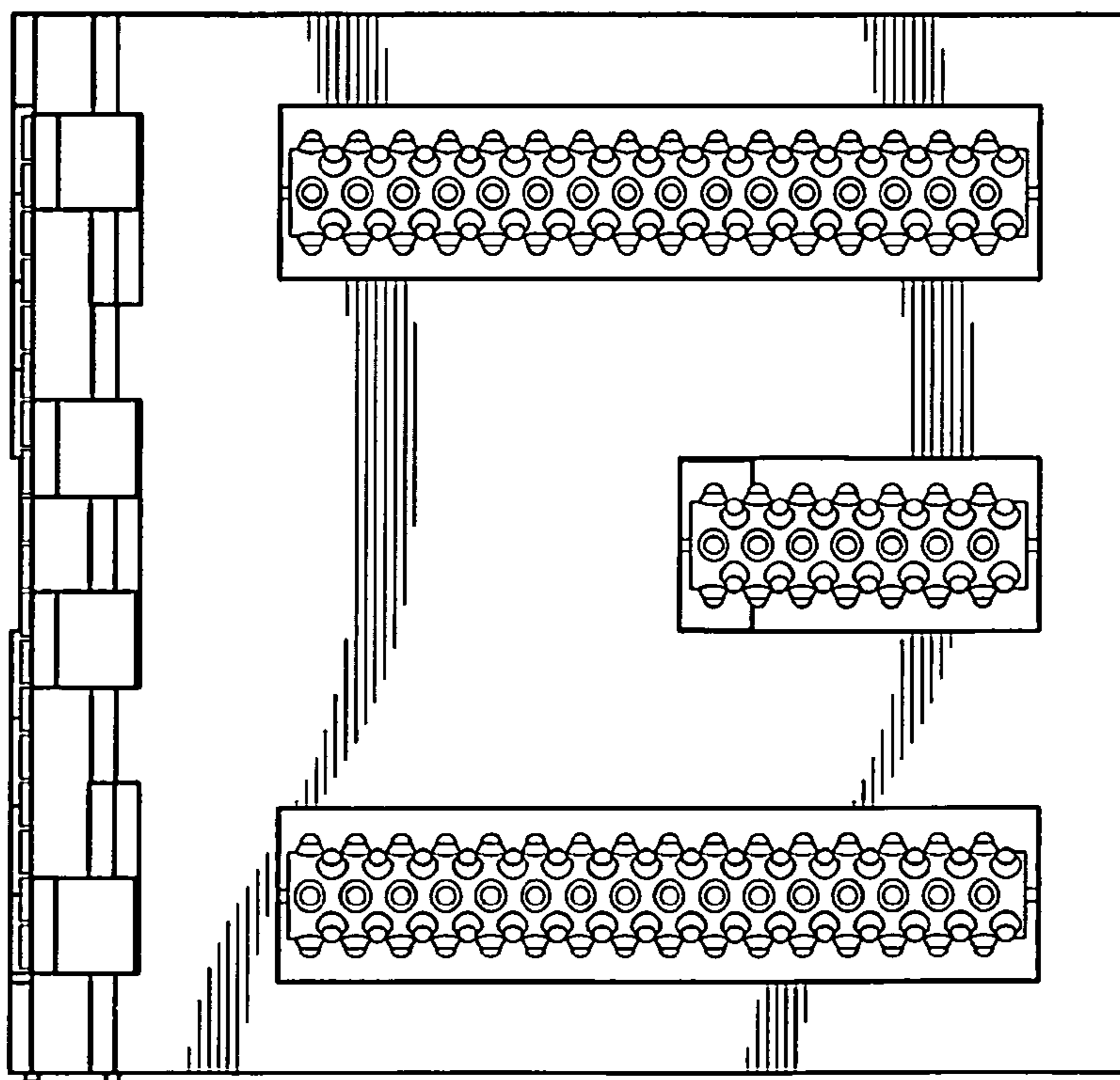

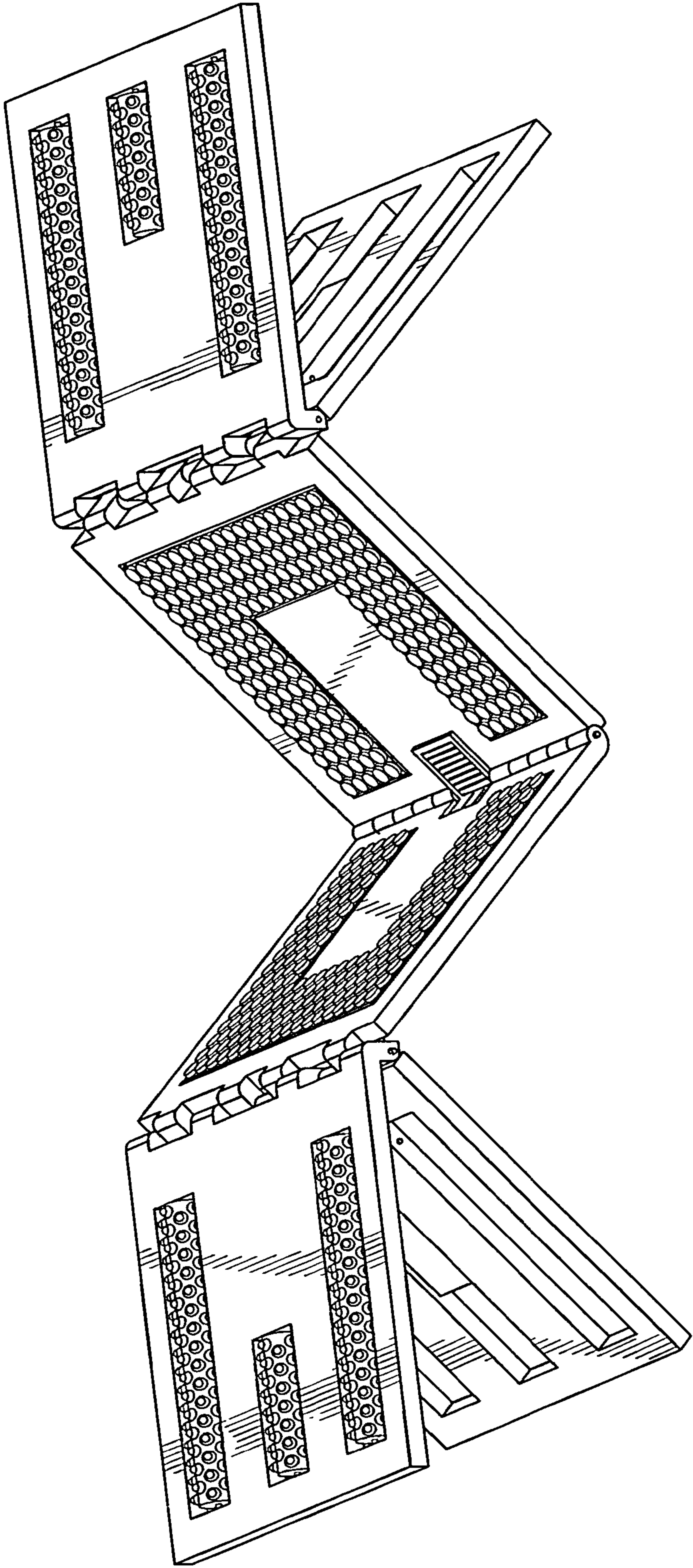

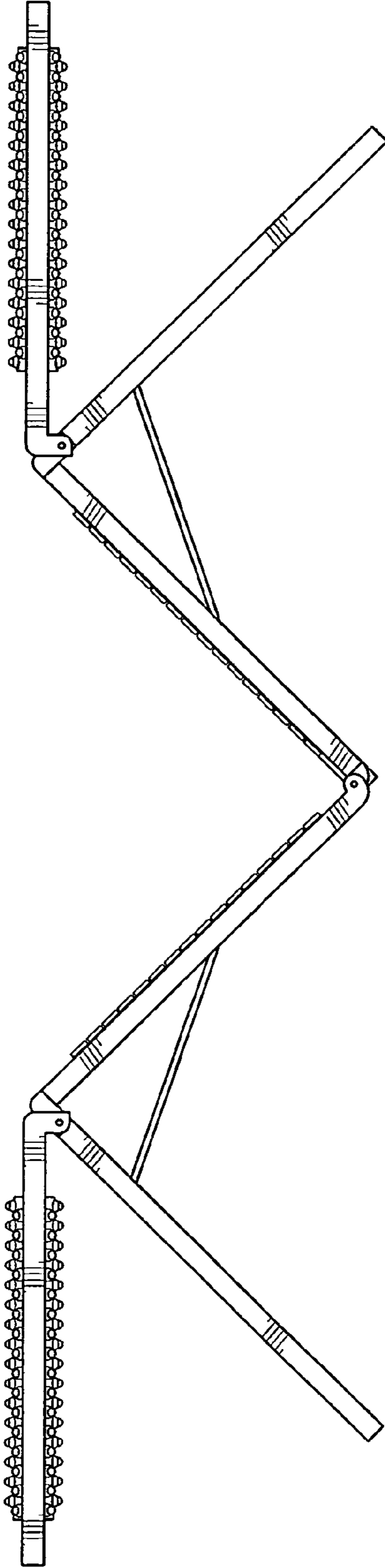

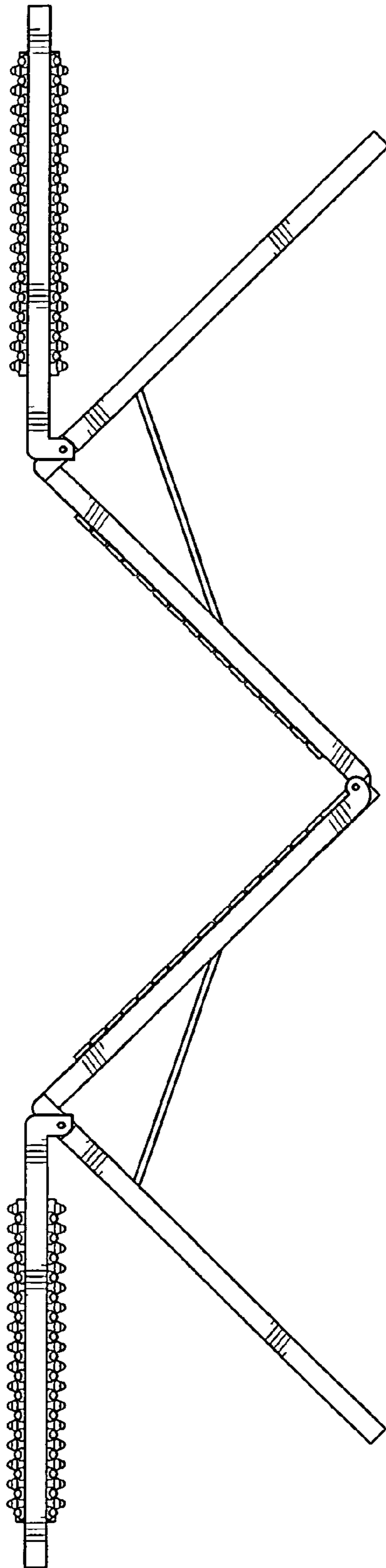

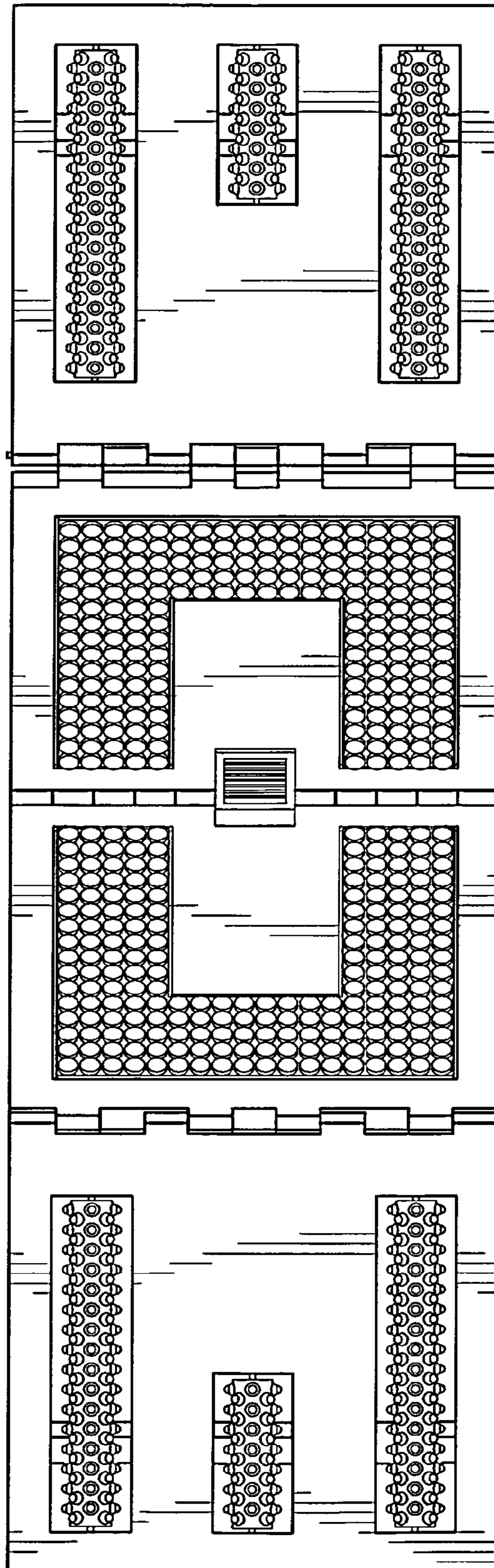

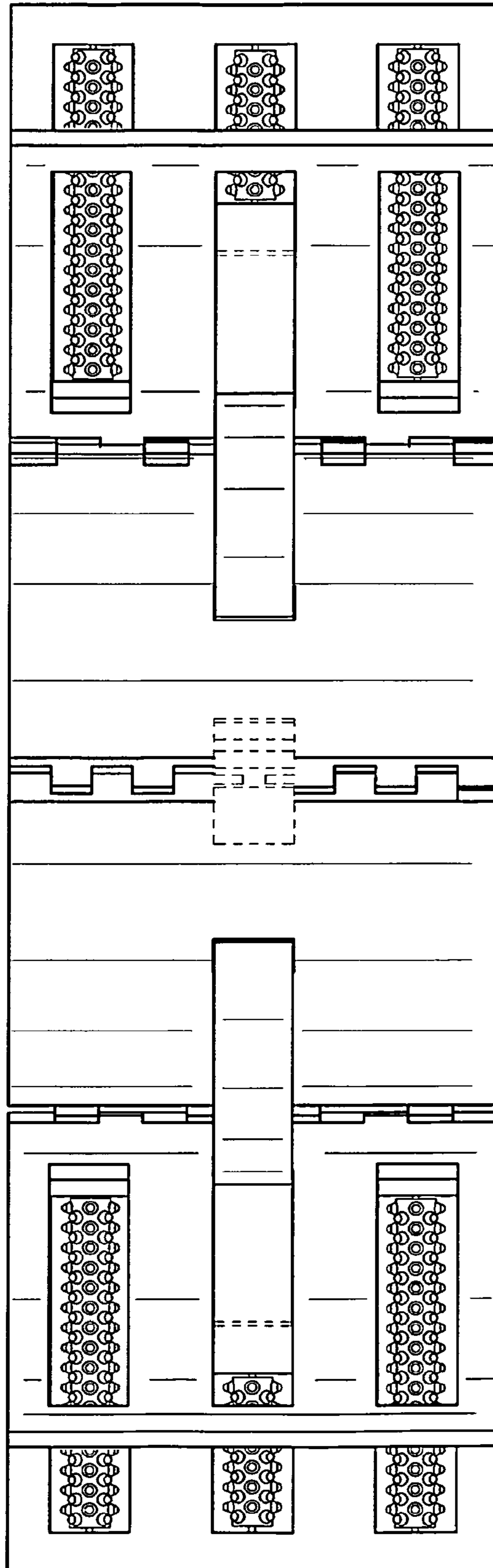

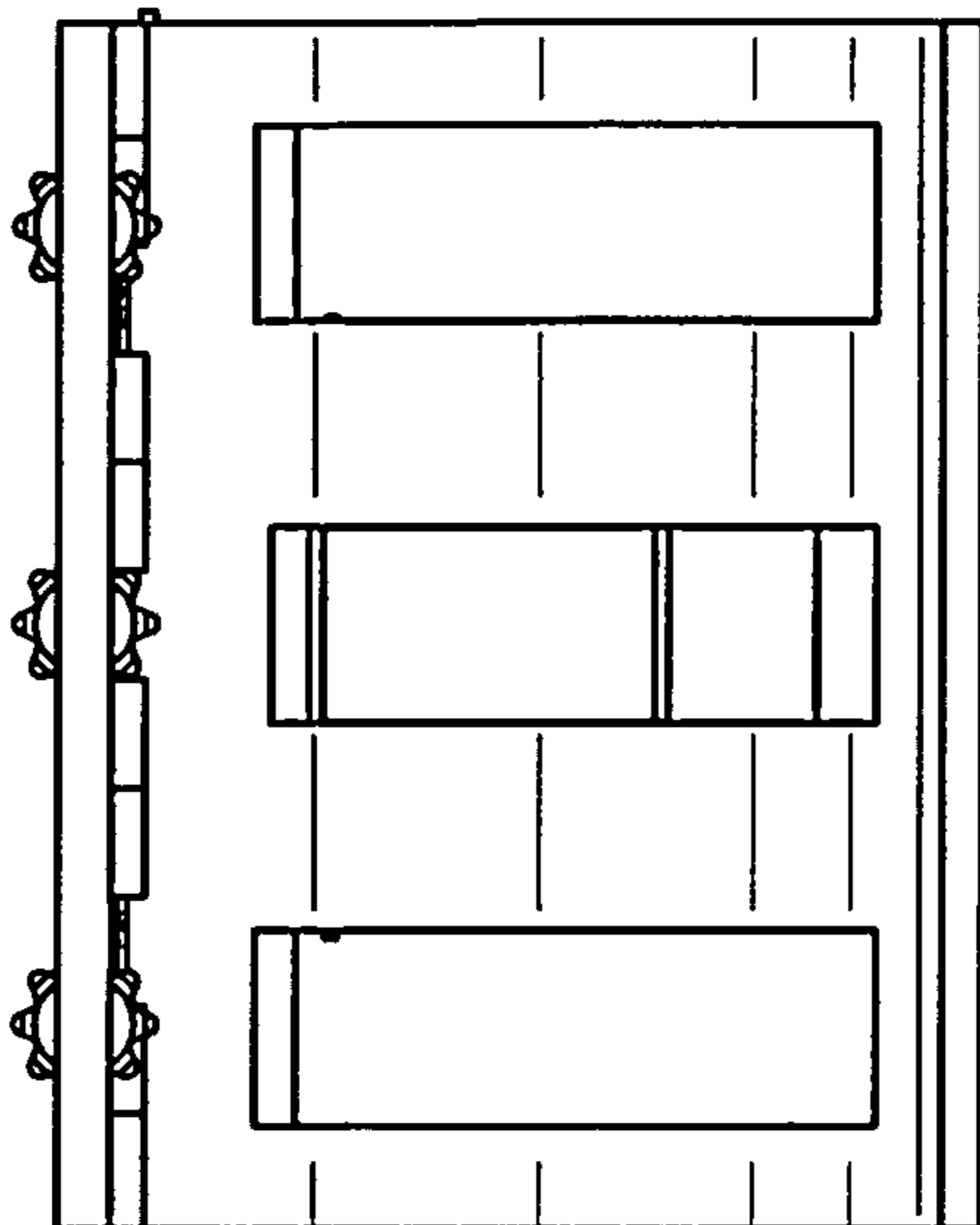

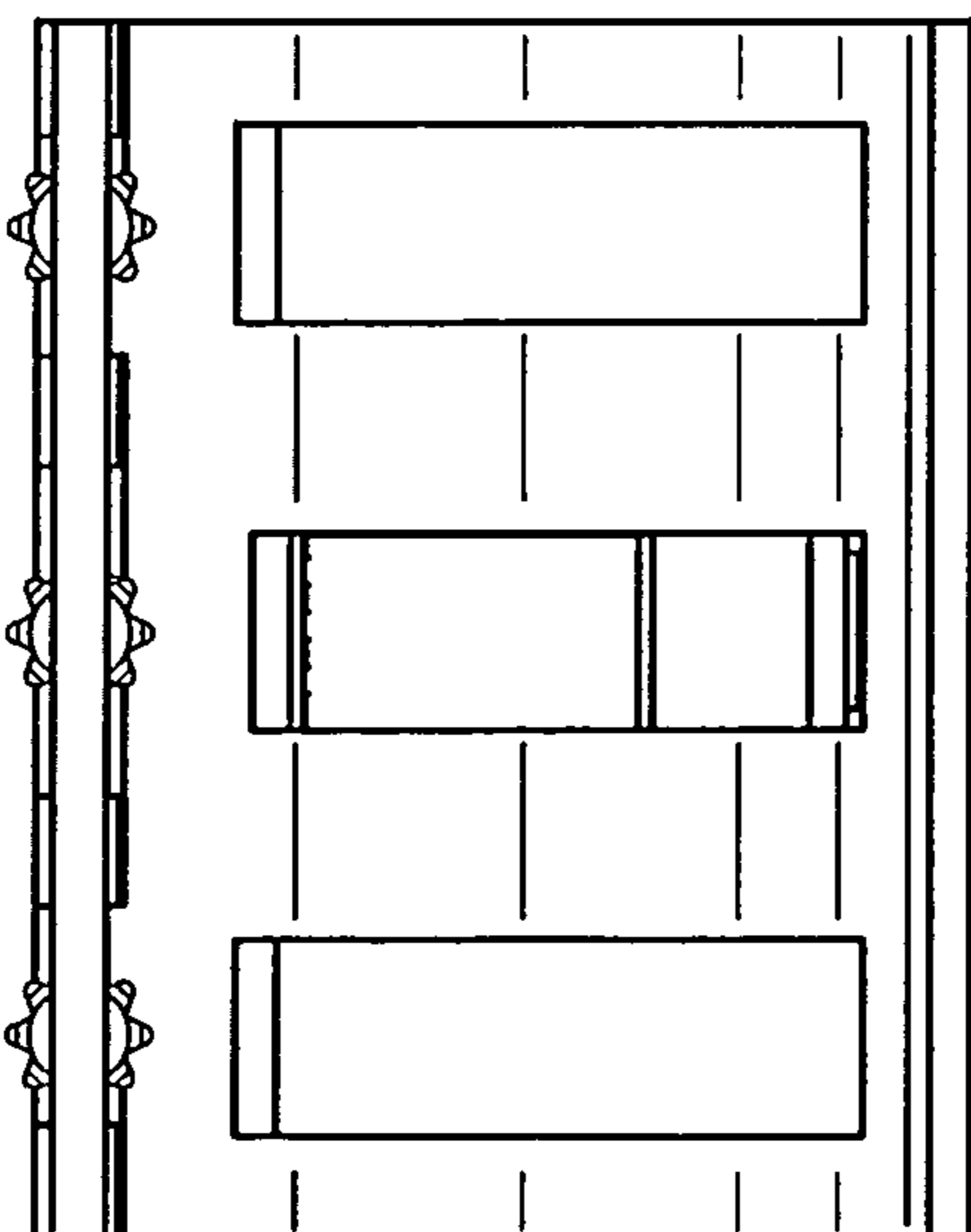

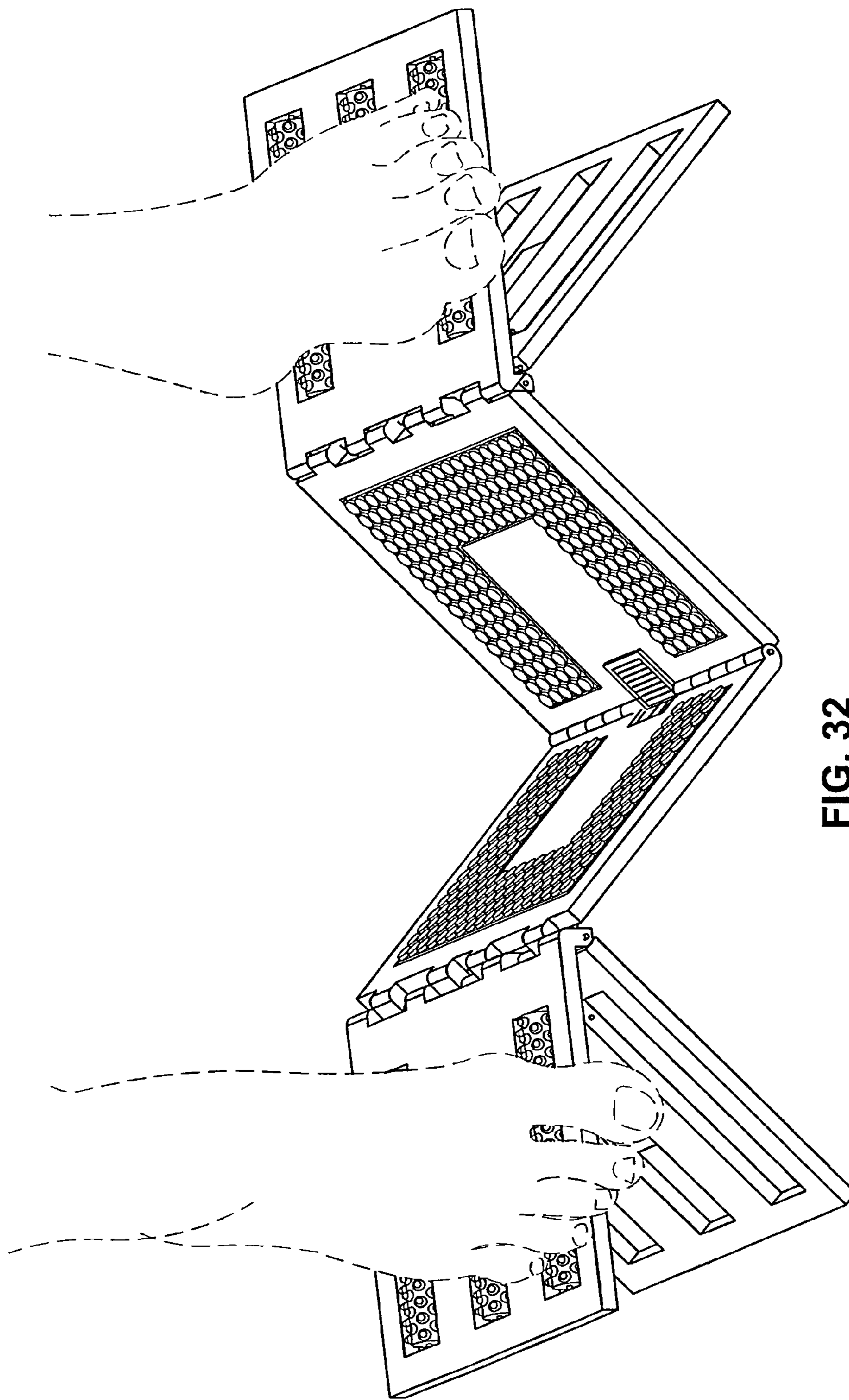

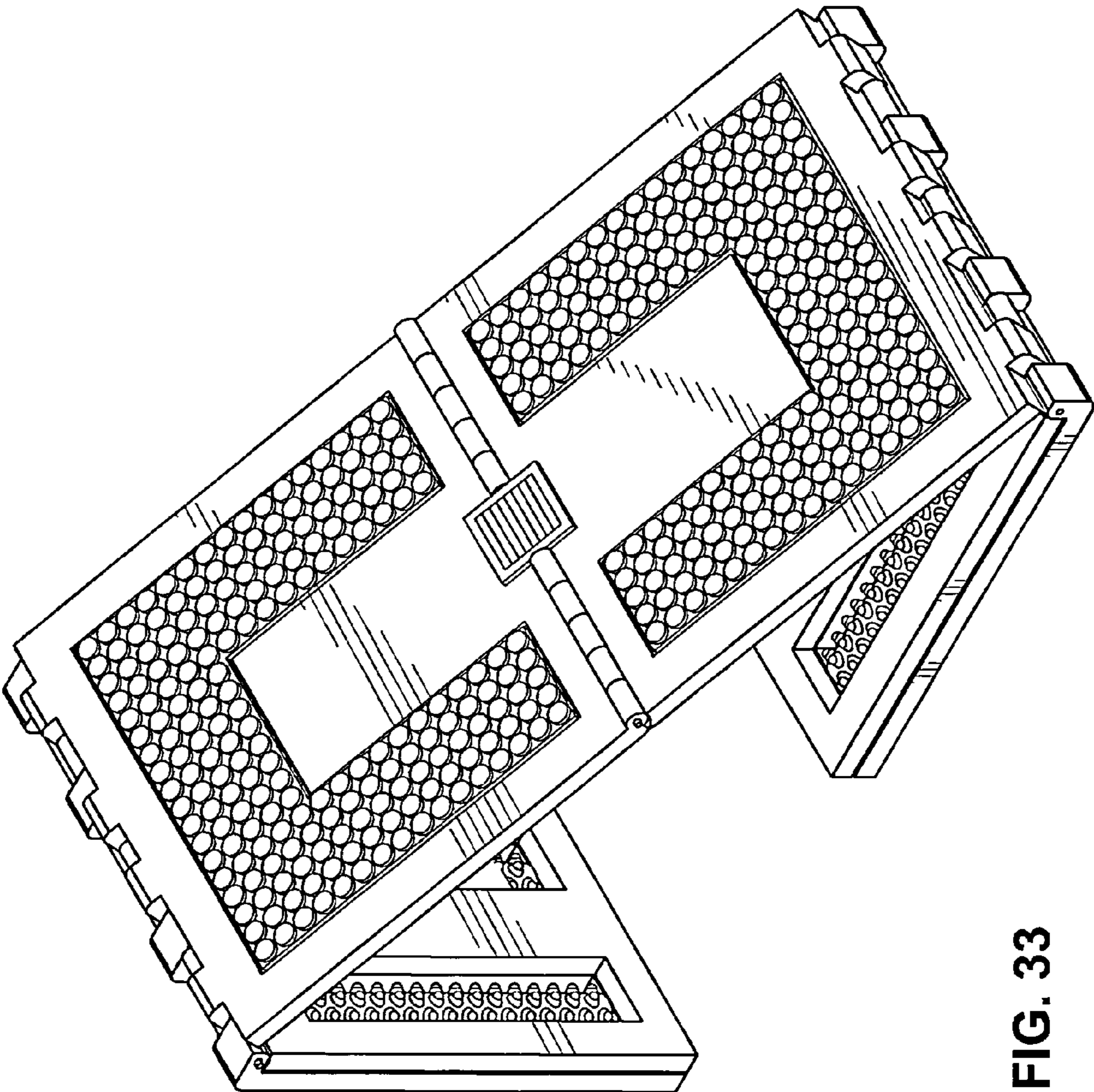

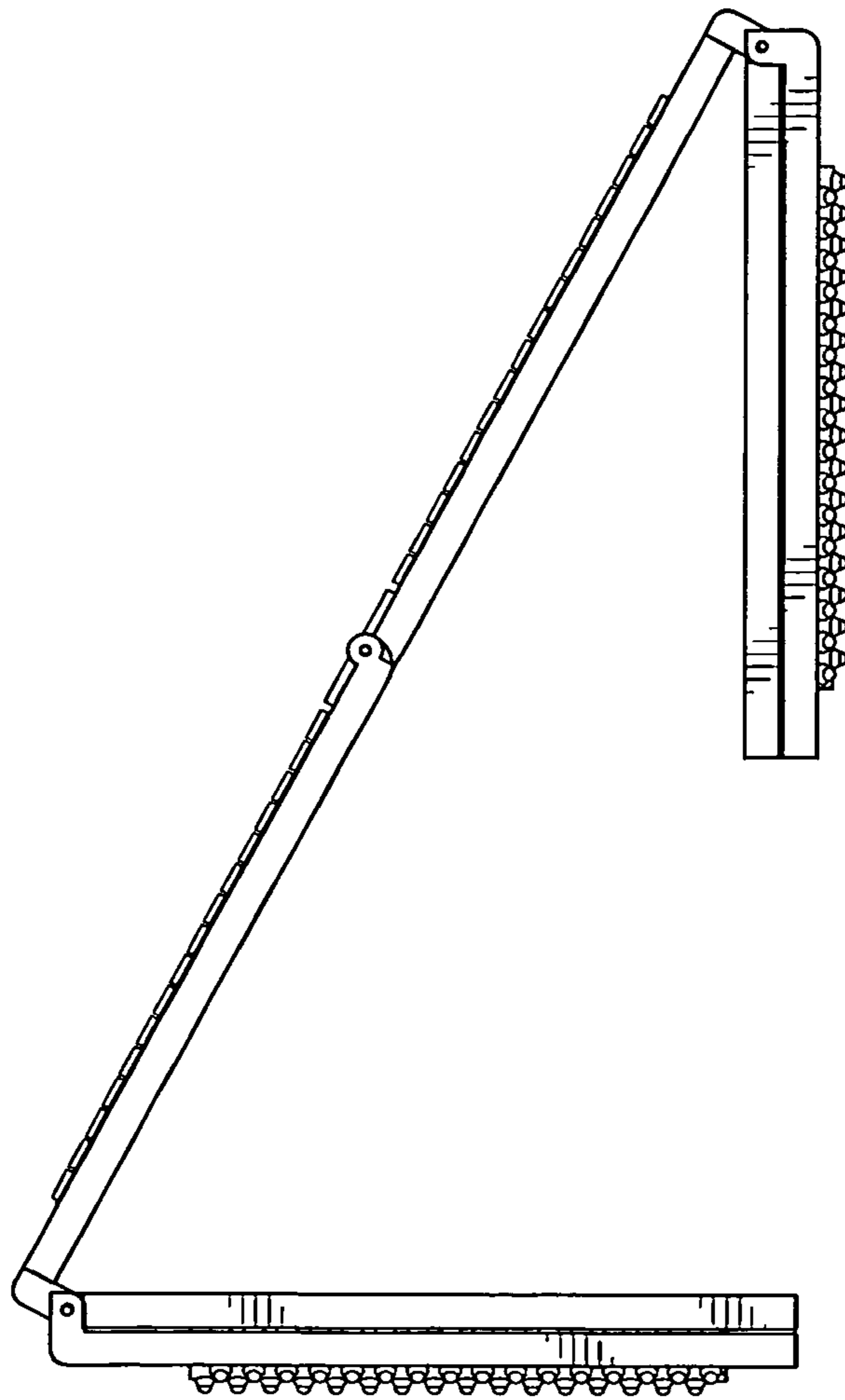

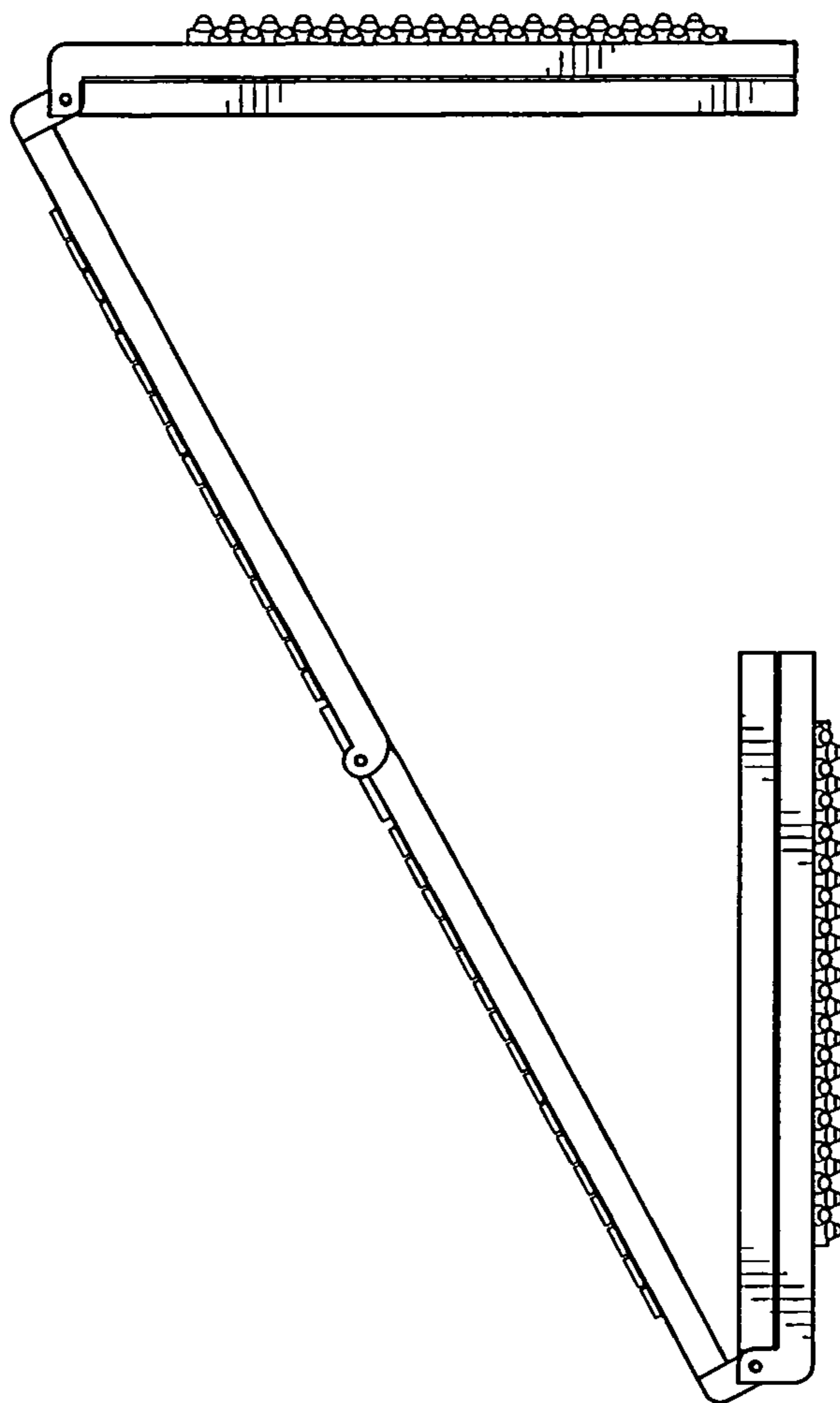

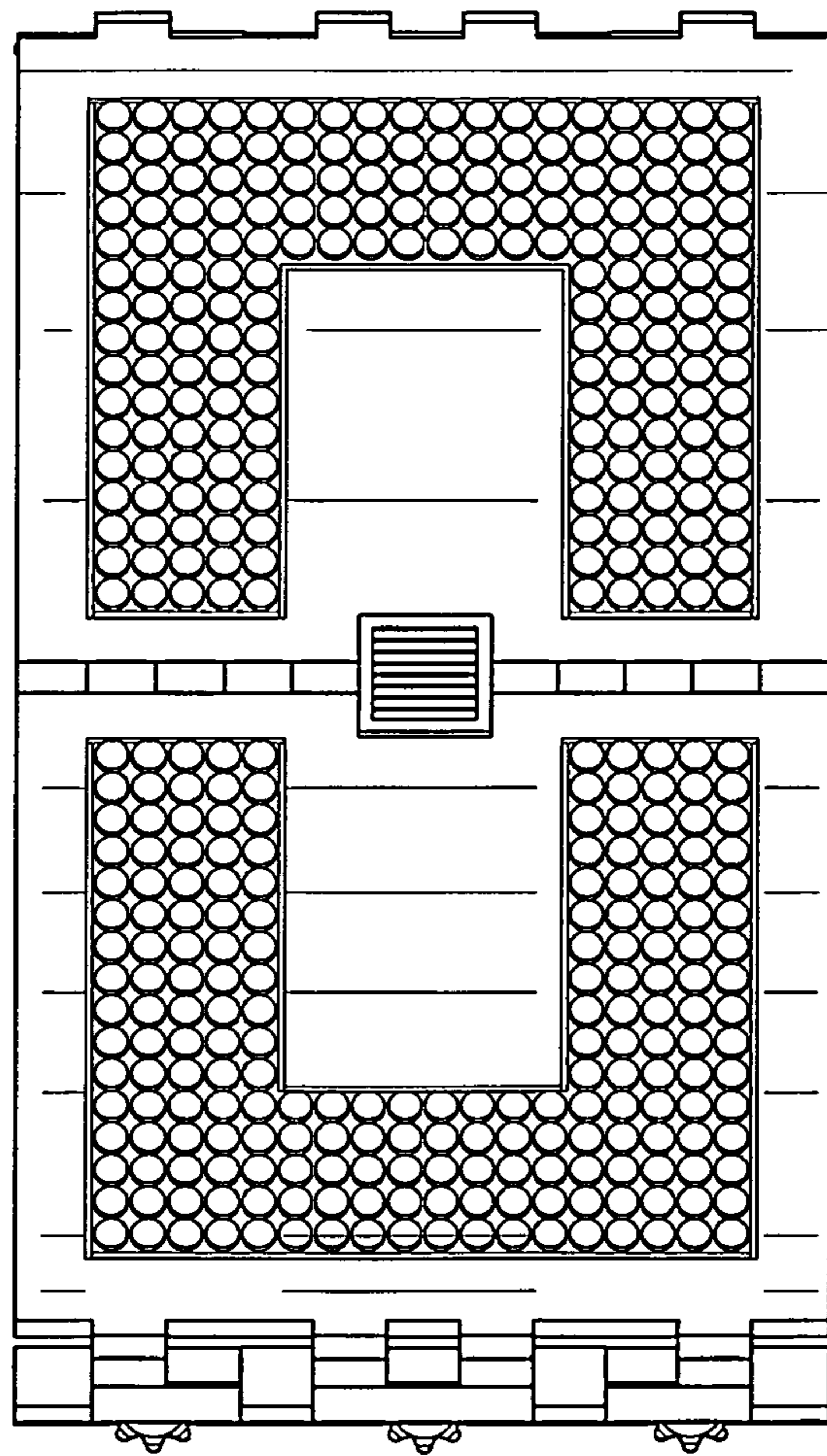

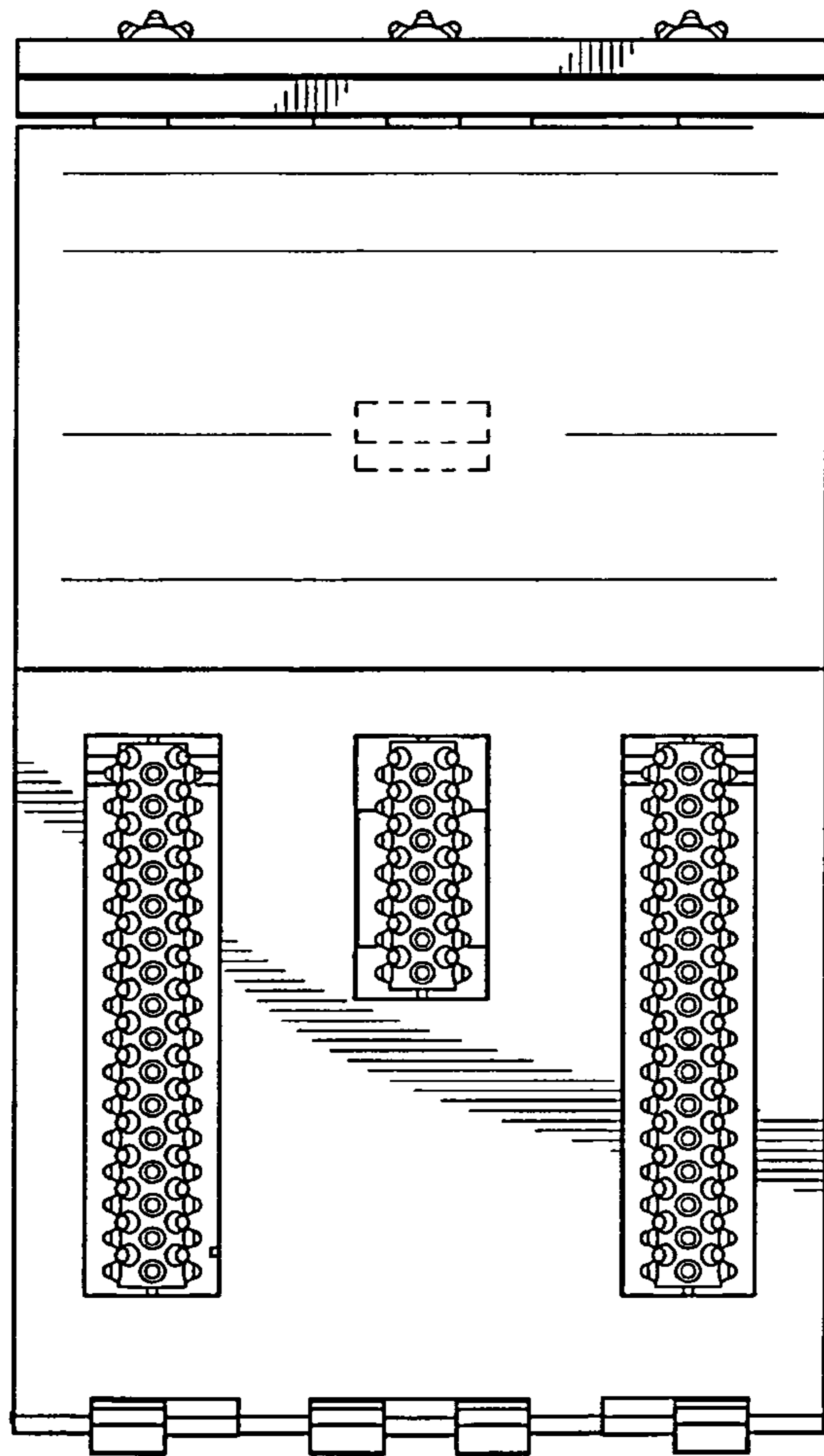

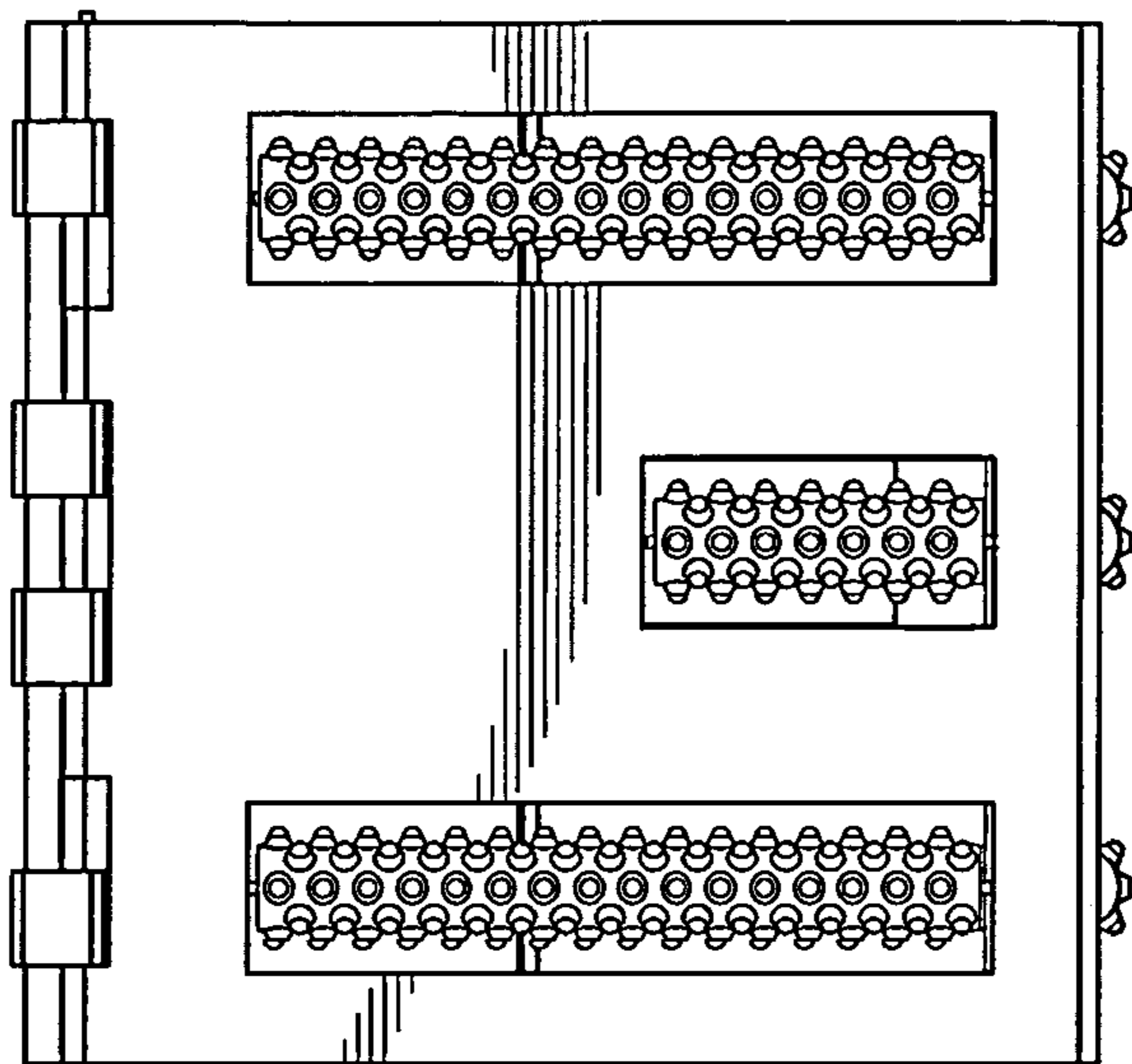

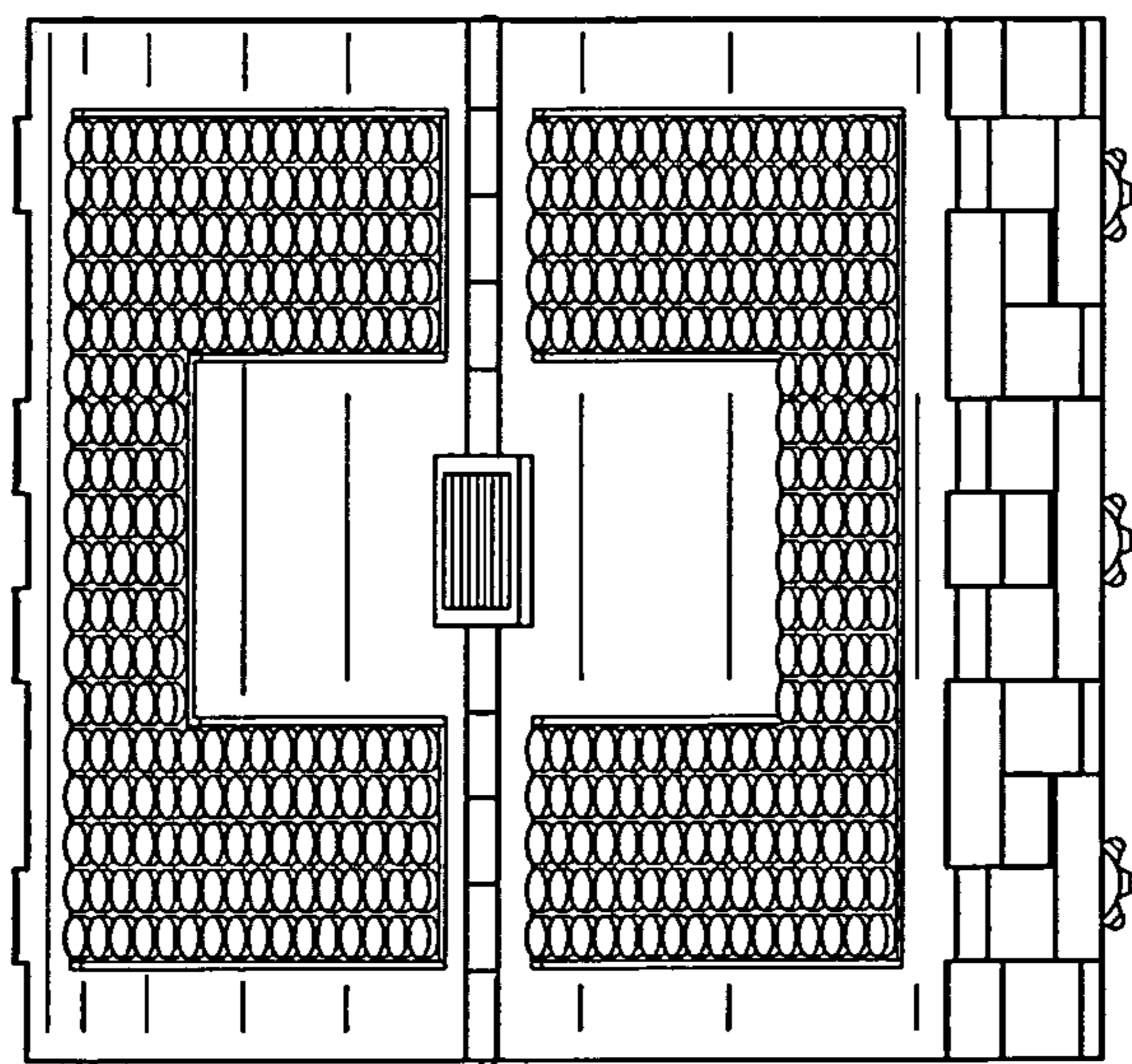

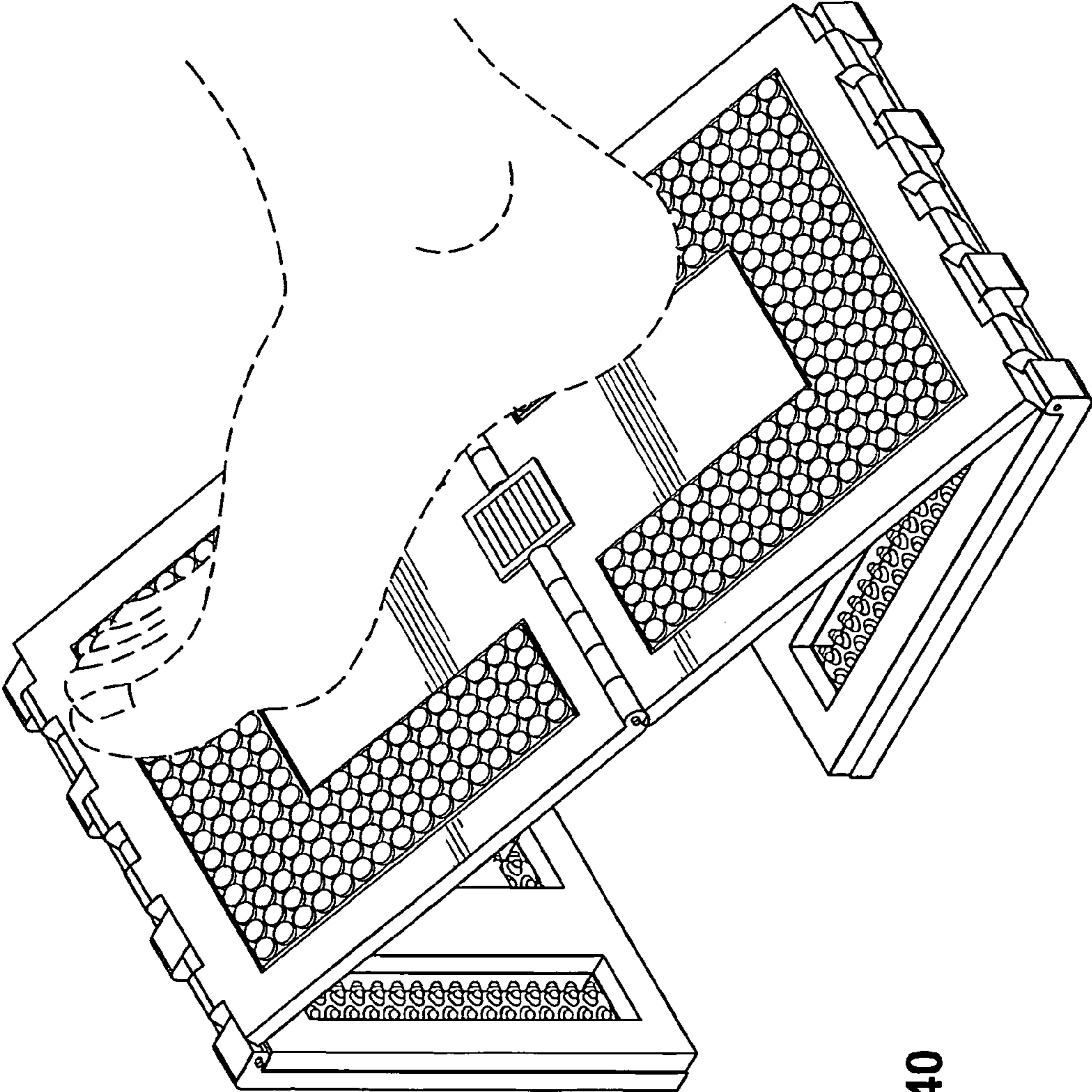

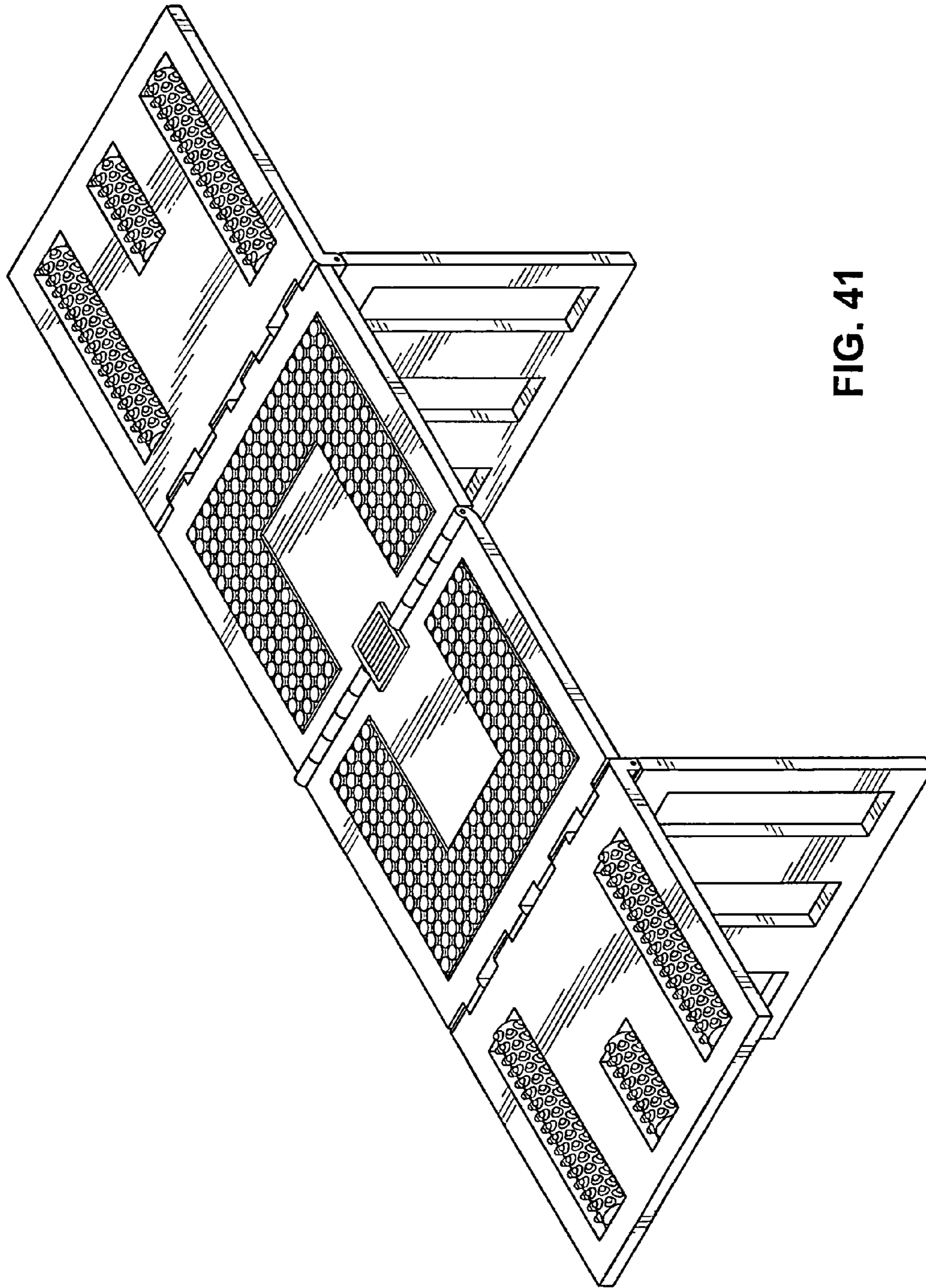

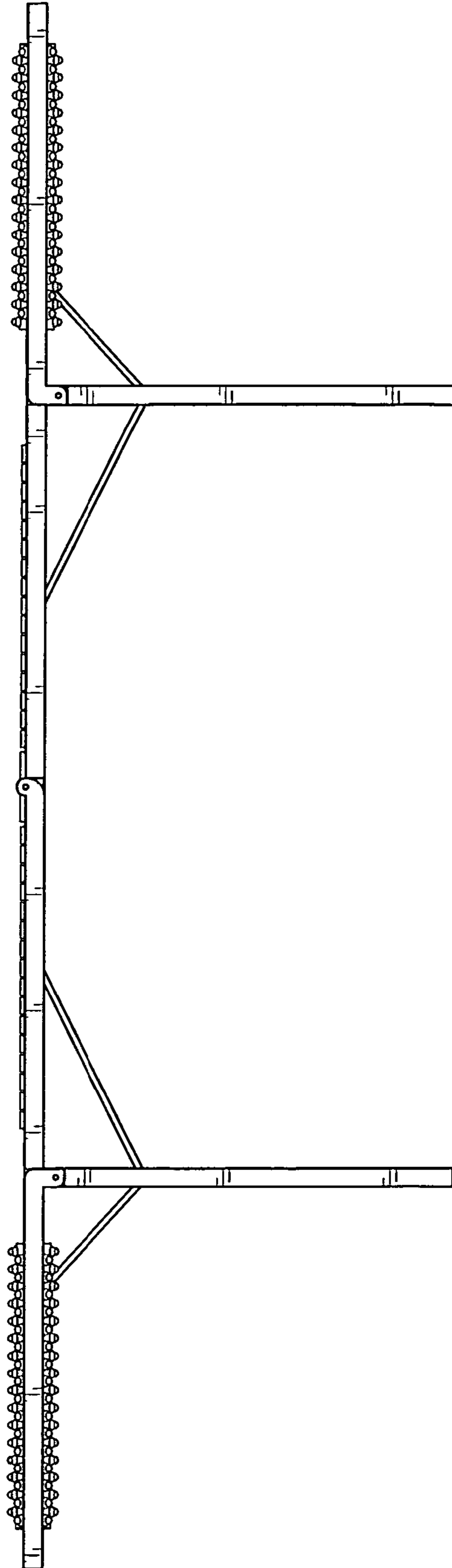

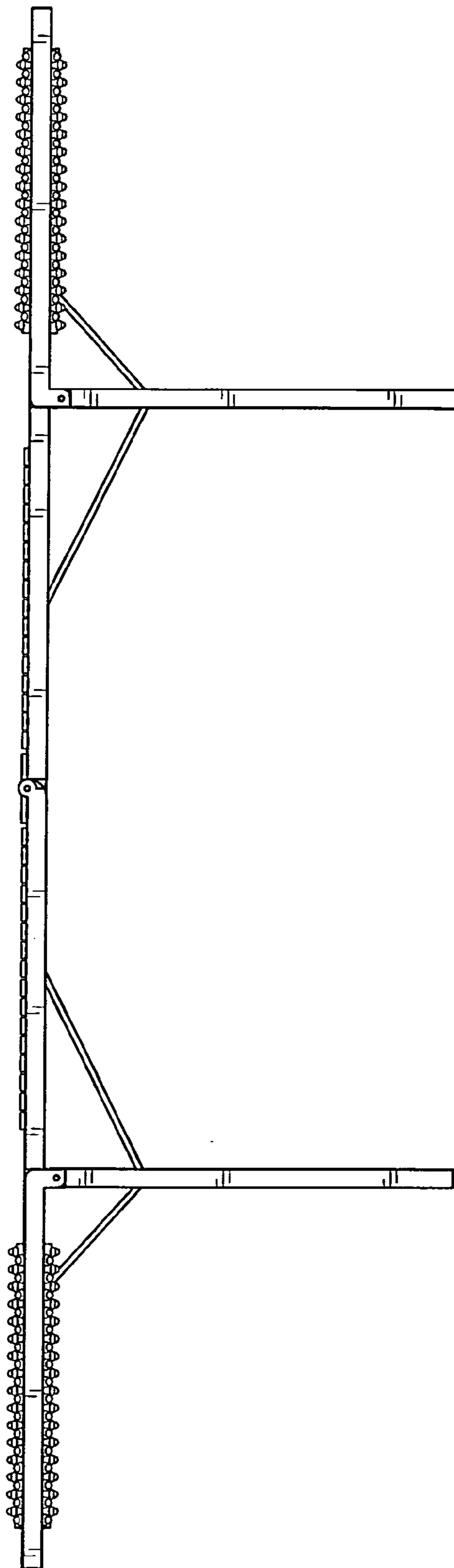

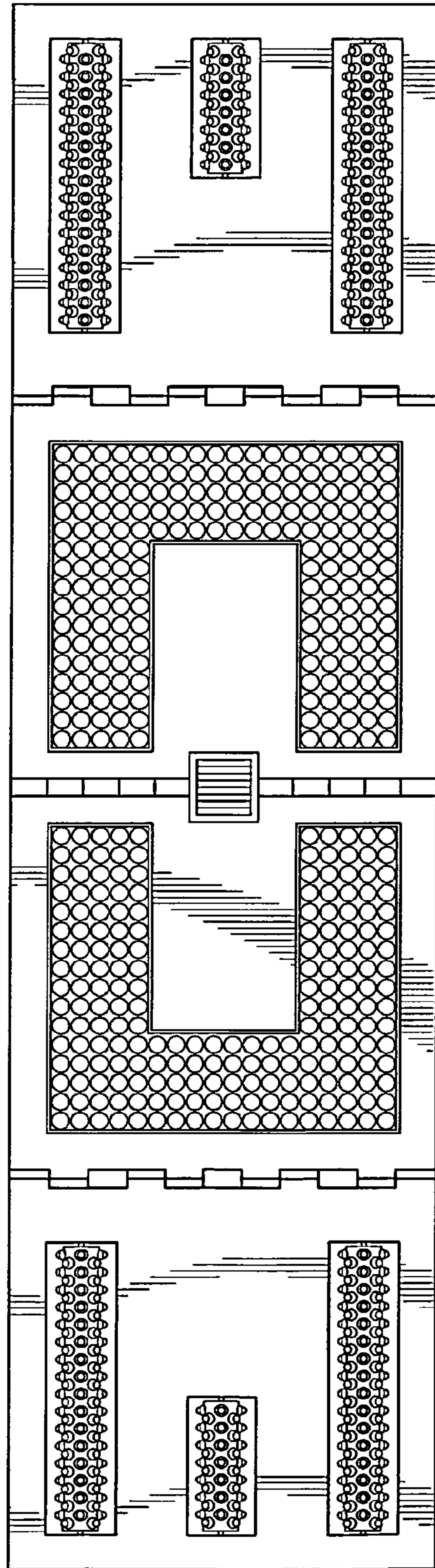

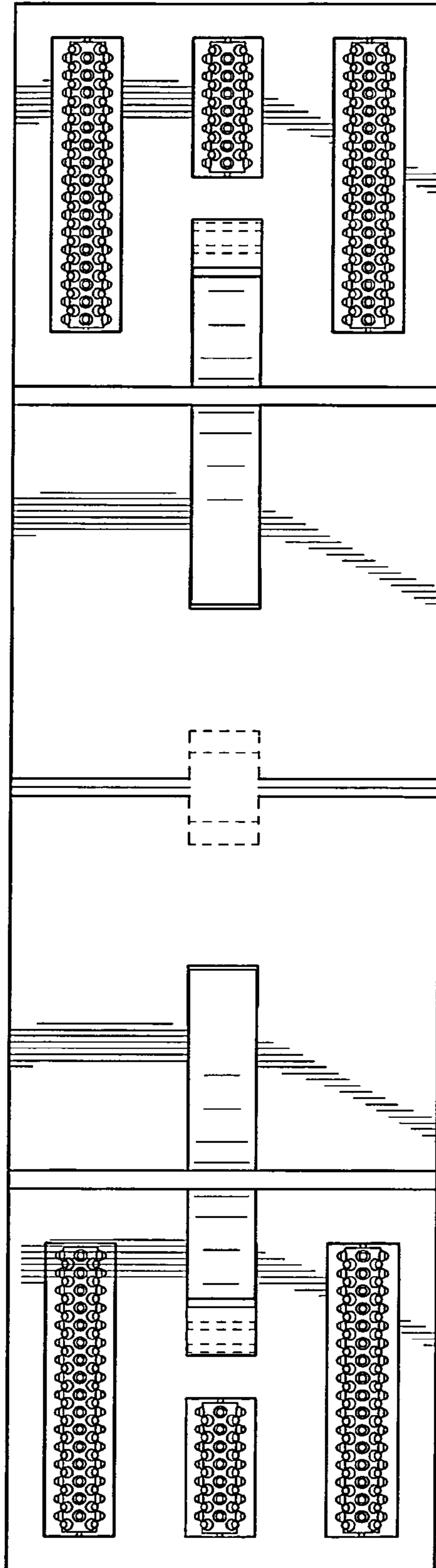

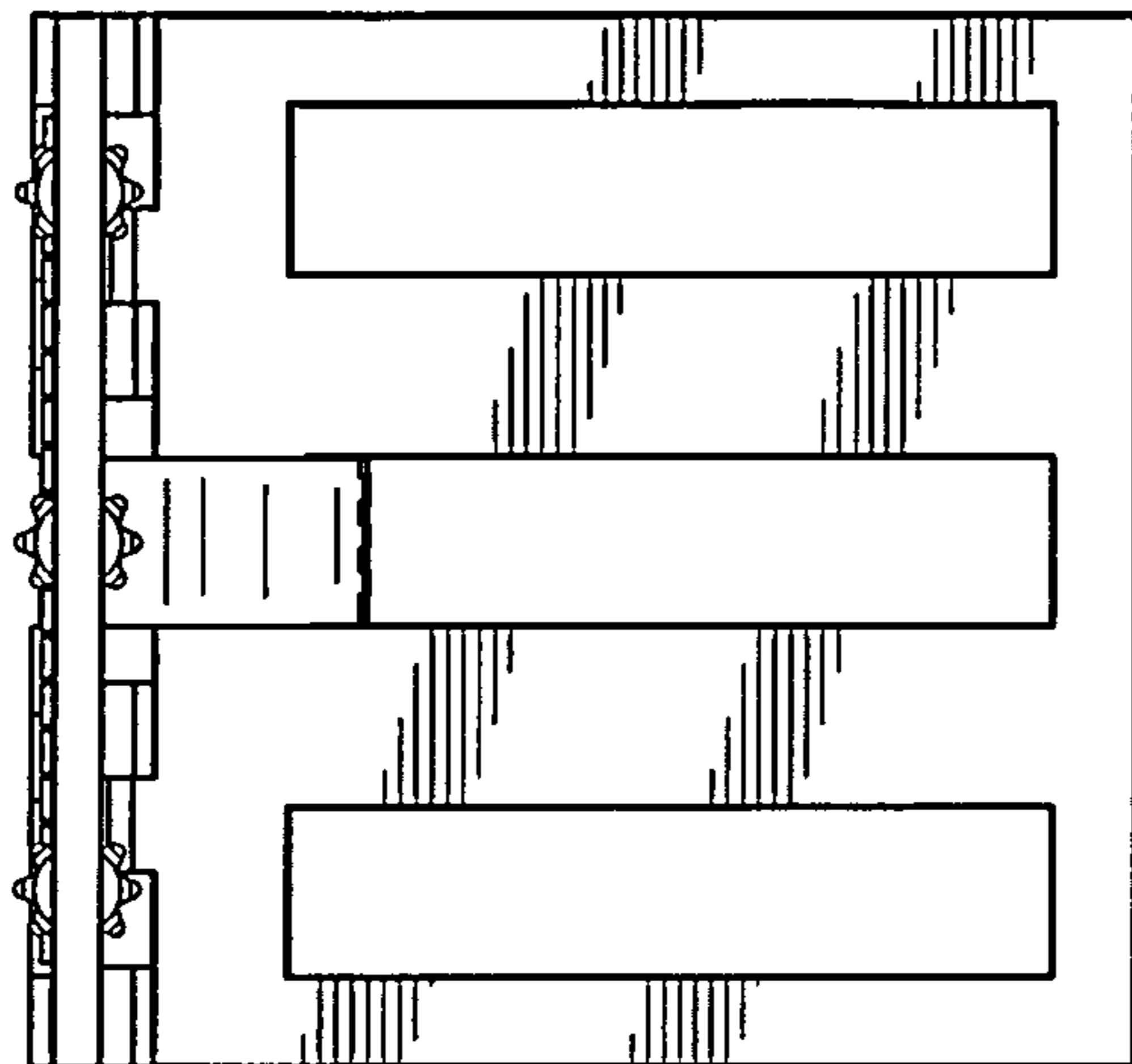

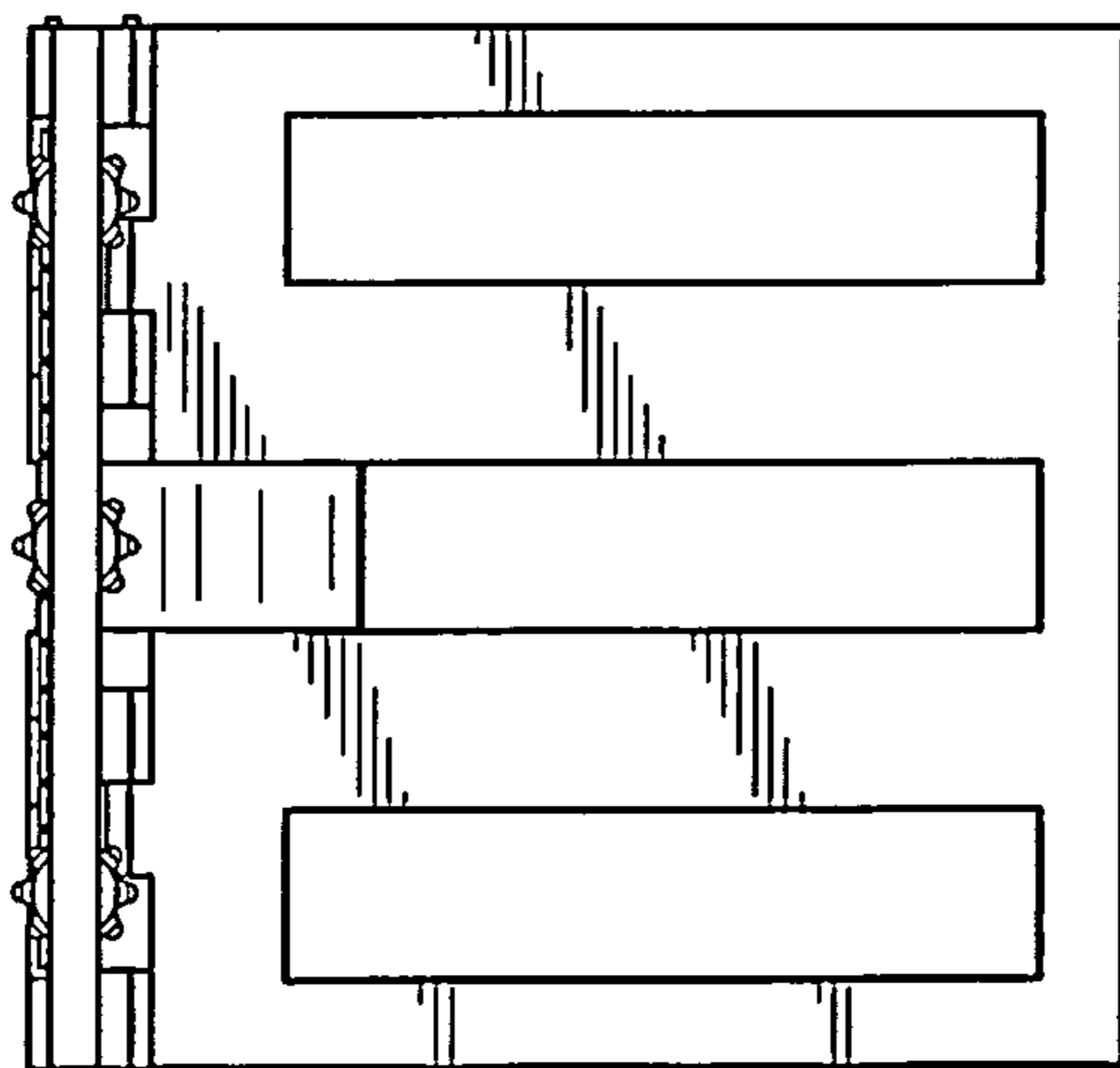

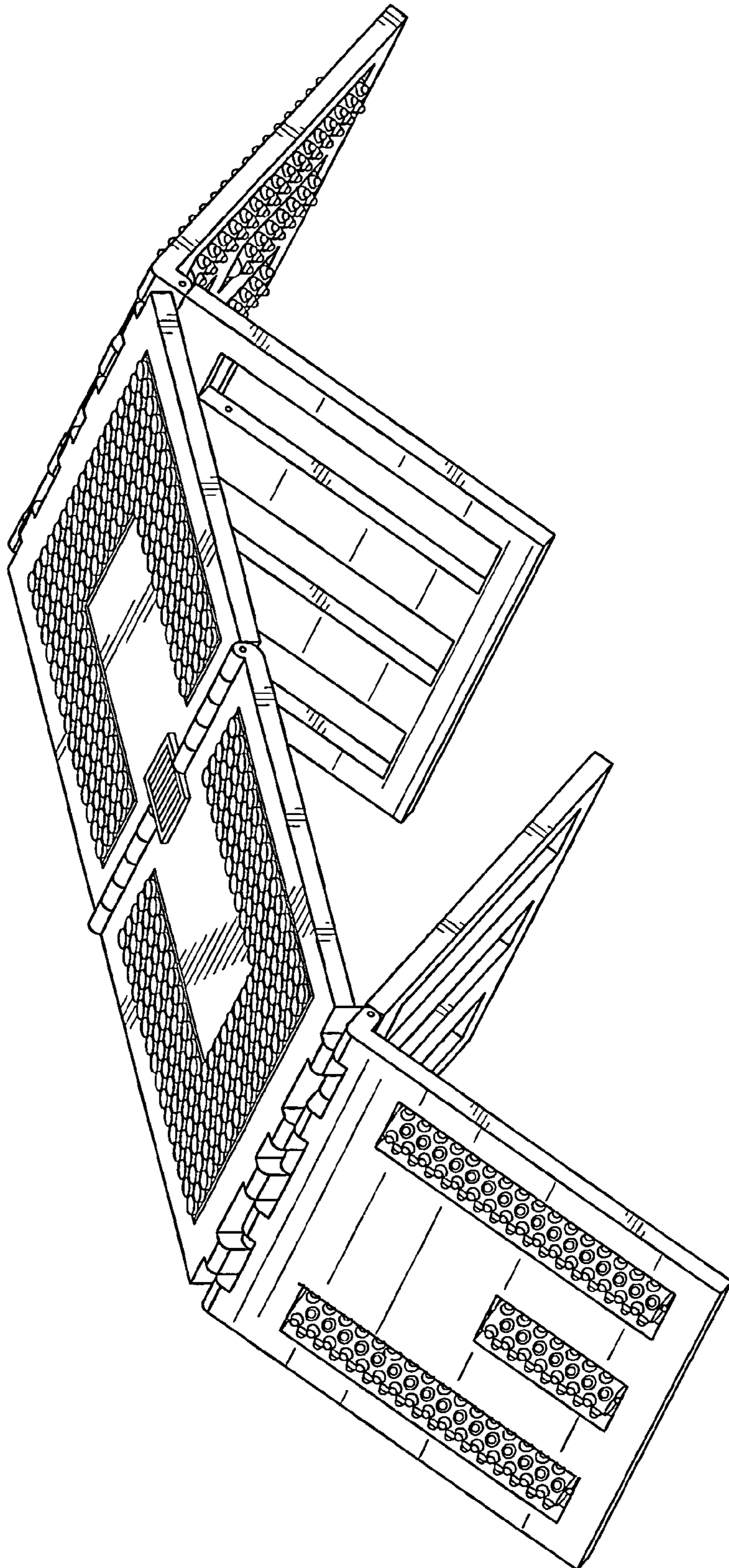

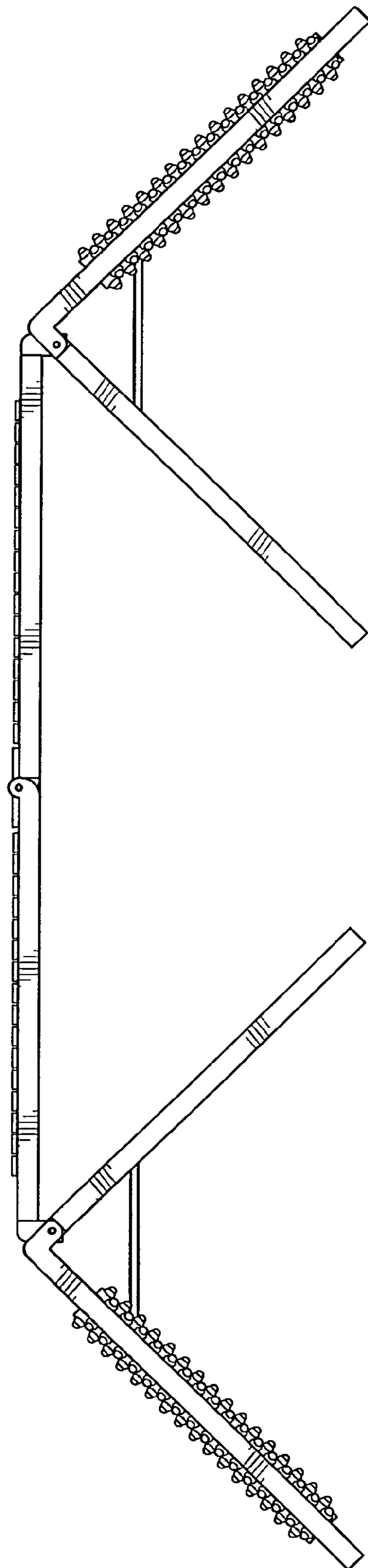

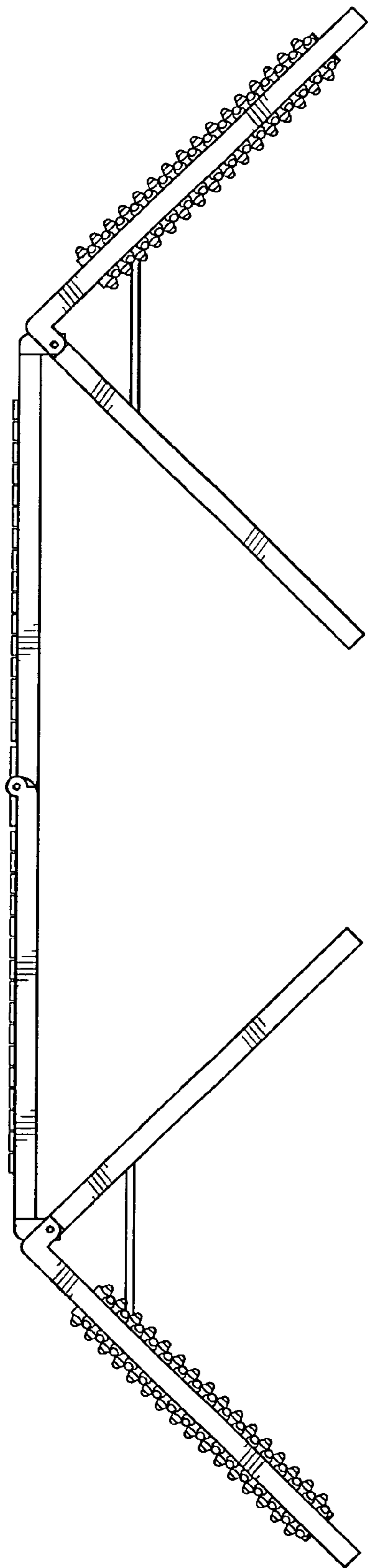

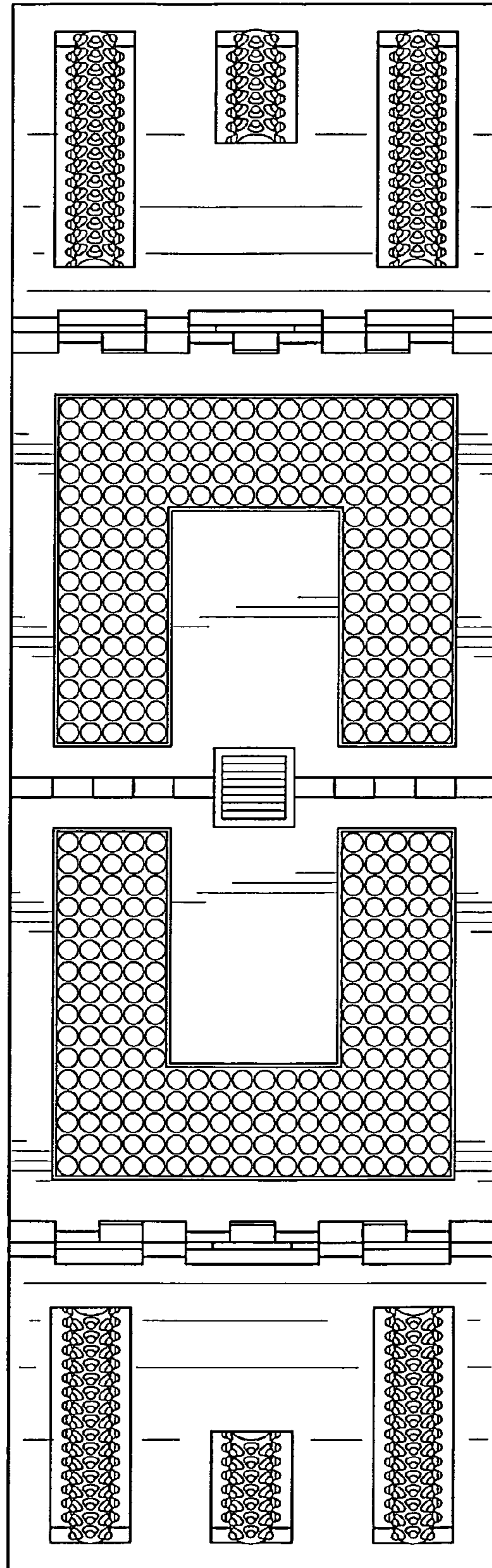

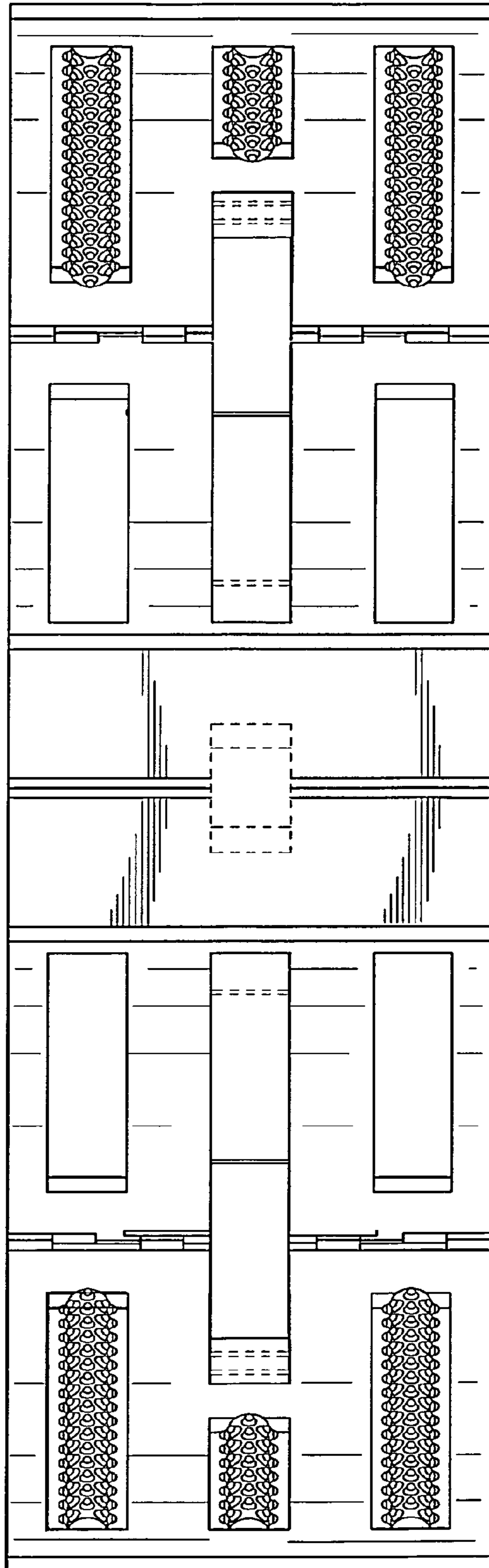

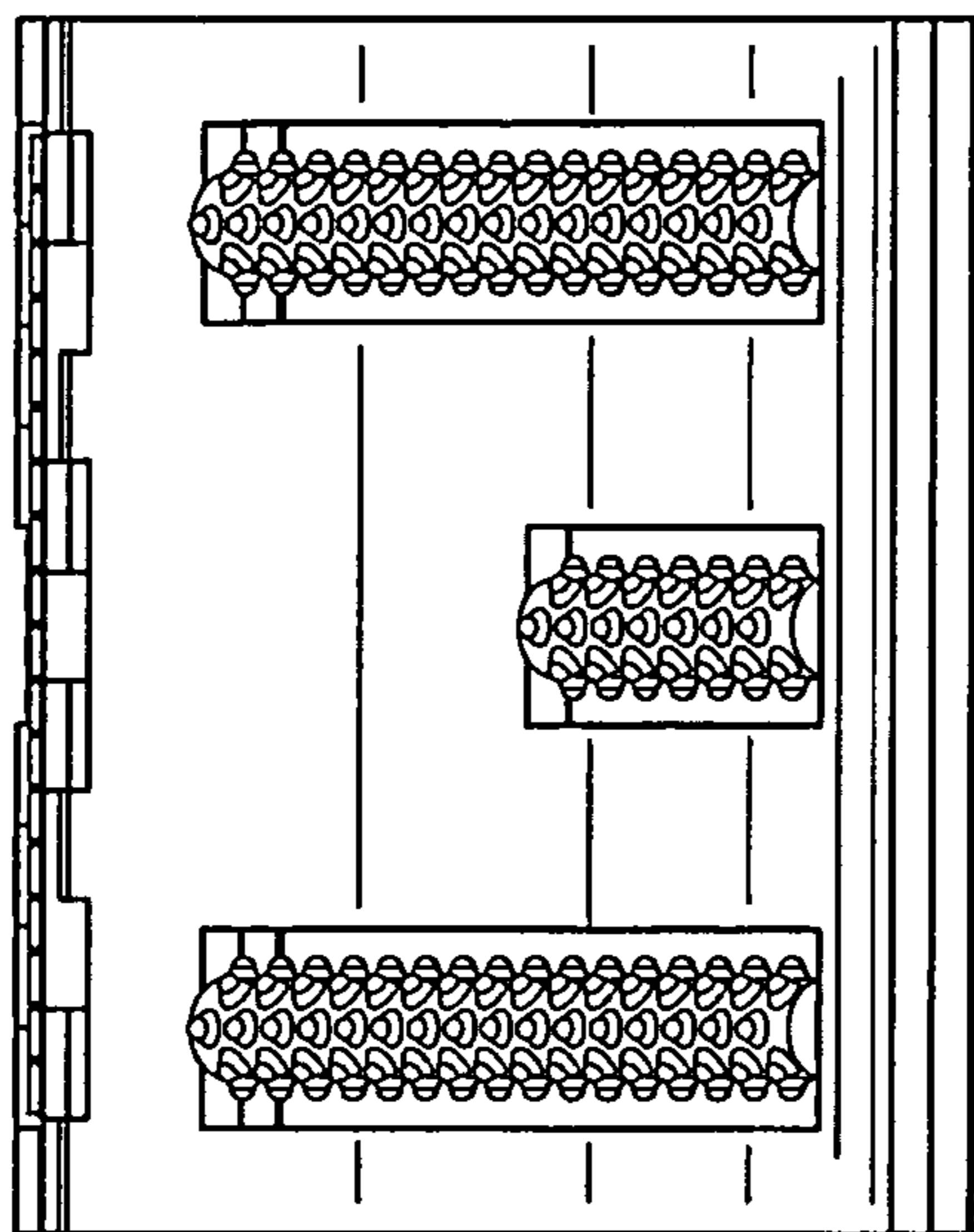

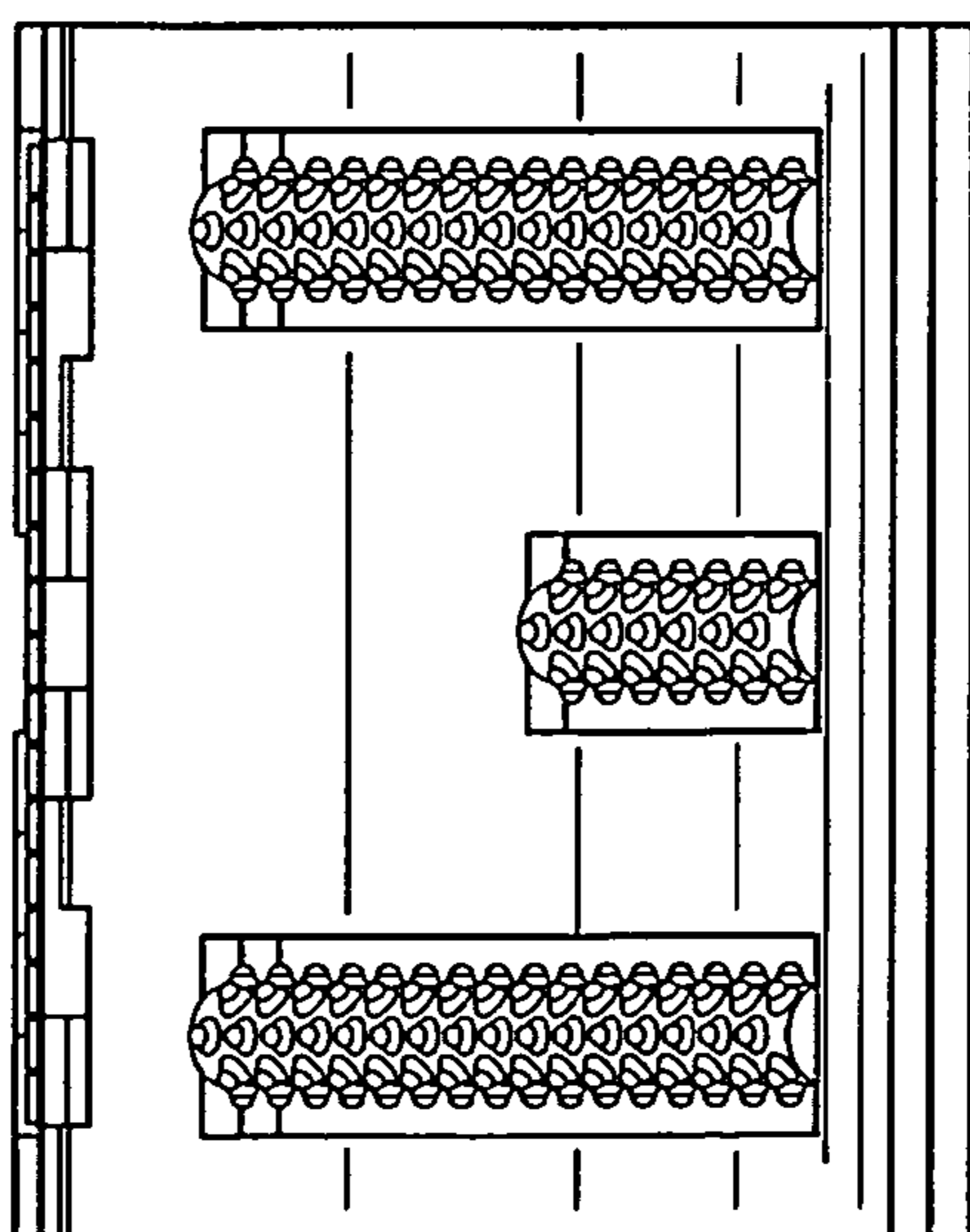
