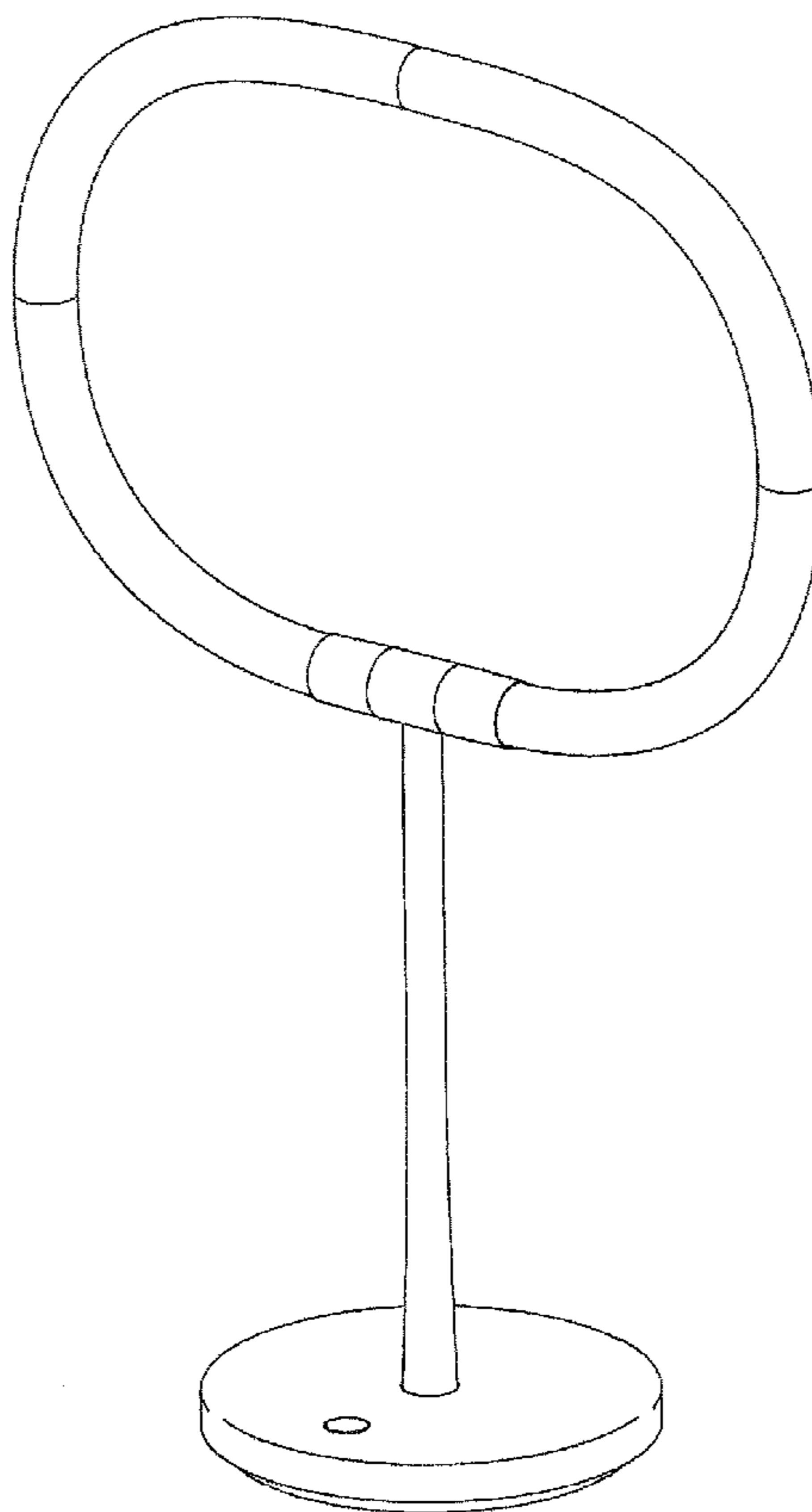
(57) **CLAIM**

I claim the ornamental design for a lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a table lamp, according to the invention;  
FIG. 2 is a front view of a table lamp, according to FIG. 1;  
FIG. 3 is a rear view of a table lamp, according to FIG. 2;  
FIG. 4 is a left side view of a table lamp, according to FIG. 2;

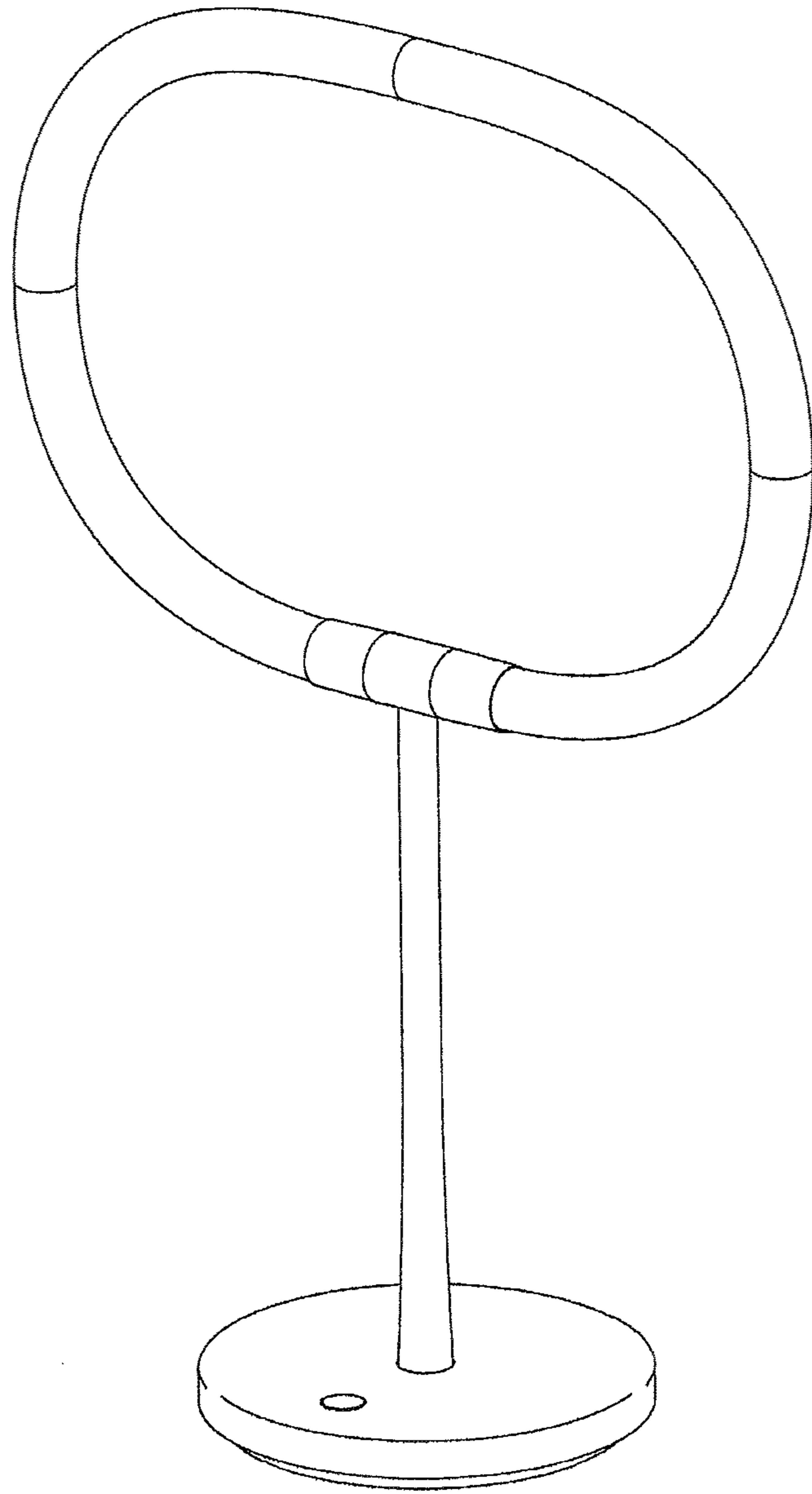
