**DESCRIPTION**

FIG. 11 is a rear view with the top closed.

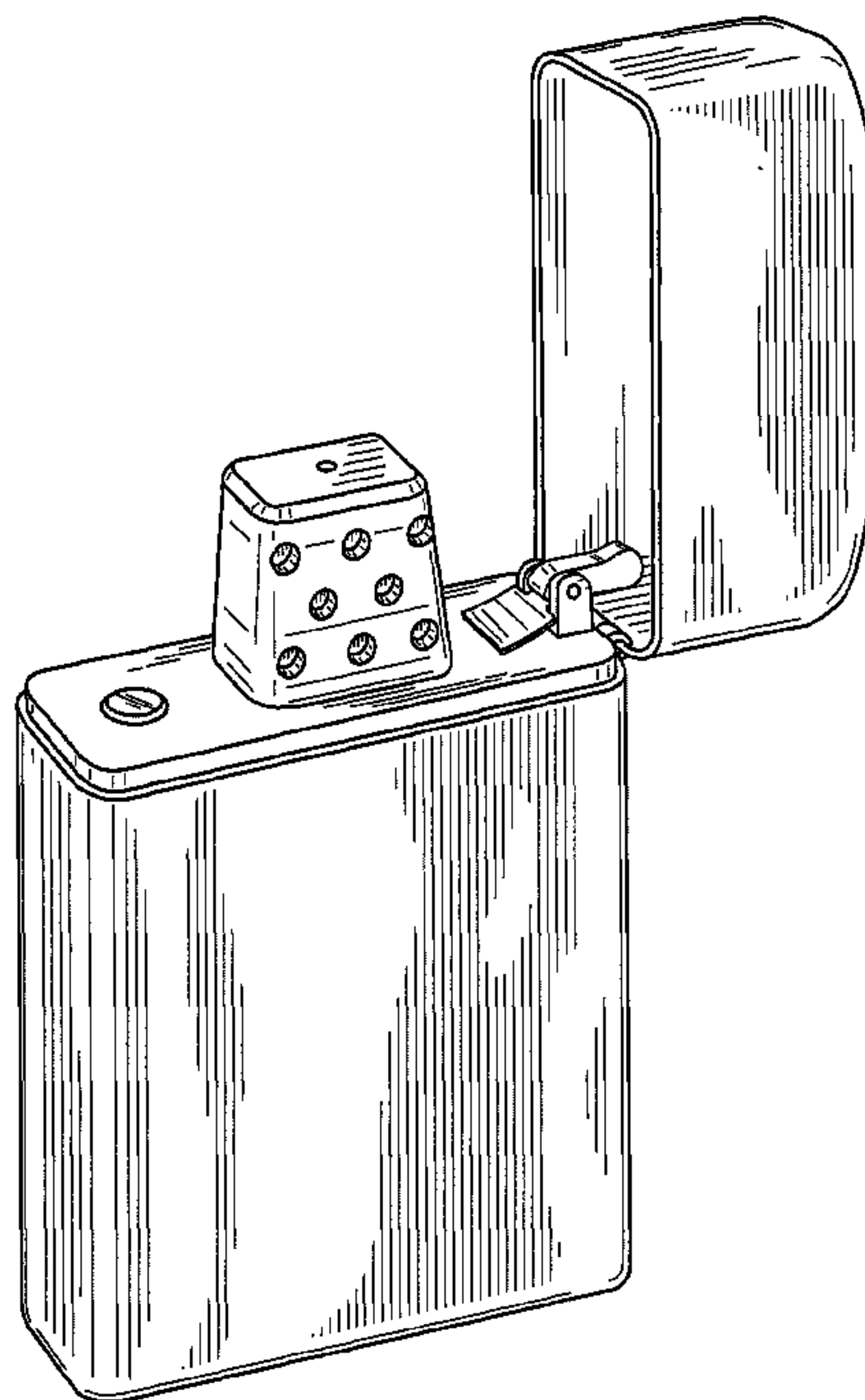
FIG. 12 is a top view with the top closed.

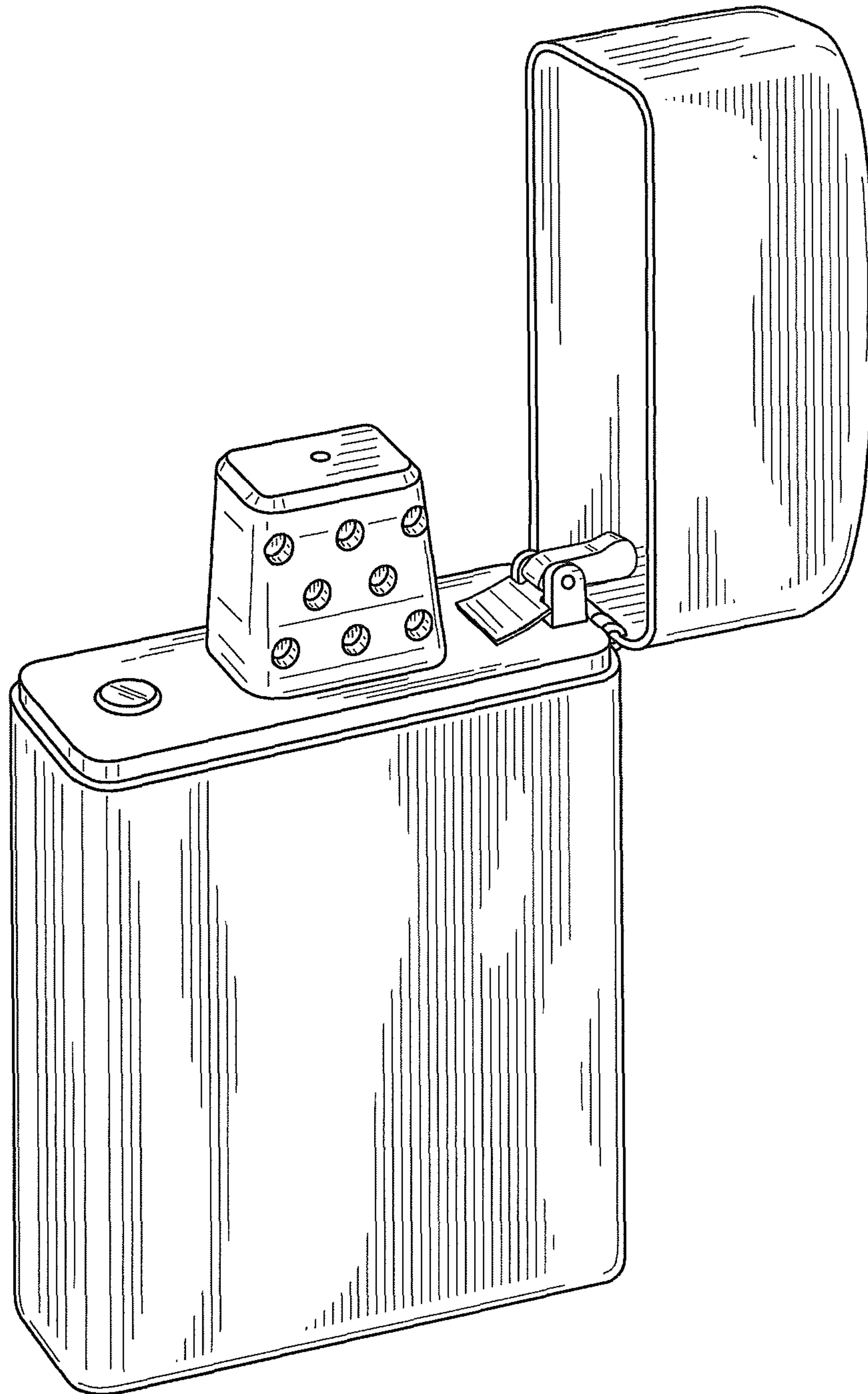

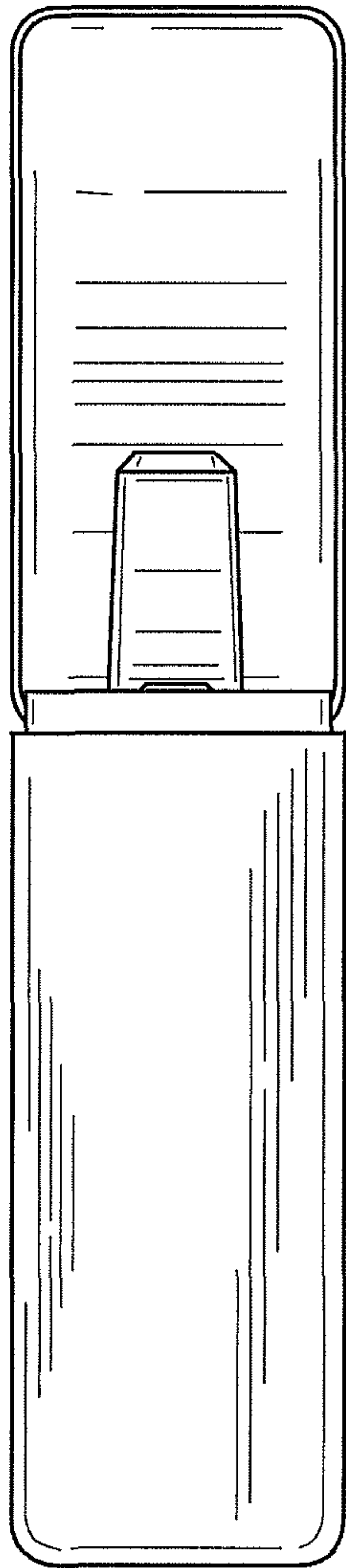

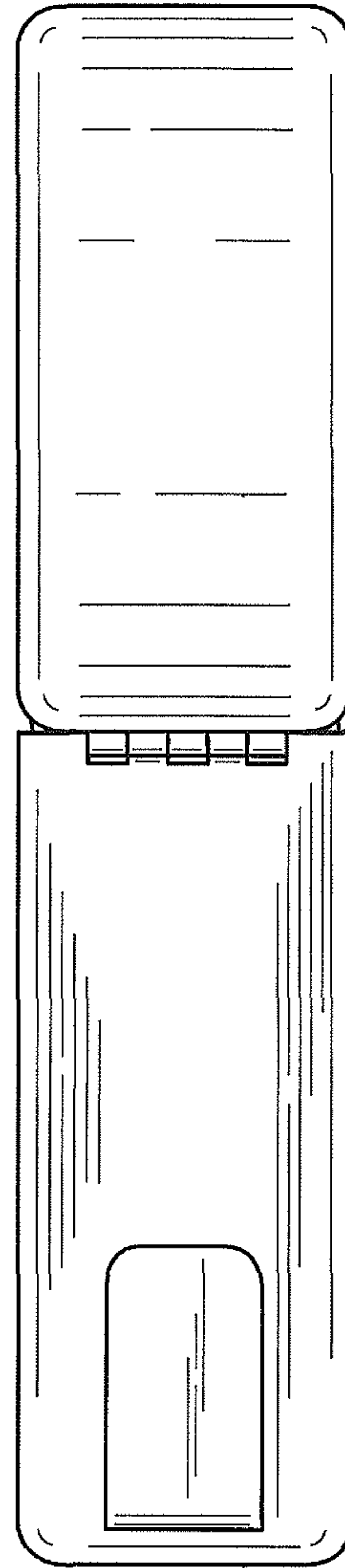

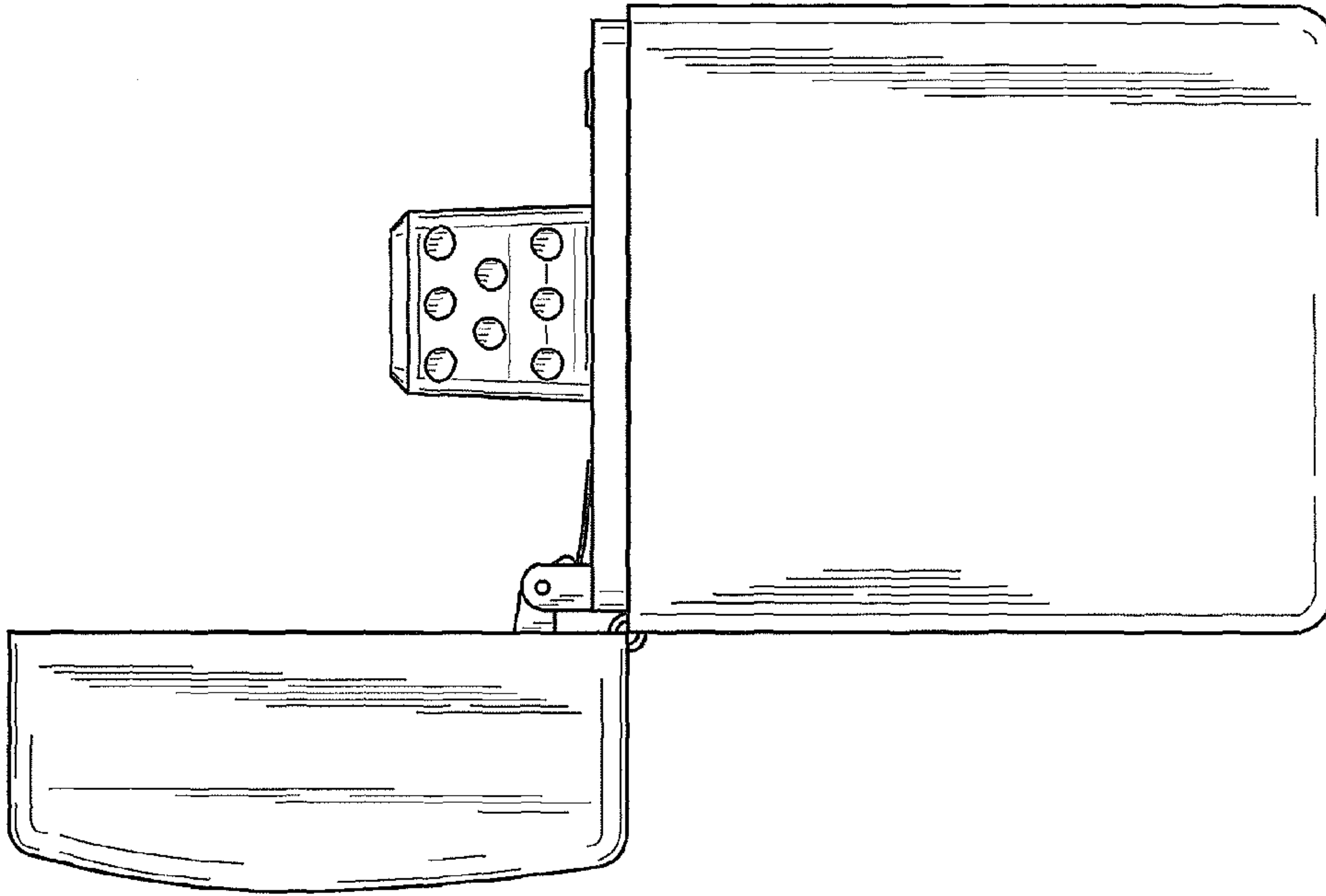

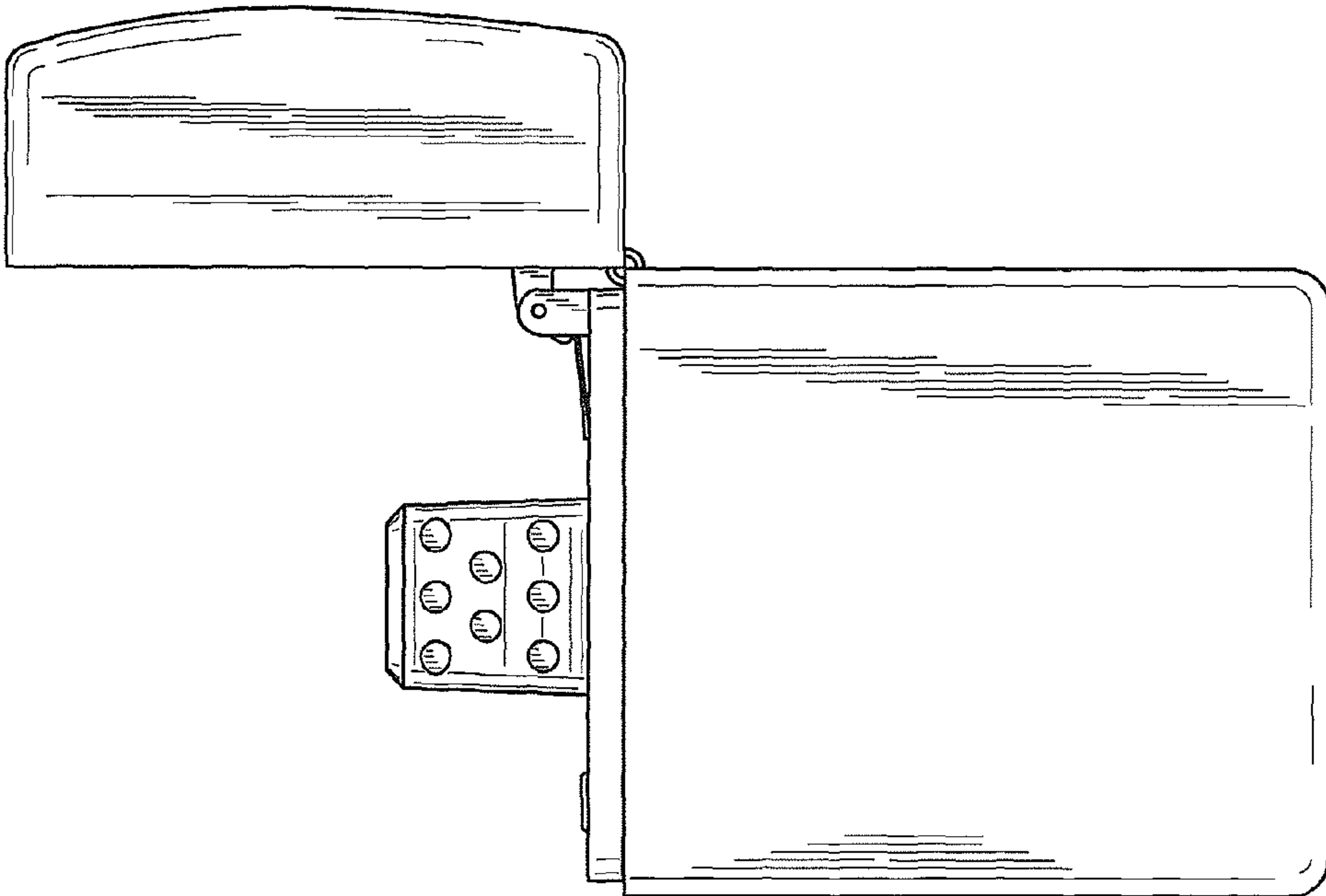

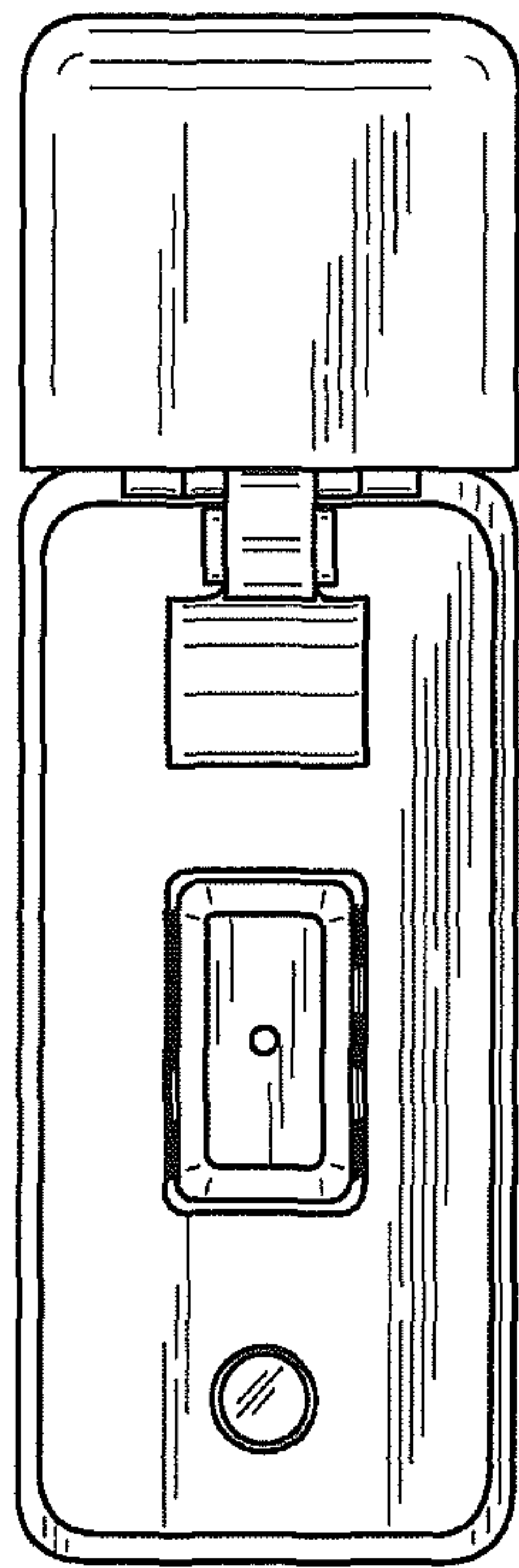

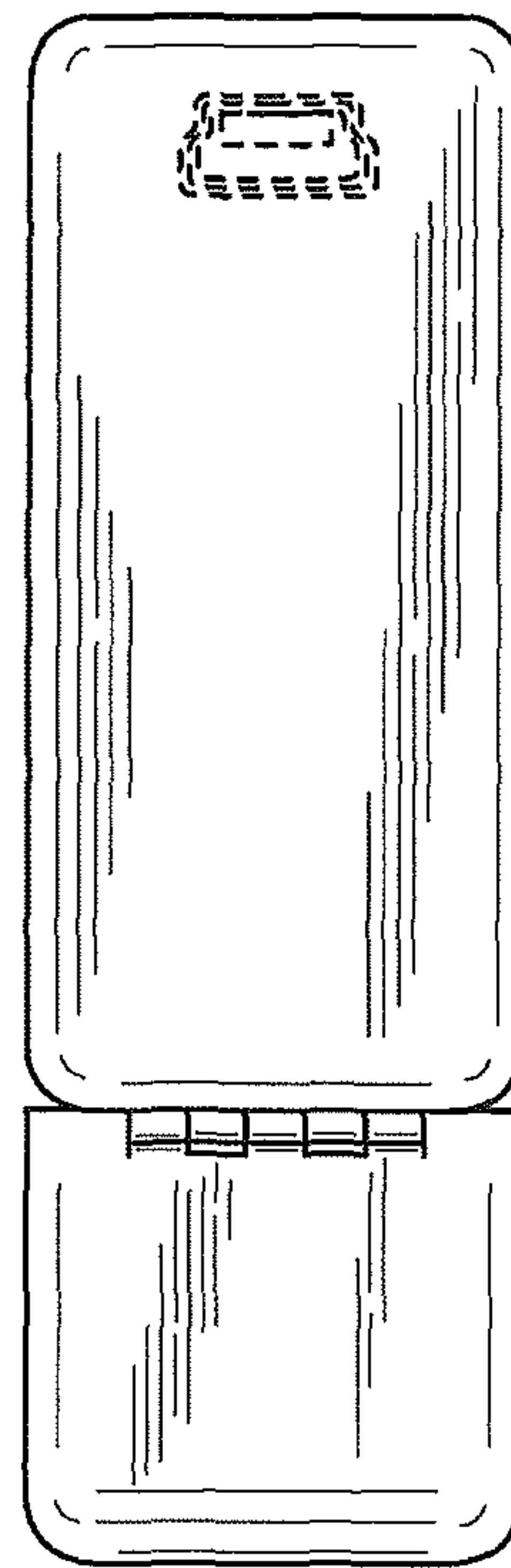

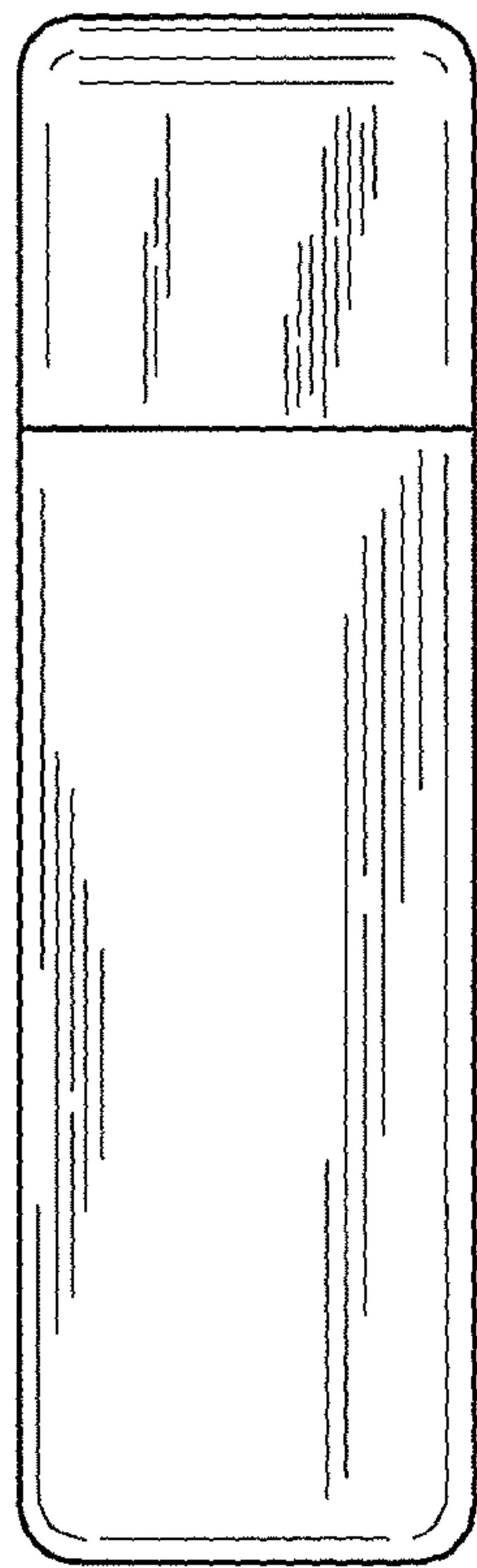

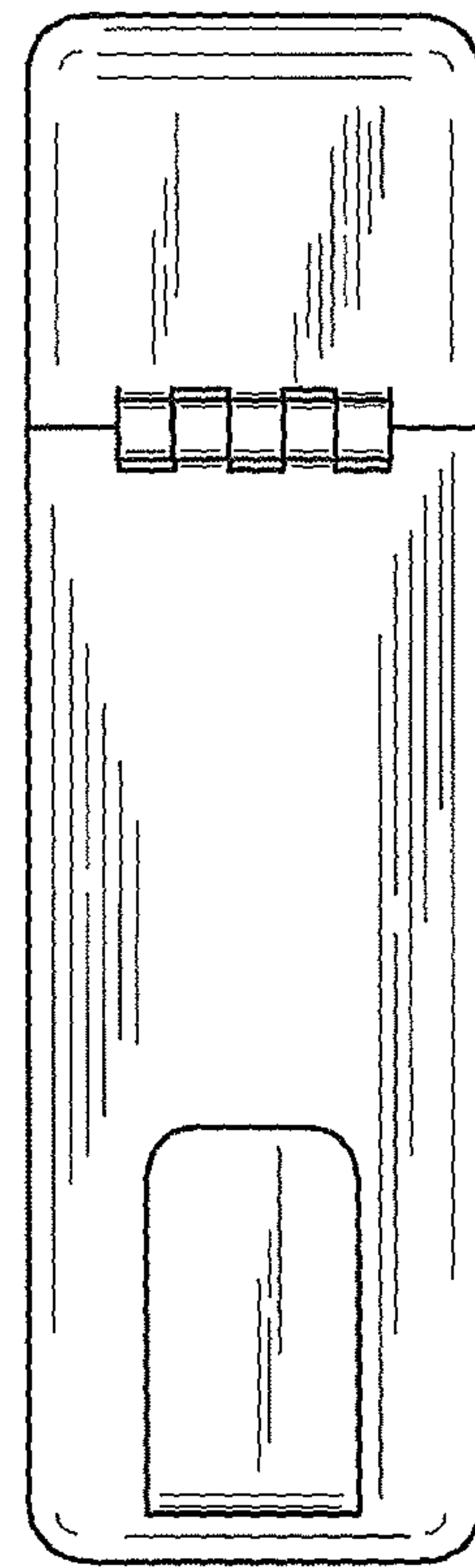

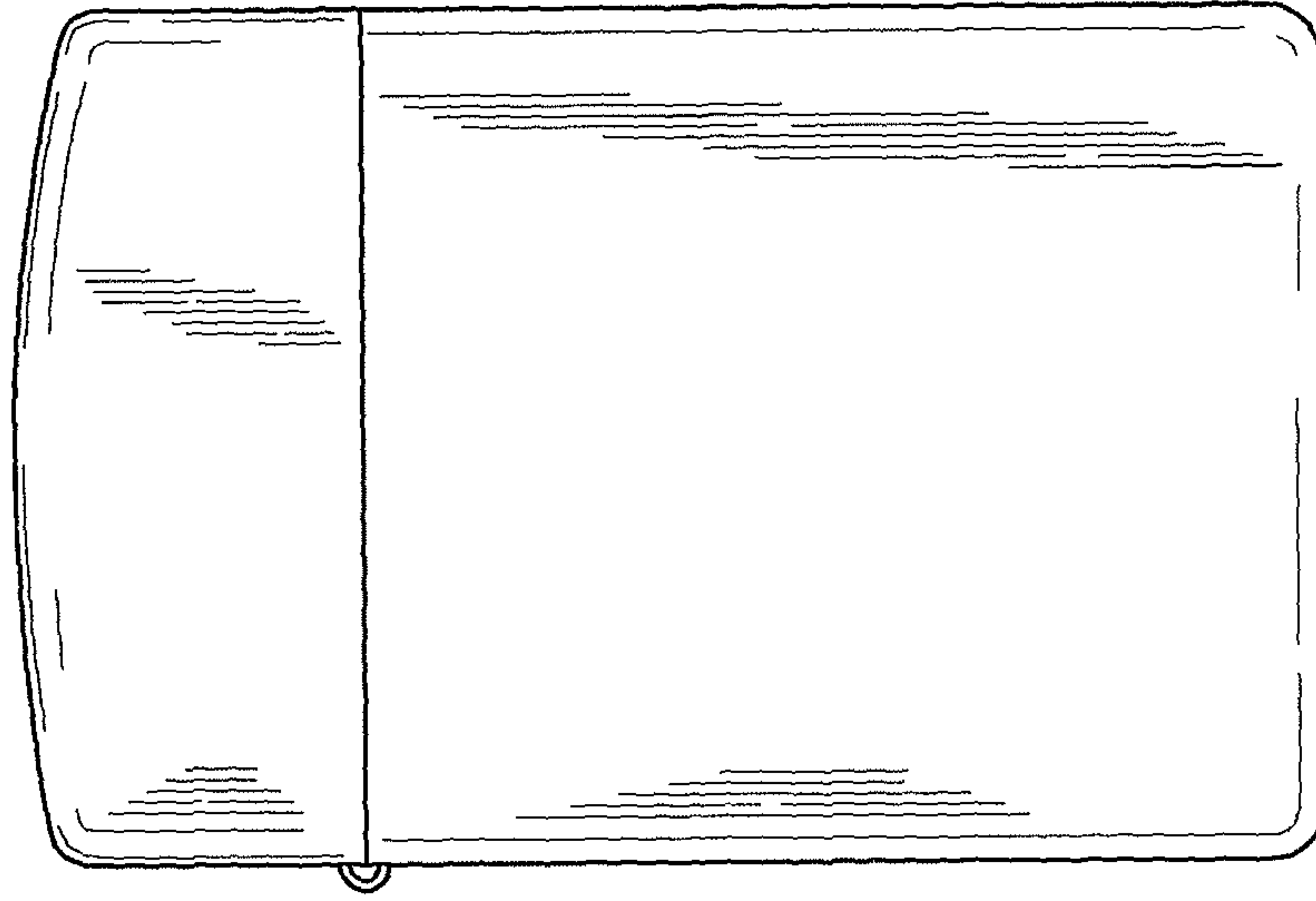

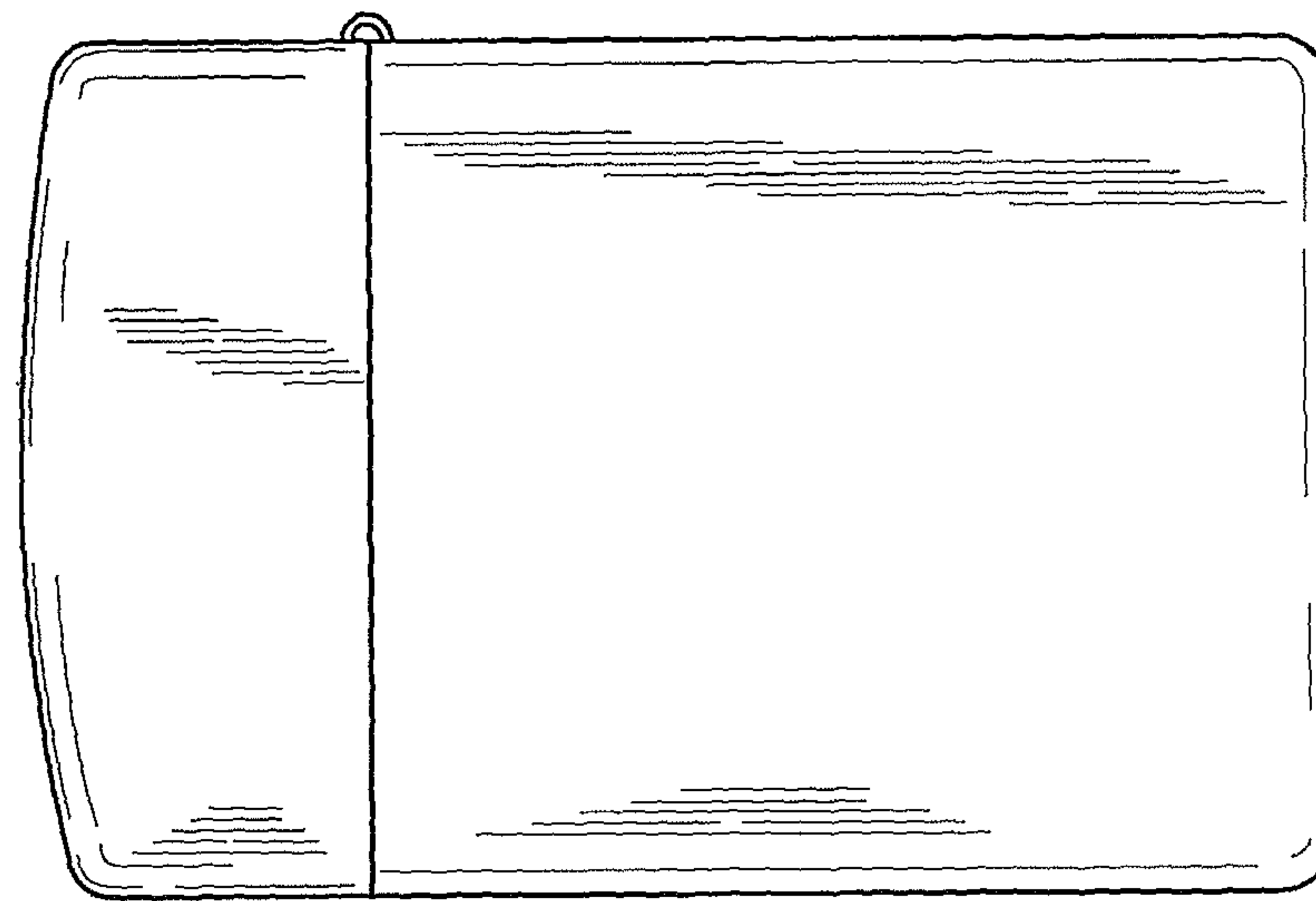

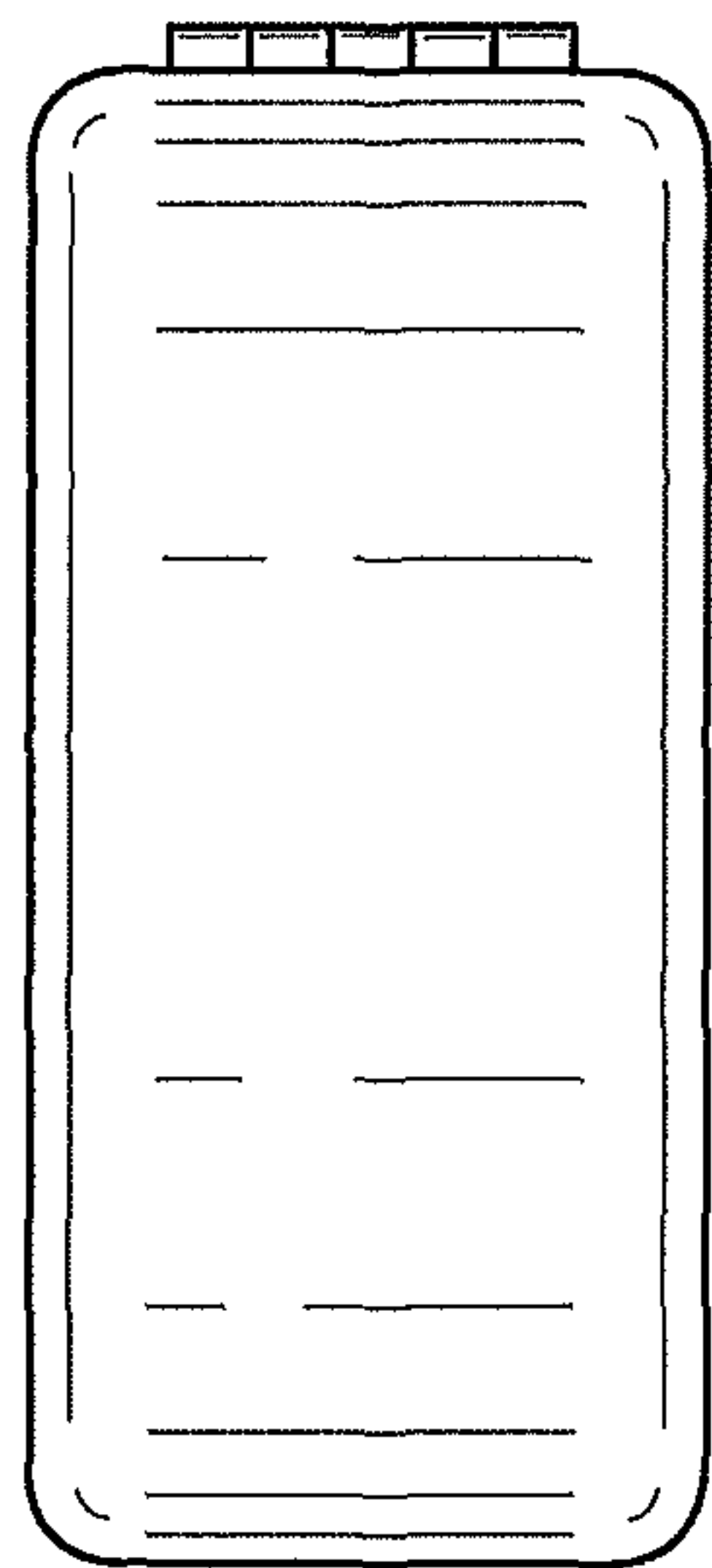

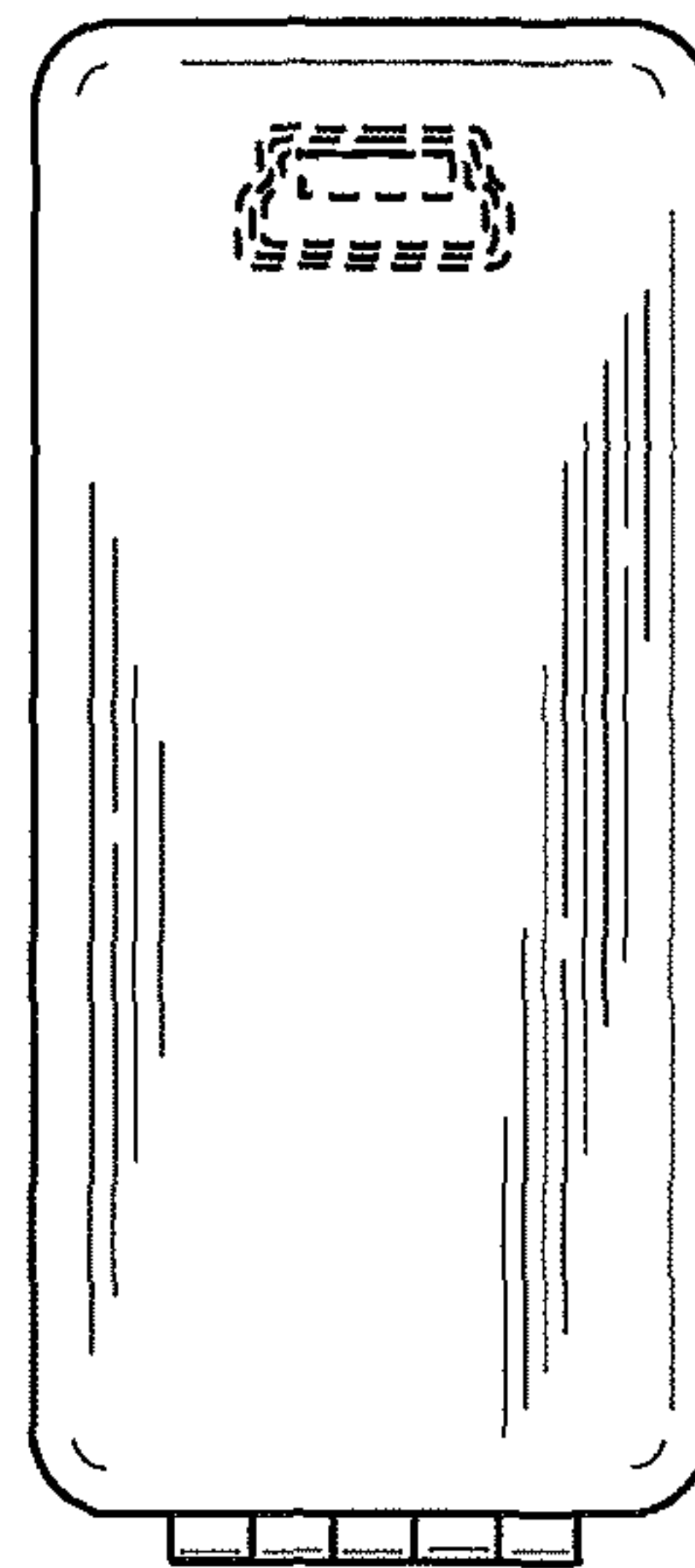

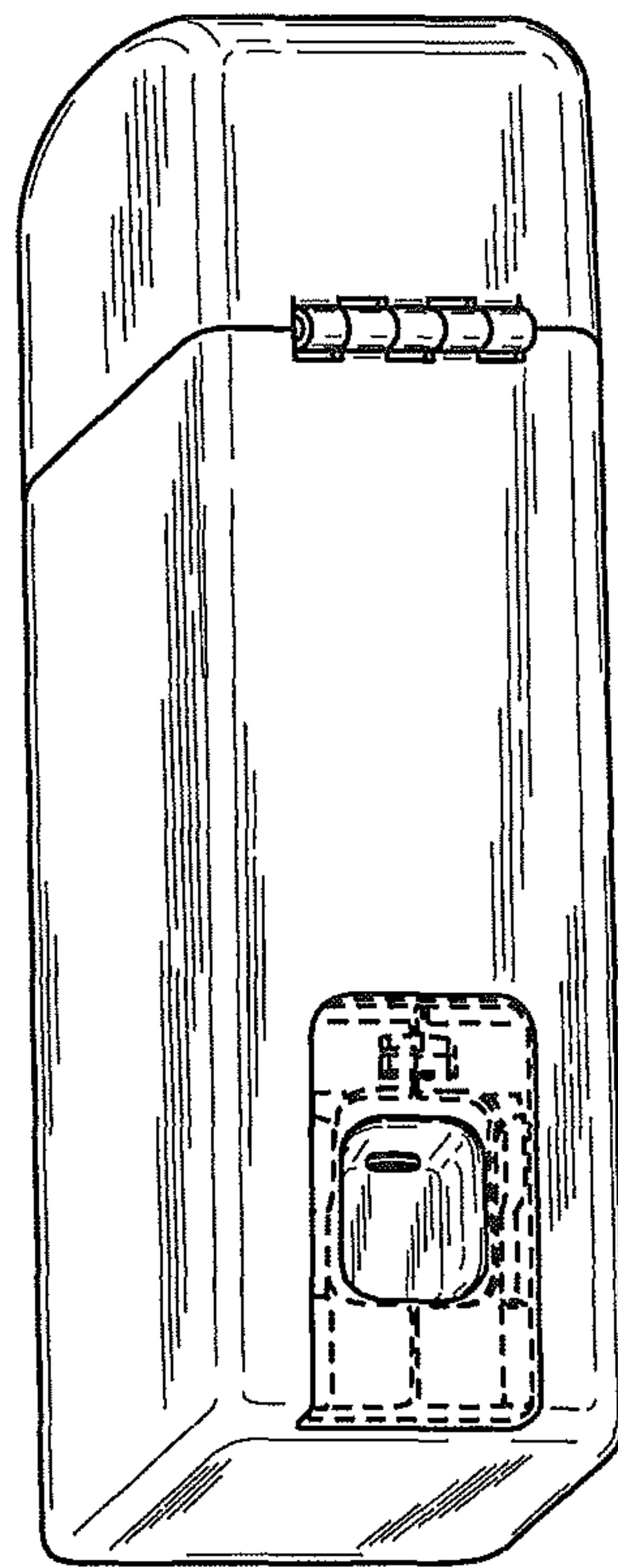
