(57) **CLAIM**

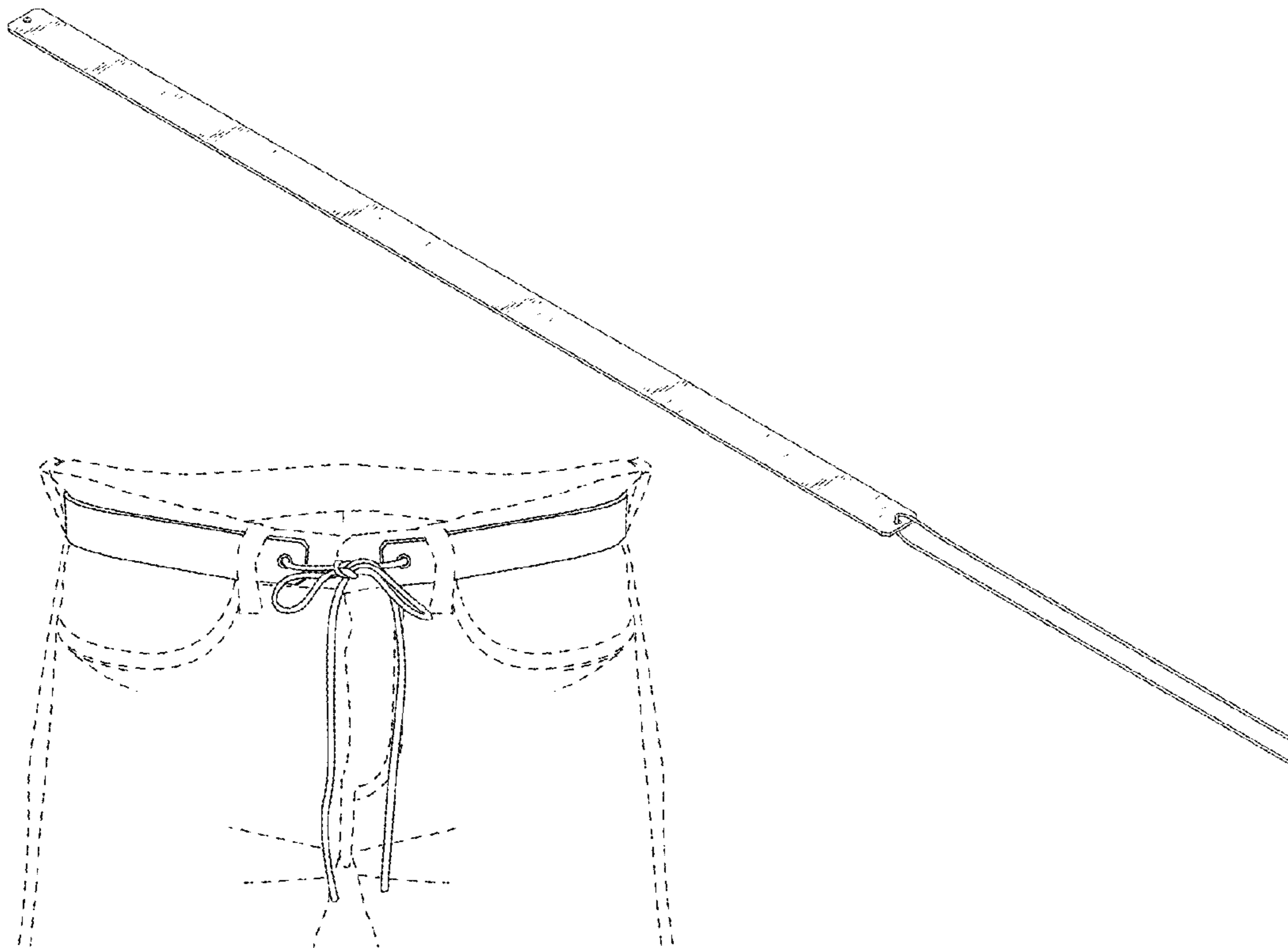
The ornamental design for a shoelace belt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoelace belt;
 FIG. 2 is a front view thereof, the back side being a mirror image thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a top view thereof, the bottom side being a mirror image thereof;
 FIG. 6 is a right side view thereof, enlarged for ease of disclosure;
 FIG. 7 is a left side view thereof, enlarged for ease of disclosure;
 FIG. 8 is a perspective view thereof shown in an untied state and in use; and,
 FIG. 9 is a perspective view thereof shown in a tied state and in use.

The broken line showing of pants in FIGS. 8 and 9 is included for the purpose of illustrating environmental matter and forms no part of the claimed design.

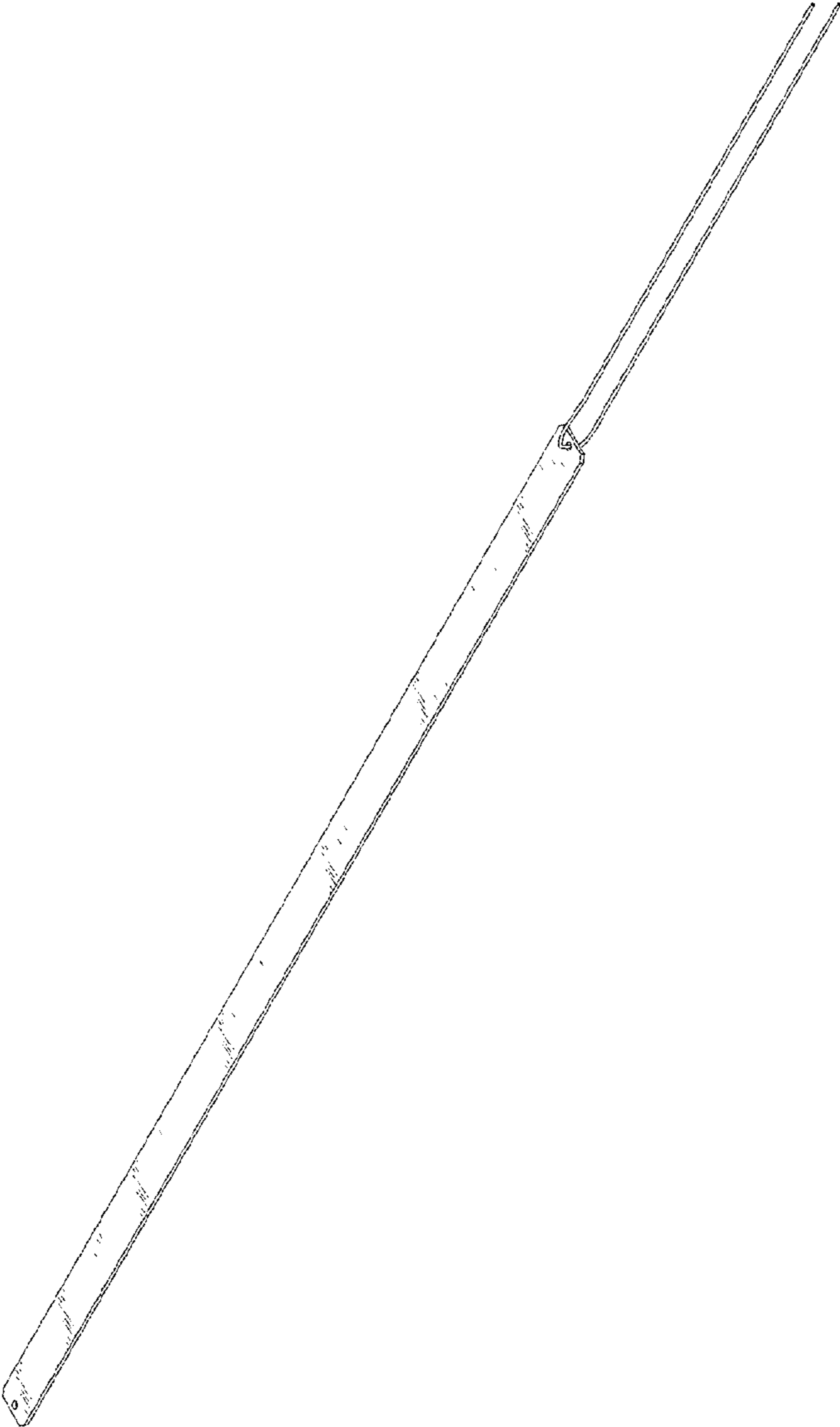

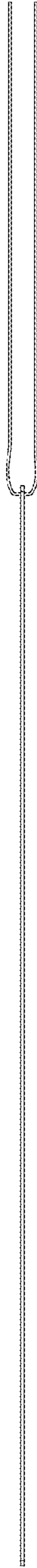

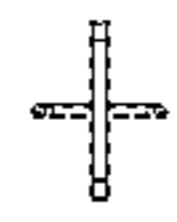

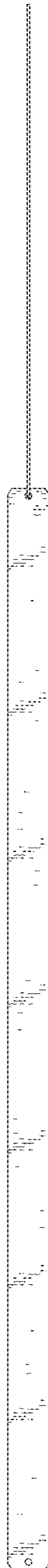

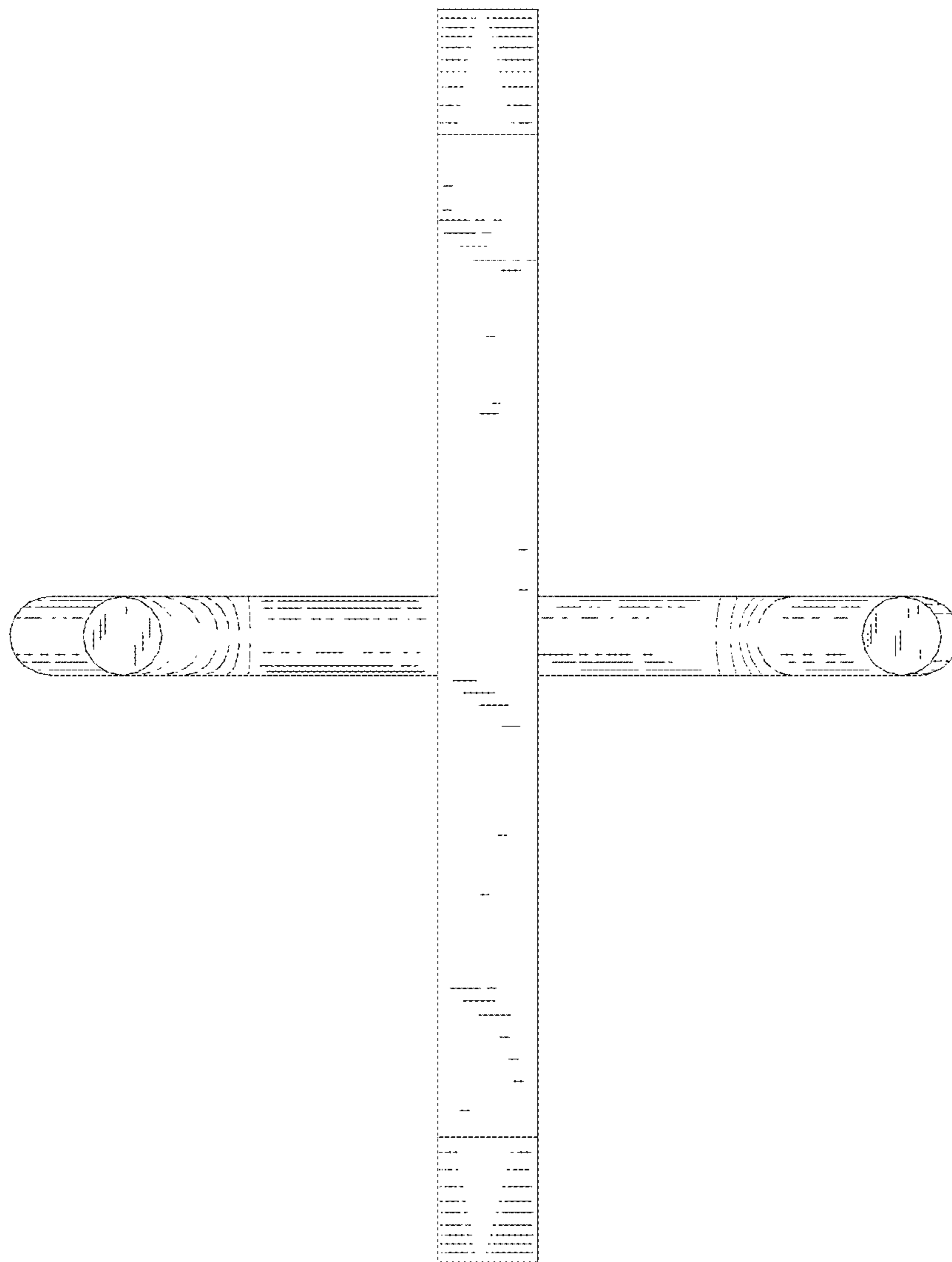

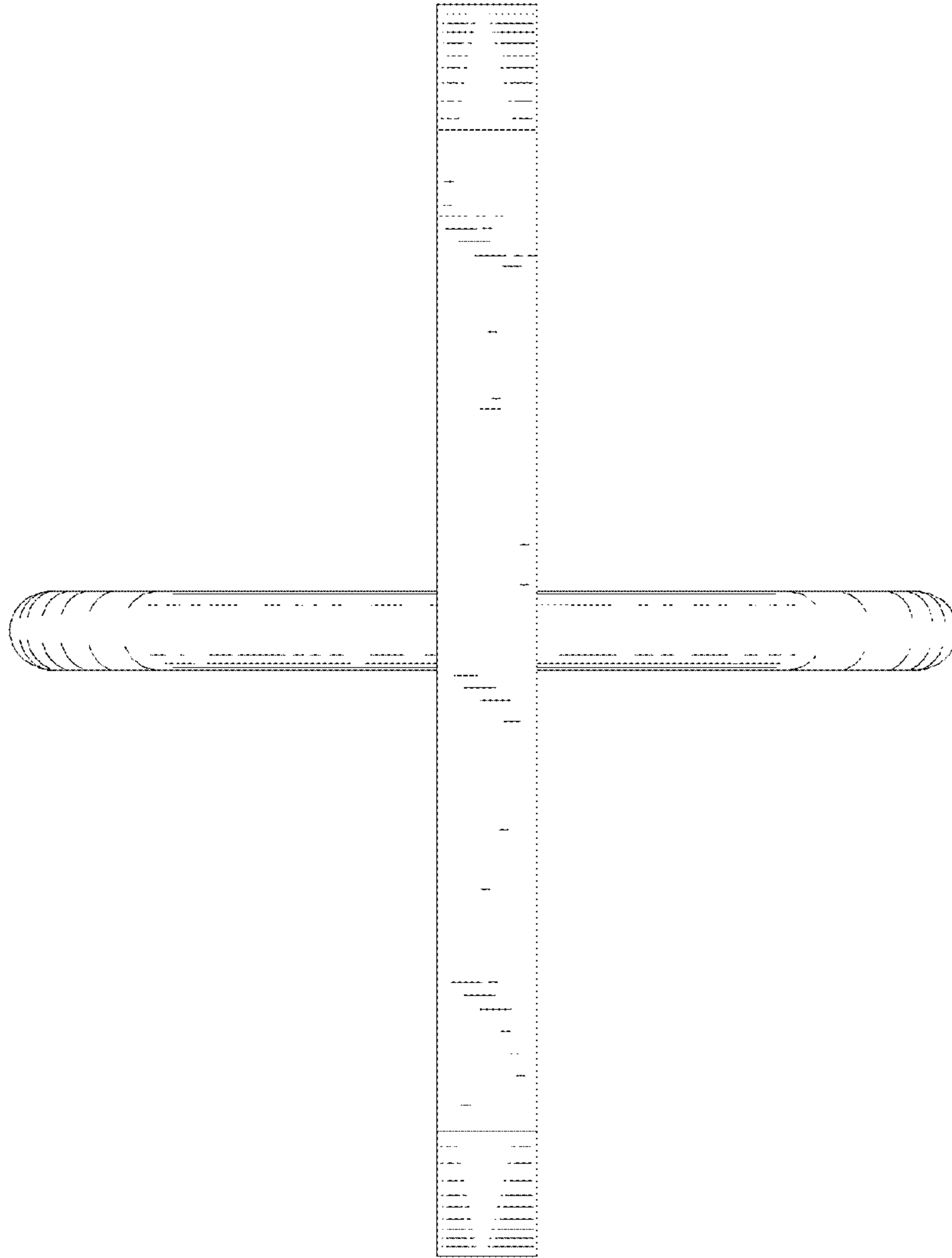

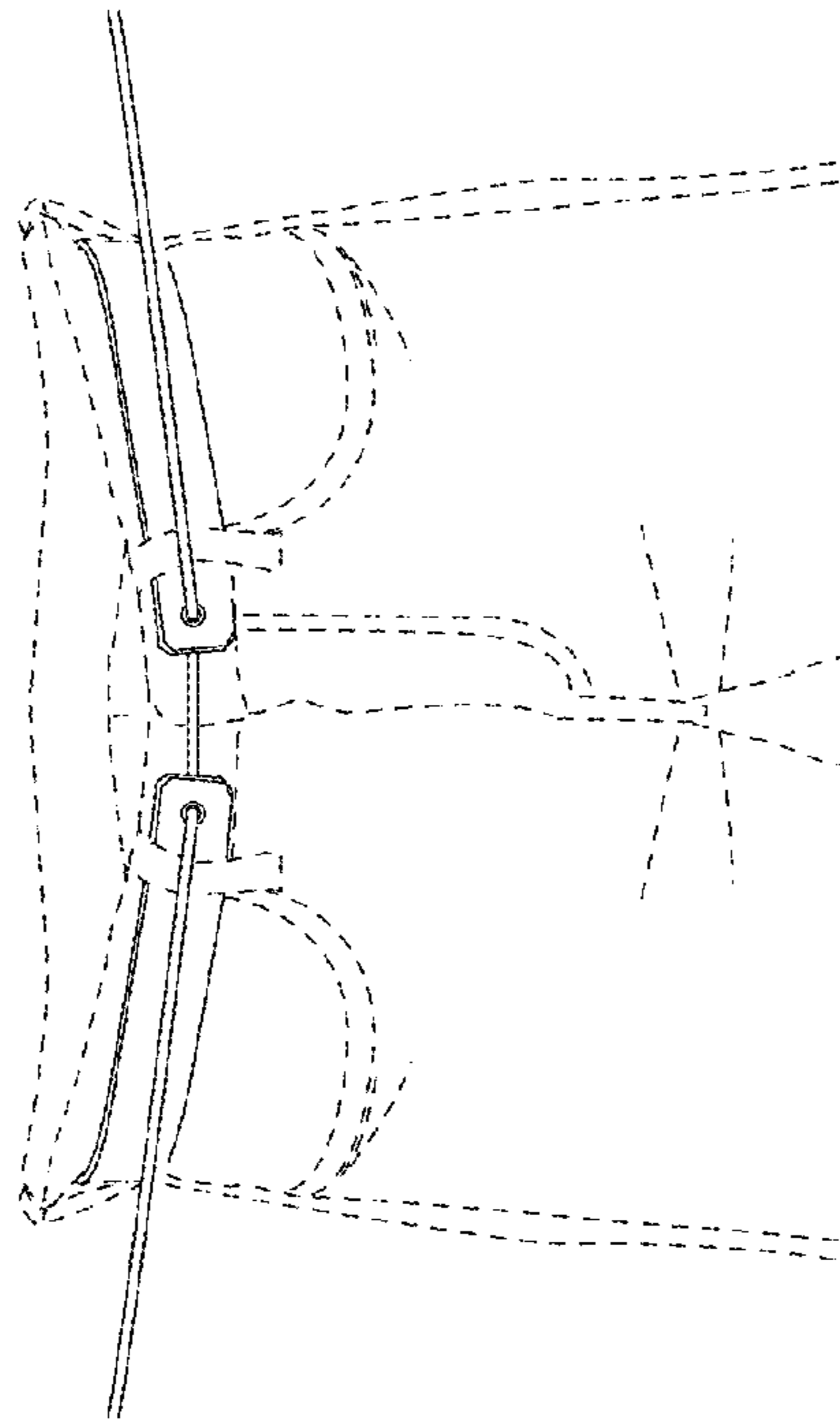

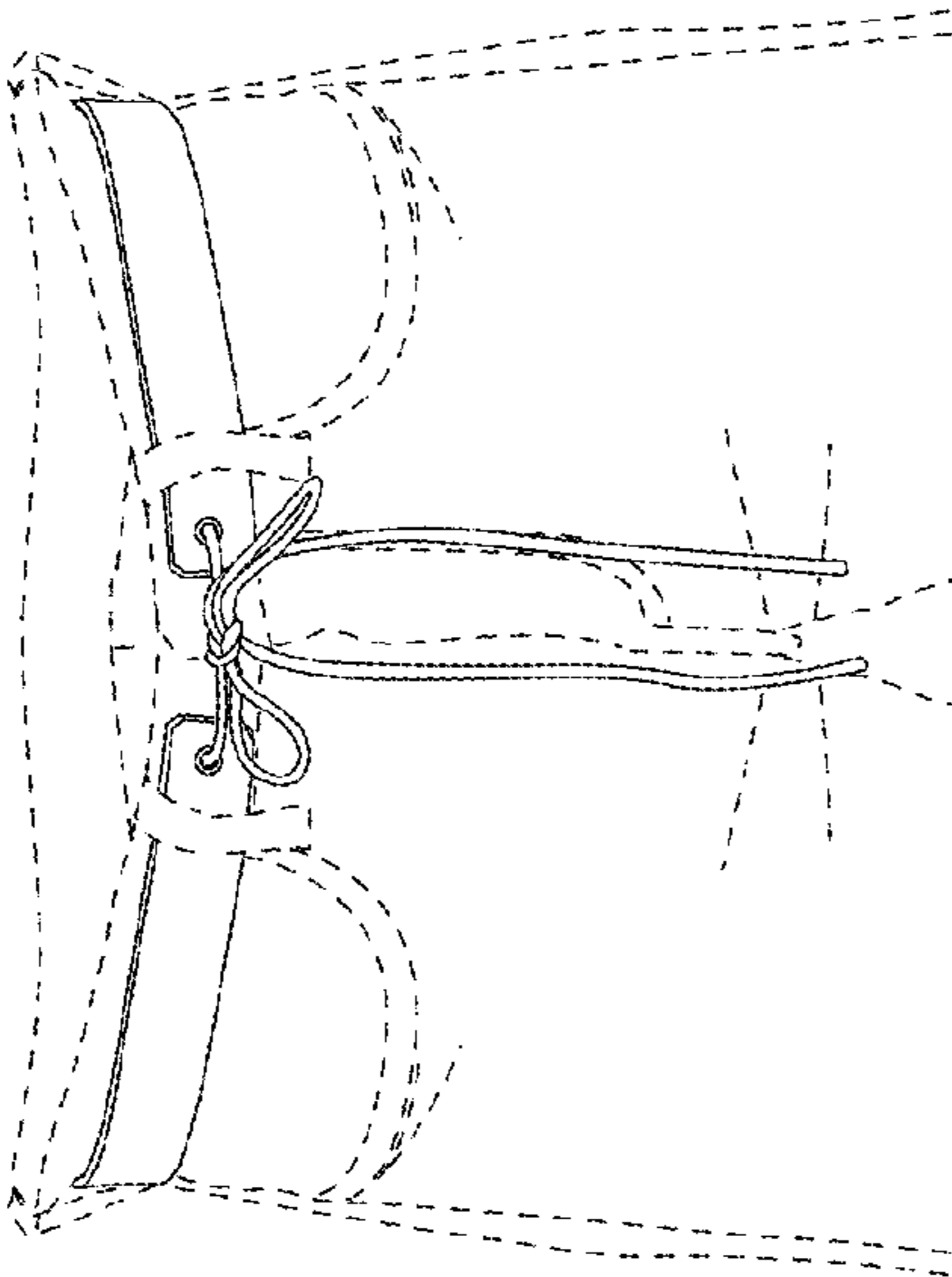
