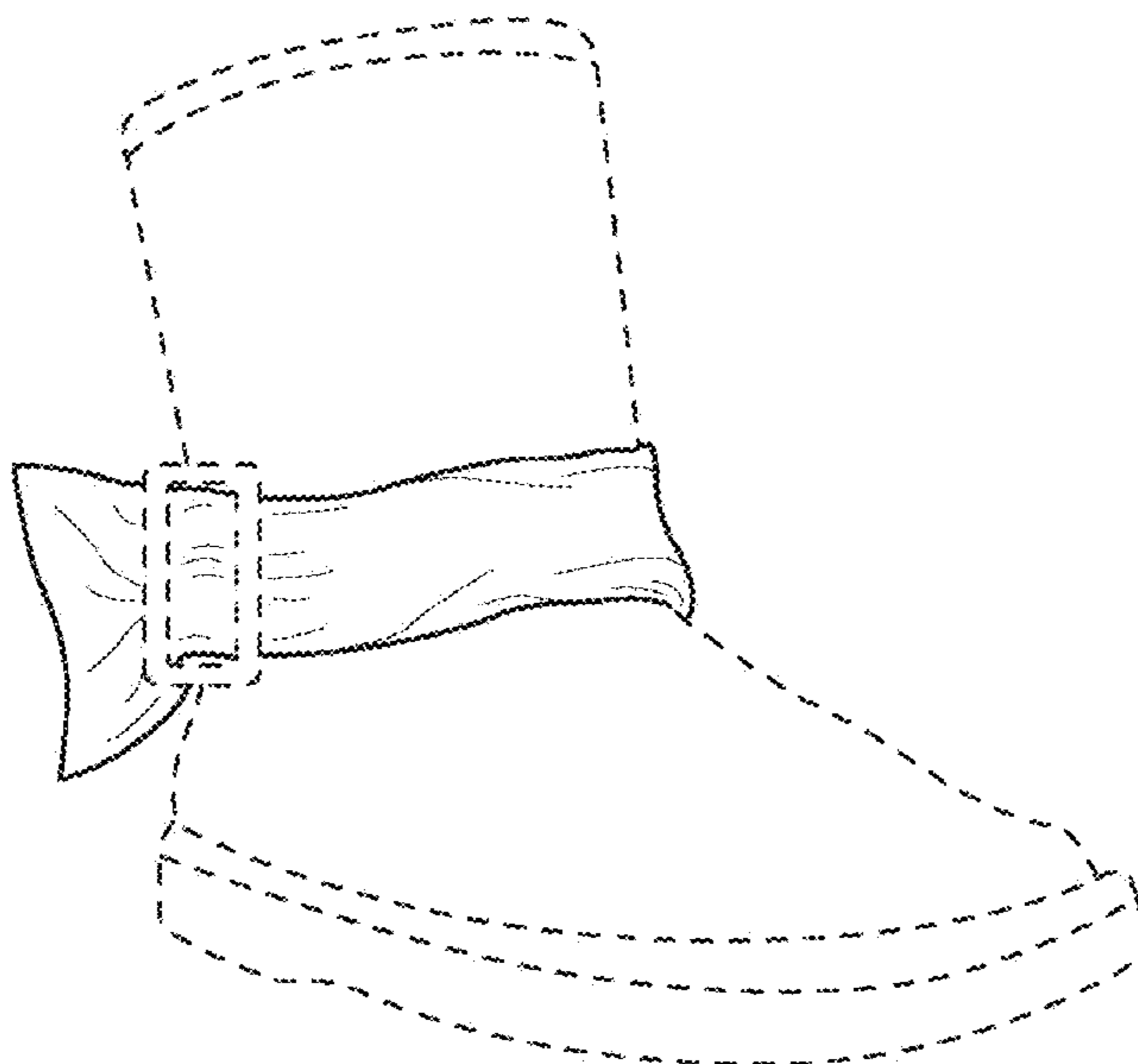
(57) **CLAIM**

The ornamental design for a boot belt, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a boot belt according to the present invention;  
FIG. 2 is a first side view of the boot belt of FIG. 1;  
FIG. 3 is a second side view of the boot belt of FIG. 1;  
FIG. 4 is a front view of the boot belt of FIG. 1;  
FIG. 5 is a back view of the boot belt of FIG. 1; and,  
FIG. 6 is a top view of the boot belt of FIG. 1.  
In FIGS. 1-6, the dashed lines indicate environmental features that form no part of the claimed invention.

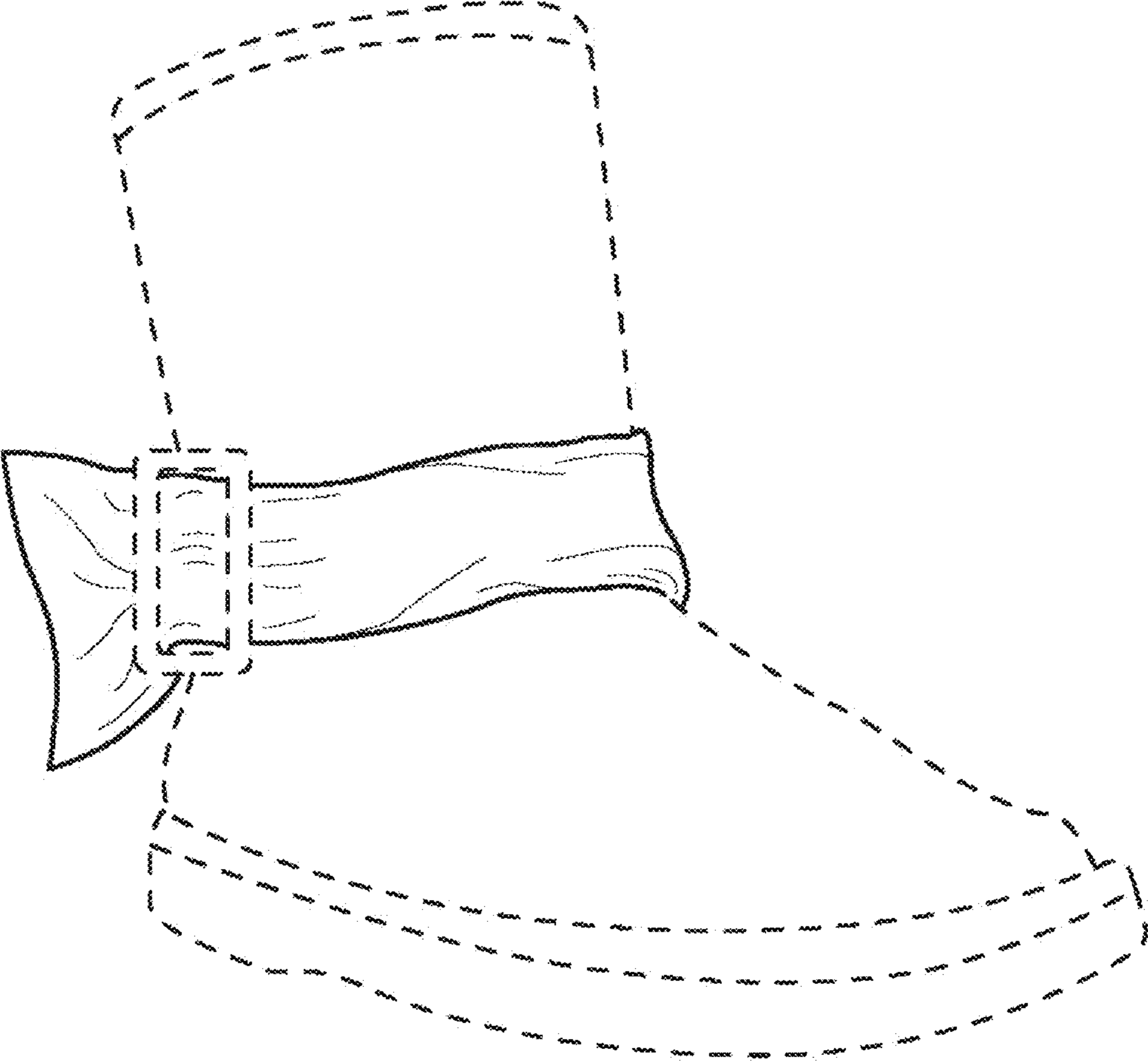

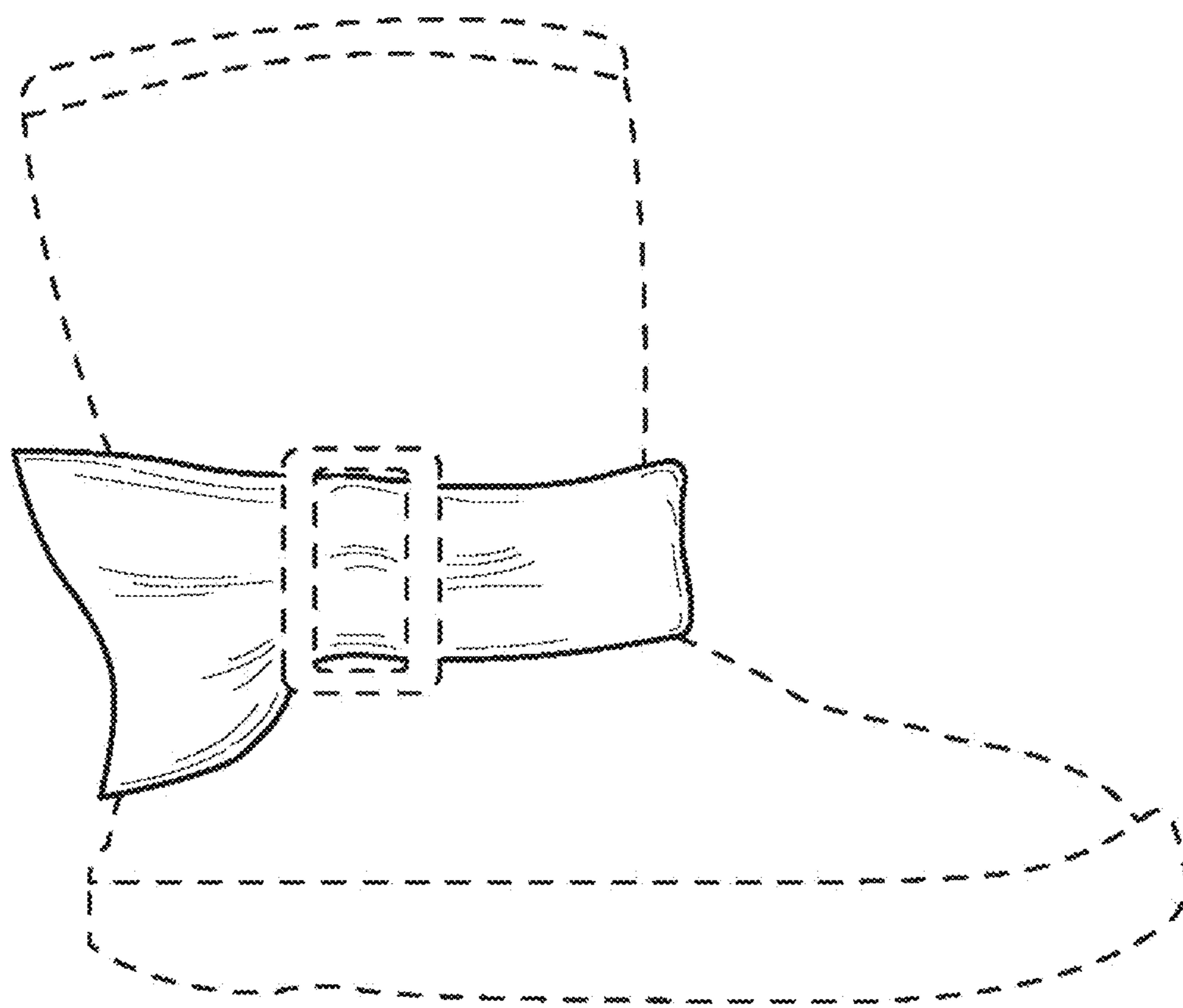

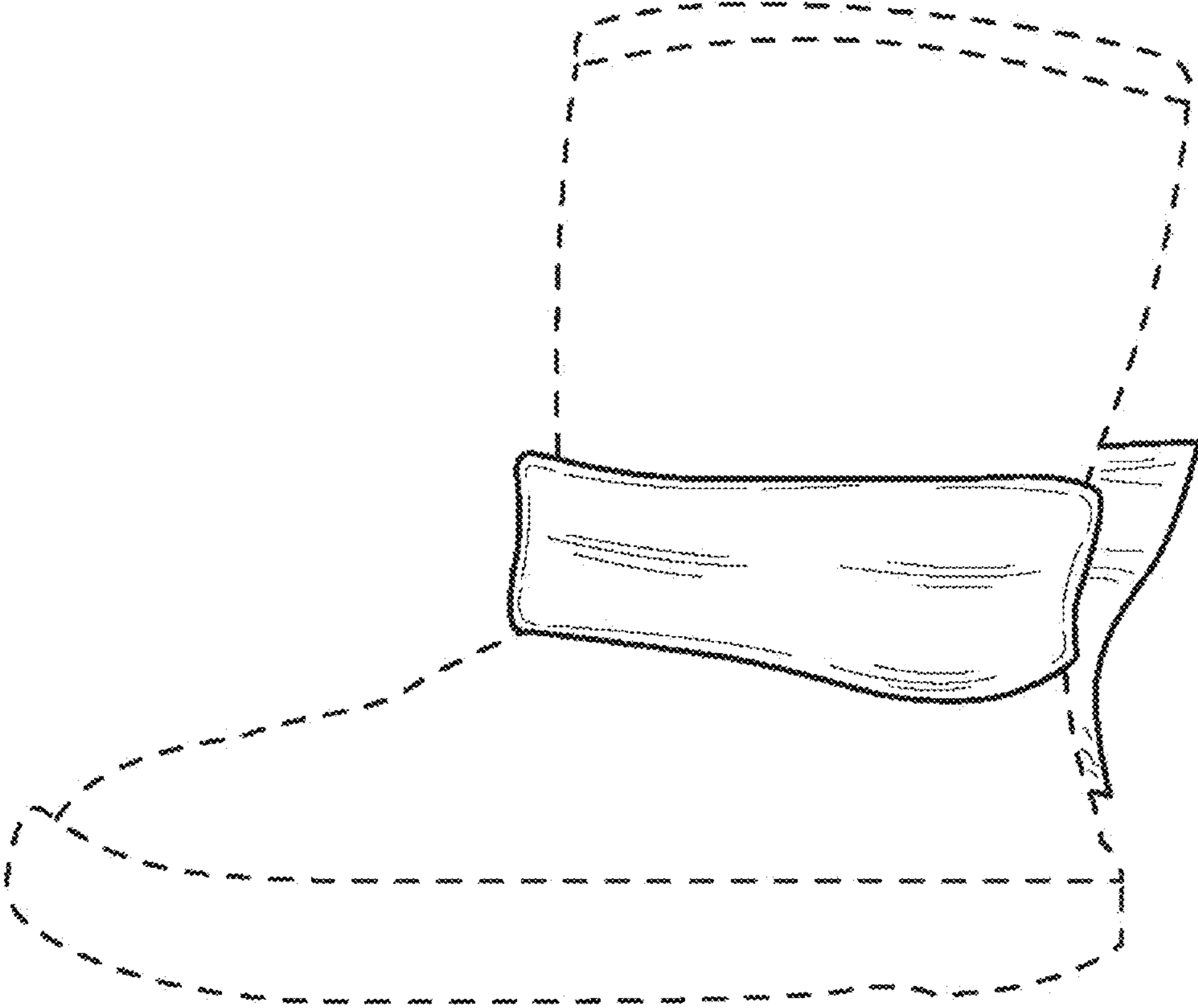

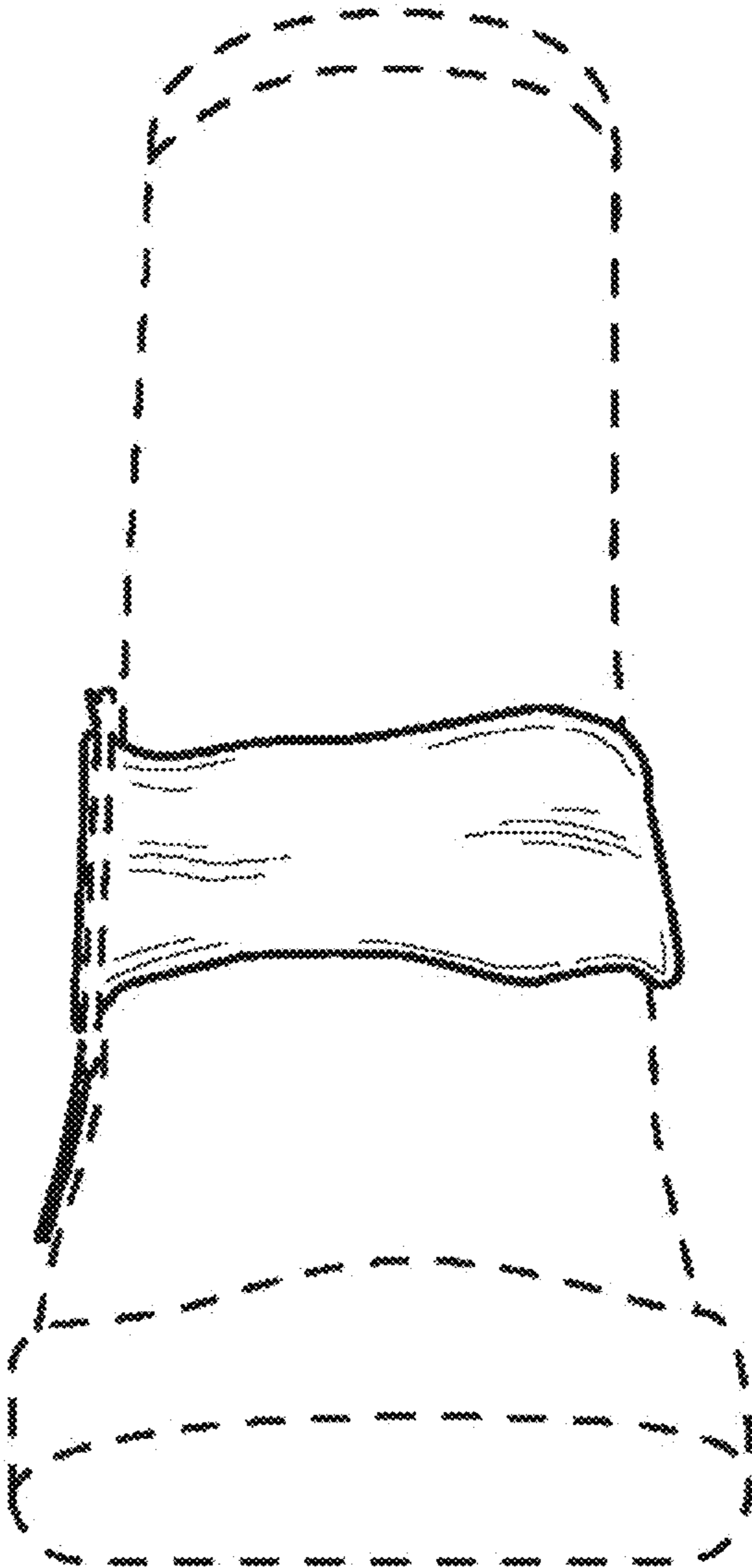

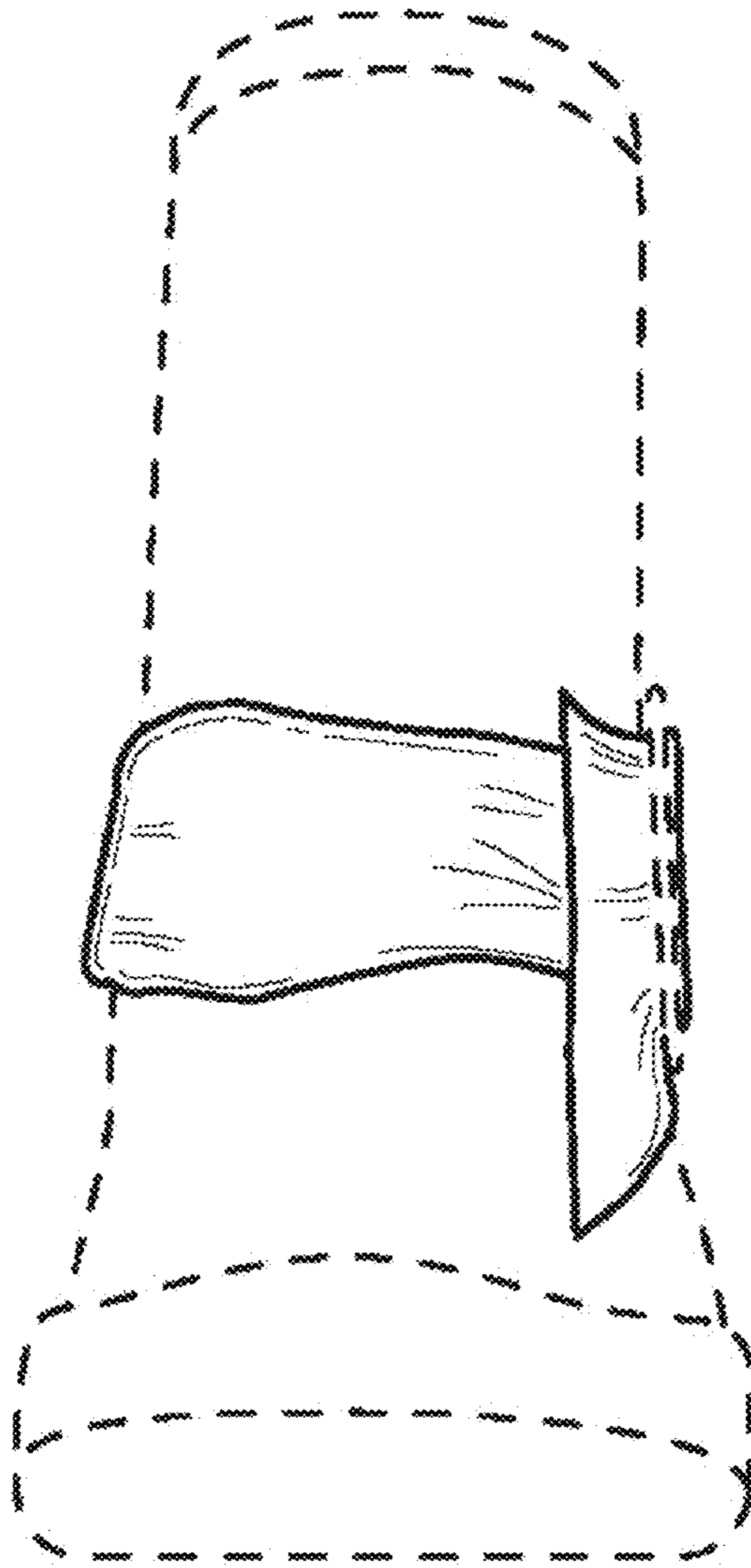

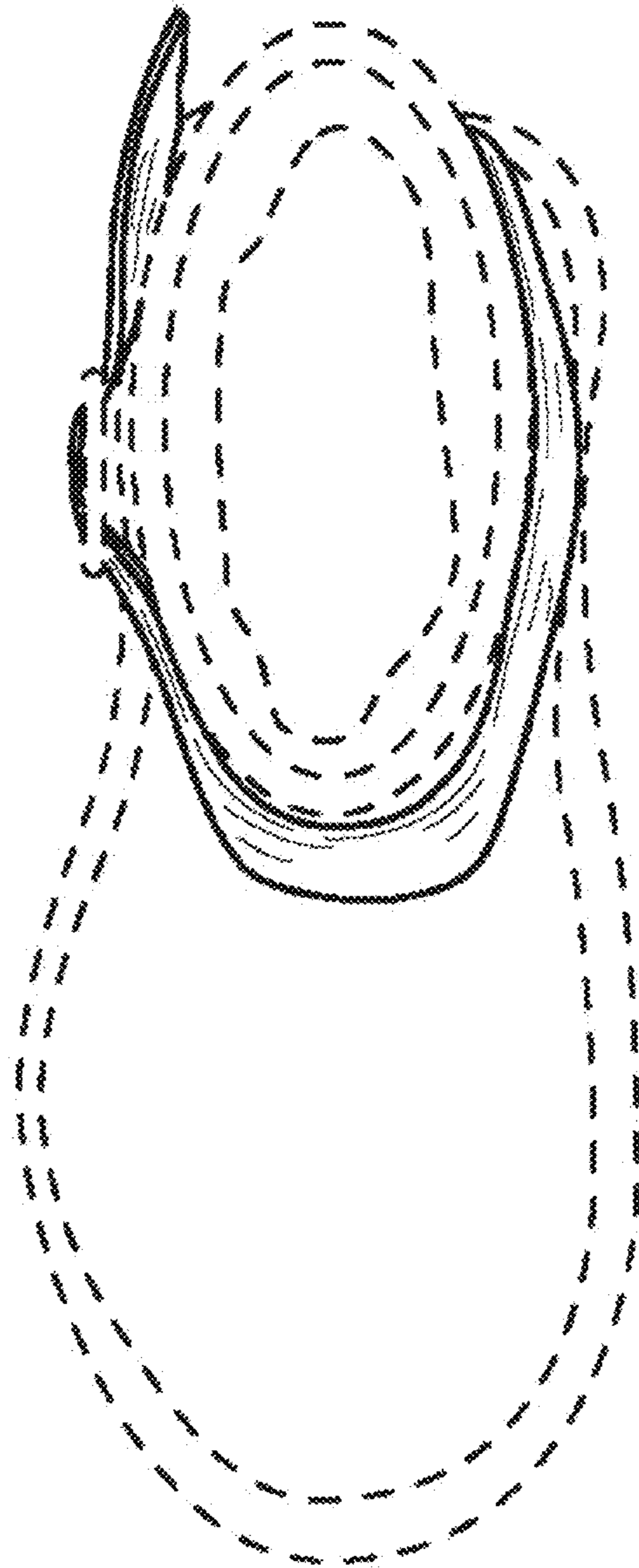
