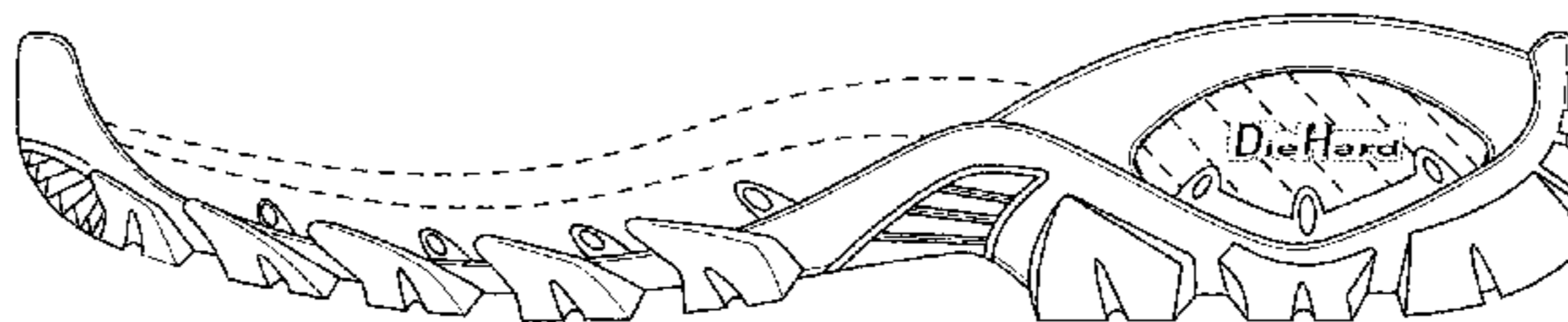
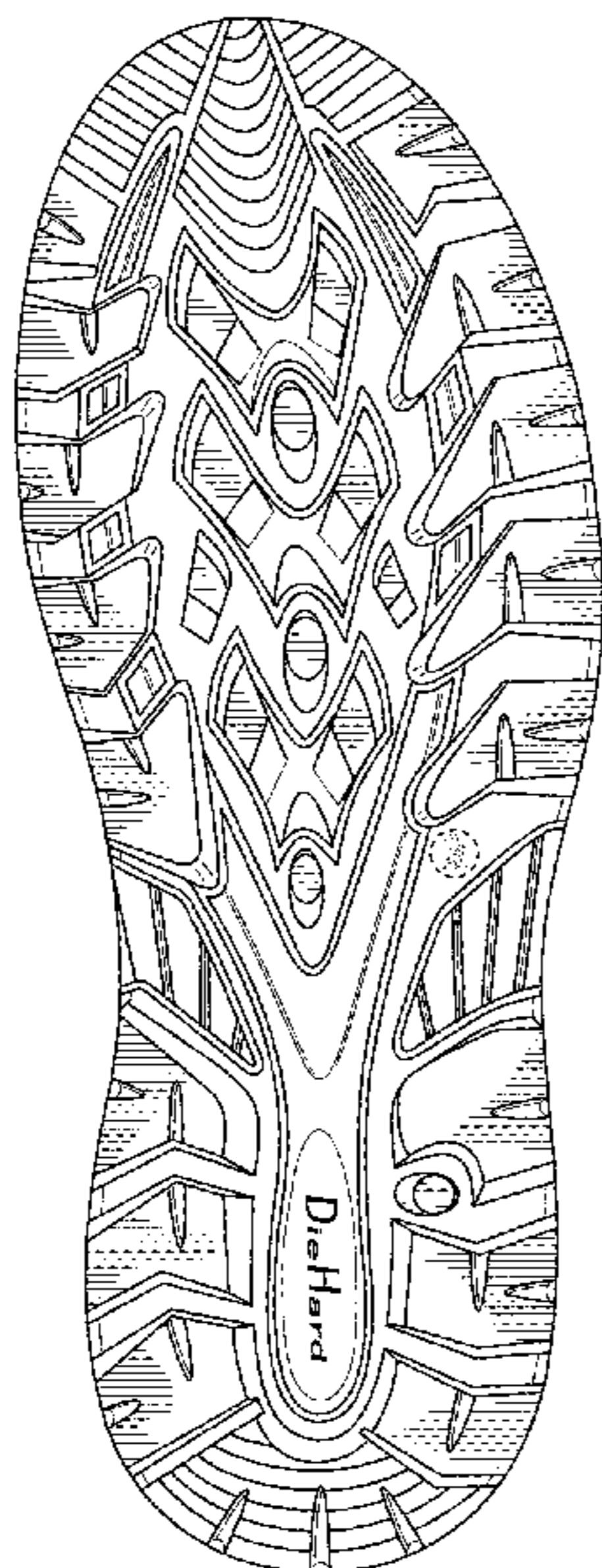
(57) **CLAIM**

What is claimed is the ornamental design for a shoe outsole and insert, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe outsole and insert showing the new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a front side elevational view thereof; and,
 FIG. 6 is a rear side elevational view thereof.
 Any elements shown in dotted lines are provided for purposes of illustrating portions of the shoe outsole and insert that form no part of the claimed design.

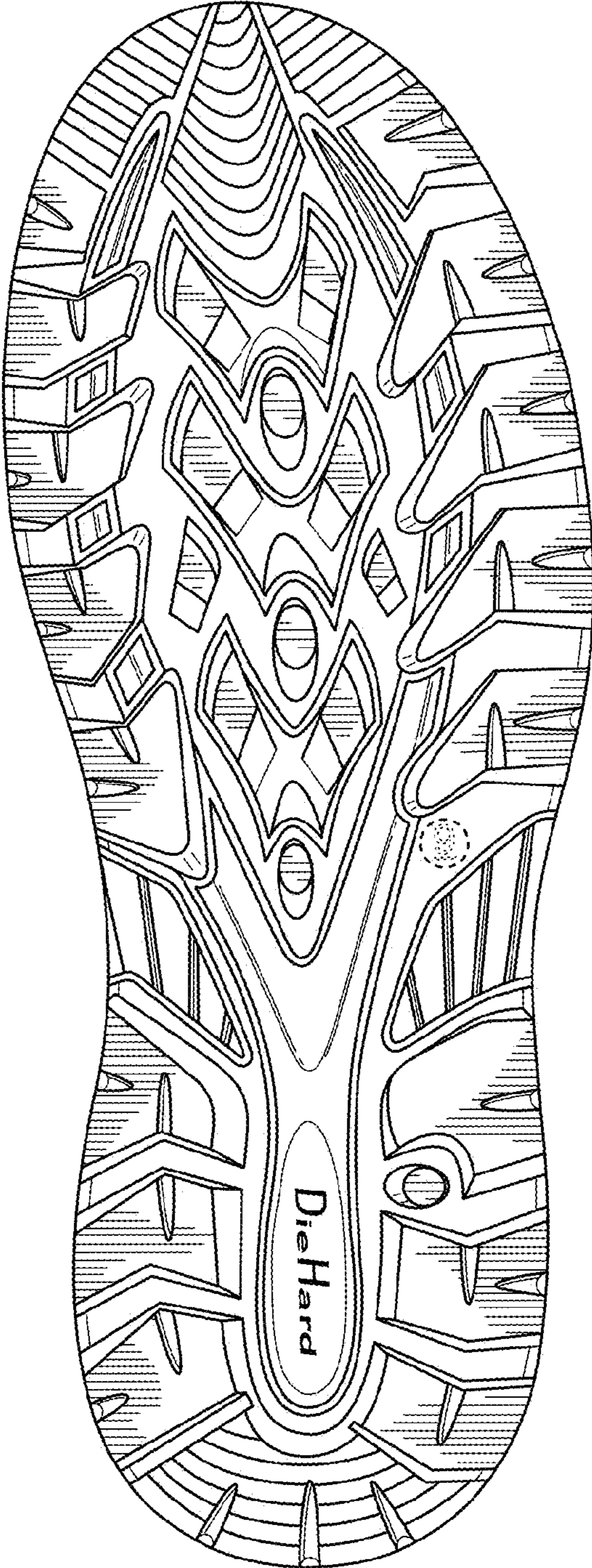

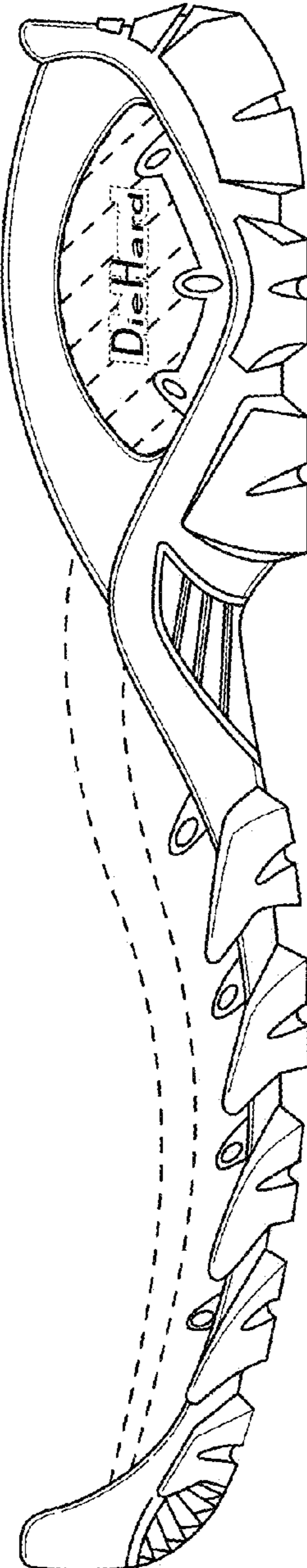

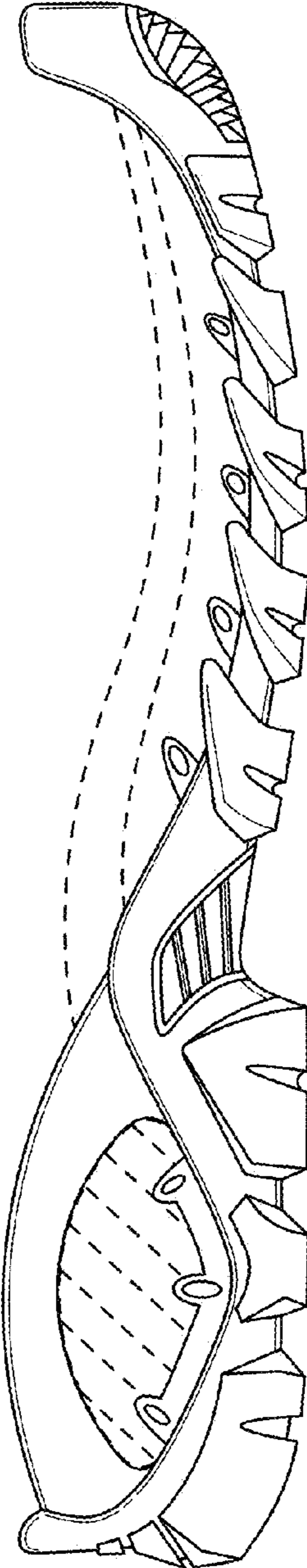

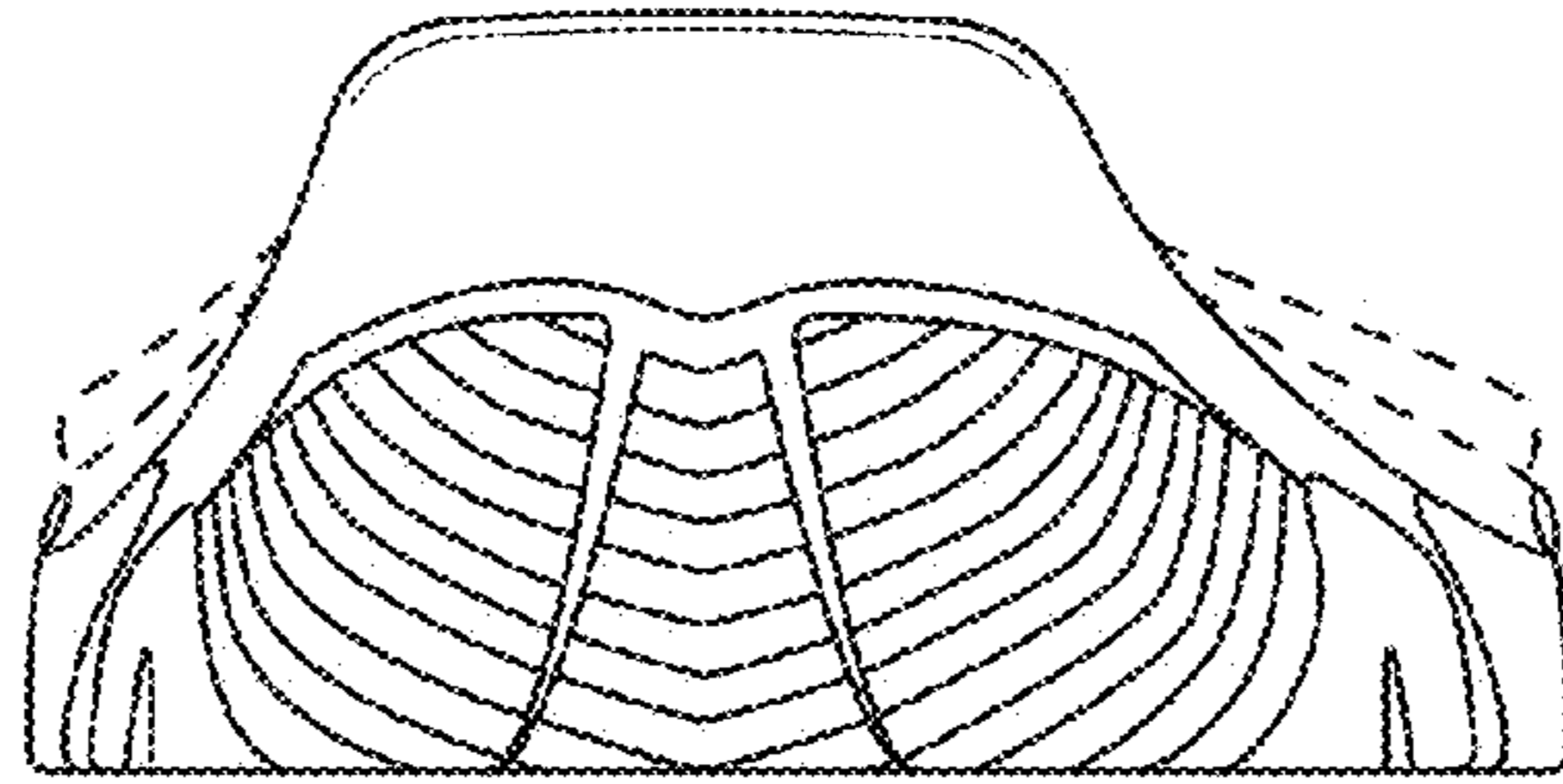

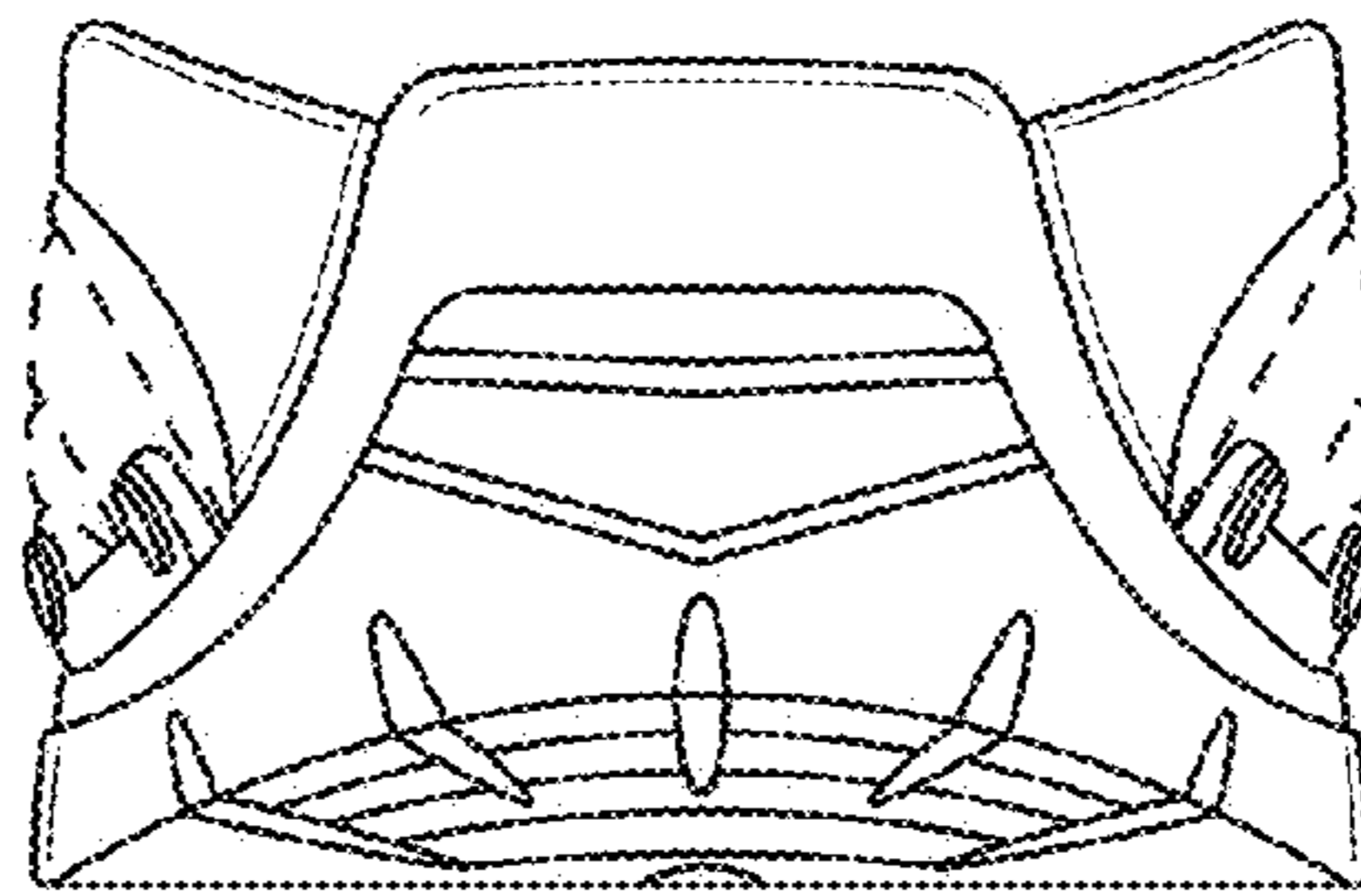
