(57) **CLAIM**

I claim, the ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a sole for footwear, showing my new design;
FIG. 2 is a side elevation view thereof;
FIG. 3 is an opposite side elevation view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view thereof.

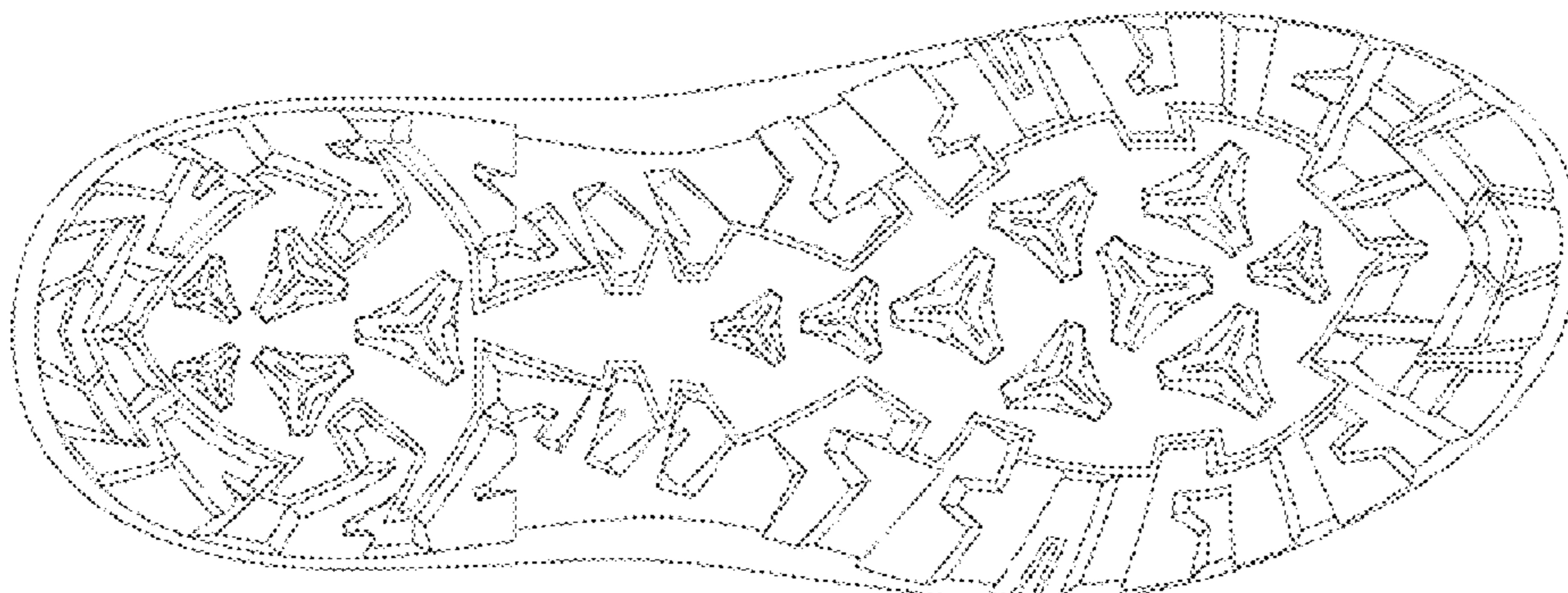
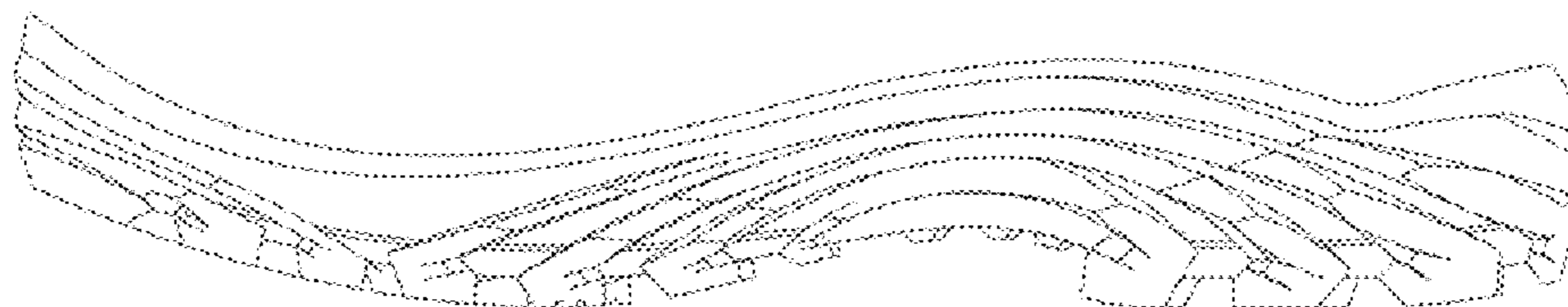

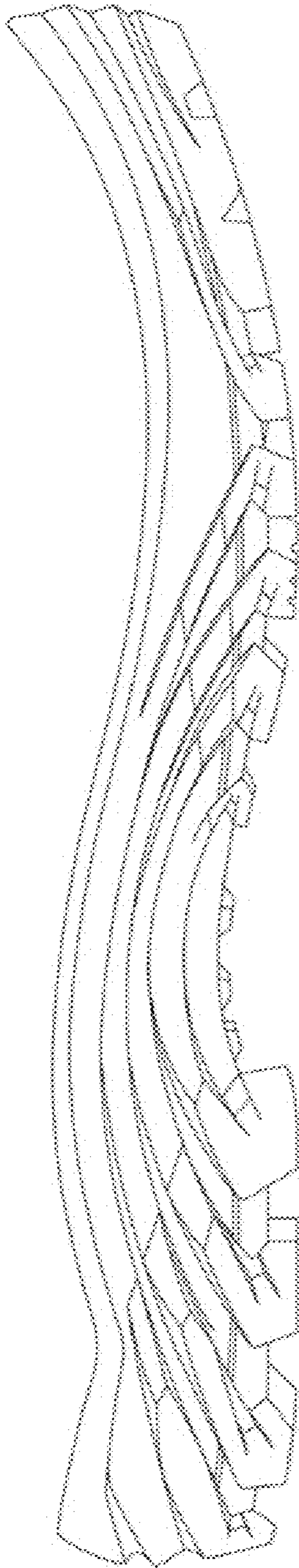

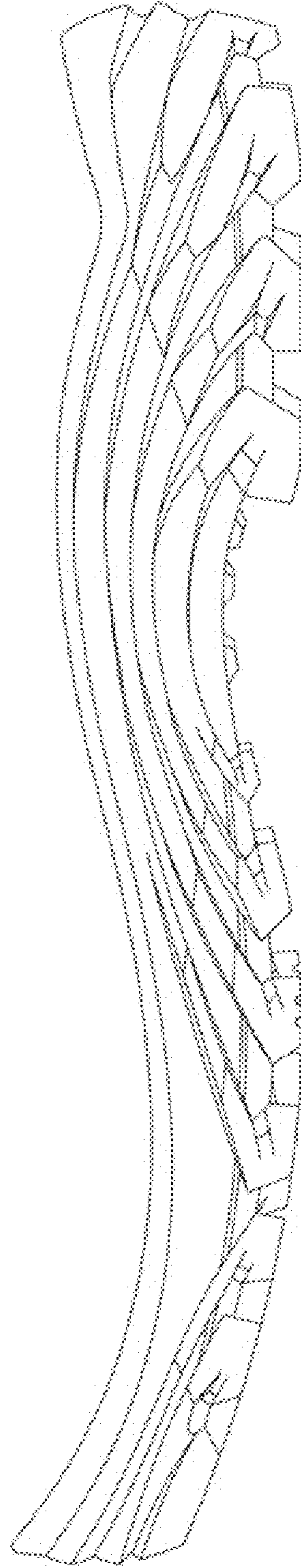

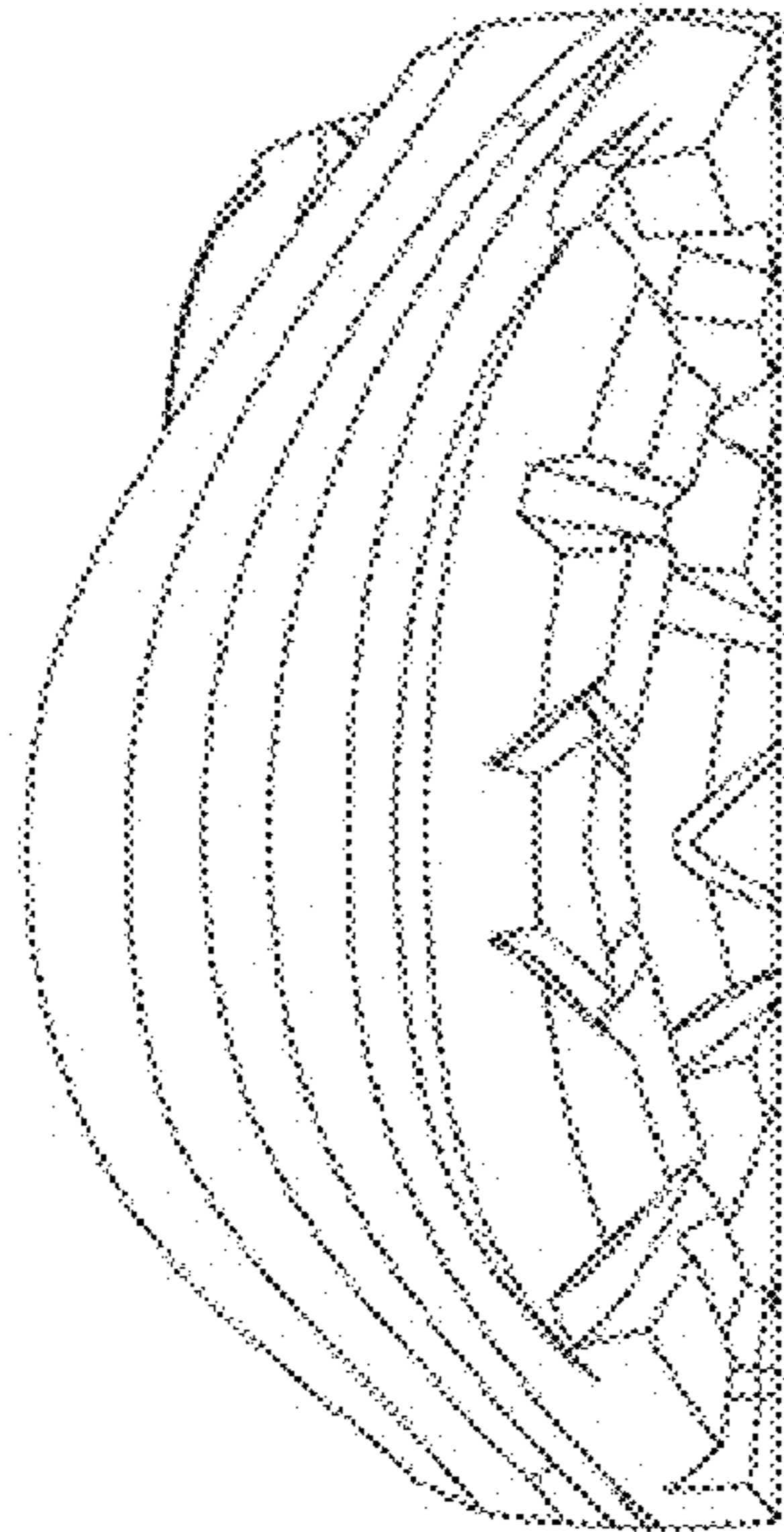

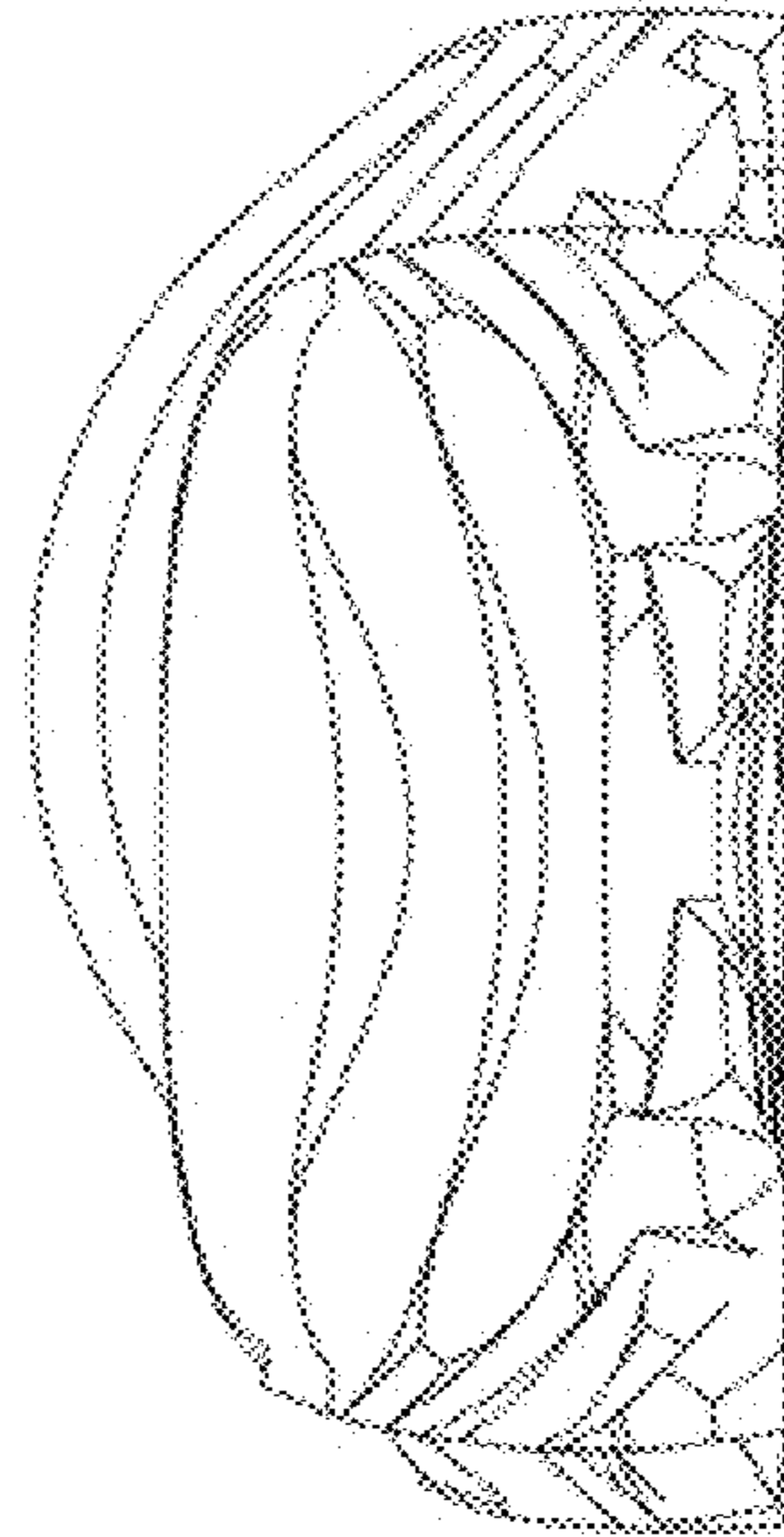

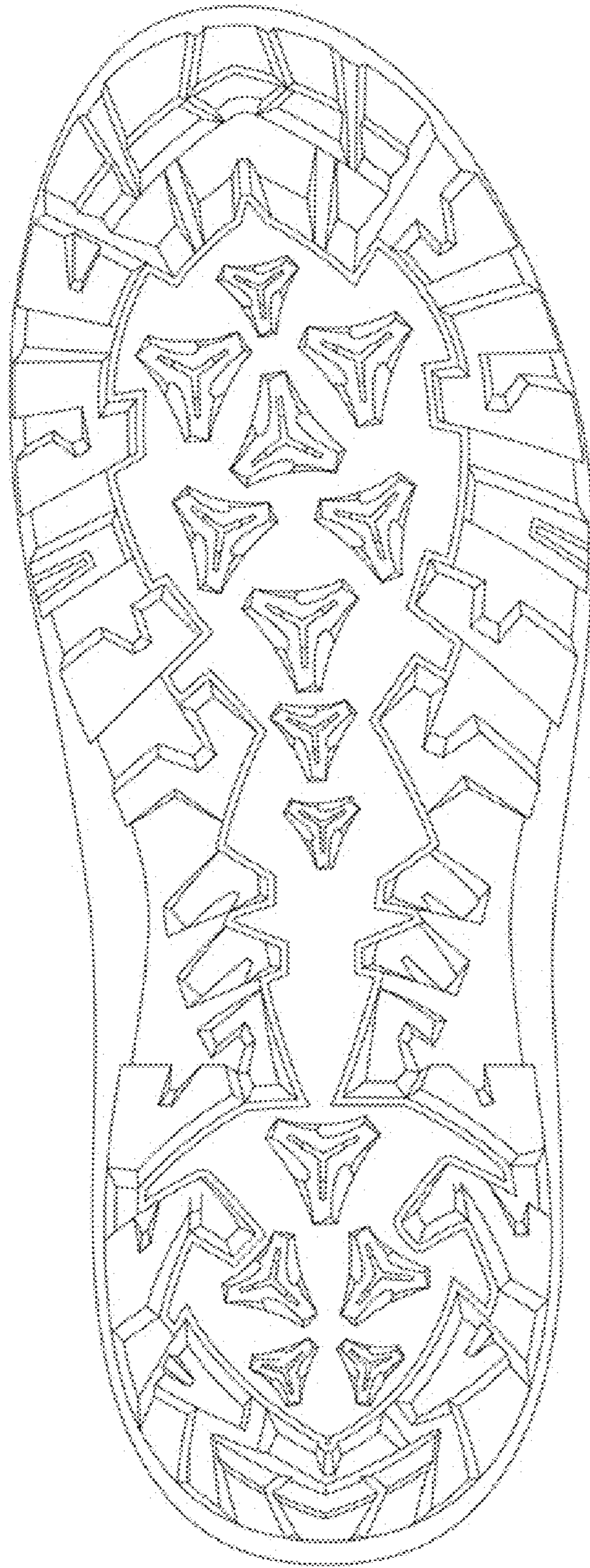
