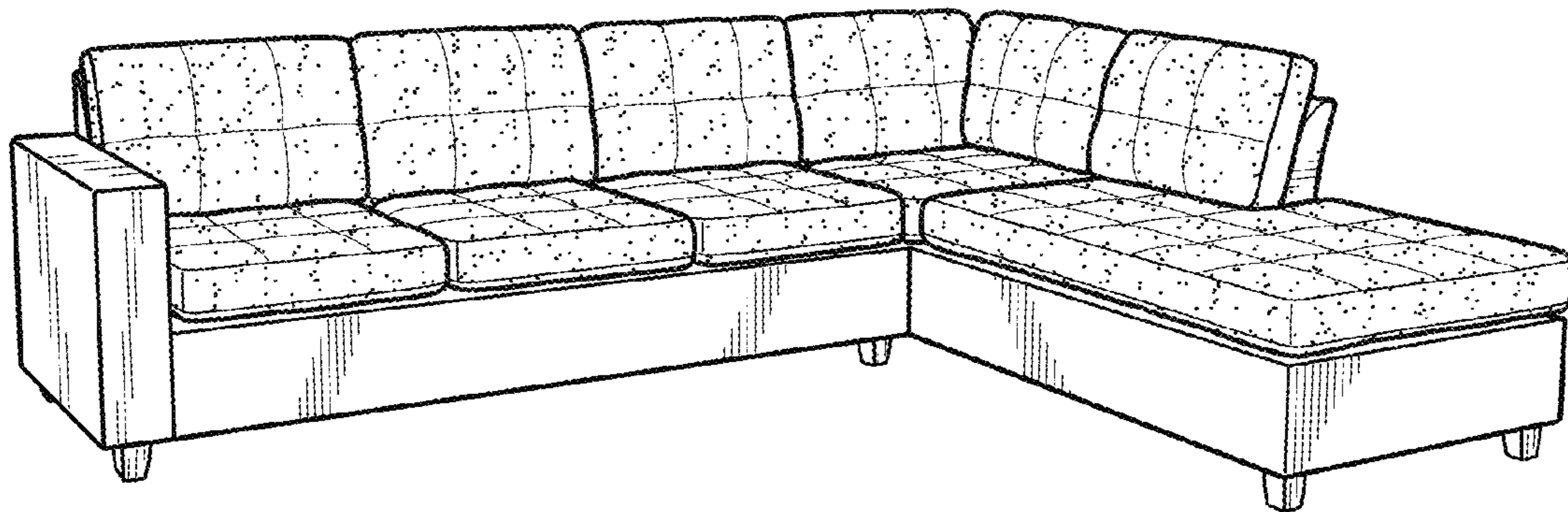
(57) **CLAIM**

The ornamental design for a sectional sofa, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sofa of the present invention; FIG. 2 is a front view of the sofa of FIG. 1; FIG. 3 is a back view of the sofa of FIG. 1; FIG. 4 is a left side view of the sofa of FIG. 1; FIG. 5 is a right side view of the sofa of FIG. 1; and, FIG. 6 is a top view of the sofa of FIG. 1, the bottom of the sofa is not illustrated as it forms no part of the present invention. The sectional sofa is typically used in home settings. The sectional sofa comprises a main central body with an extended sectional ottoman that extends outwards.

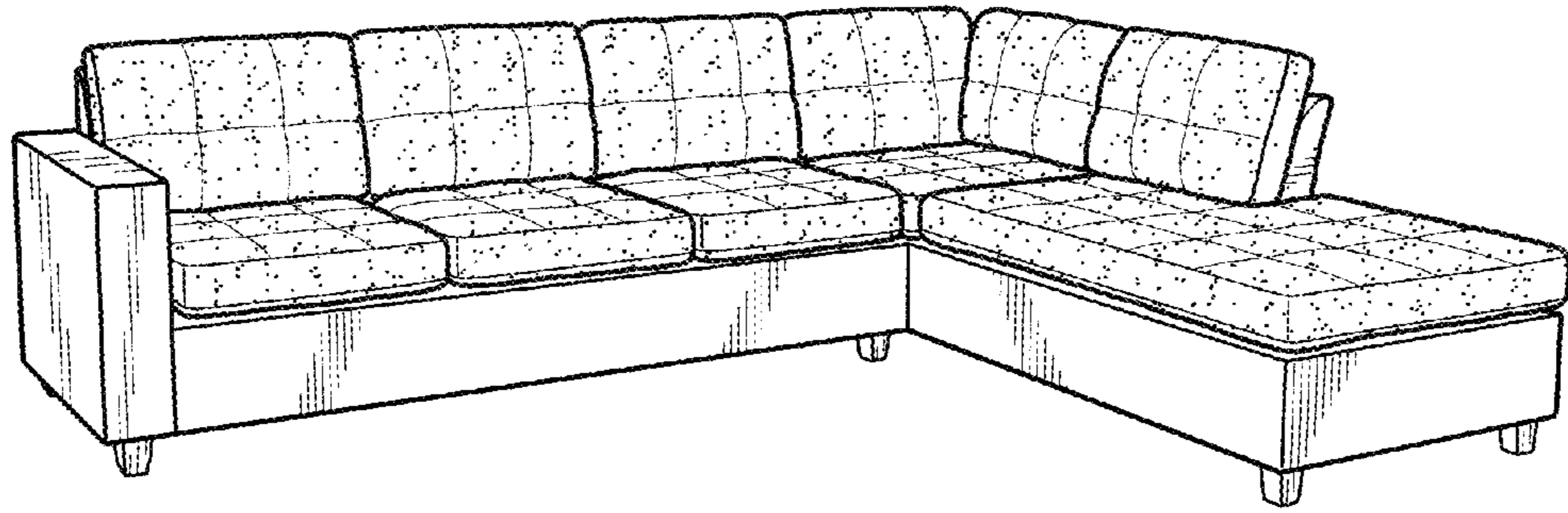

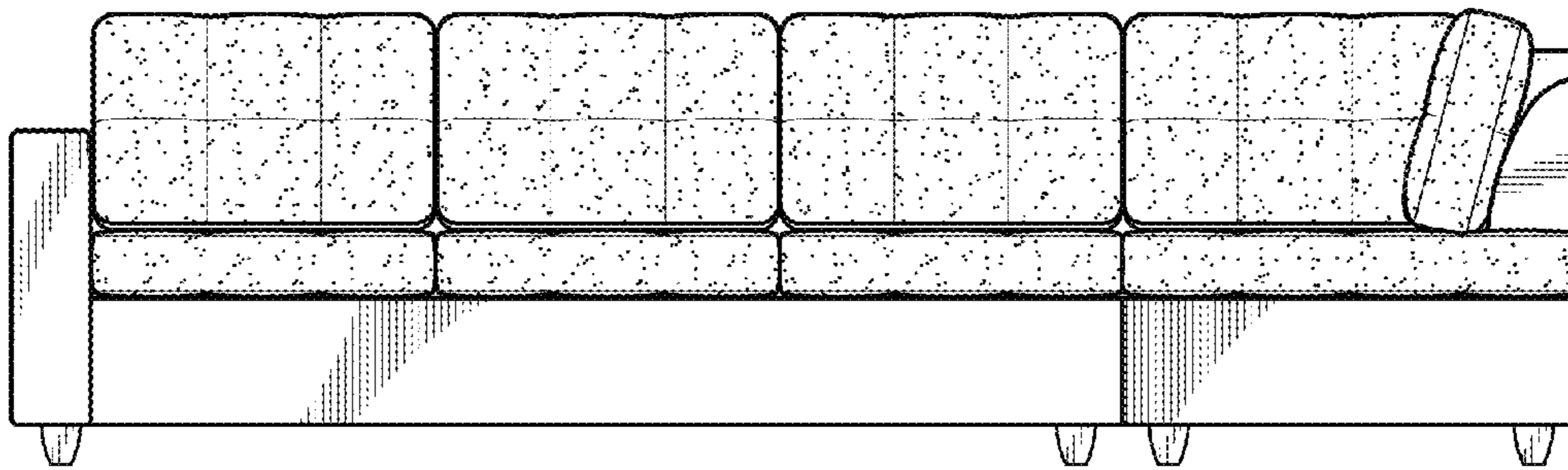

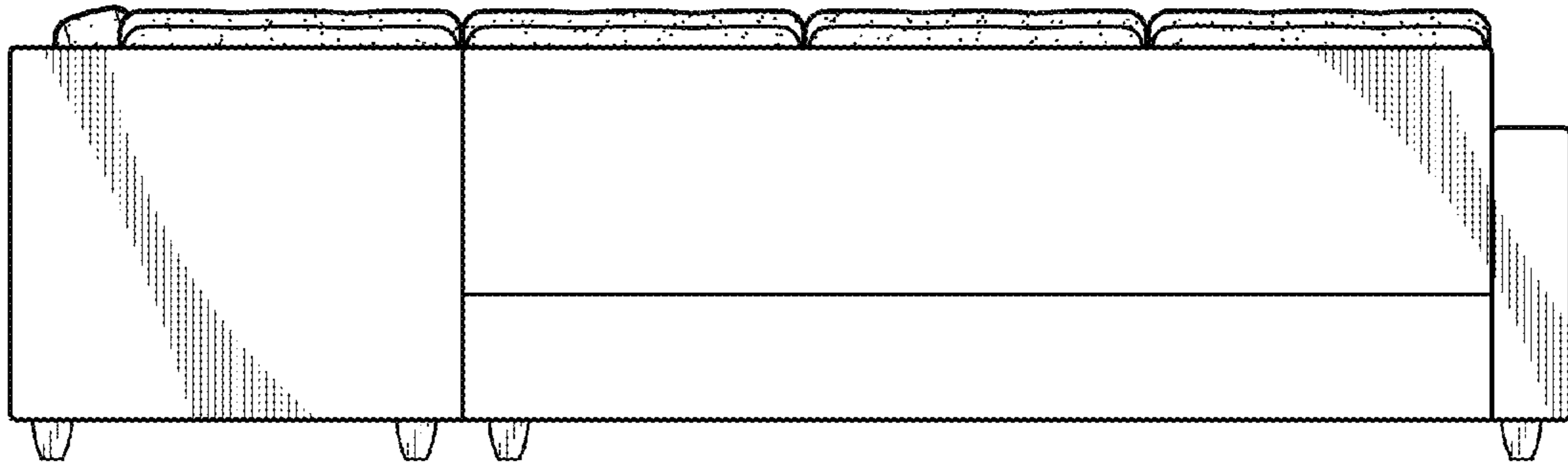

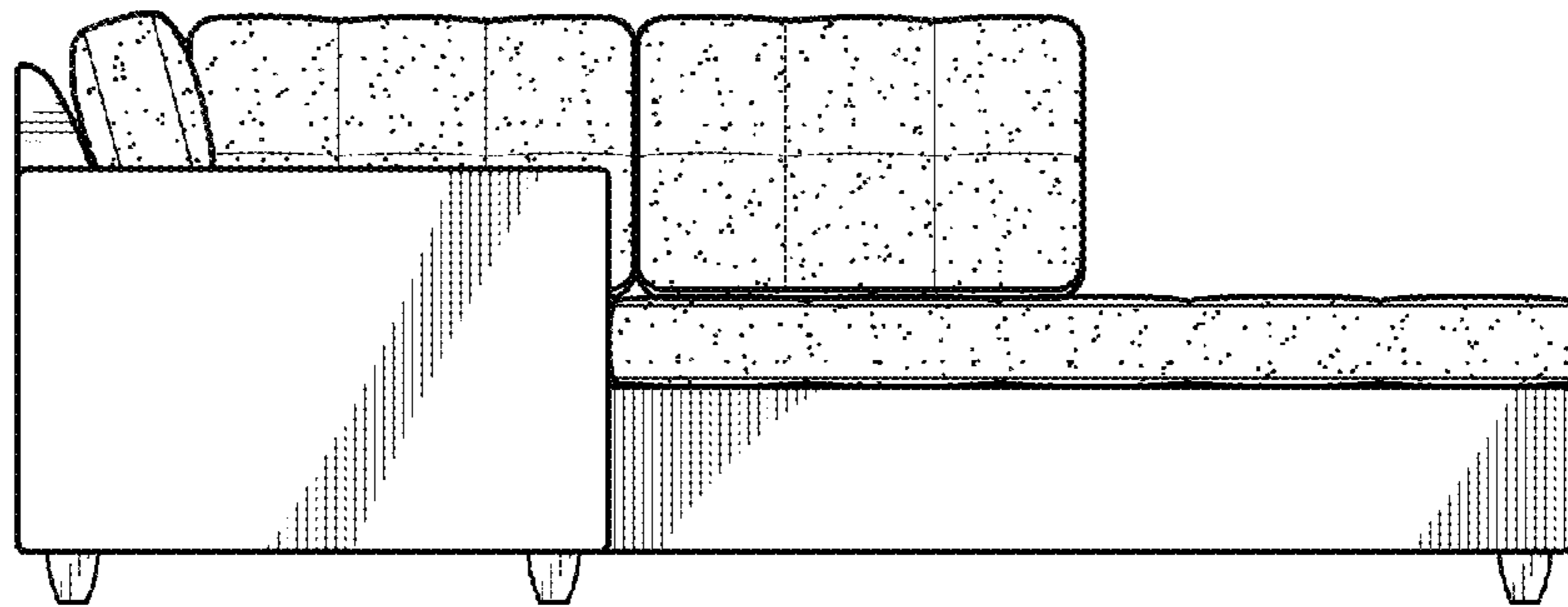

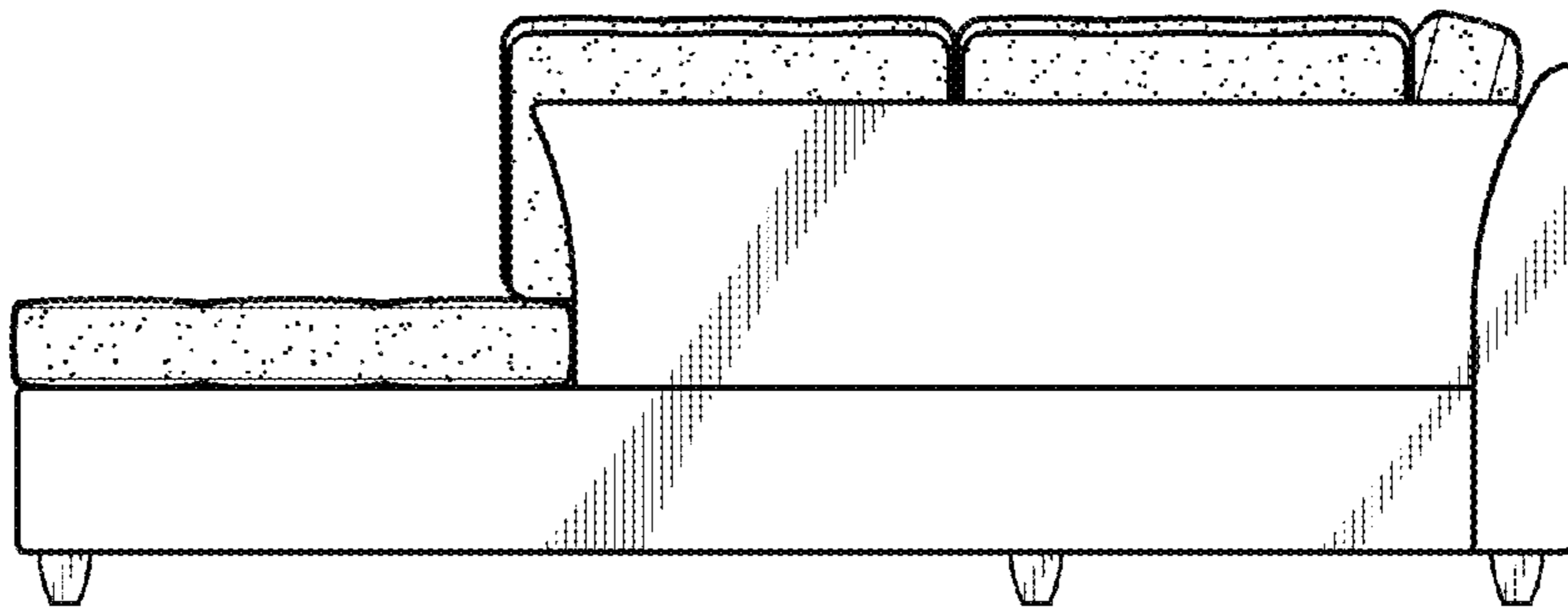

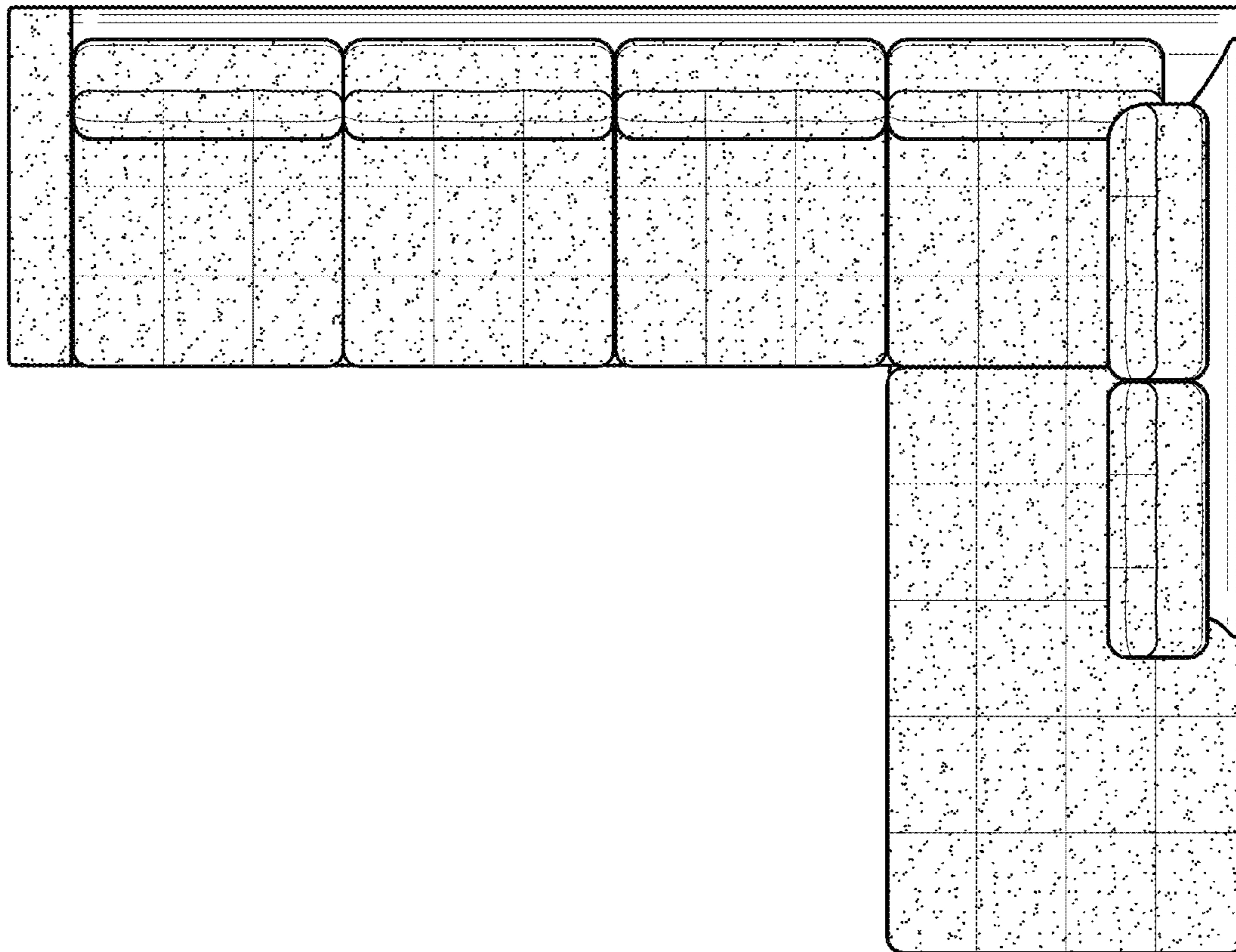
