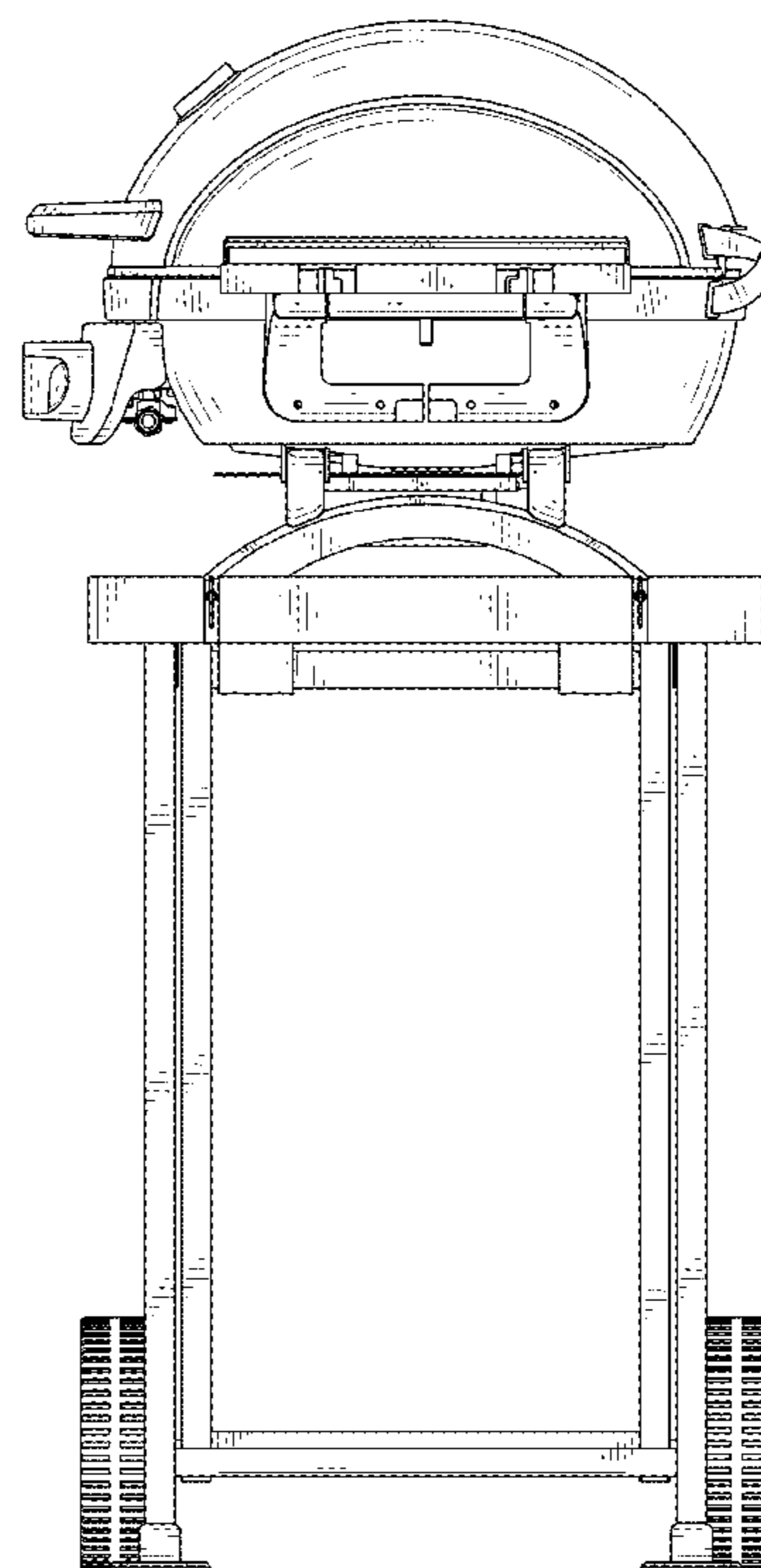
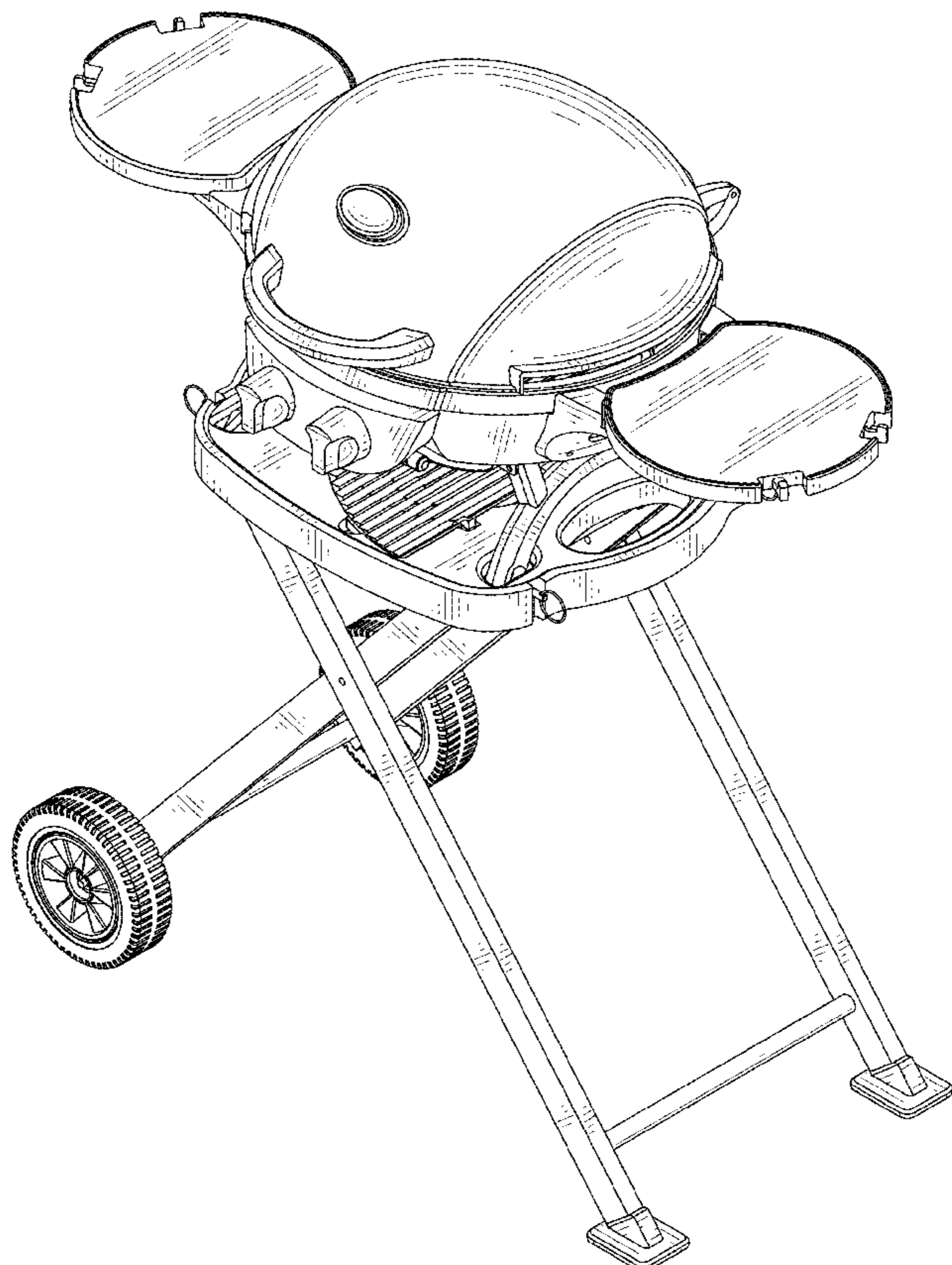
(57) **CLAIM**

I claim a new ornamental design for a grill, as shown and described.

DESCRIPTION

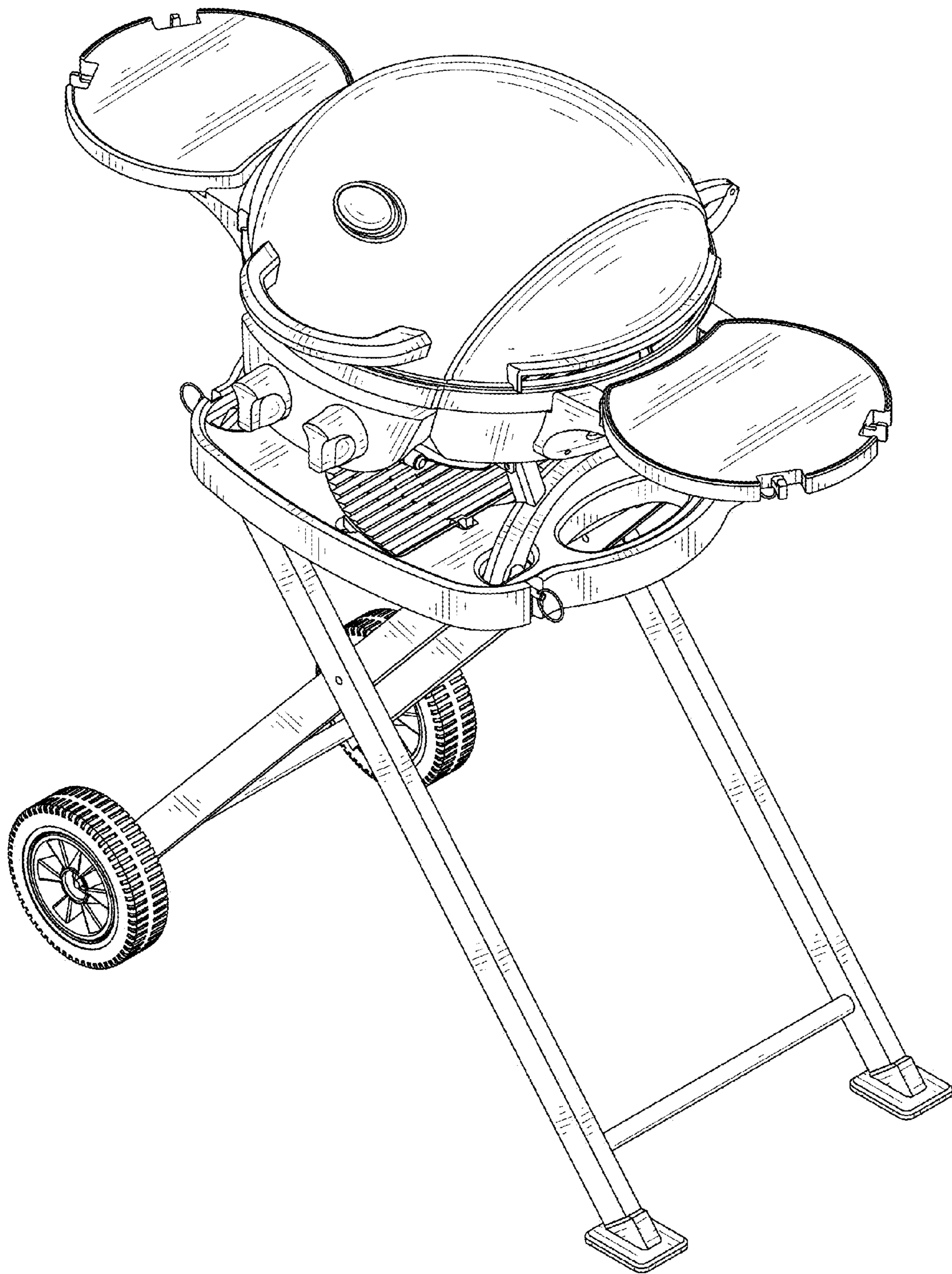

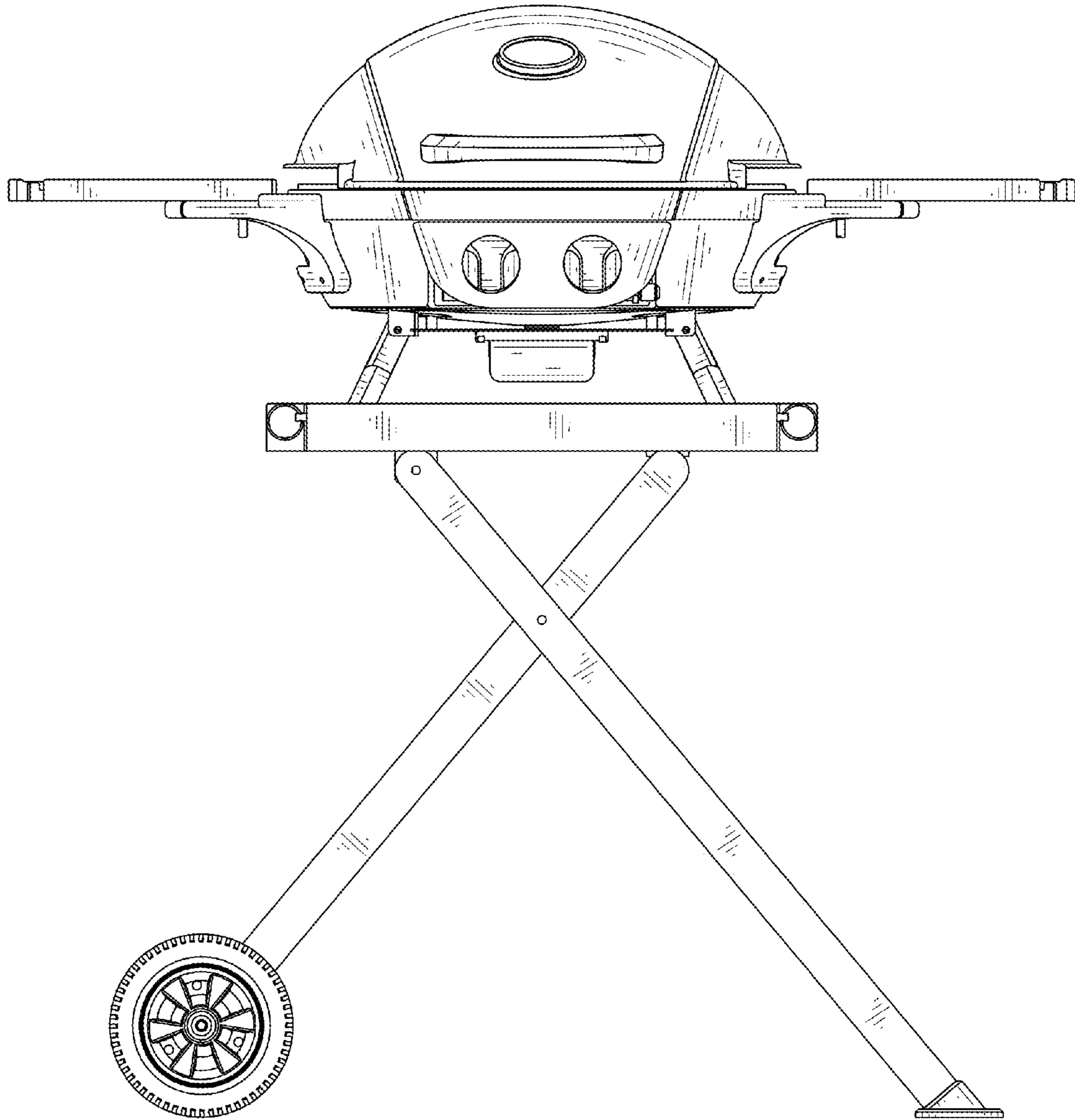

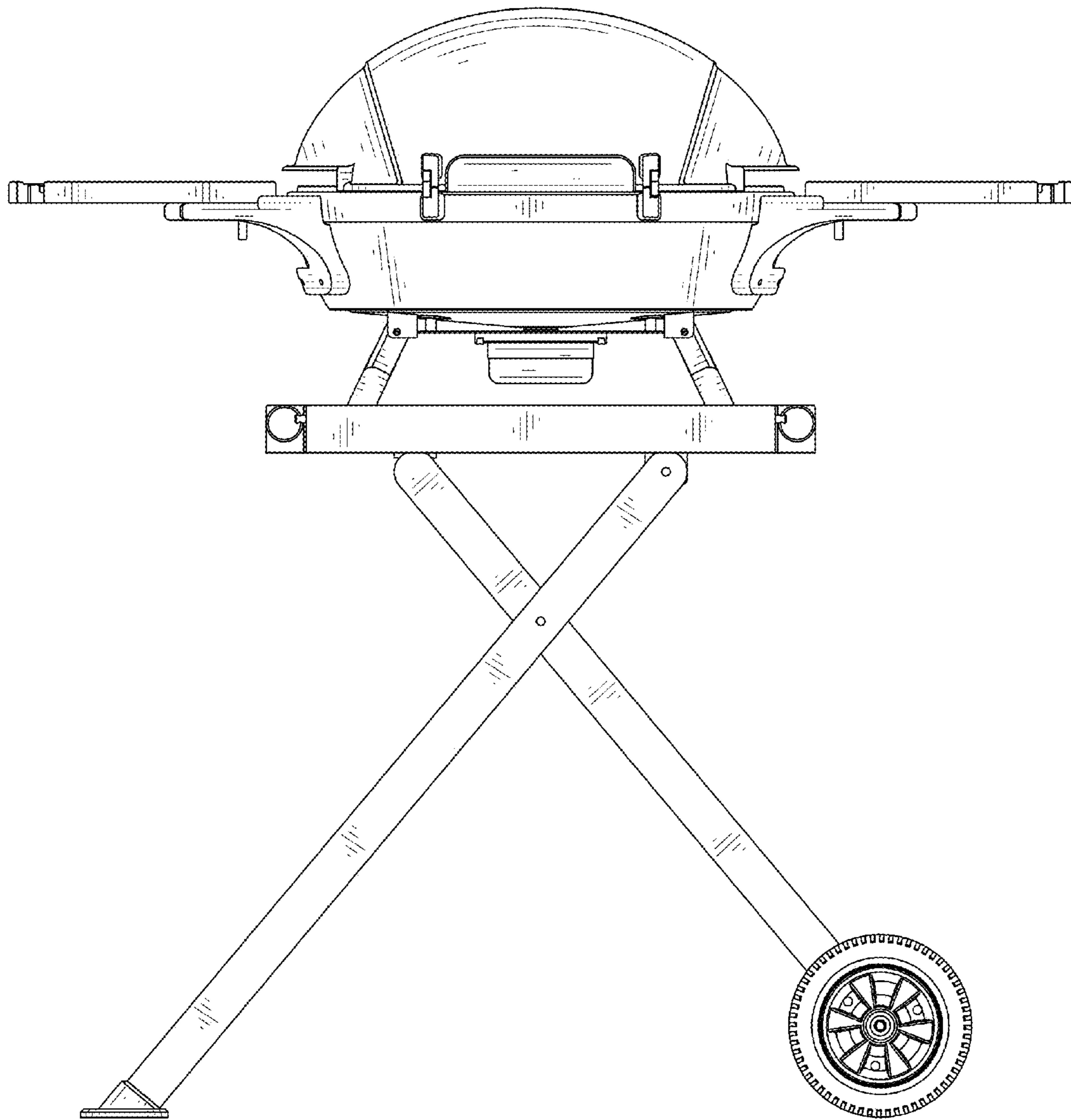

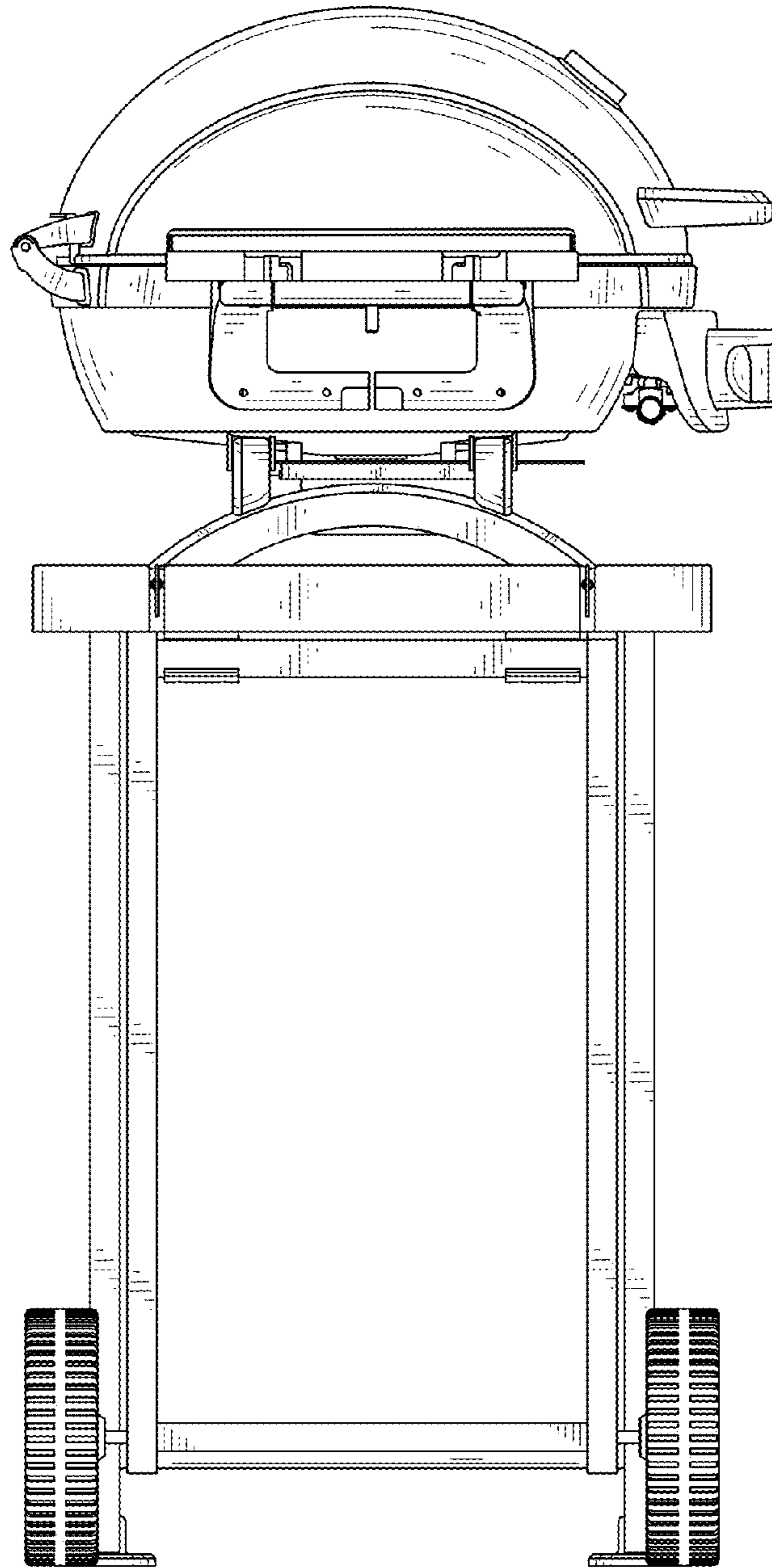

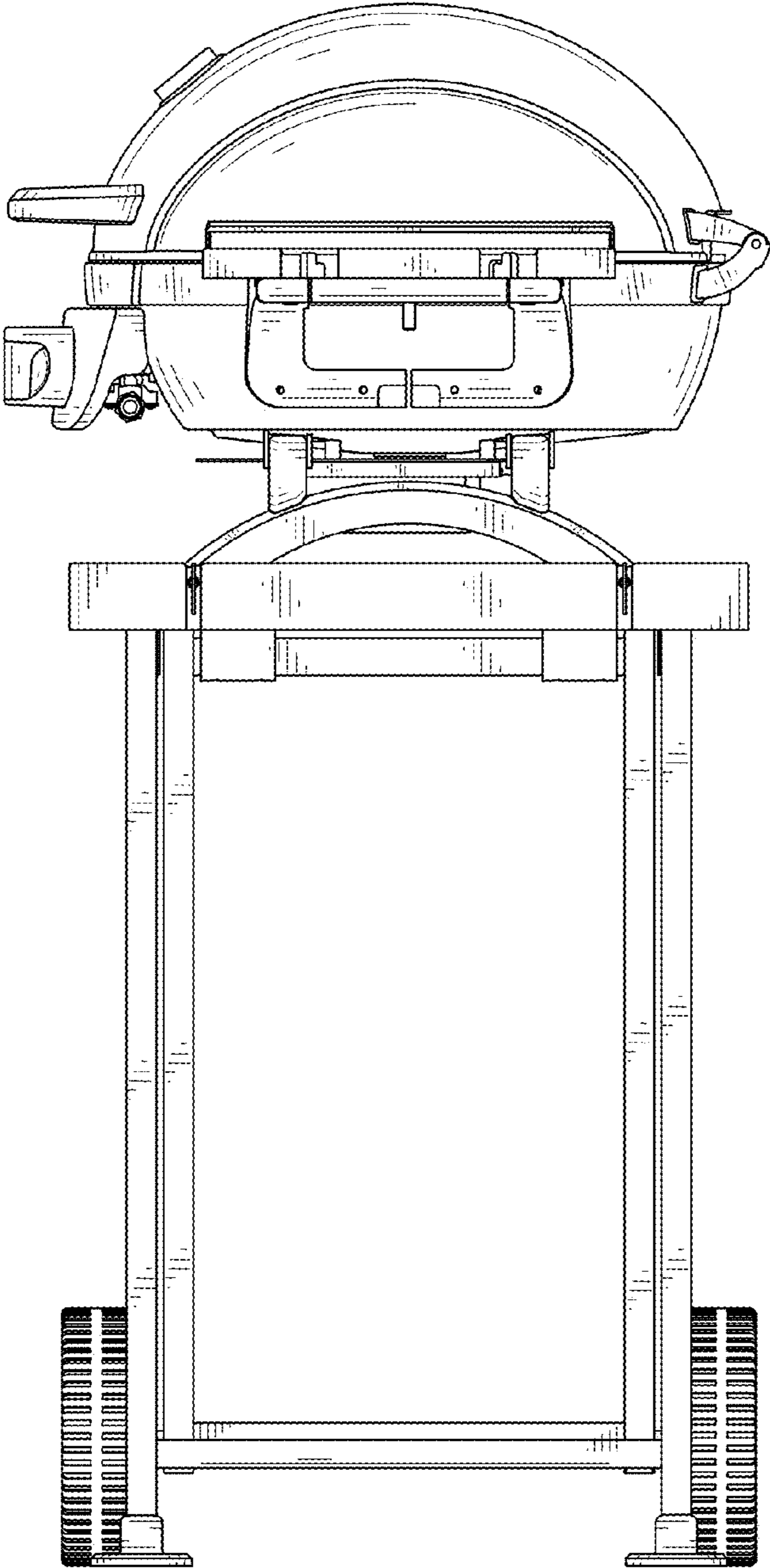

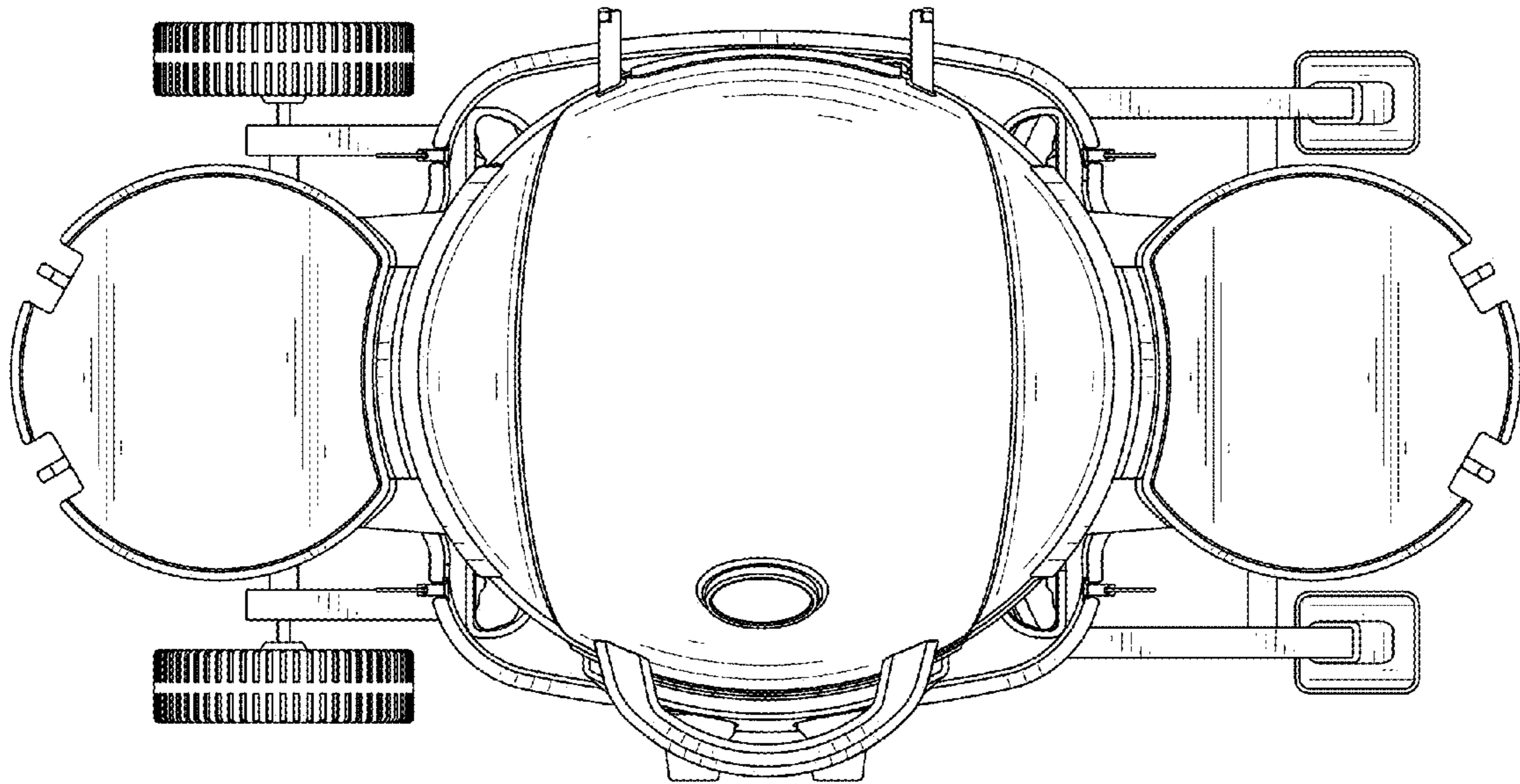
