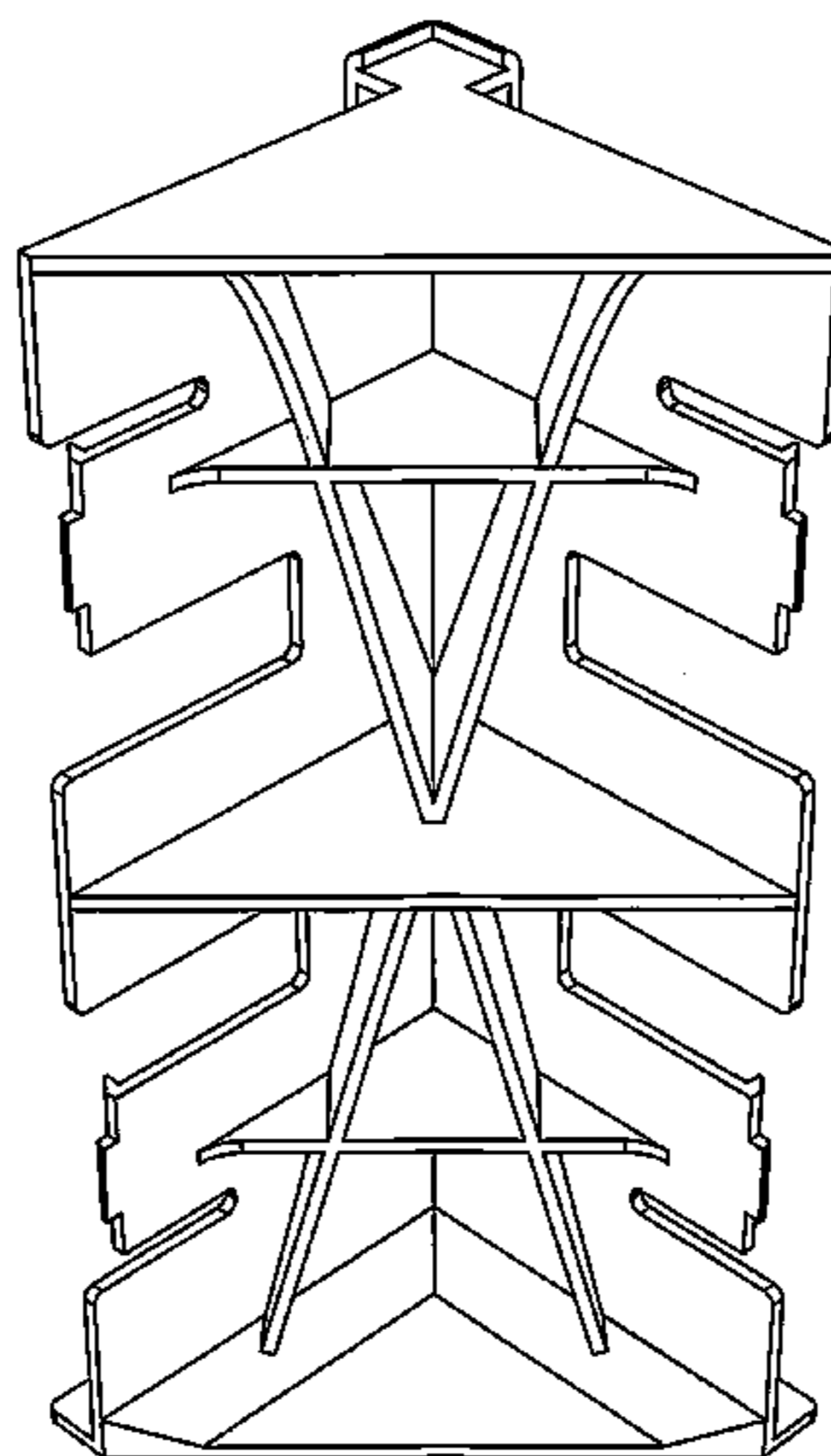
(57) **CLAIM**

The ornamental design for a corner connector for a structure, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top isometric perspective view of a corner connector for a structure, showing my new design;

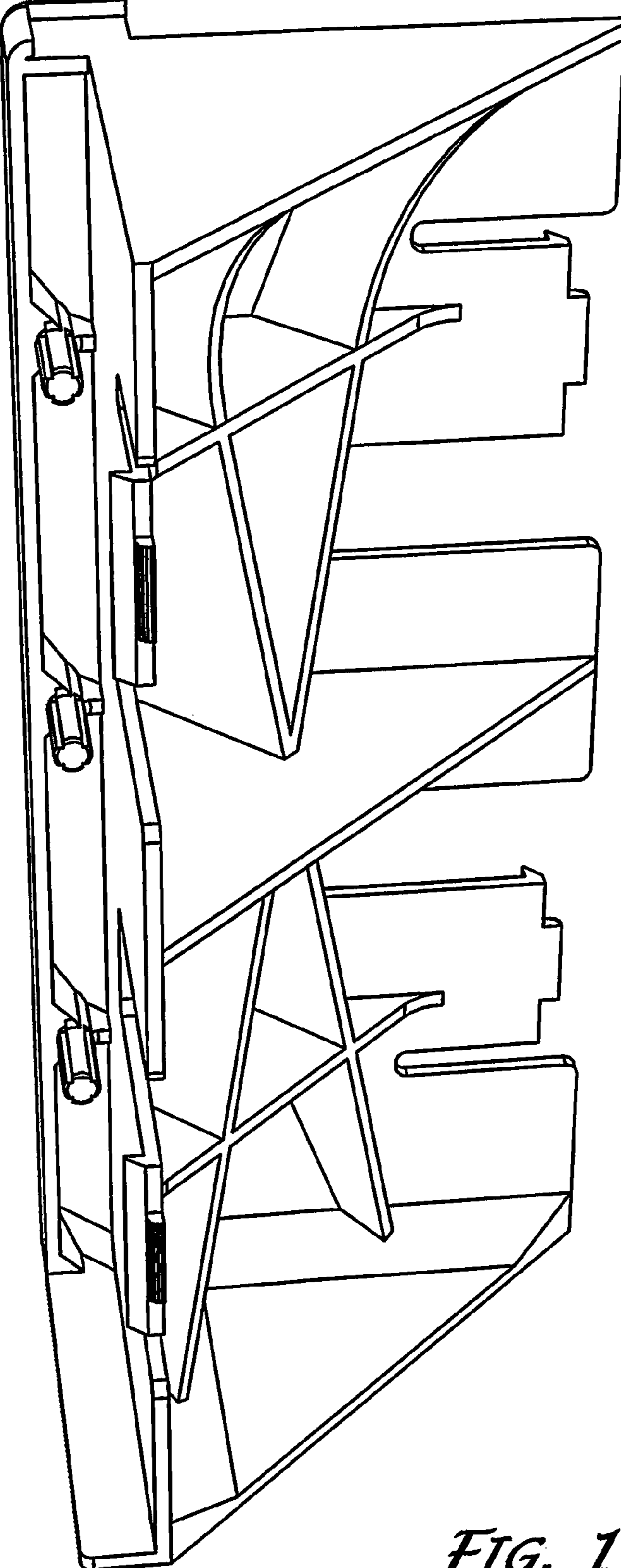

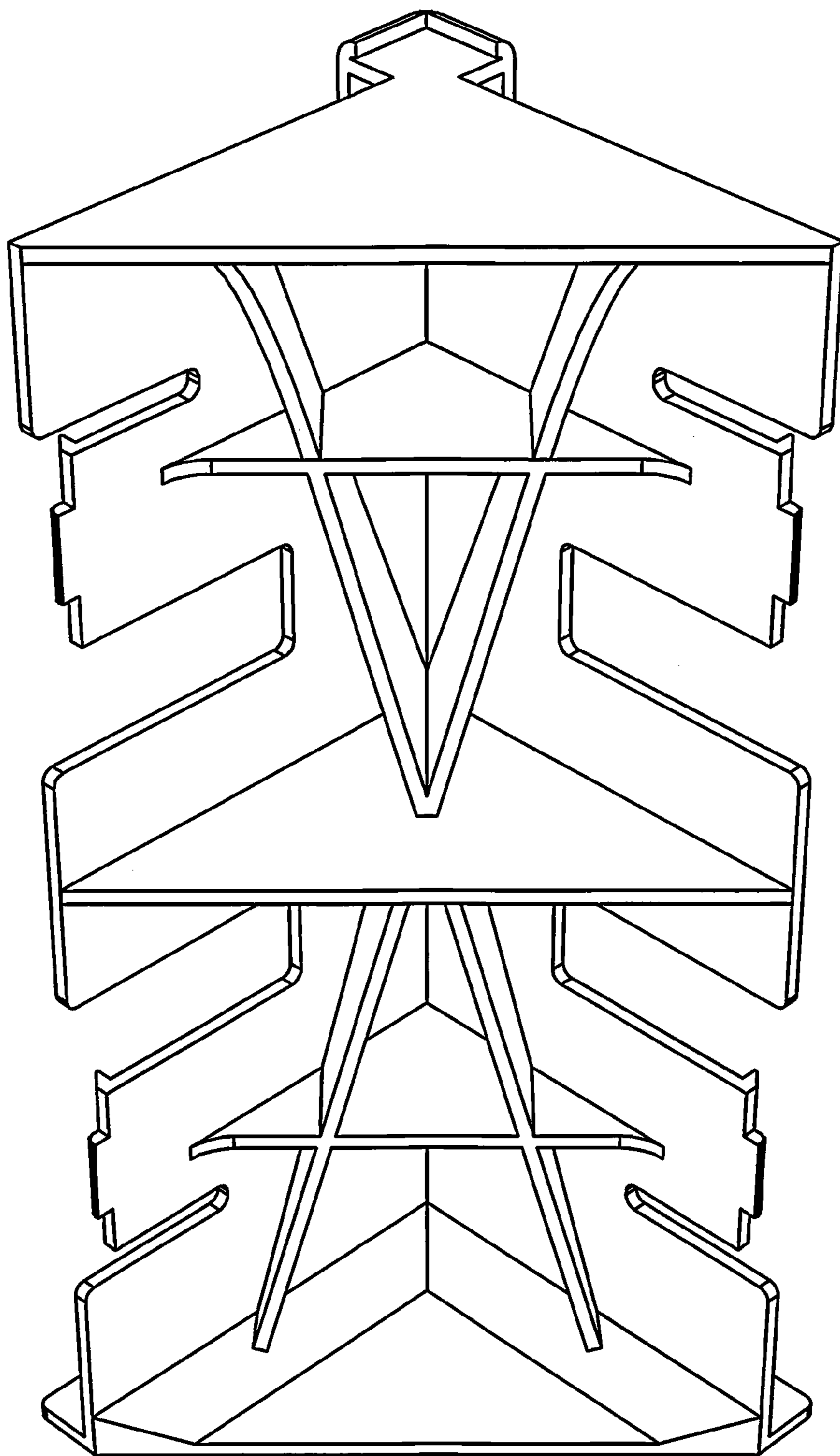

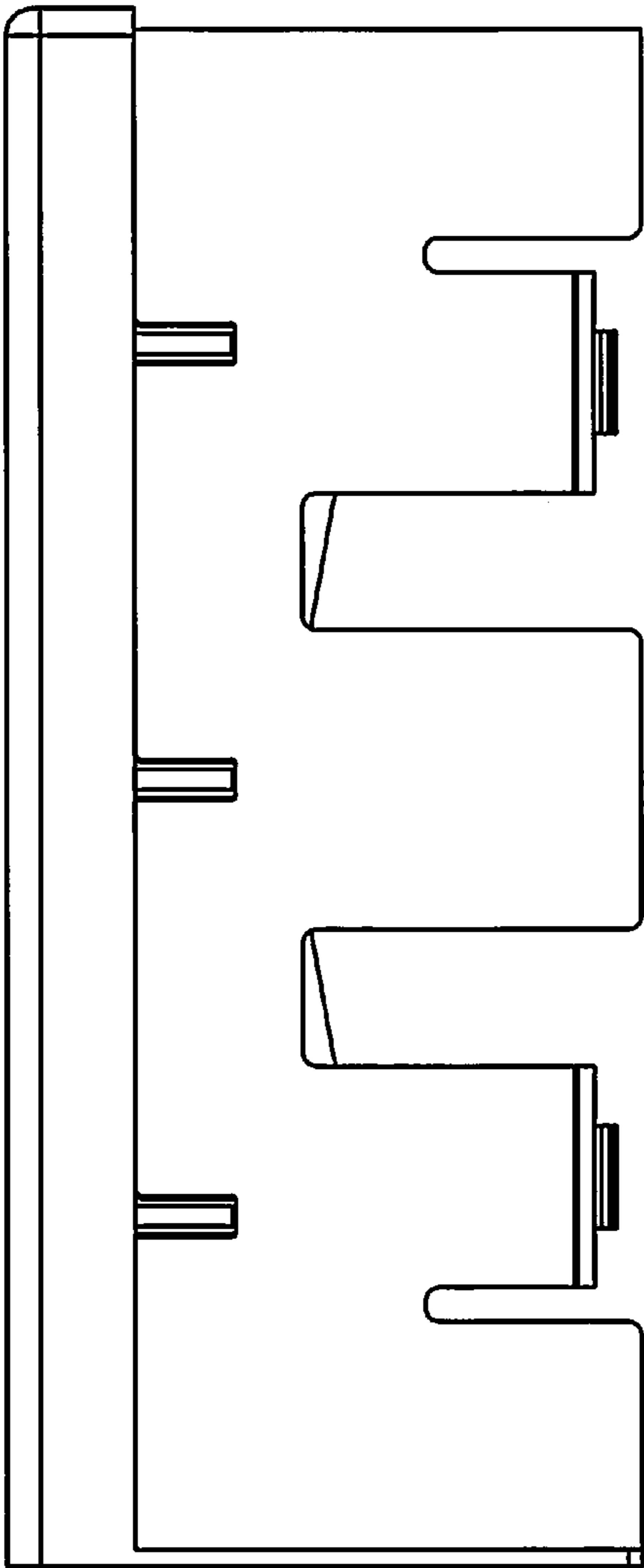

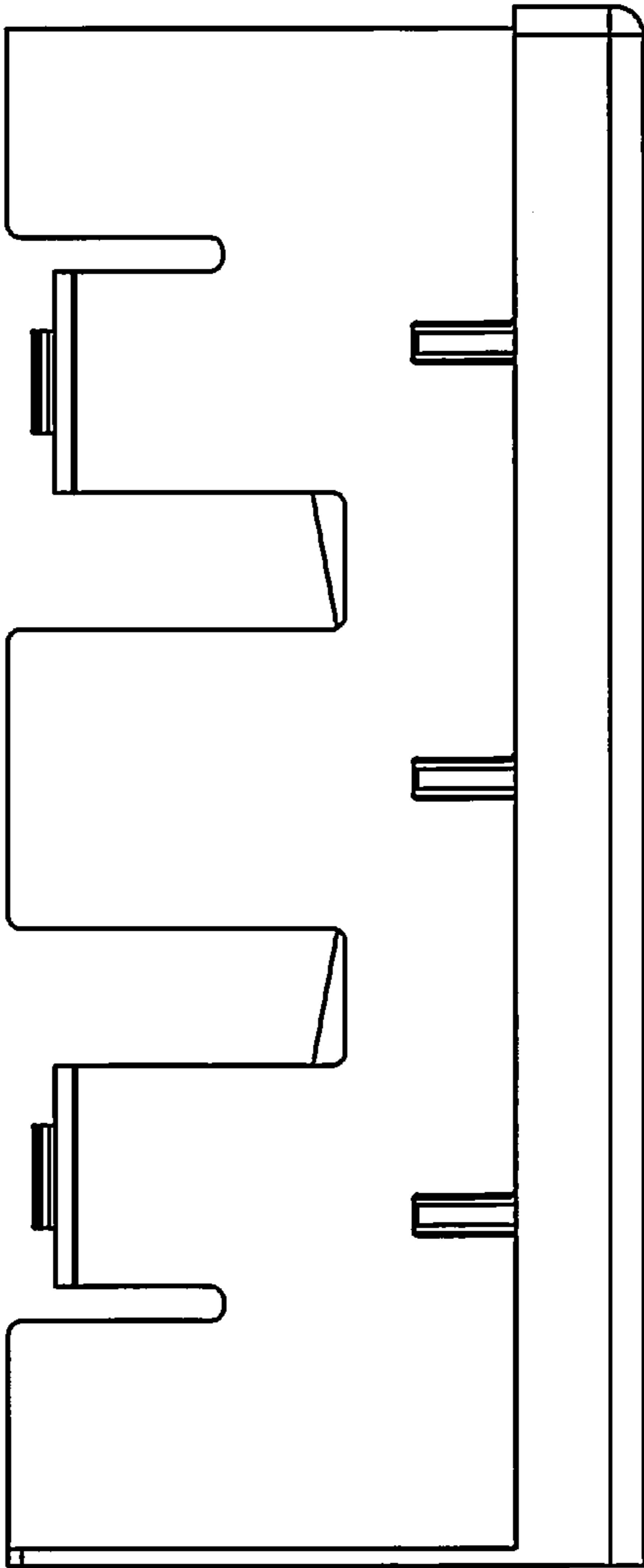

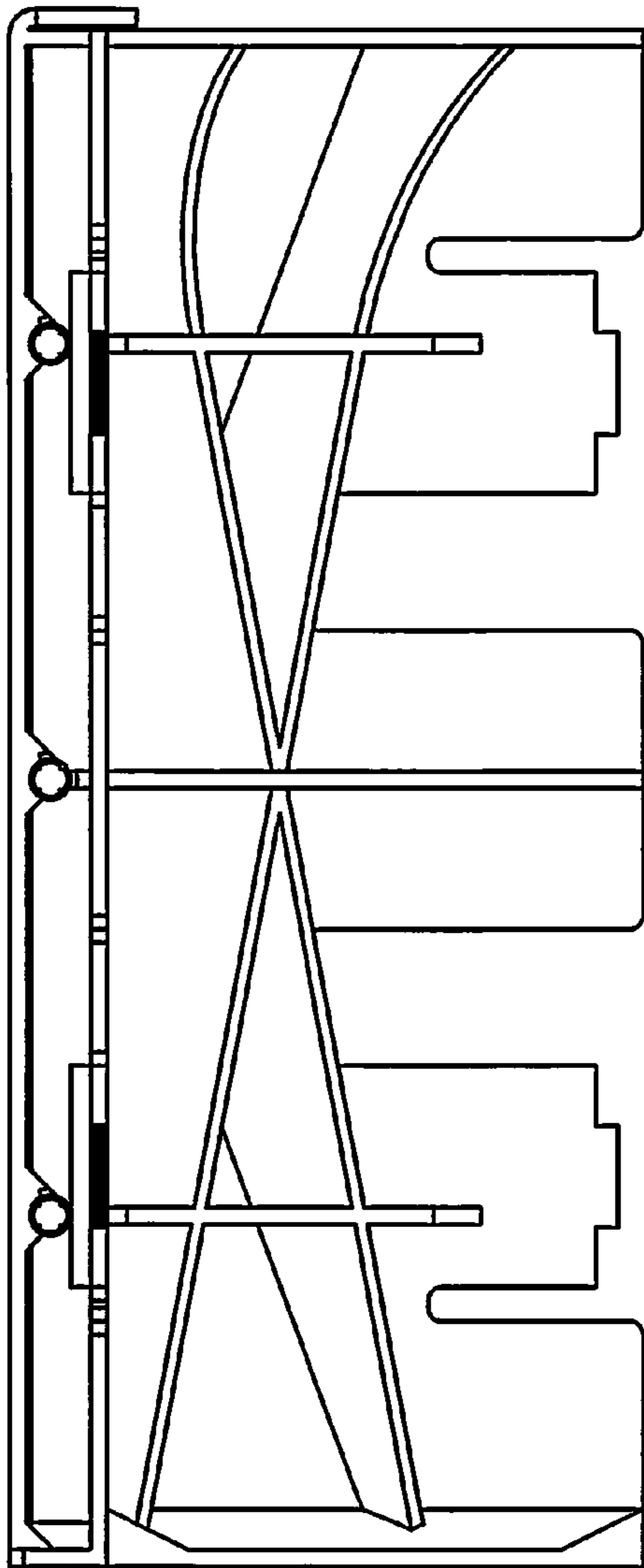

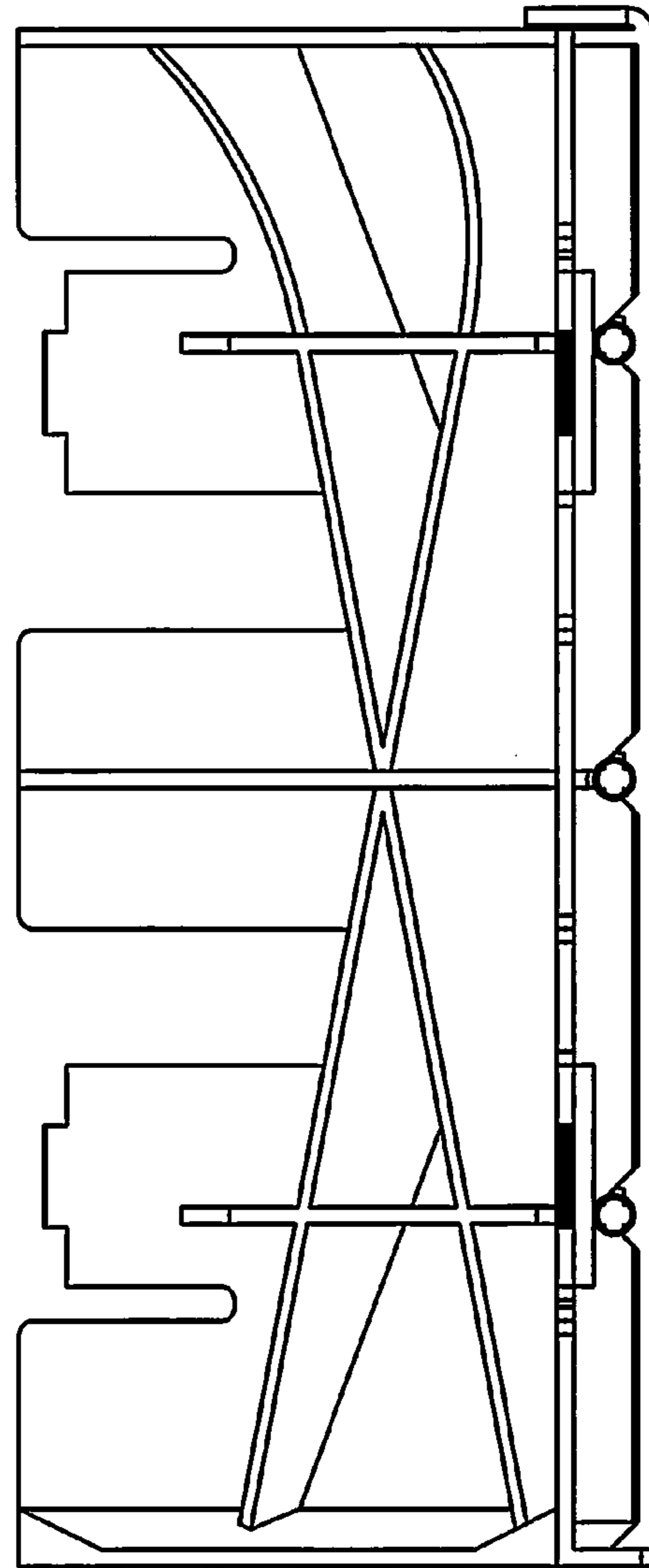

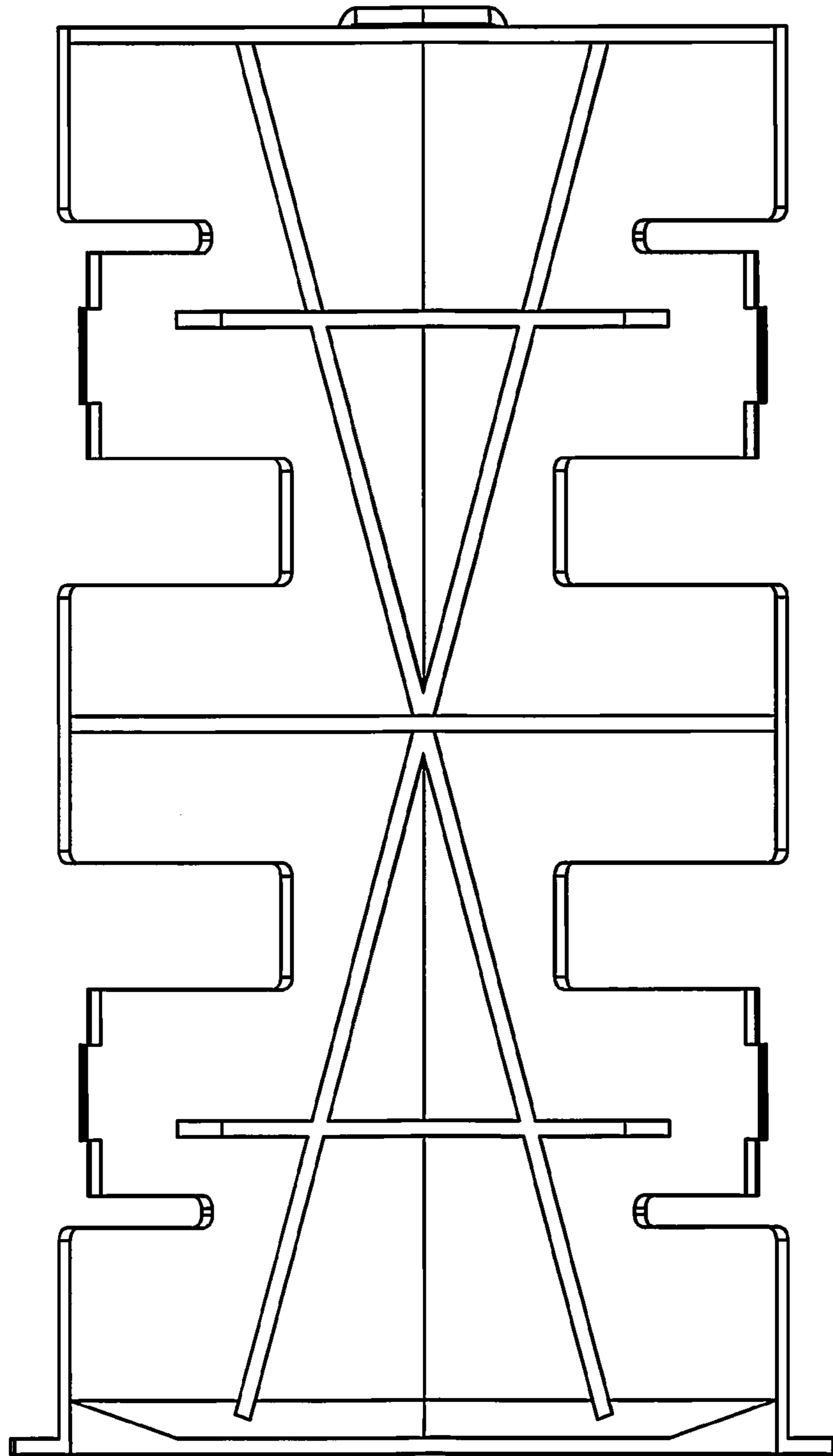

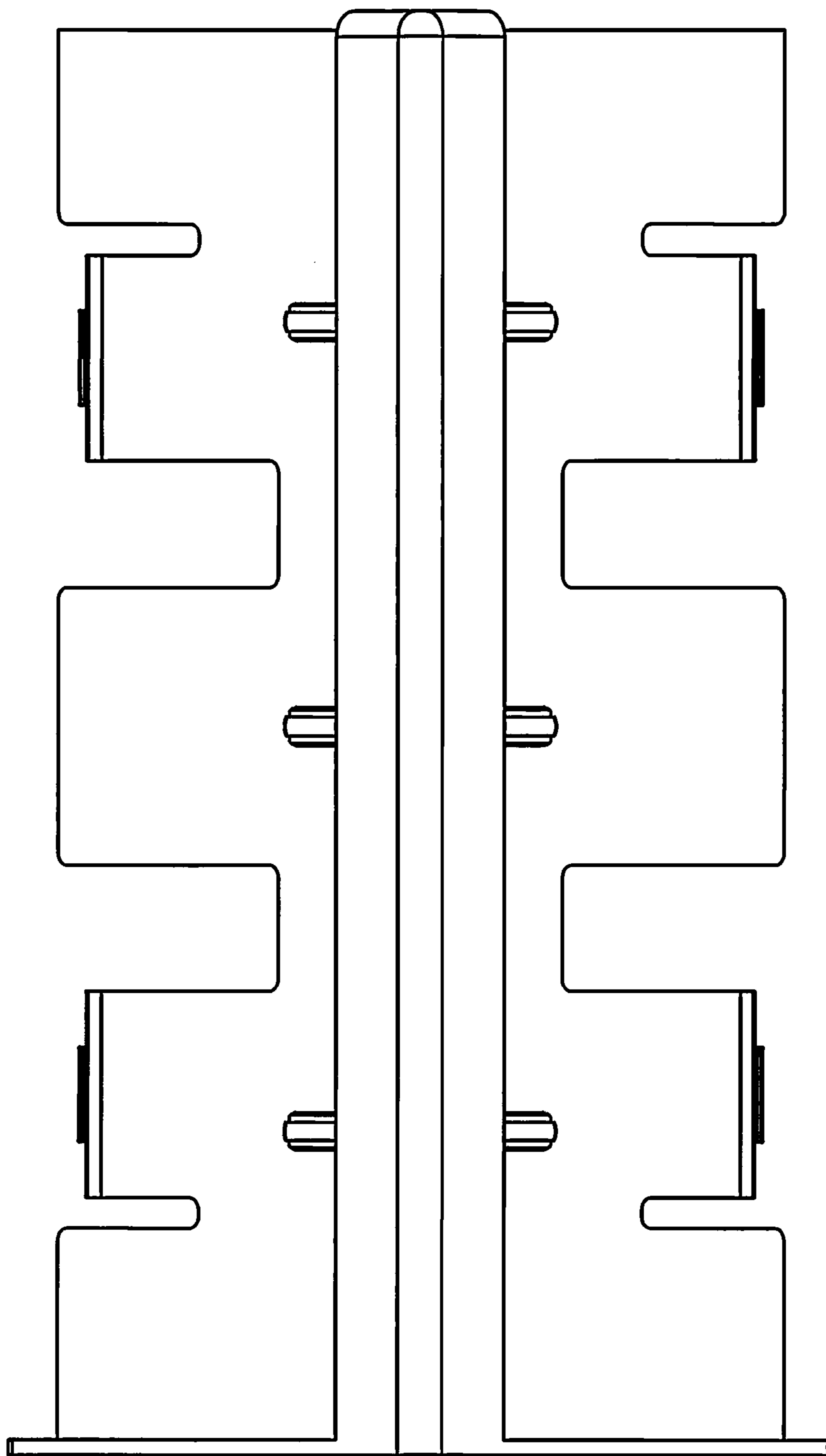

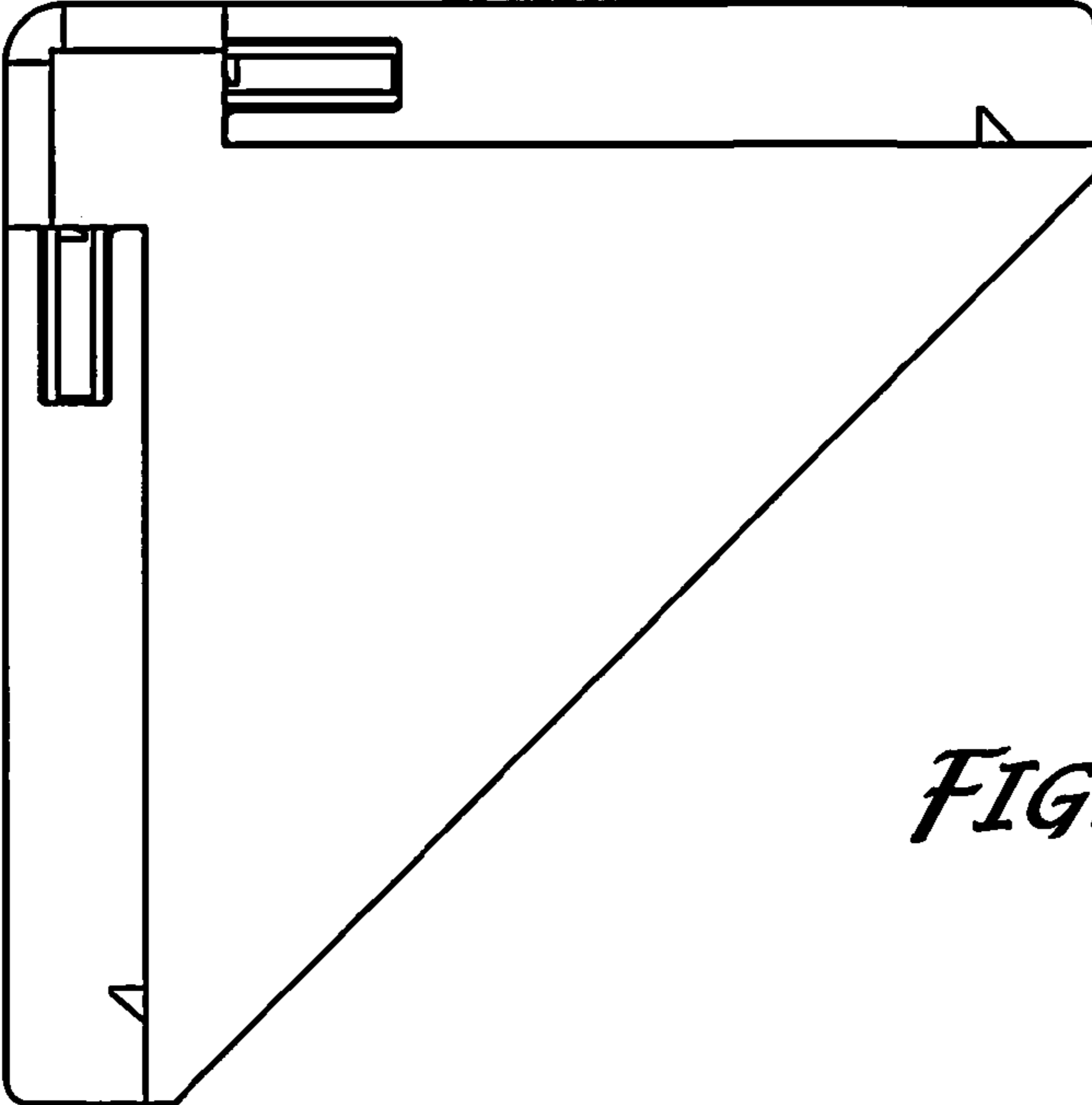

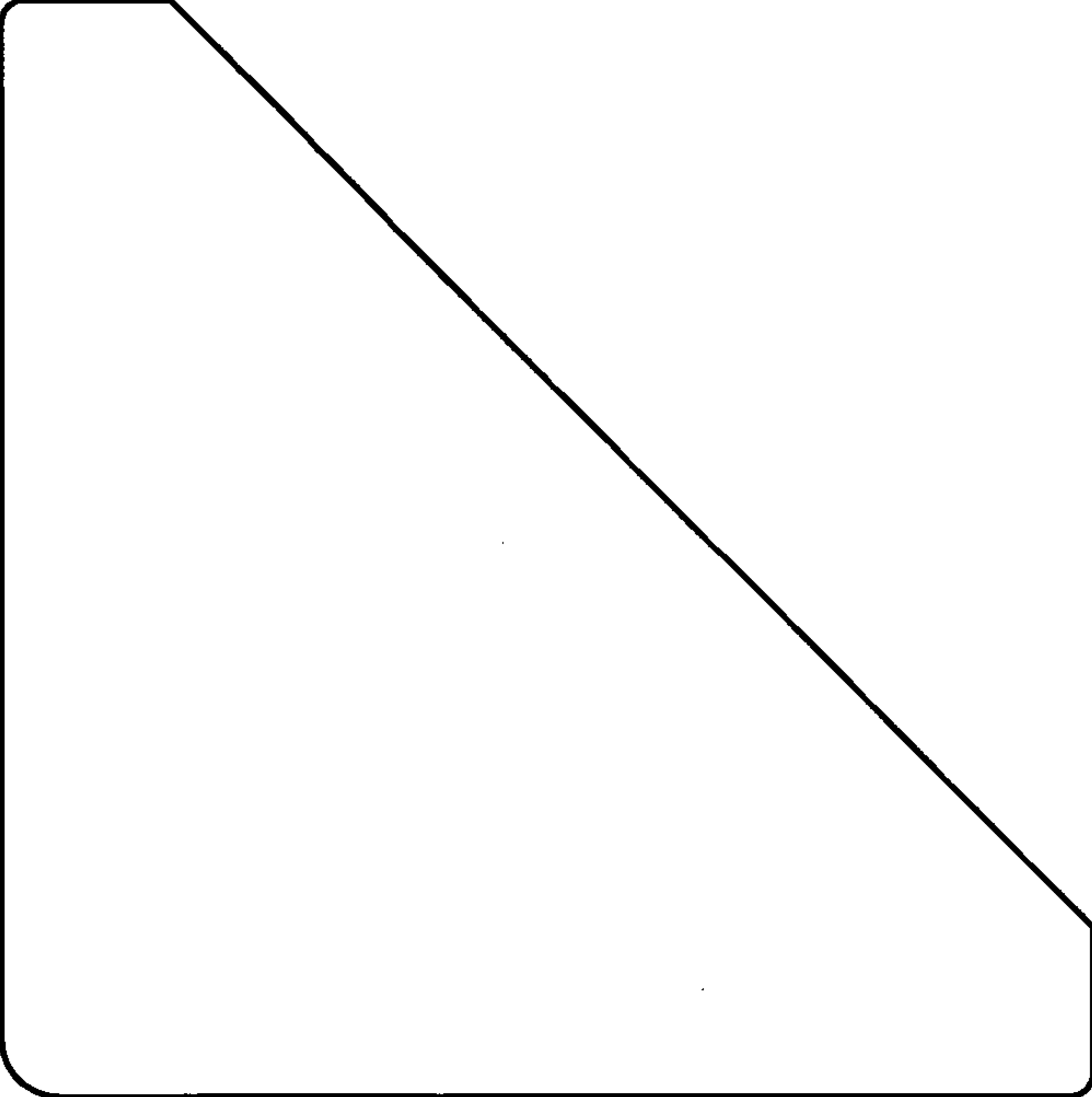

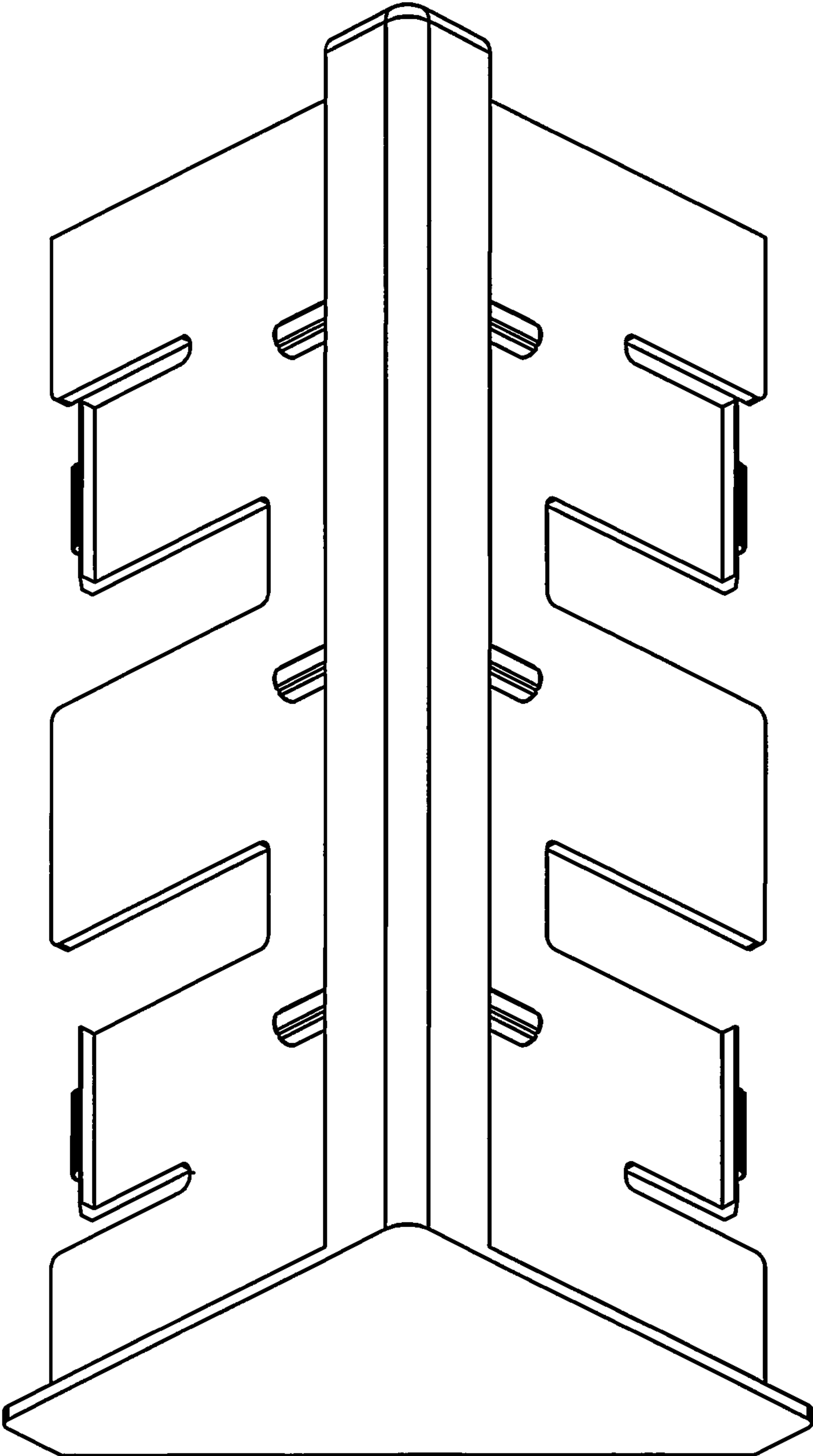
