(57) **CLAIM**

The ornamental design for a device for securing an ornamental element, substantially as shown and described.

DESCRIPTION

FIG. 1 is an isometric frontal view of a device for securing an ornamental element showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a top plan view thereof;

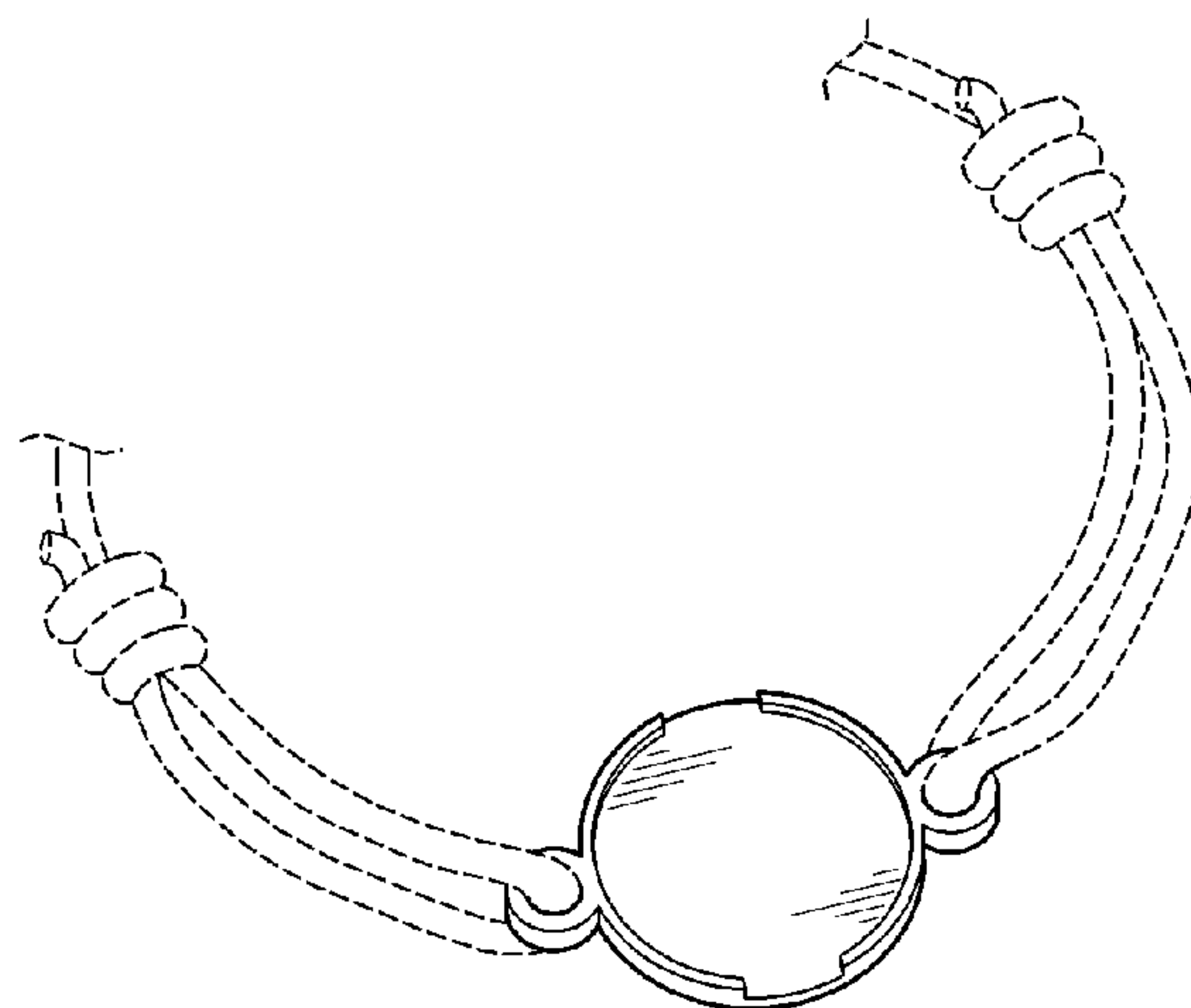
FIG. 5 is a right side elevational view thereof;

FIG. 6 is an isometric frontal view of the device when an ornamental element is inserted; and,

FIG. 7 is a close-up isometric frontal view of the device when an ornamental element is inserted.

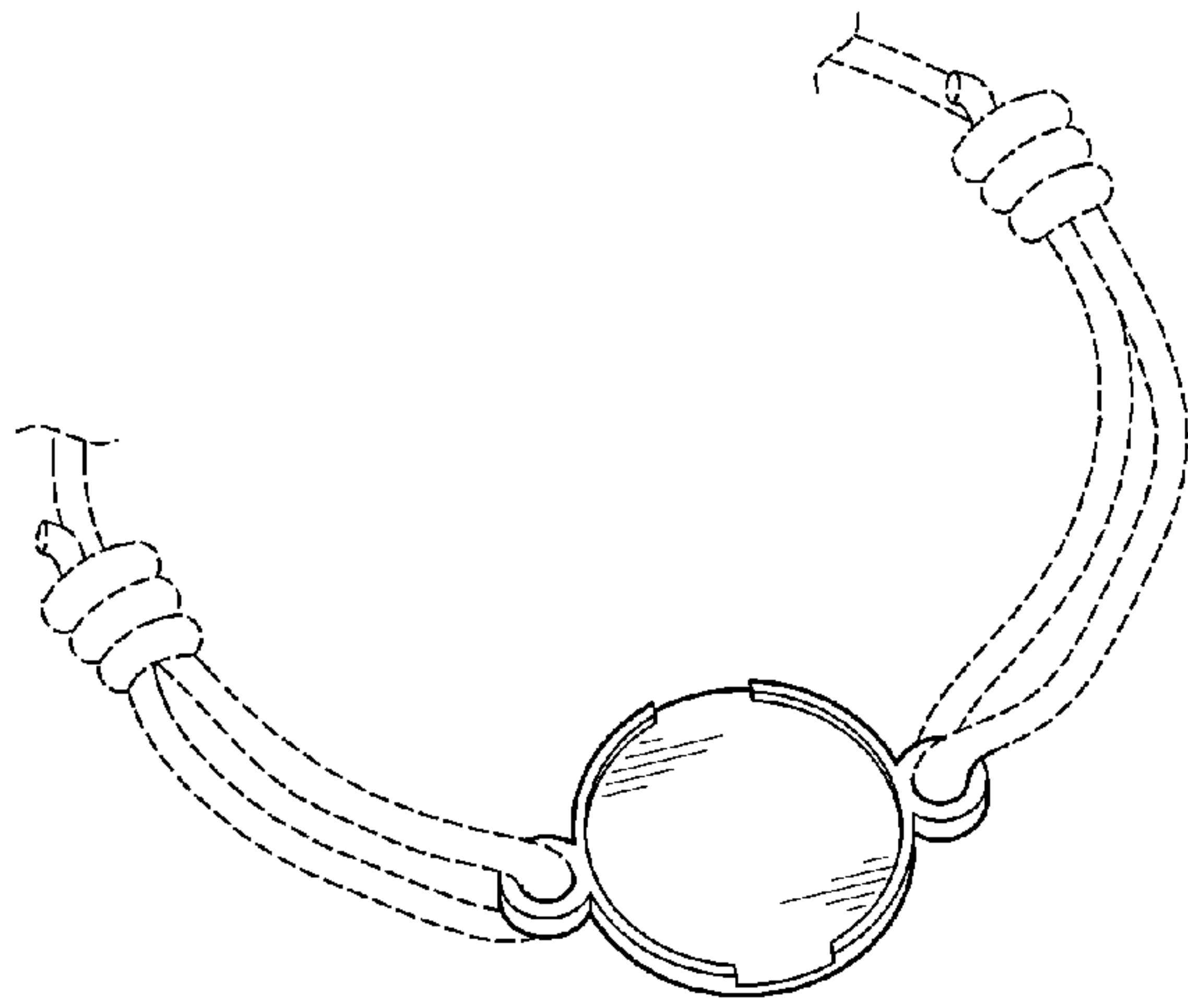

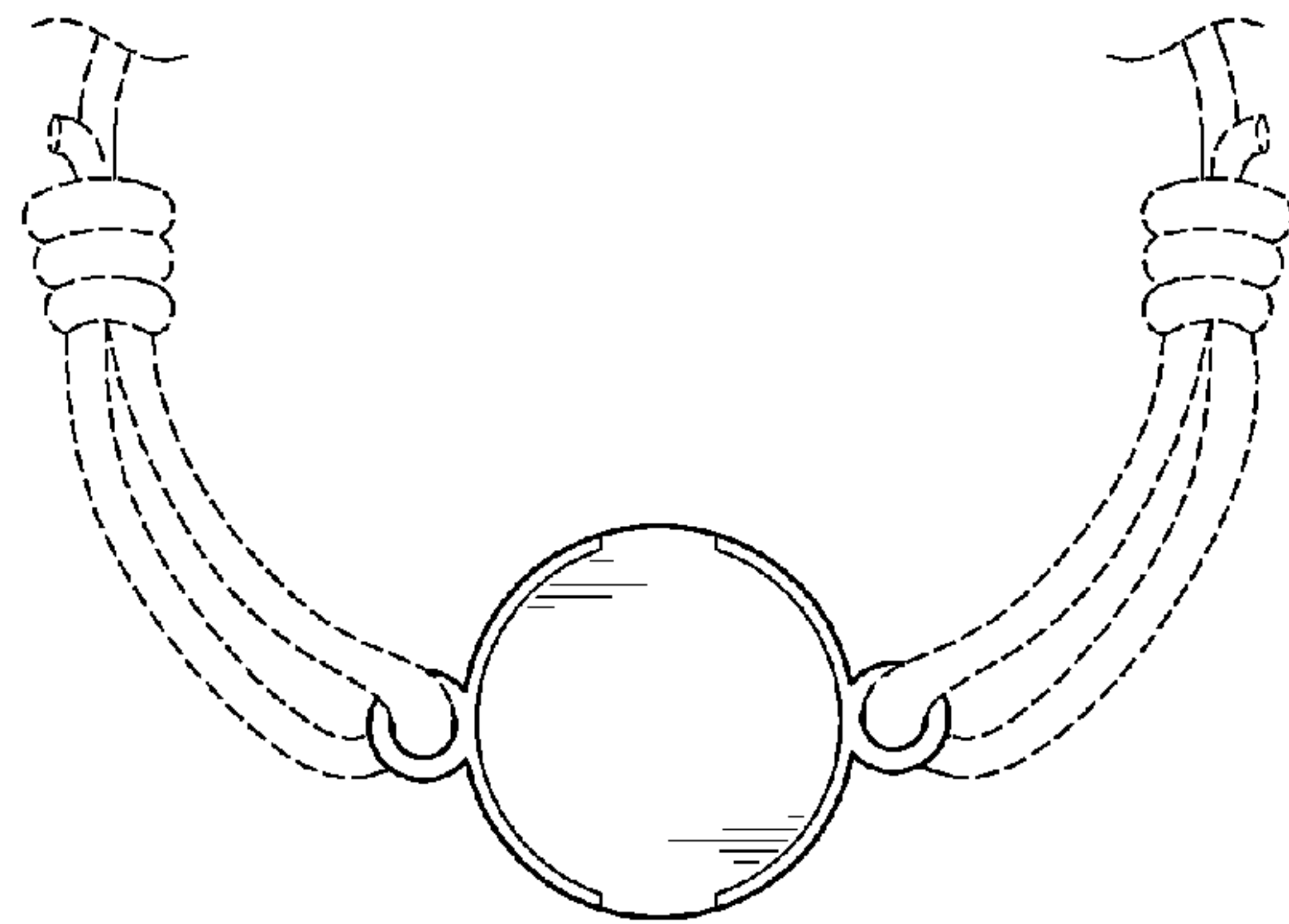

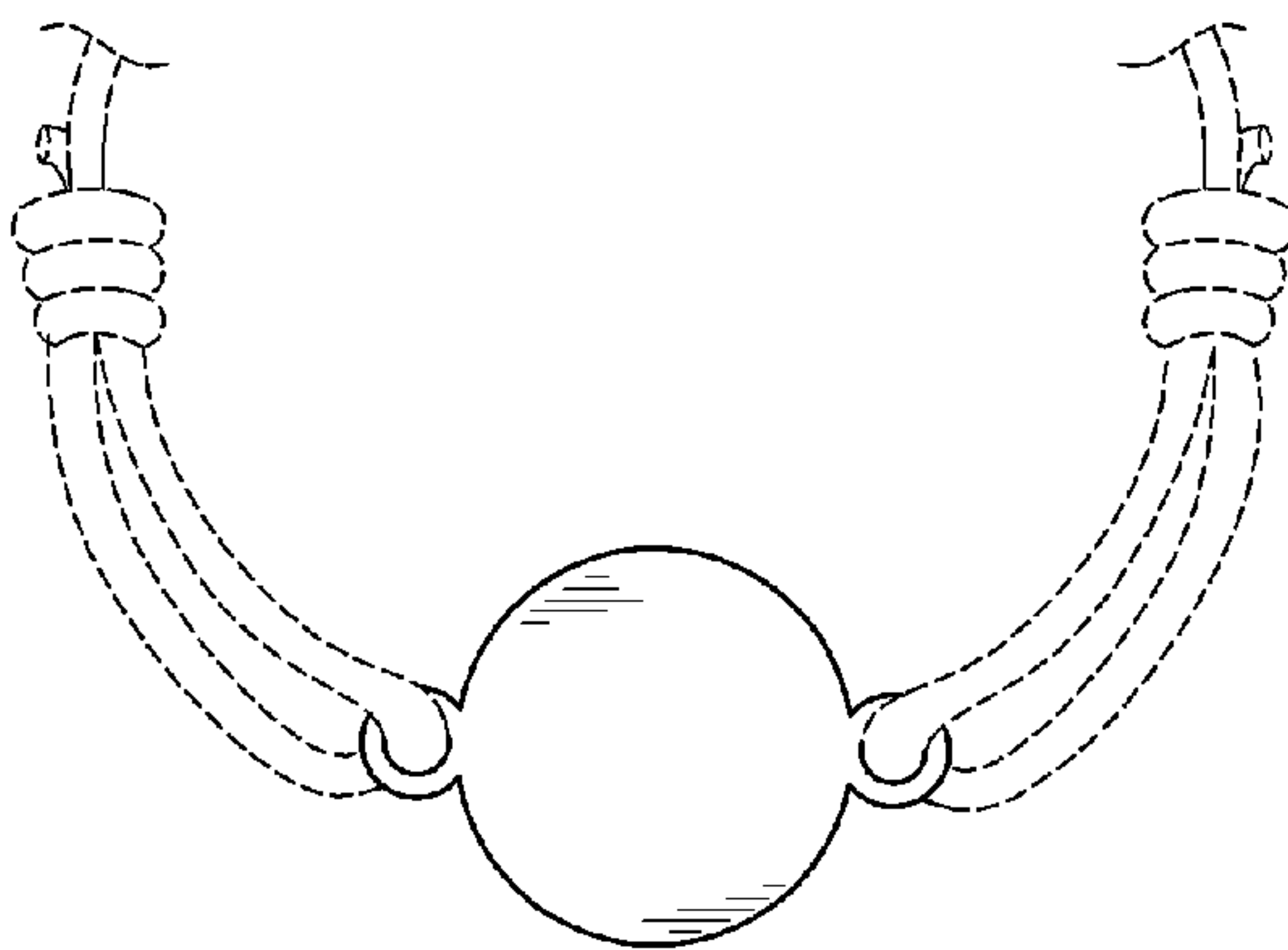

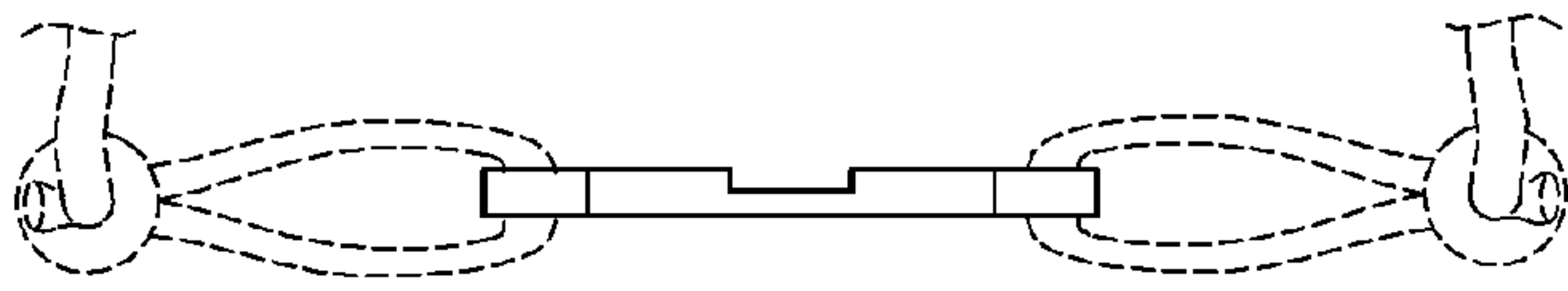

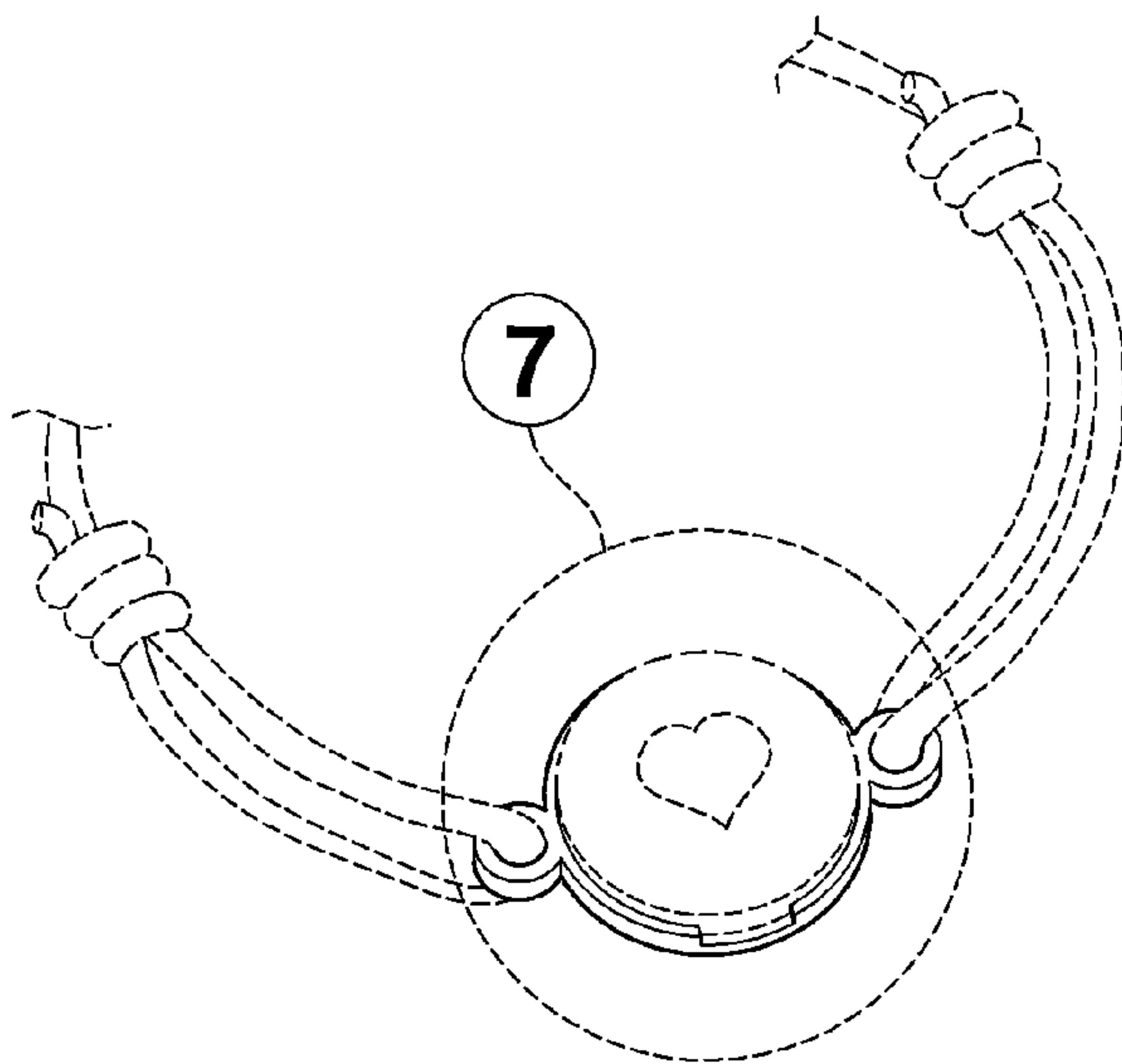

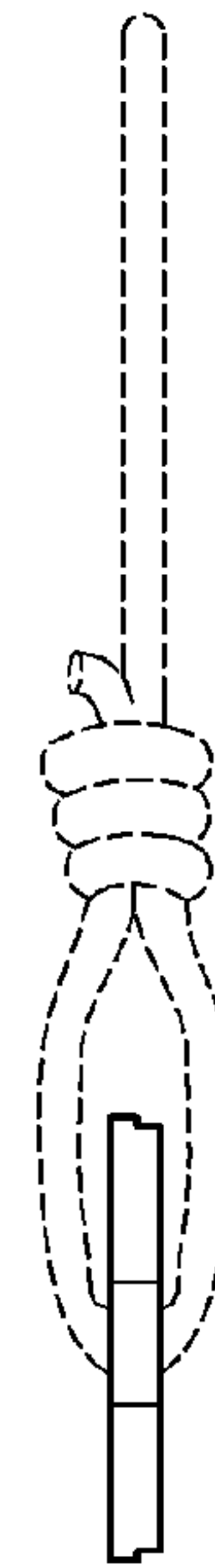

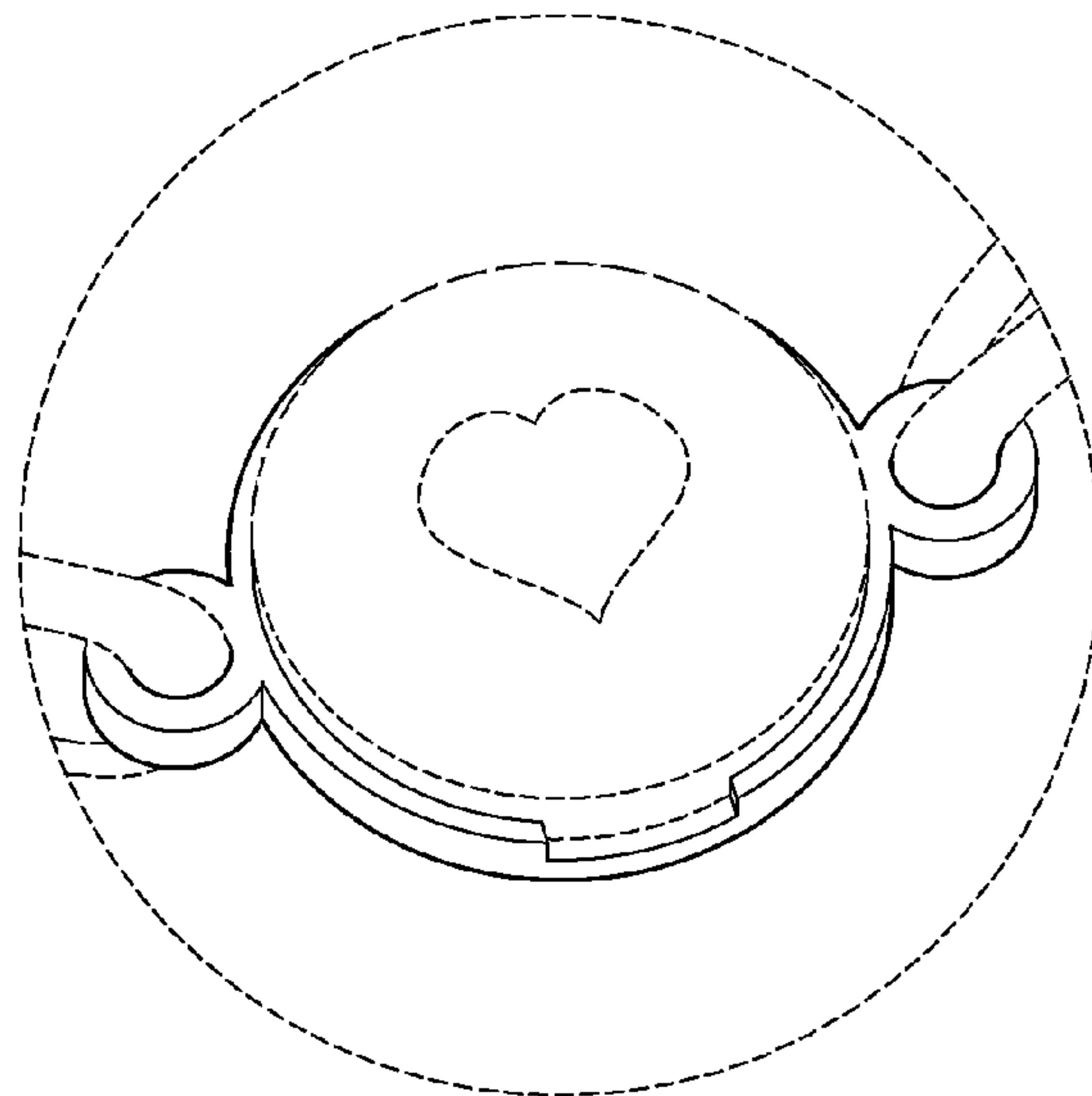
