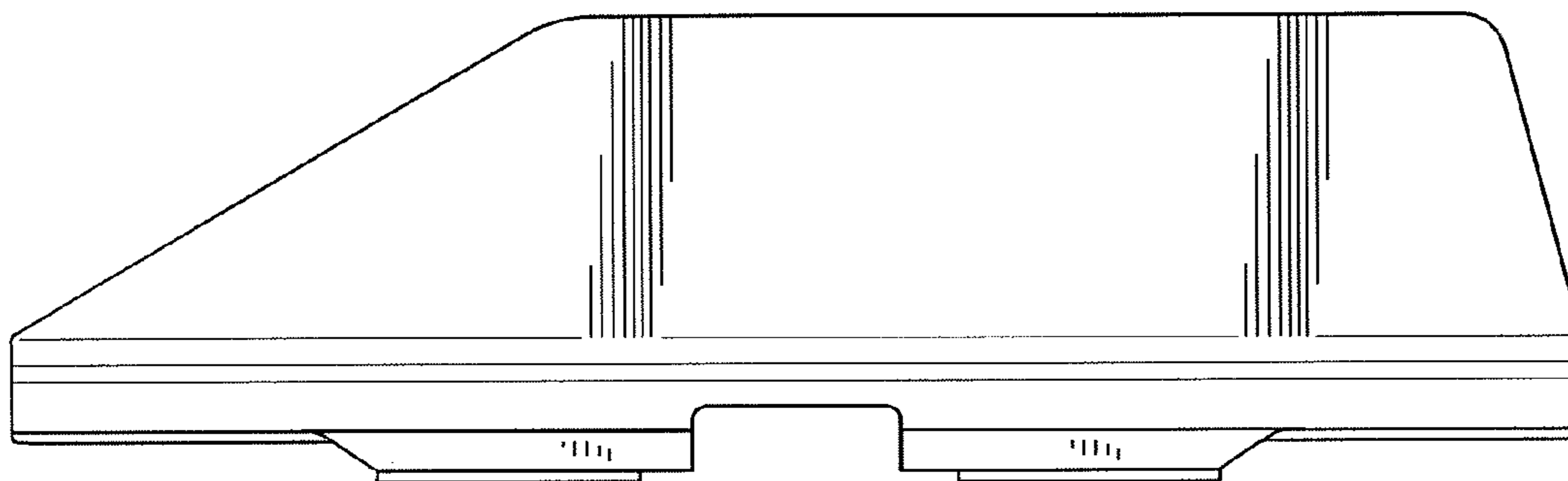
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of a rear floorboard exhaust guard showing my new design;

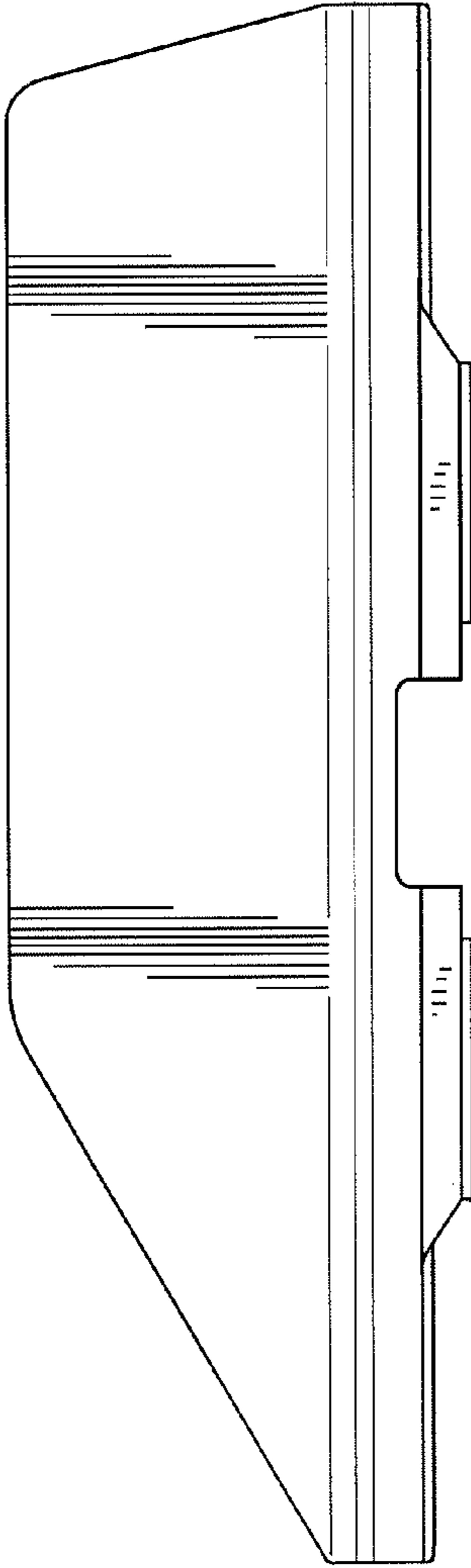

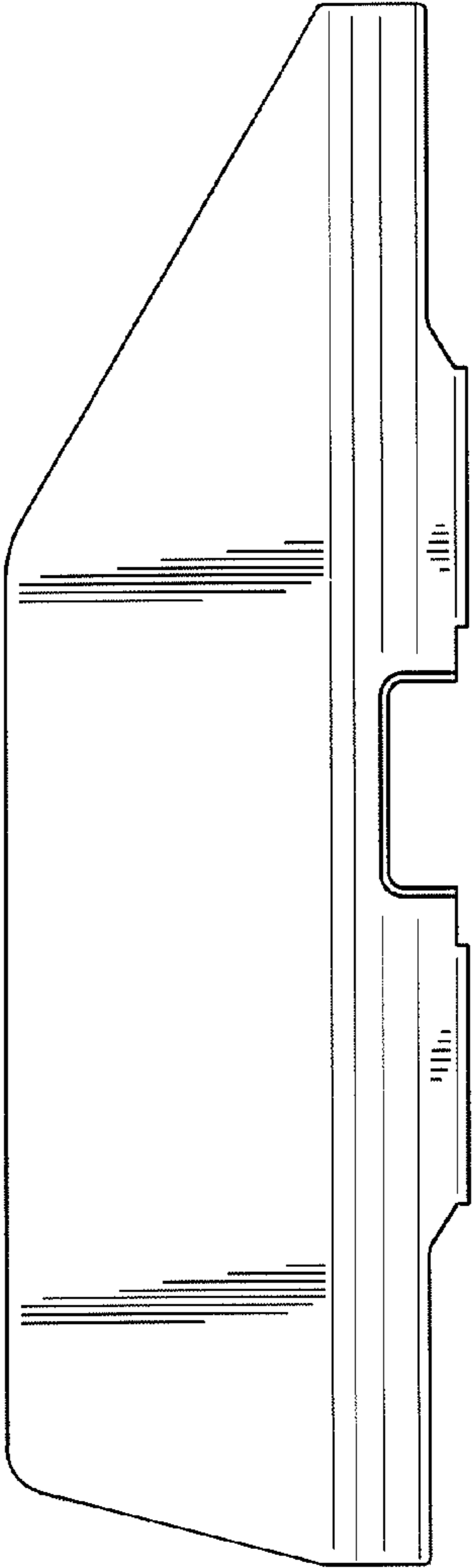

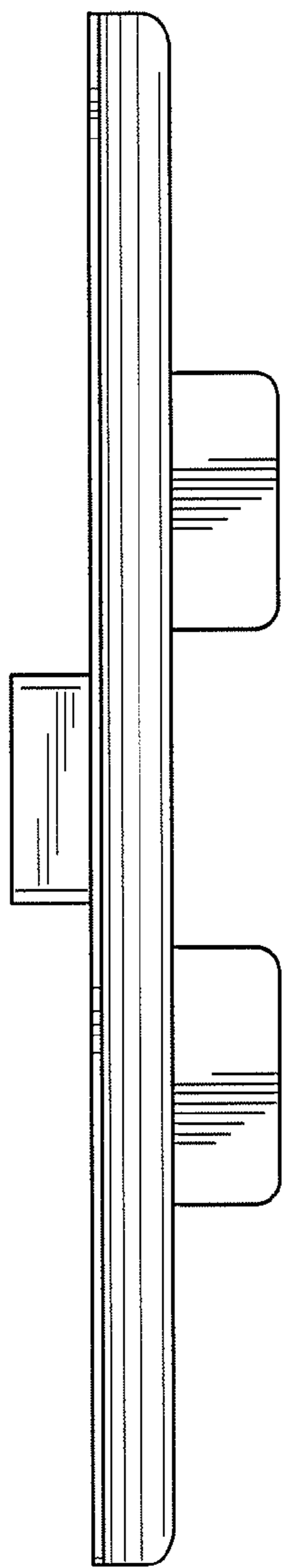

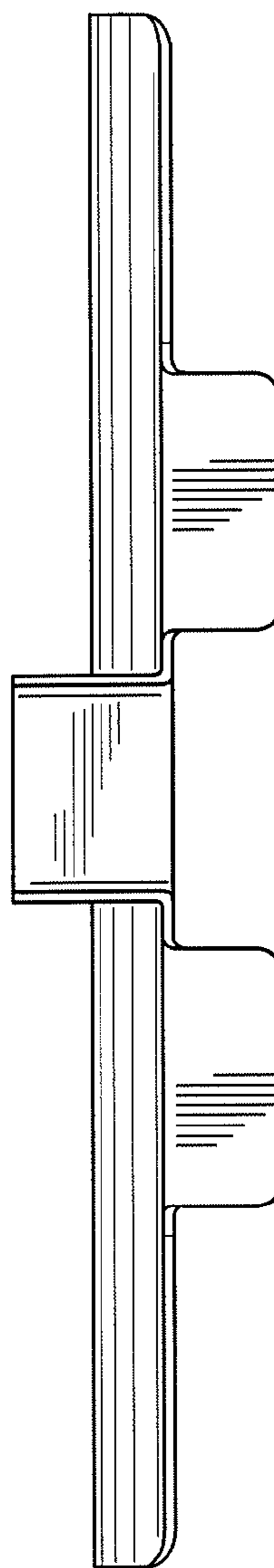

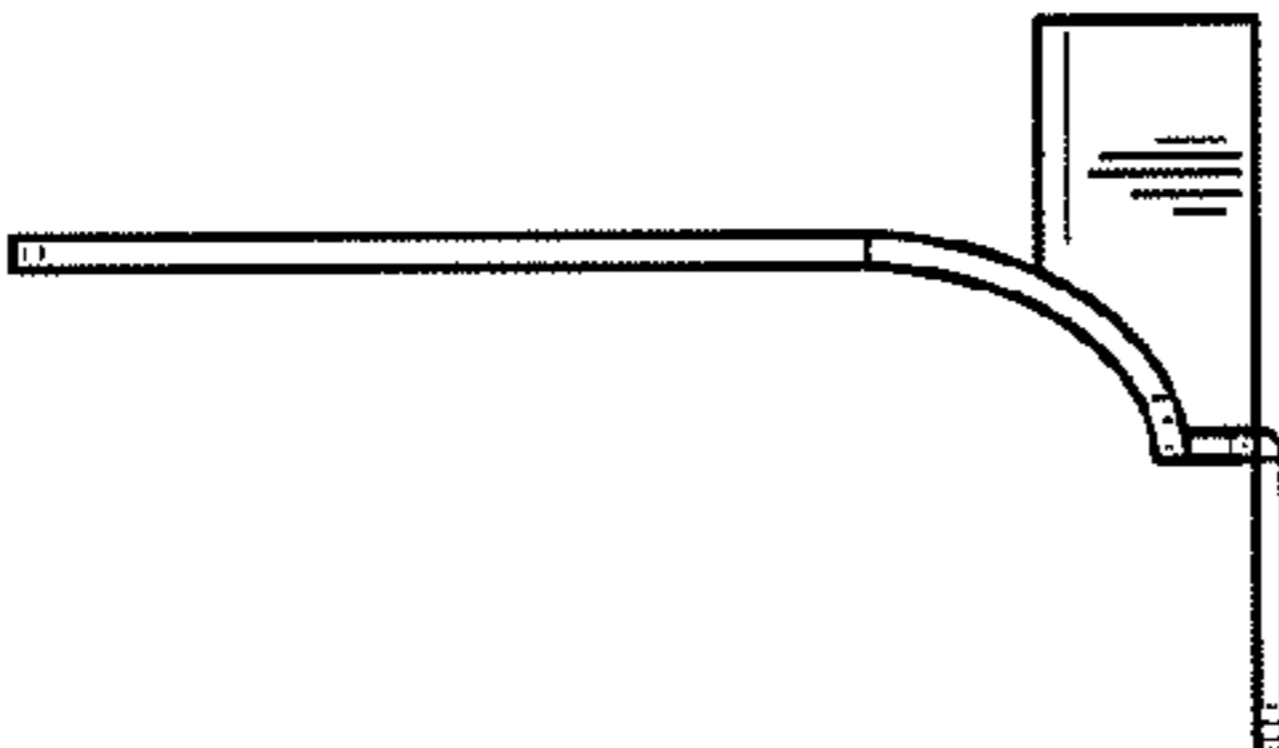

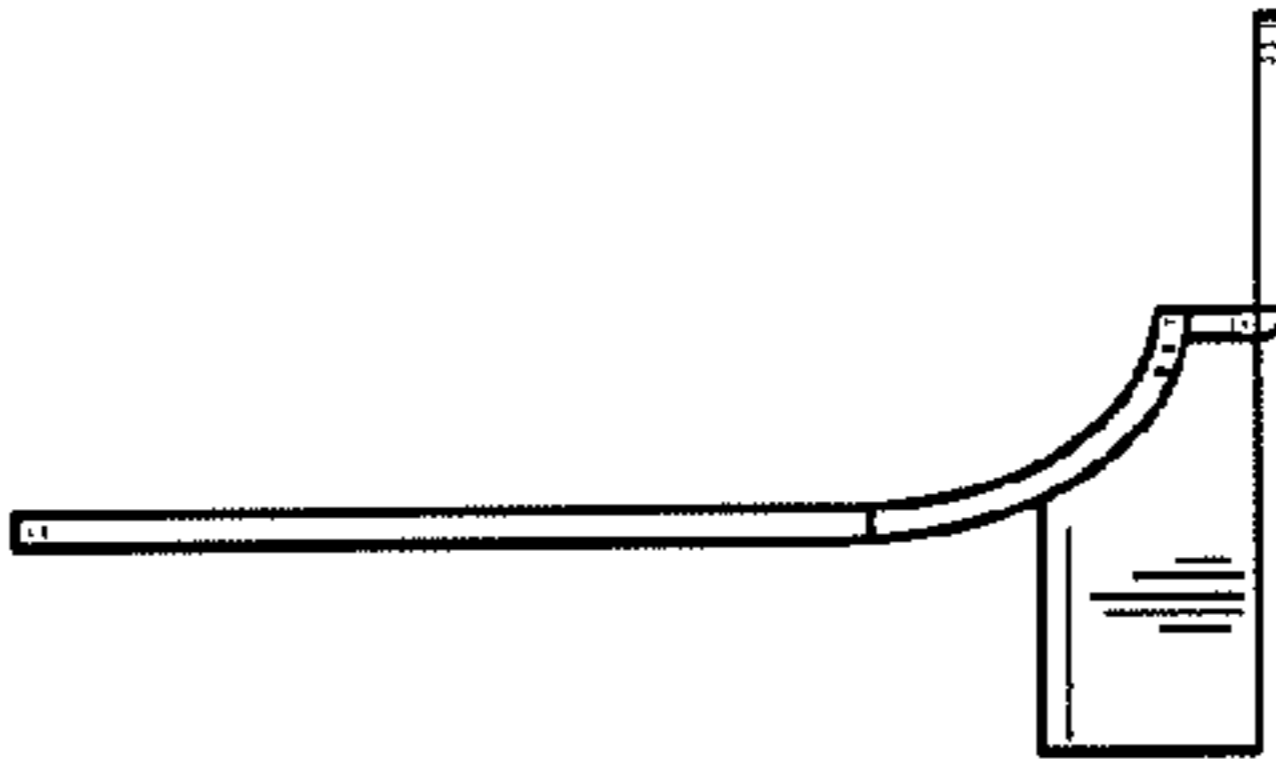

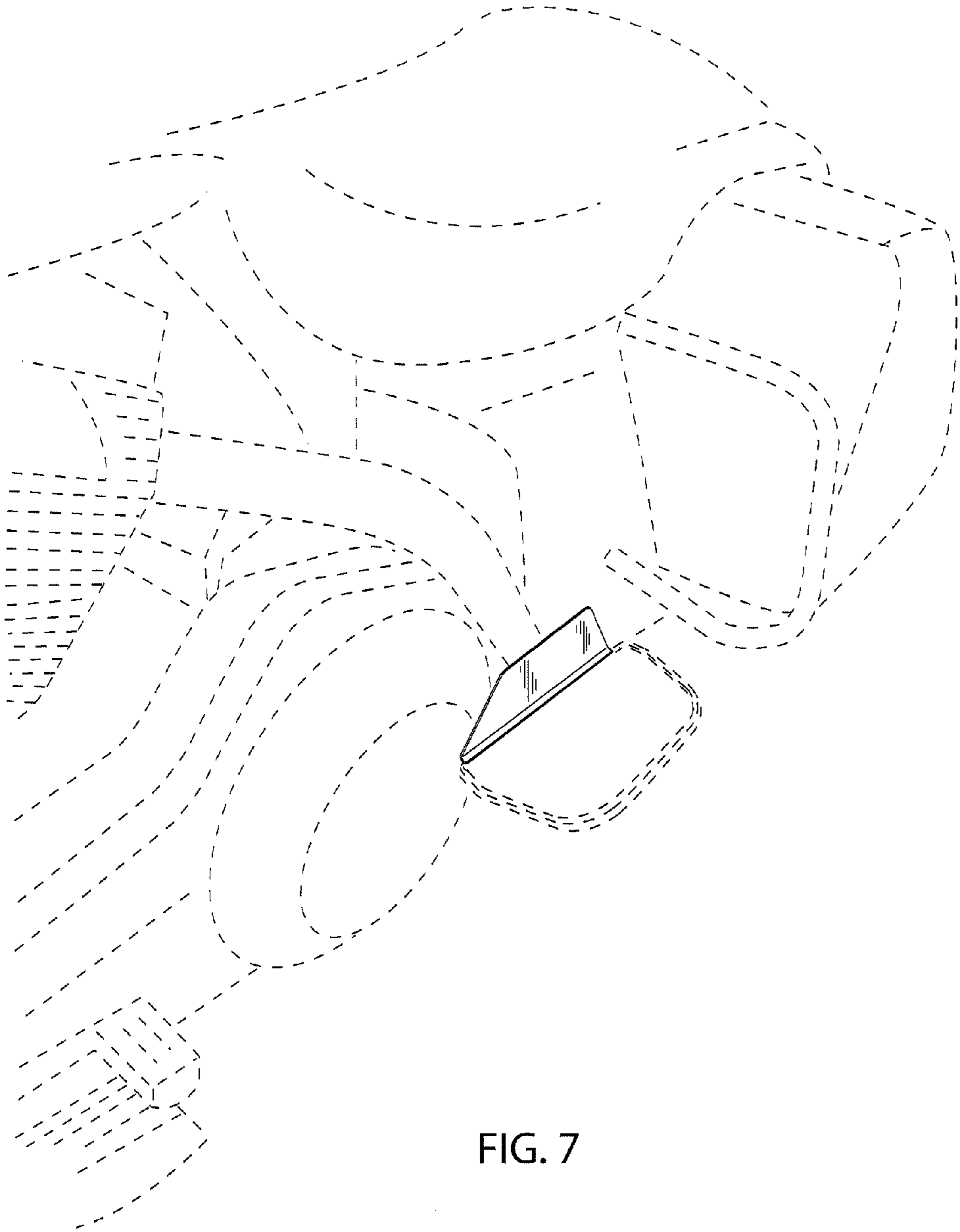
