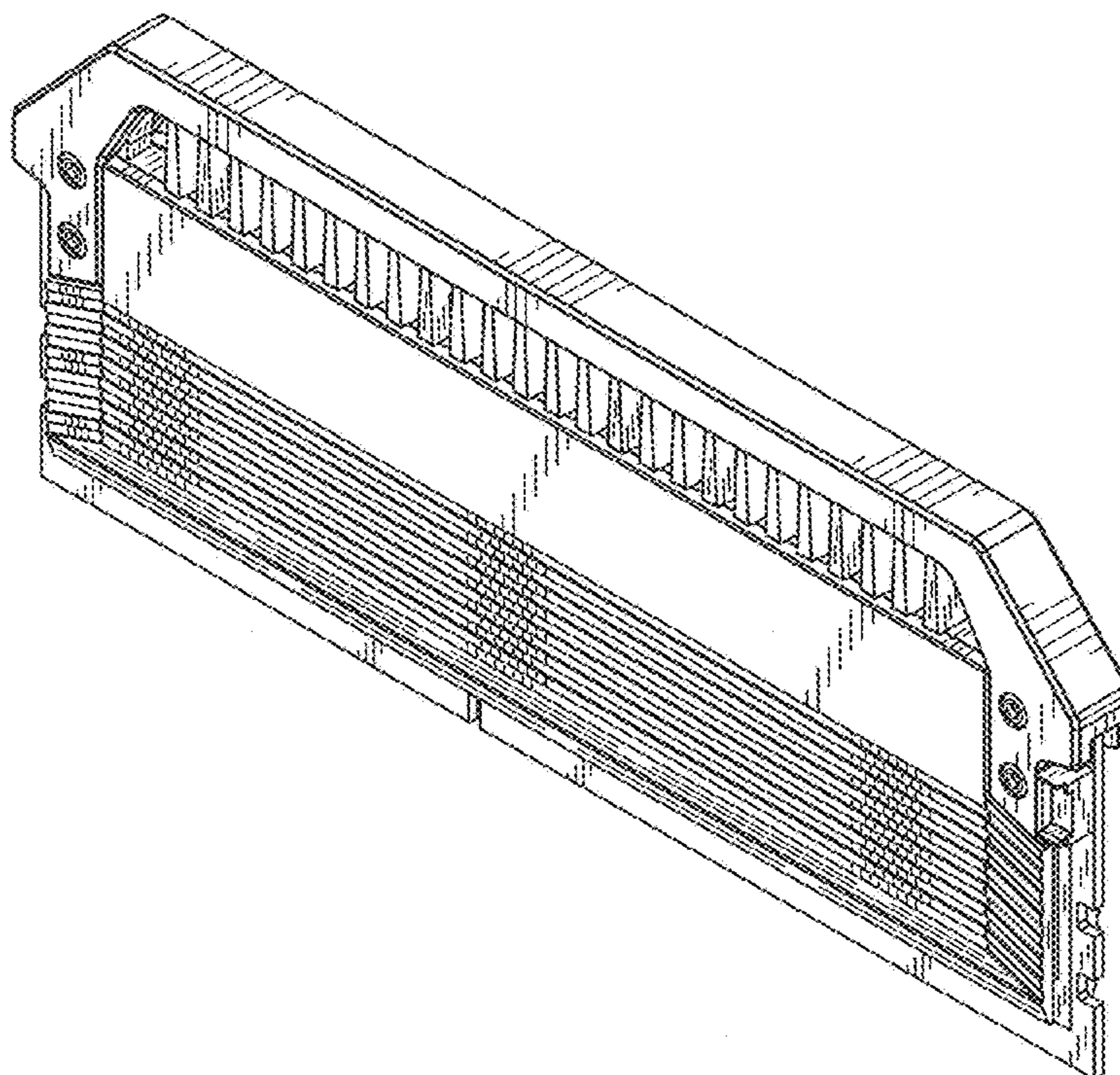
(57) **CLAIM**

The ornamental design for a heat spreader with fins and top bar on a memory module, as shown and described.

DESCRIPTION

FIG. 1 is a front right side perspective view of a heat spreader on a memory module showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof; and,
FIG. 7 is a right side view thereof.
The shade lines in the figures show contour and not surface ornamentation.

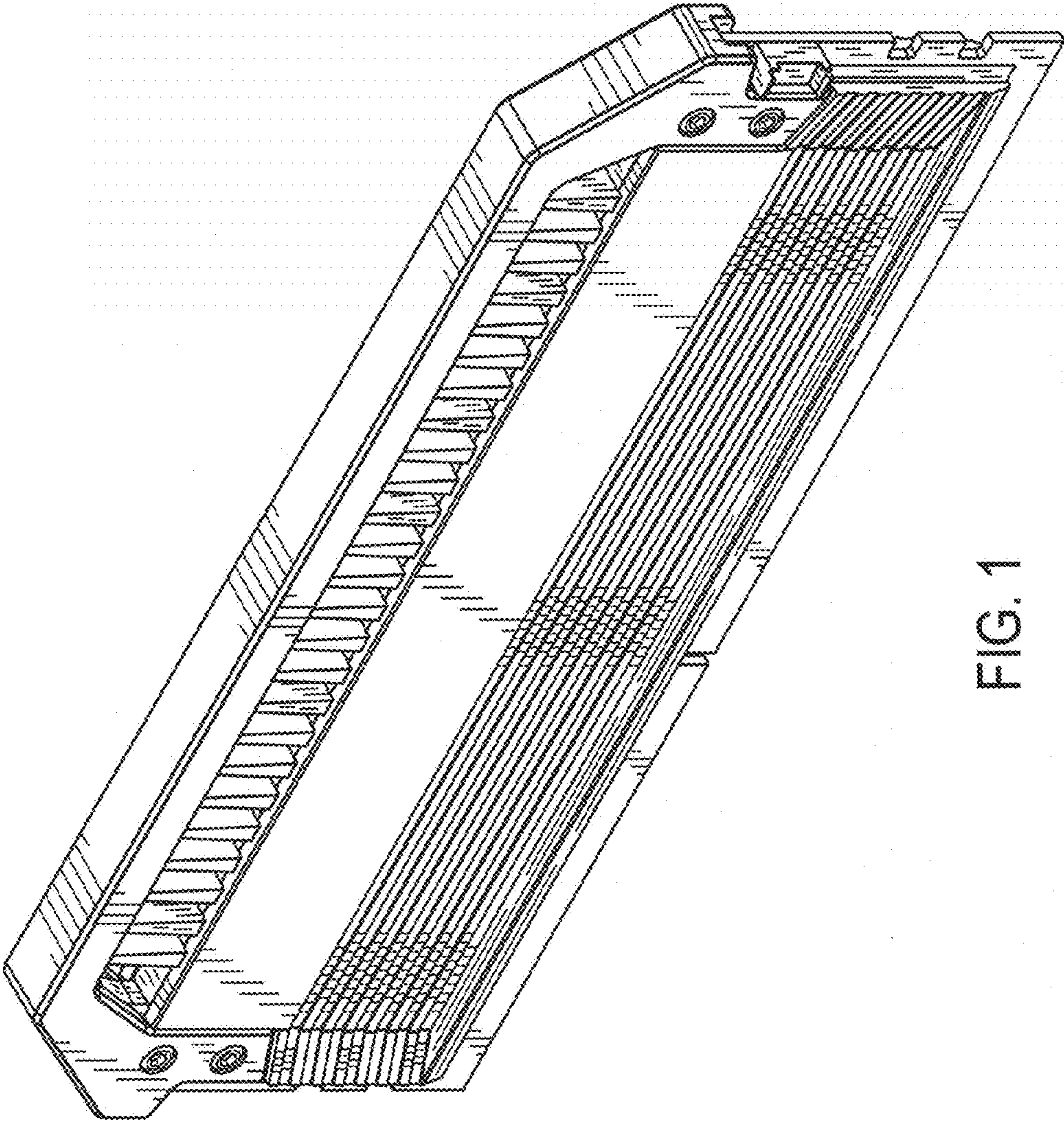

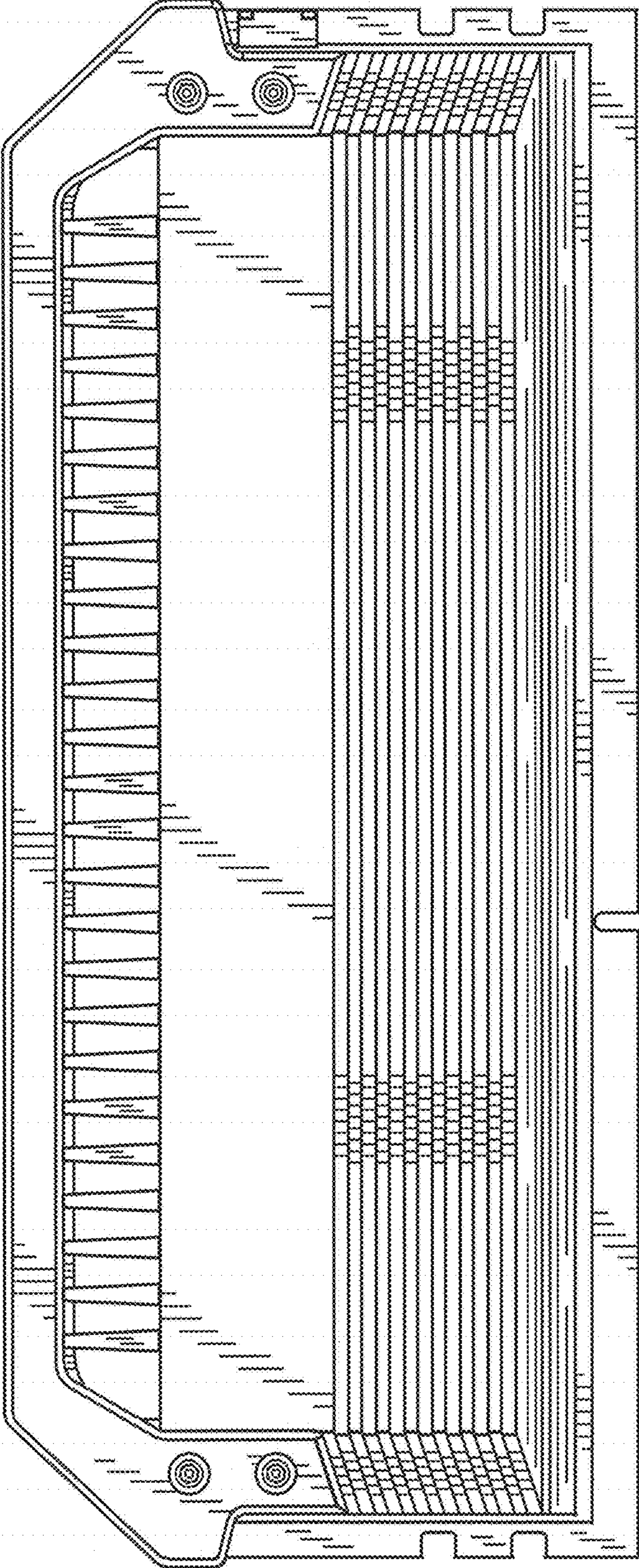

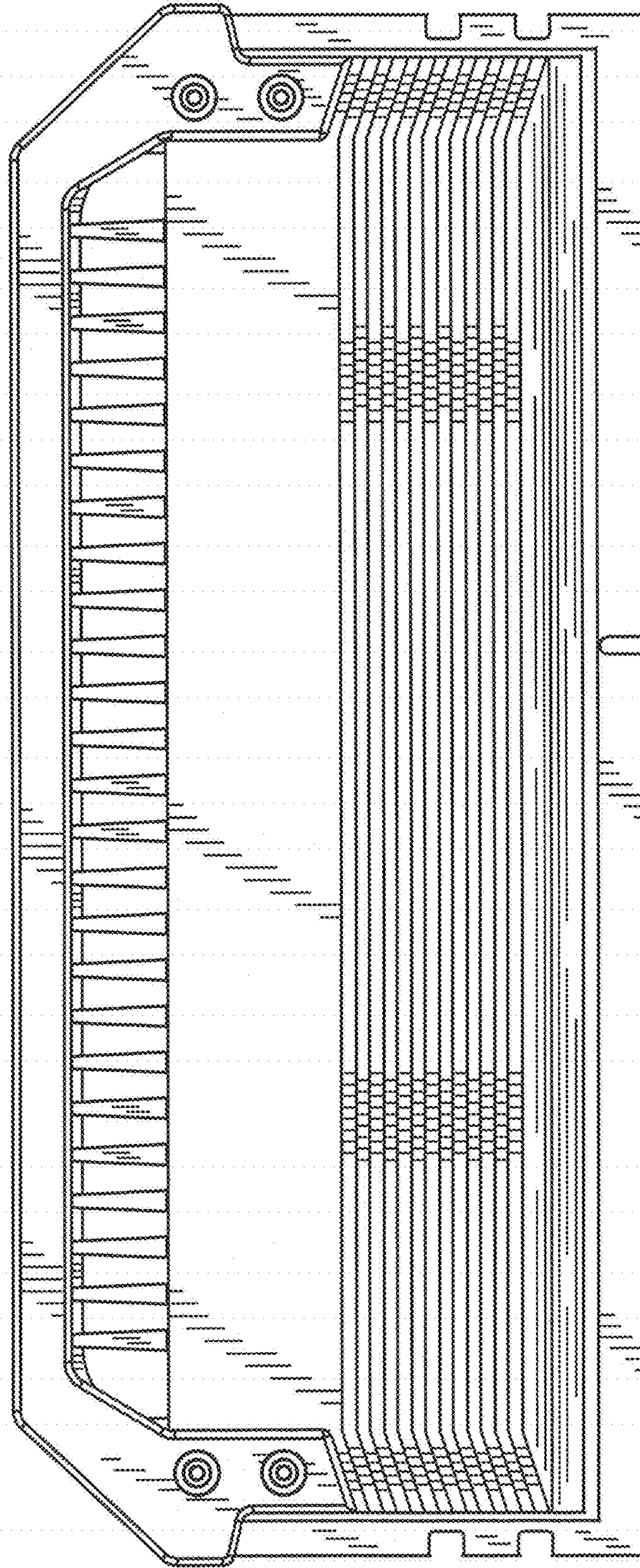

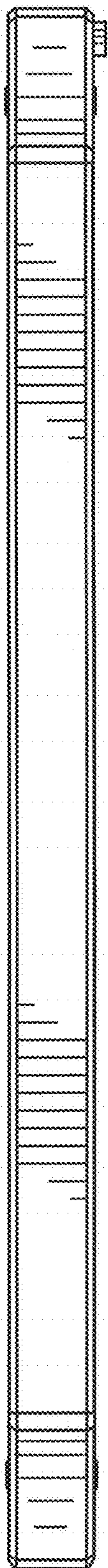

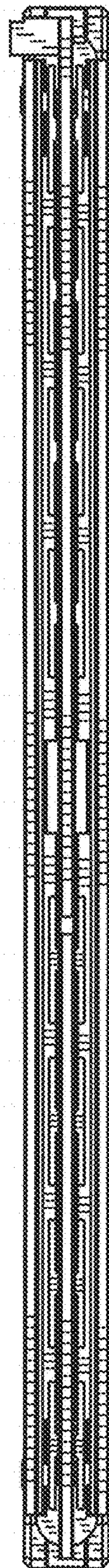

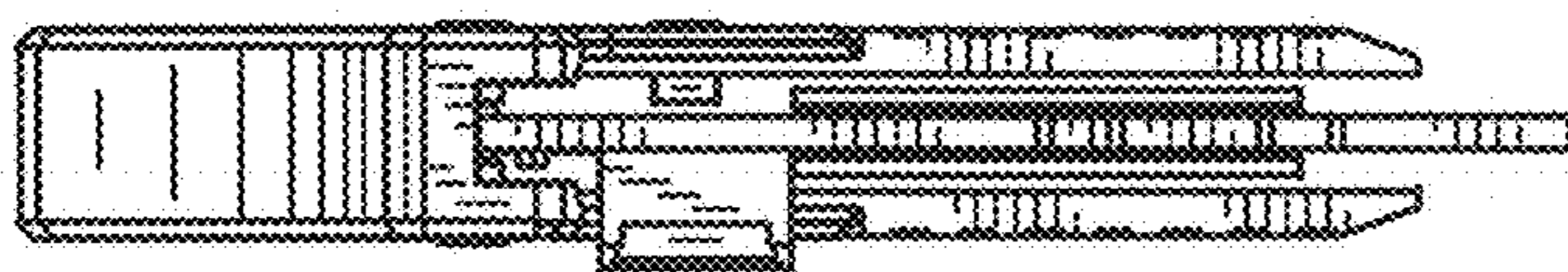

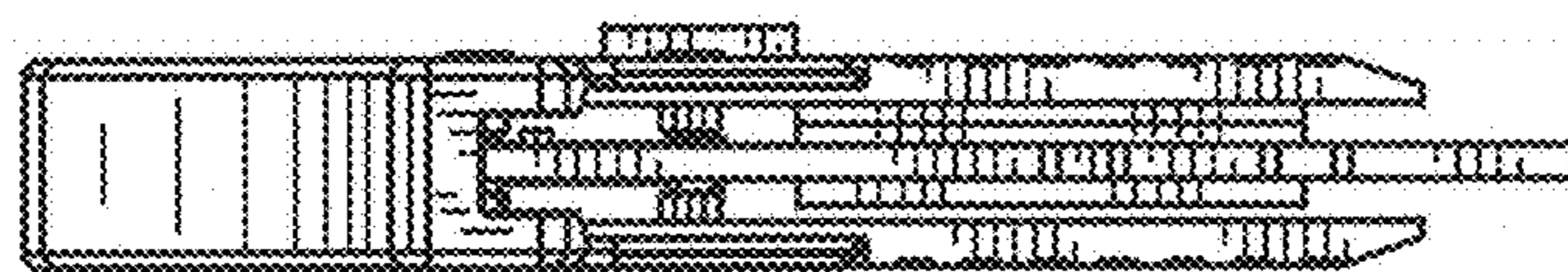
