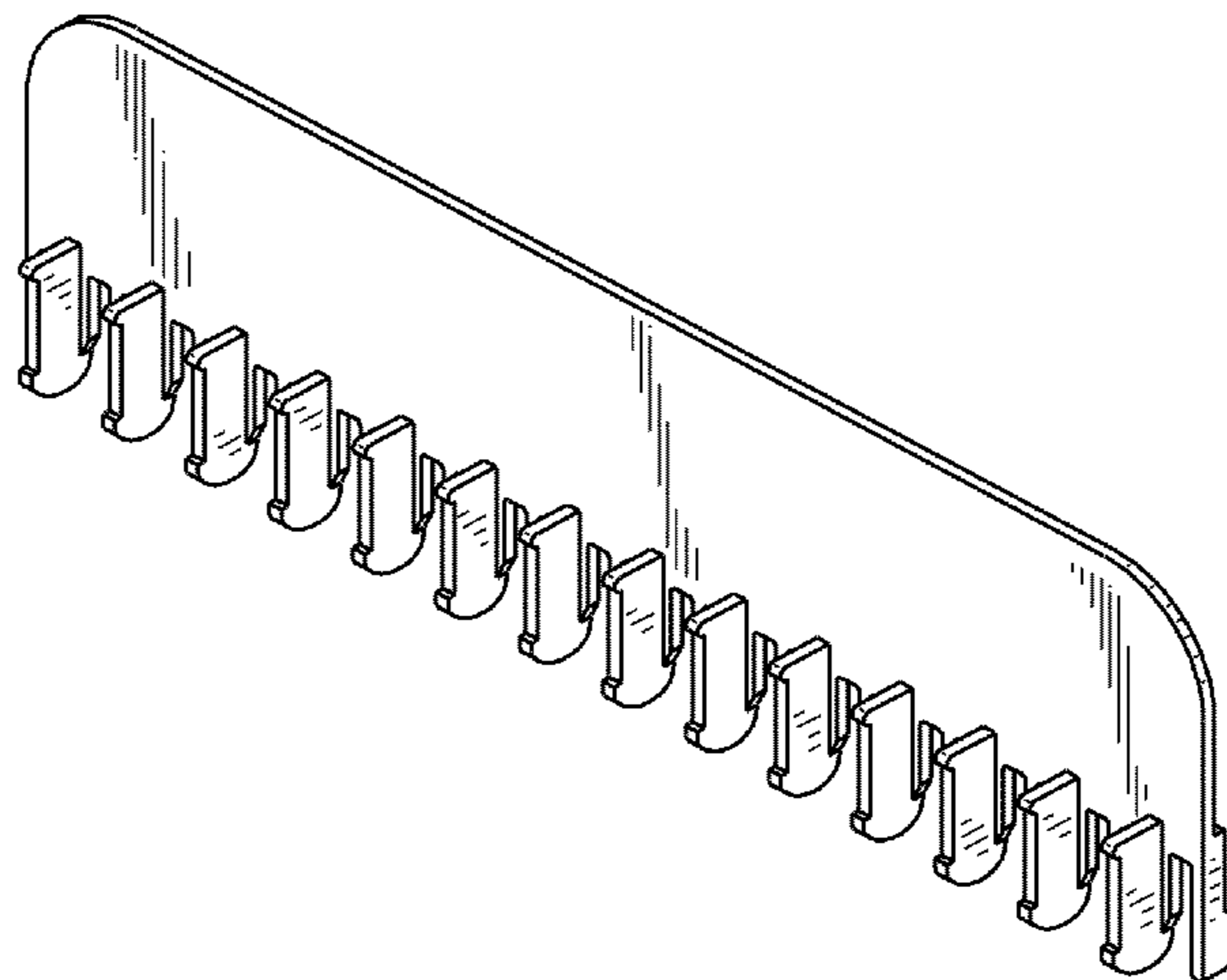
(57) **CLAIM**

I claim the ornamental design for a purse loom, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a purse loom showing our new design;
FIG. 2 is Fin-side (Front) view thereof;
FIG. 3 is a Hook-side (Rear) view thereof;
FIG. 4 is a first end (Right) view thereof;
FIG. 5 is second end (Left) view thereof;
FIG. 6 is a hand grip (Top) view thereof; and,
FIG. 7 is a working view (Bottom) view thereof.

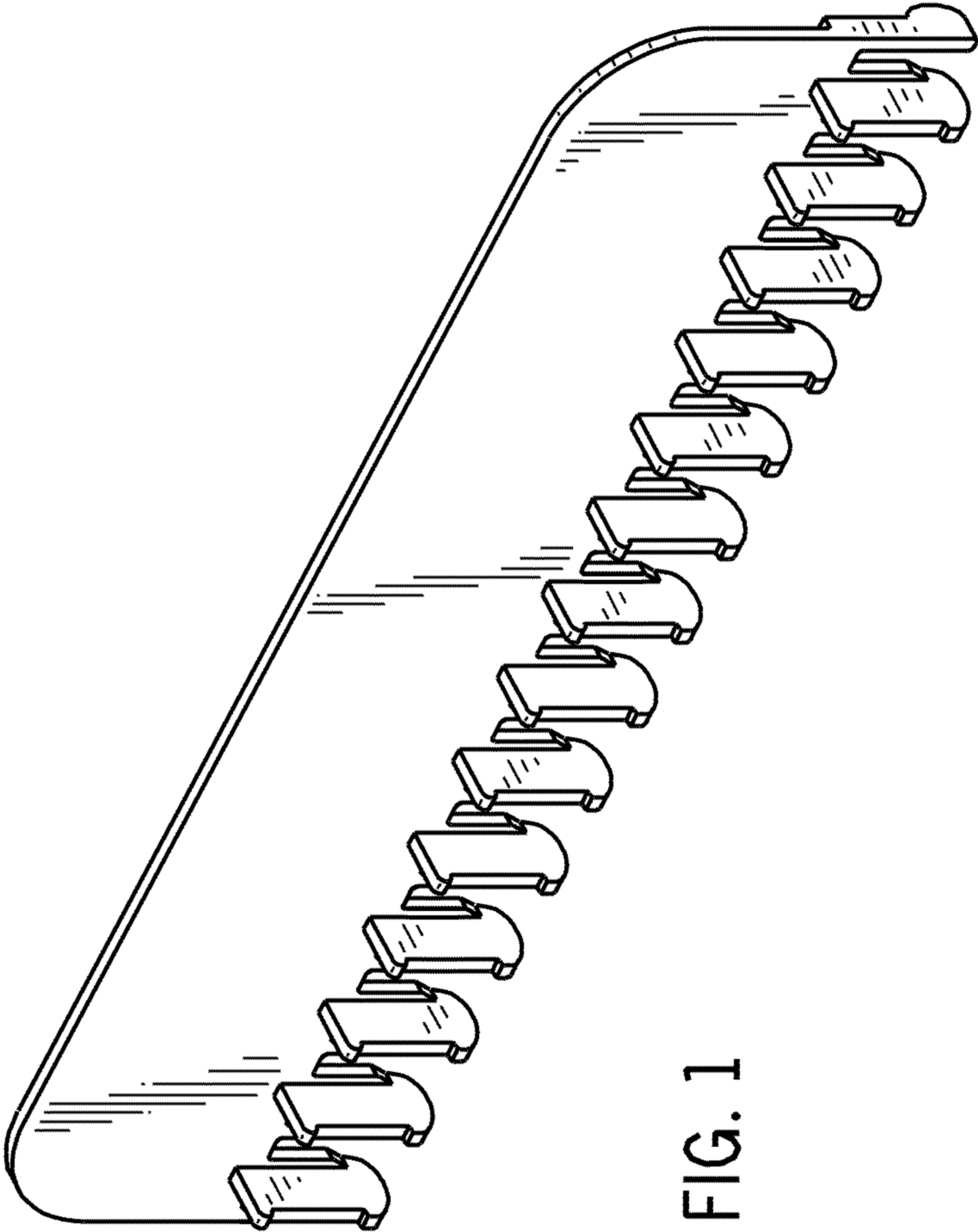

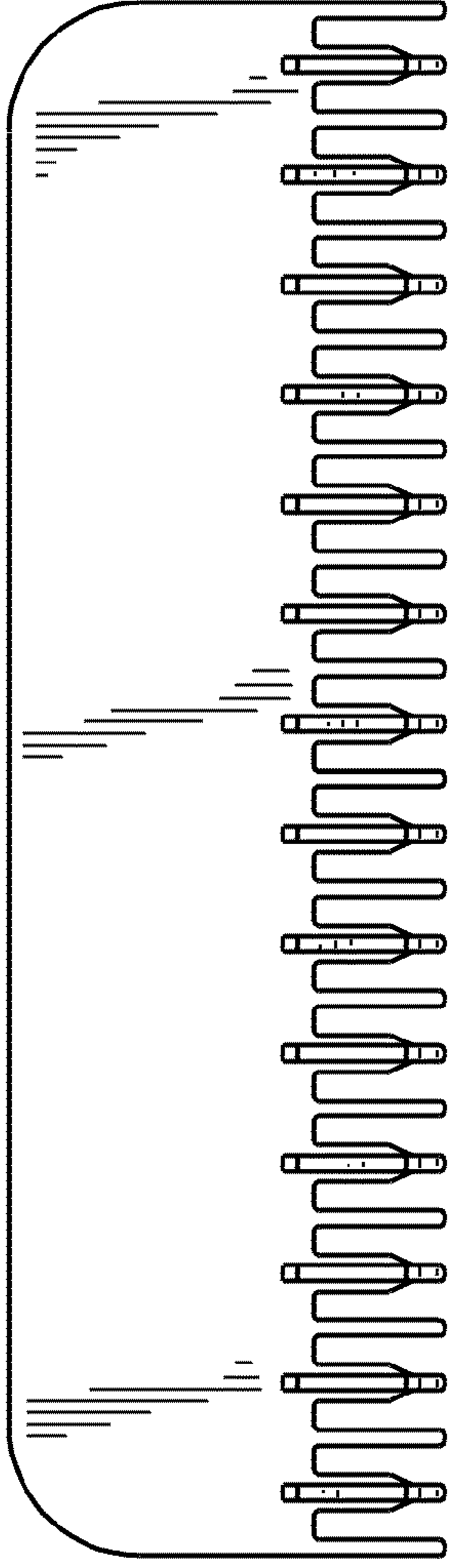

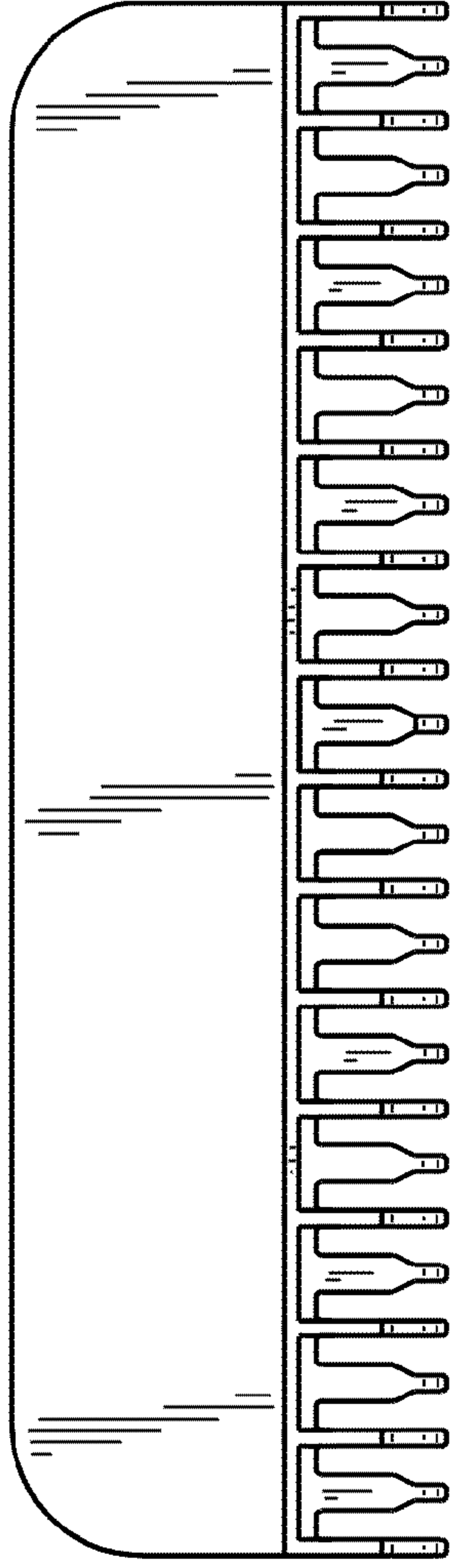

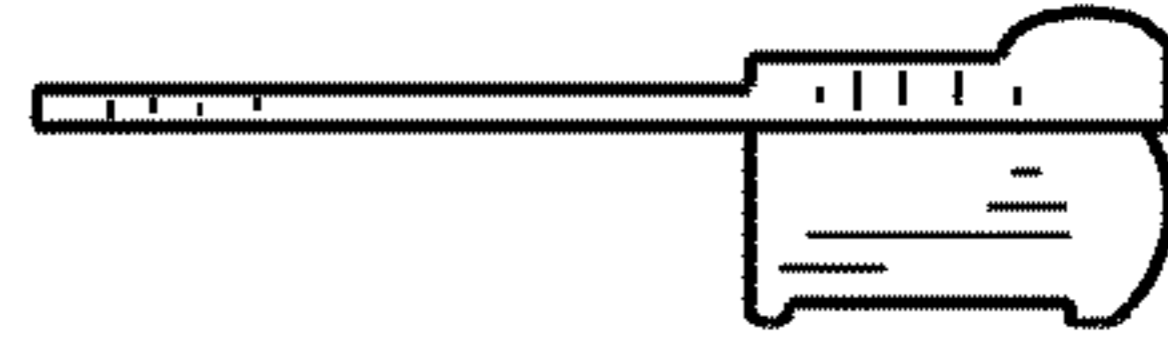

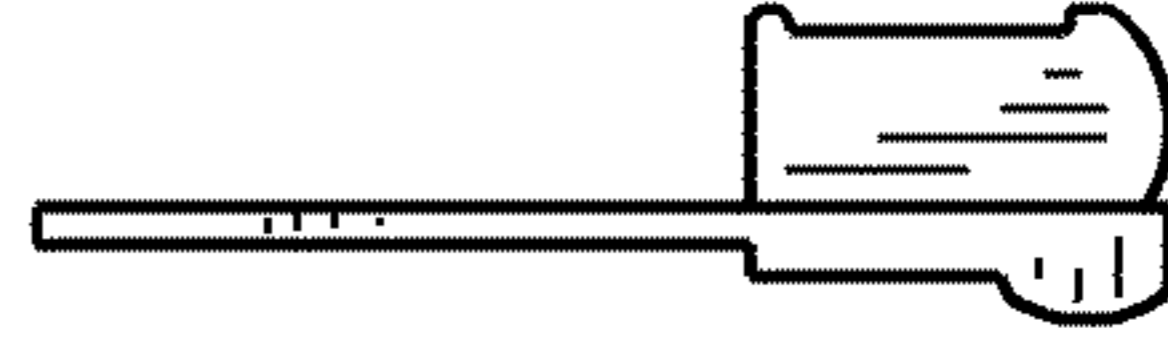

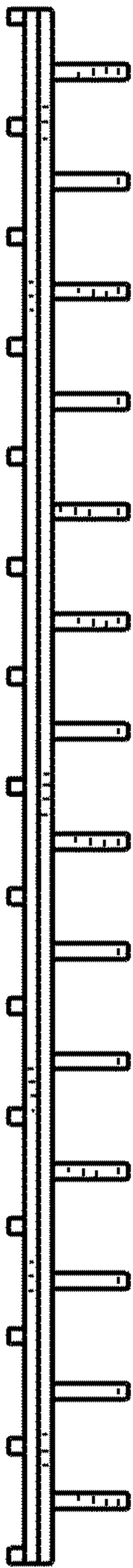

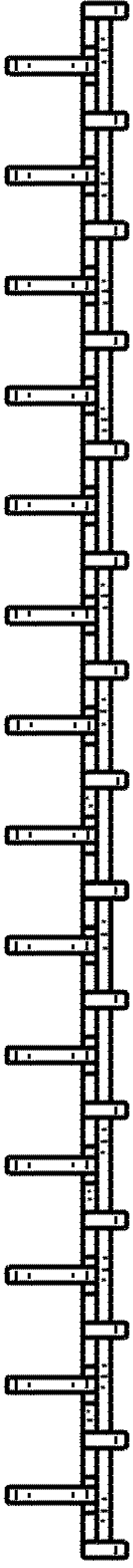
