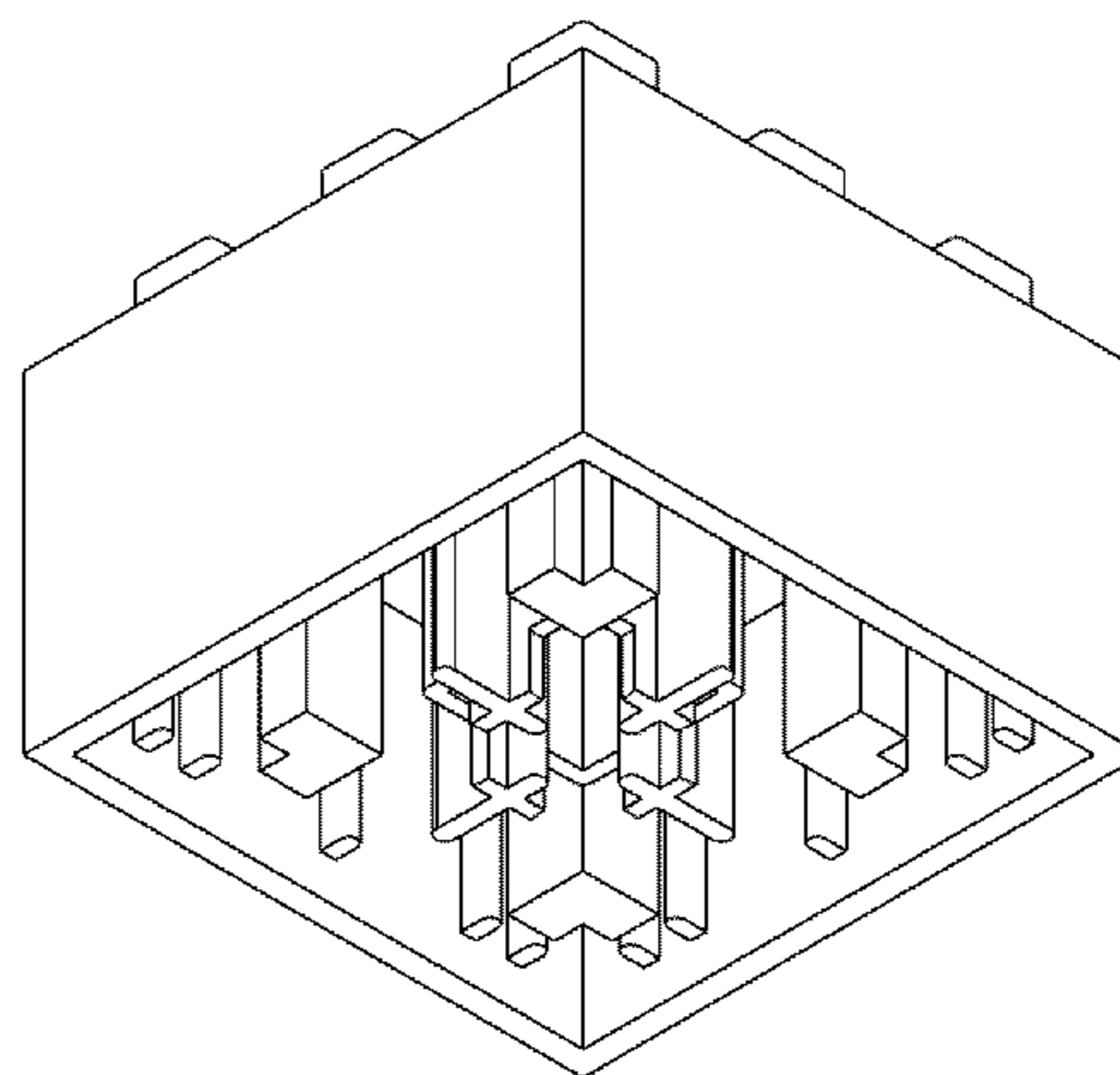
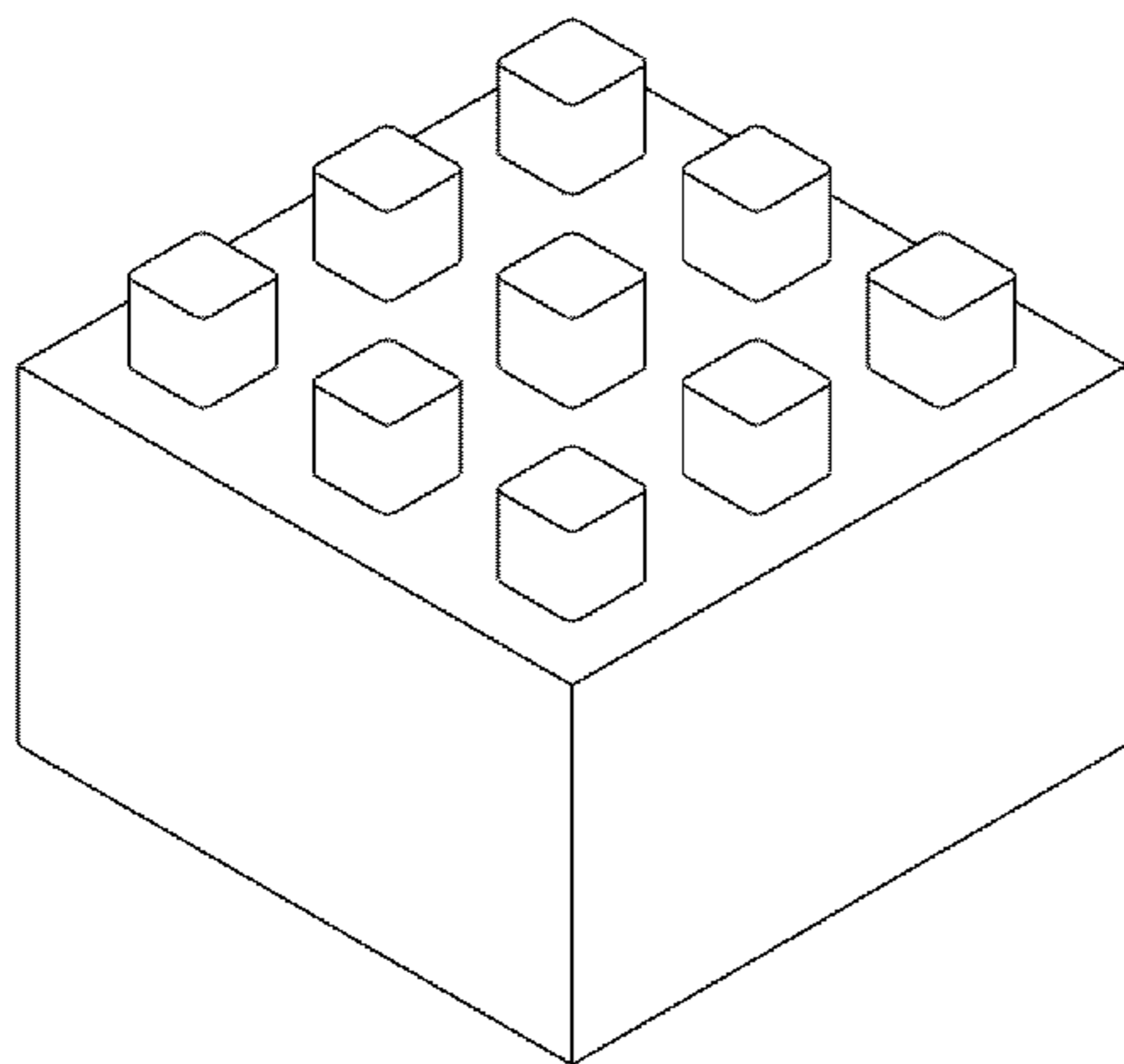
(57) **CLAIM**

The ornamental design for a building block, as shown and described.

**DESCRIPTION**

FIG. 1 shows a top plan view of a building block.  
FIG. 2 shows a front elevation view thereof, the rear elevation and side elevation views being identical.  
FIG. 3 shows a bottom plan view thereof.  
FIG. 4 shows a top and side perspective view thereof, the reverse top and side view being identical; and,  
FIG. 5 shows a bottom and side perspective view thereof, the reverse bottom and side view being identical.

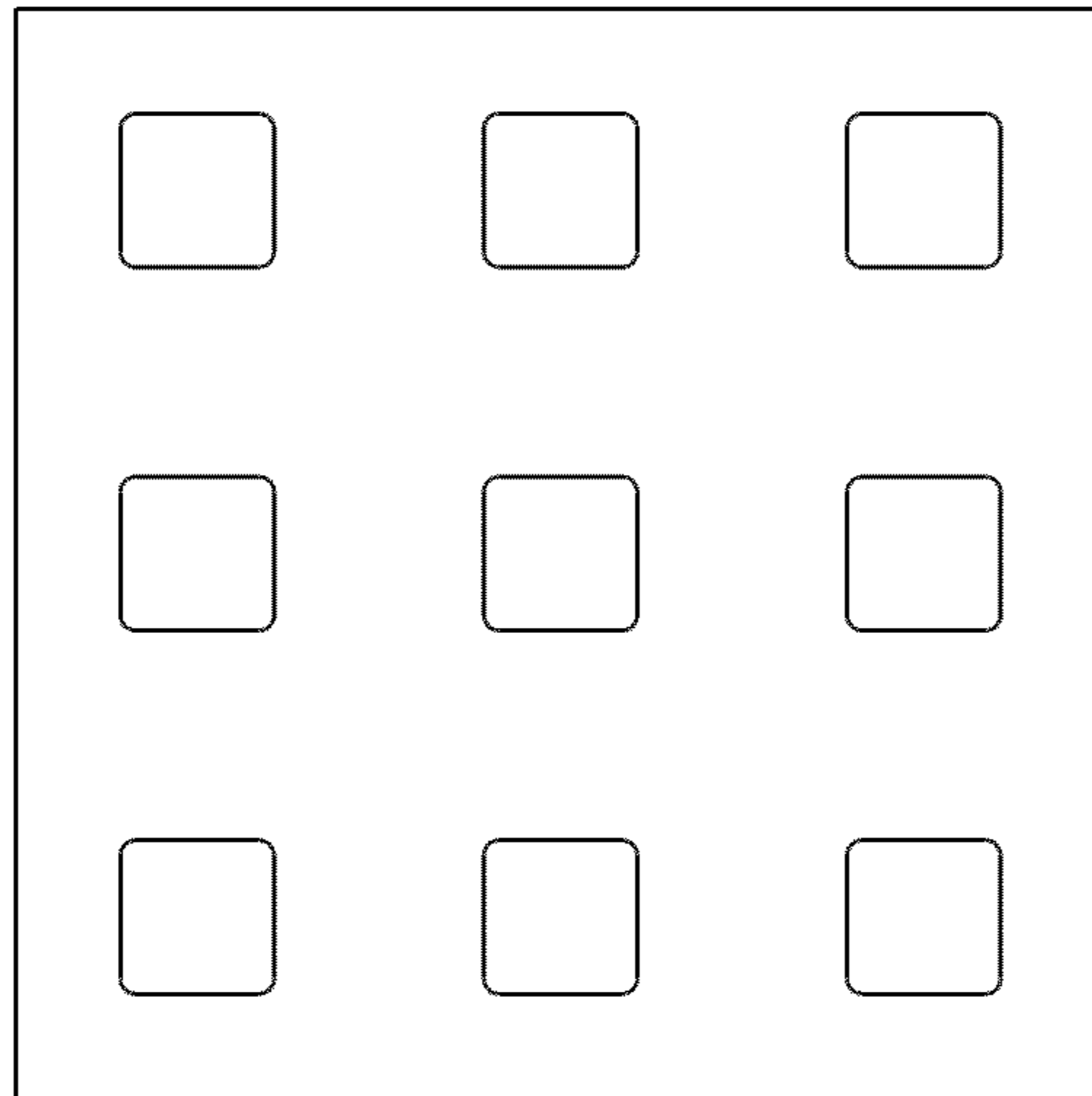

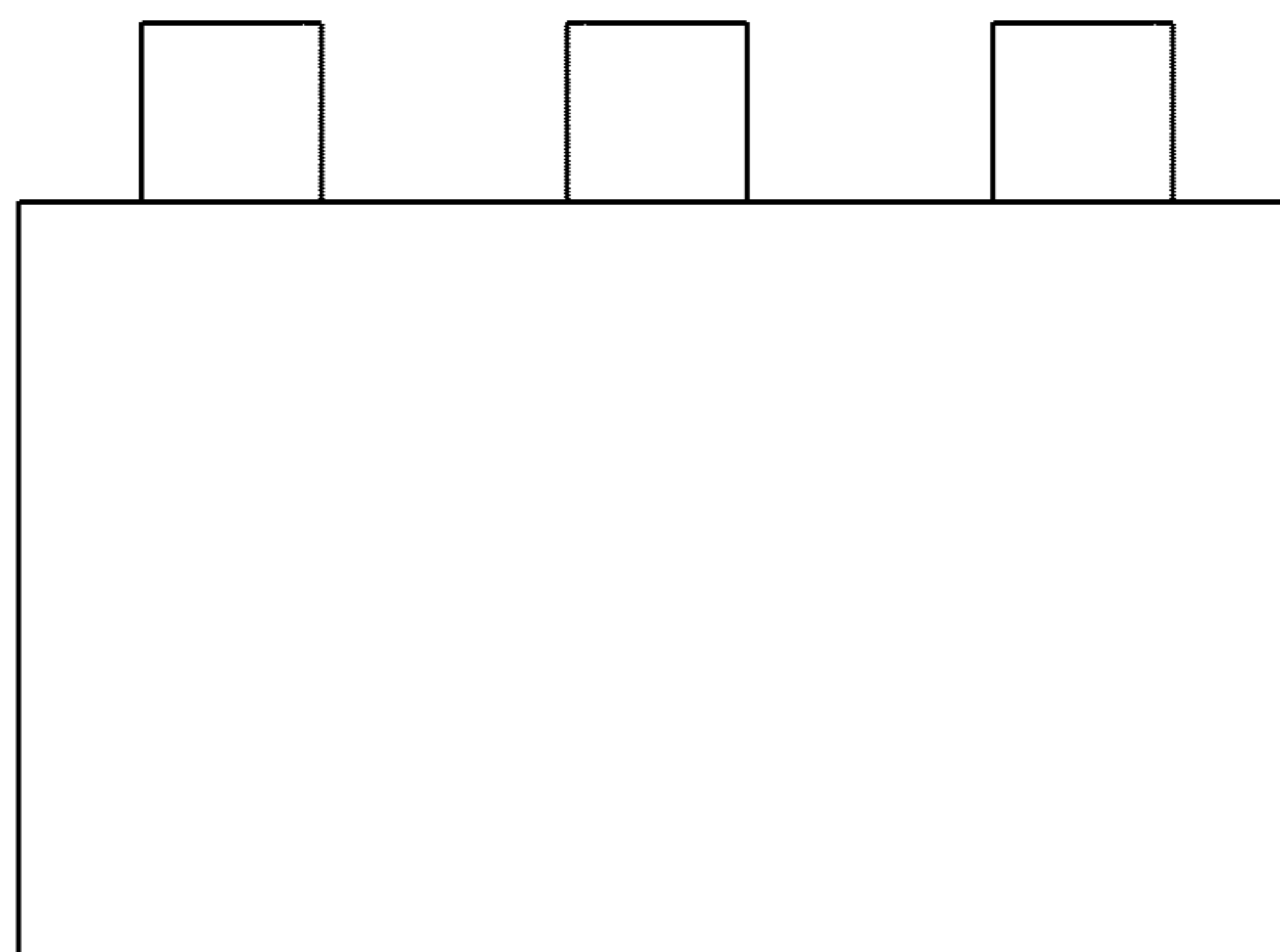

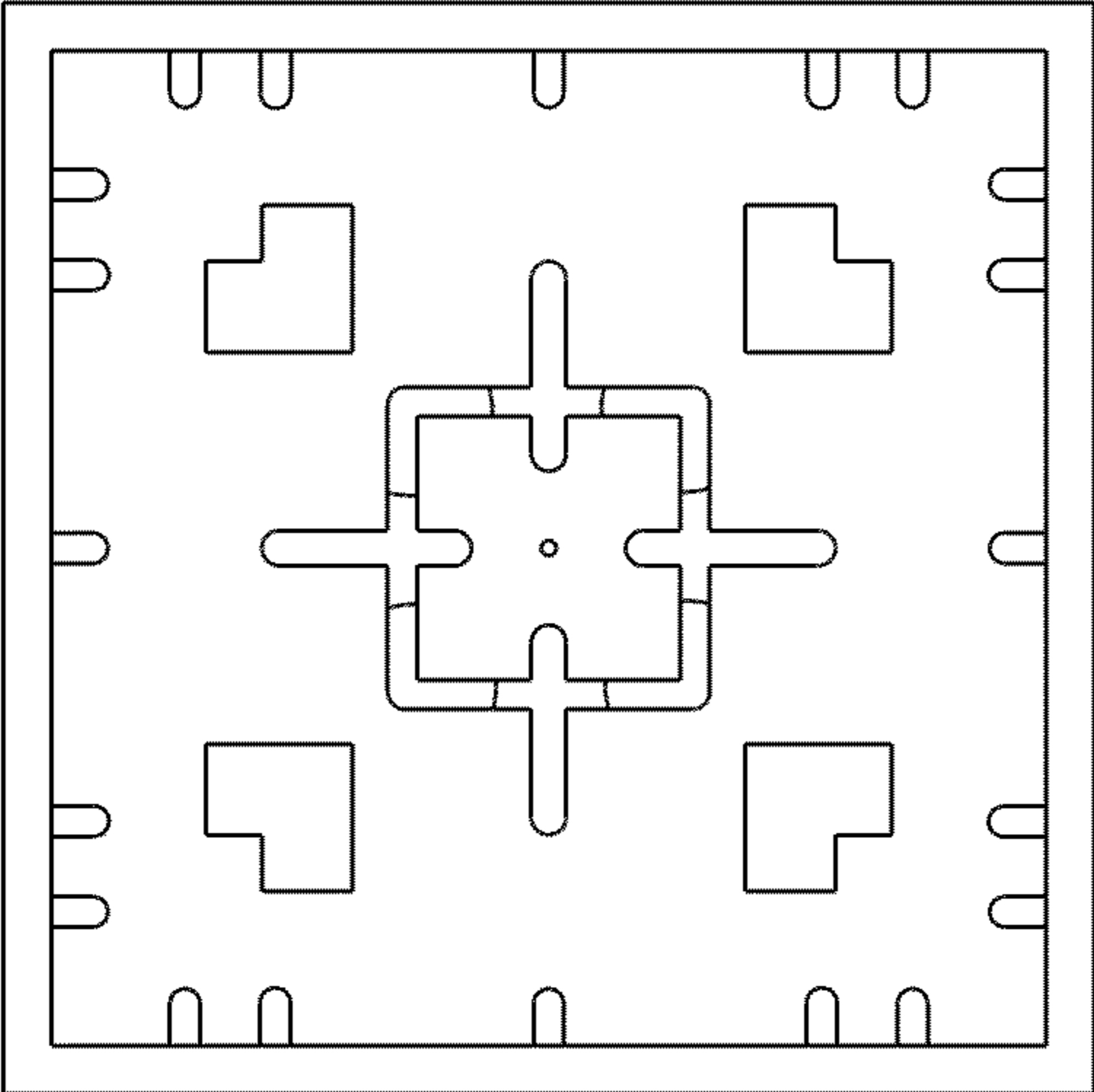

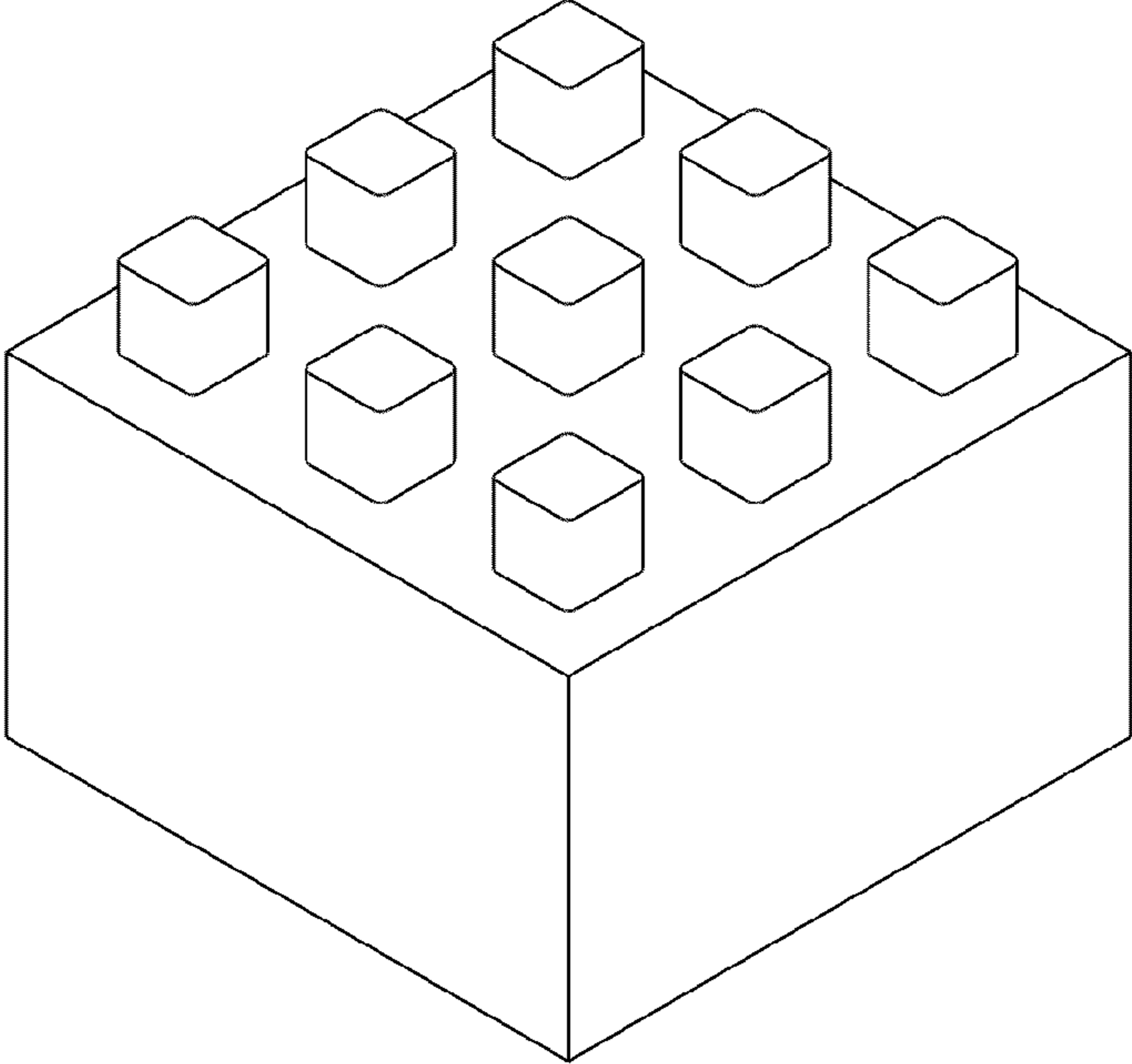

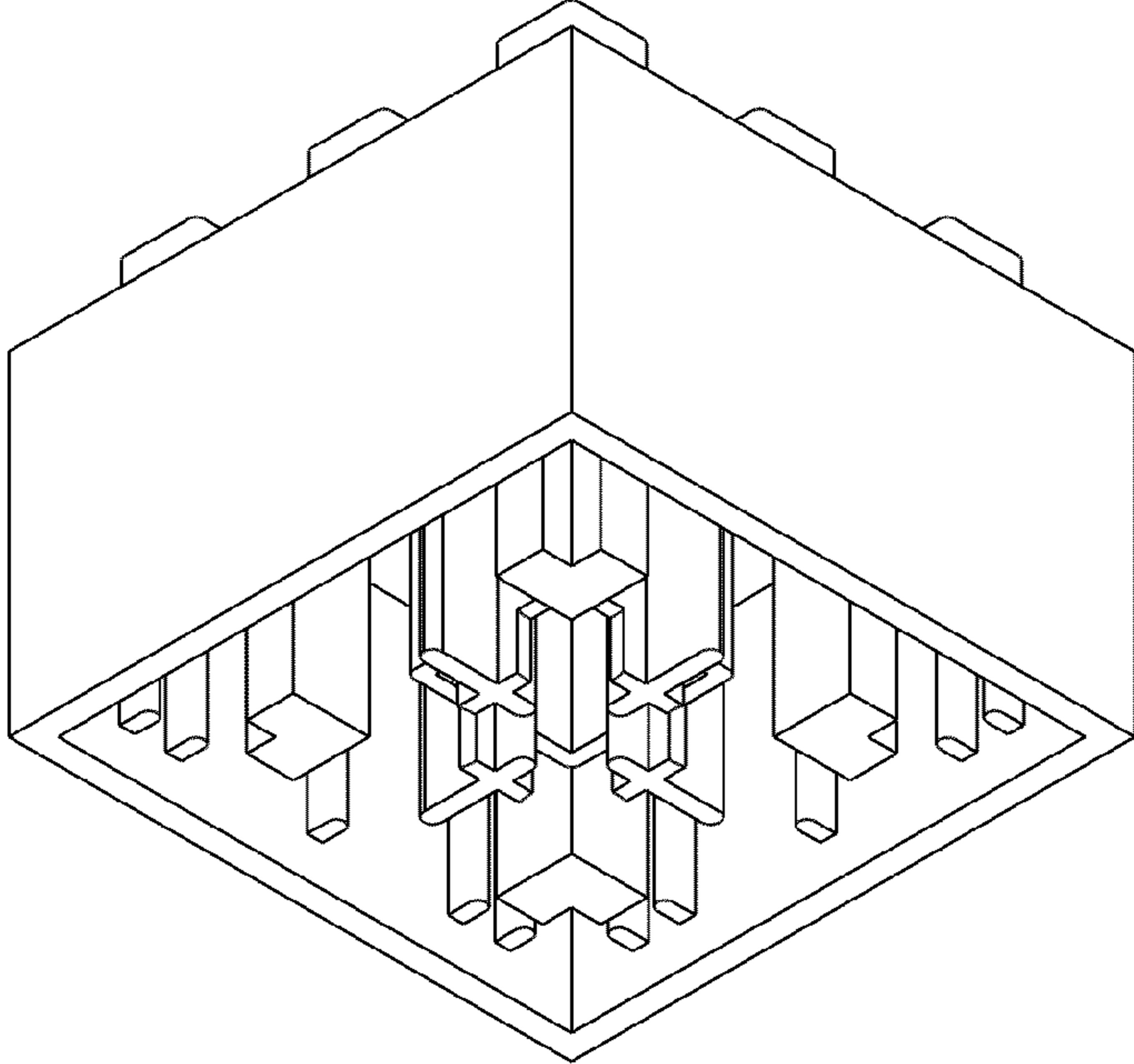
