**DESCRIPTION**

FIG. 1 is a front perspective view of a defibrillator in accordance with the present invention;  
FIG. 2 is a front side plan view thereof;

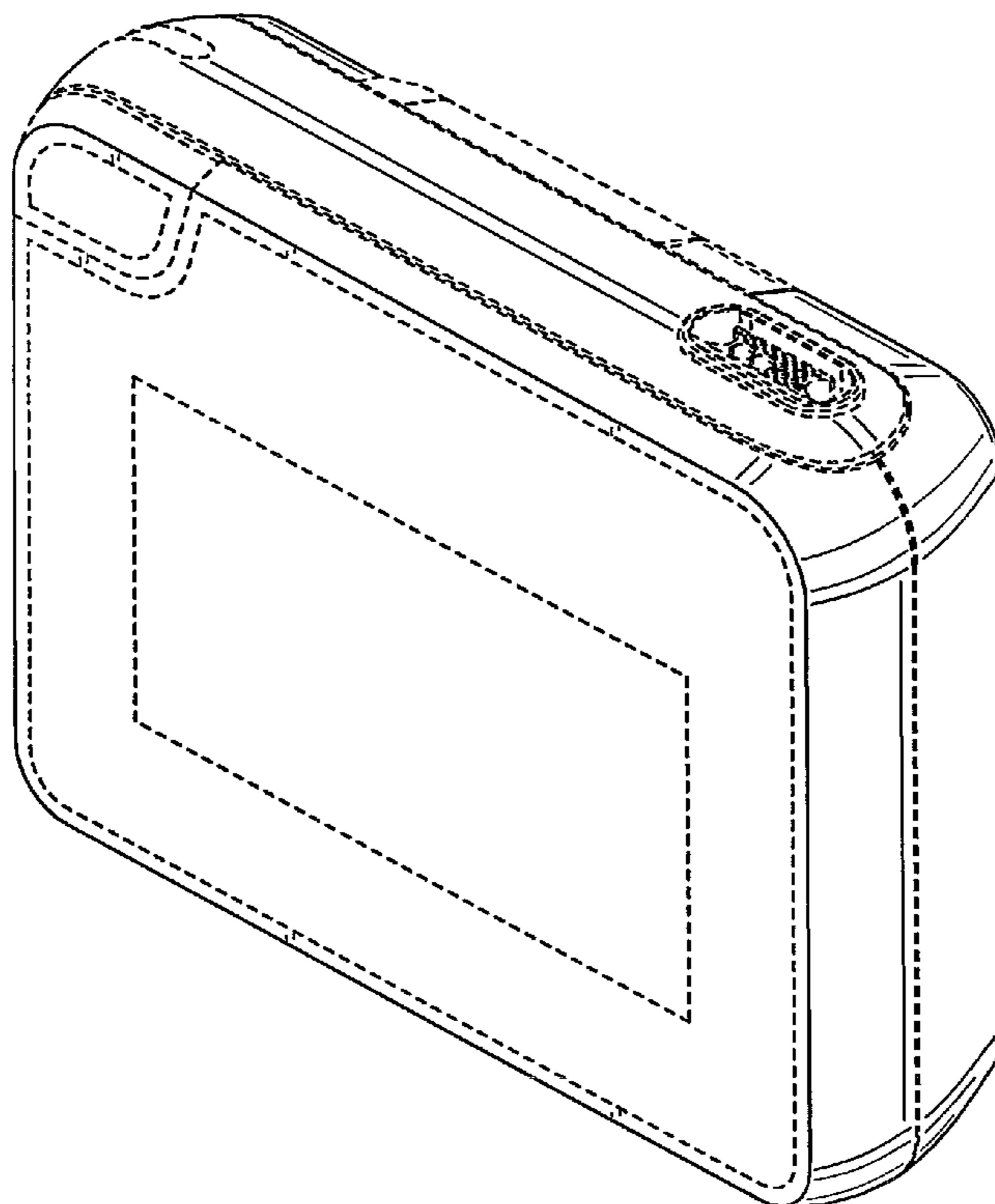

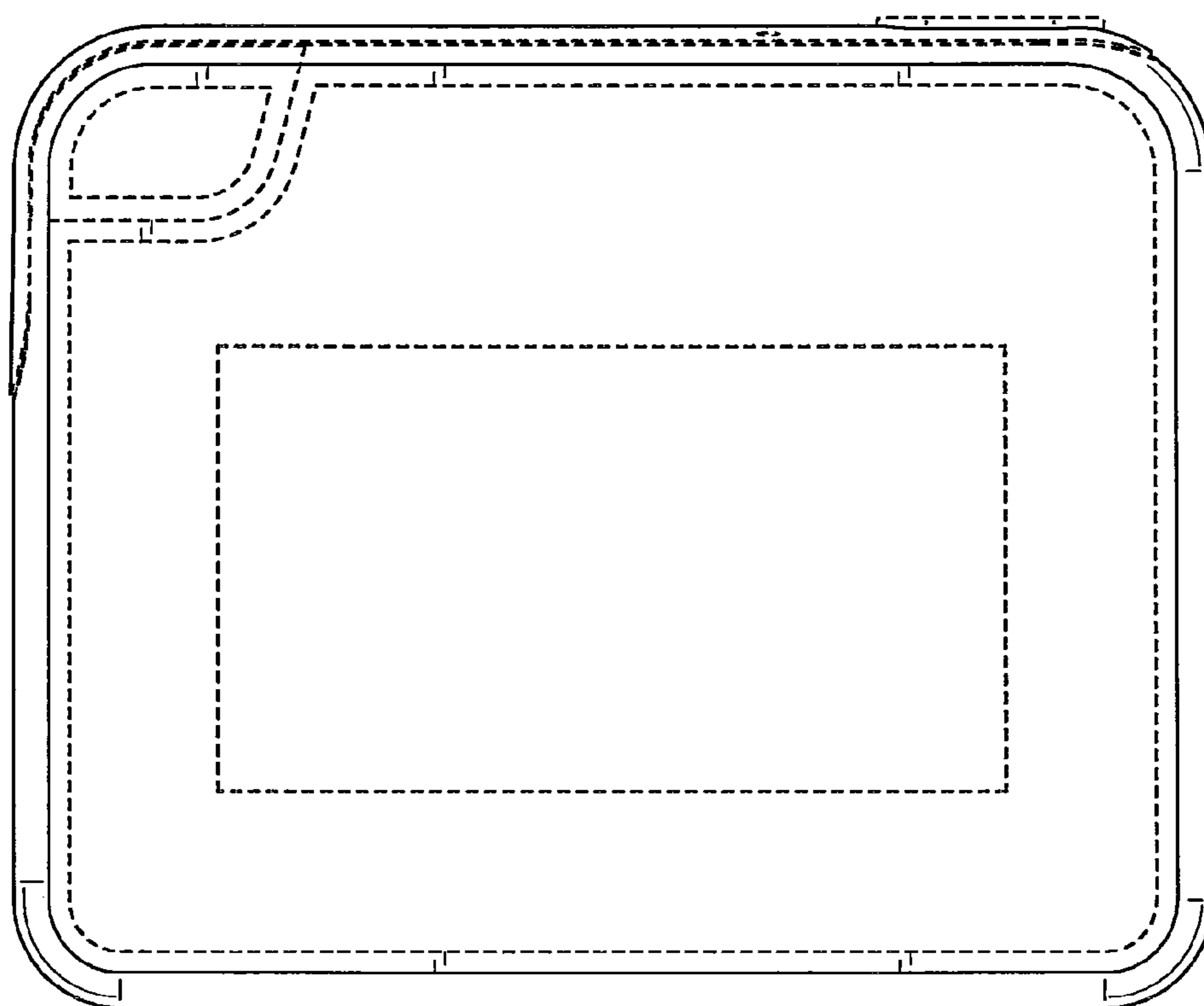

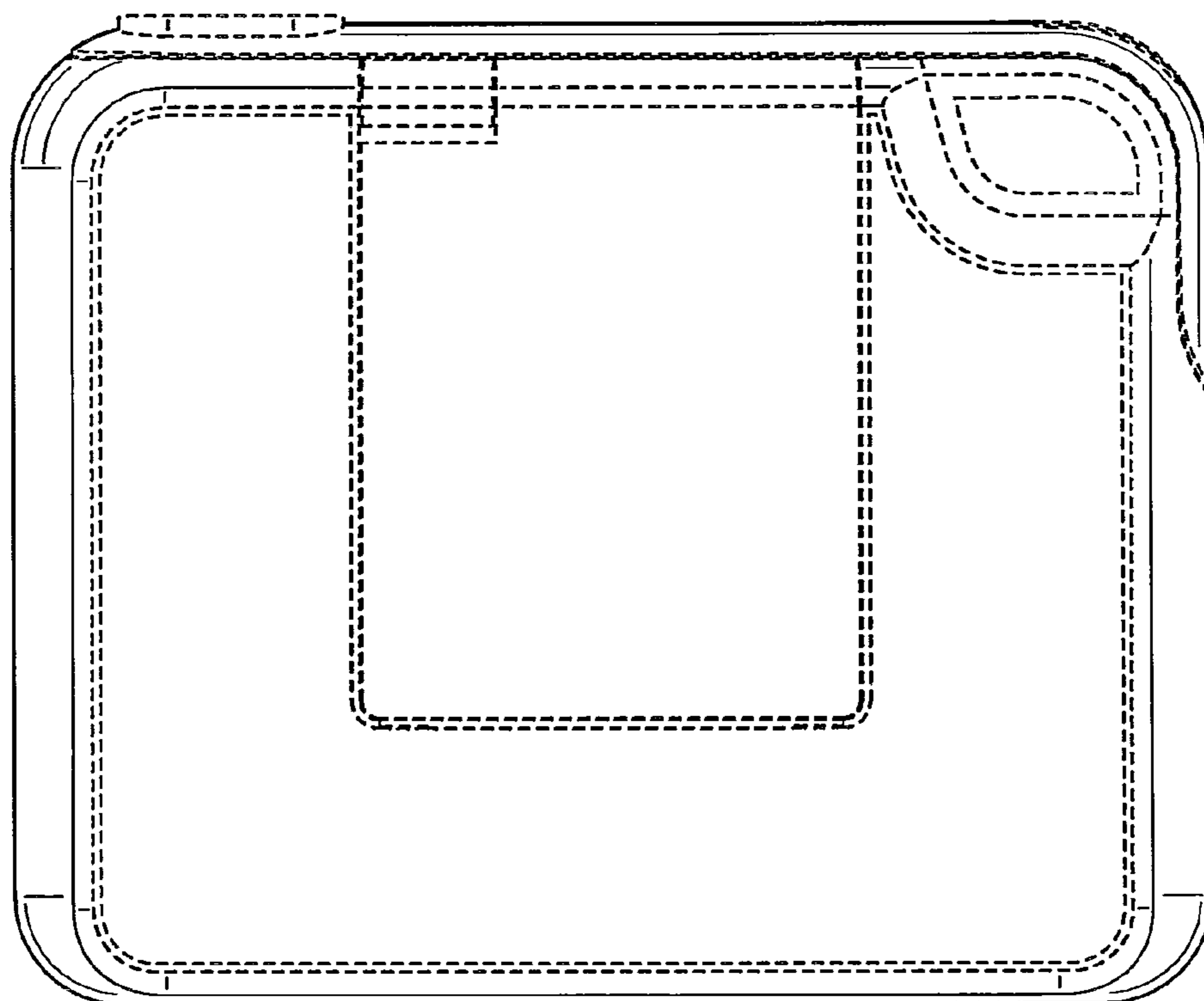

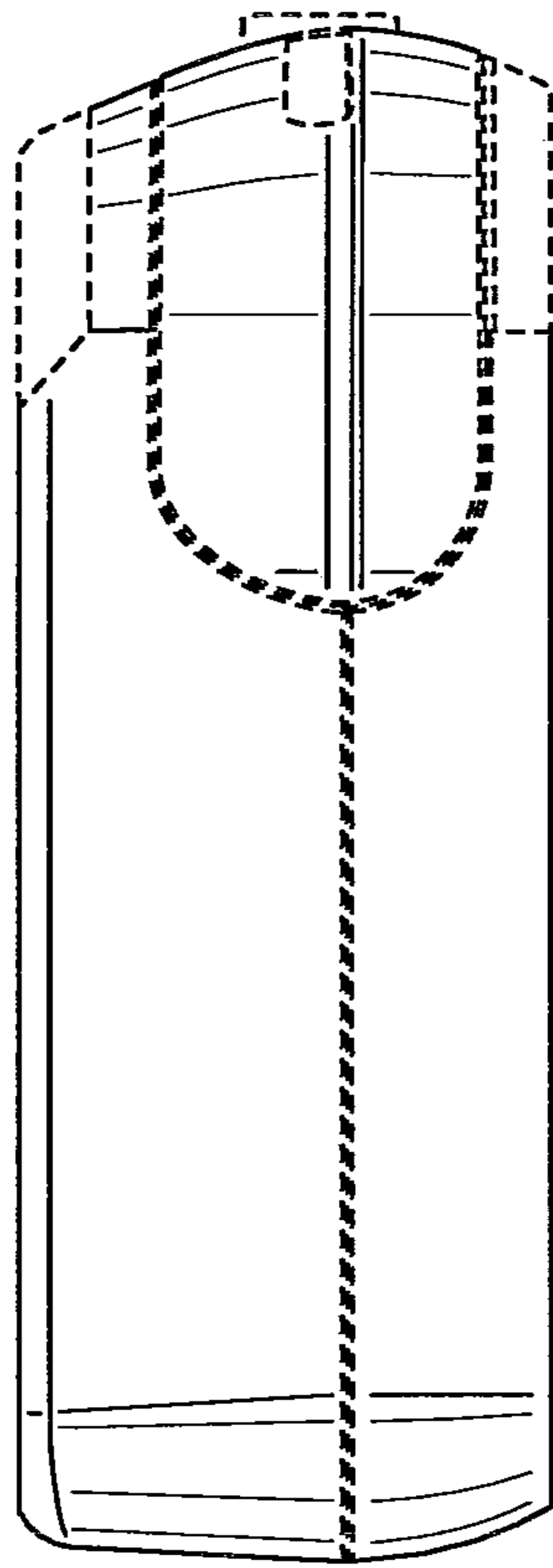

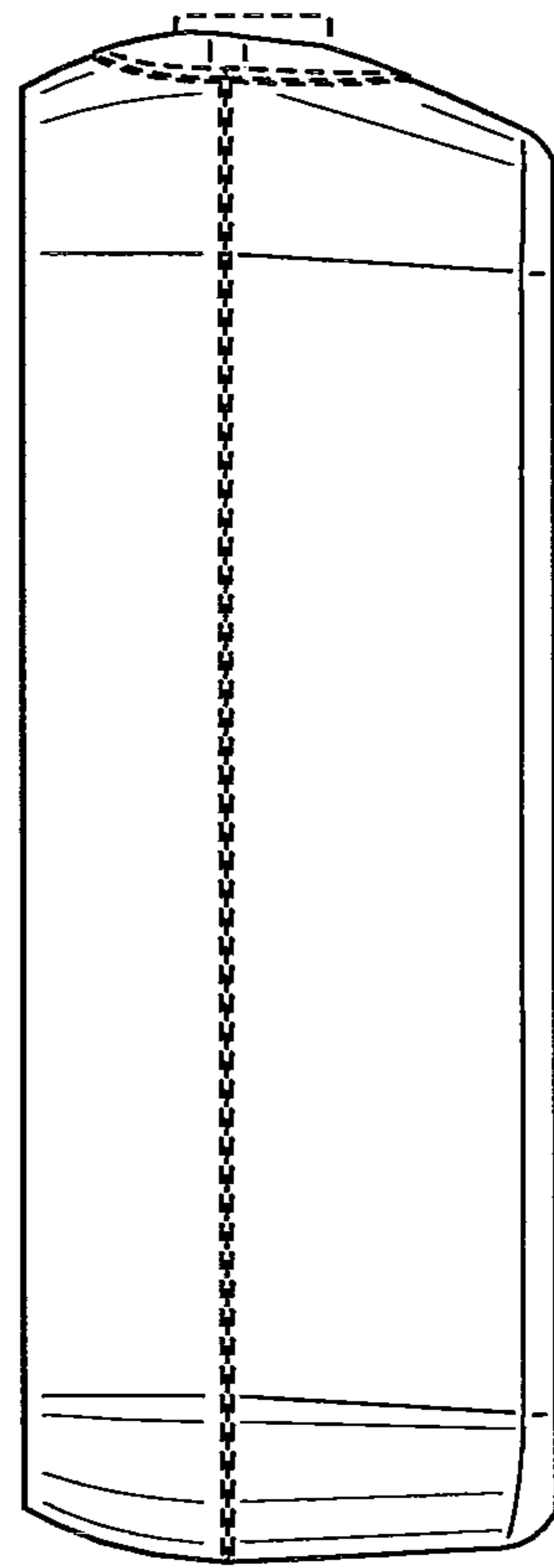

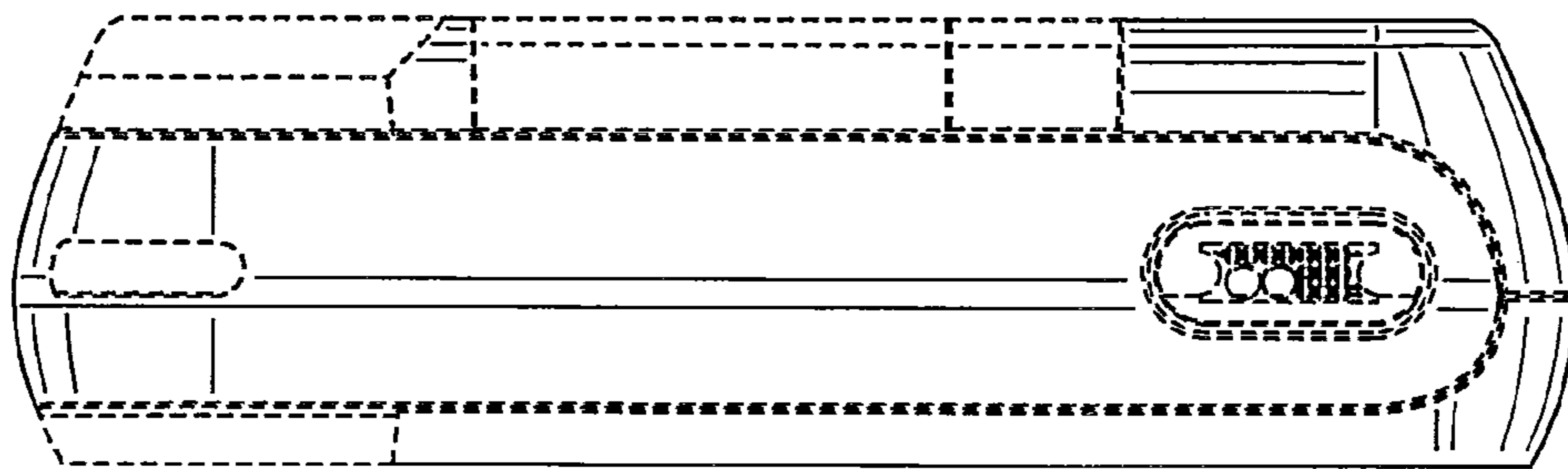

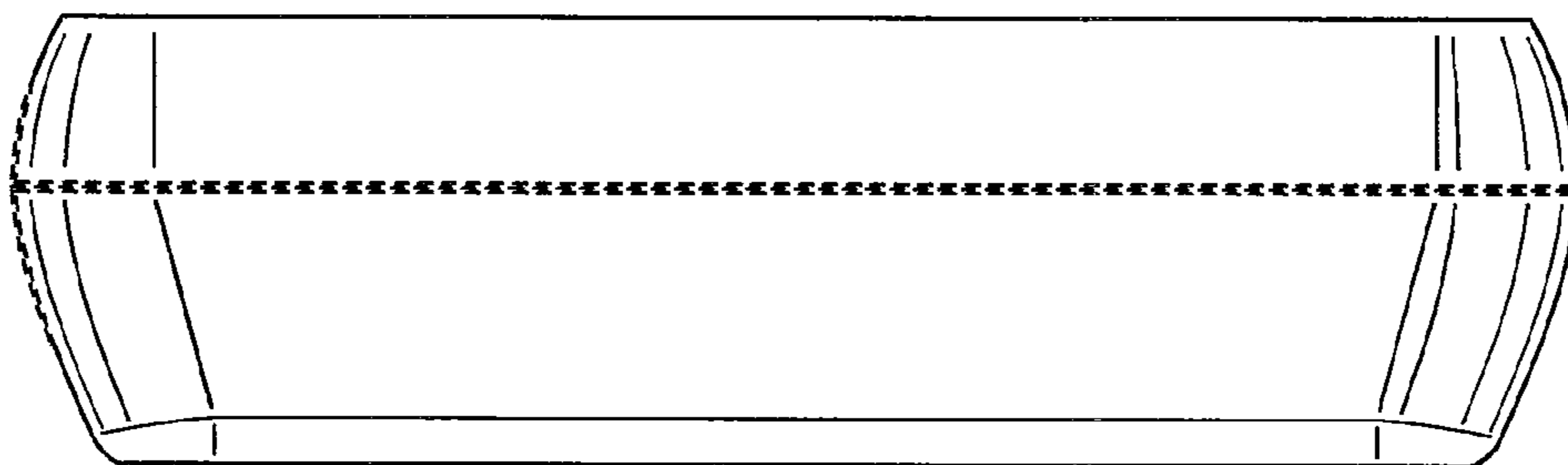
