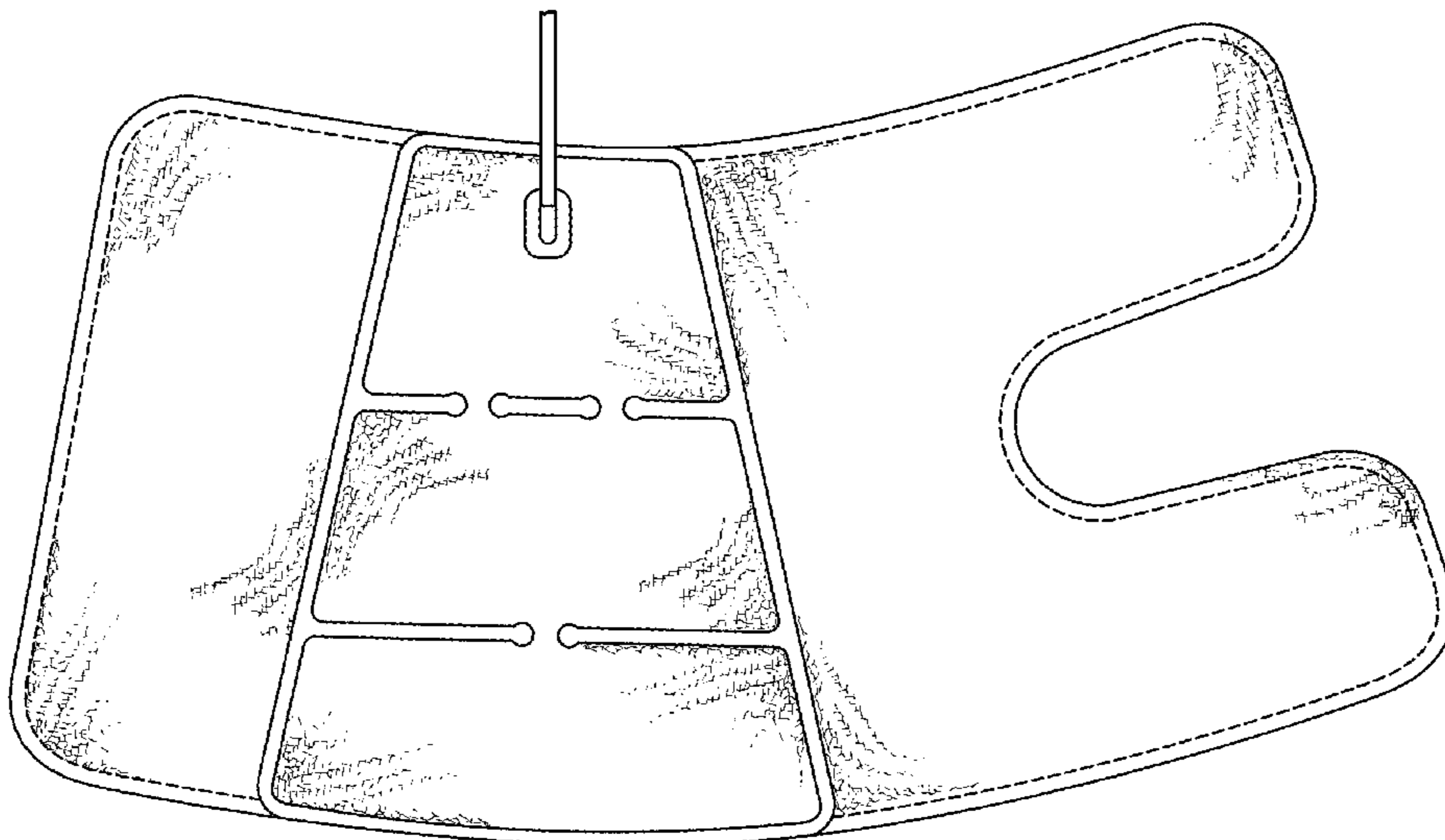
(57) **CLAIM**
I claim the ornamental design for a calf pad, as shown and described.

DESCRIPTION

FIG. 1 is an illustration of a top perspective view of a calf pad showing my new design.
FIG. 2 is an illustration of a bottom perspective view thereof.
FIG. 3 is an illustration of a top elevational view thereof.
FIG. 4 is an illustration of a right side elevational view thereof.
FIG. 5 is an illustration of a left side elevational view thereof.
FIG. 6 is an illustration of a bottom elevational view thereof.
FIG. 7 is an illustration of a rear elevational view thereof; and, FIG. 8 is an illustration of a front elevational view thereof.
The broken line showing on a calf pad is for the purpose of illustrating stitching that forms part of the claimed design.

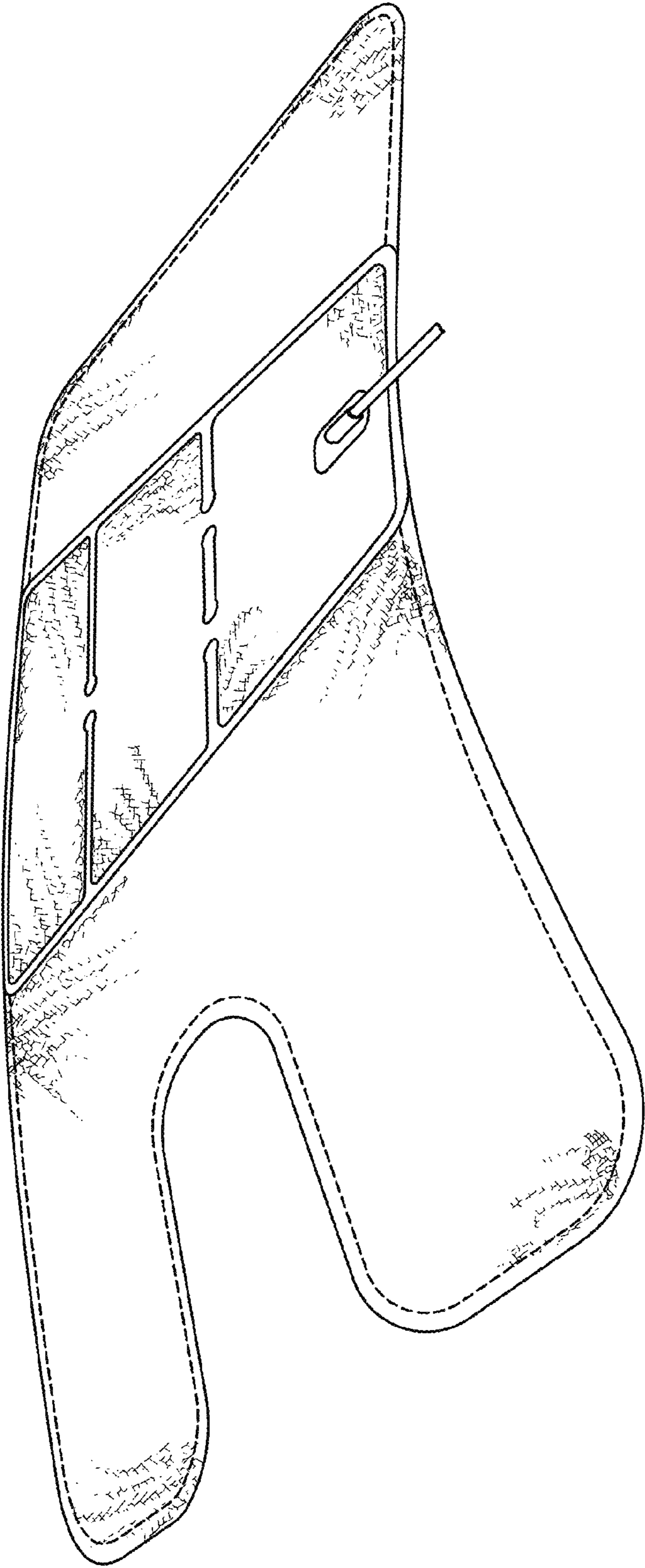

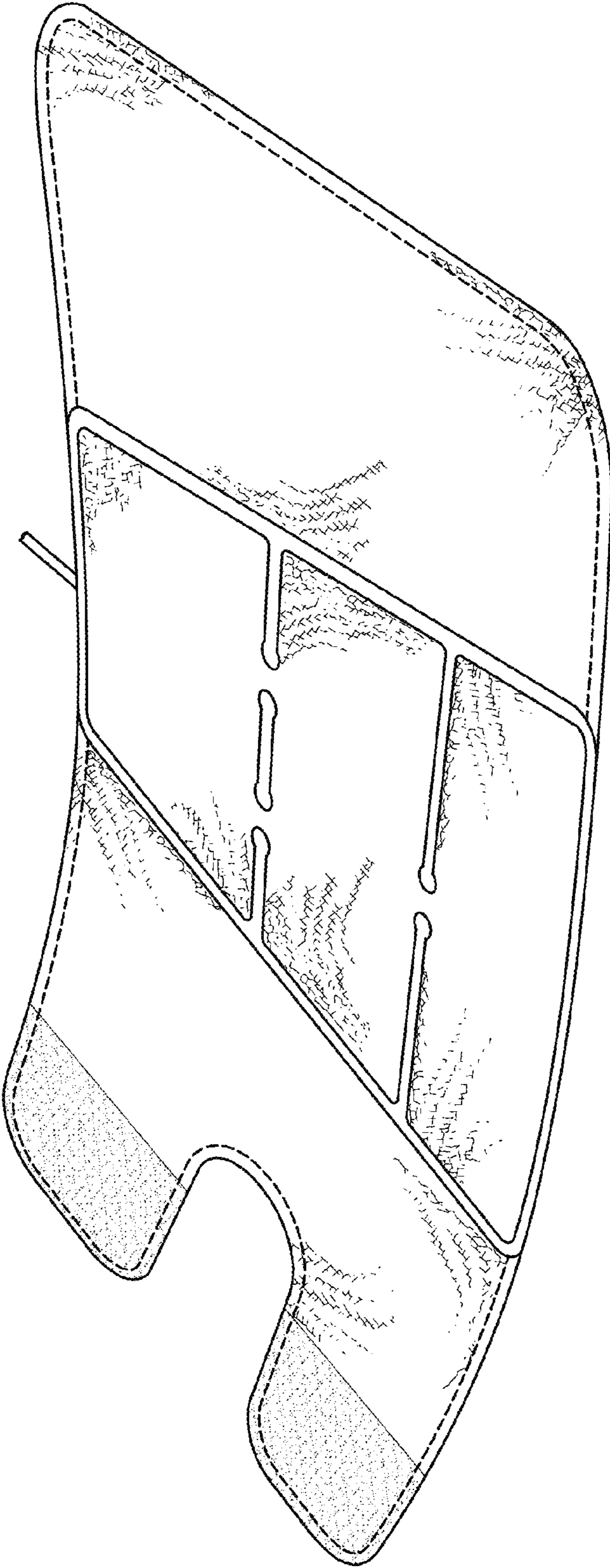

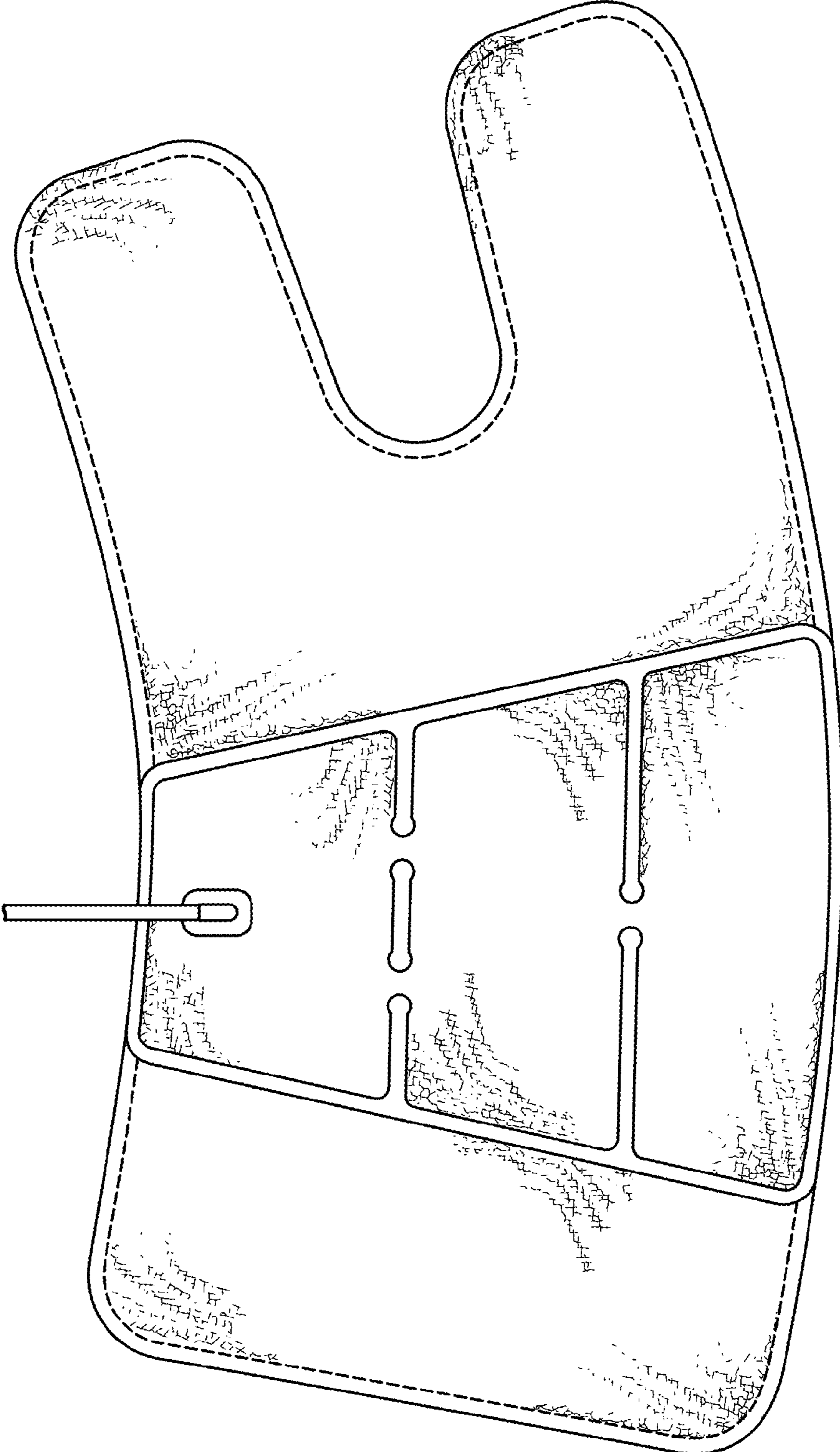

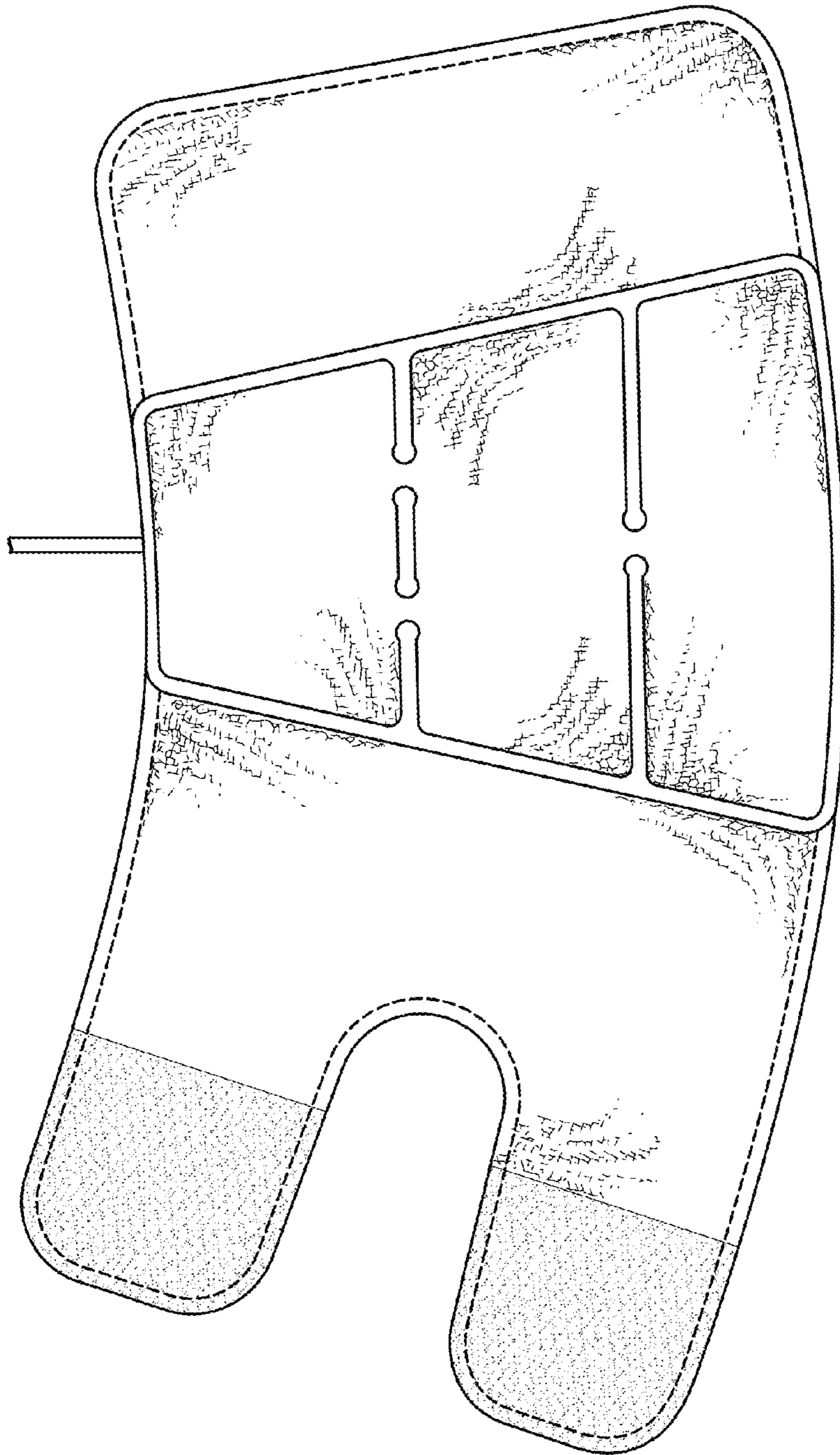
