The ornamental design for a device for preparing and transferring reaction mixture, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a device for preparing and transferring a reaction mixture in accordance with the new design;

FIG. 3 is a left side elevation view of the device in FIG. 1;

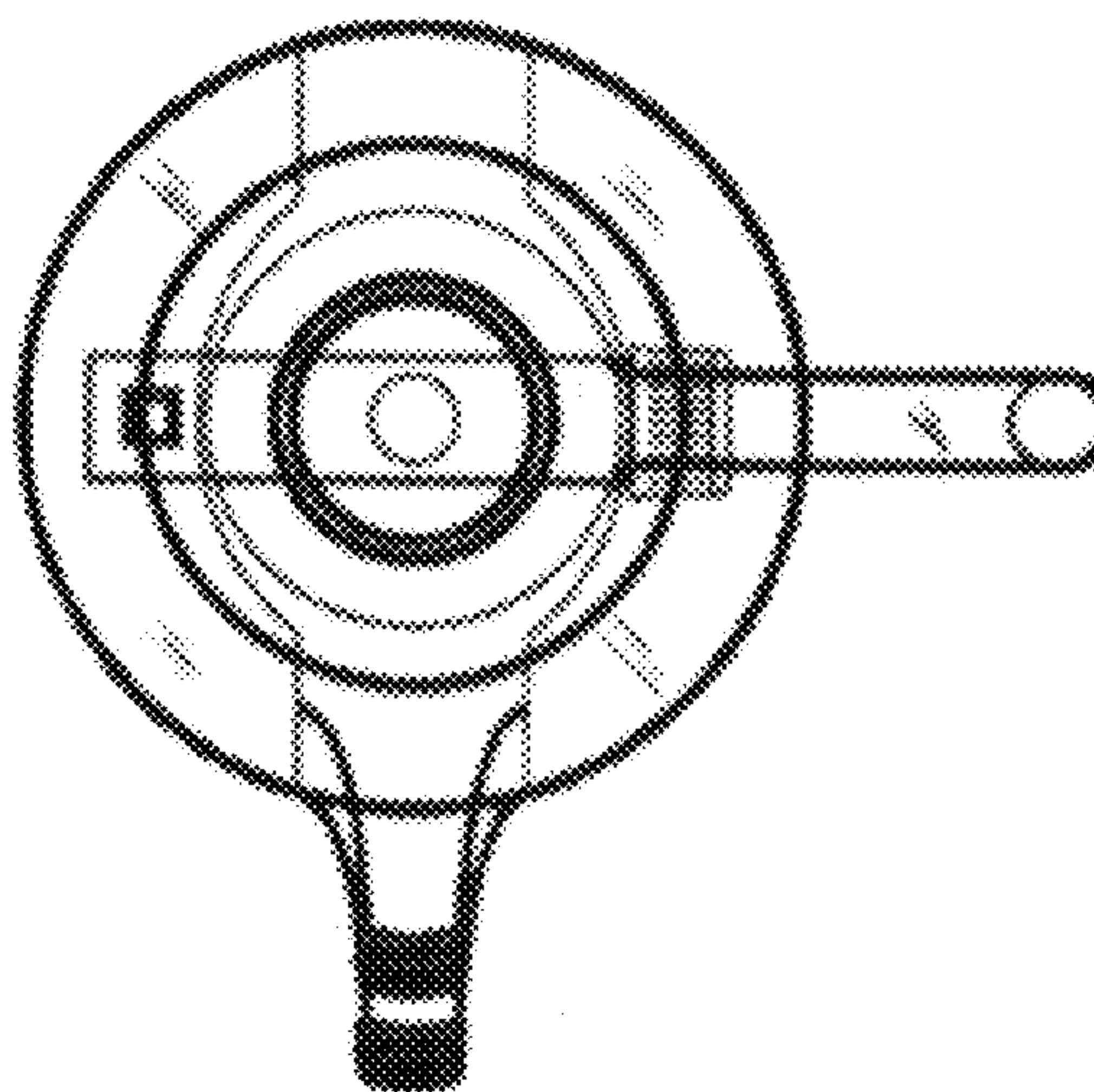
FIG. 4 is a right side elevation view of the device in FIG. 1;

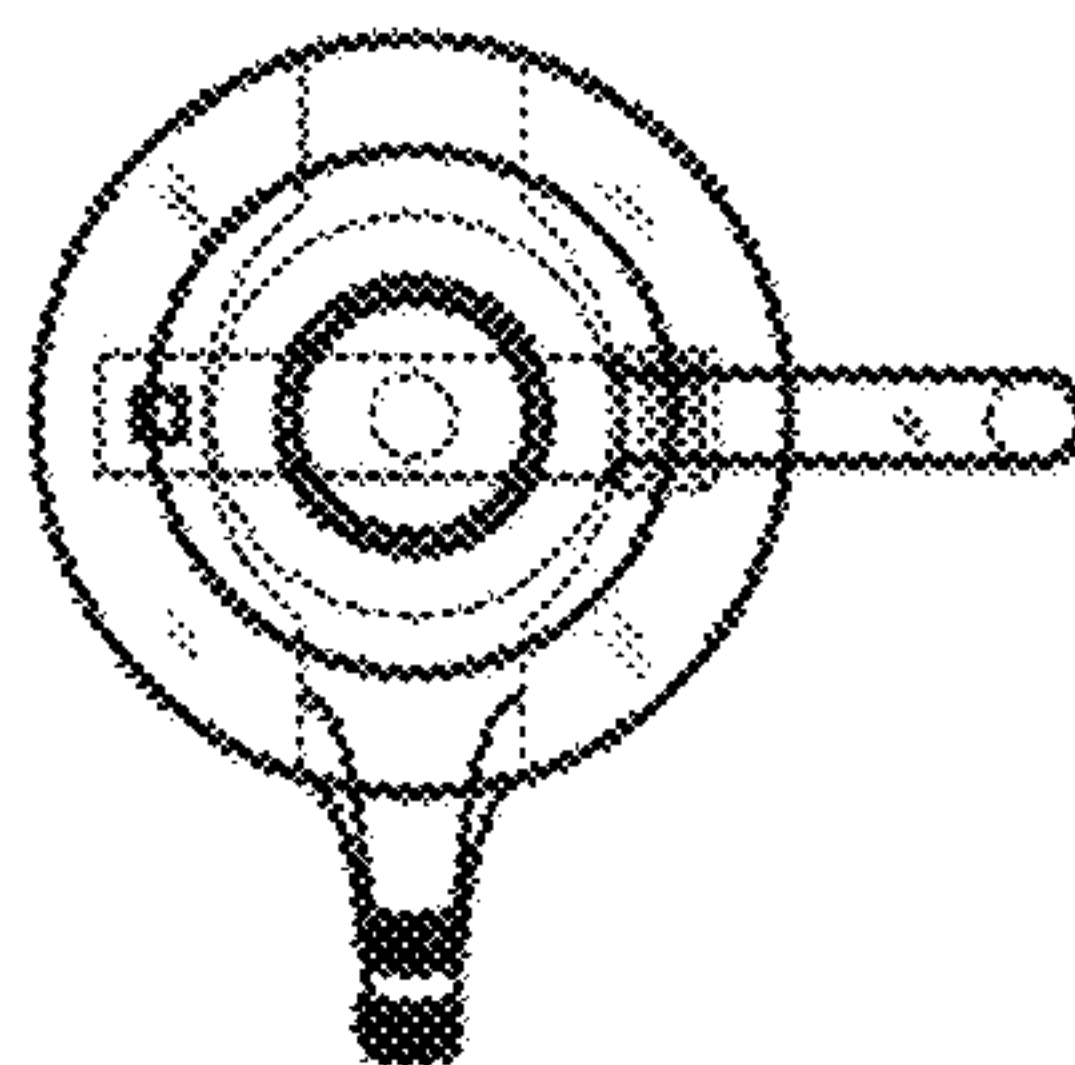

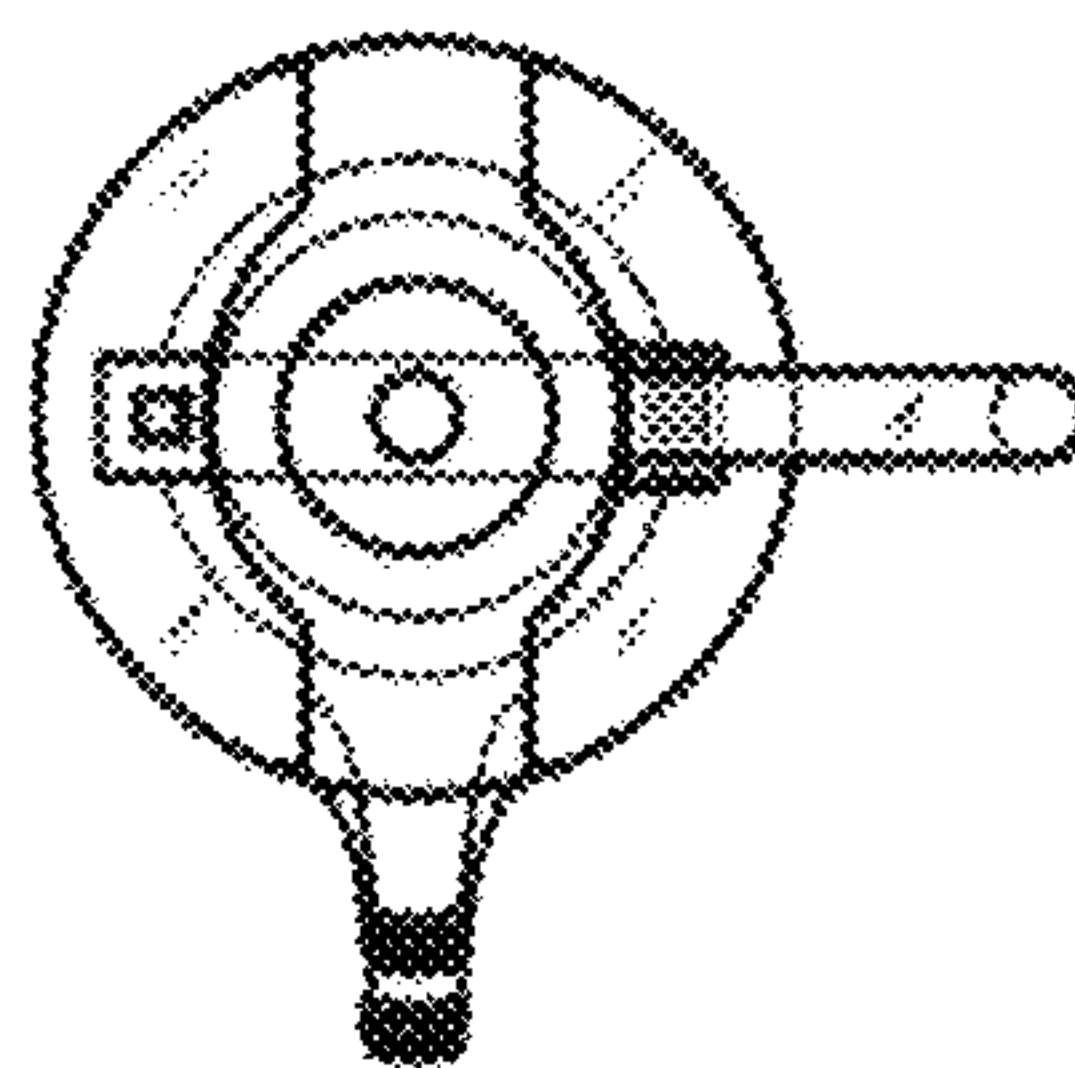

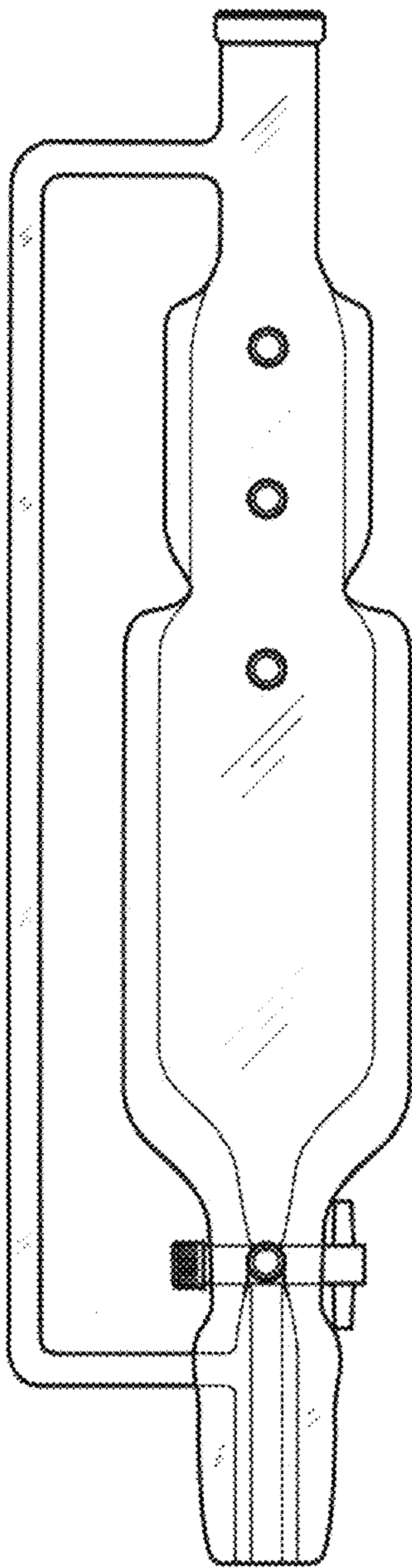

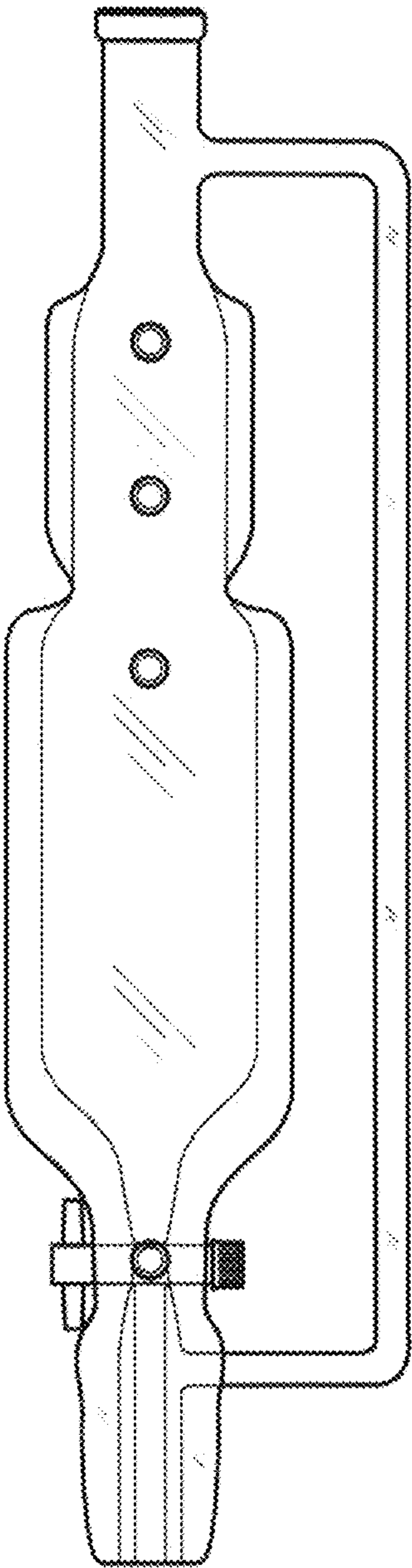

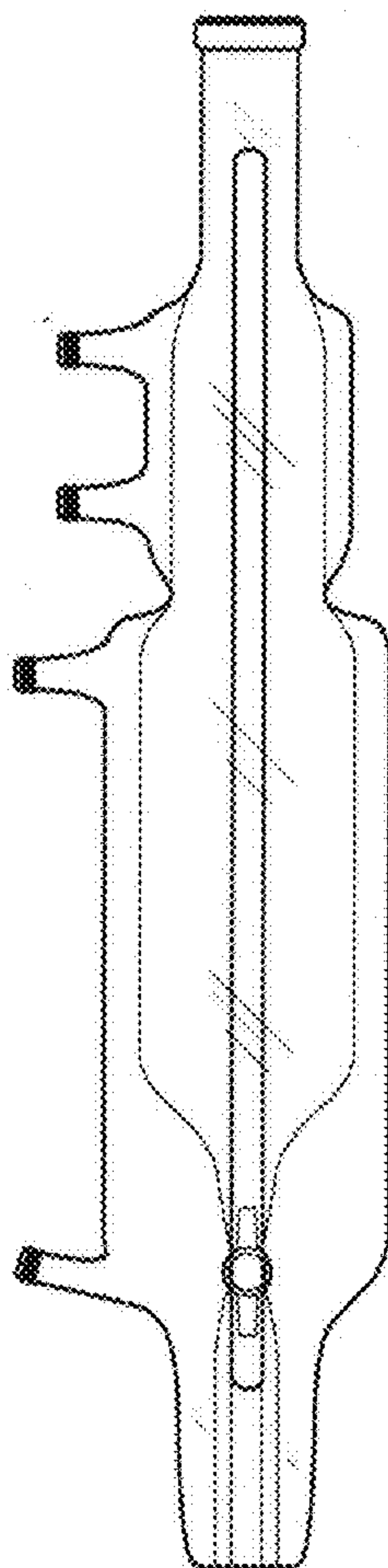

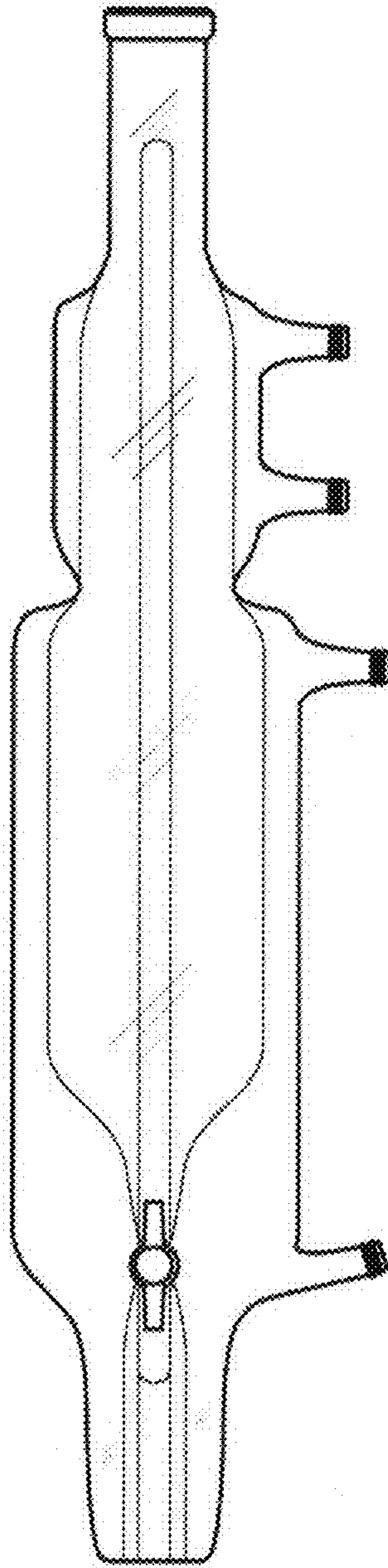

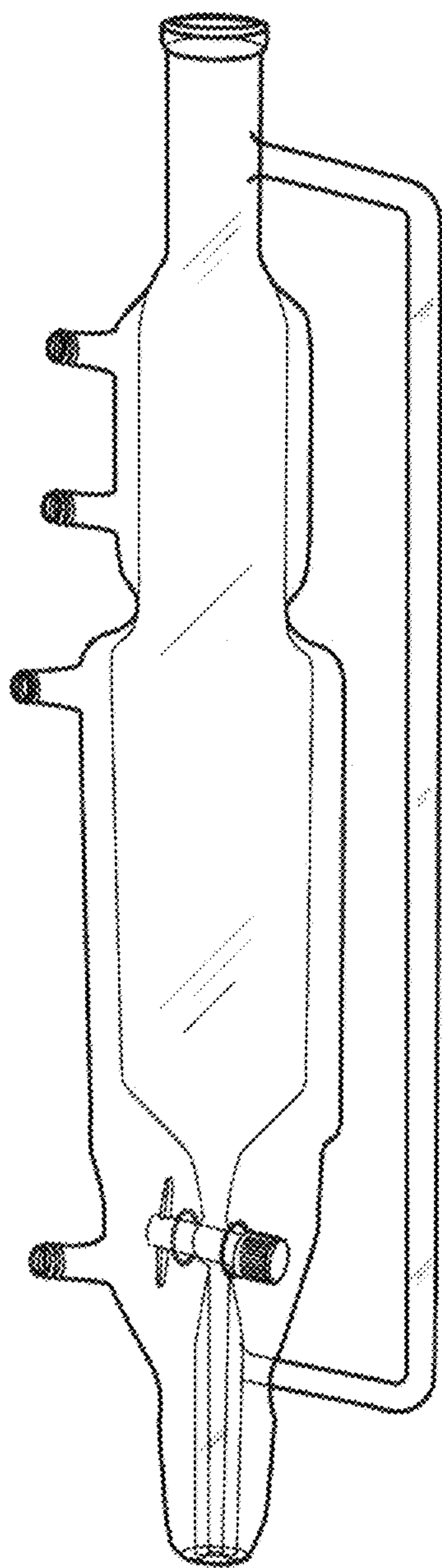
