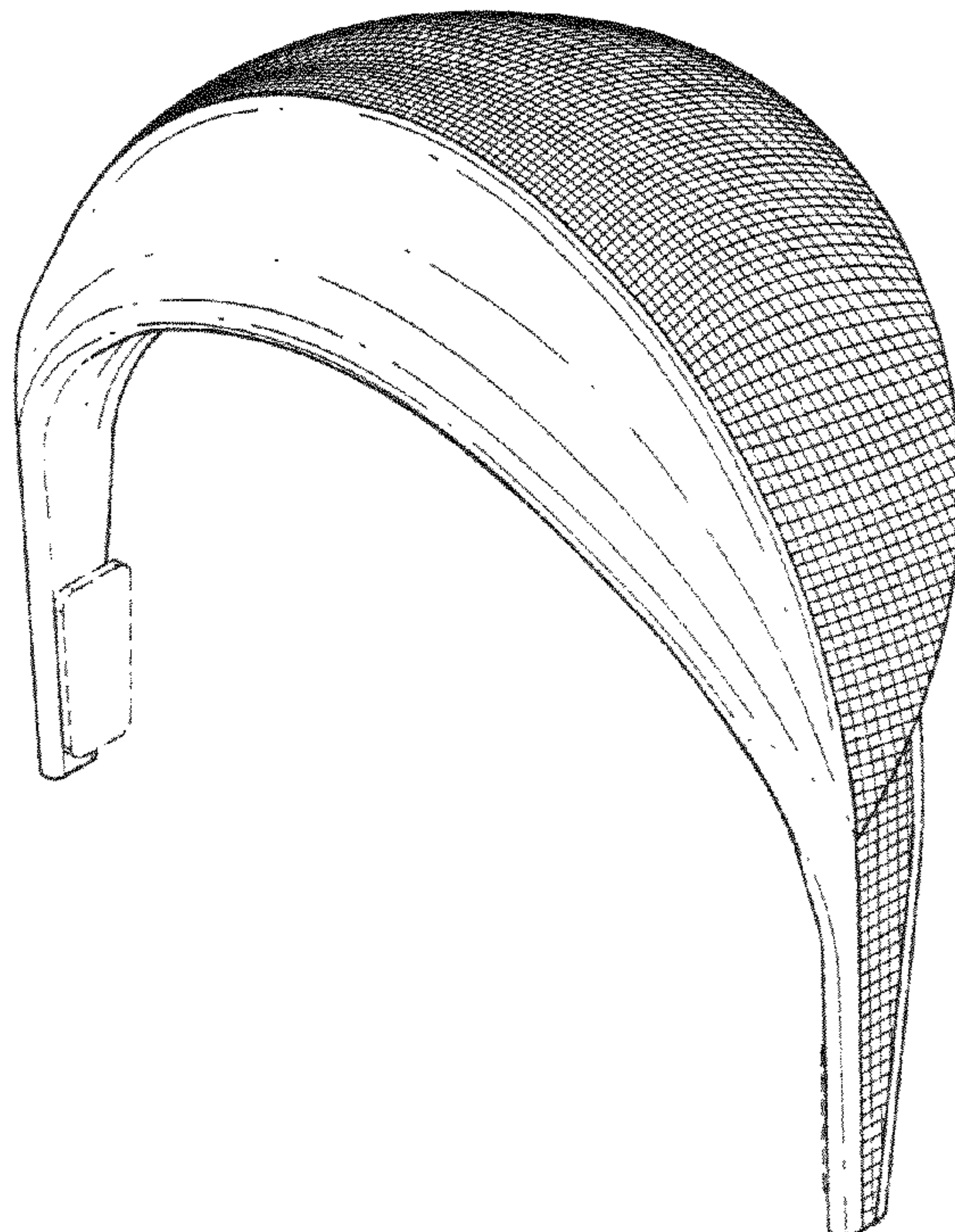
(57) **CLAIM**

The ornamental design for a hair volumizing accessory, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a hair volumizing accessory showing my new design; FIG. 2 is a bottom, rear, right side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevation view thereof; and, FIG. 8 is a right side elevation view thereof. The broken lines shown in the drawings illustrate hair clips and form no part of the claimed design.

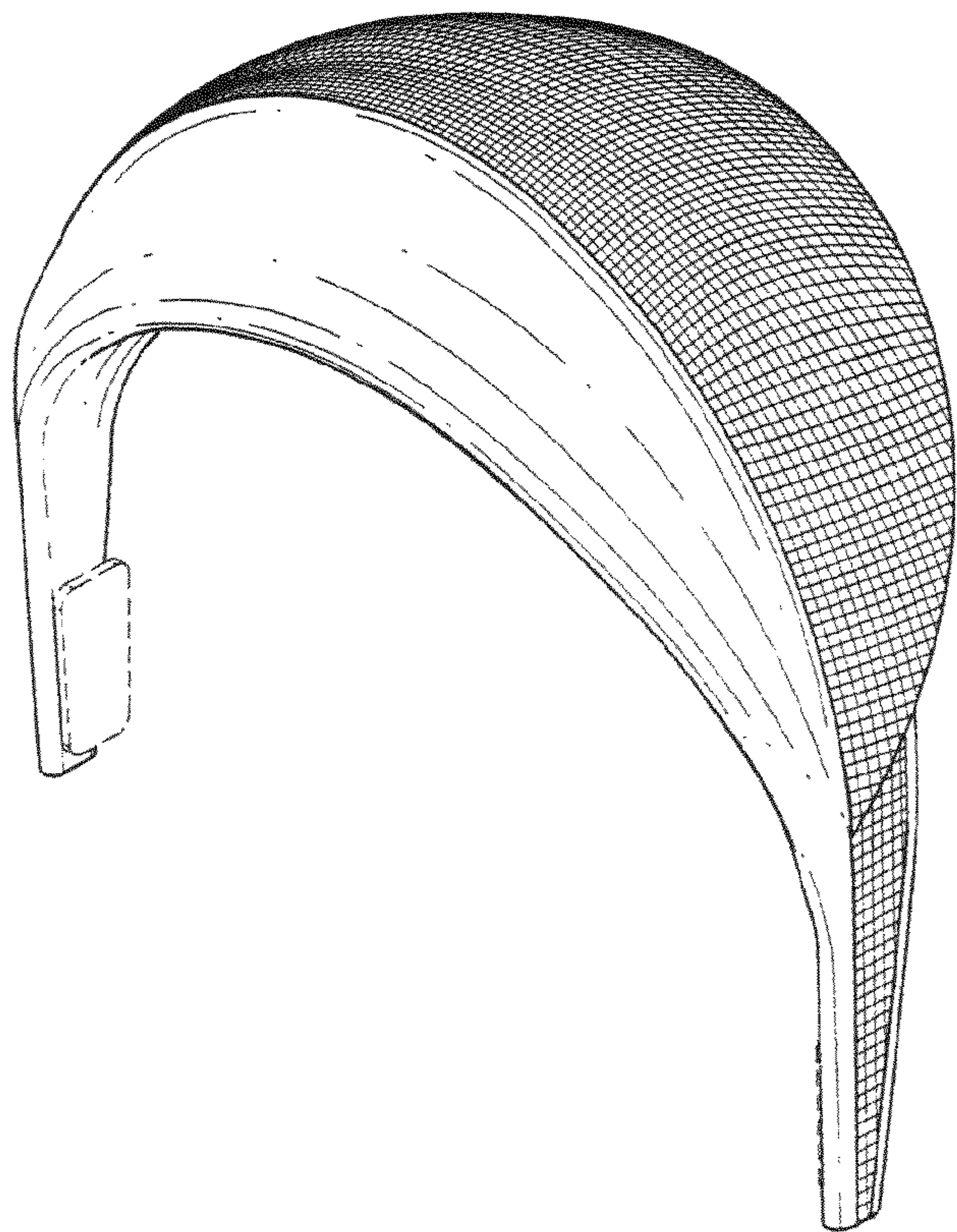

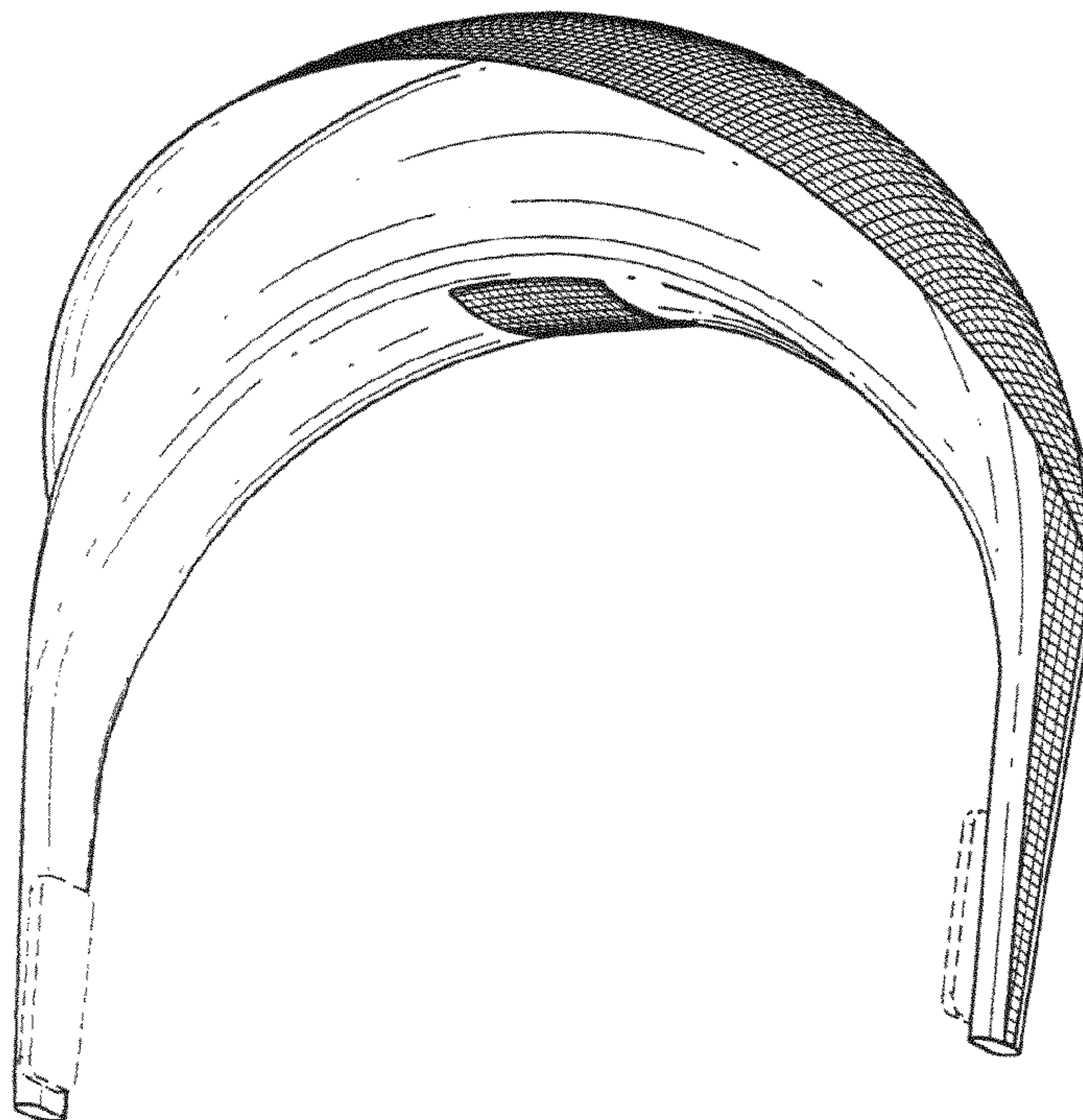

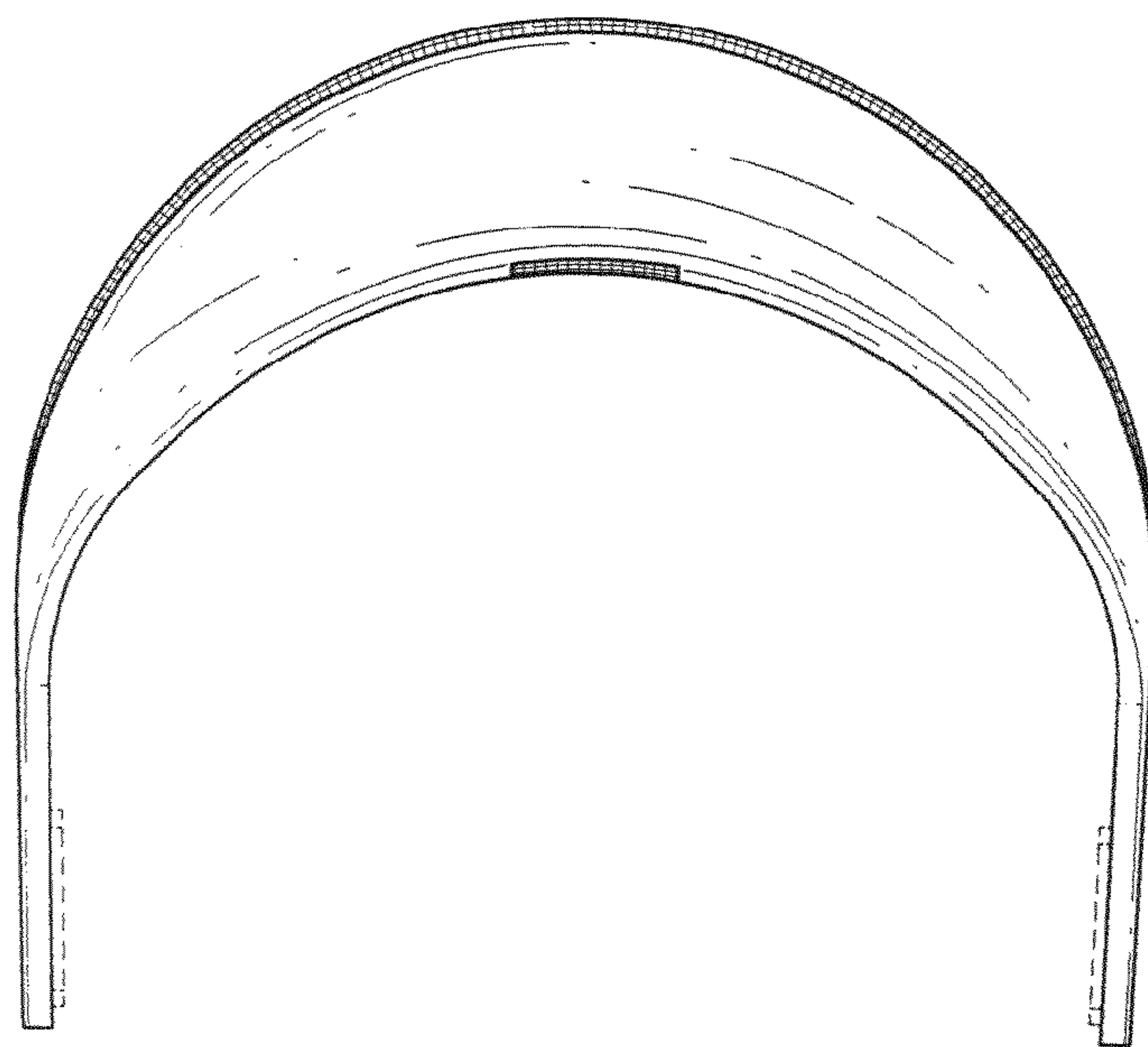

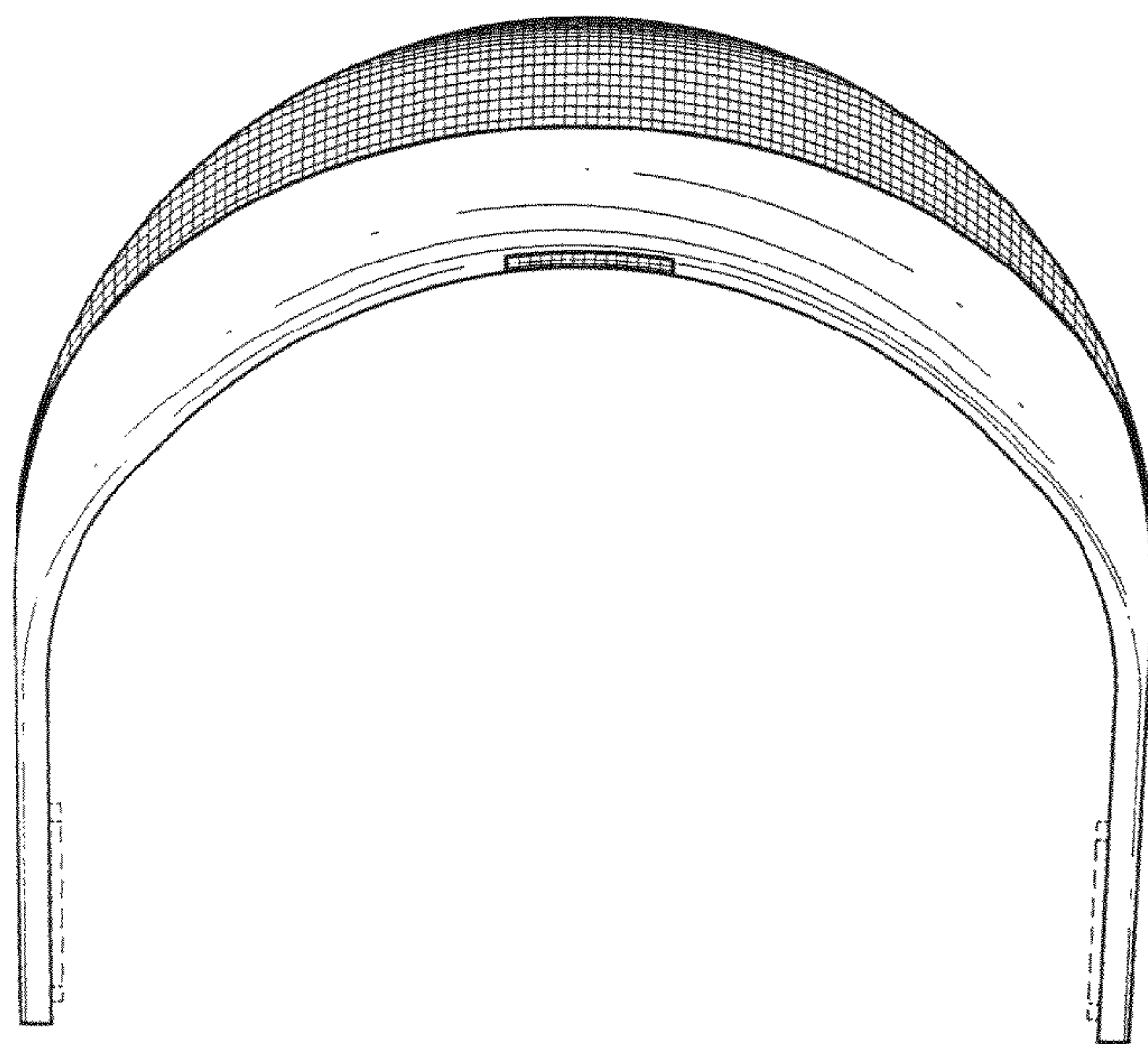

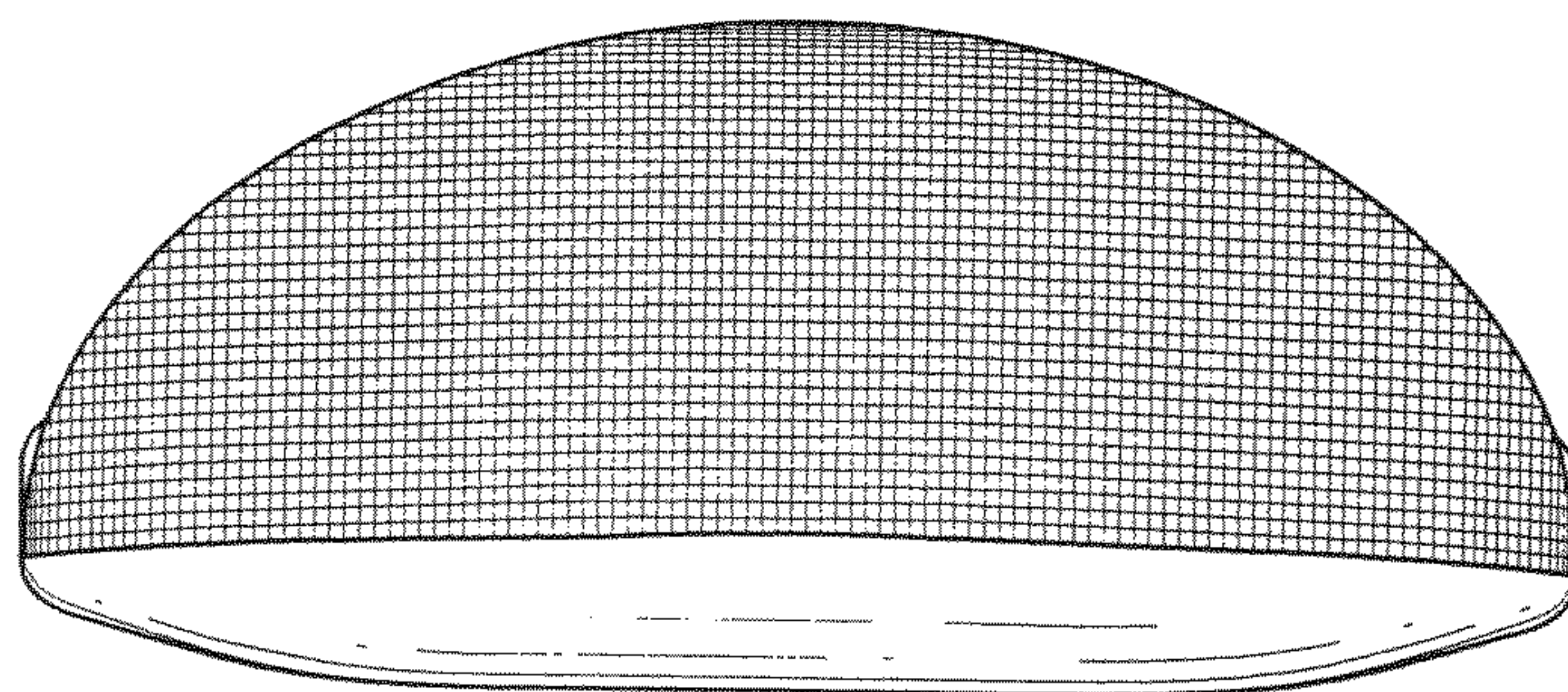

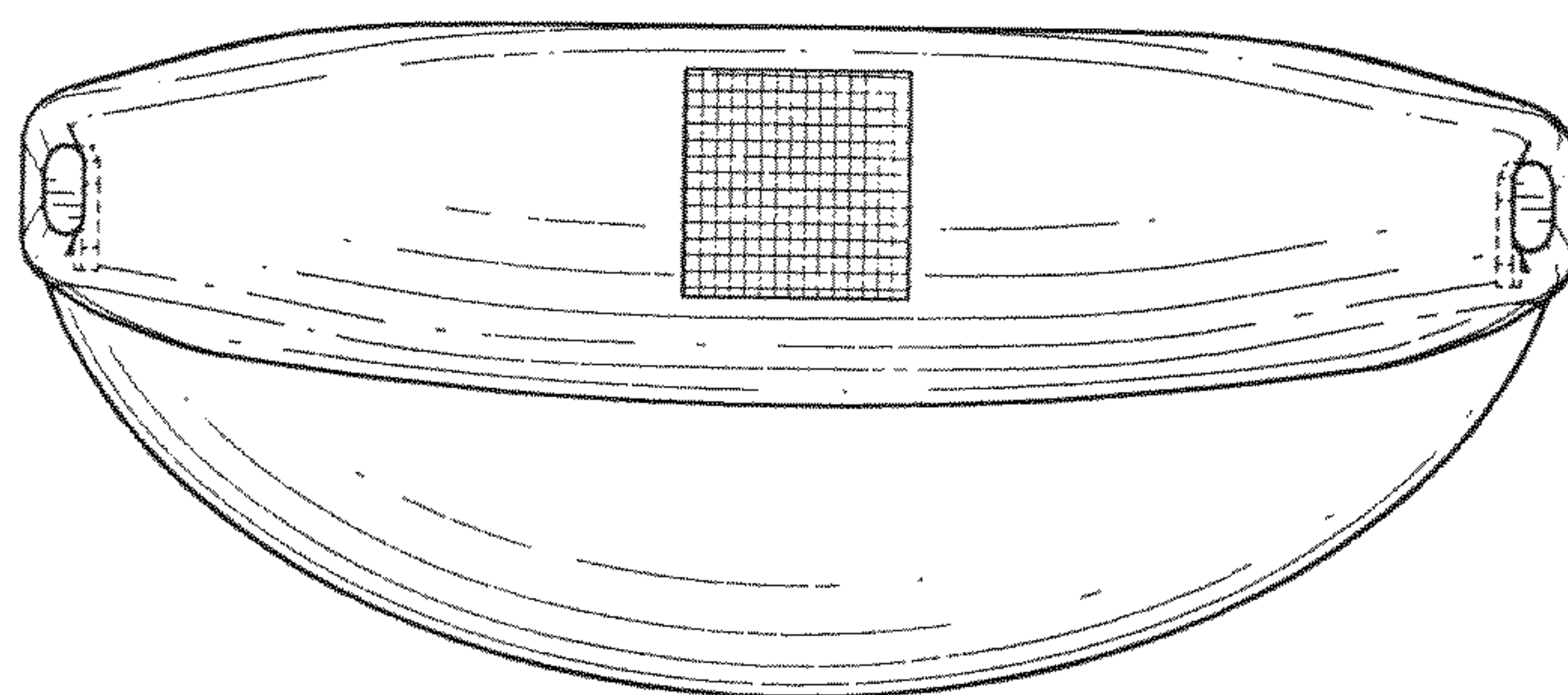

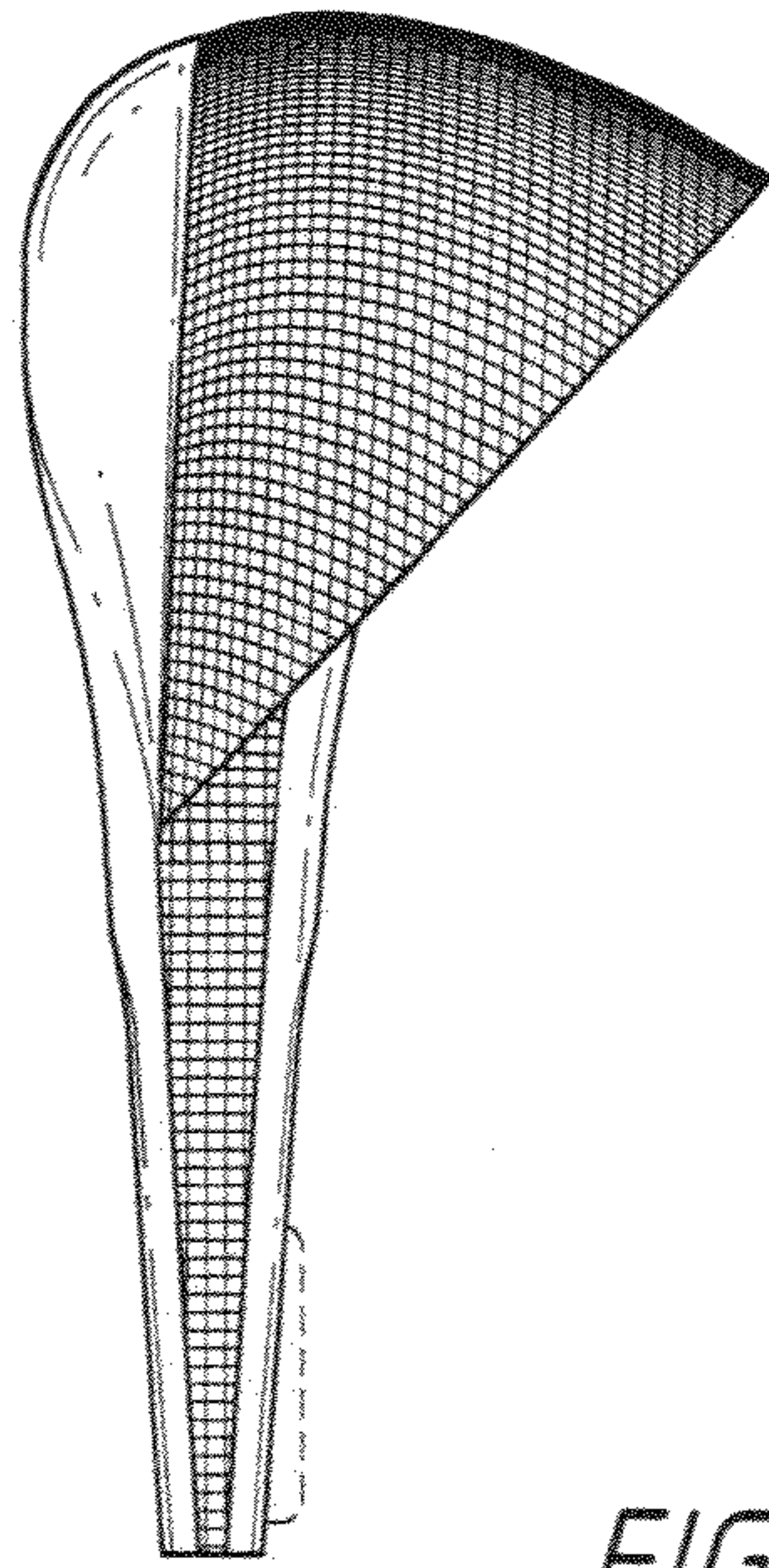

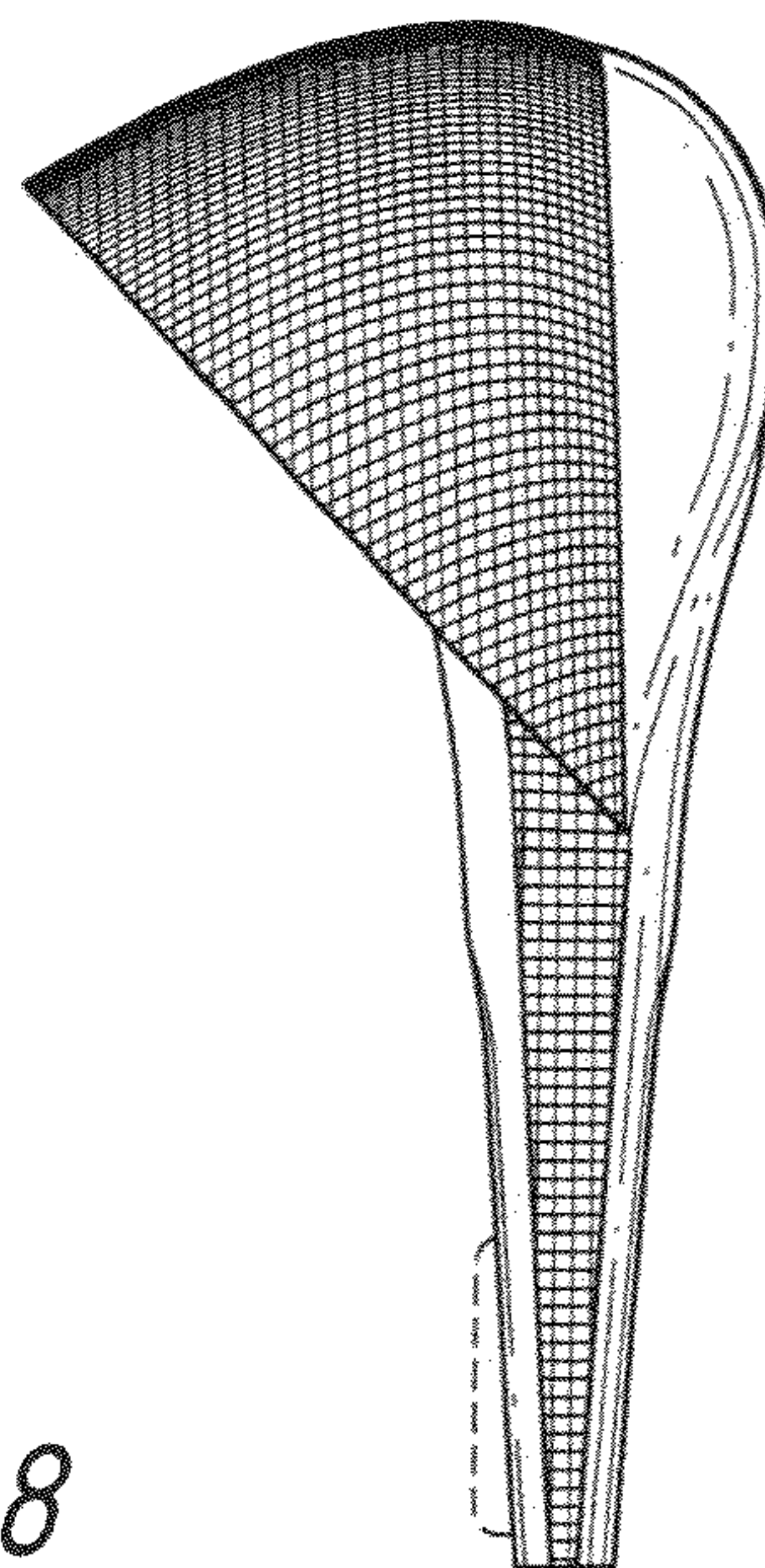
