The ornamental design for a pet treat, as shown and described.

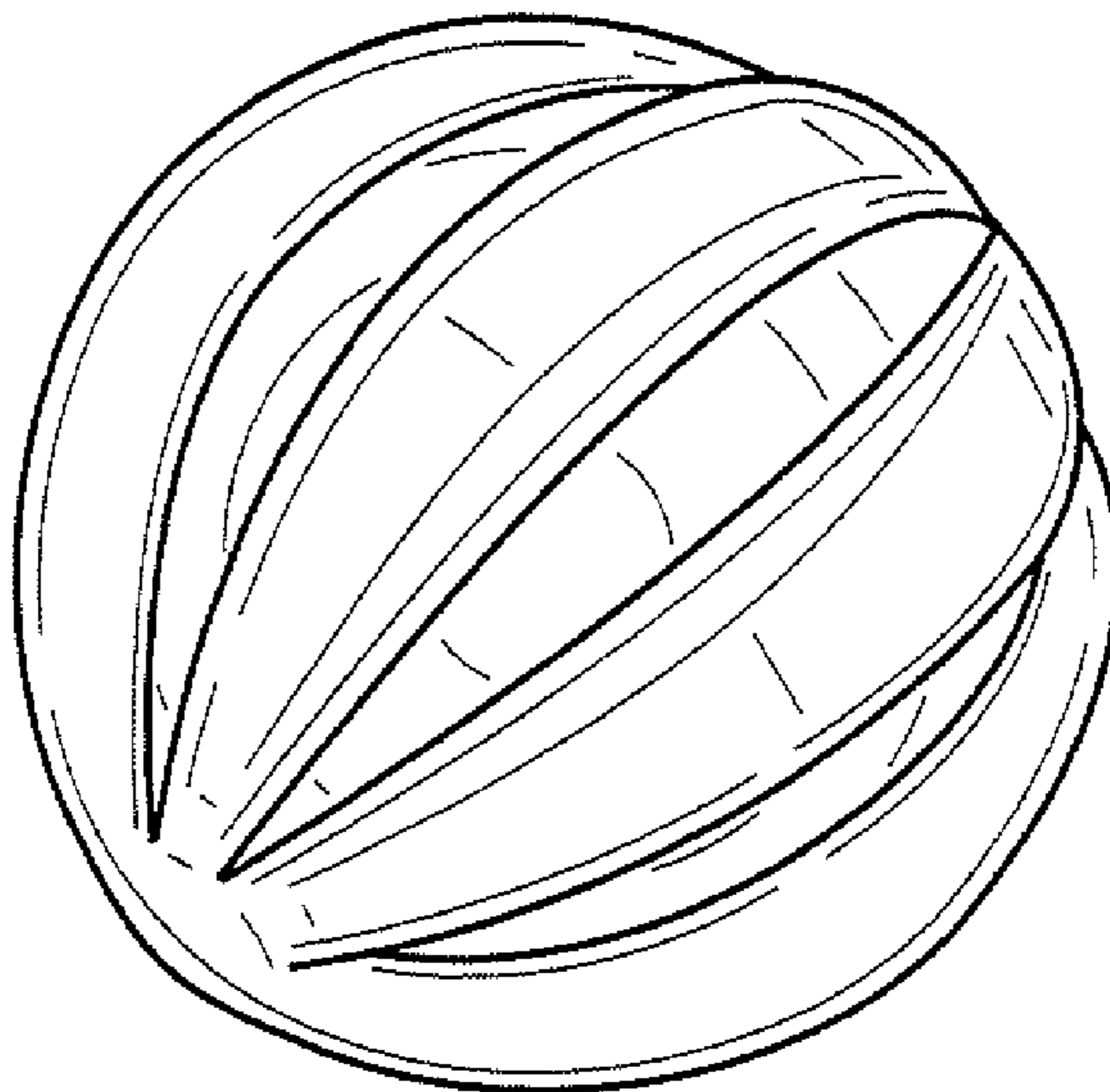
**DESCRIPTION**

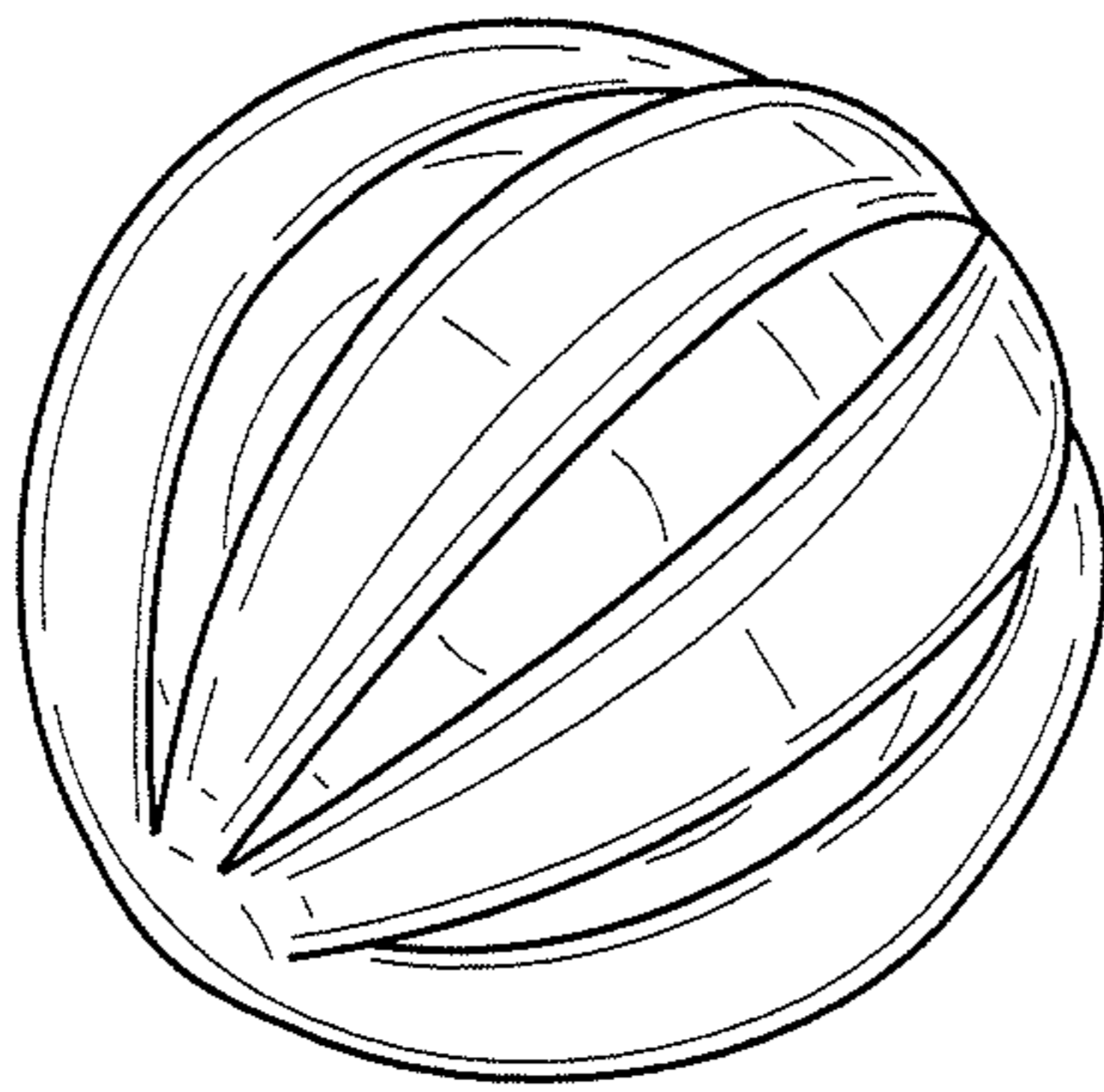

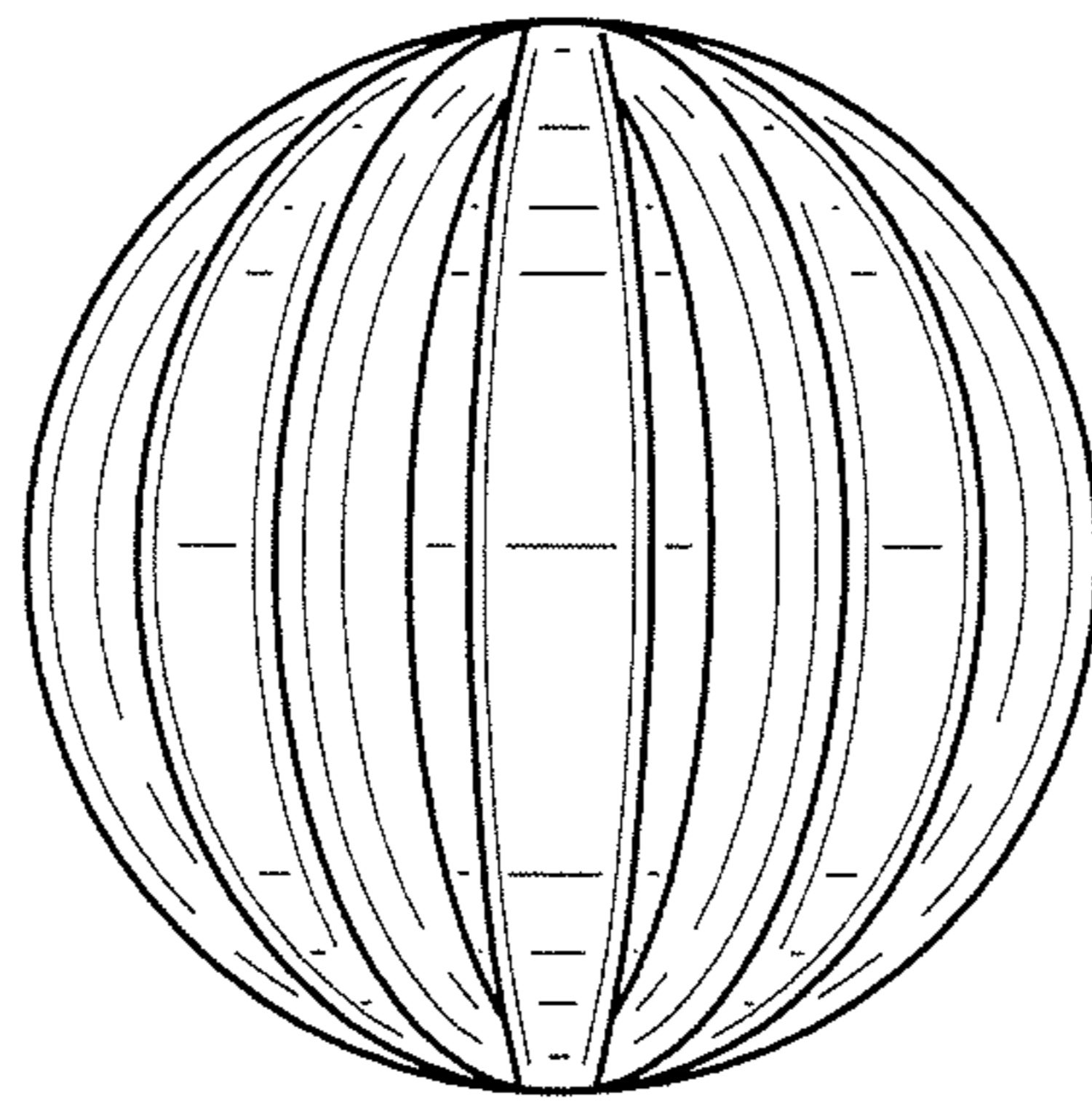

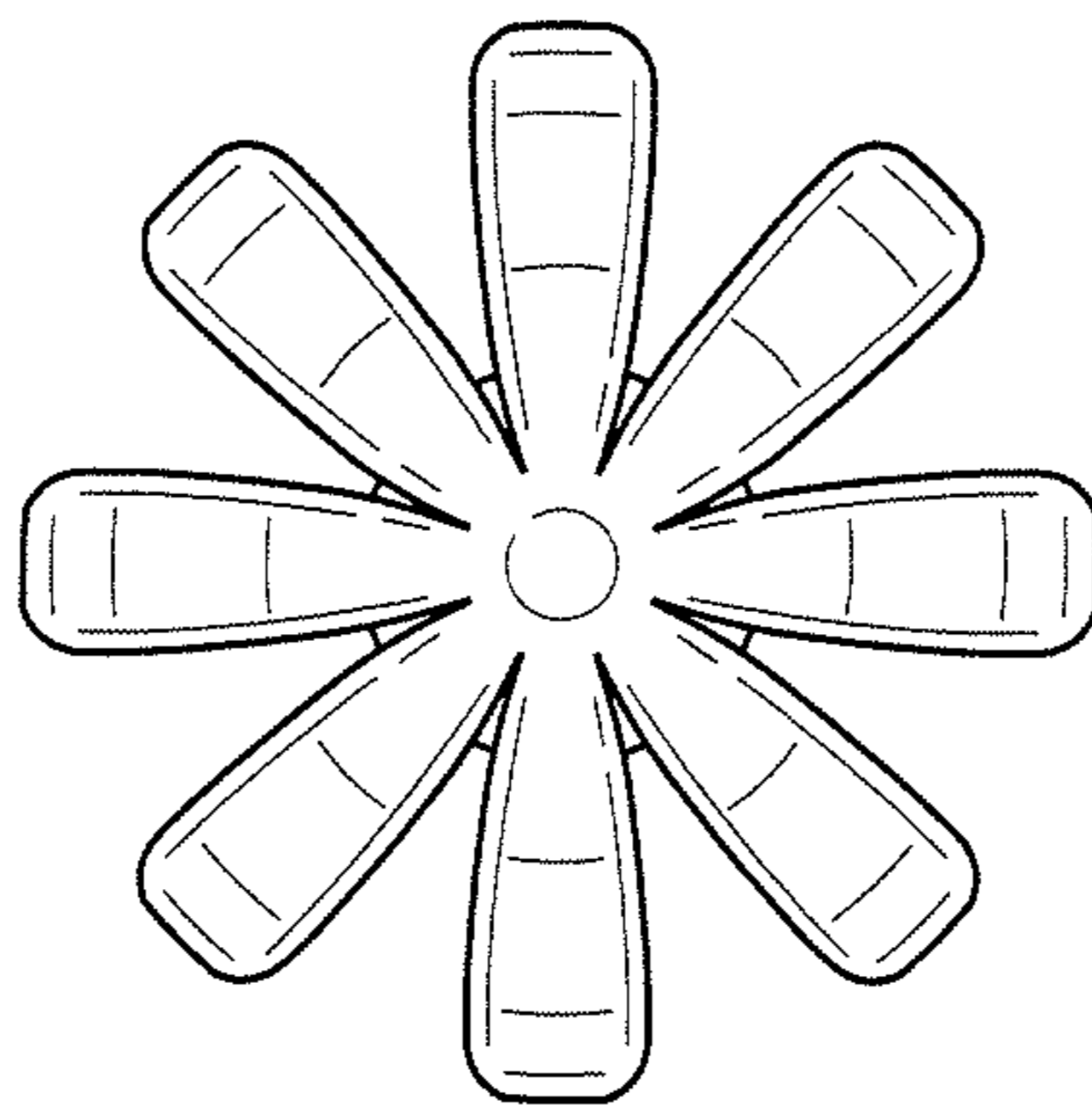
