(57) **CLAIM**

We claim the ornamental design for a hooded garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hooded garment, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

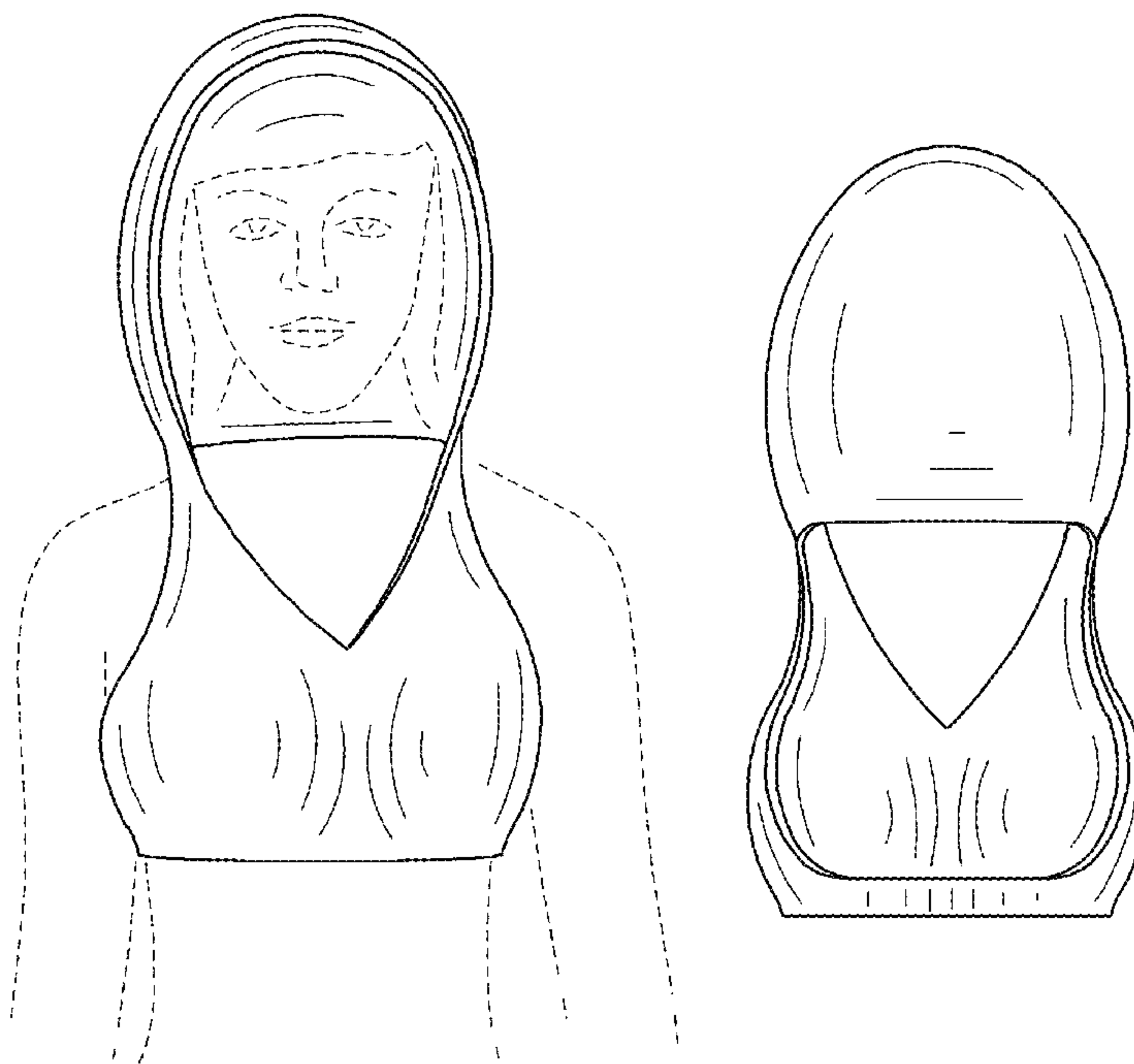
FIG. 4 is a left-side elevational view thereof, the right side elevational view being a mirror image thereof;

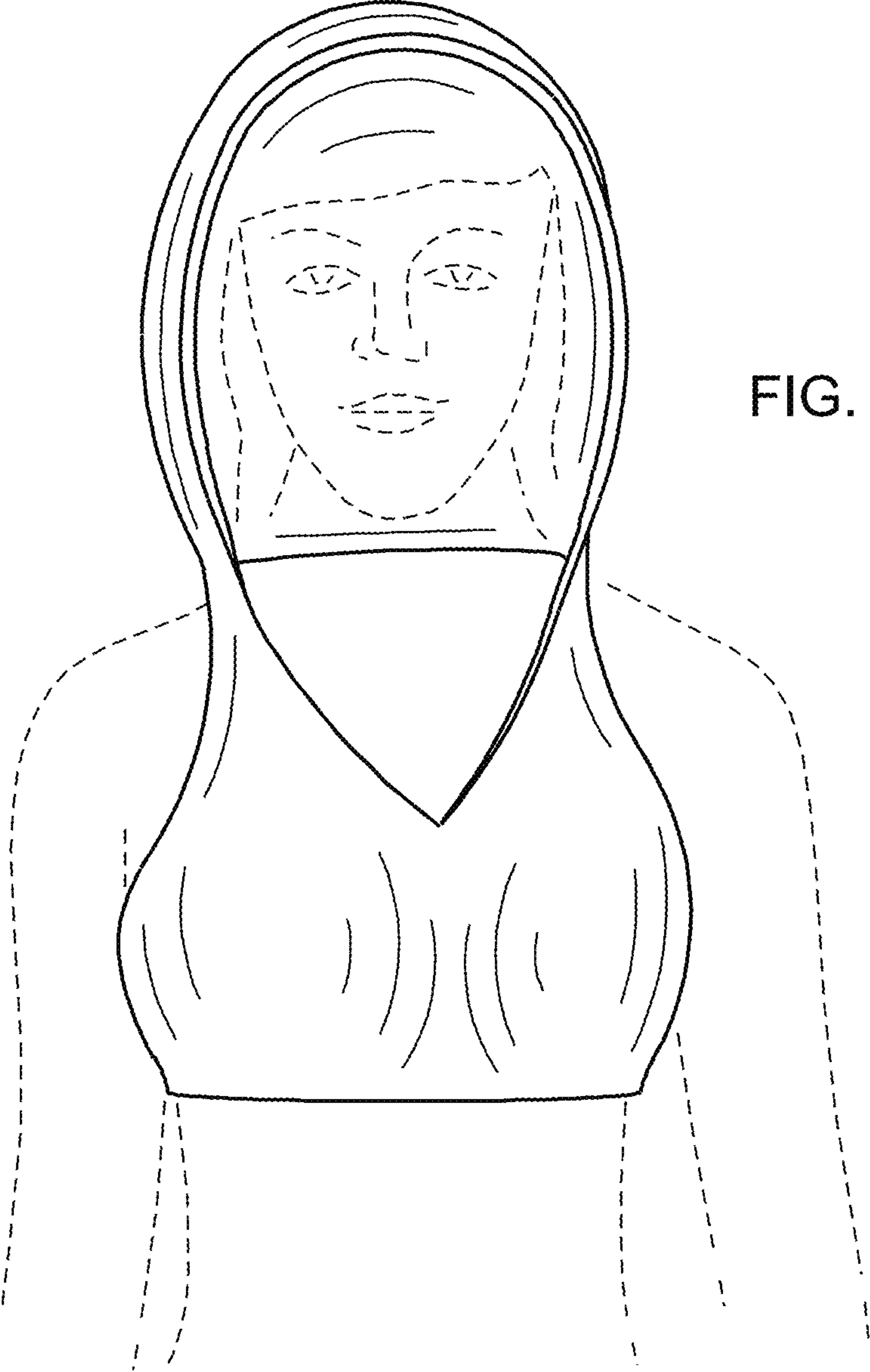

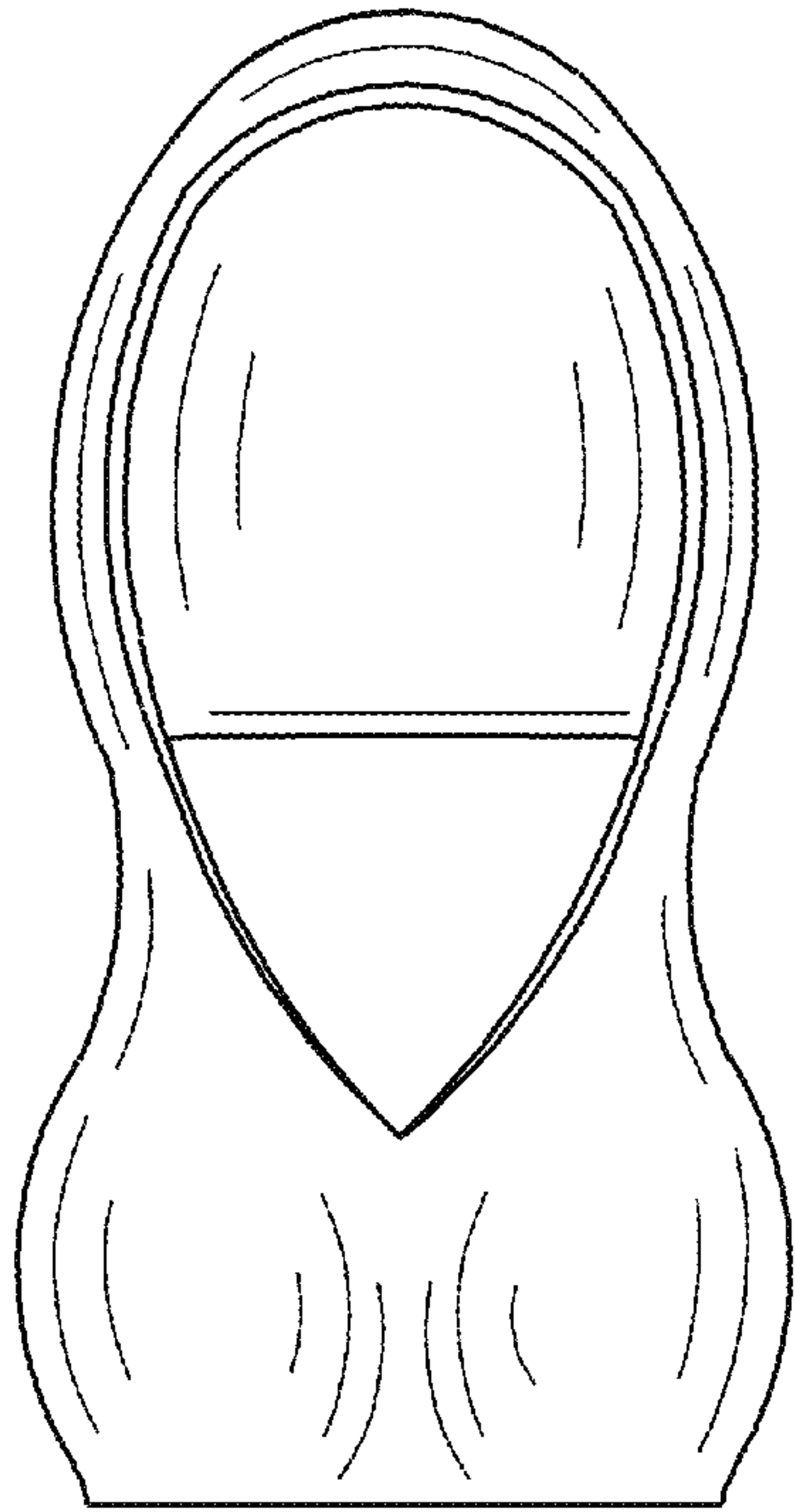

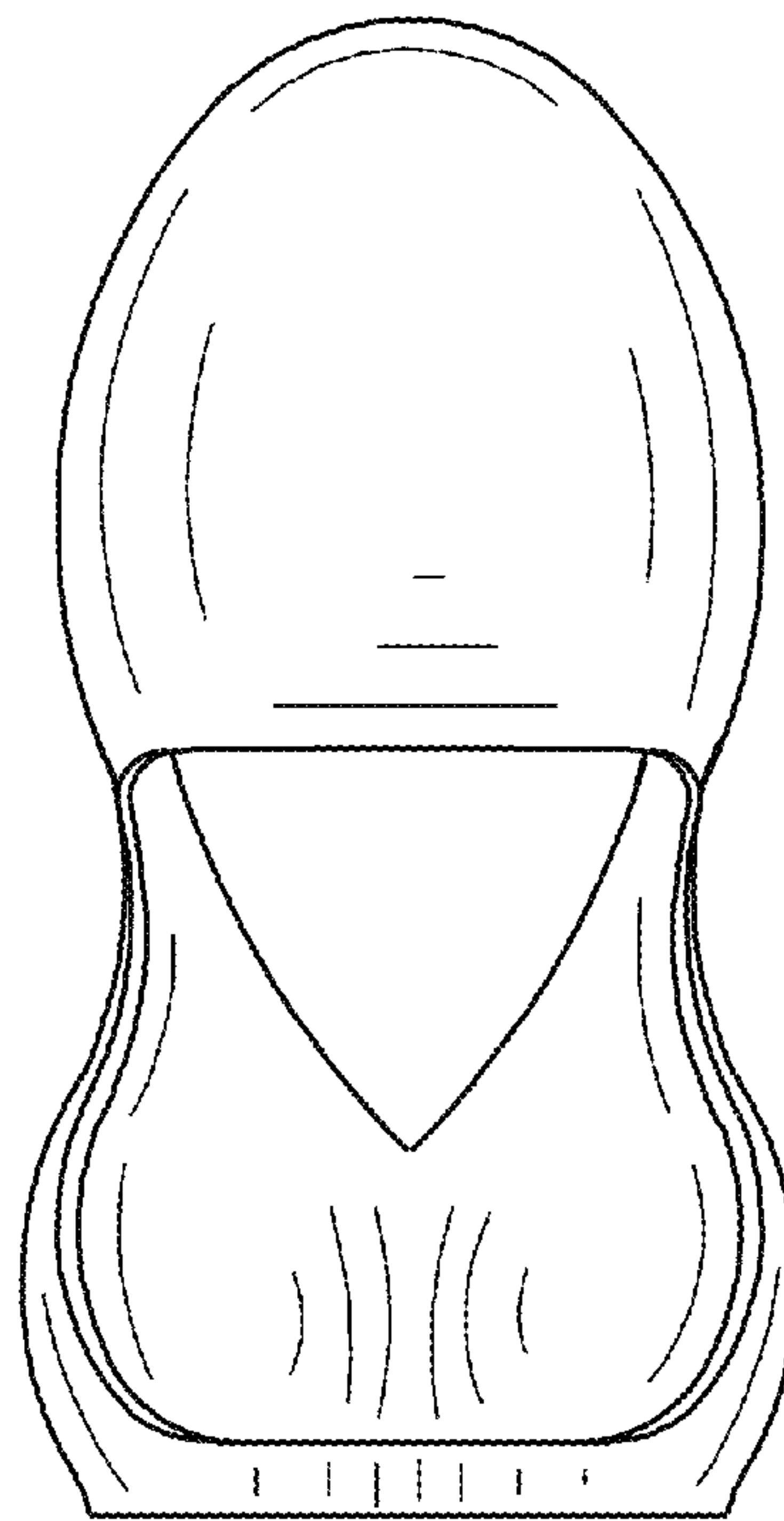

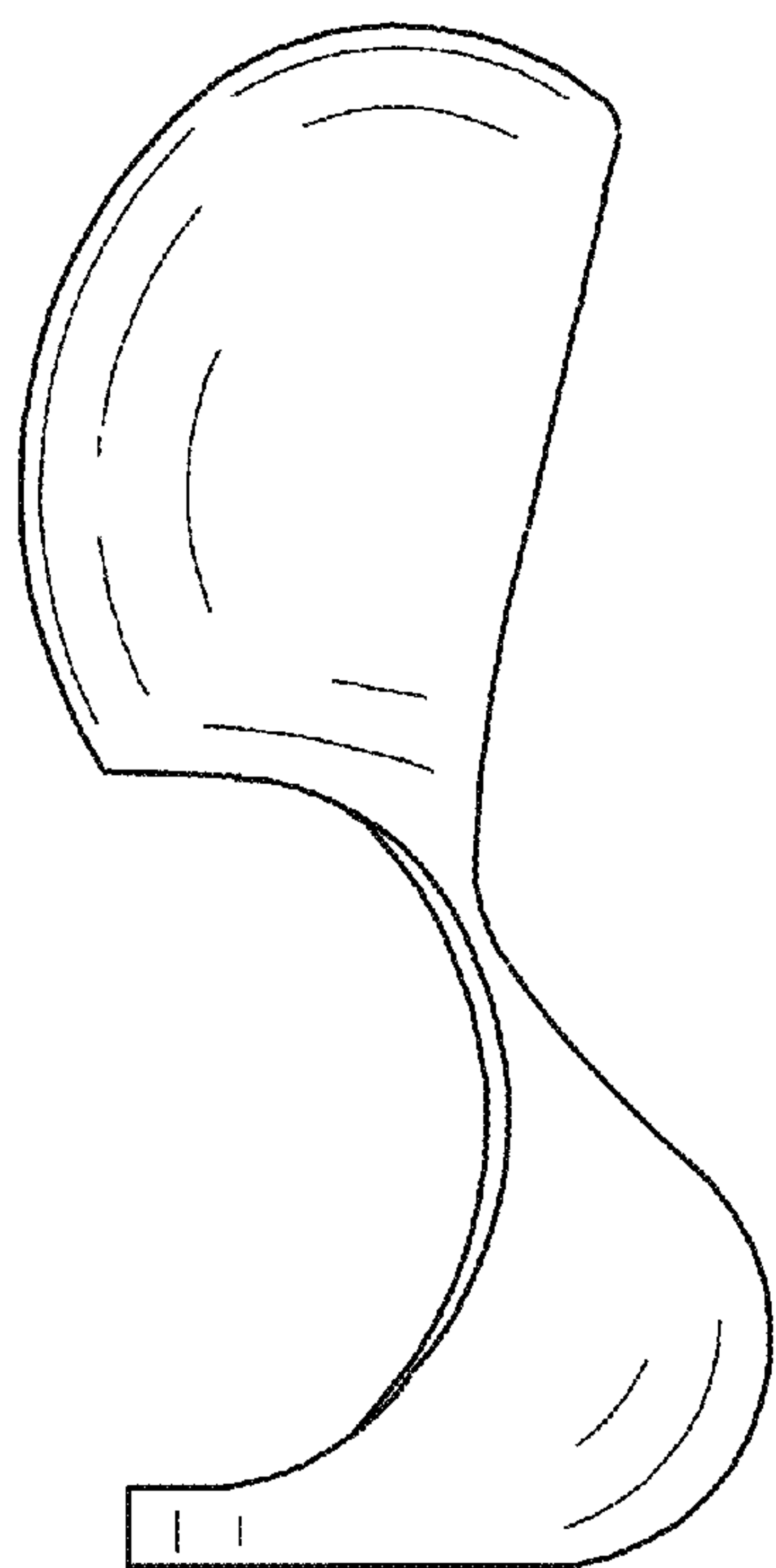

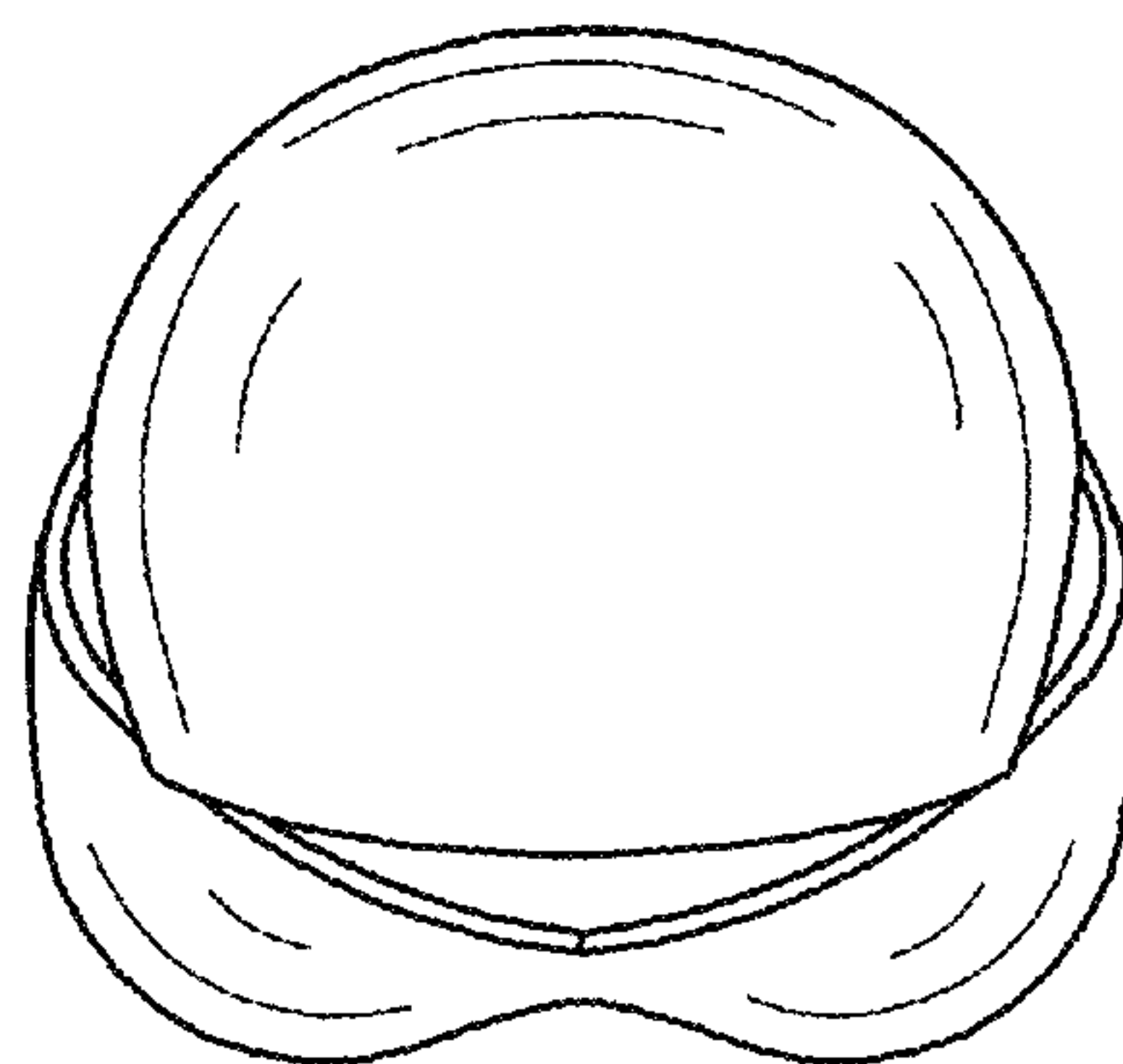

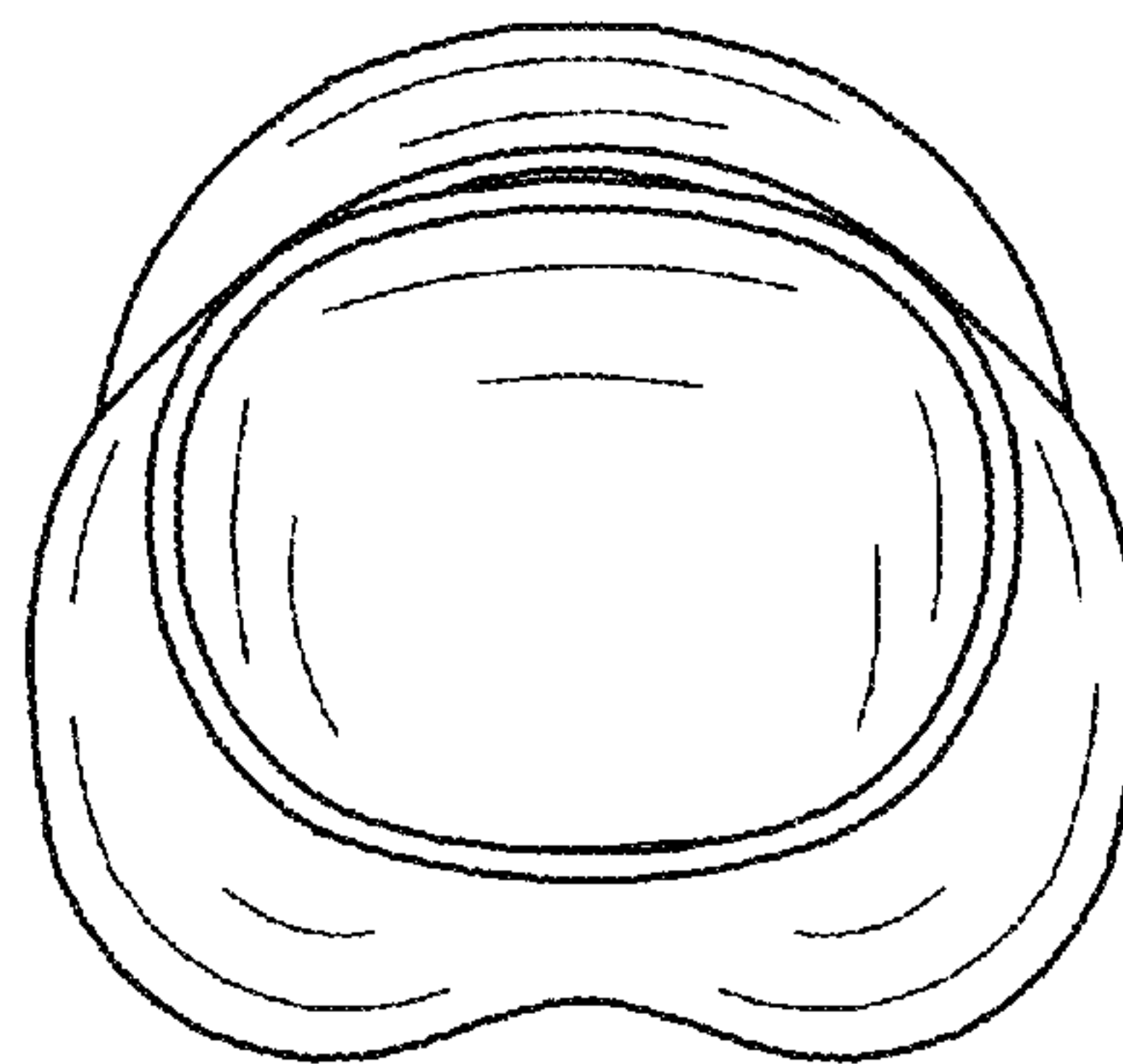
