The ornamental design for a upper for a shoe, as shown and described.

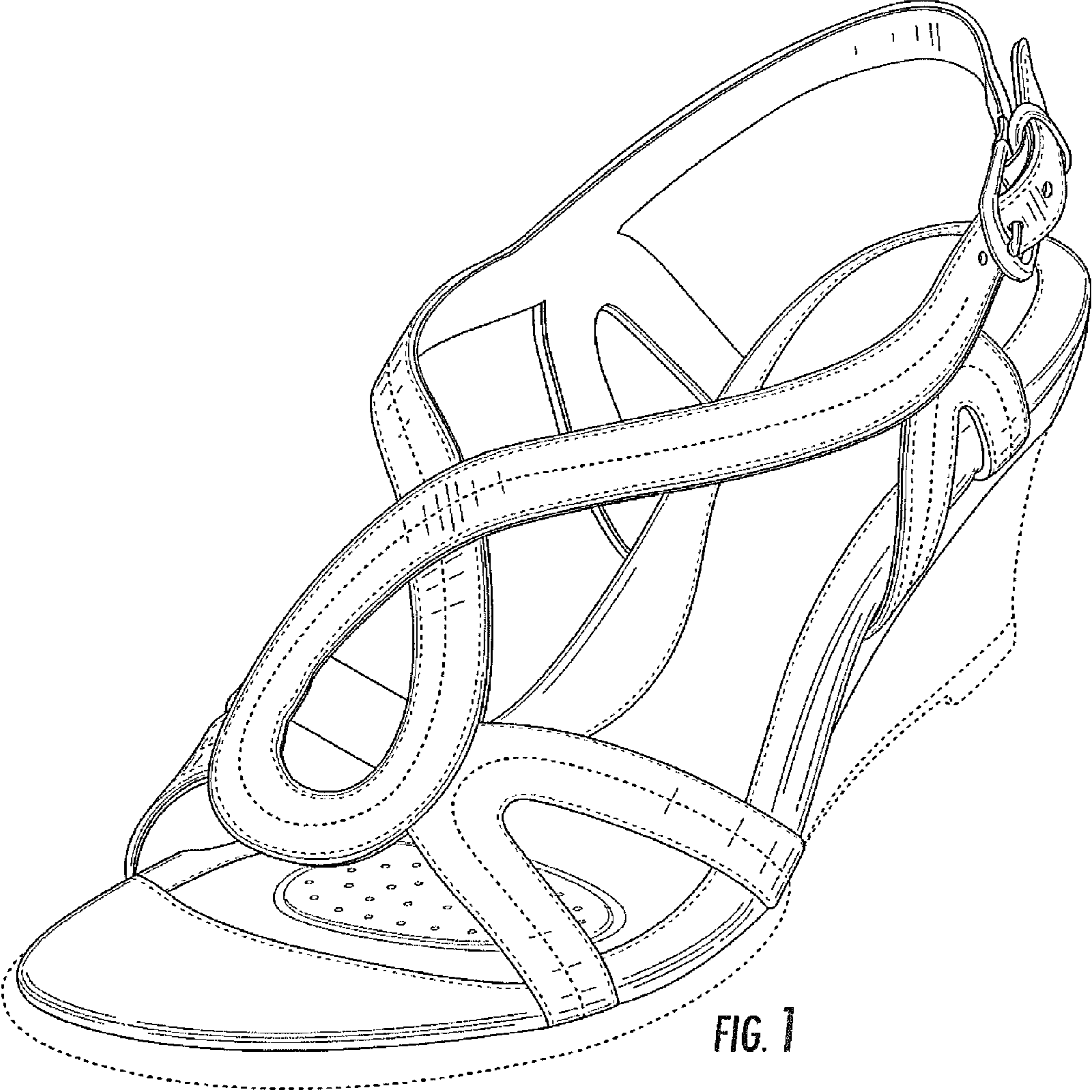
**DESCRIPTION**

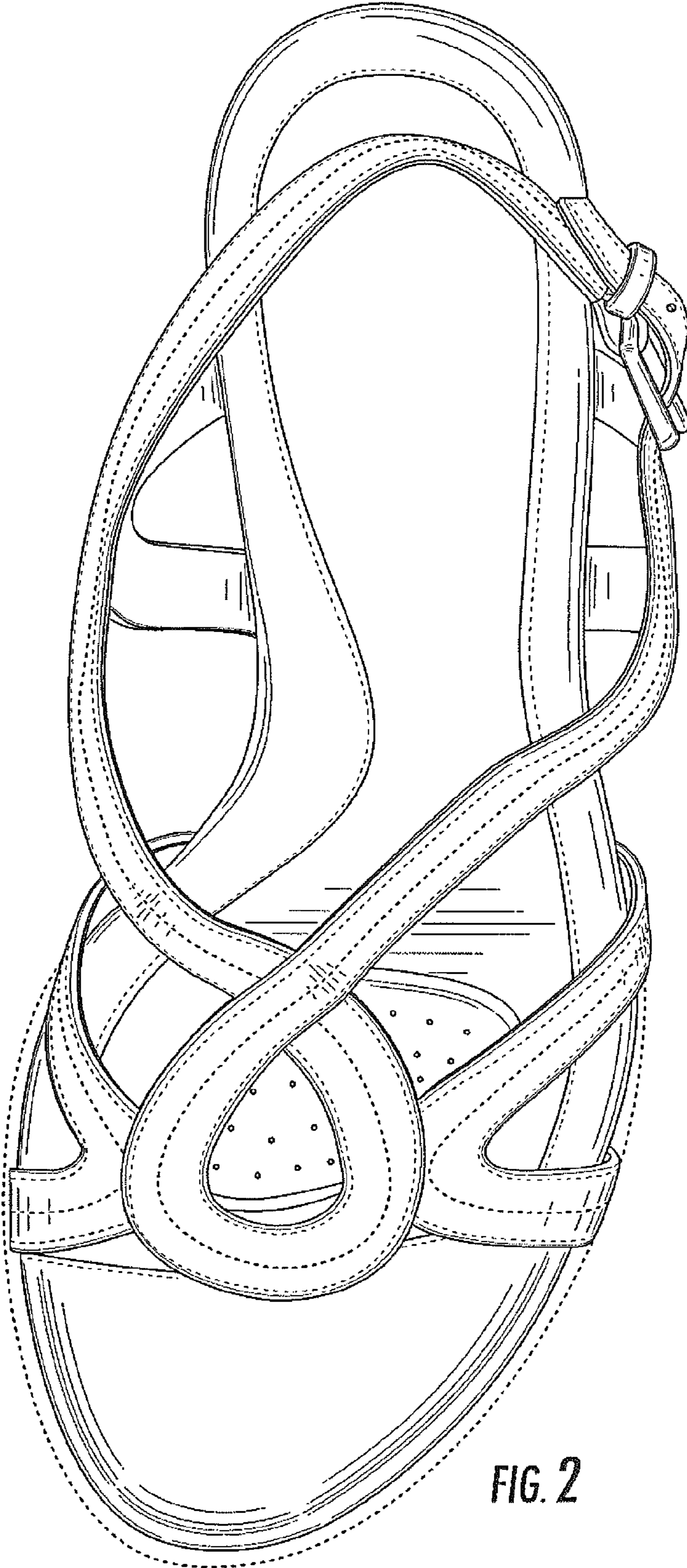

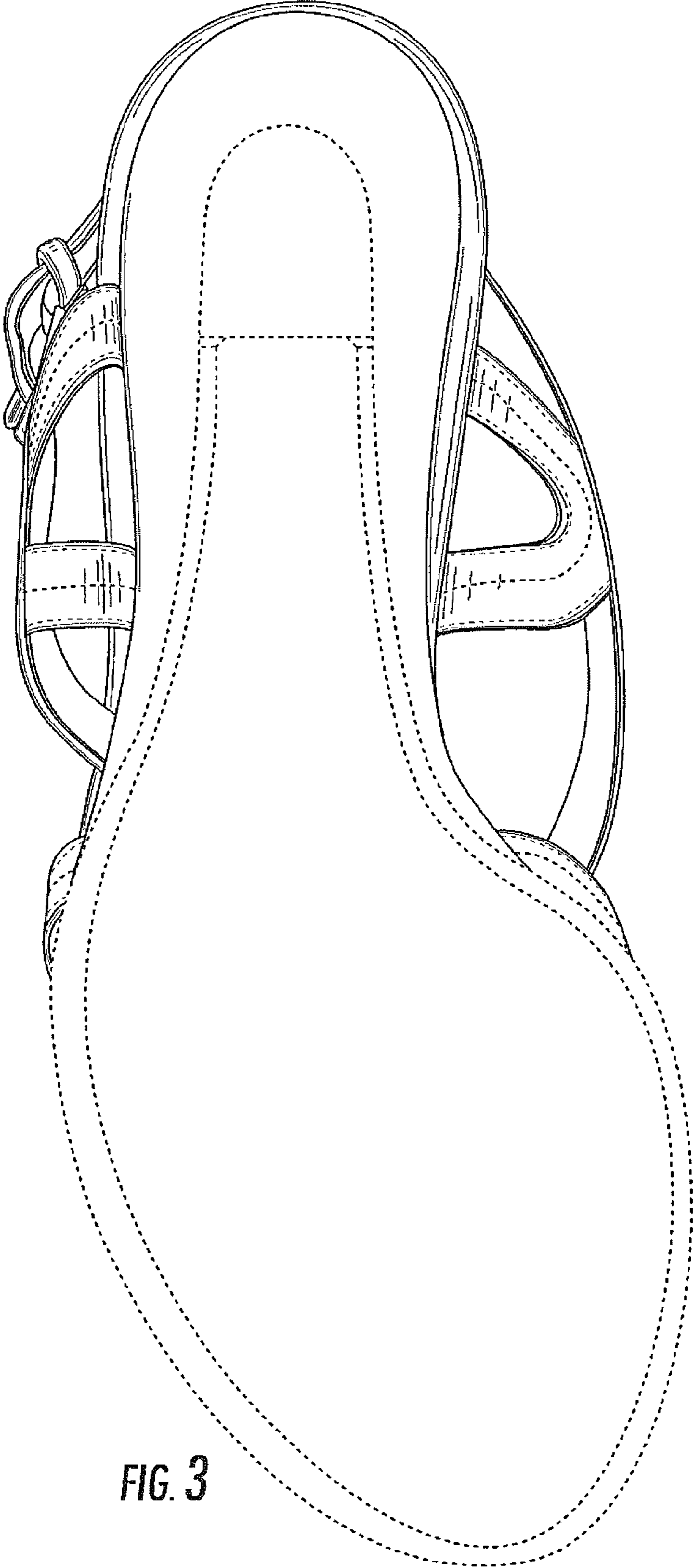

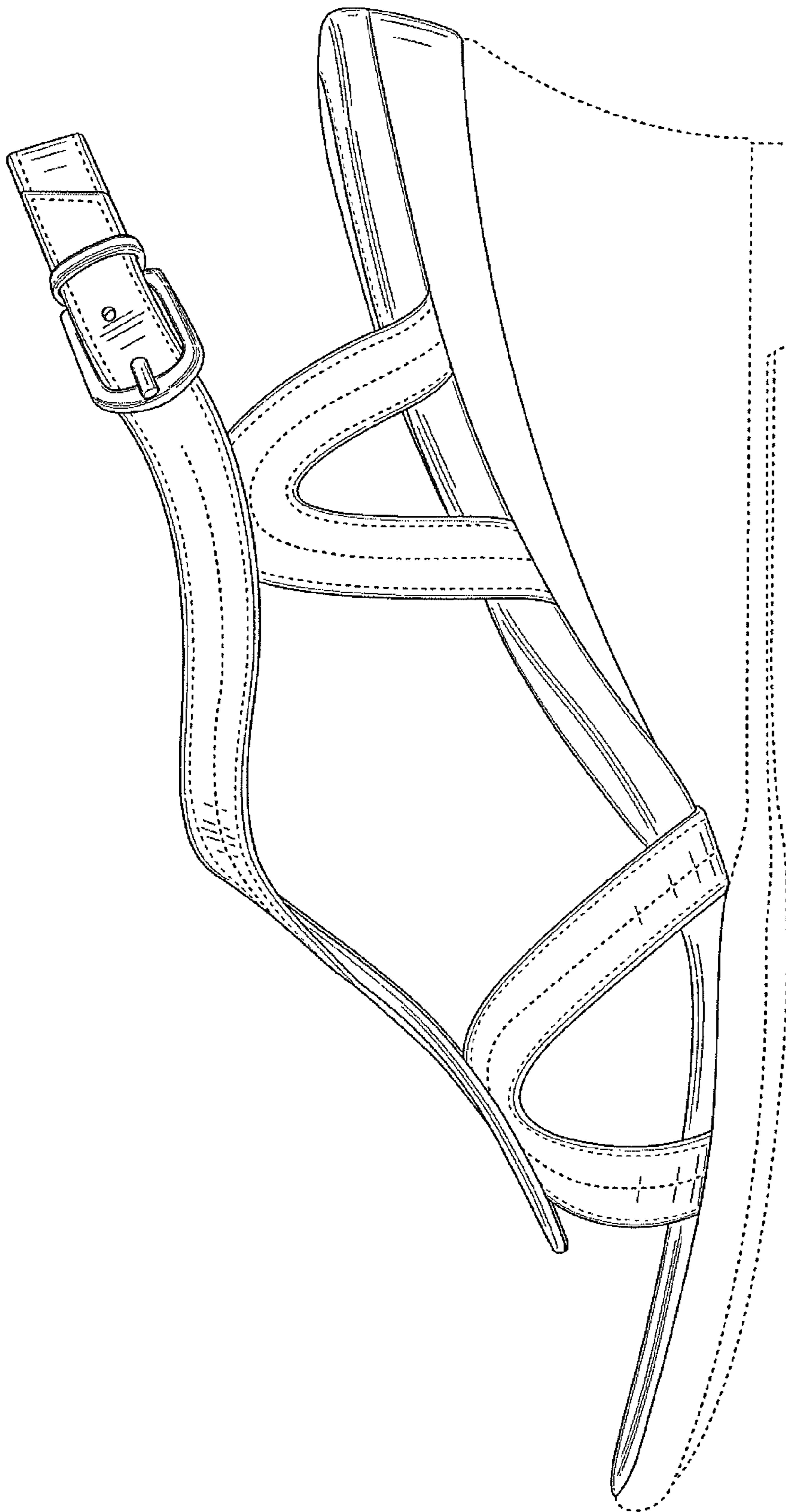

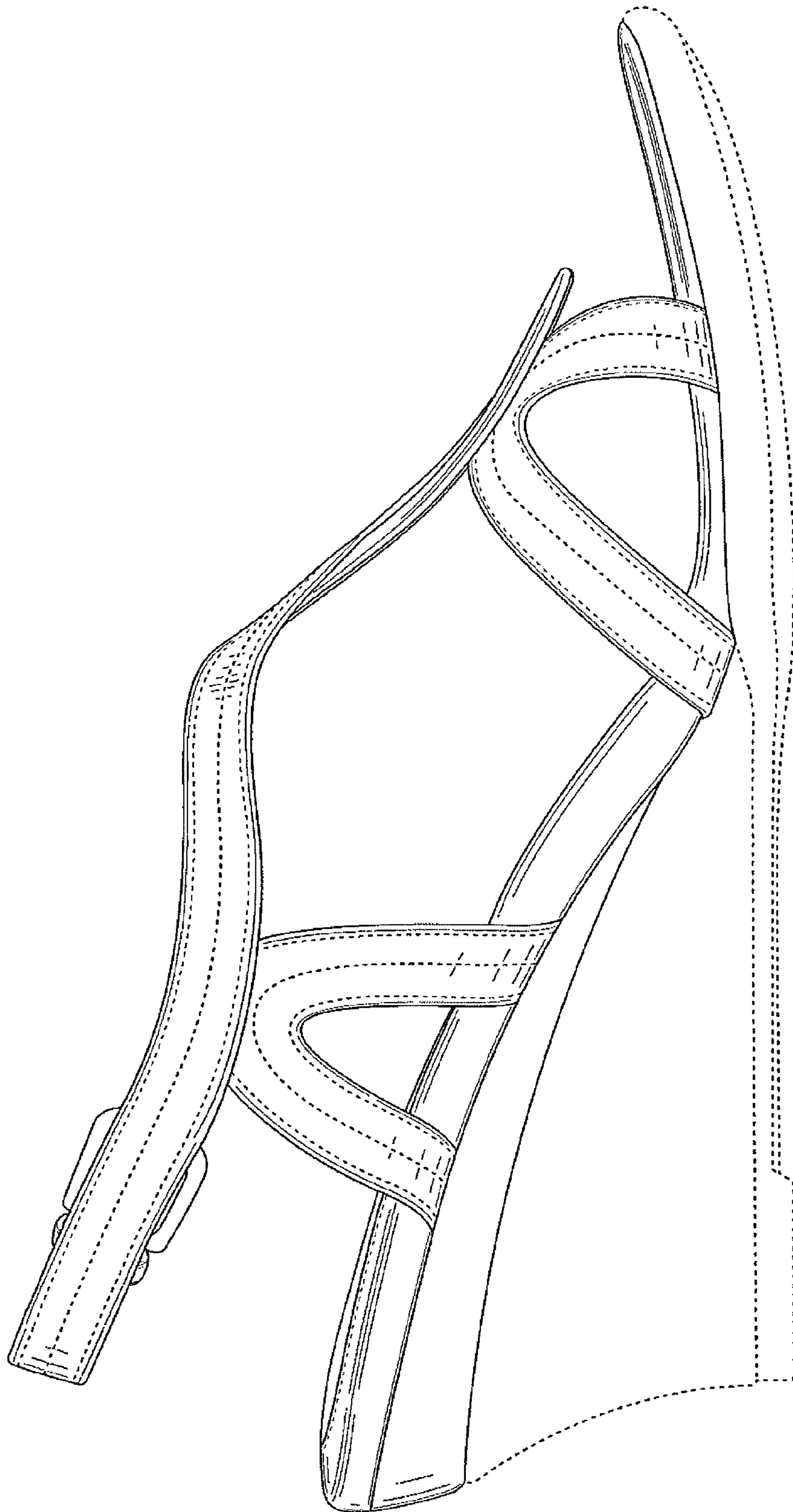

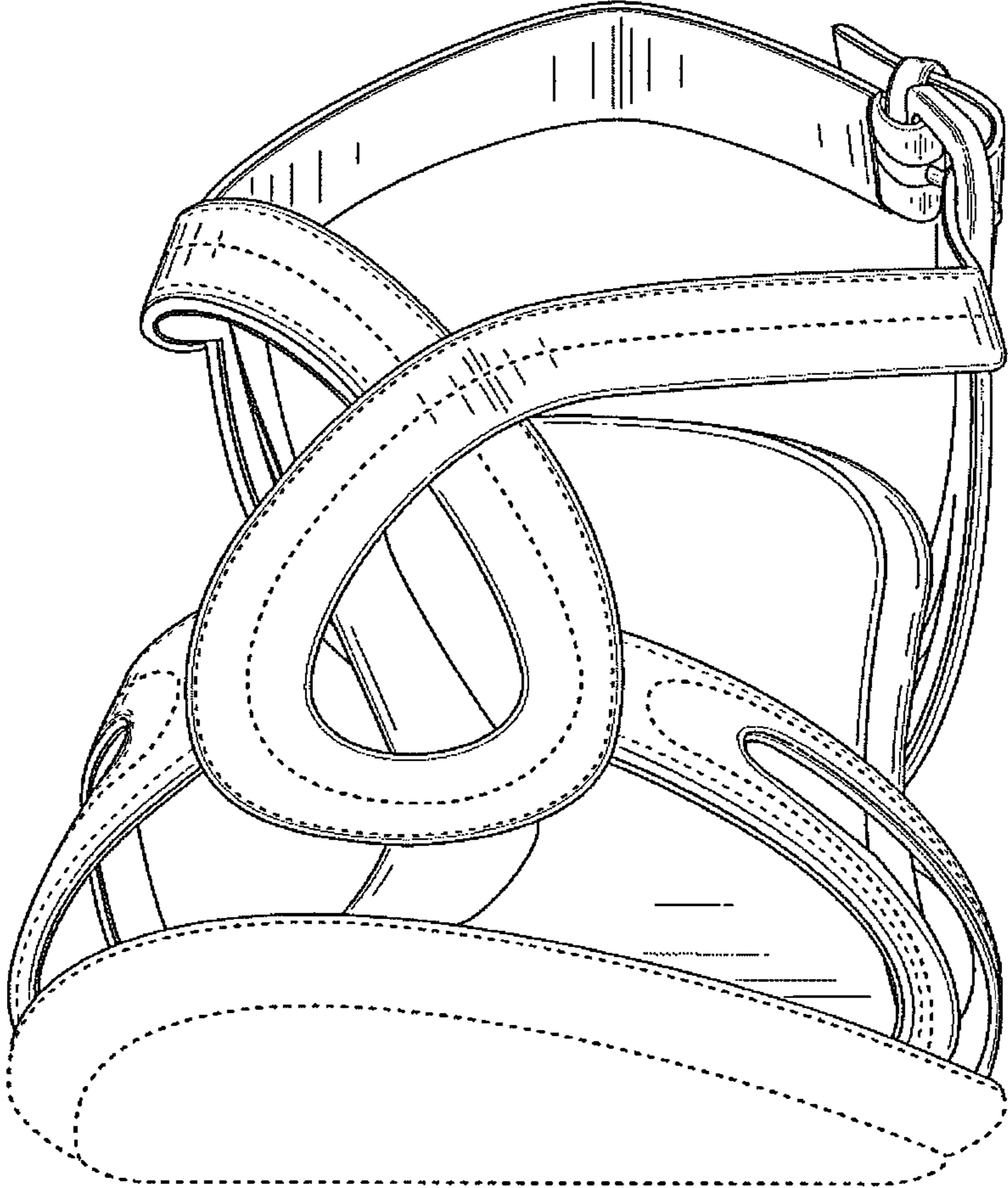

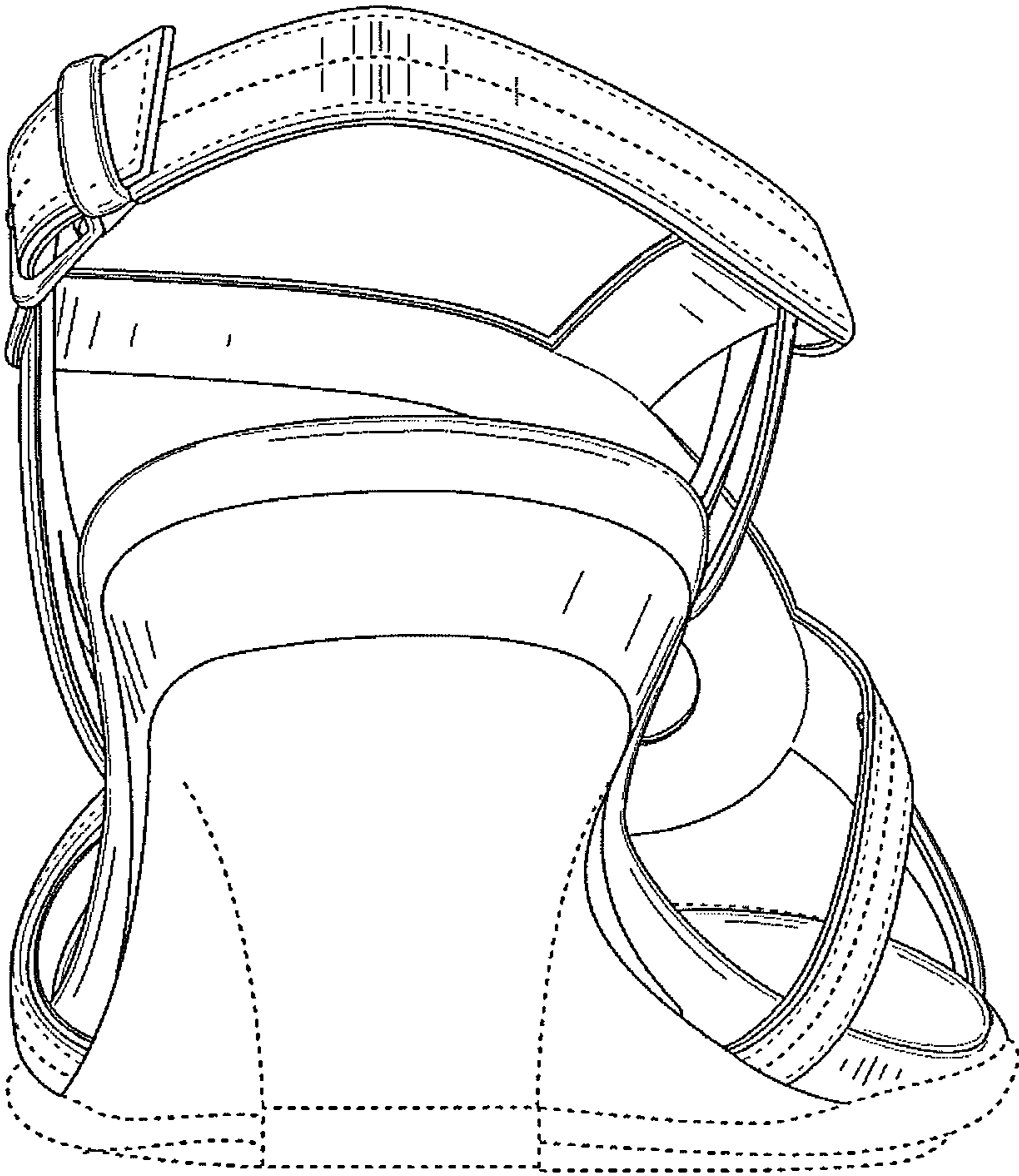
