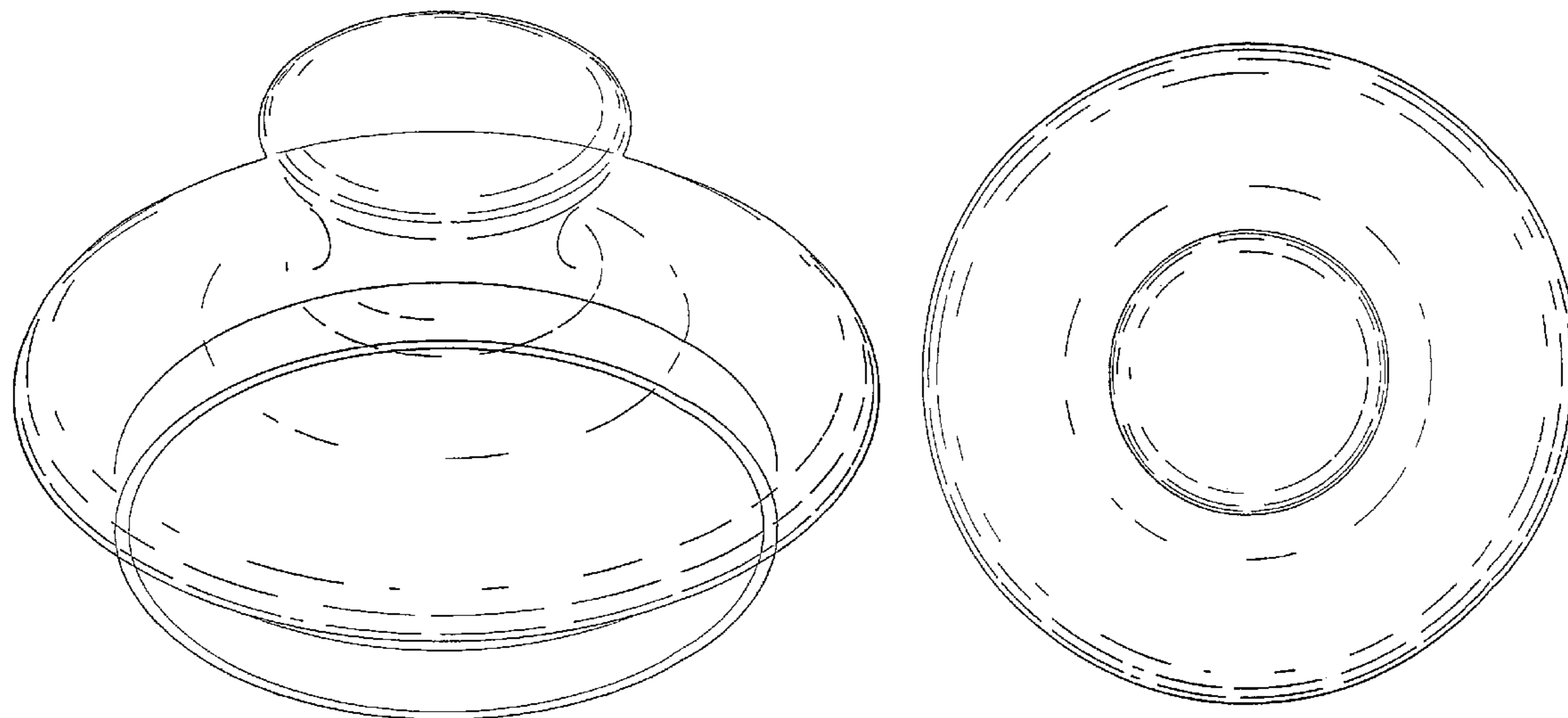
(57) **CLAIM**

The ornamental design for a combination bowl and lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combination bowl and lid;
FIG. 2 is a reduced top view thereof;
FIG. 3 is a reduced bottom view thereof;
FIG. 4 is a reduced left side view thereof with the remaining sides being identical thereto; and,
FIG. 5 is a cross-sectional view taken along a line and viewed in the direction of arrows 5-5 of FIG. 4.

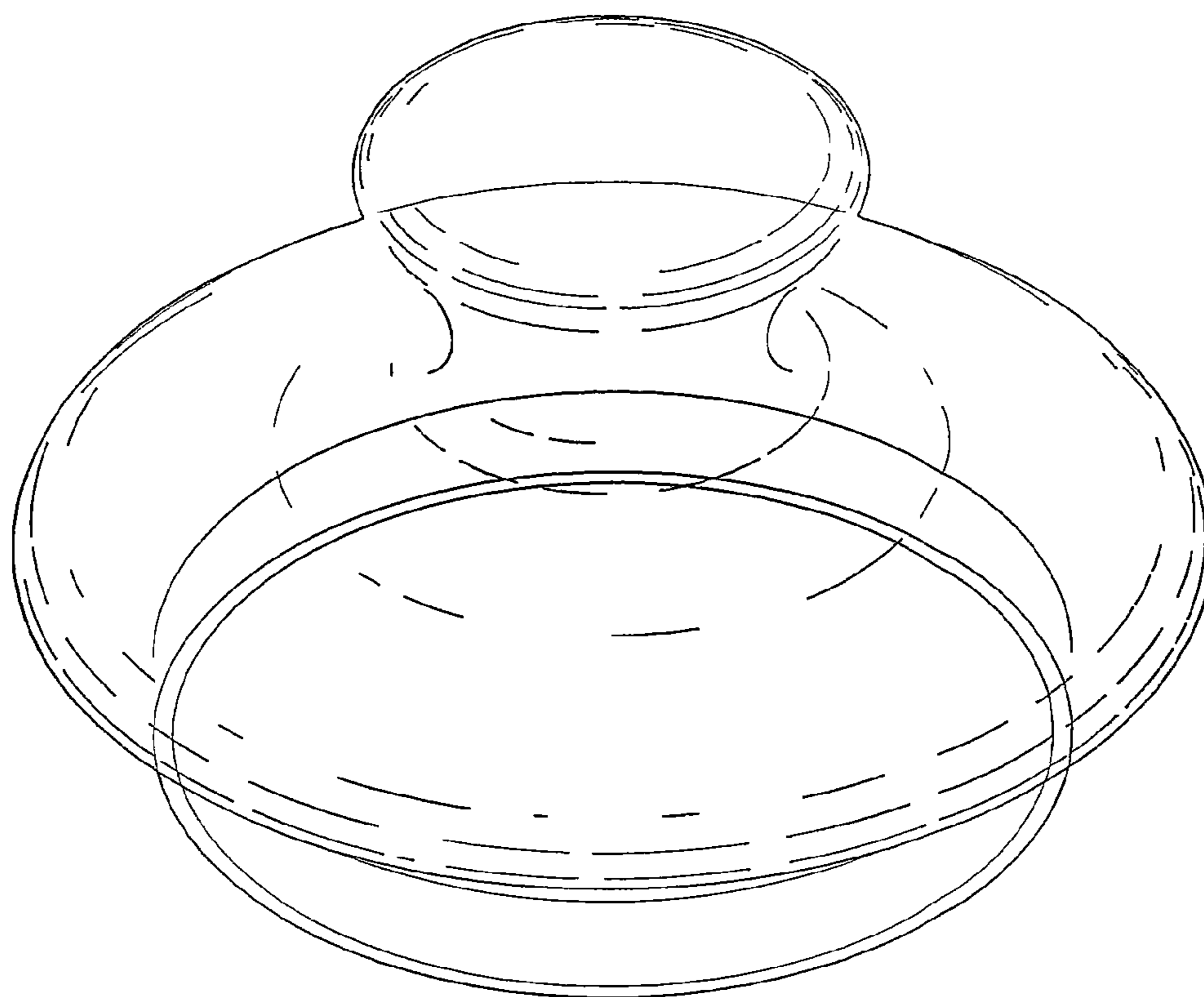

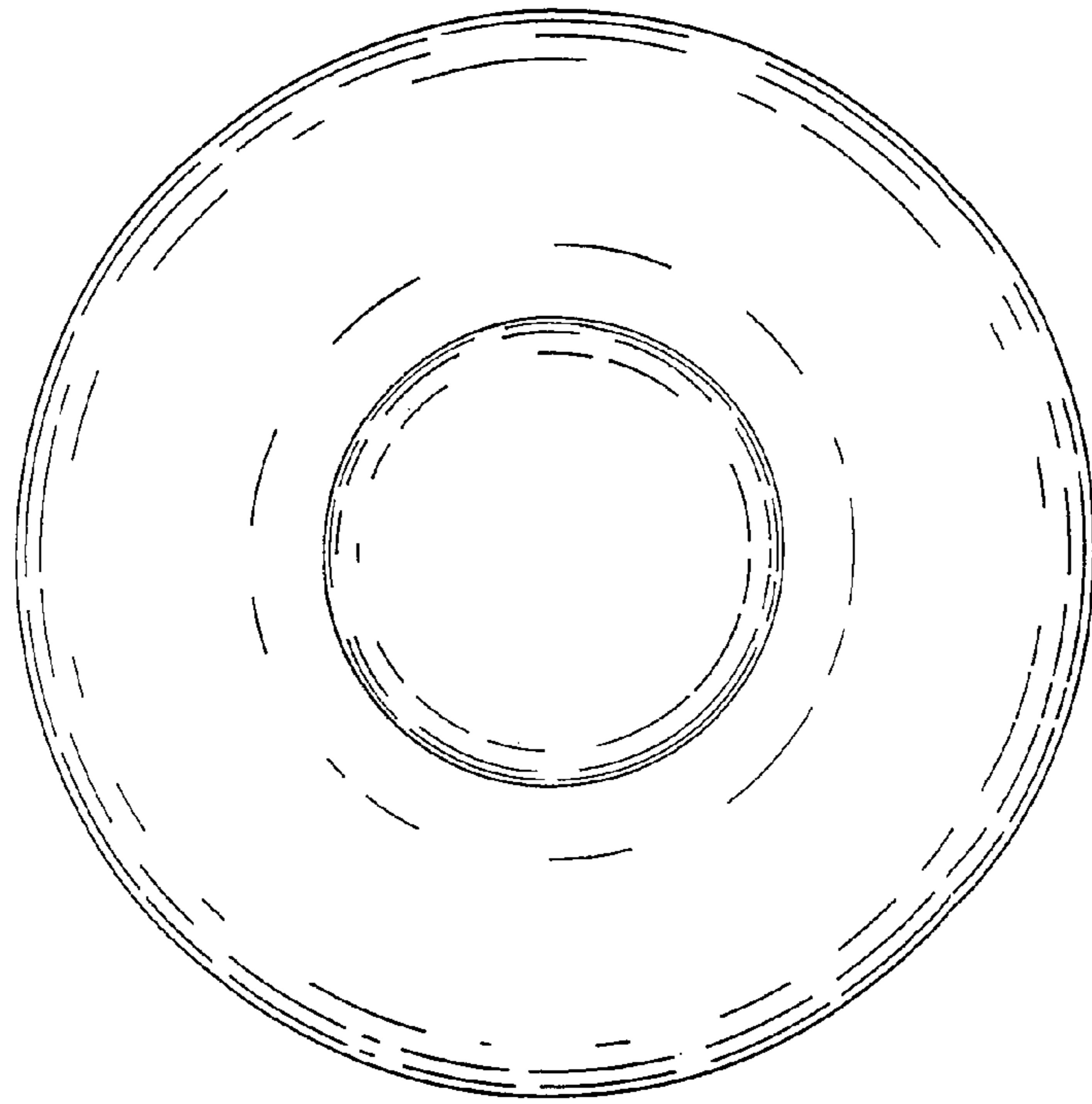

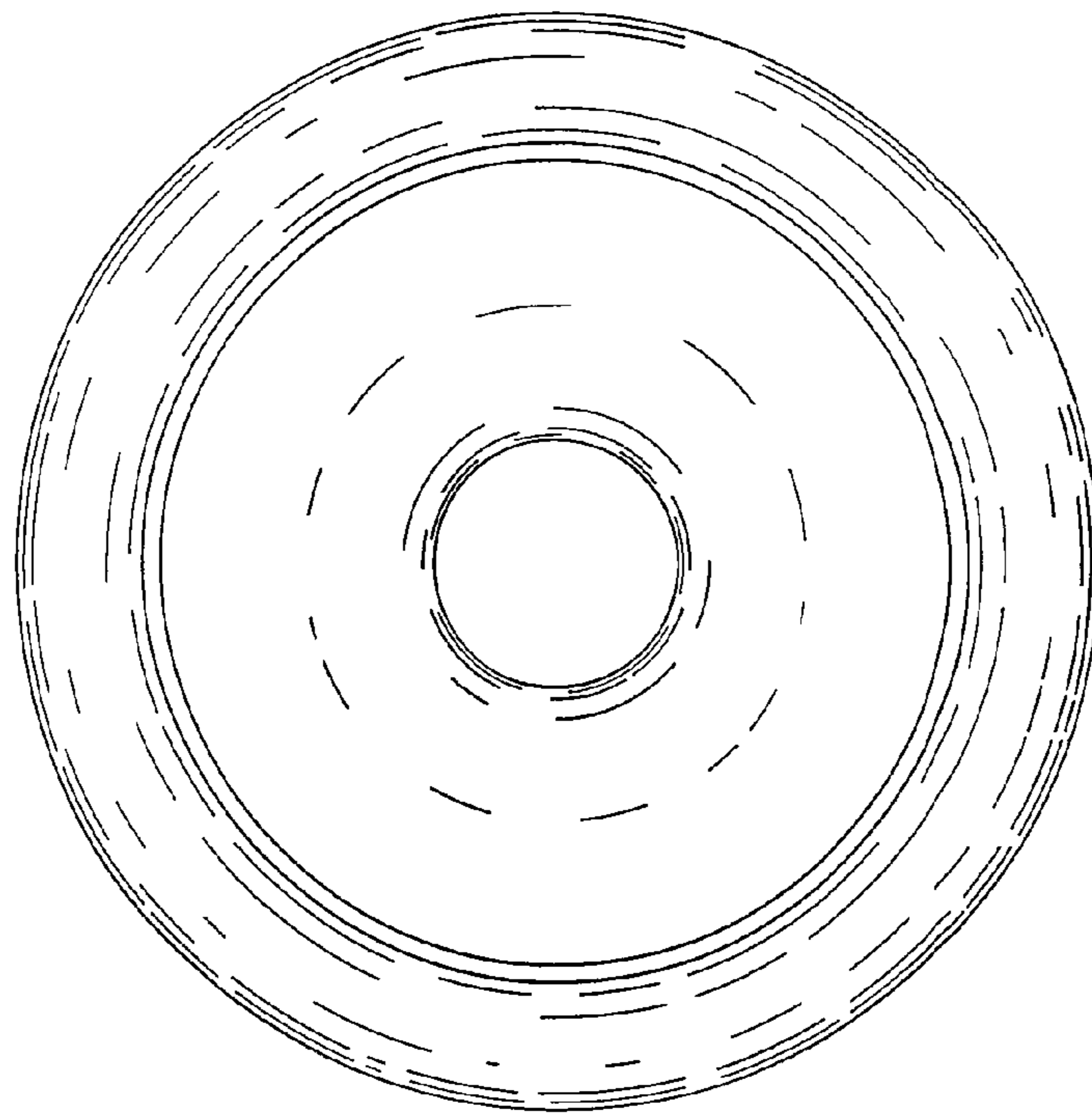

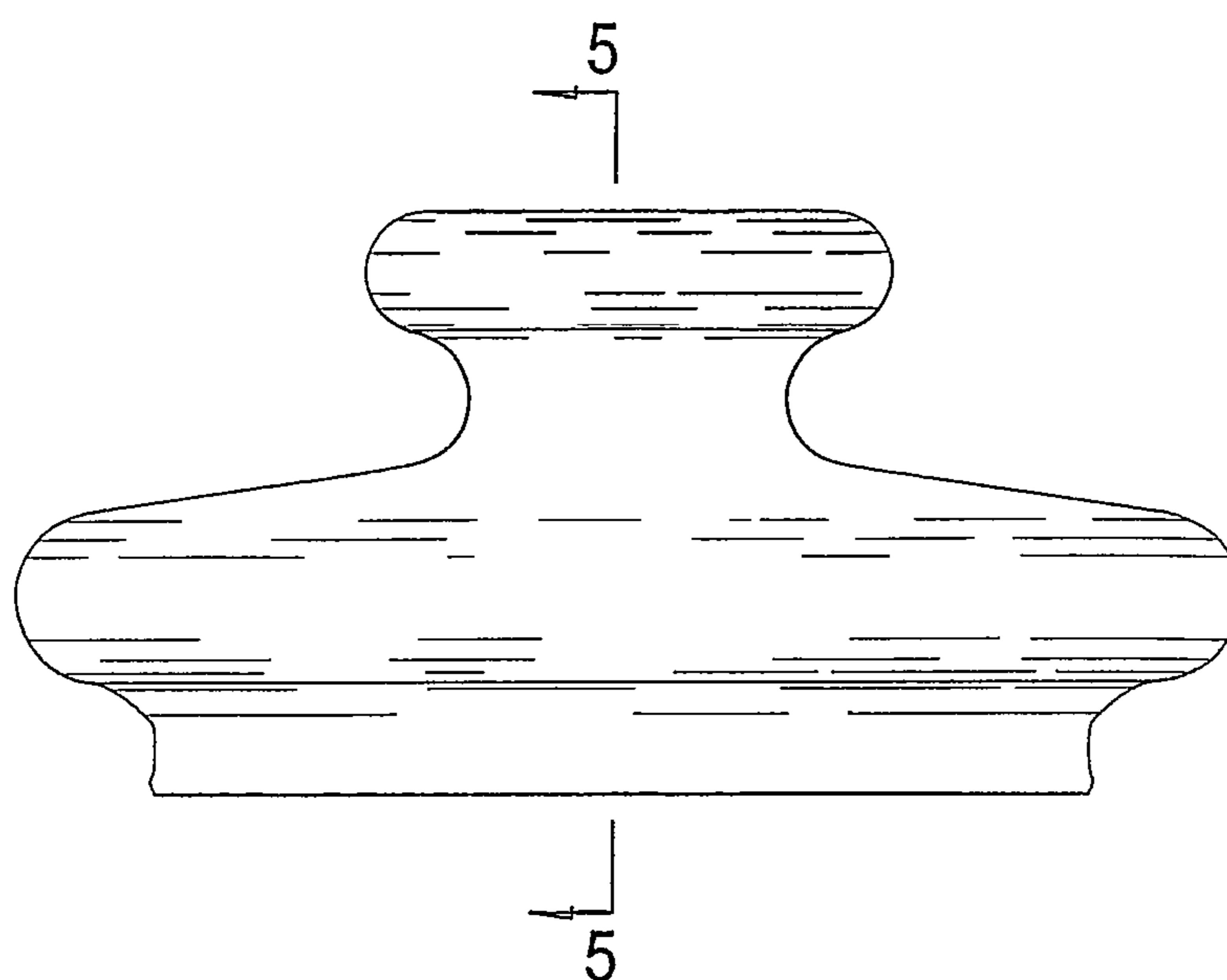

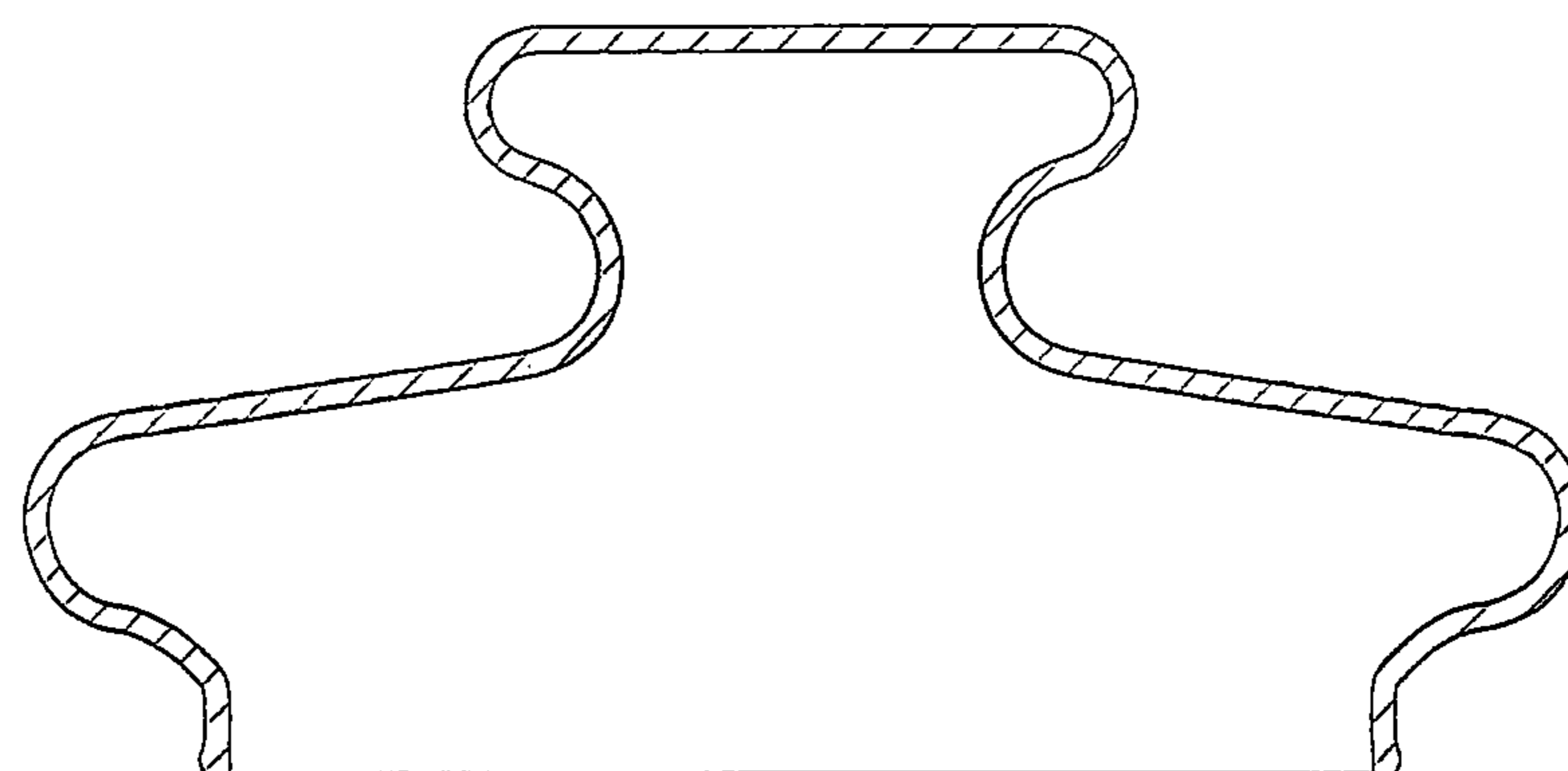
