The ornamental design for a handle having bifurcated brackets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the handle having bifurcated brackets showing my new design;

FIG. 2 is a side view thereof, the opposite side view being identical thereof;

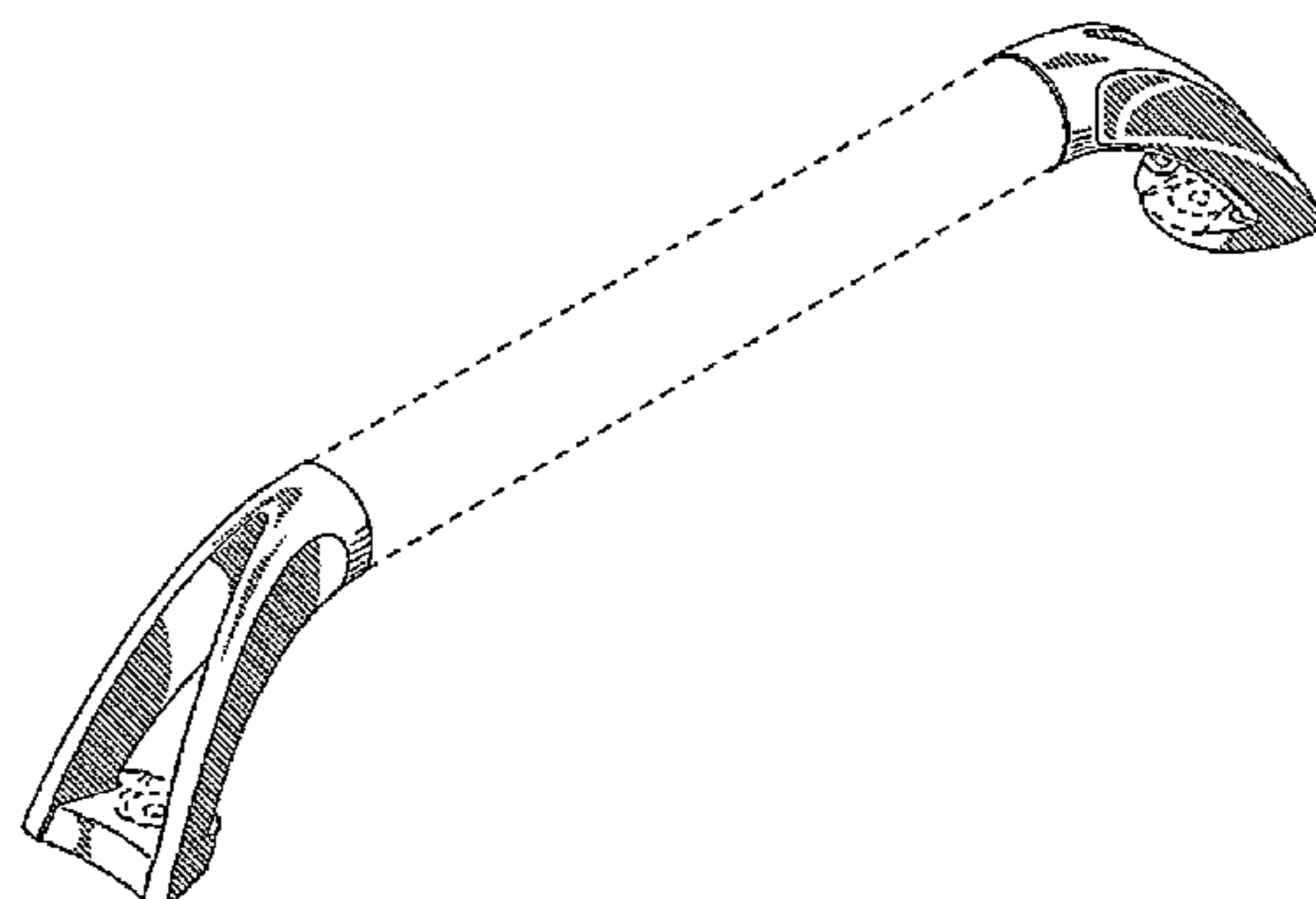
FIG. 3 is a top view thereof;

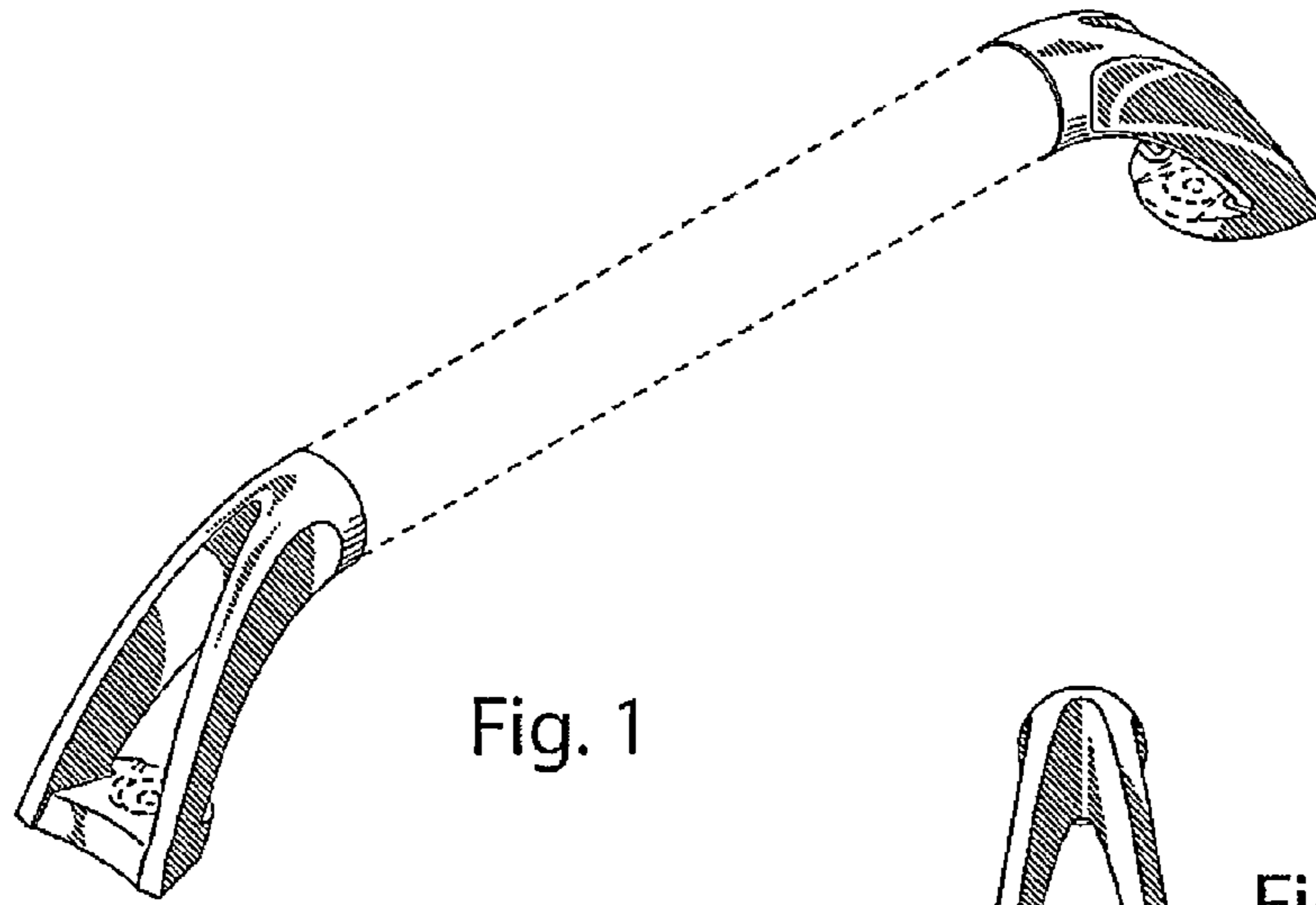

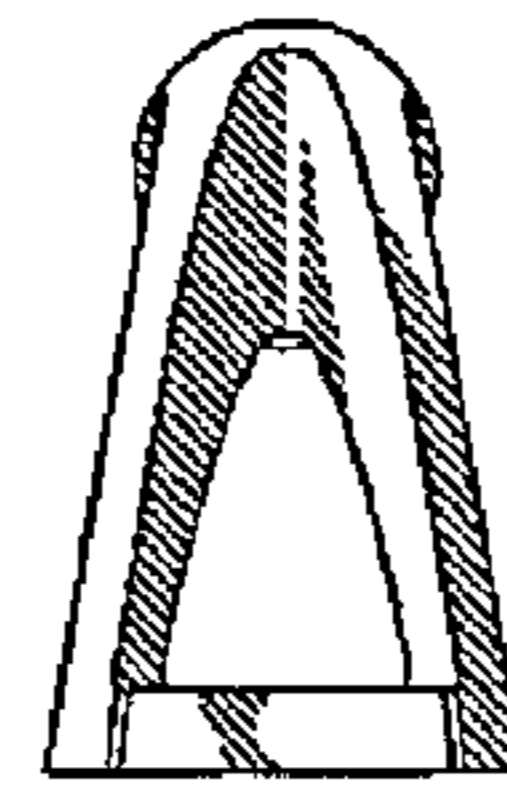

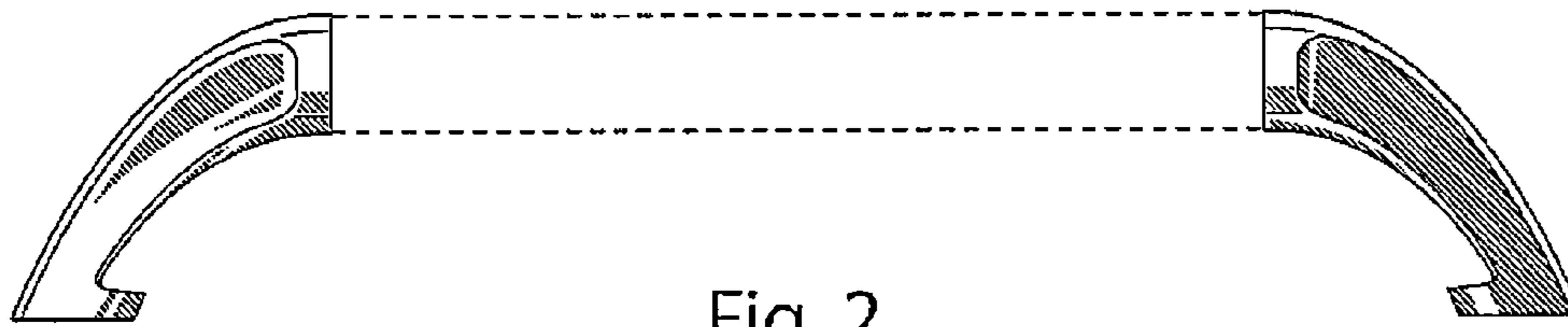

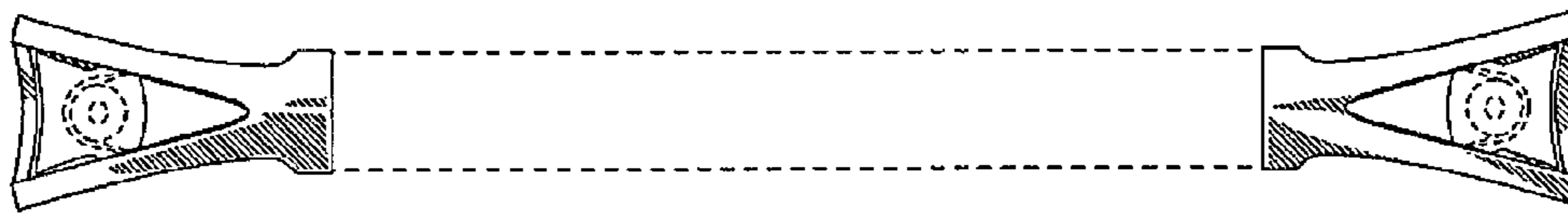

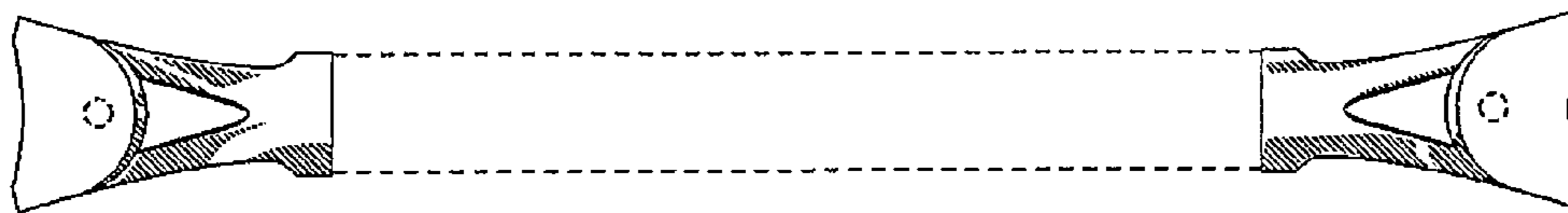
