a rabbit.

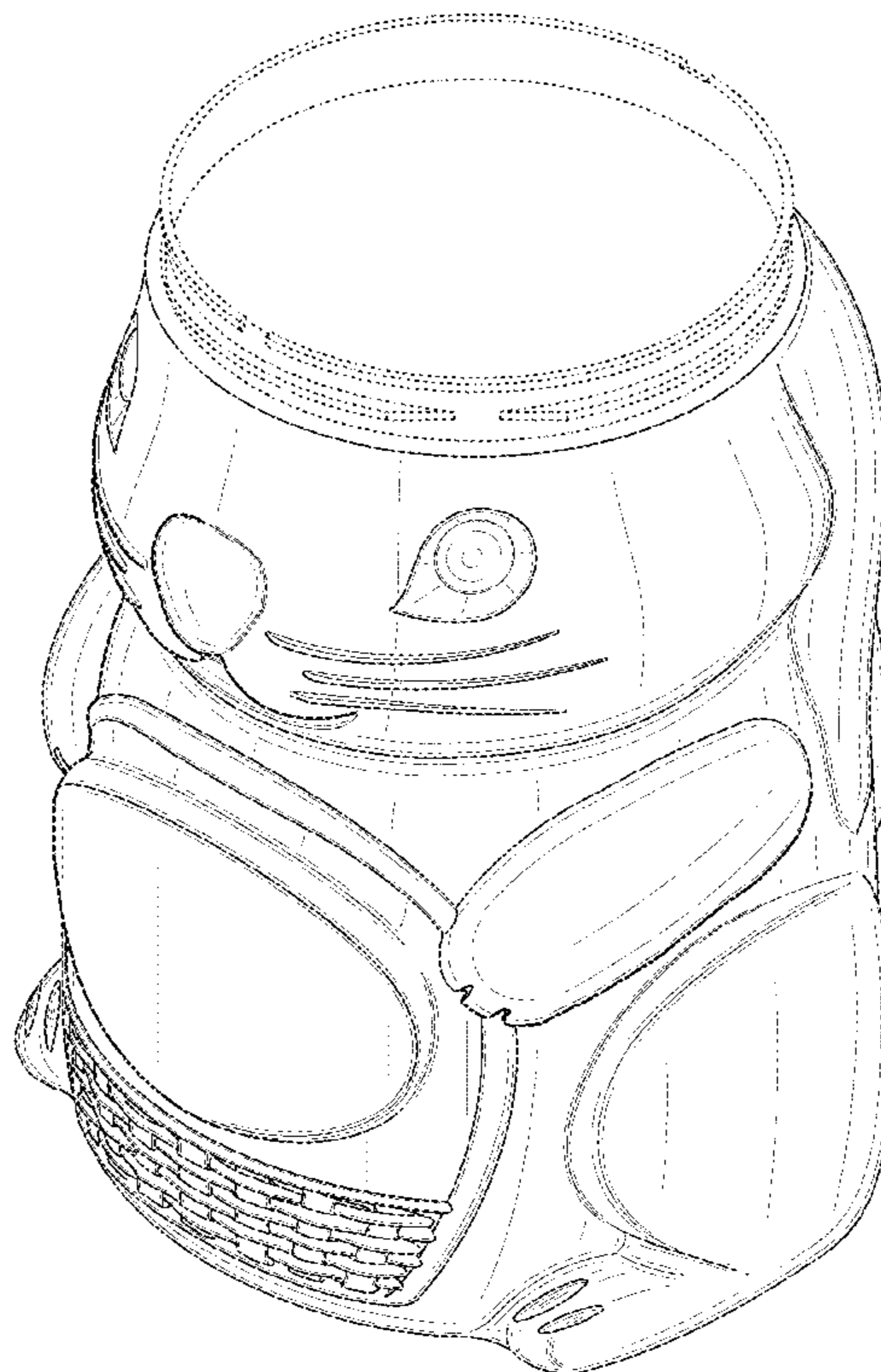
The broken lines showing connectors for the lid, rim, and

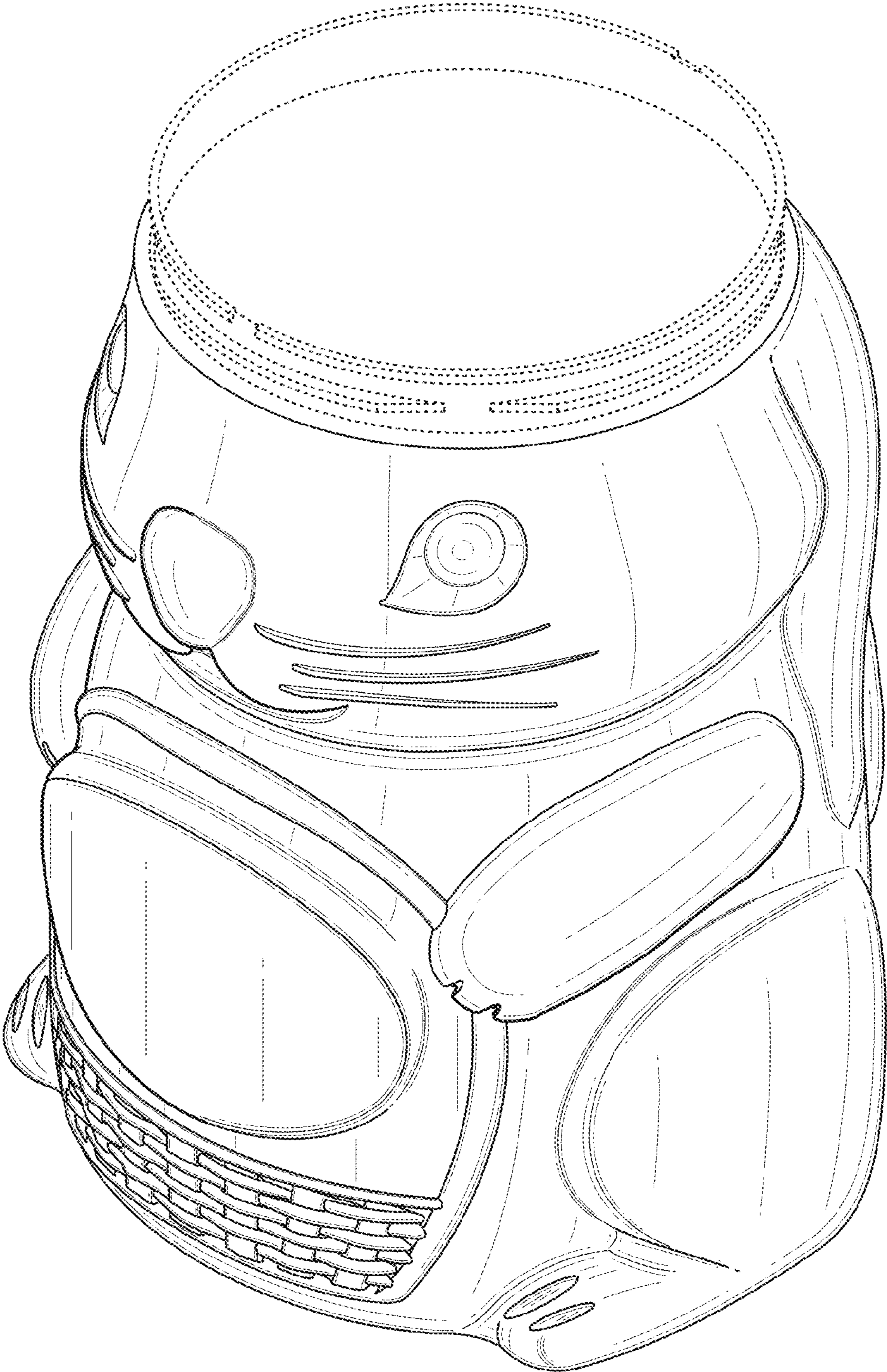

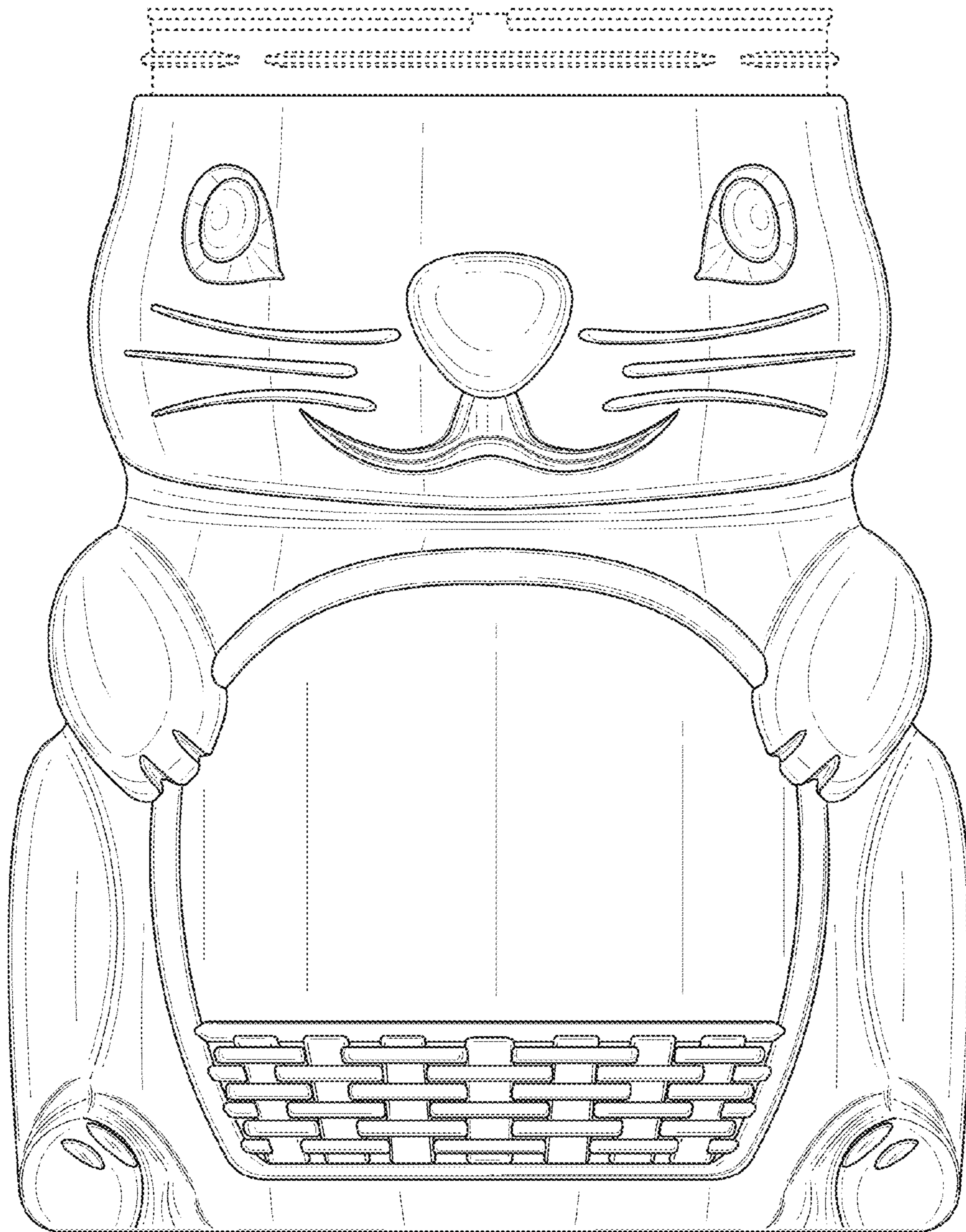

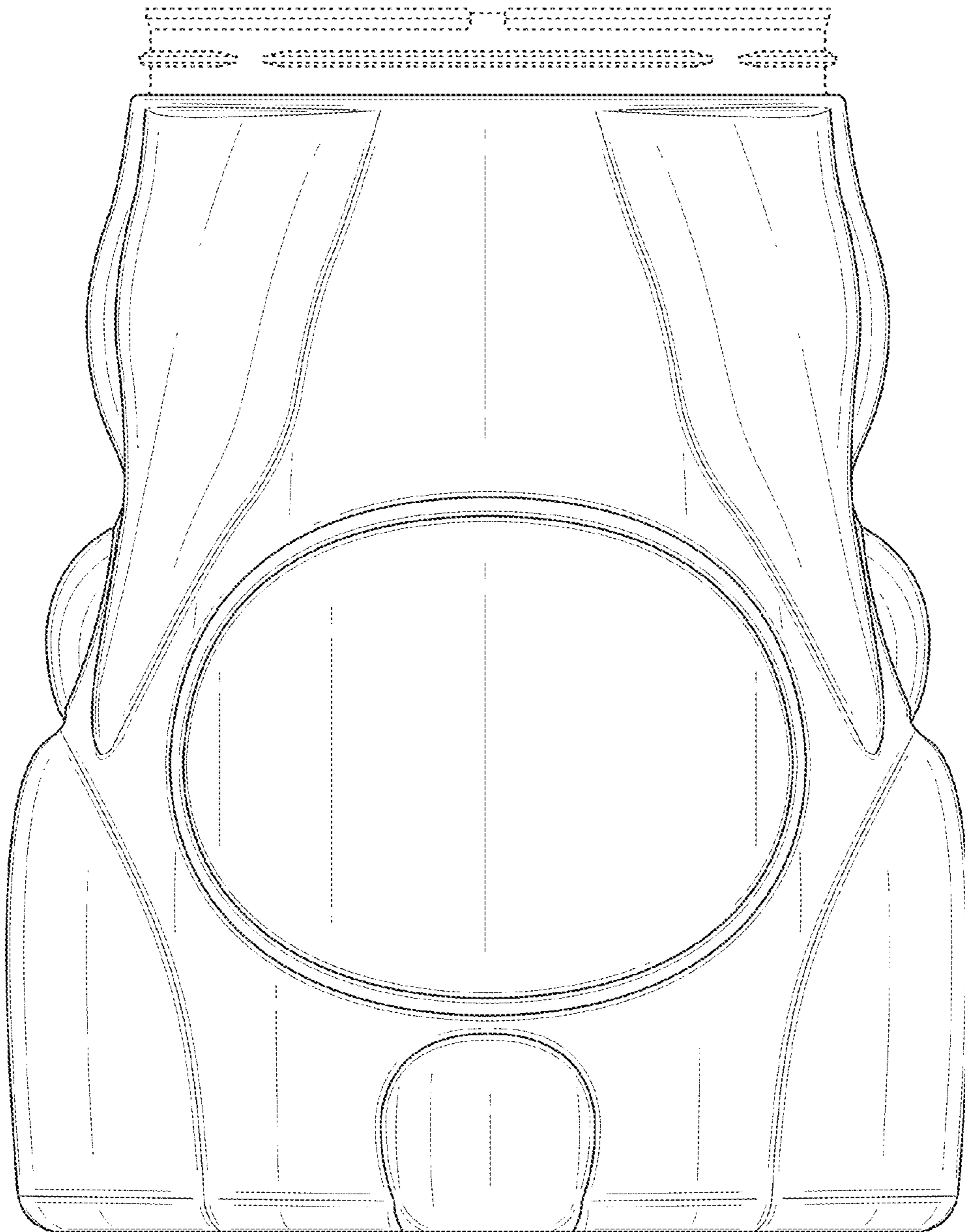

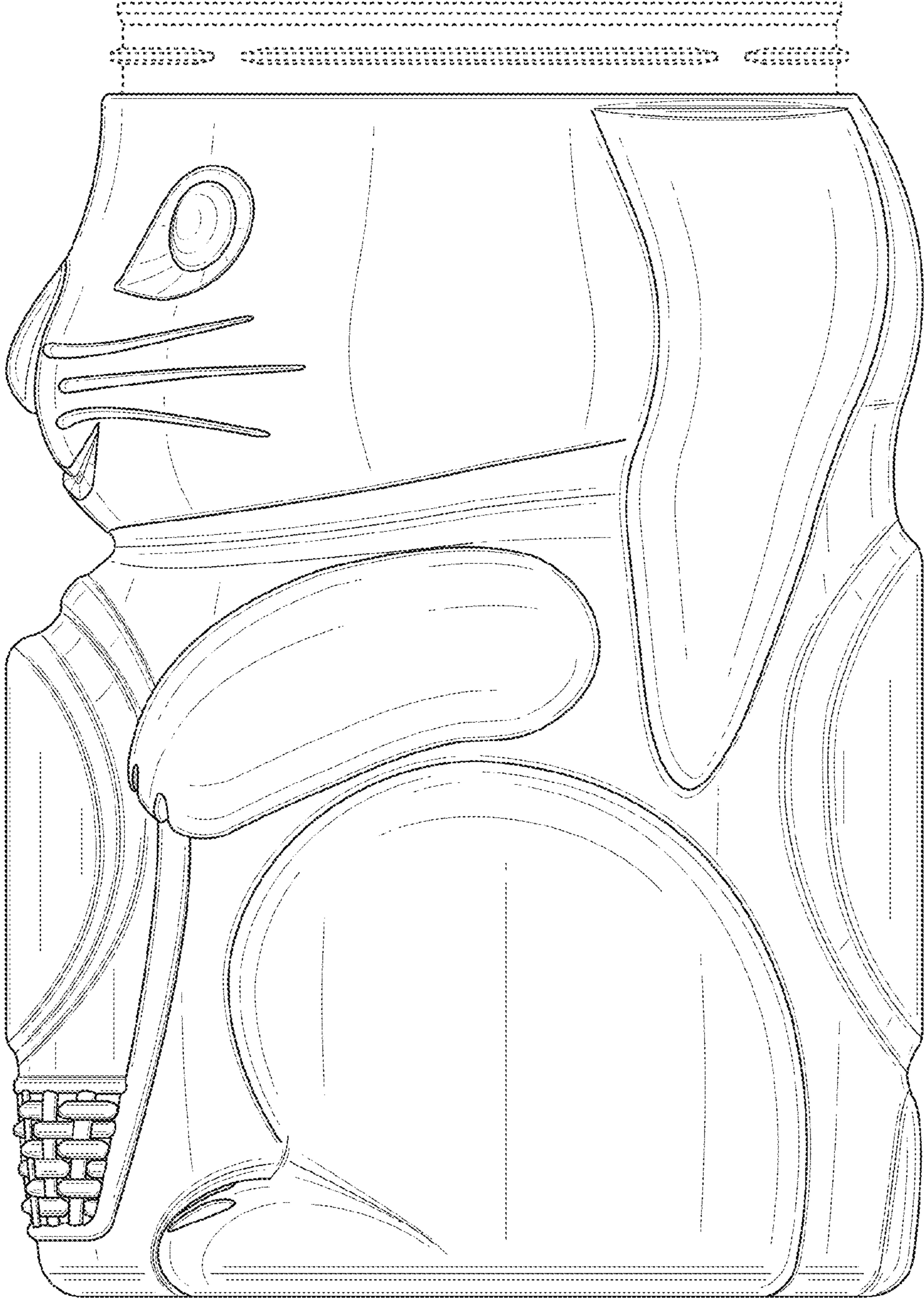

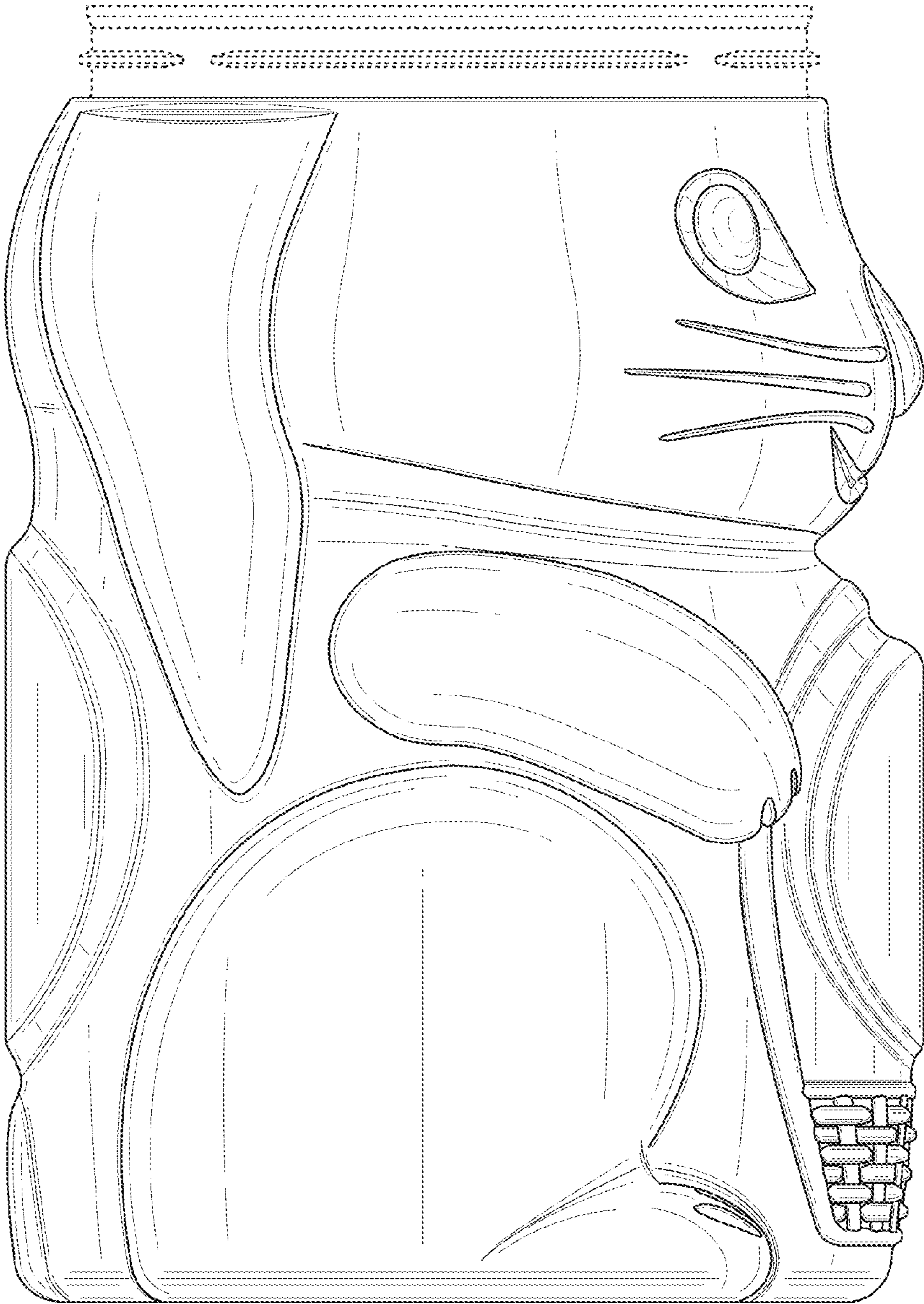

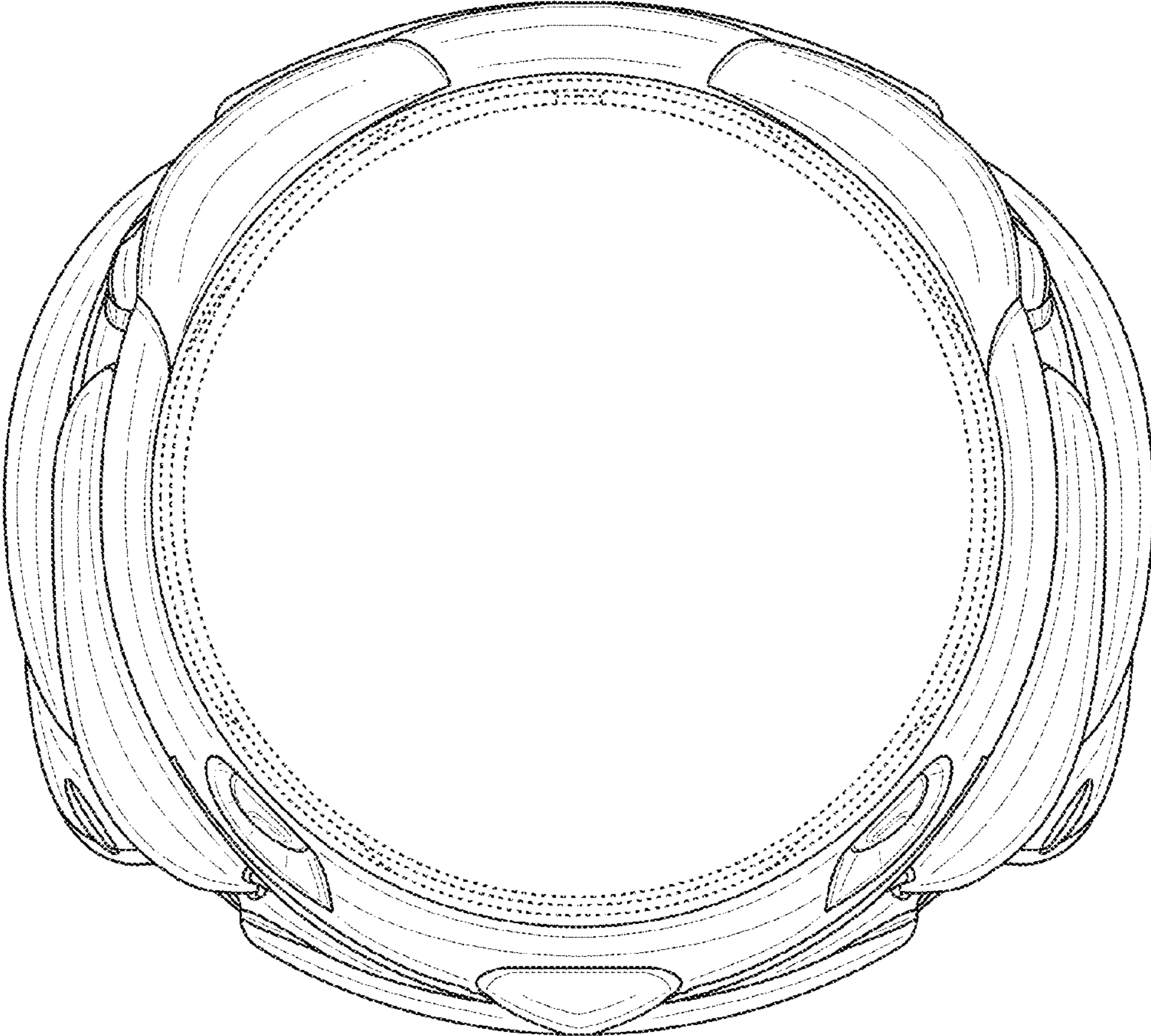

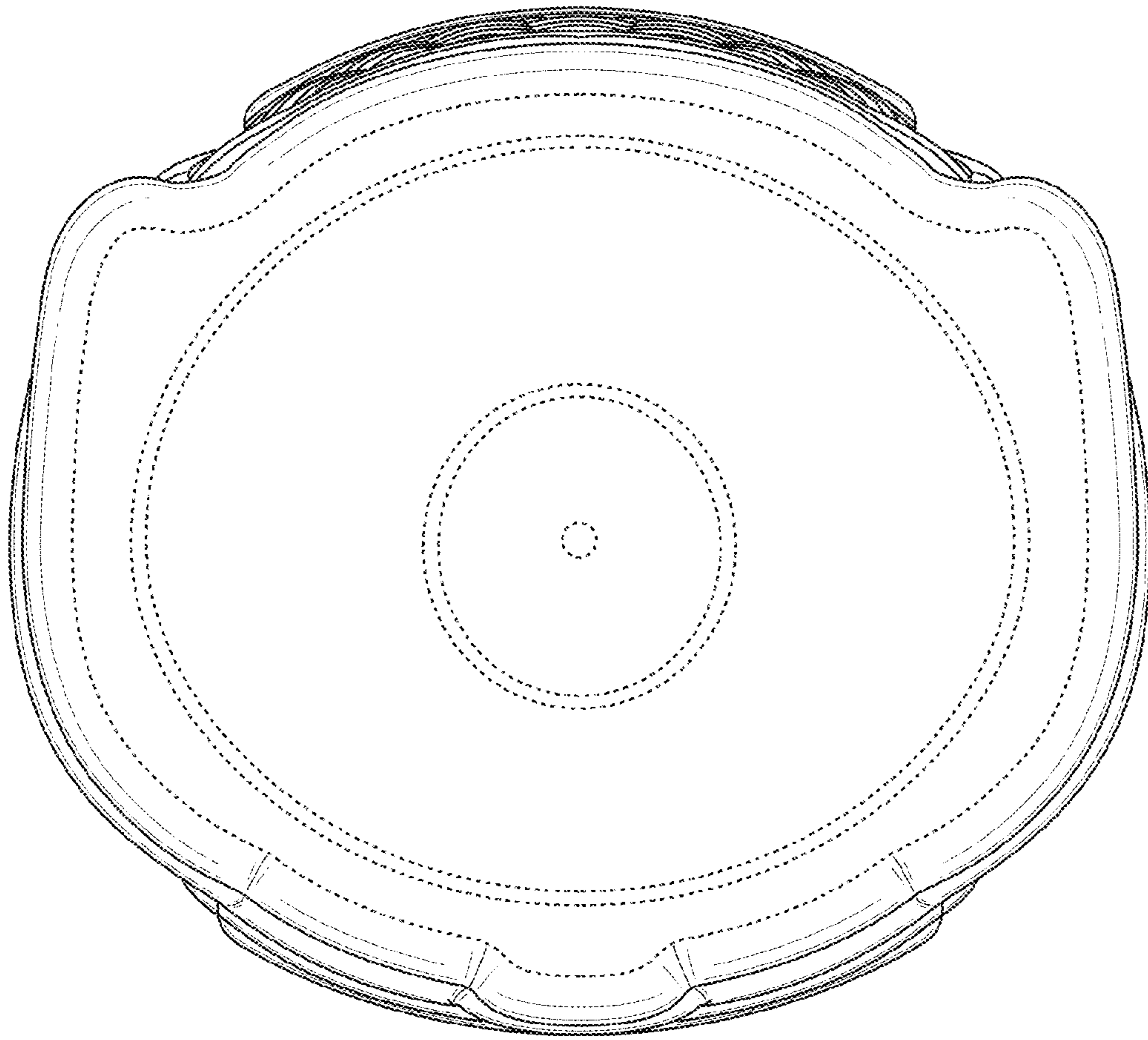
