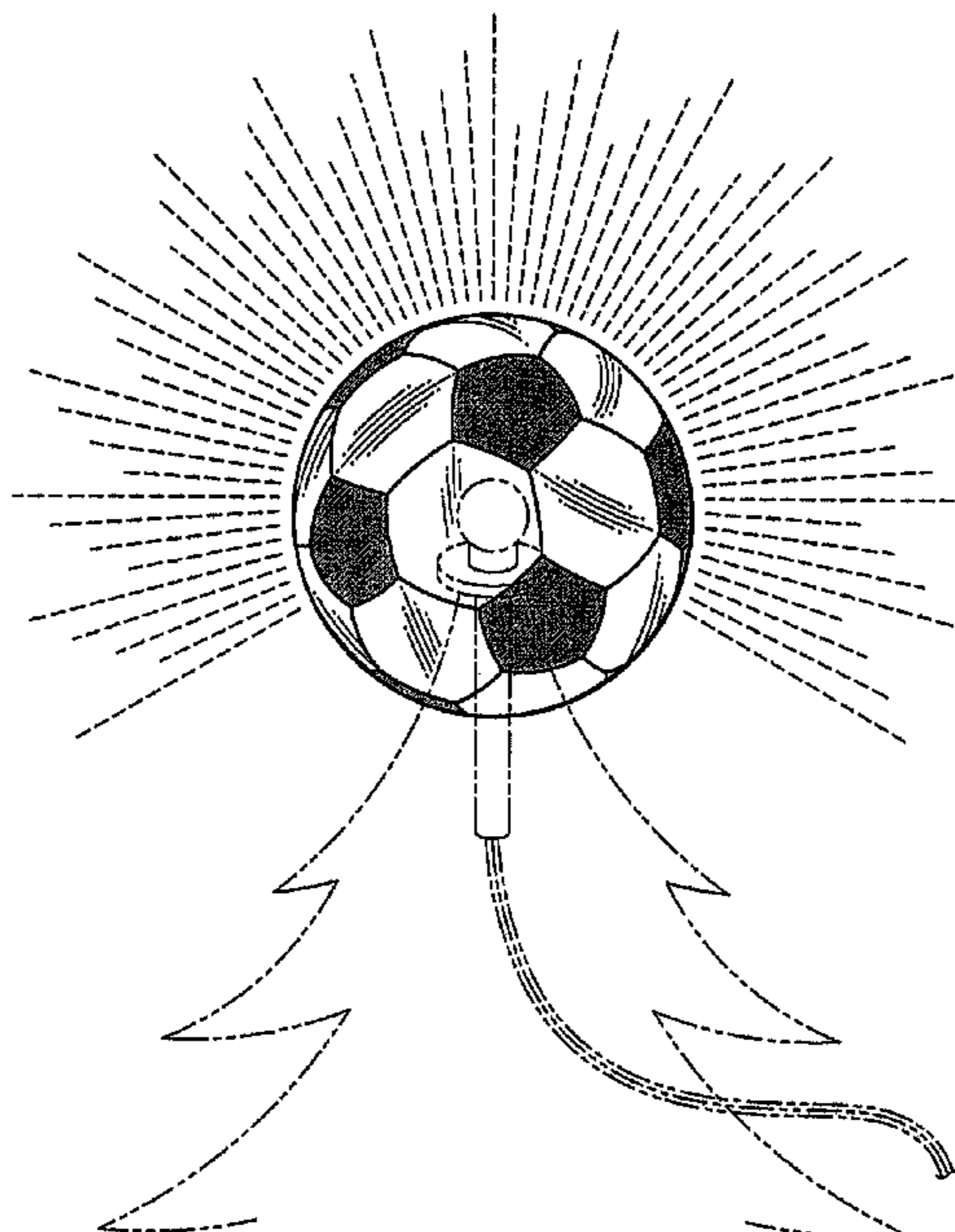

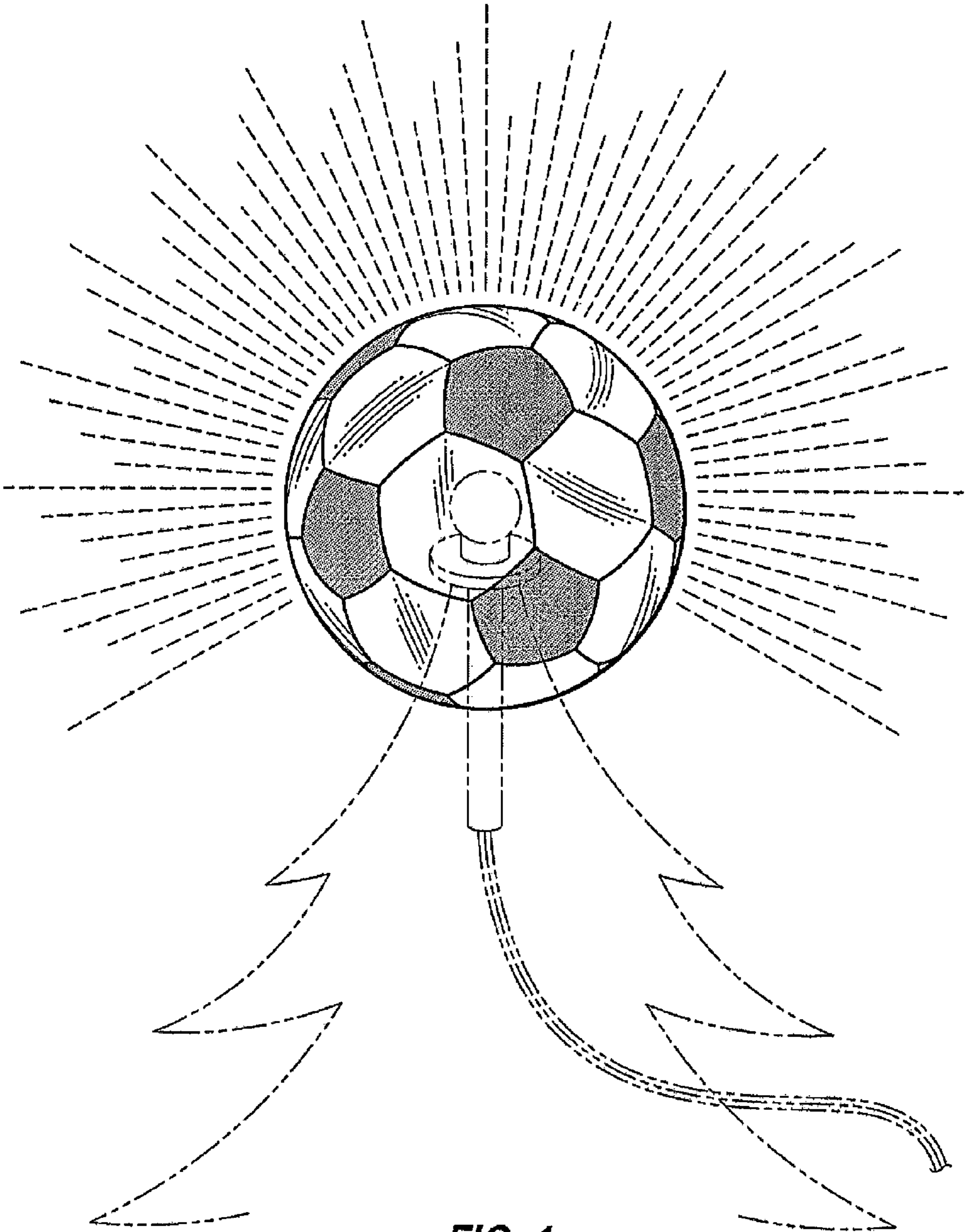

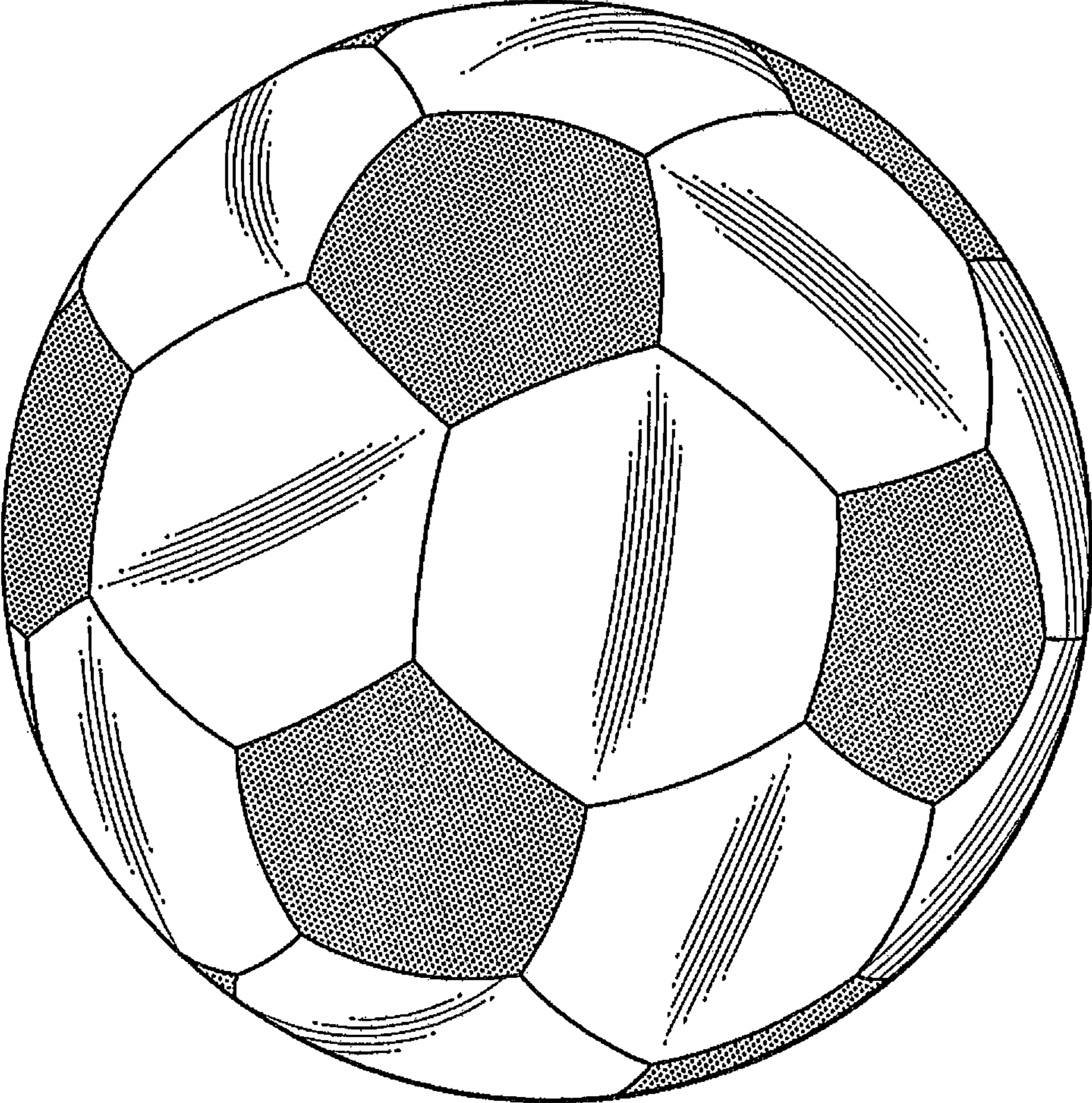
FIG. 1 is a perspective view of a lighted tree ornament, showing our new design, in a used condition with a tree shown in broken lines;

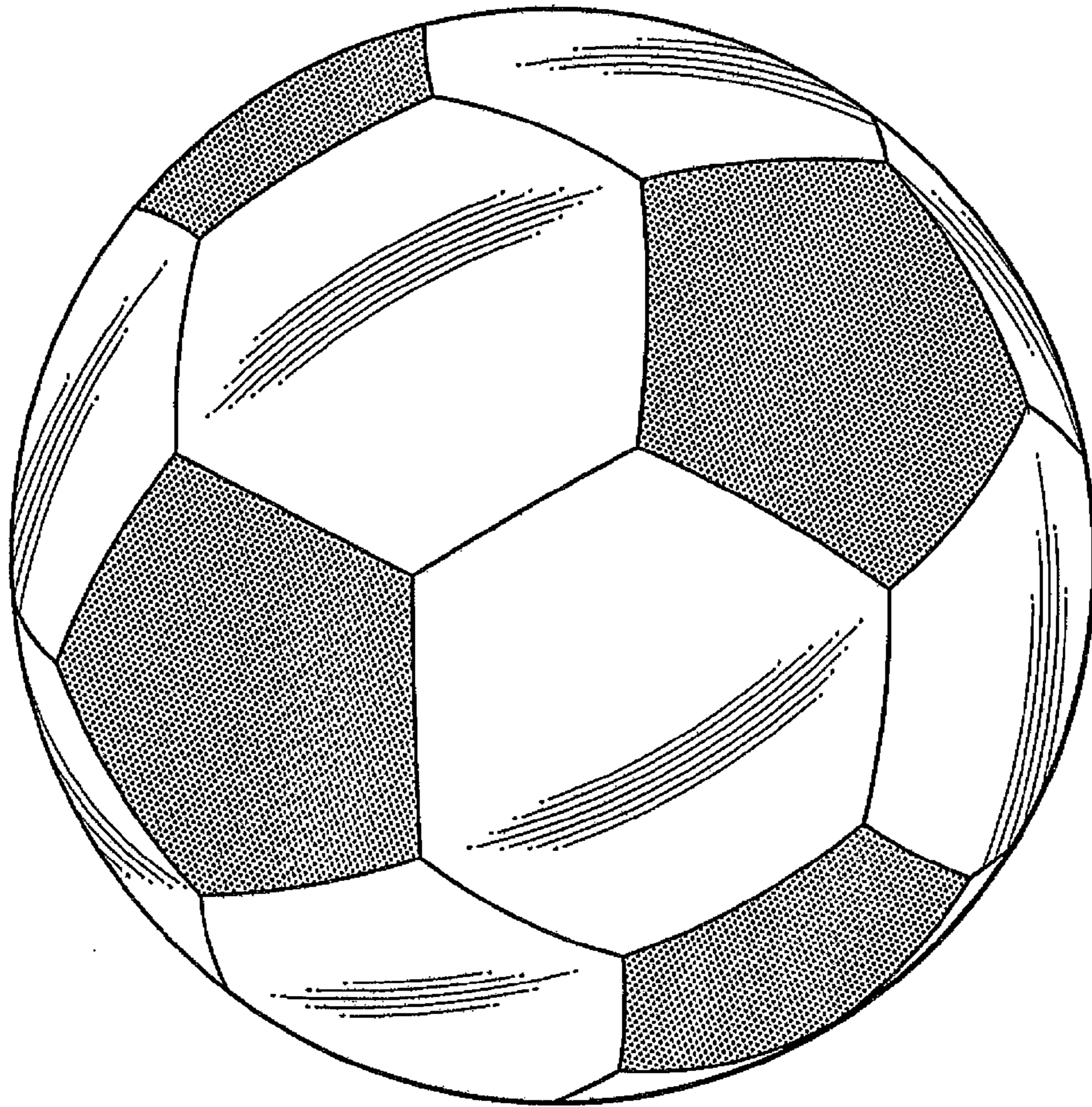




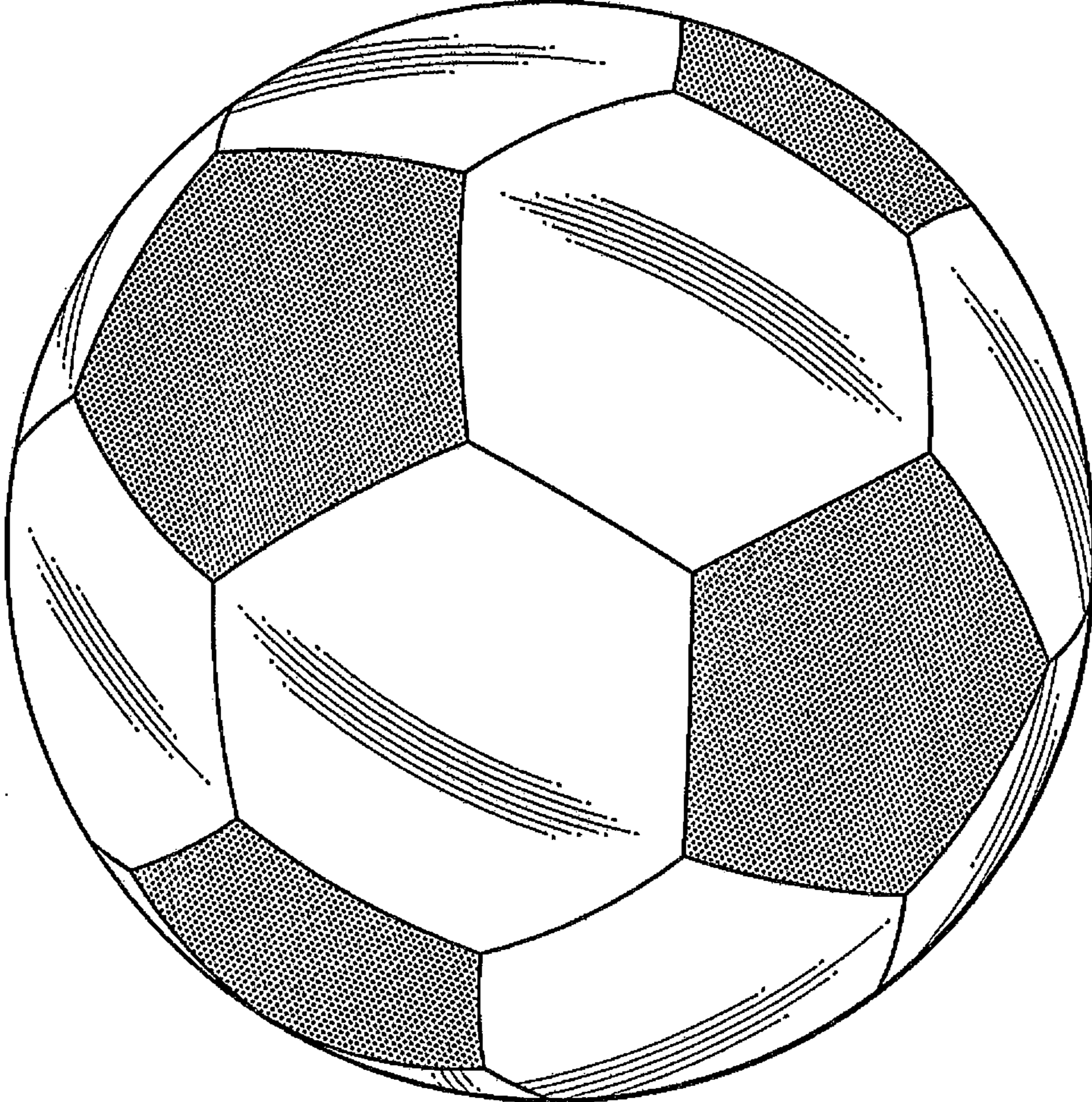

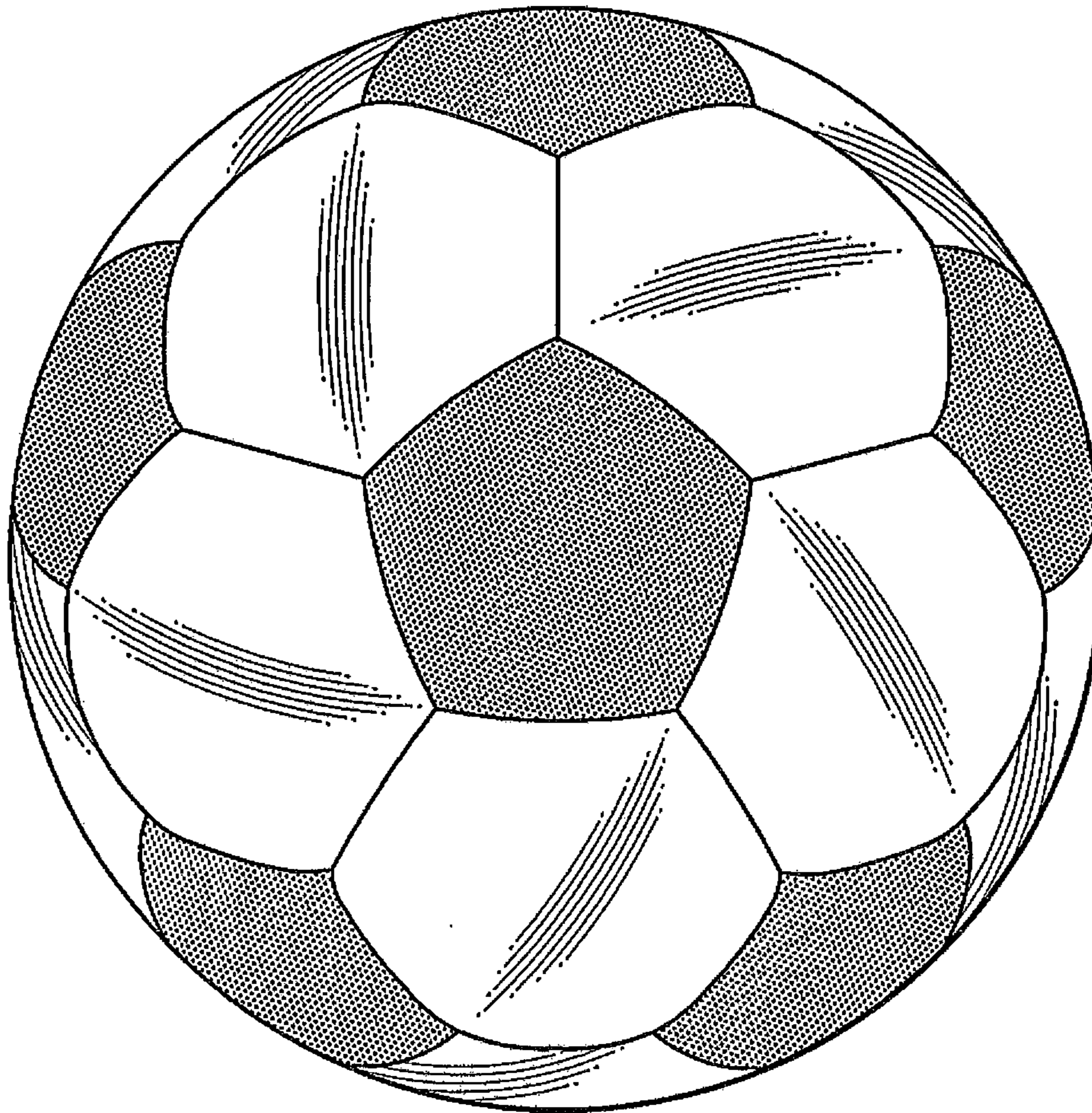

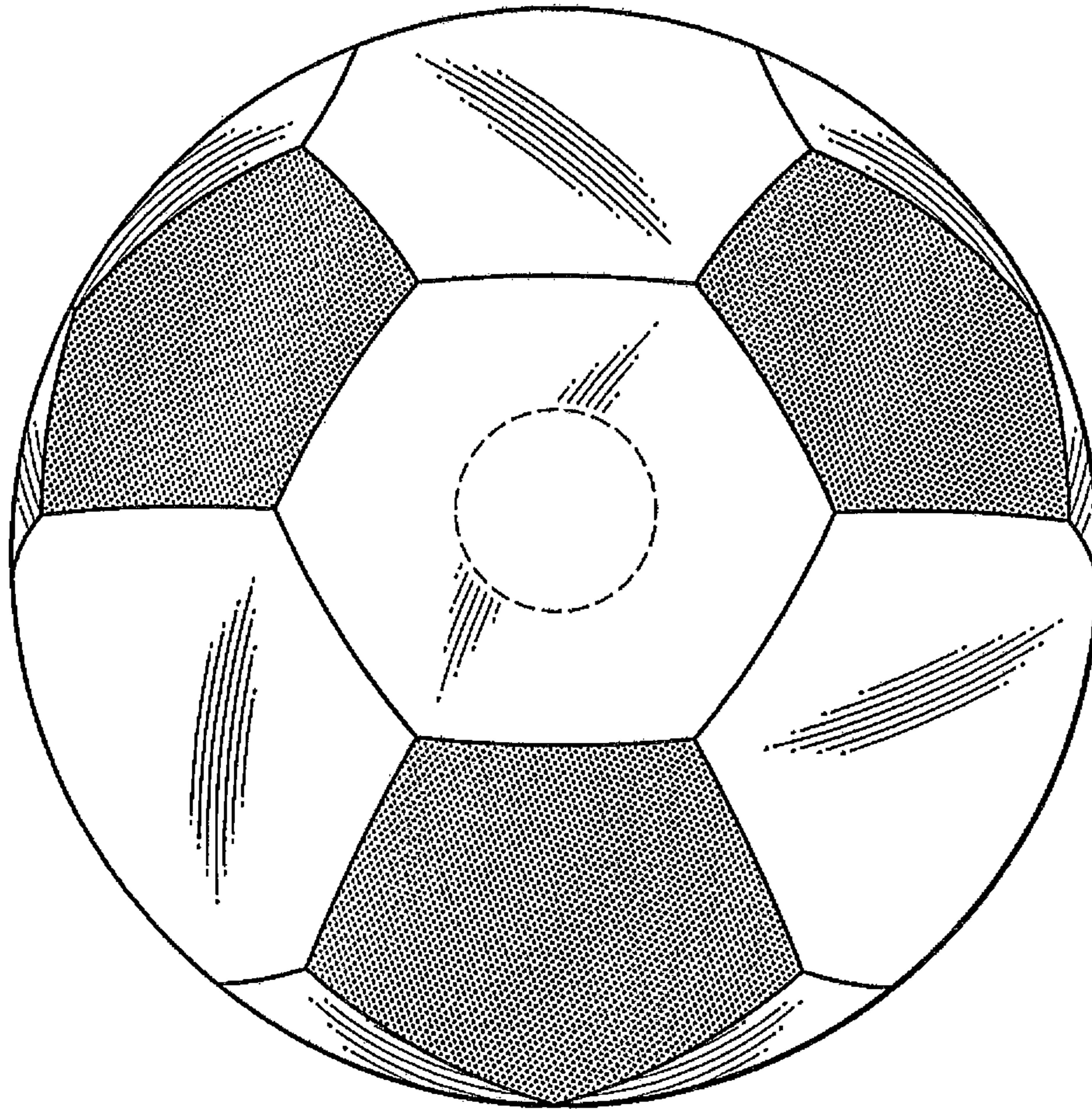
