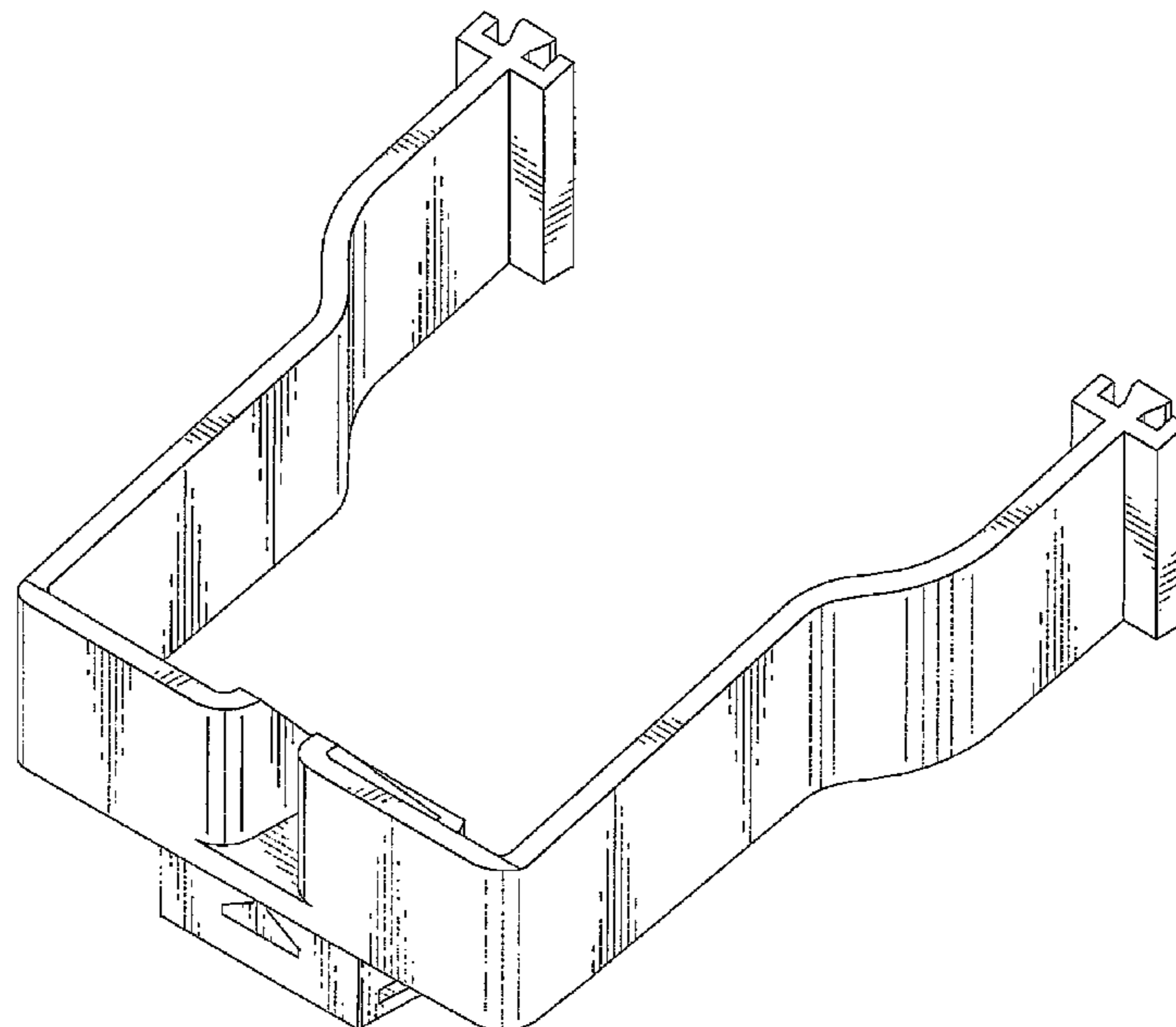
(57) **CLAIM**

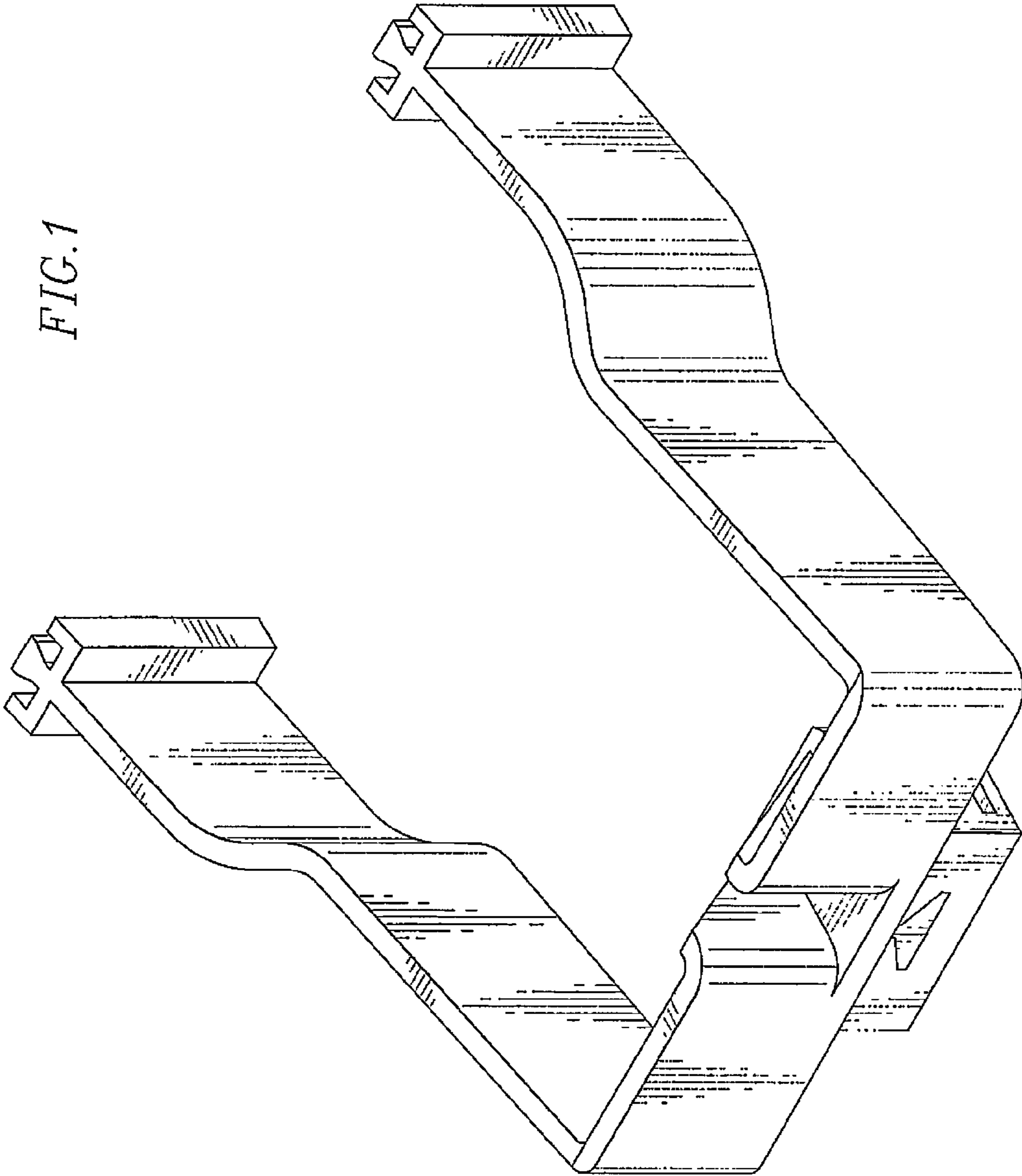
The ornamental design for photographic diffuser support, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a photographic diffuser support;
 FIG. 2 is a front exploded perspective view of the photographic diffuser support of FIG. 1;
 FIG. 3 is a top view of the photographic diffuser support of FIG. 1;
 FIG. 4 is a bottom view of the photographic diffuser support of FIG. 1;
 FIG. 5 is a rear view of the photographic diffuser support of FIG. 1;
 FIG. 6 is a right side view of the photographic diffuser support of FIG. 1, the left side being a mirror image of the right side;
 FIG. 7 is a front view of the photographic diffuser support of FIG. 1; and,
 FIG. 8 is a perspective view of the photographic diffuser support of FIG. 1 having a diffuser attached thereto.

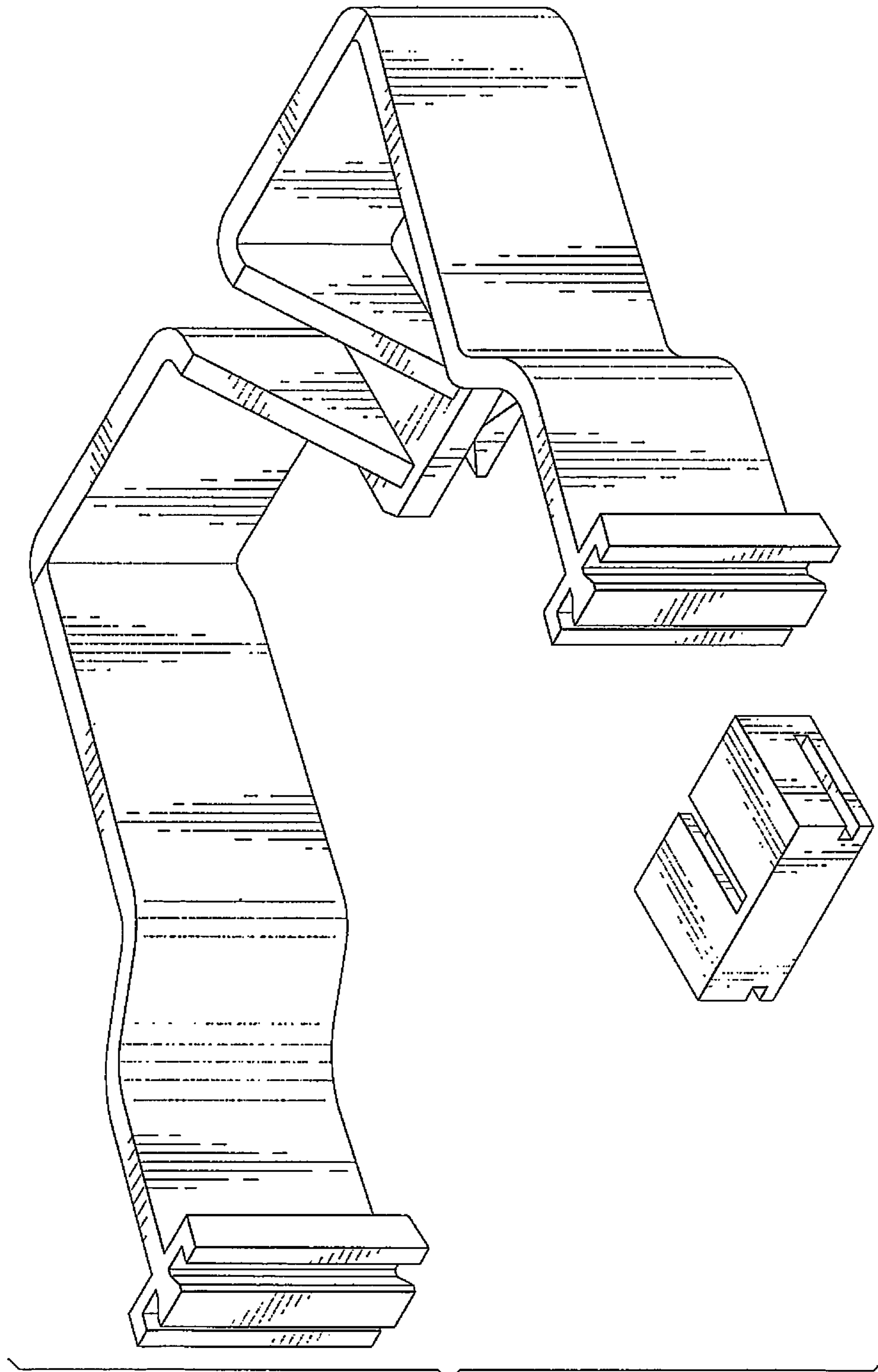

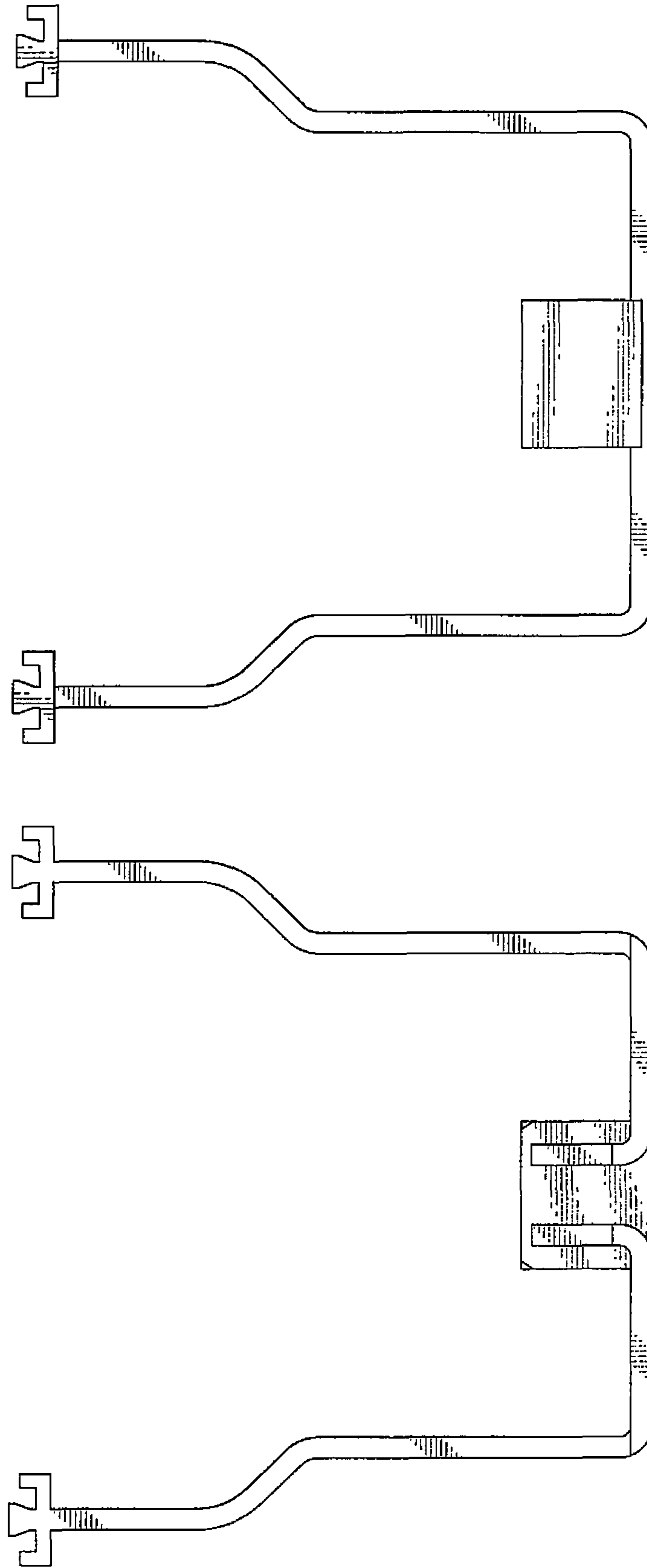

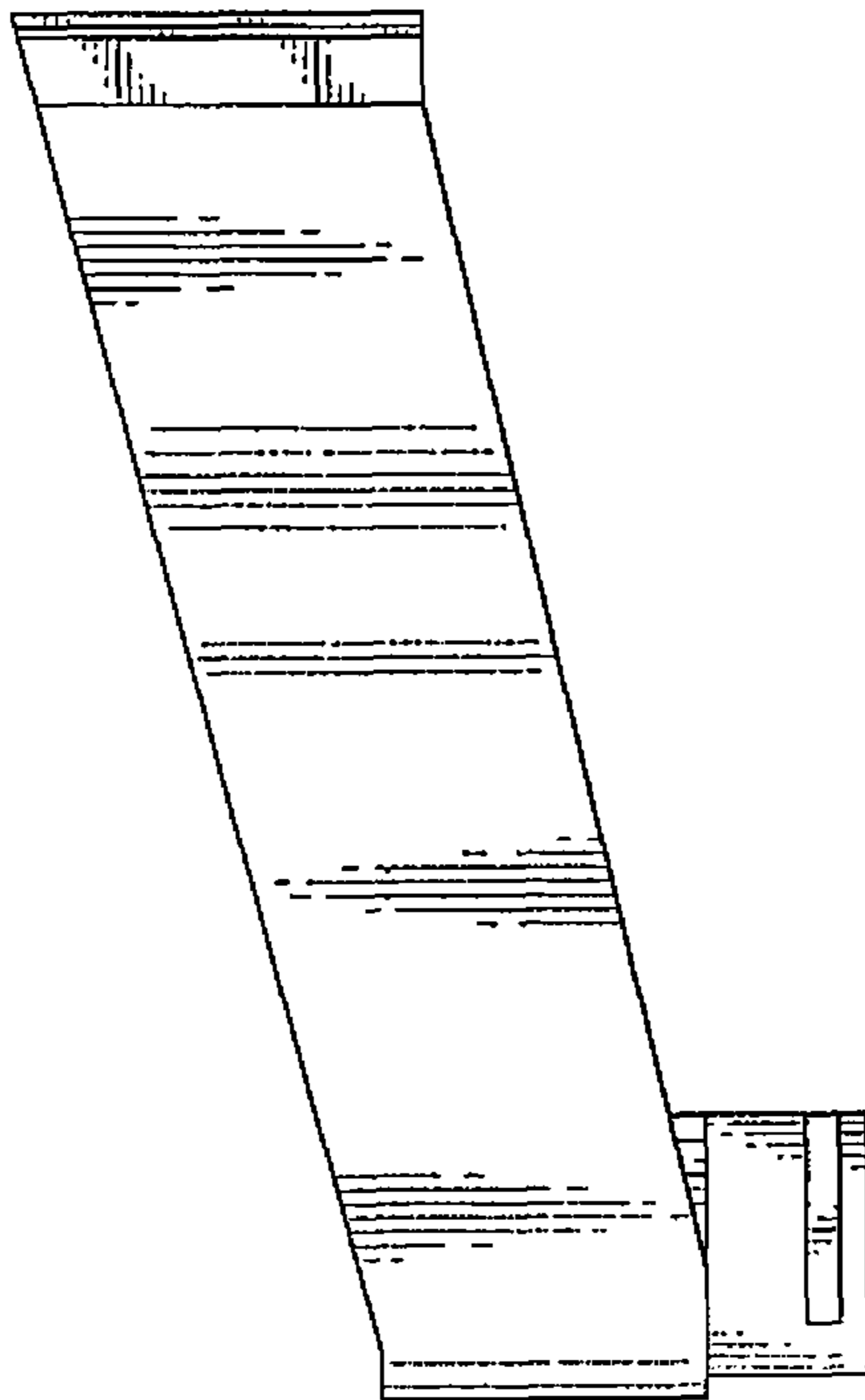

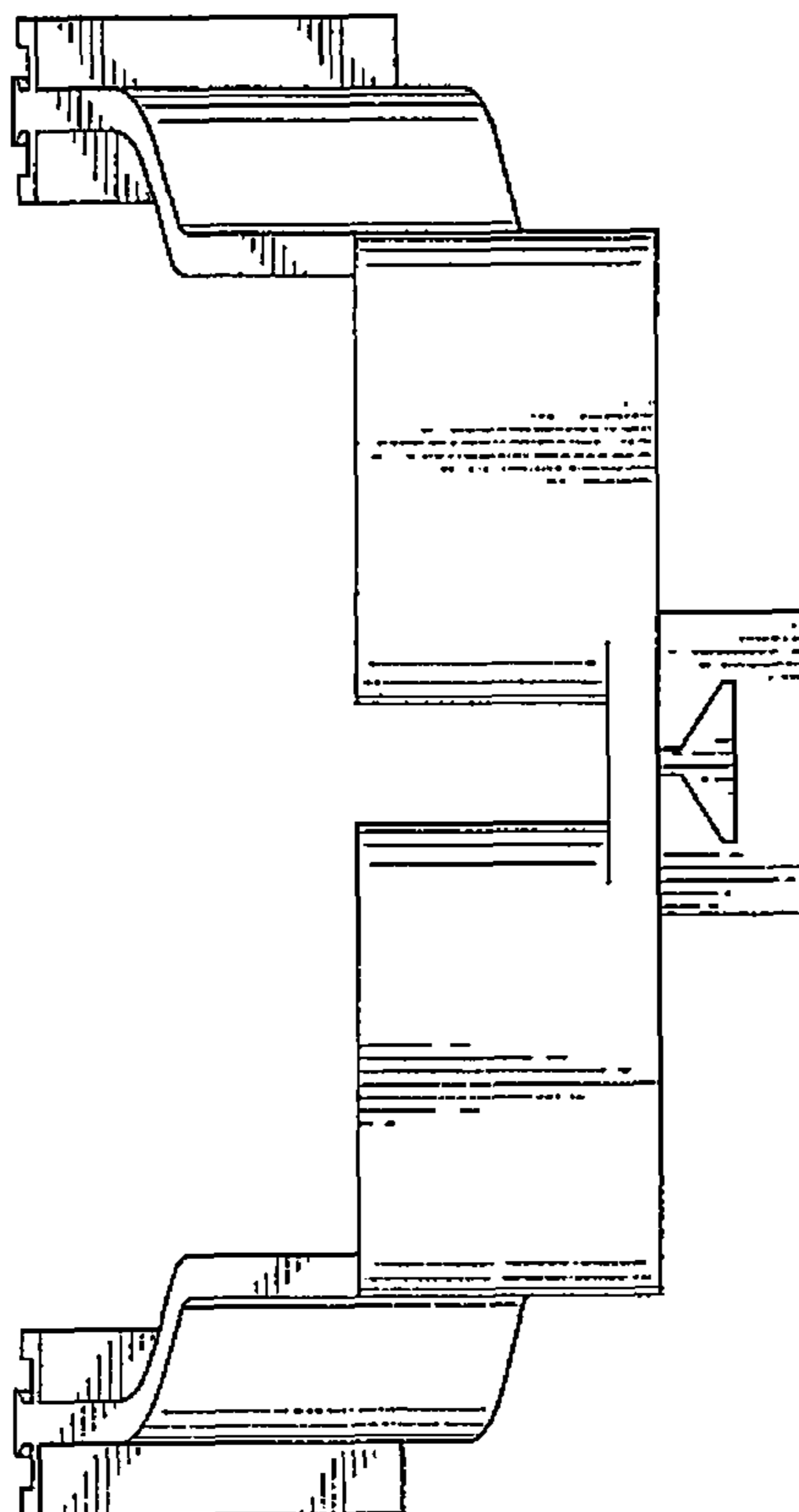
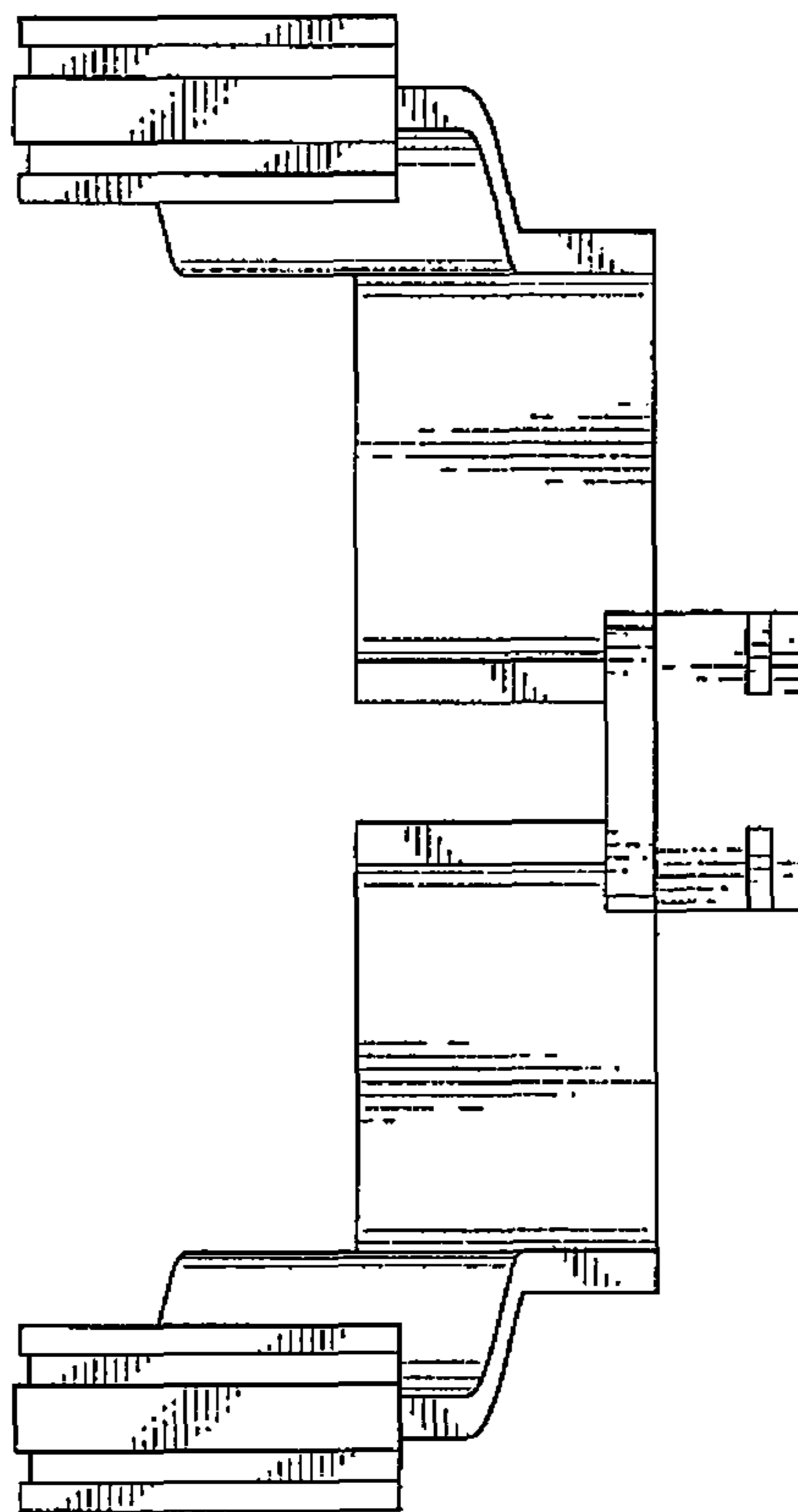

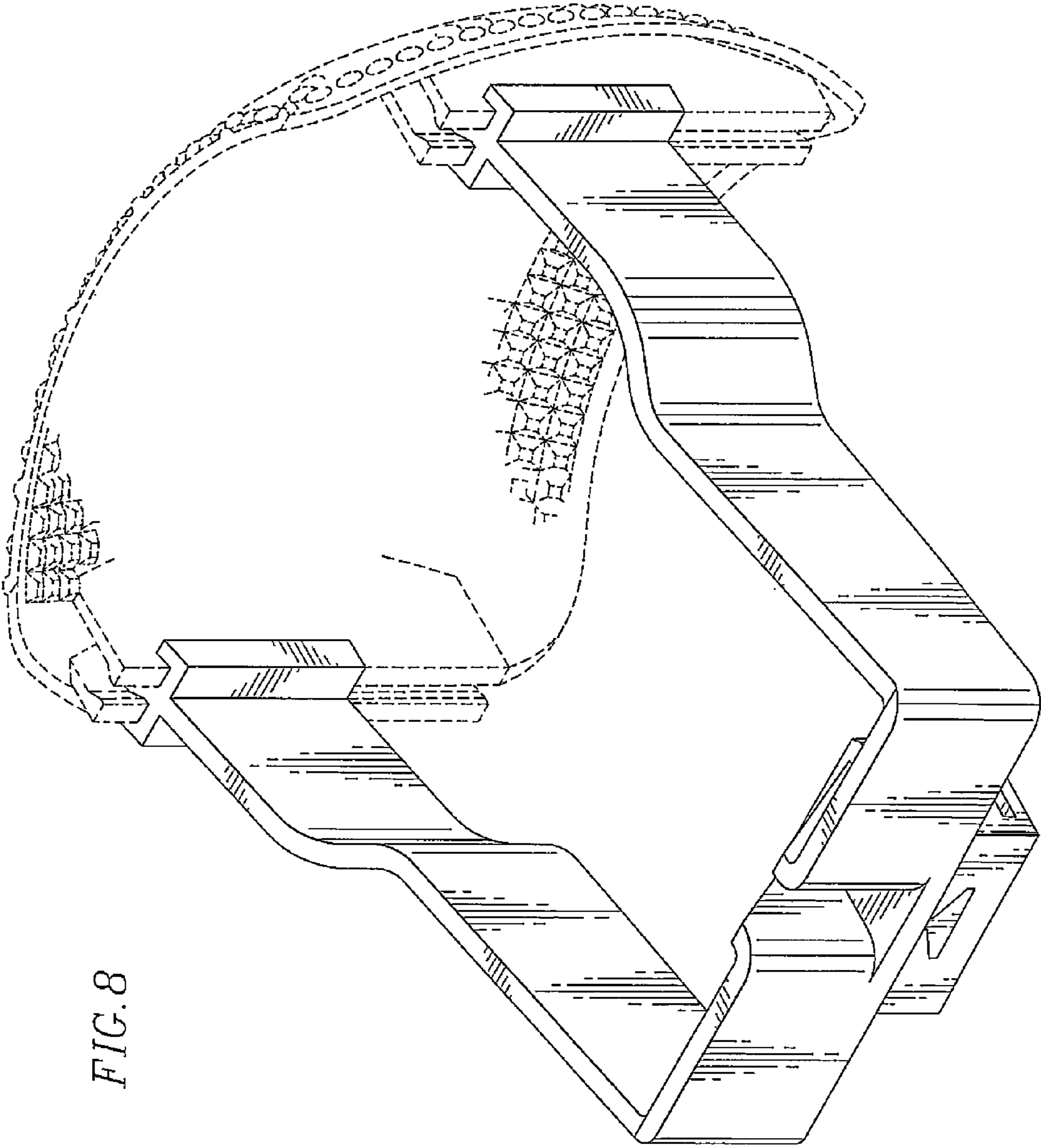
