FIG. 4 is provided for illustration as an exemplary sectional view along section 4-4 in FIG. 3, noting the common uniform structure thereof for the present invention.

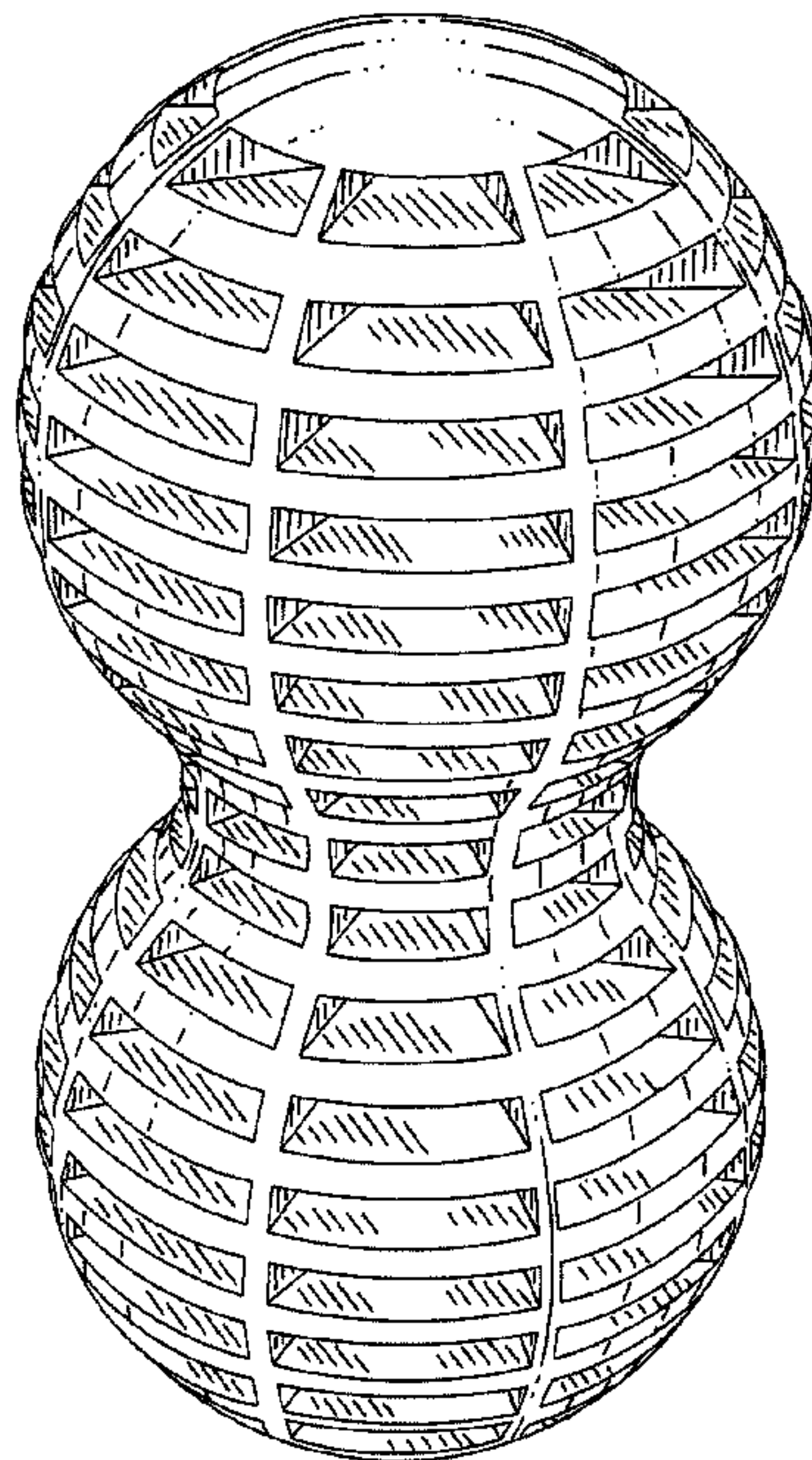
(56) **References Cited**

The therapeutic device is symmetrical about a central axis and a central region as shown with a series of formed ribs to enhance use. The recesses are noted and are lightly lined to show contour, but no claim is made to a particular surface shading, texture, or color, and these linings form no part of the claimed design. The recesses from top to bottom respectively reach a relative arrangement similar to that shown in FIG. 4 from top to bottom.

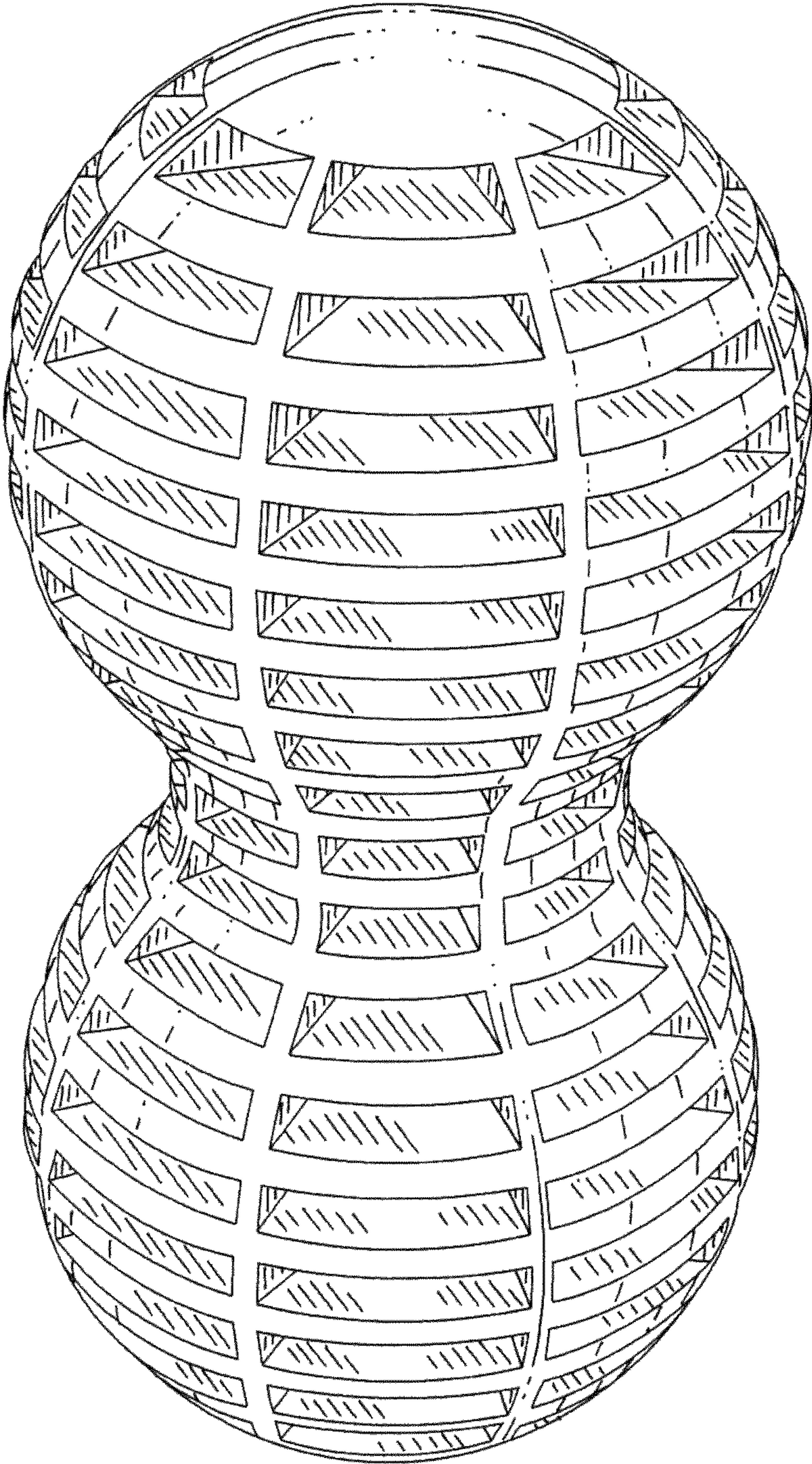

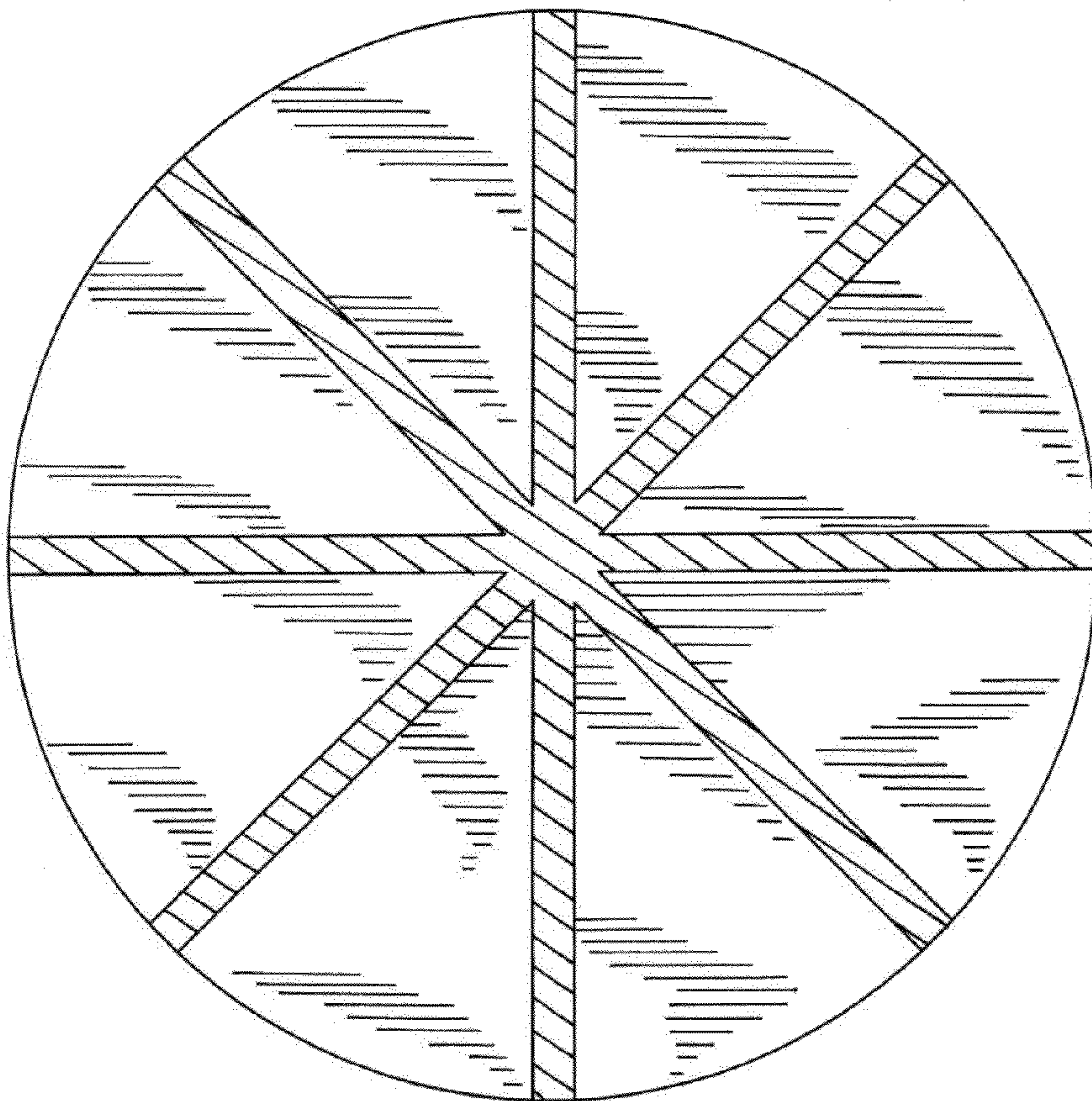
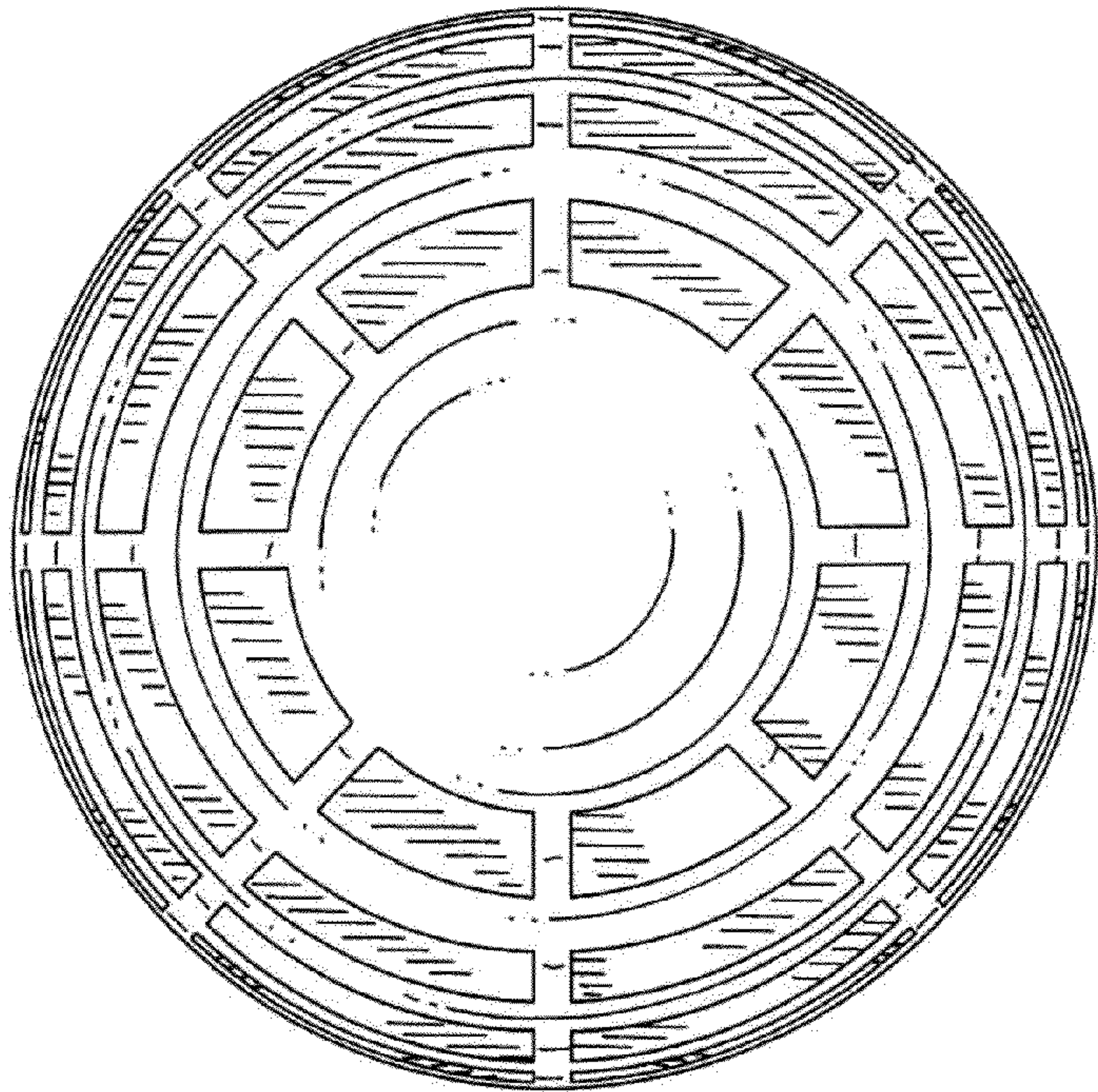

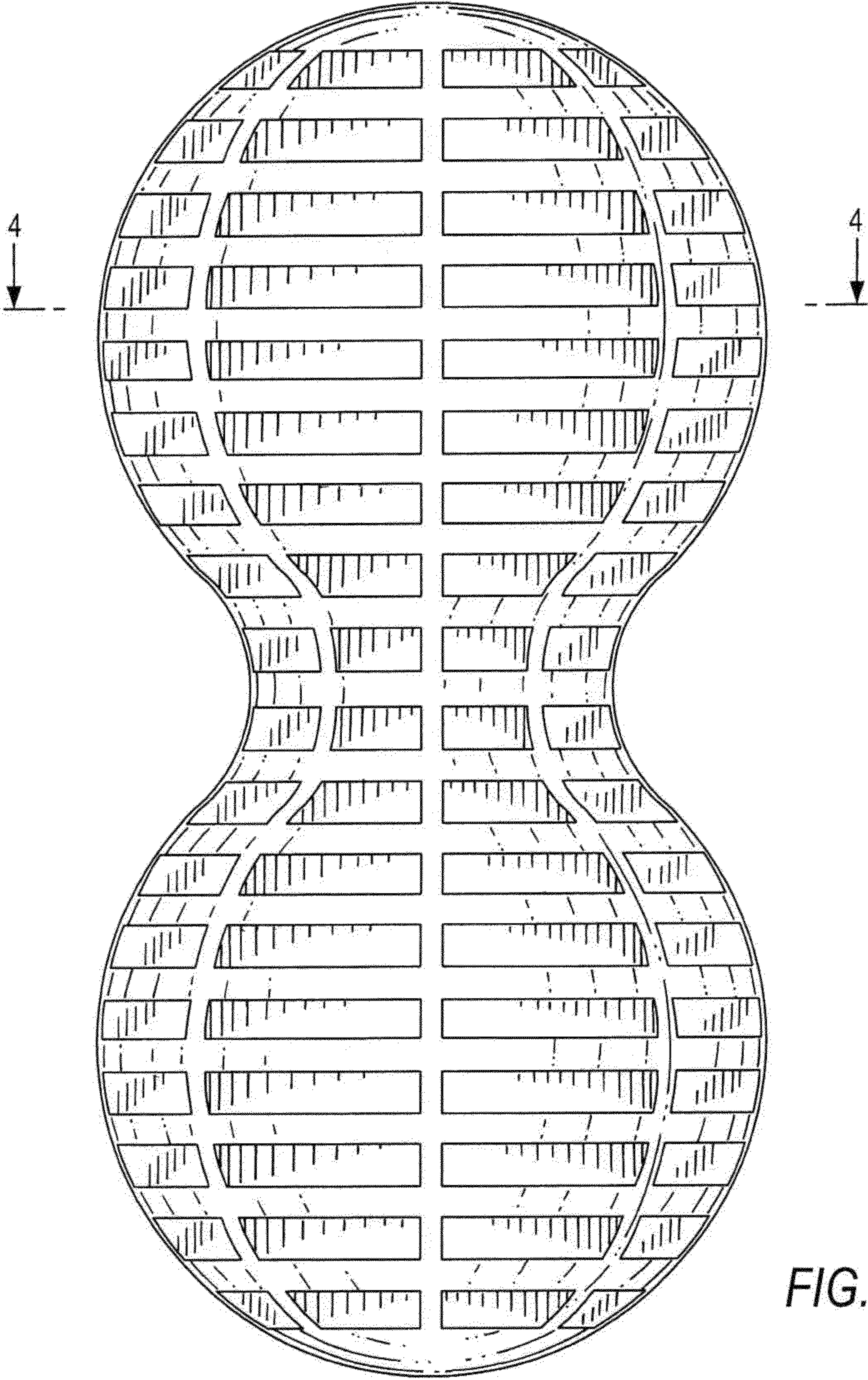
