(57) **CLAIM**
The ornamental design for an eyeliner applicator, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an eyeliner applicator; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof. Broken lines are used to illustrate unclaimed portions of the eyeliner applicator; broken lines for no part of the claimed design.

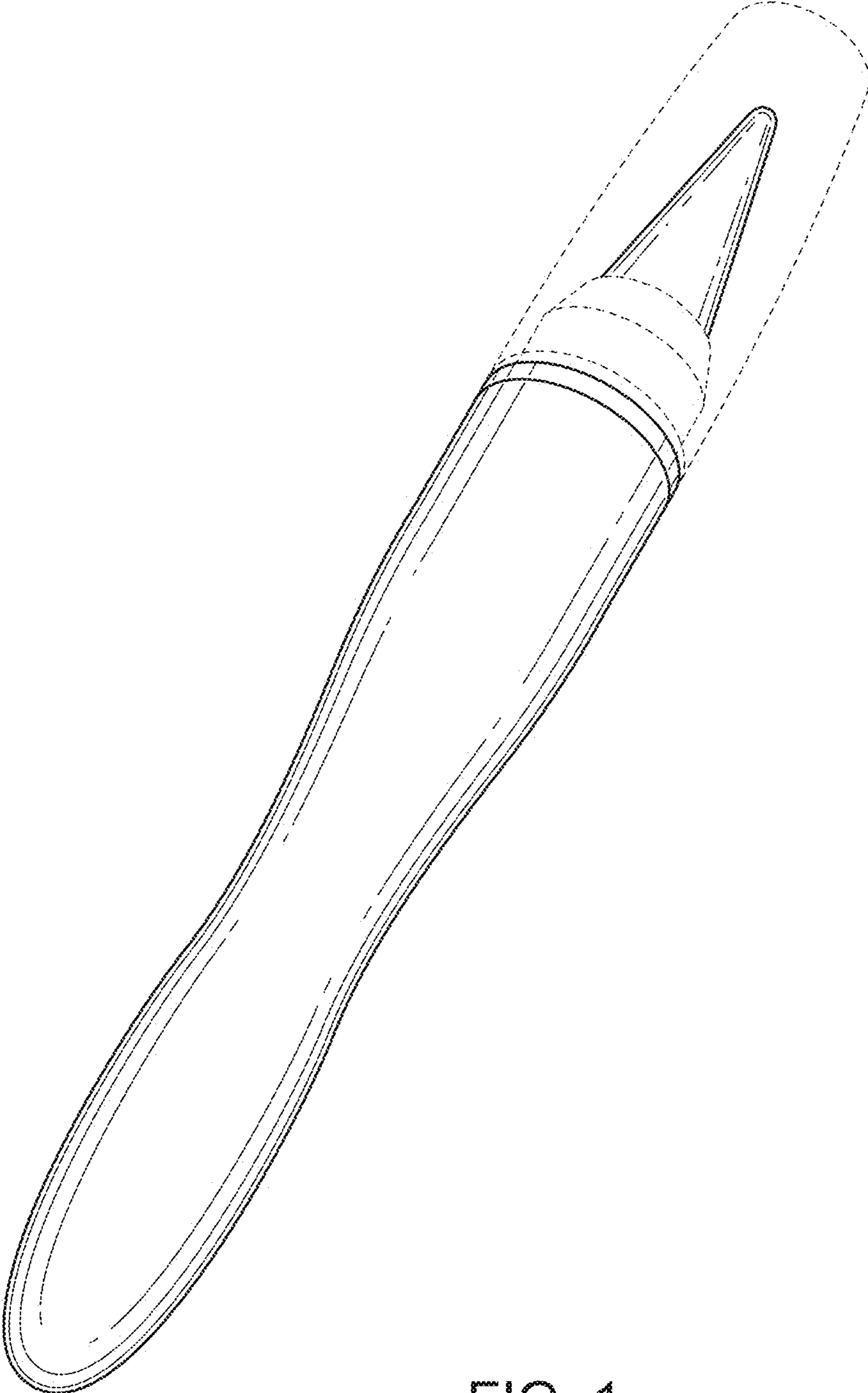

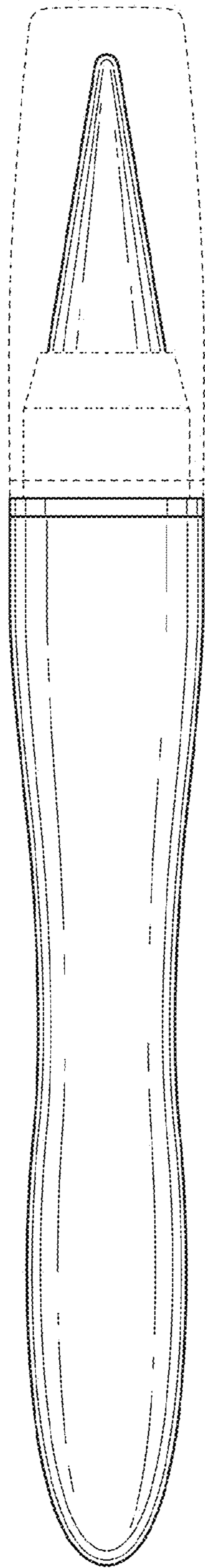

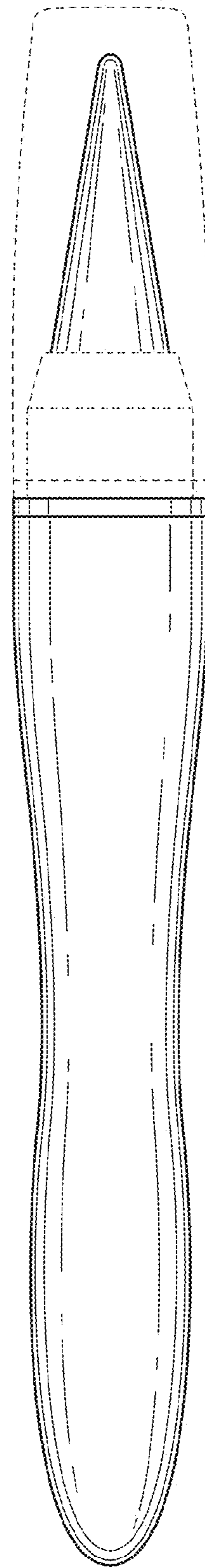

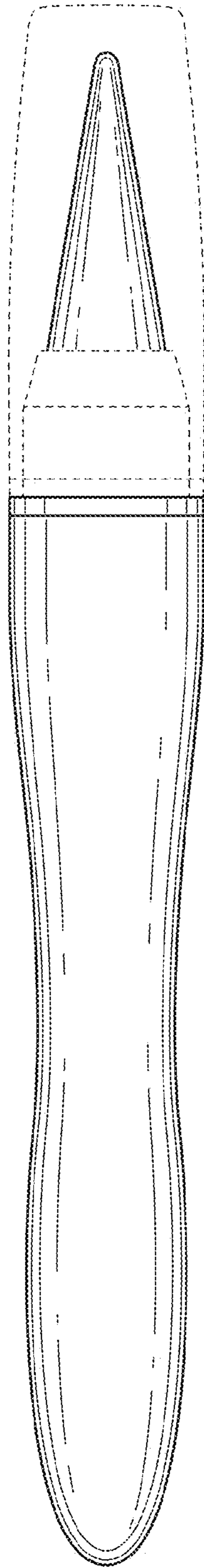

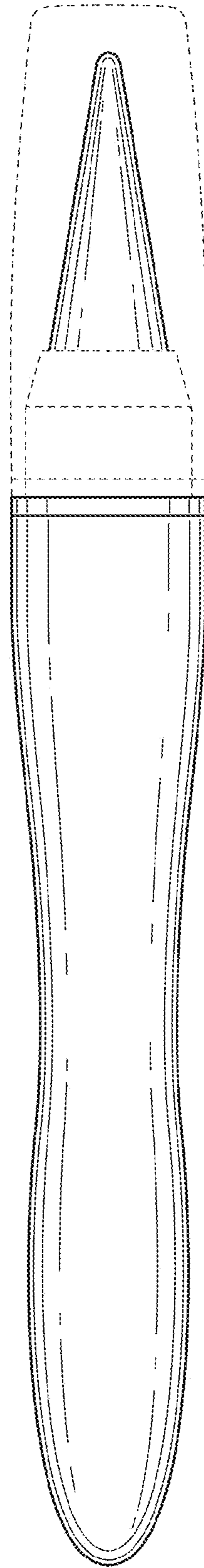

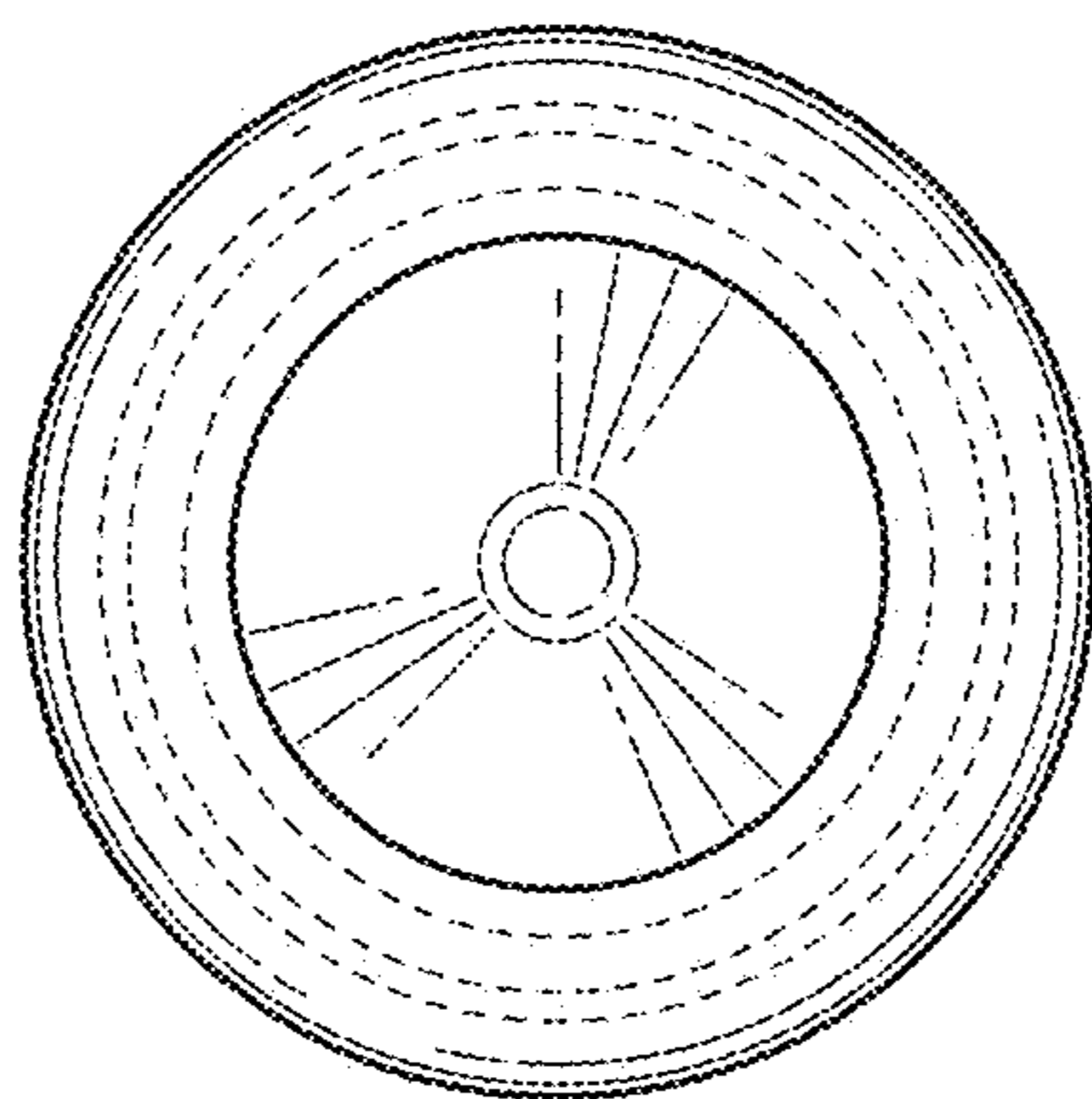

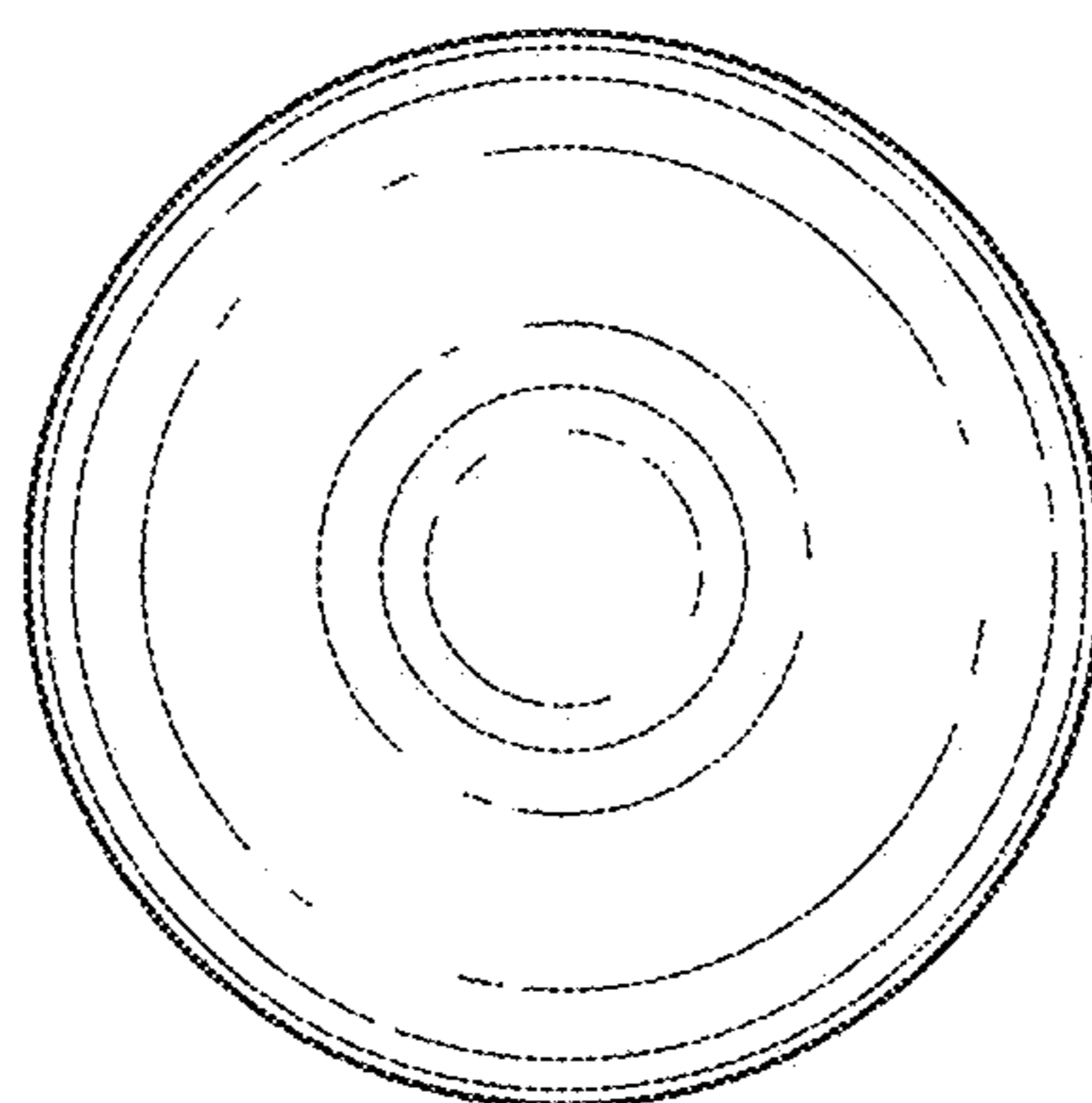
