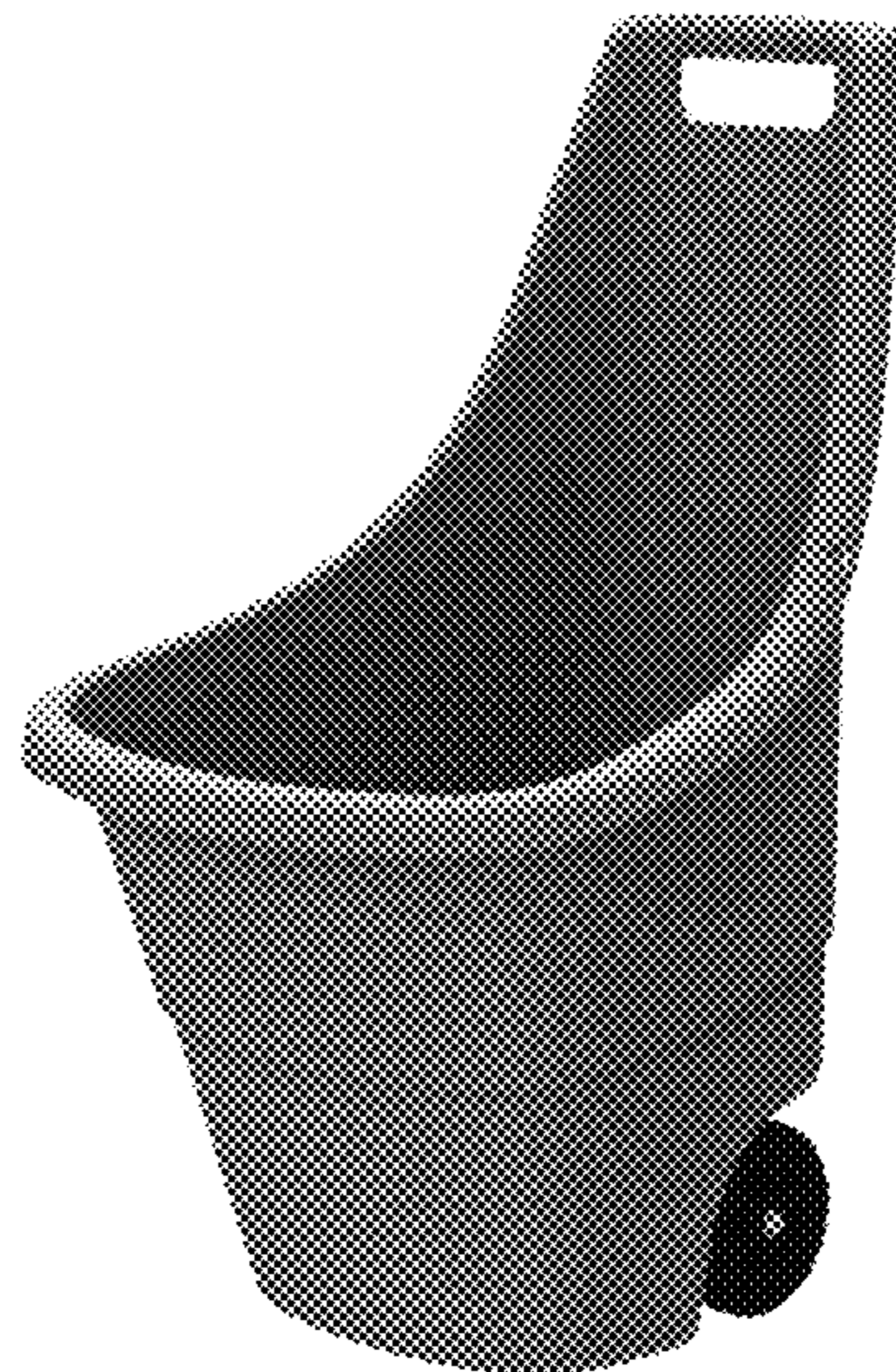
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top and front perspective view of a garden cart, FIG. 2 is a bottom and rear perspective view thereof, FIG. 3 is a front elevational view thereof, FIG. 4 is a rear elevational view thereof, FIG. 5 is a left-side elevational view thereof, FIG. 6 is a right-side elevational view thereof, FIG. 7 is a top planar view thereof; and, FIG. 8 is a bottom planar view thereof.
