The ornamental design for an bib, as shown and described.

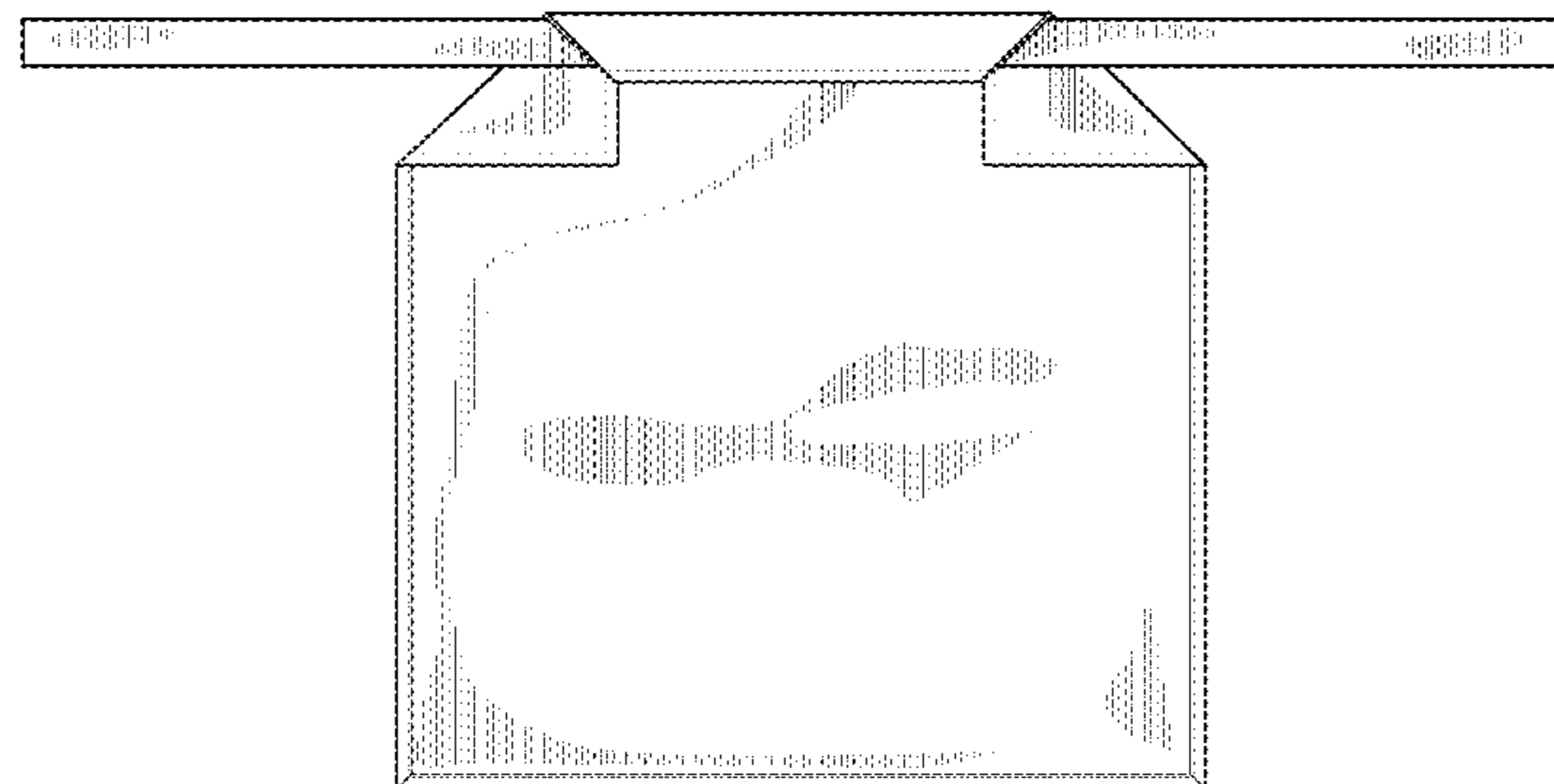
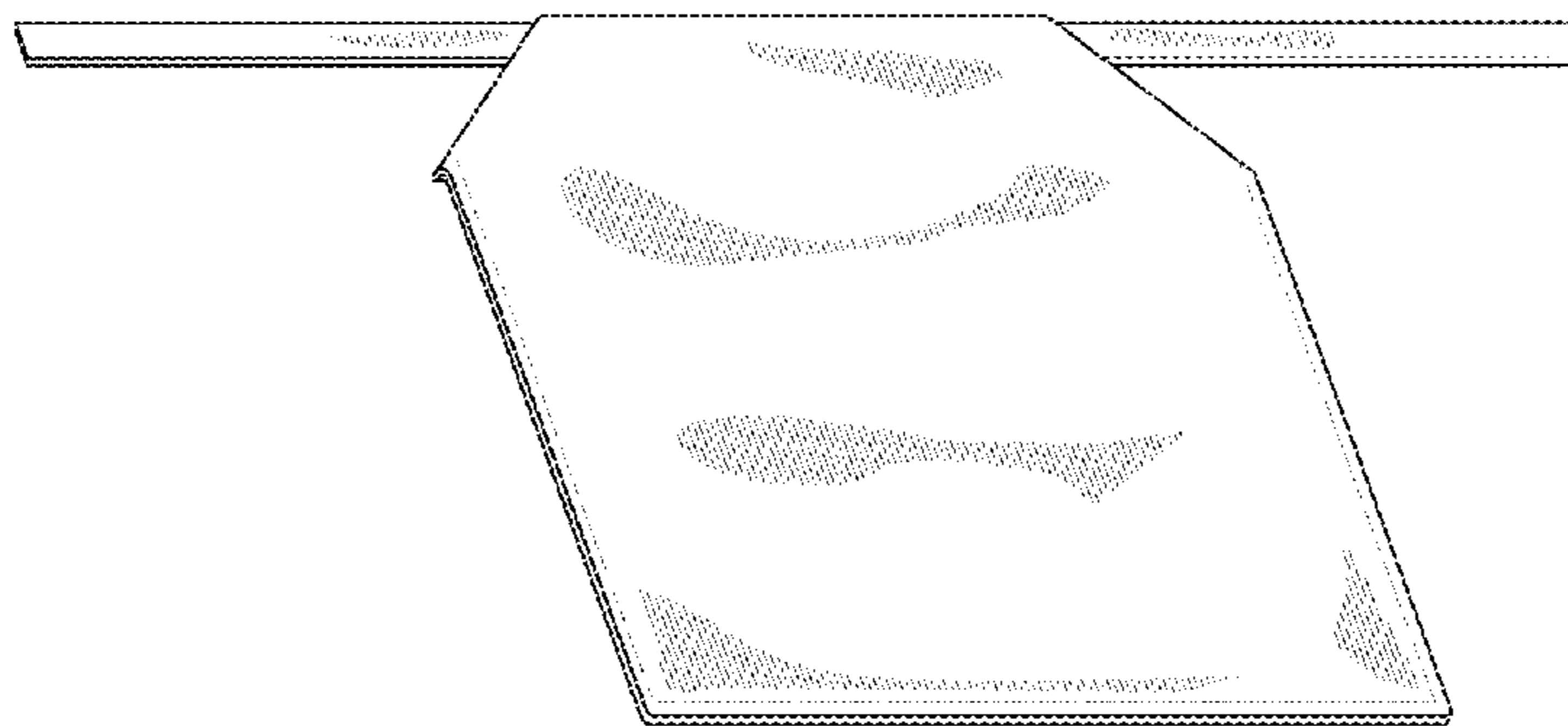
**DESCRIPTION**

FIG. 1 is a front perspective view of a bib, showing a first embodiment of my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a front perspective view of a bib, showing a second embodiment of the design;  
 FIG. 8 is a front elevational view thereof;  
 FIG. 9 is a rear elevational view thereof;  
 FIG. 10 is a right side elevational view thereof; the left side elevational view being a mirror image thereof;  
 FIG. 11 is a top plan view thereof; and,  
 FIG. 12 is a bottom plan view thereof.  
 The broken lines in FIGS. 1-3 and 7-10 represent the portions of the design, which form no part of the claimed design.

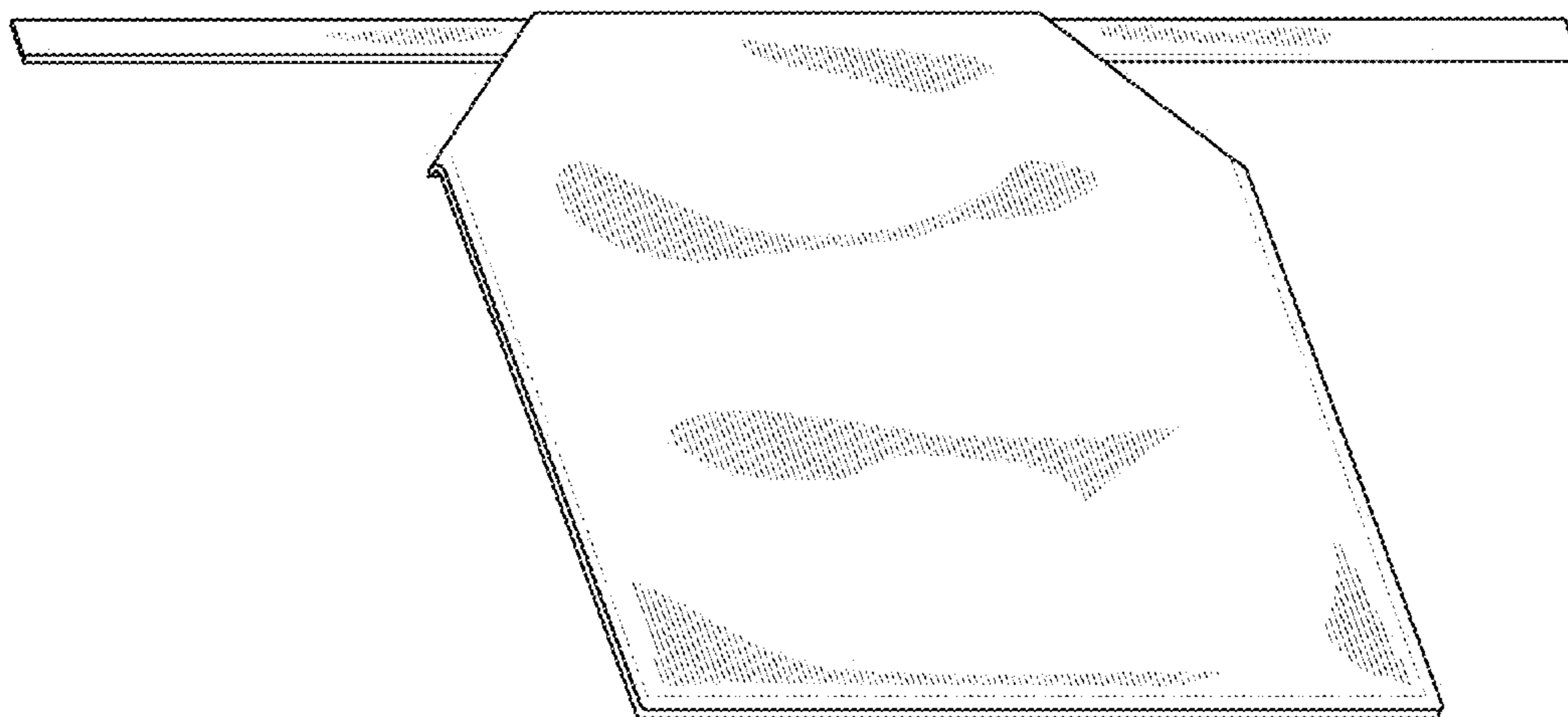

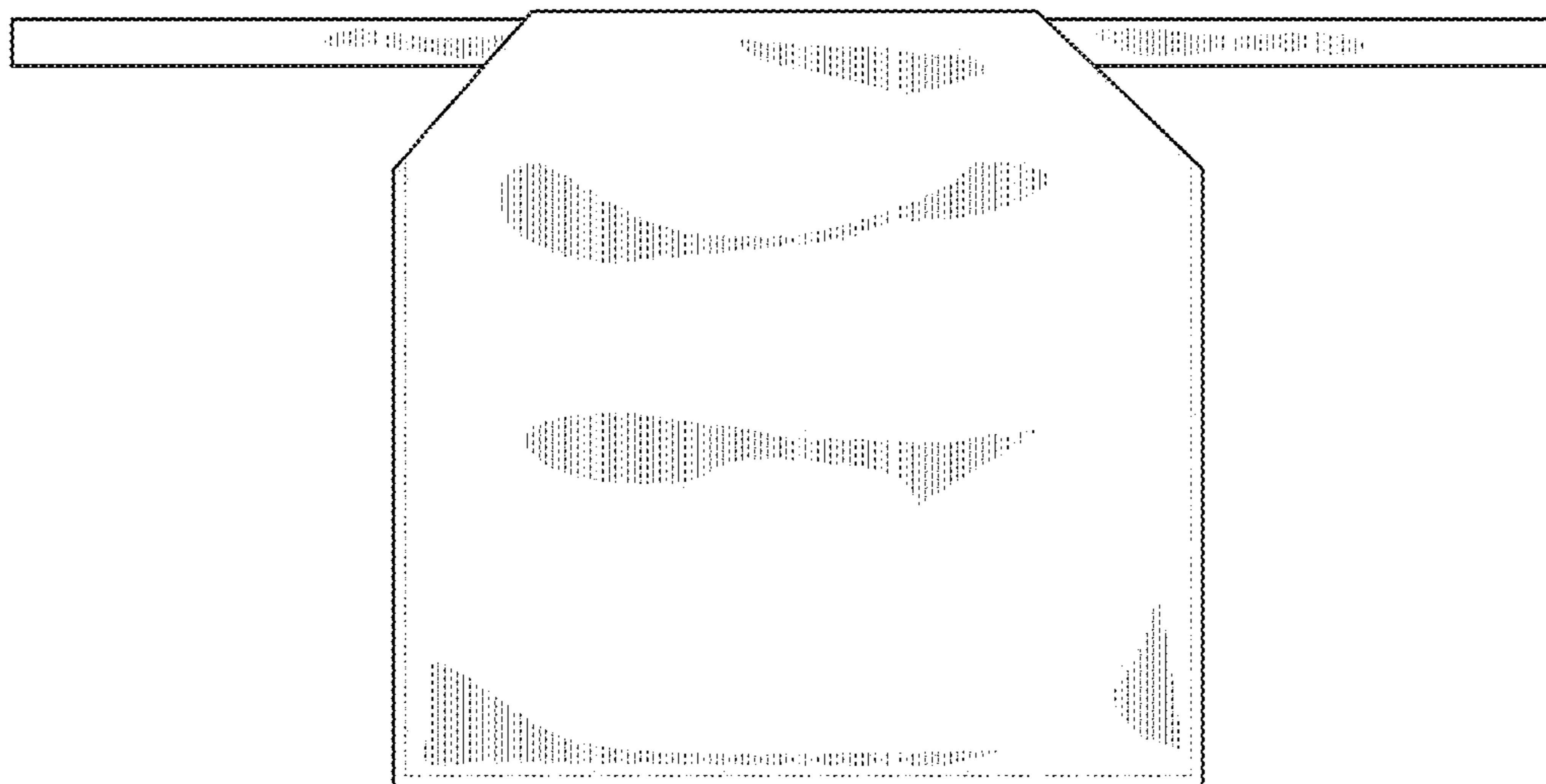

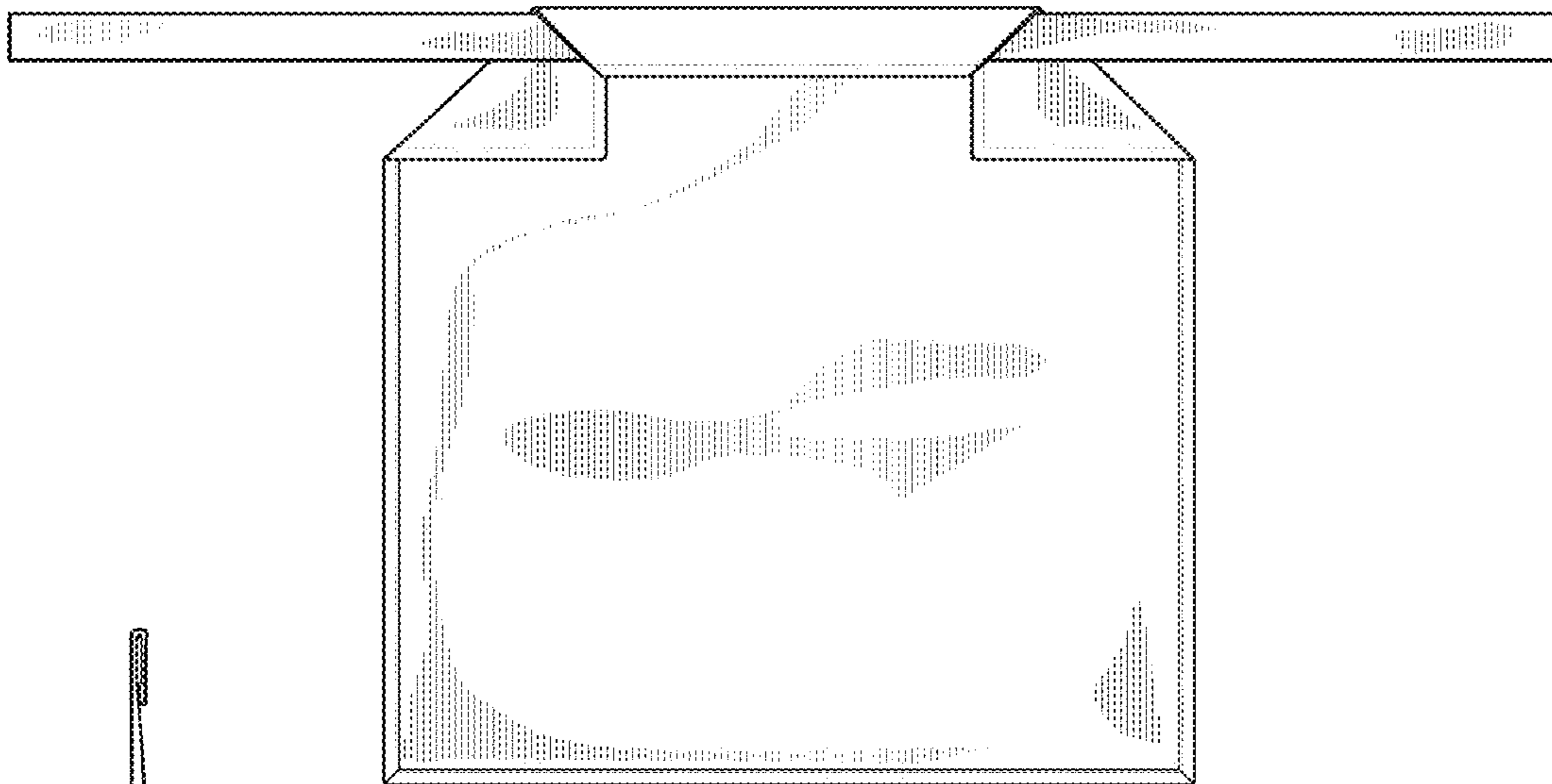

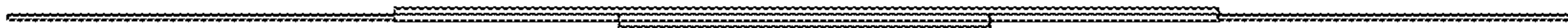

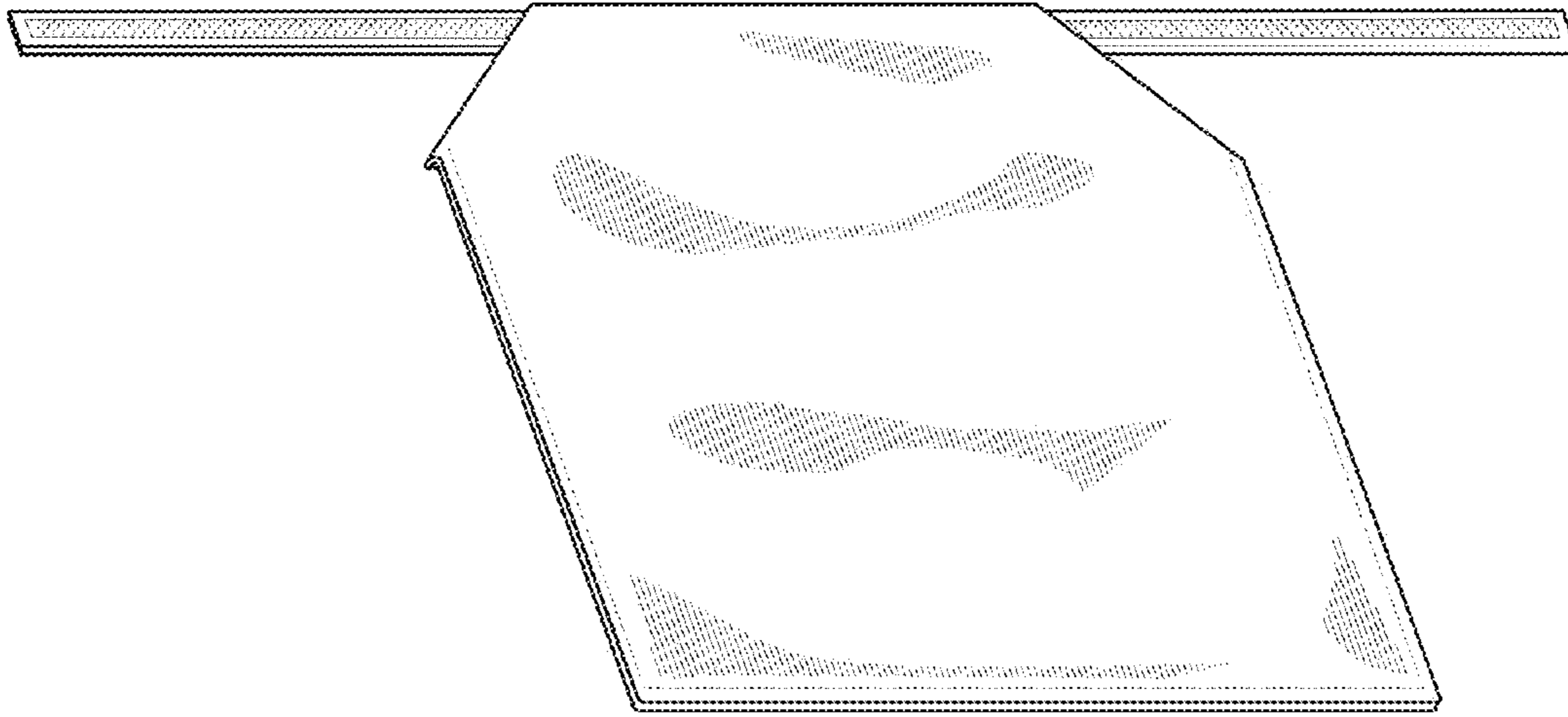

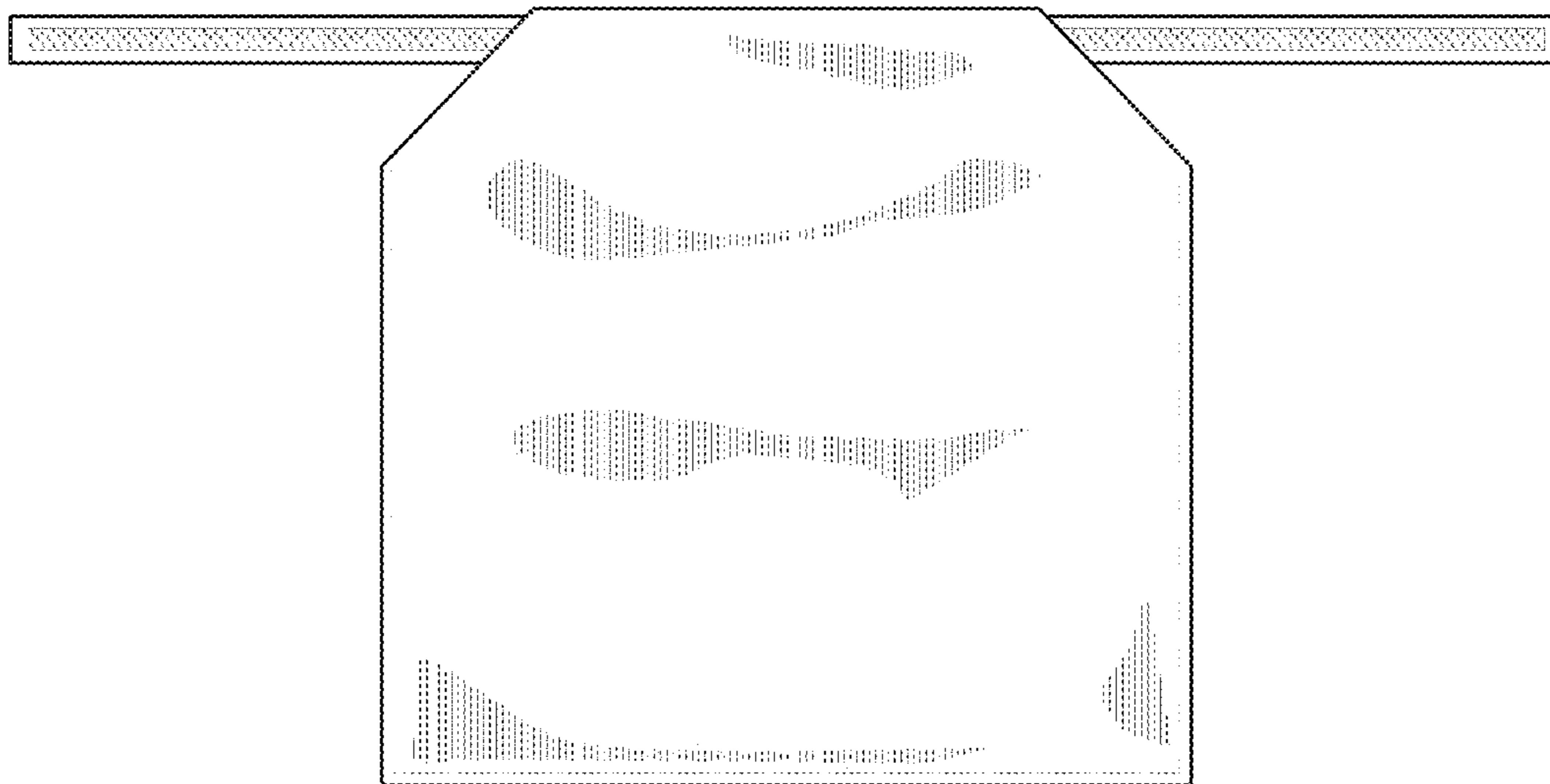

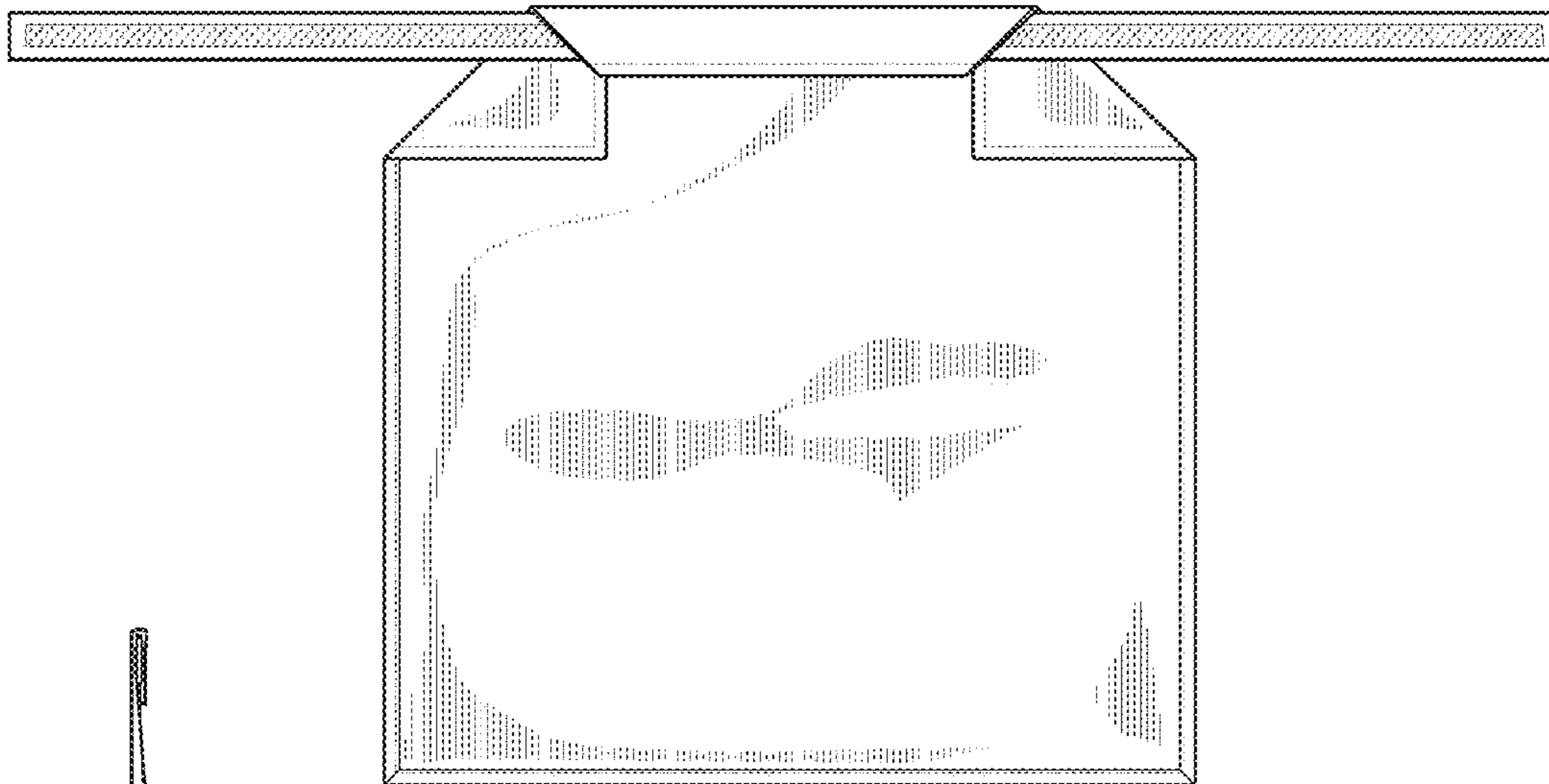

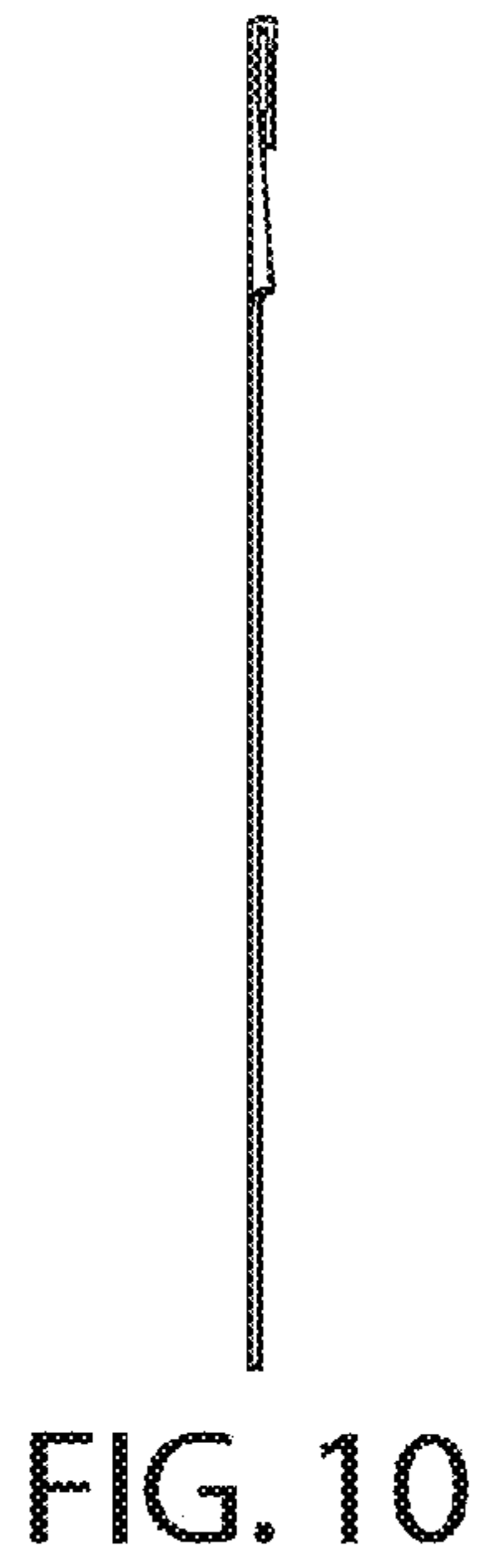
