(57) **CLAIM**

We claim the ornamental design for a portion of an upper of a footwear article, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a portion of an upper of a footwear article; and,  
FIG. 2 is a side view of the portion of an upper of a footwear article of FIG. 1.

The ornamental design that is claimed is shown in solid lines in the drawings. The broken (dashed) lines shown in the figures are included for the purpose of illustrating environmental elements only and form no part of the claimed design.

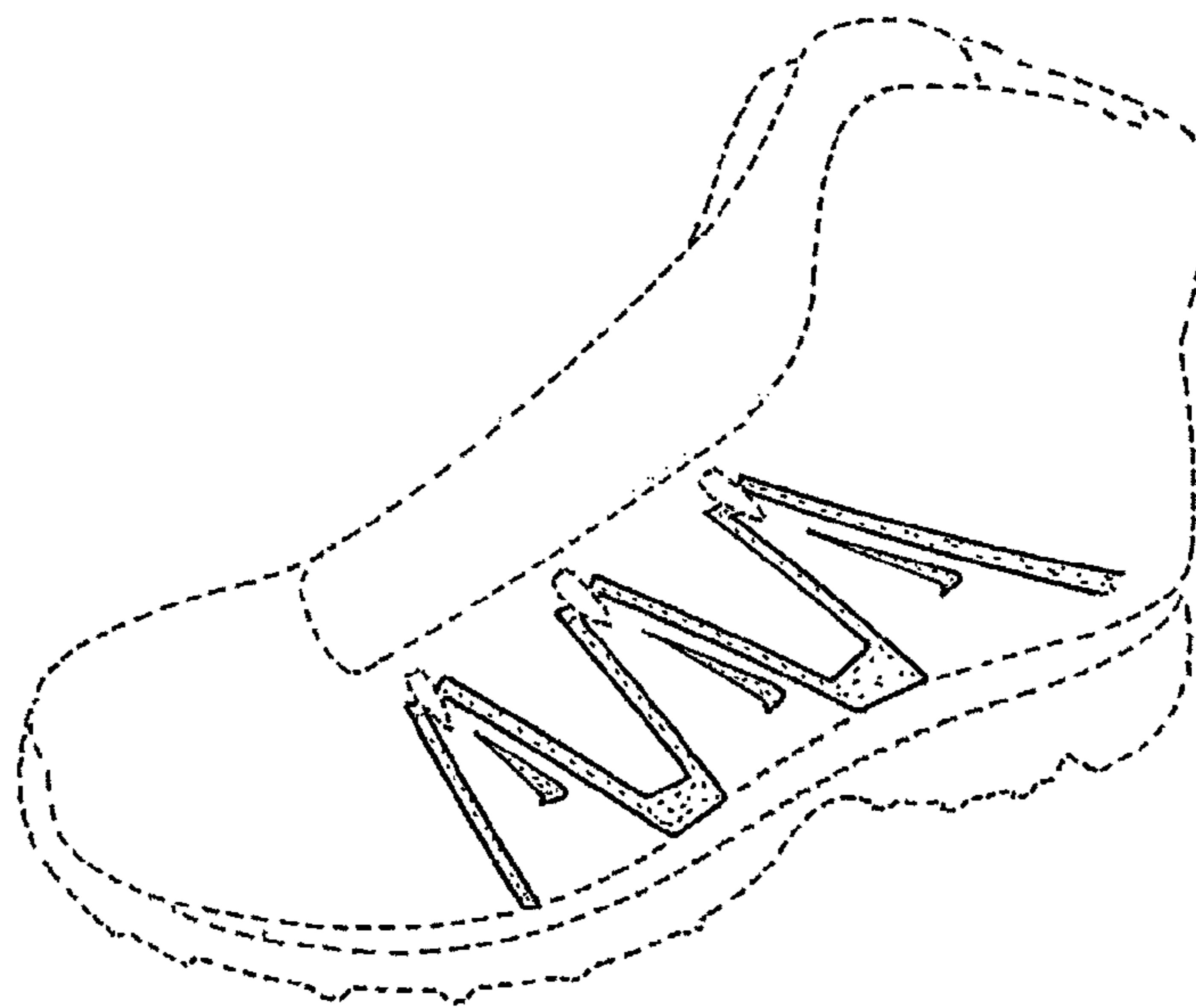

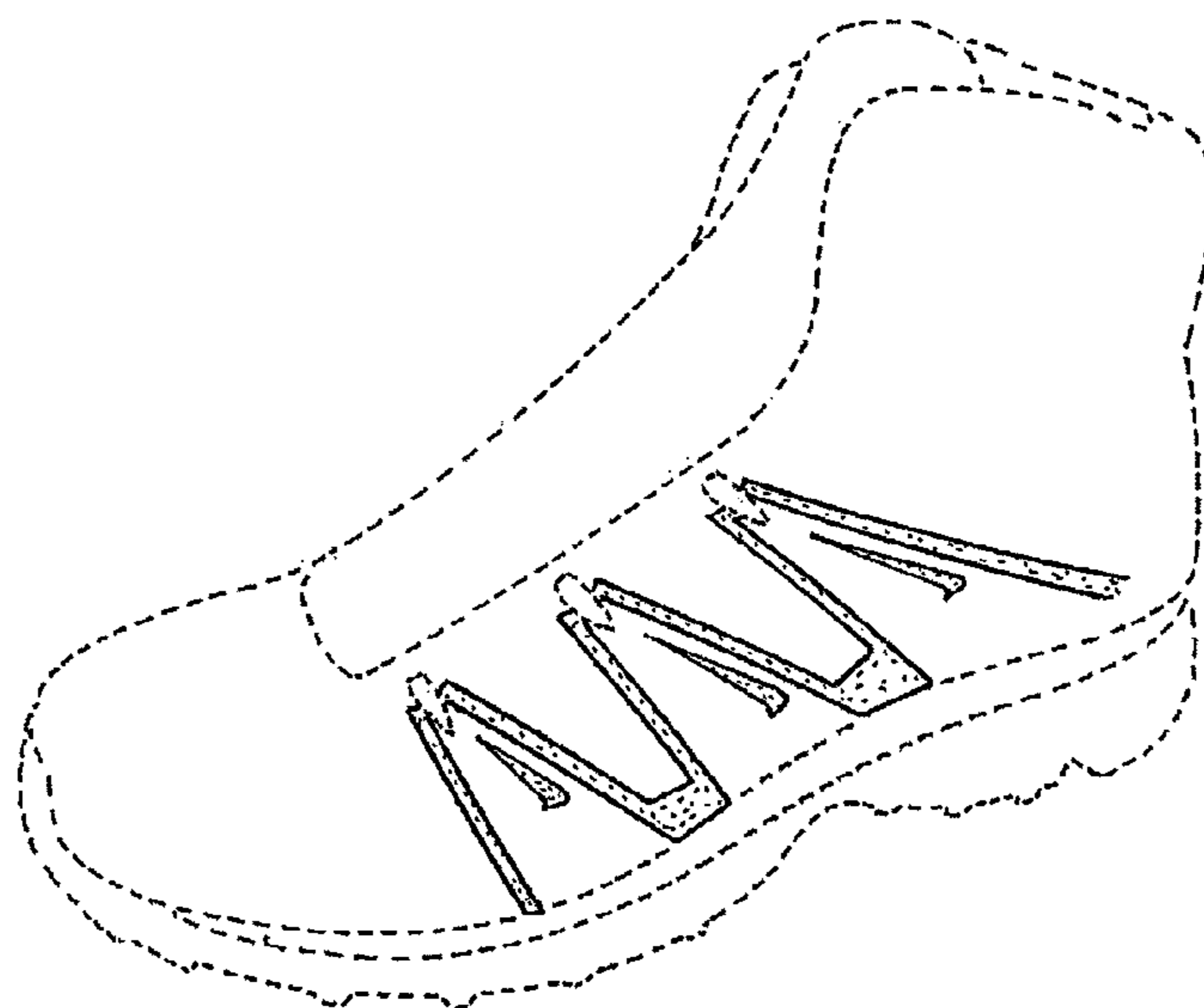
