DESCRIPTION

FIG. 1 is an upper perspective view of the corkscrew showing my new design.

FIG. 2 is a rear elevation view thereof;

FIG. 3 is front elevation view thereof;

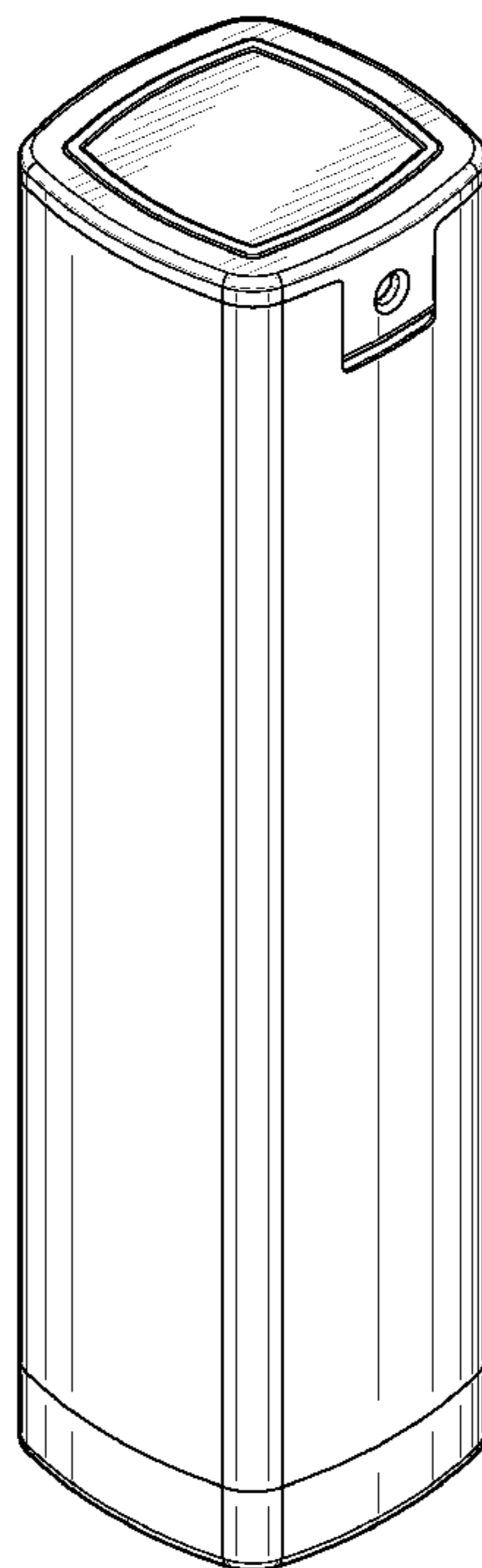
FIG. 4 is a side view thereof, an opposite side view being identical;

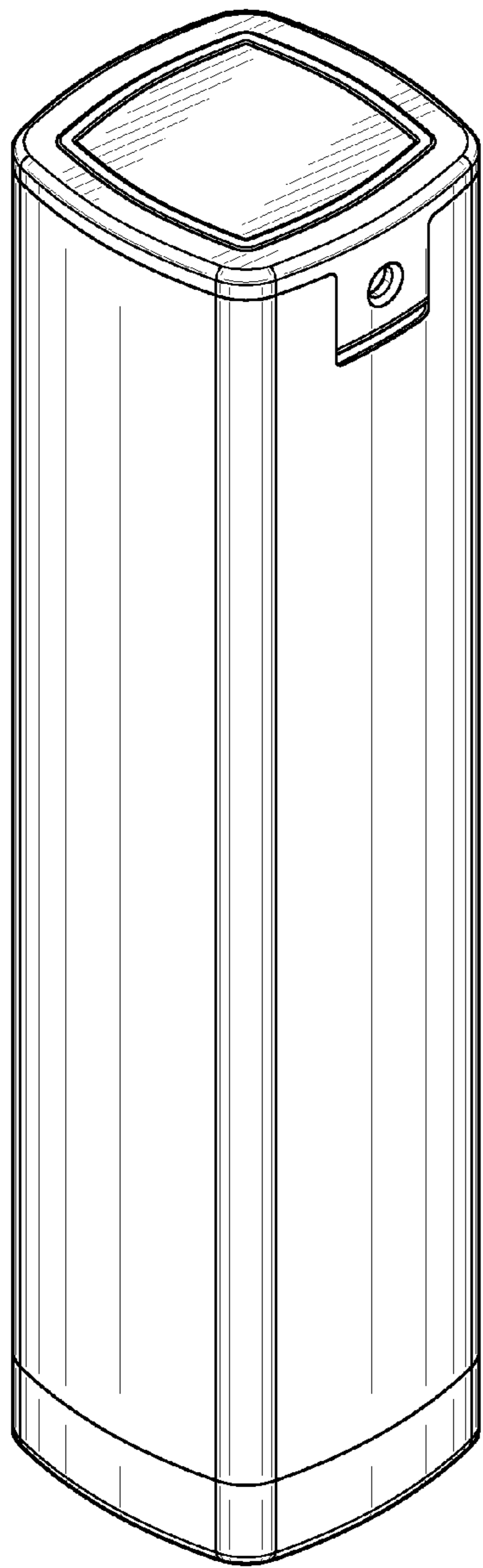

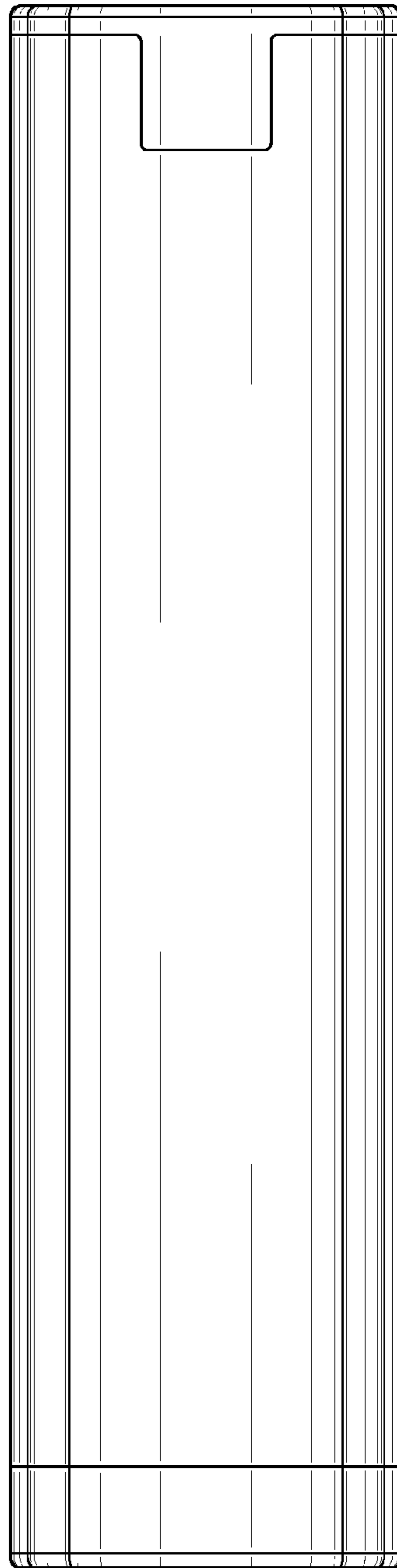

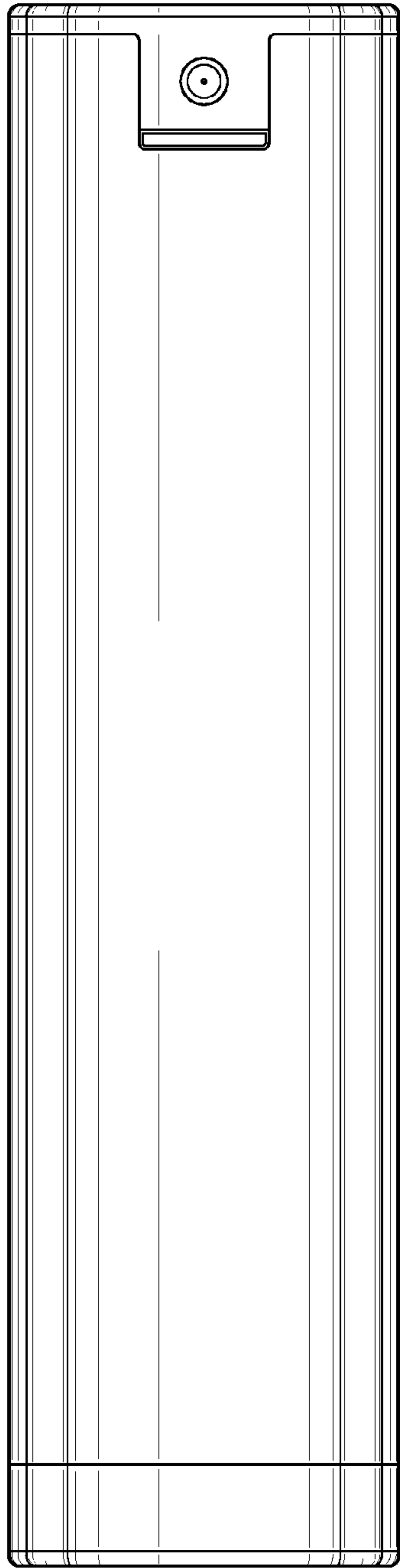

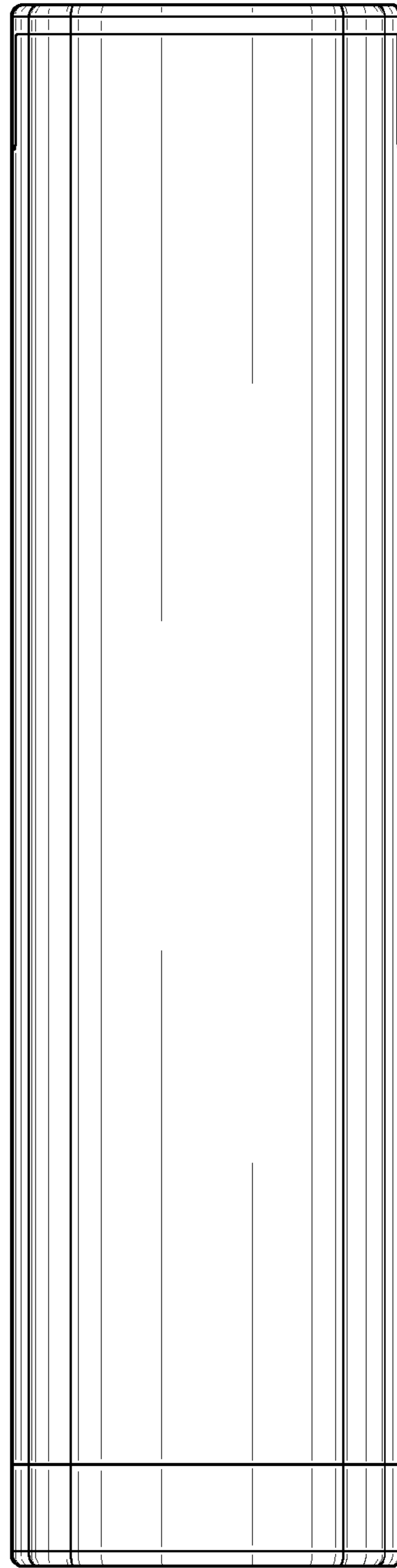

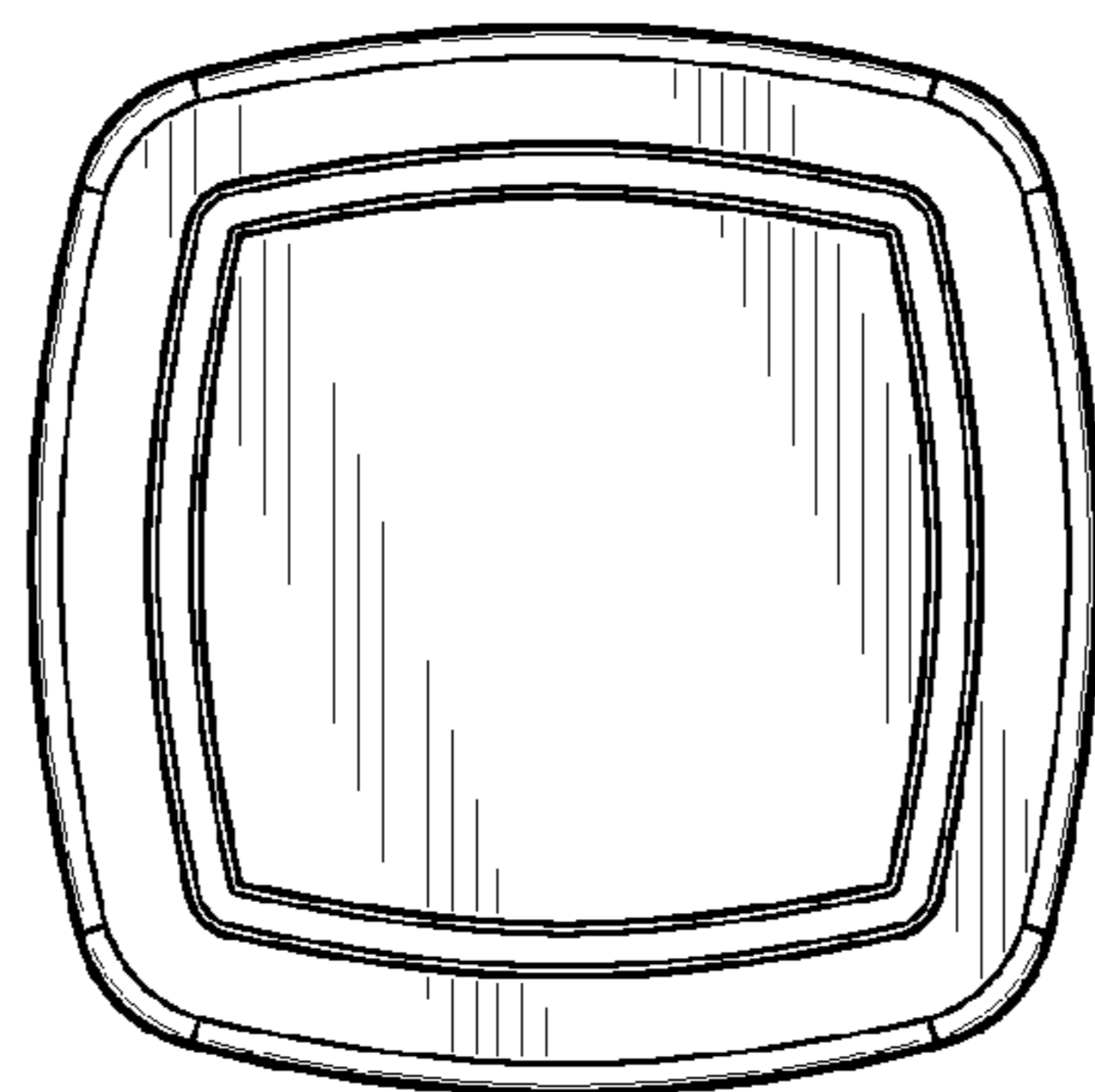

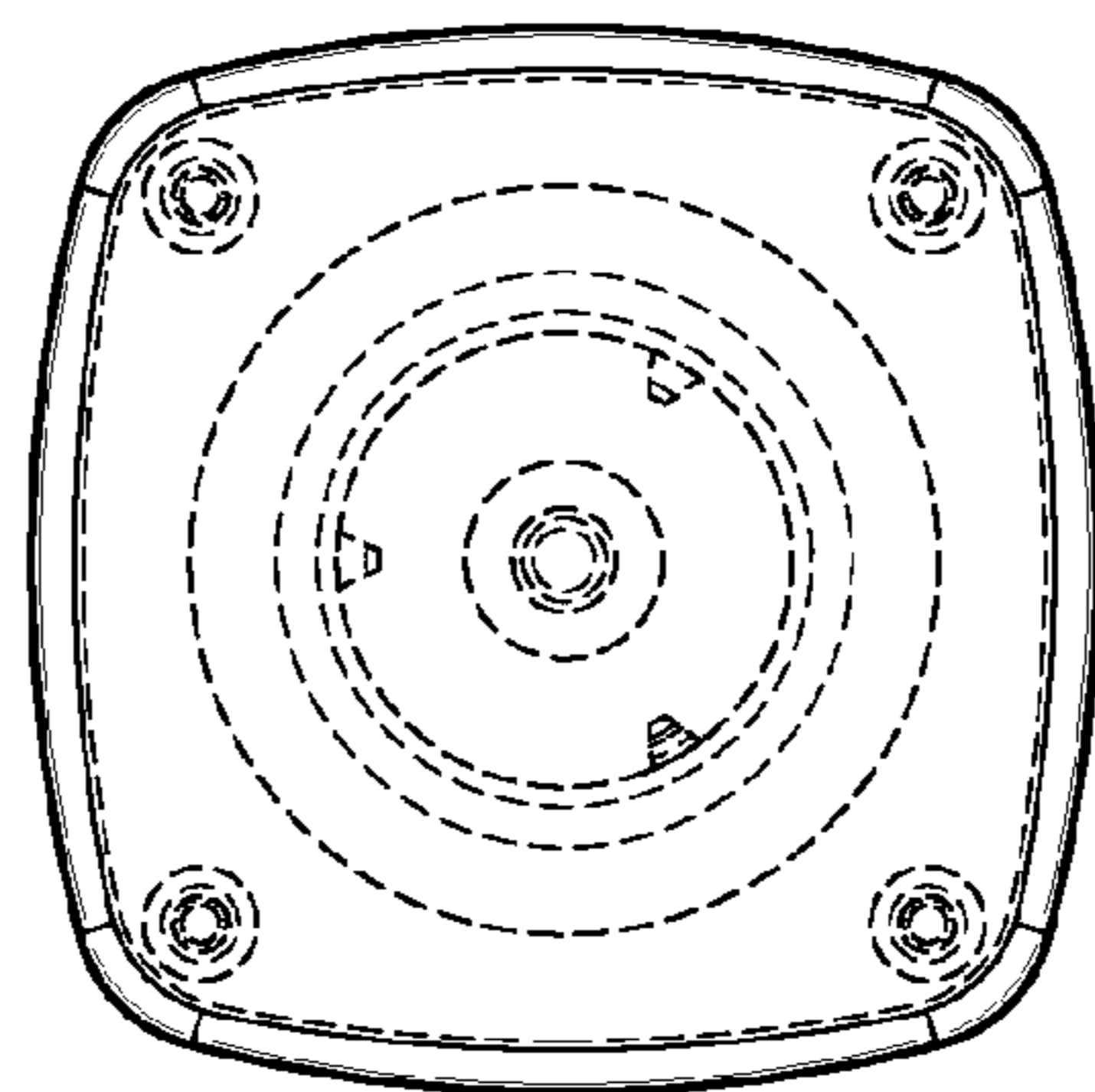
