FIG. 3 is a bottom perspective view thereof.

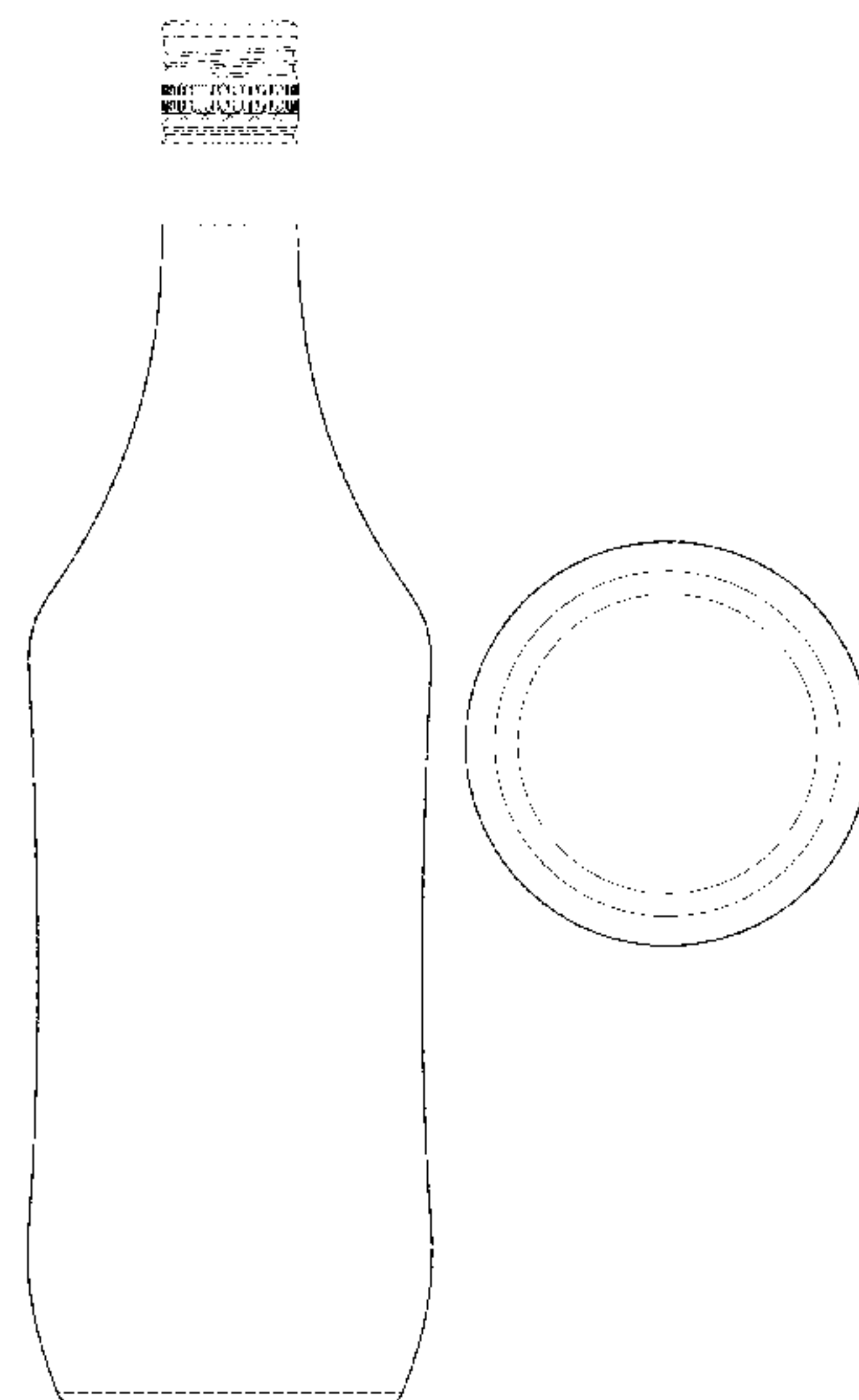
FIG. 4 is a top perspective view thereof.

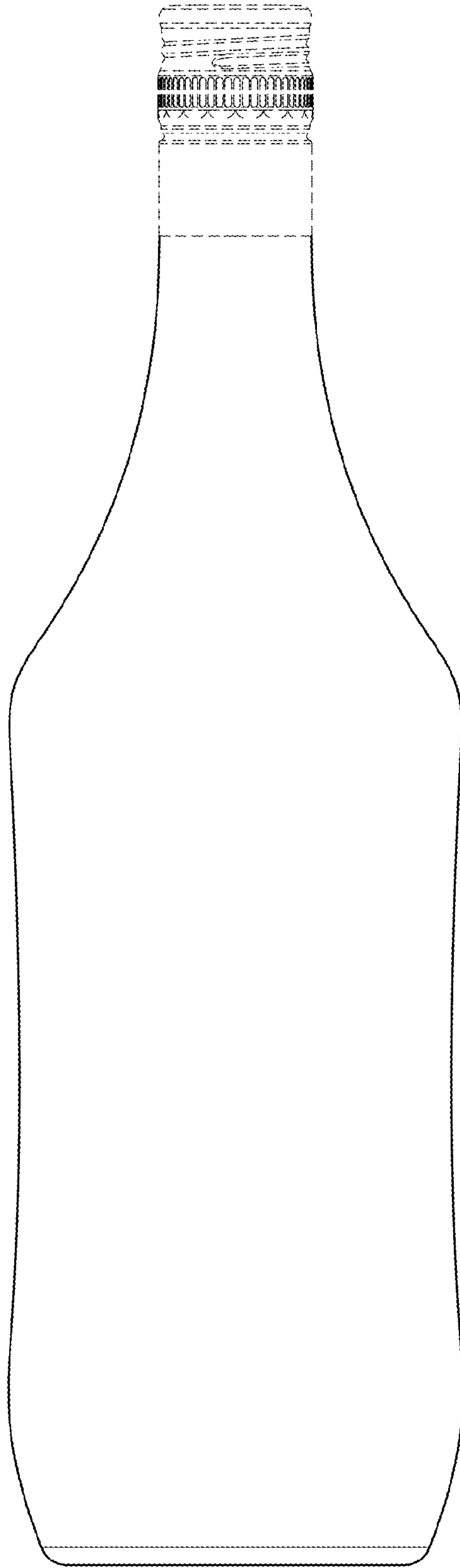

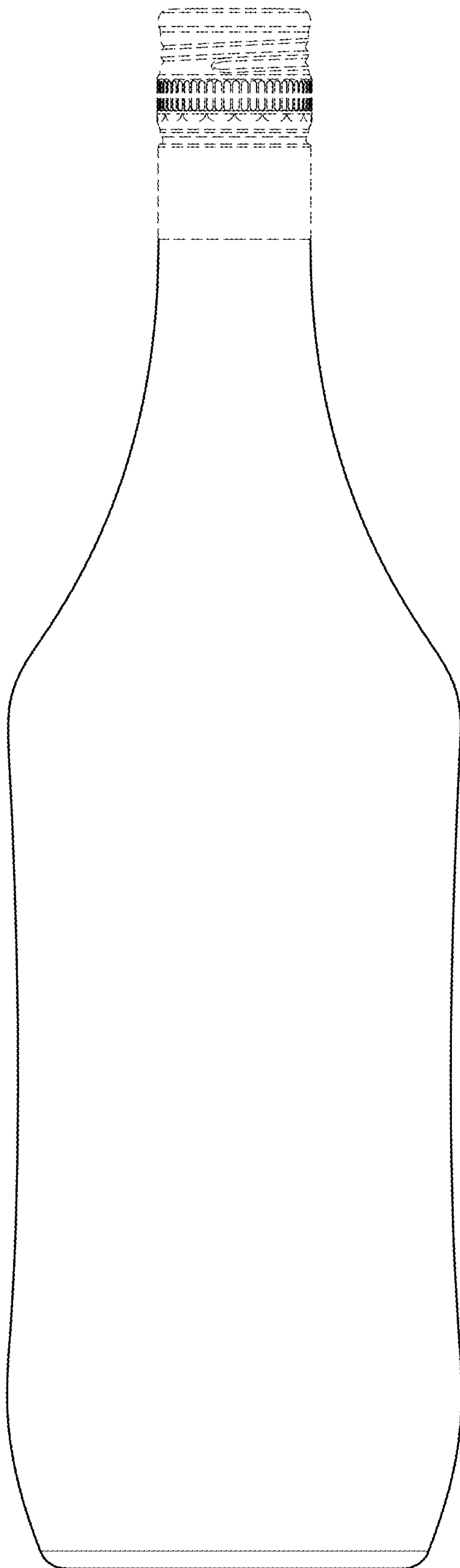

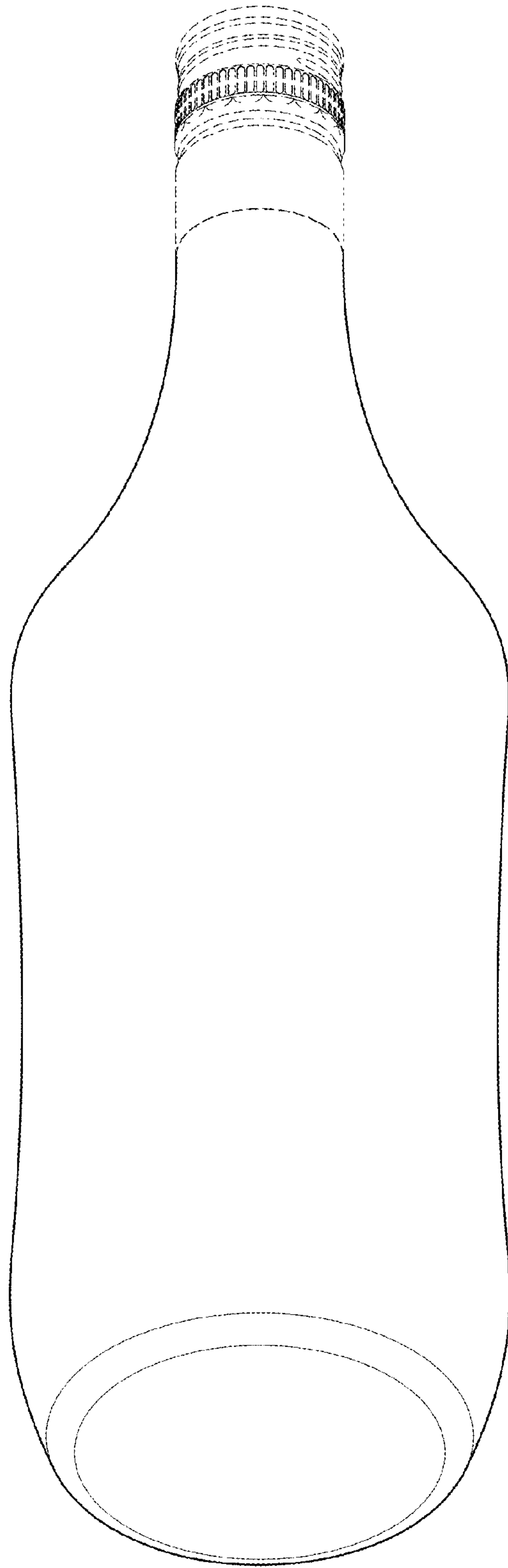

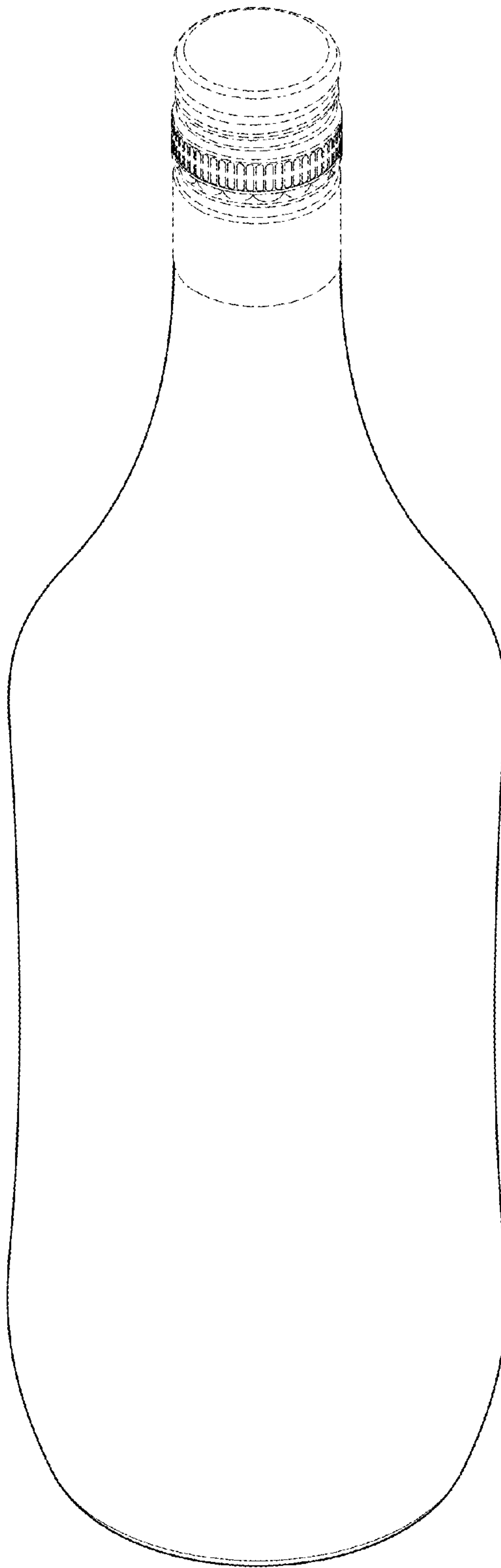

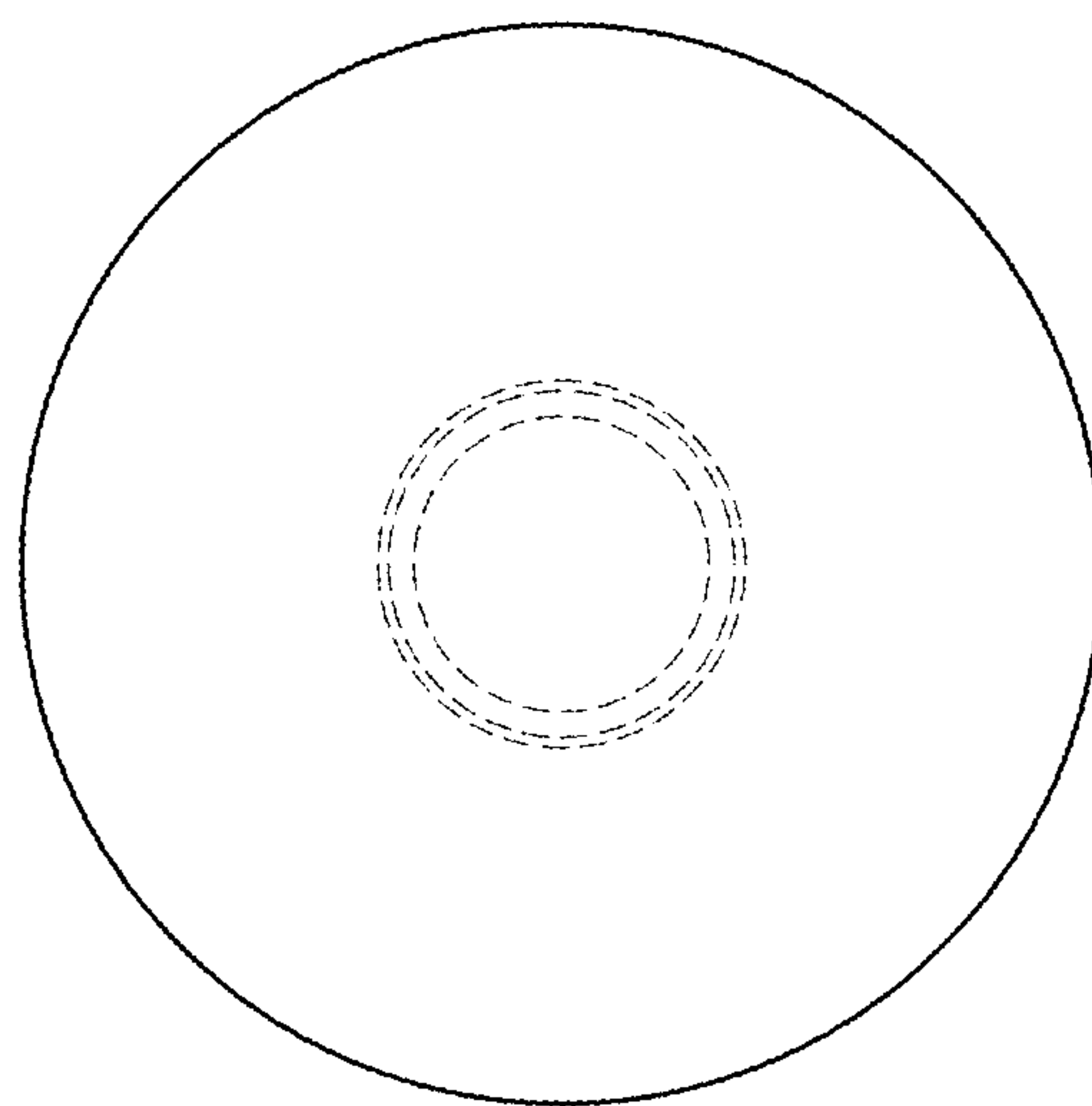

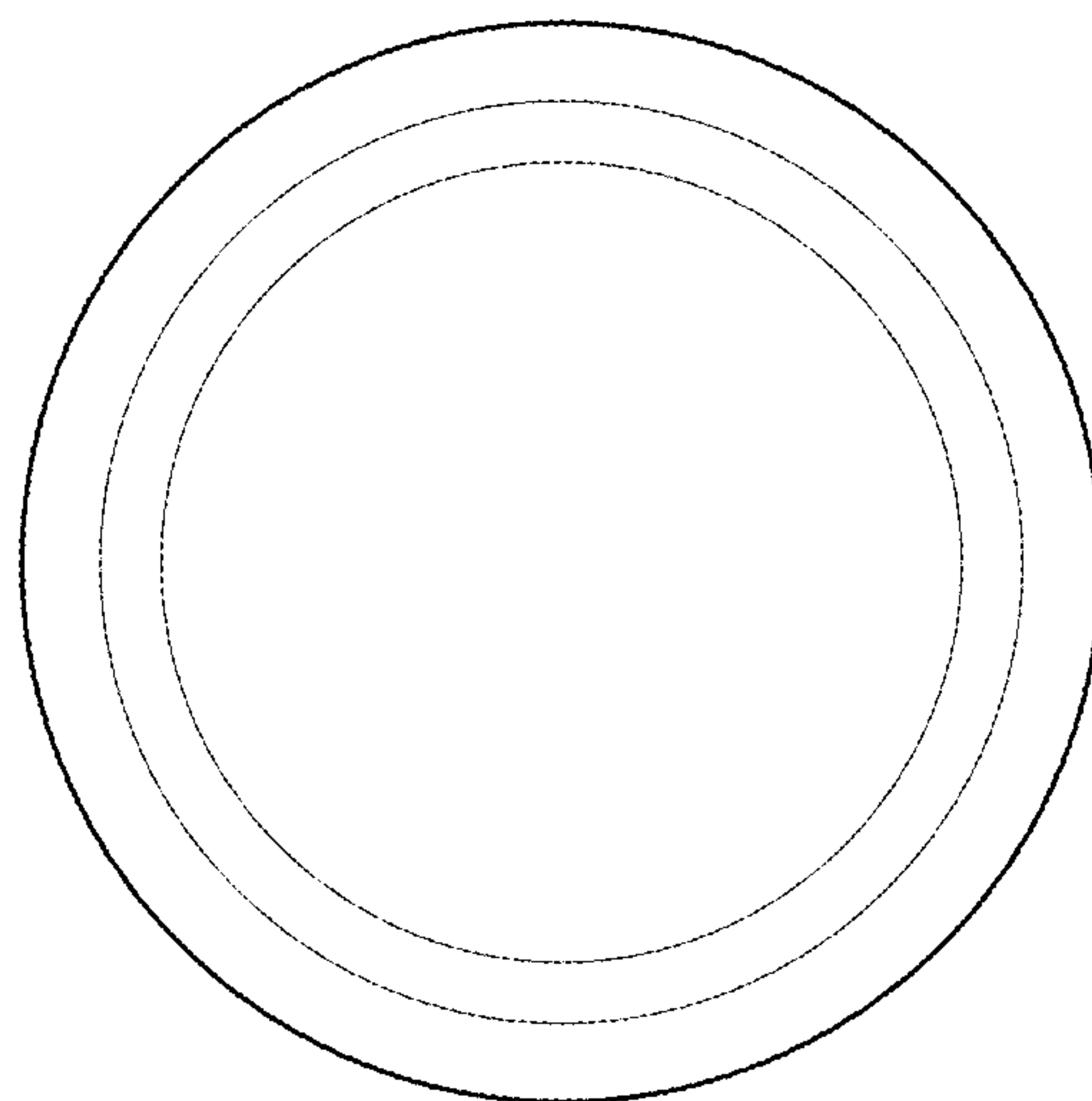
