The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a second embodiment of a bottle;

FIG. 2 is a front view thereof;

FIG. 4 is a right side view thereof;

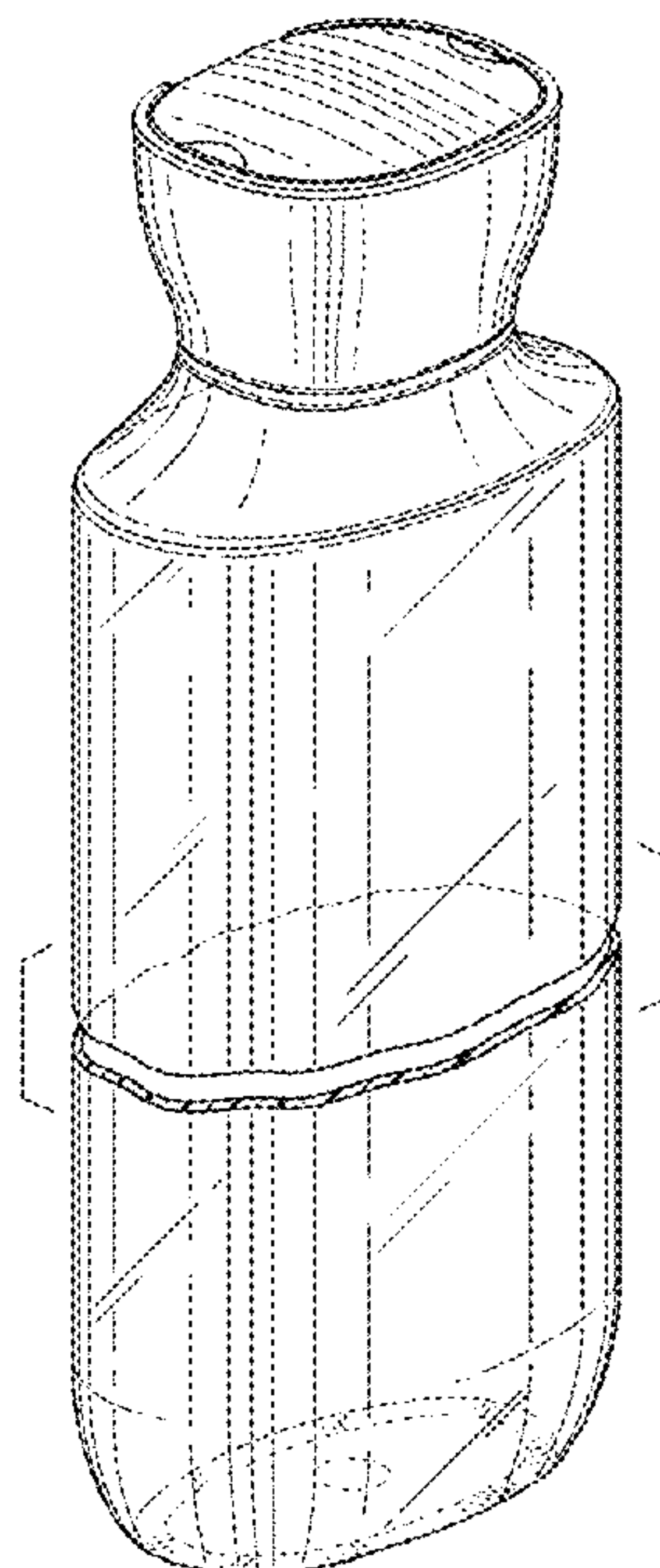
FIG. 5 is a left side view thereof;

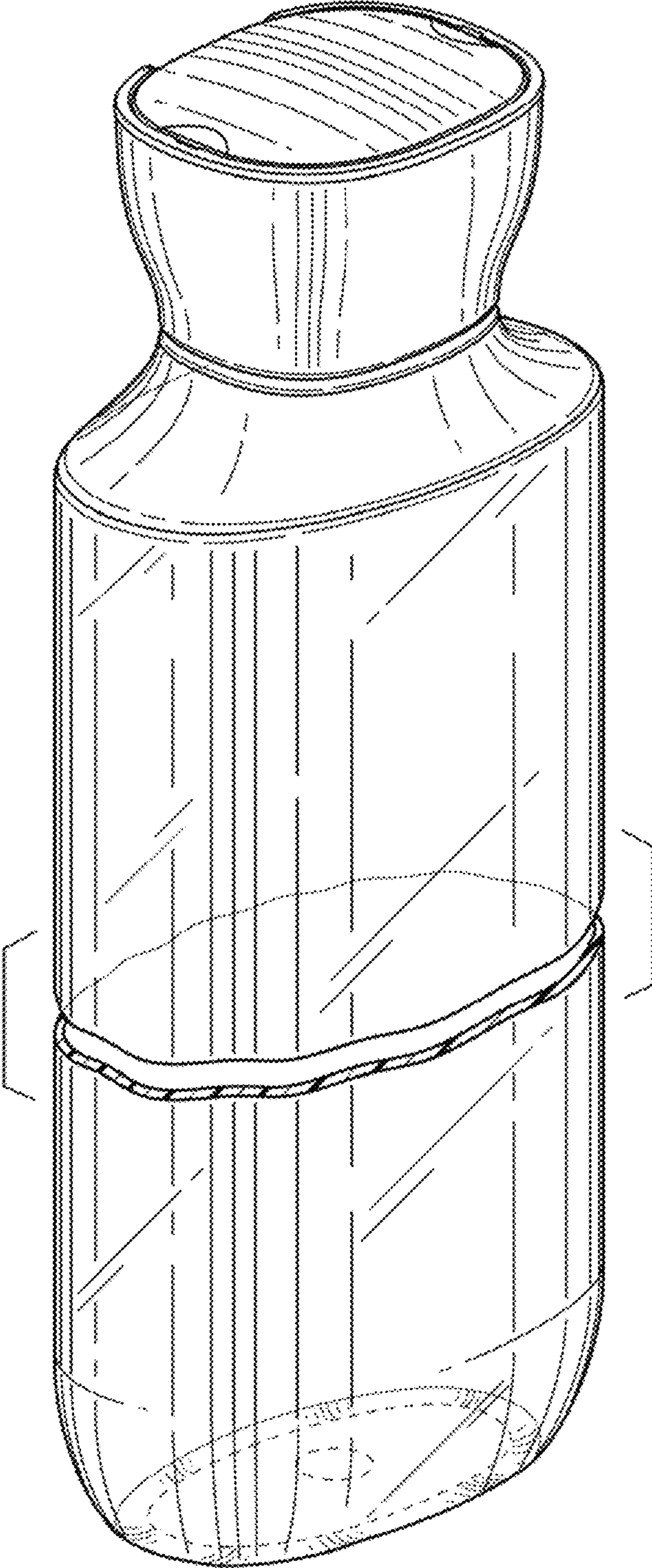

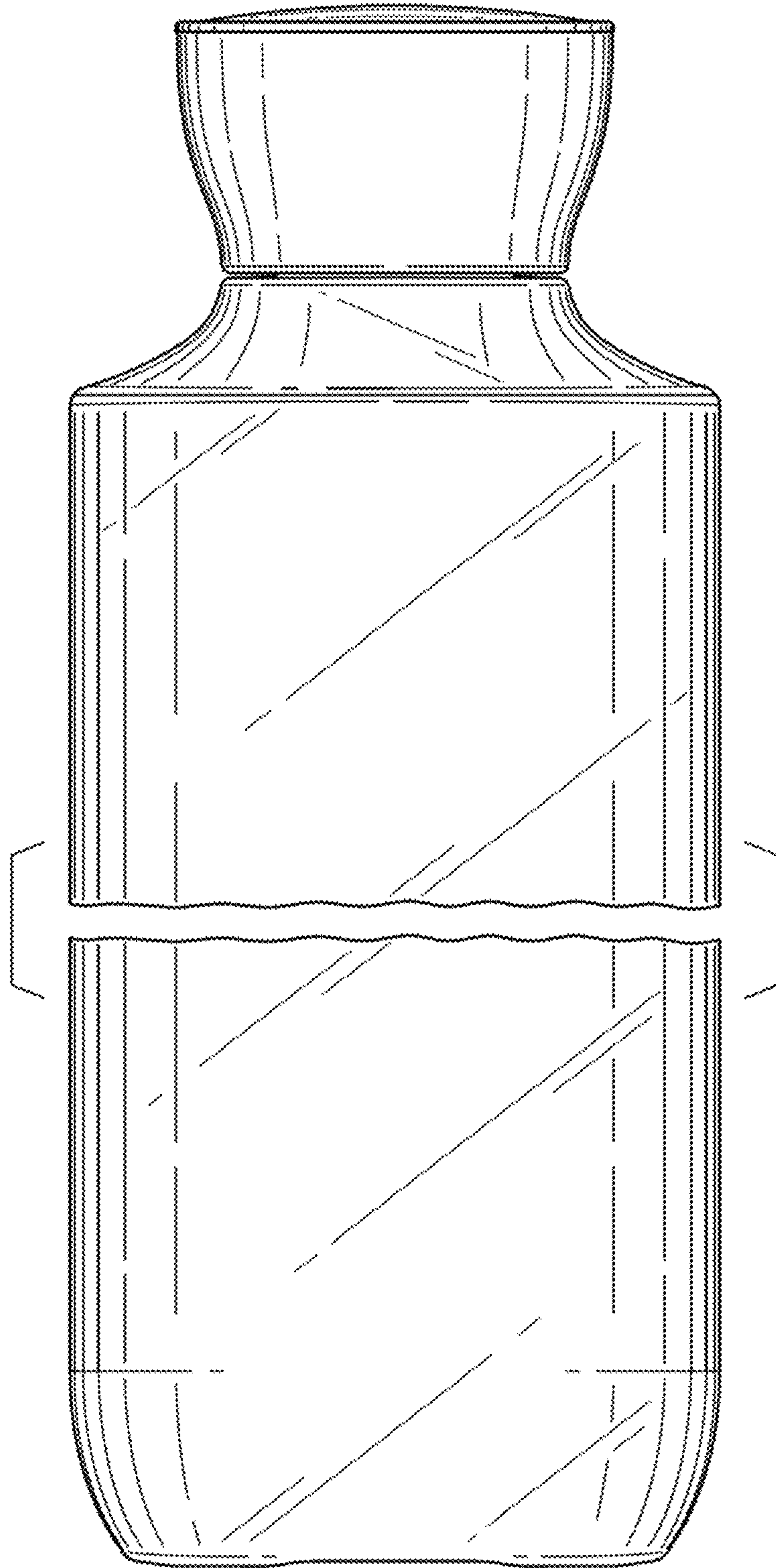

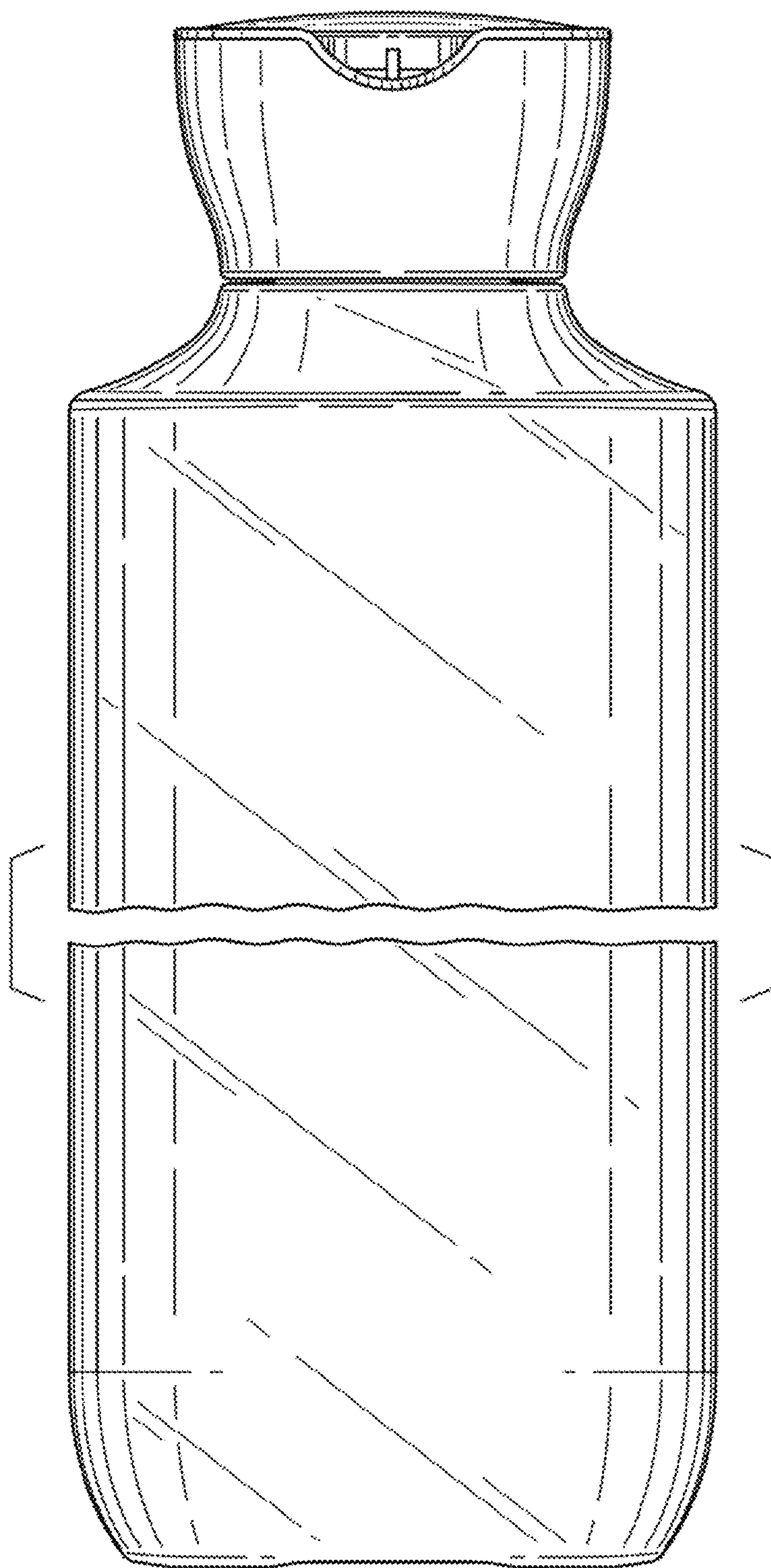

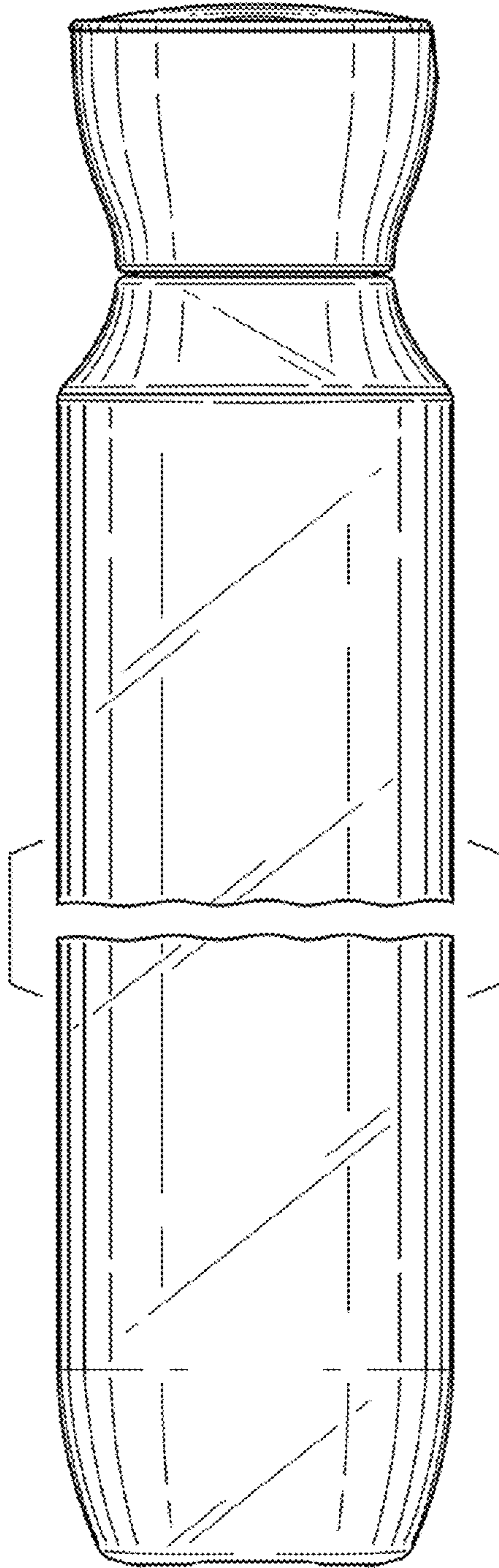

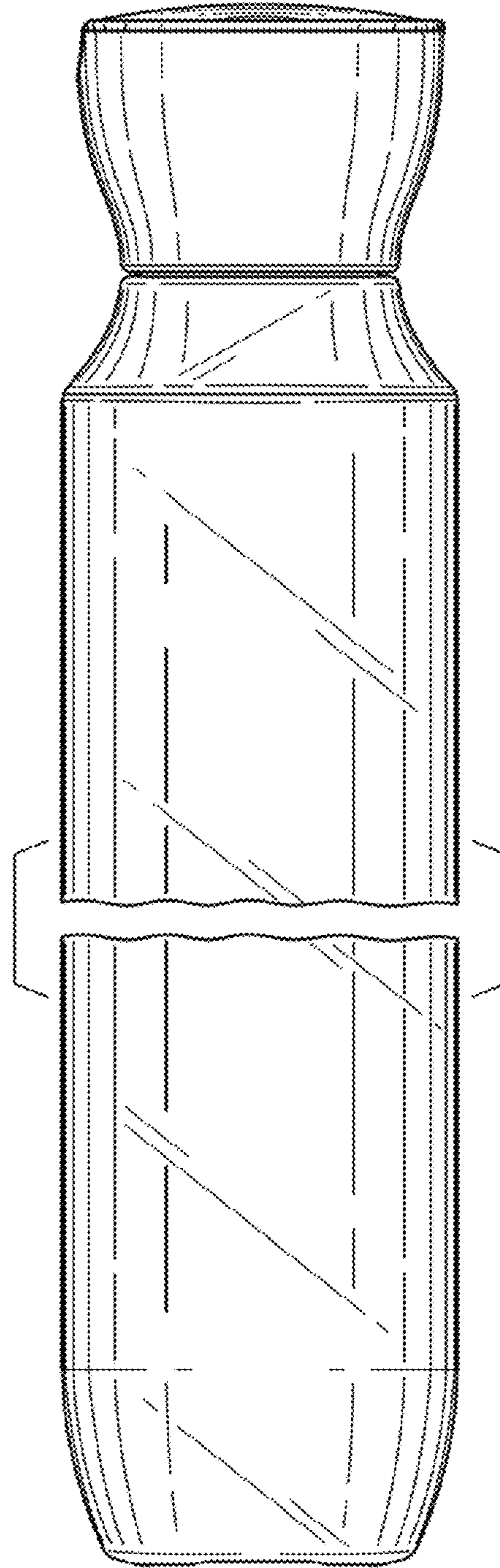

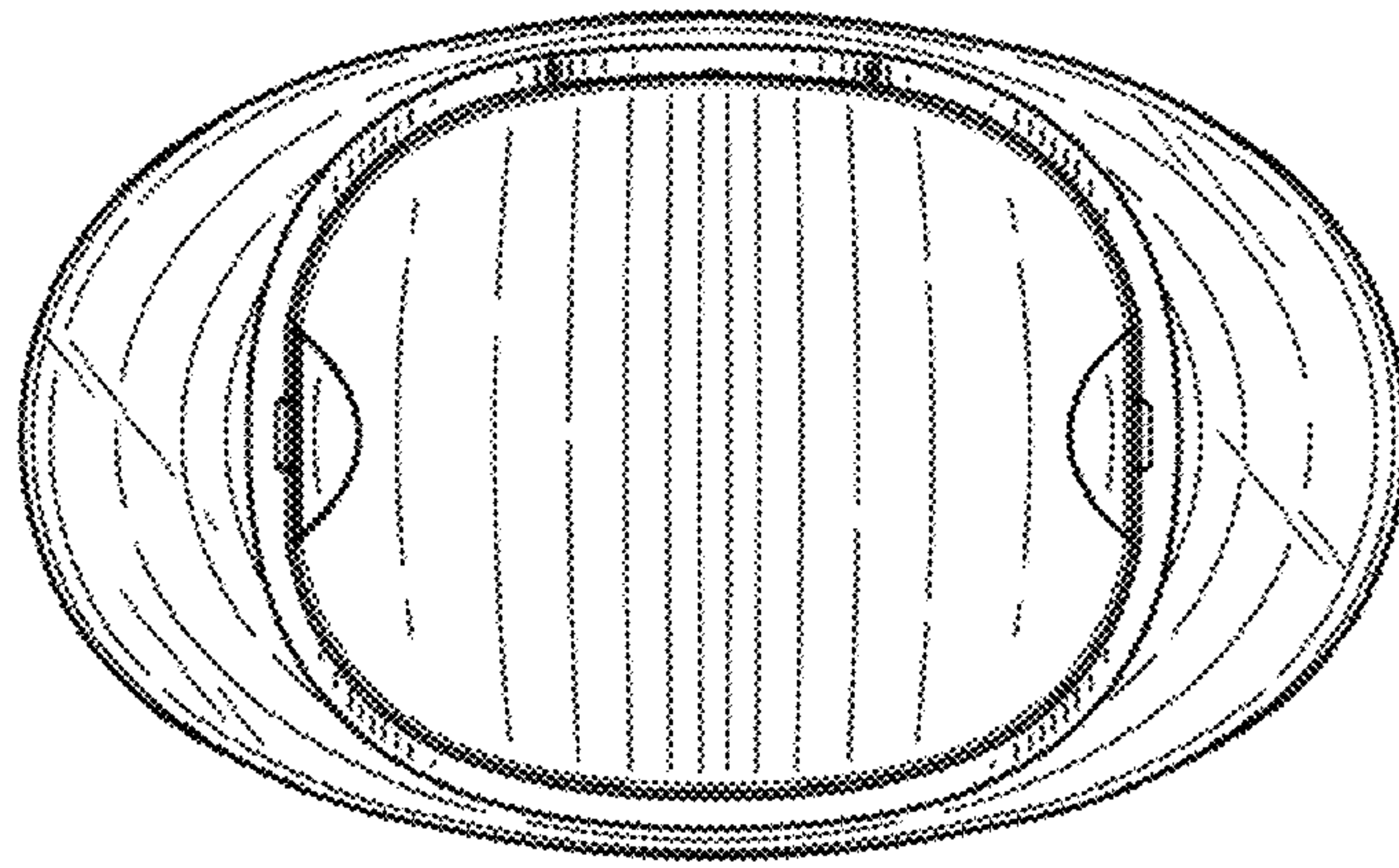

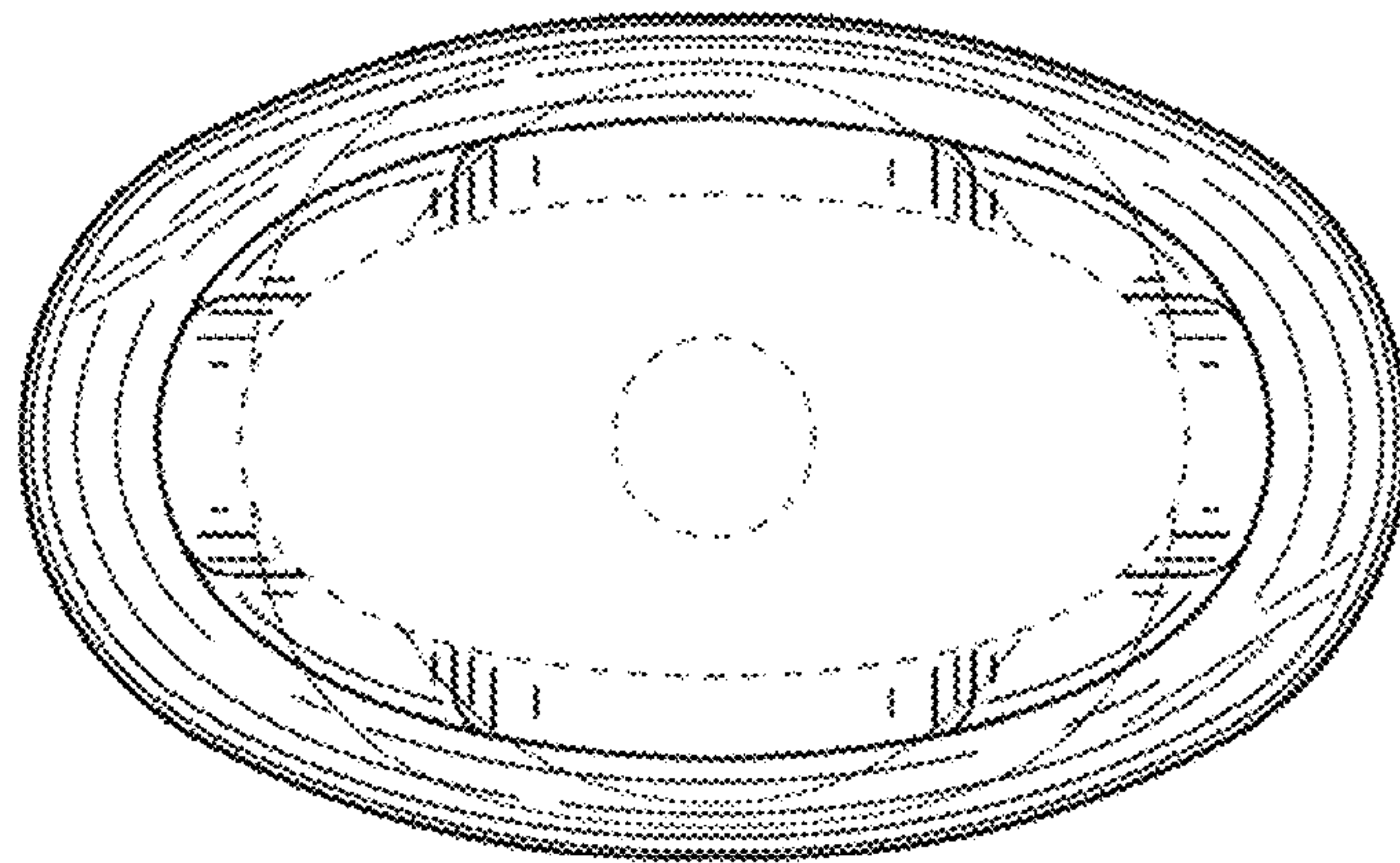
