FIG. 2 is a front view thereof, which is identical to the back view, thereof (not separately shown);

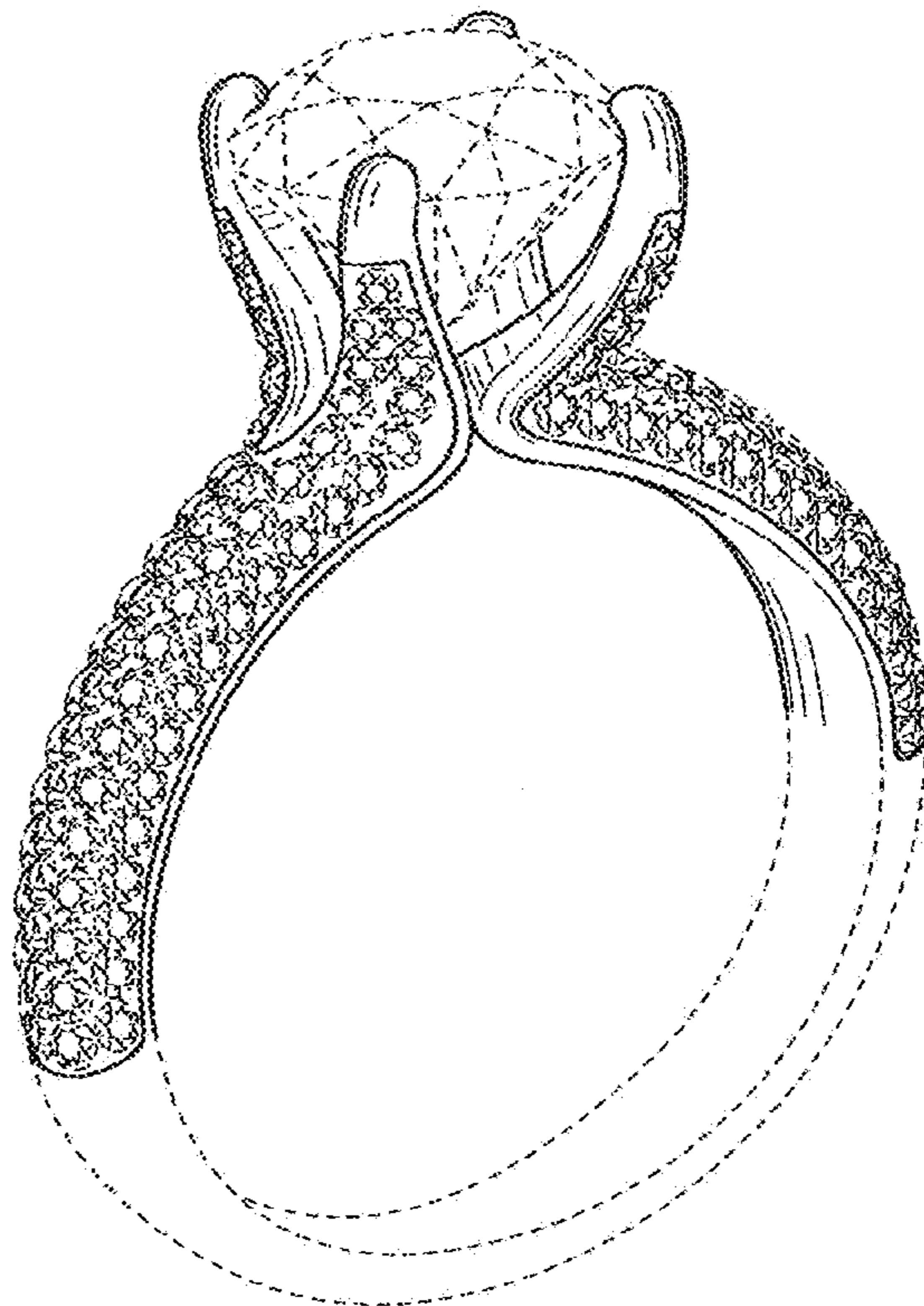
FIG. 3 is a side view thereof;

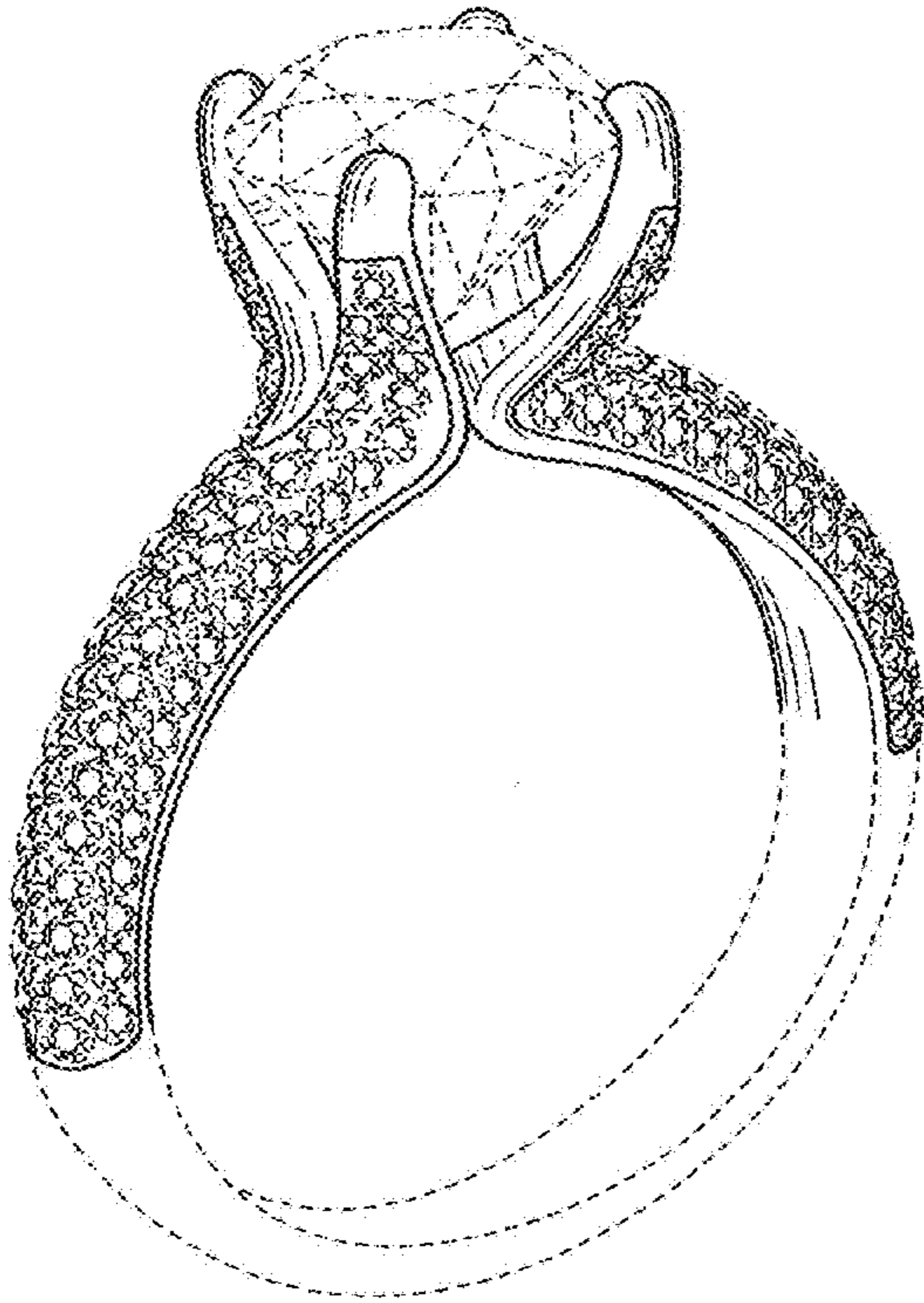

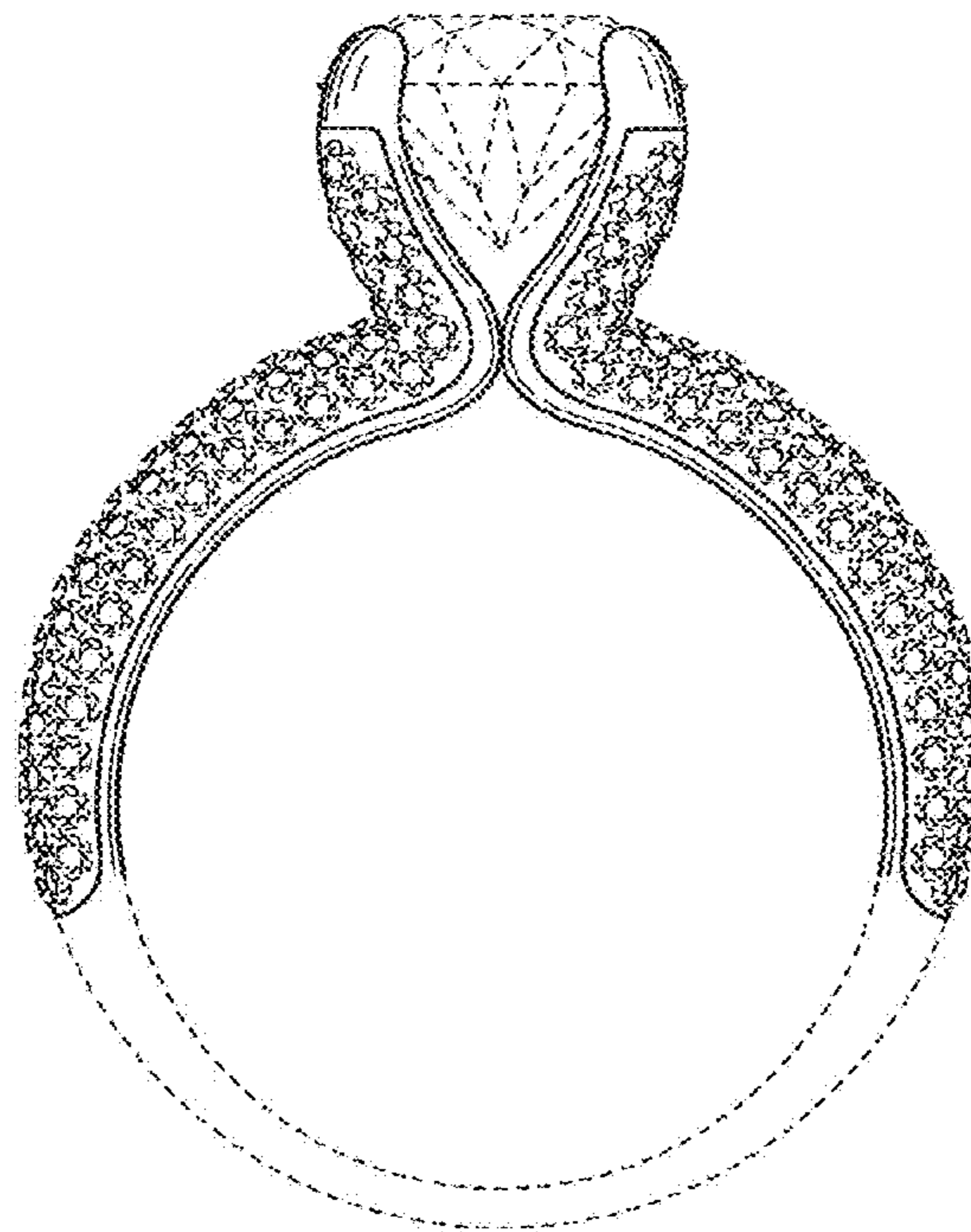

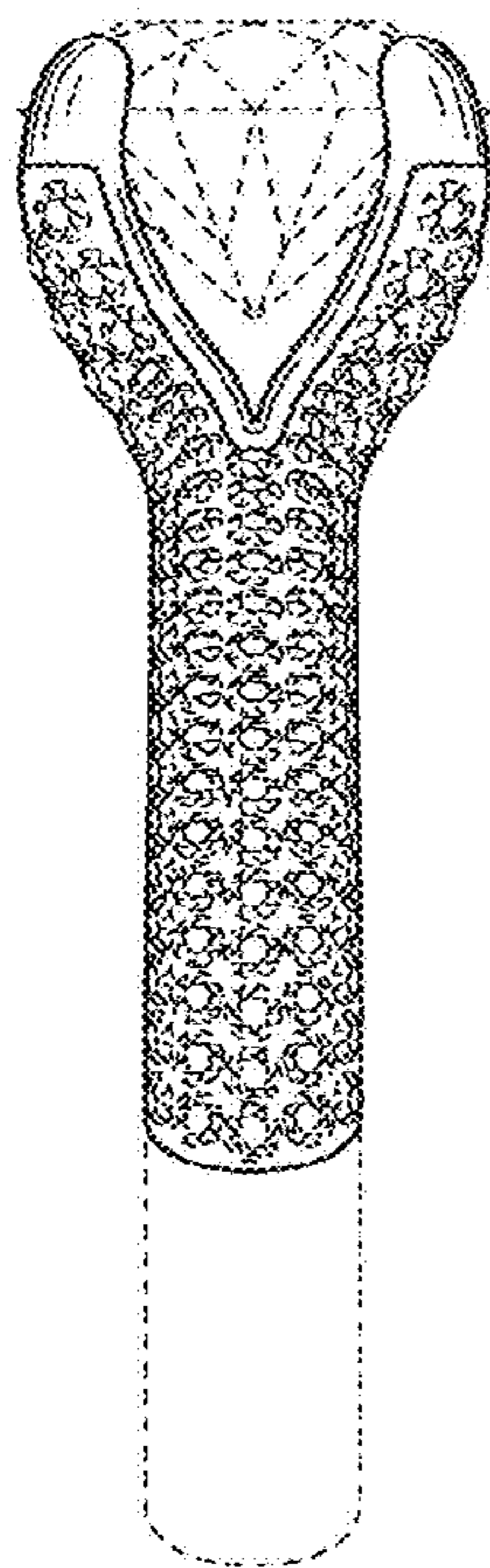

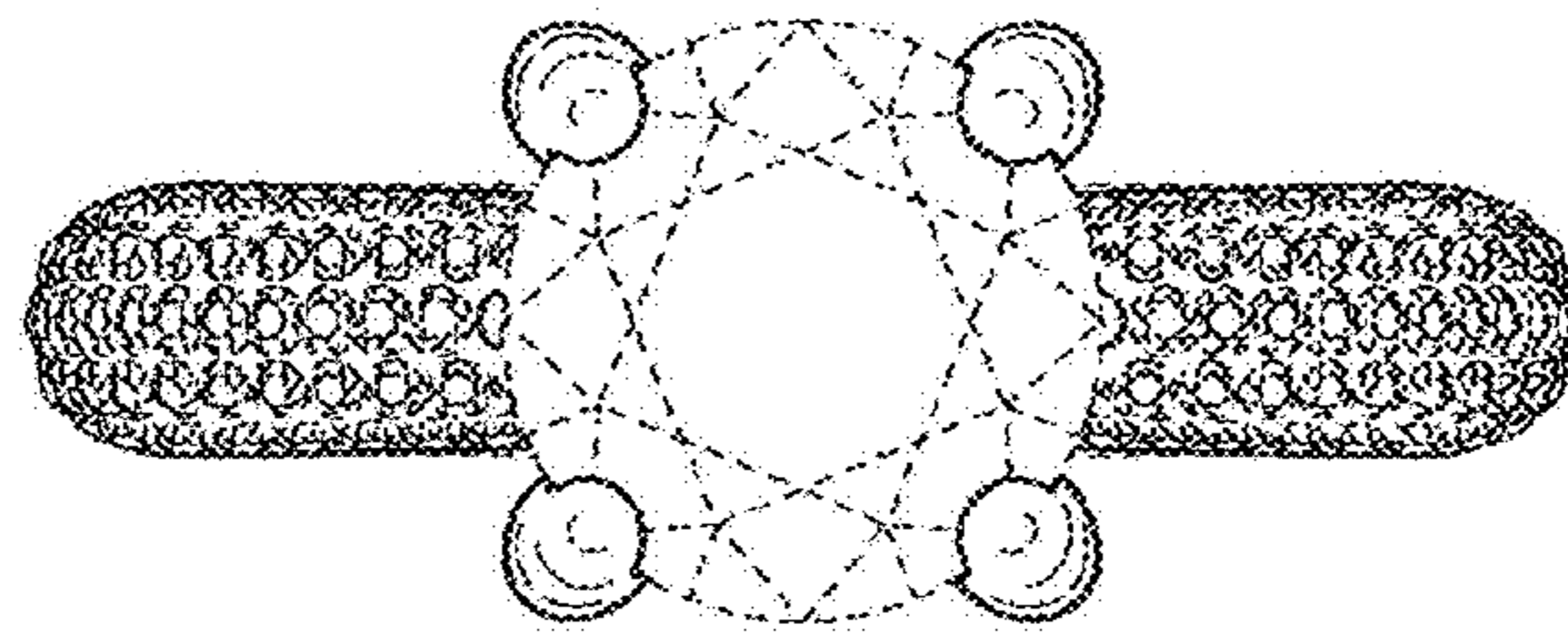

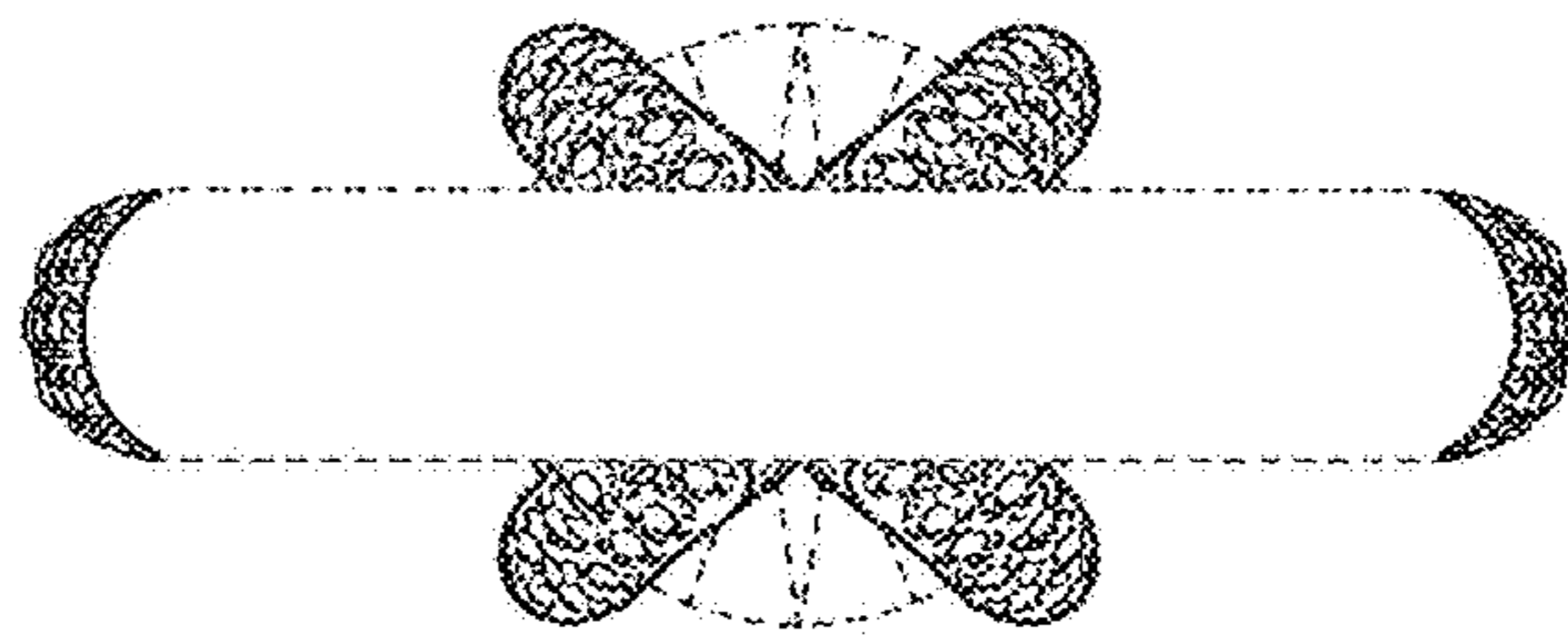
